(57) **CLAIM**  
The ornamental design for a shower plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a first embodiment of a shower plate in accordance with our design;  
FIG. 2 is a cross-section thereof taken along line 2-2 of FIG. 1;  
FIG. 3 is a front view thereof; and the back view will be identical thereto;  
FIG. 4 is a right side view thereof; and the left side view will be identical thereto; and  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a top view of a second embodiment of a shower plate in accordance with our design;  
FIG. 7 is a cross-section thereof taken along line 7-7 of FIG. 6;  
FIG. 8 is a front view thereof; and the back view will be identical thereto;  
FIG. 9 is a right side view thereof; and the left side view will be identical thereto; and  
FIG. 10 is a bottom view thereof;  
FIG. 11 is a top view of a third embodiment of a shower plate in accordance with our design;  
FIG. 12 is a cross-section thereof taken along line 12-12 of FIG. 11;  
FIG. 13 is a front view thereof; and the back view will be identical thereto;  
FIG. 14 is a right side view thereof; and the left side view will be identical thereto; and  
FIG. 15 is a bottom view thereof;  
FIG. 16 is a top view of a fourth embodiment of a shower plate in accordance with our design;  
FIG. 17 is a cross-section thereof taken along line 17-17 of FIG. 16;  
FIG. 18 is a front view thereof; and the back view will be identical thereto;  
FIG. 19 is a right side view thereof; and the left side view will be identical thereto; and,  
FIG. 20 is a bottom view thereof.

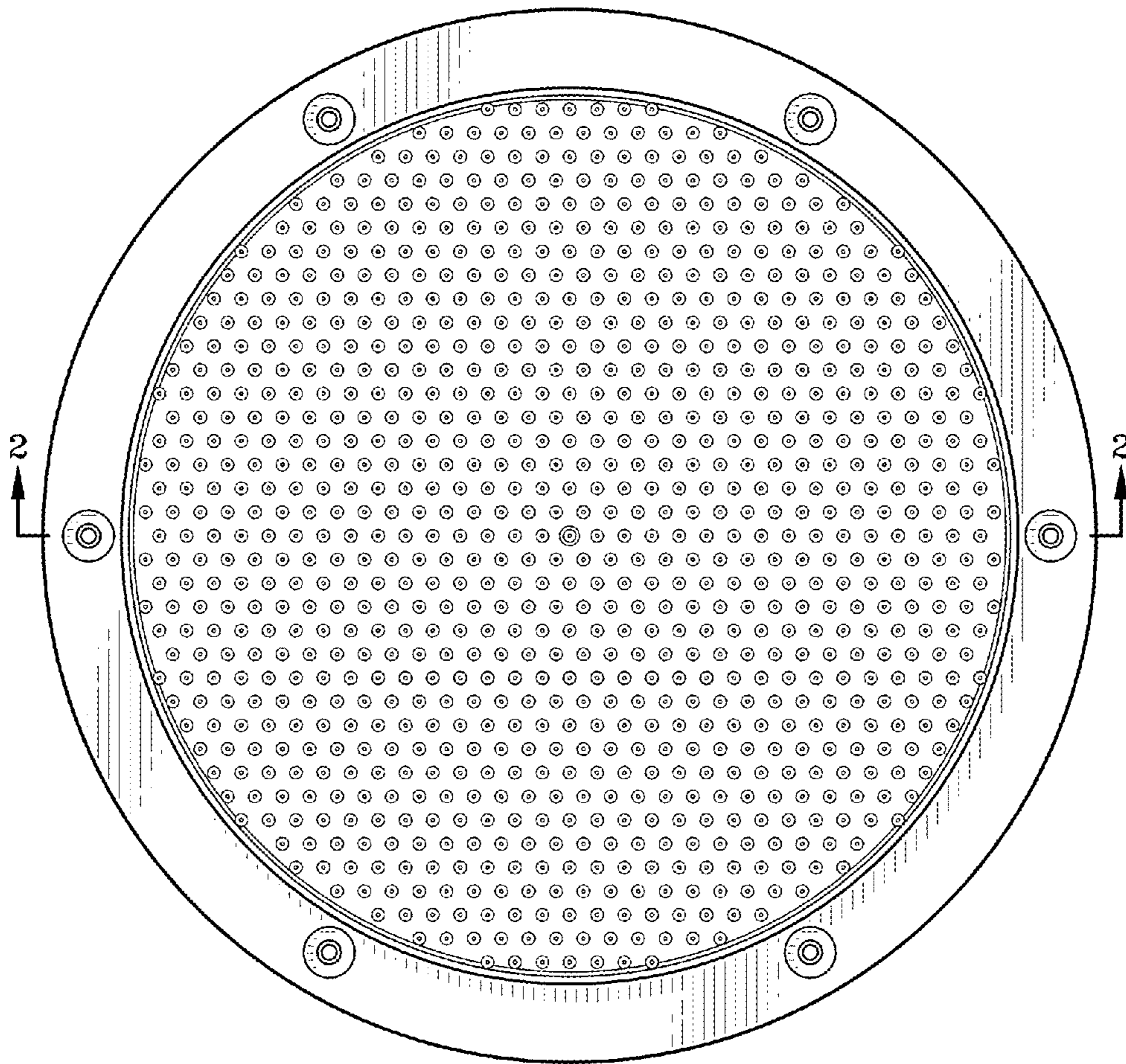

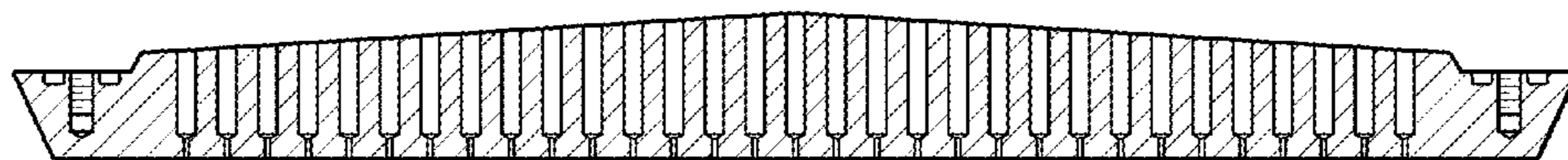

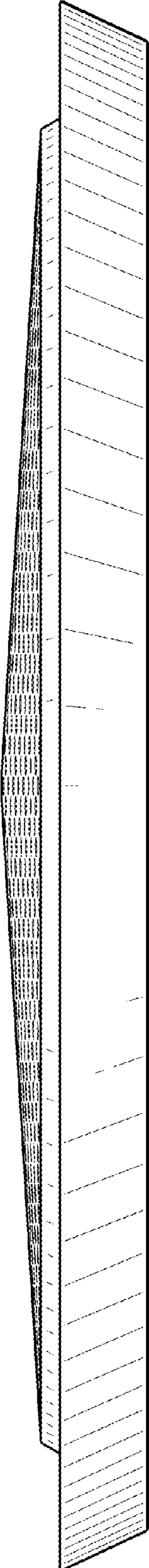

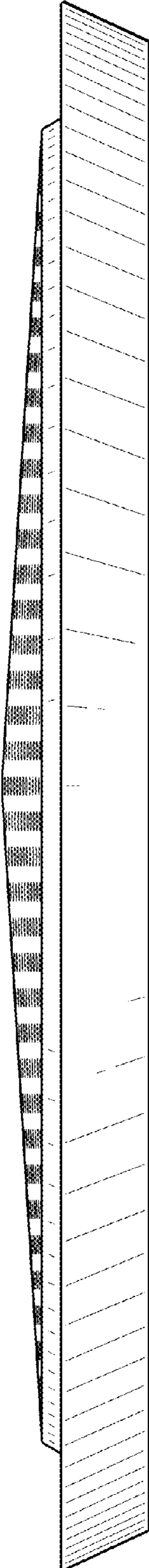

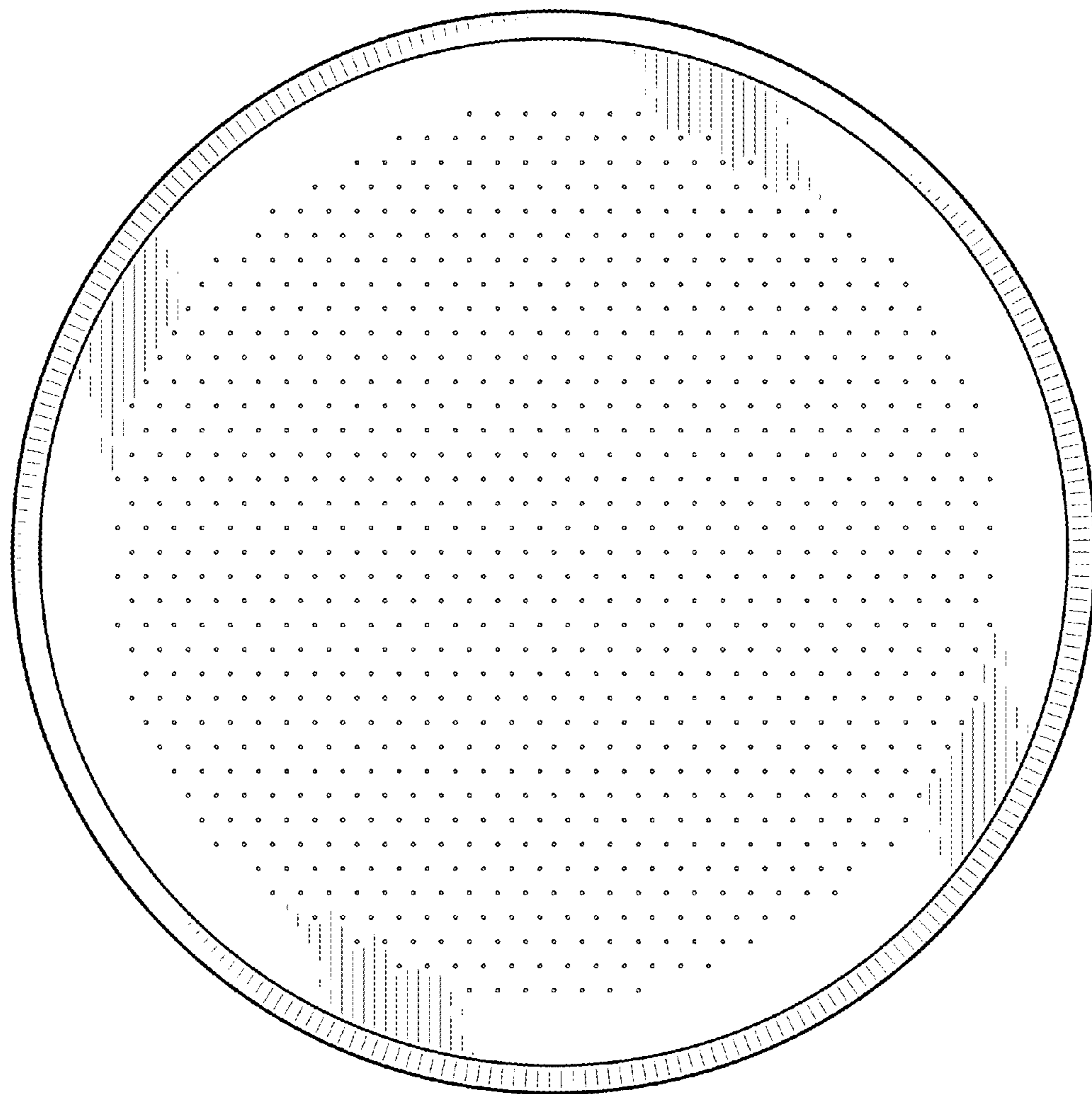

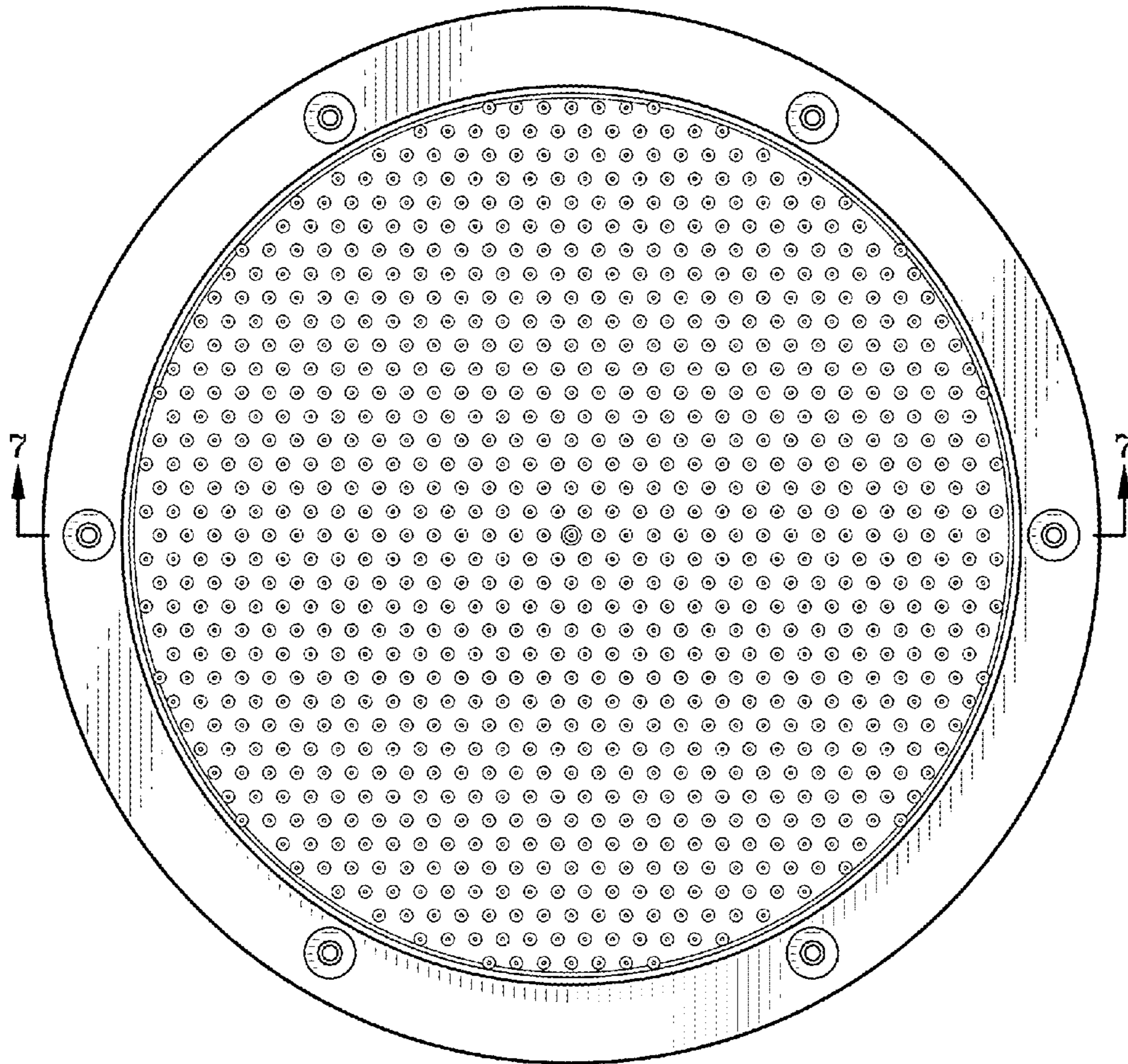

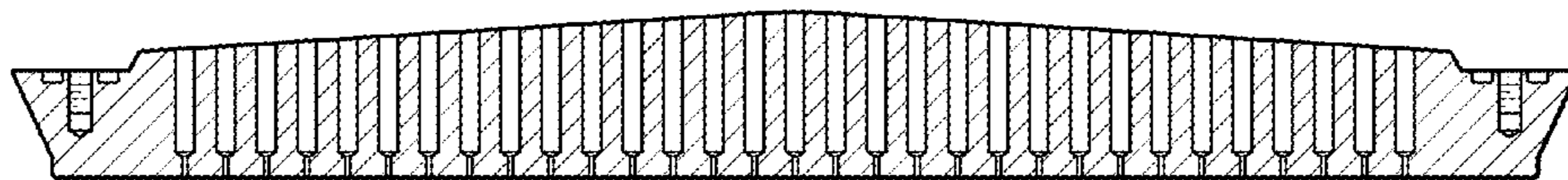

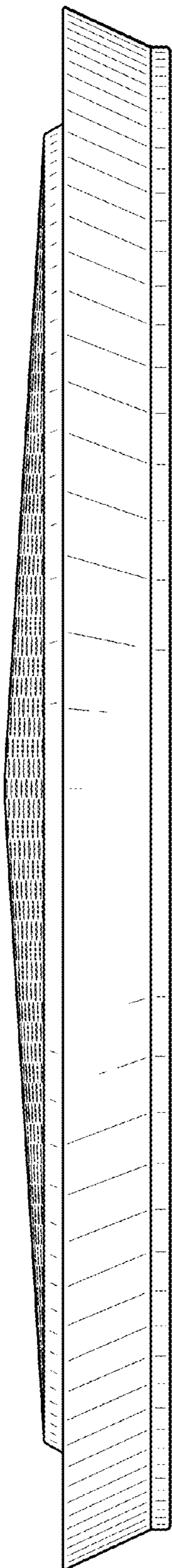

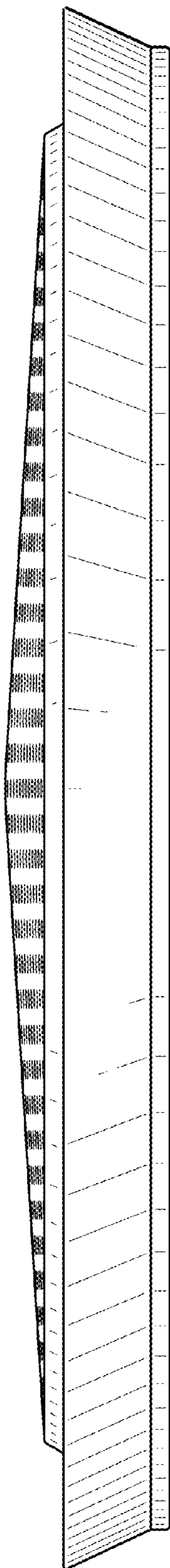

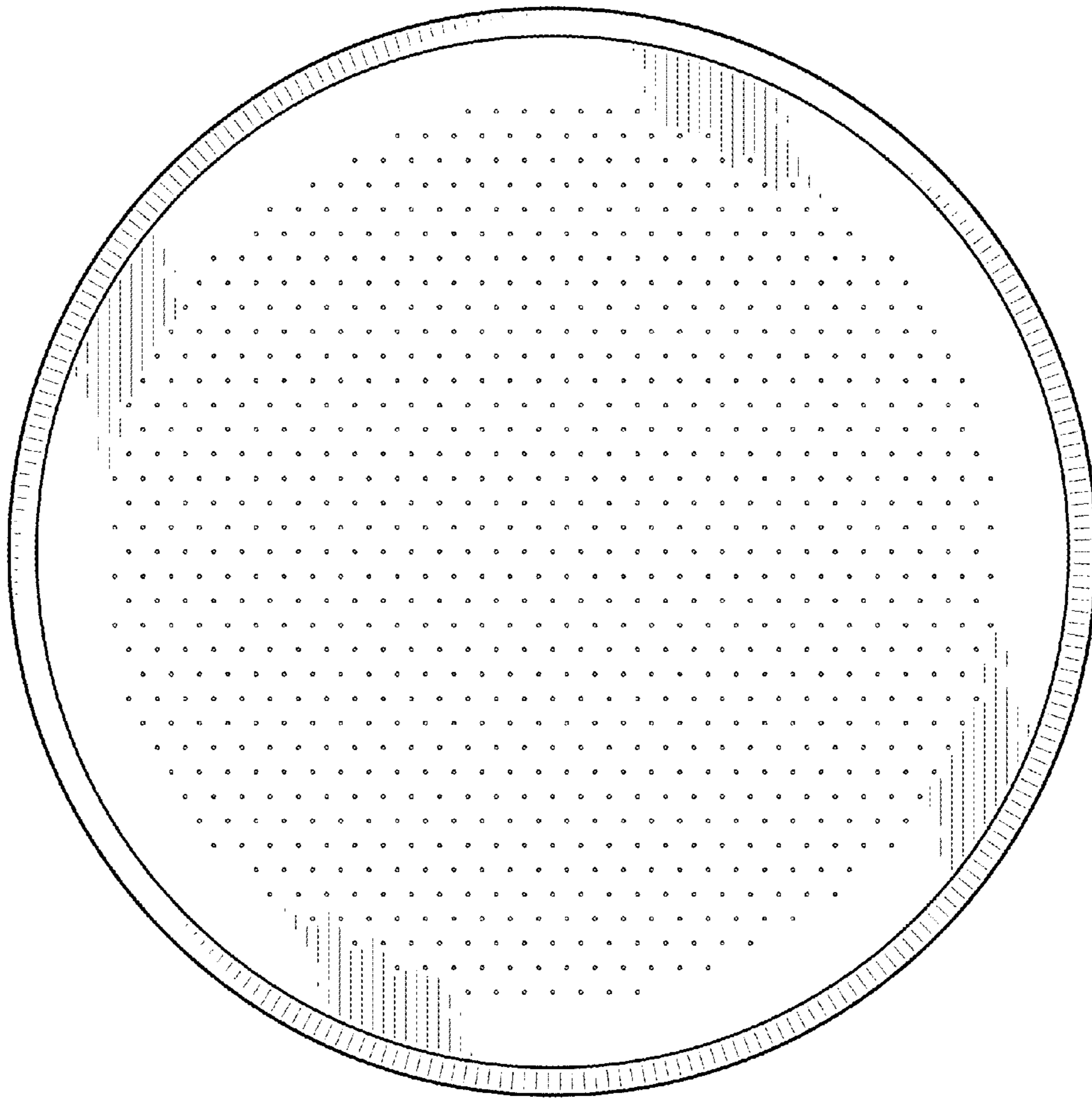

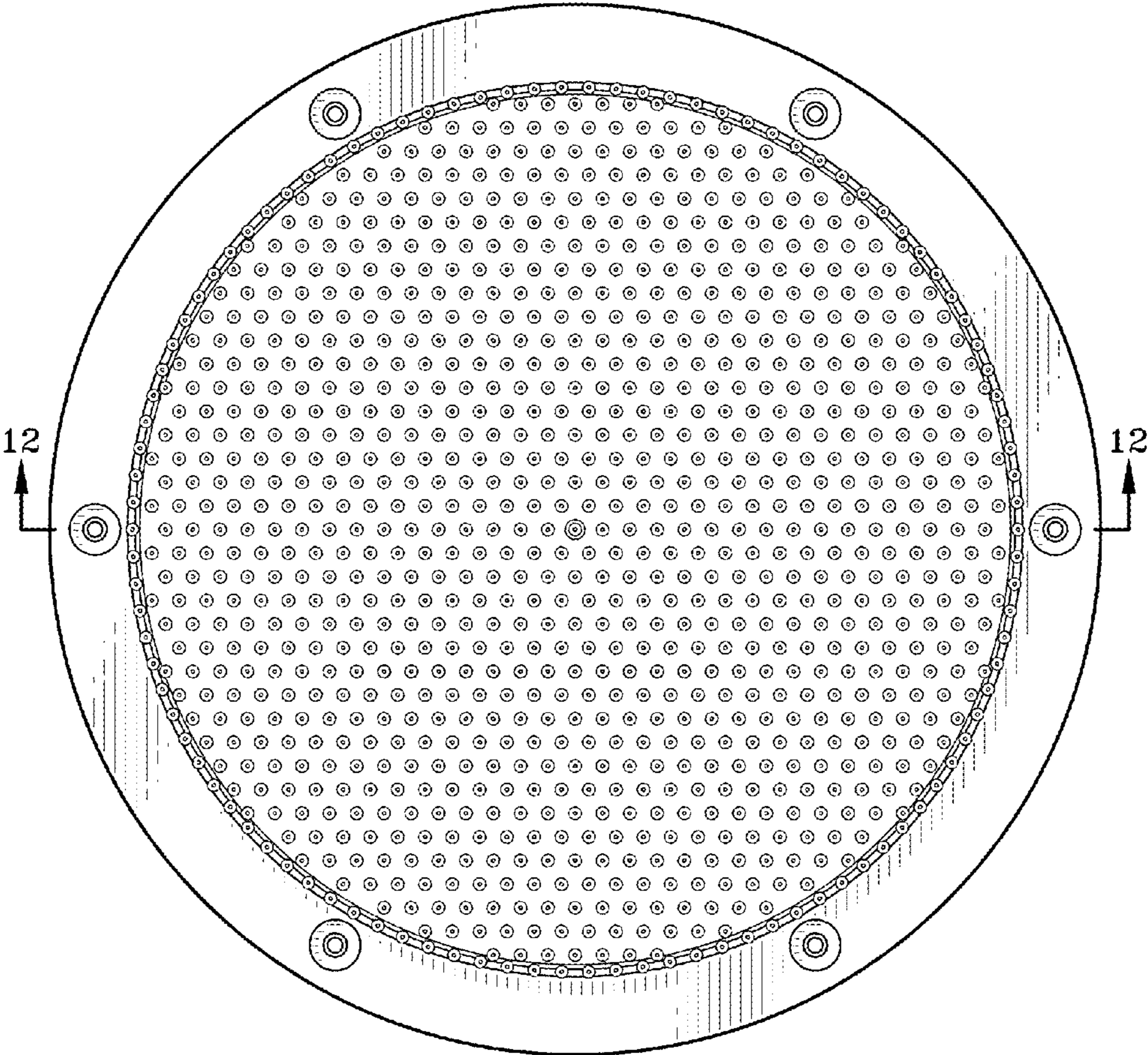

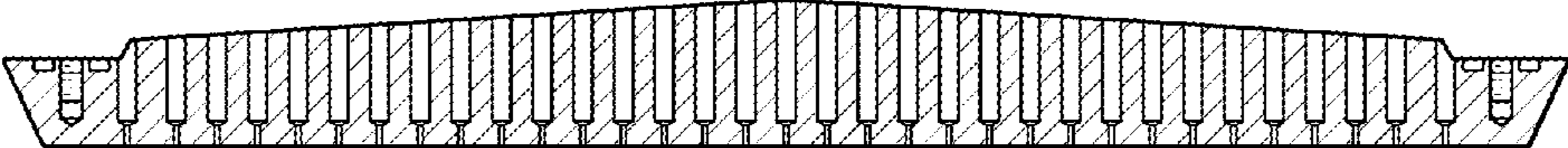

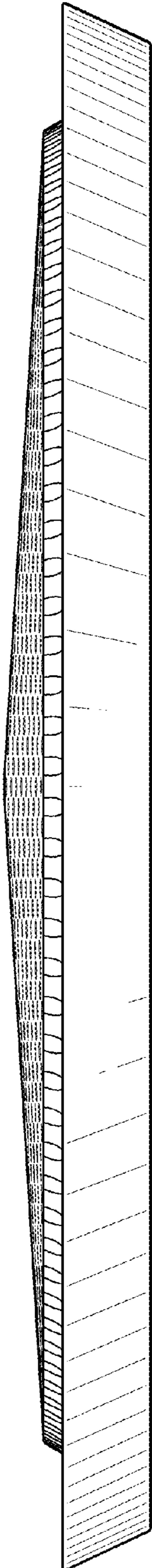

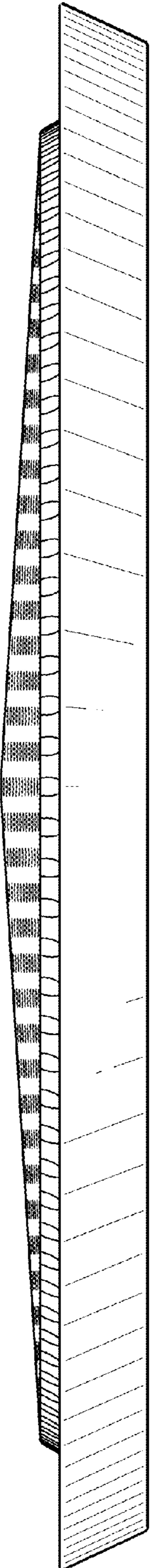

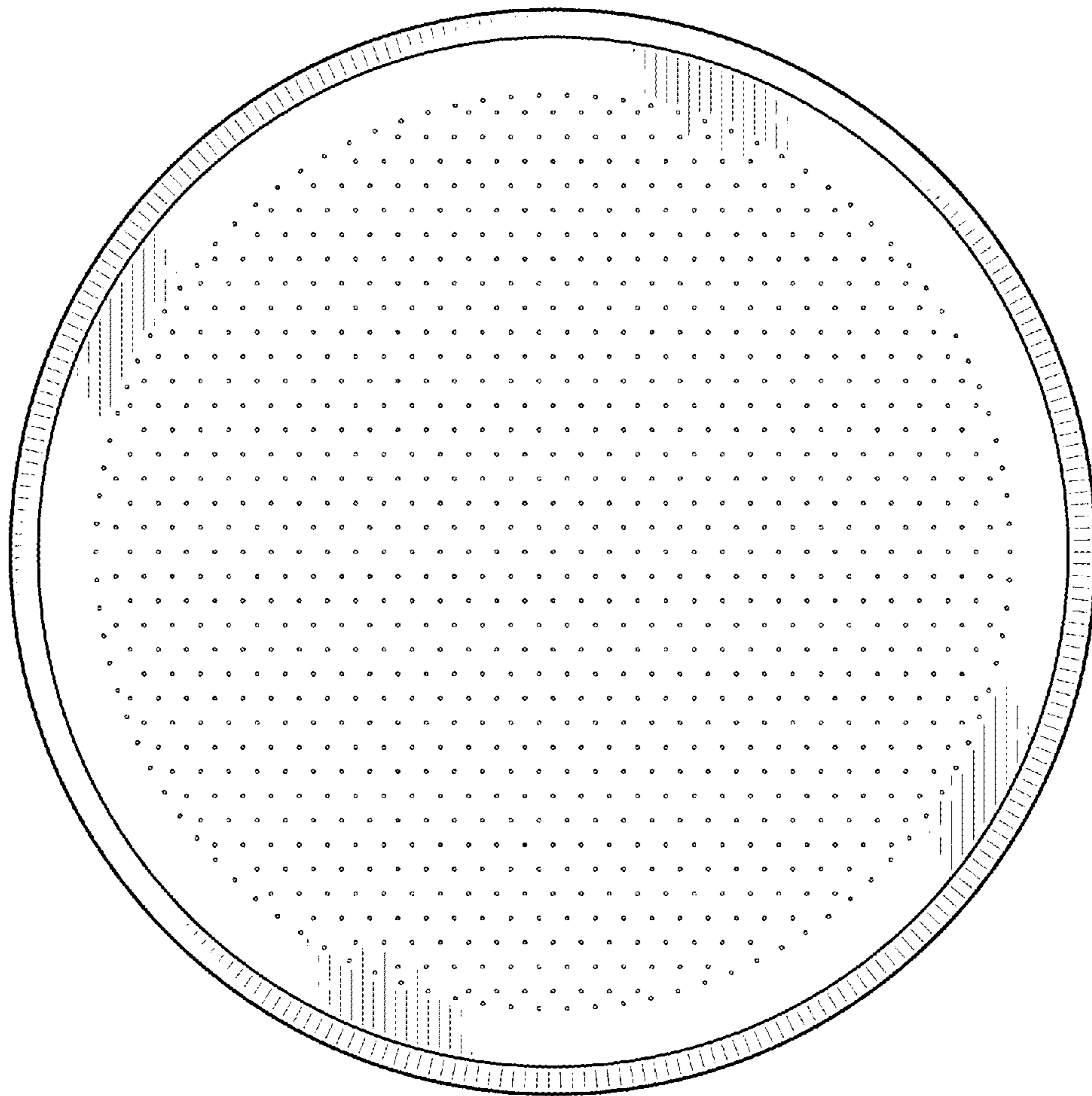

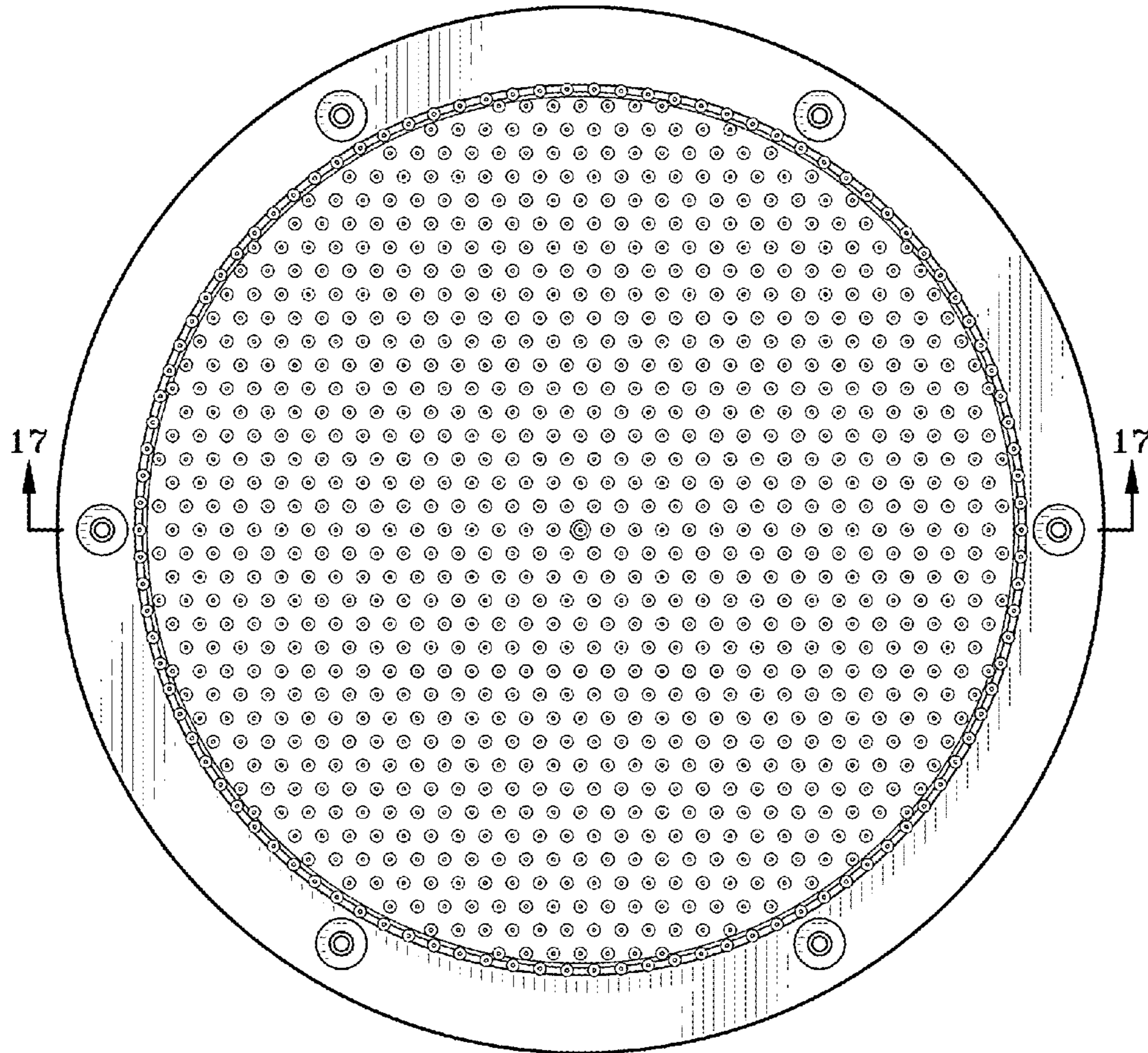

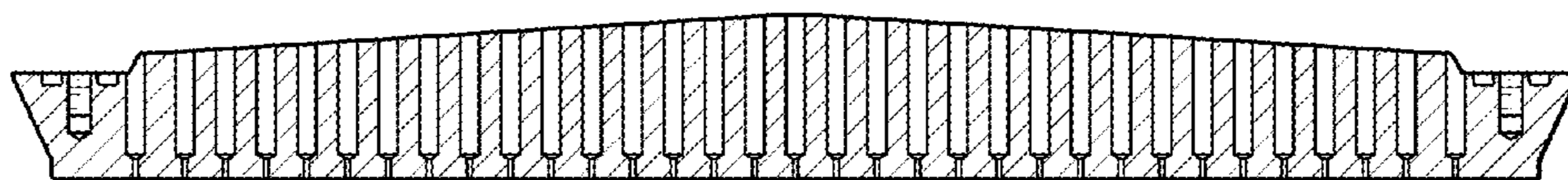

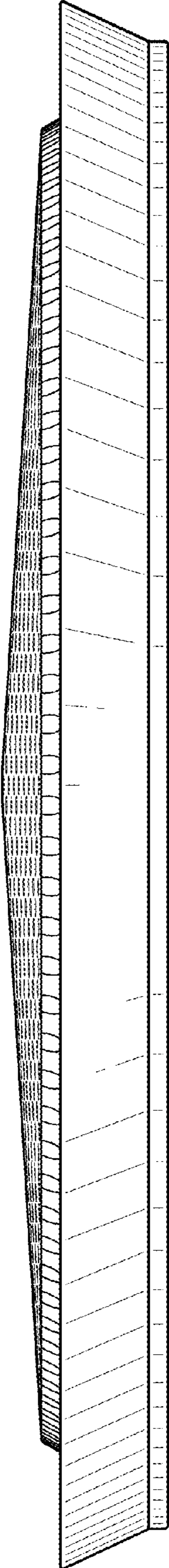

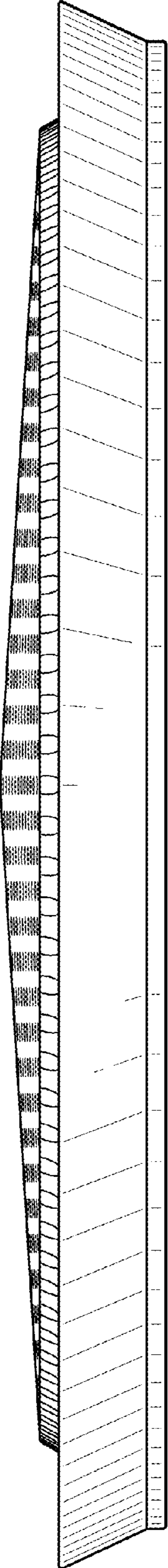

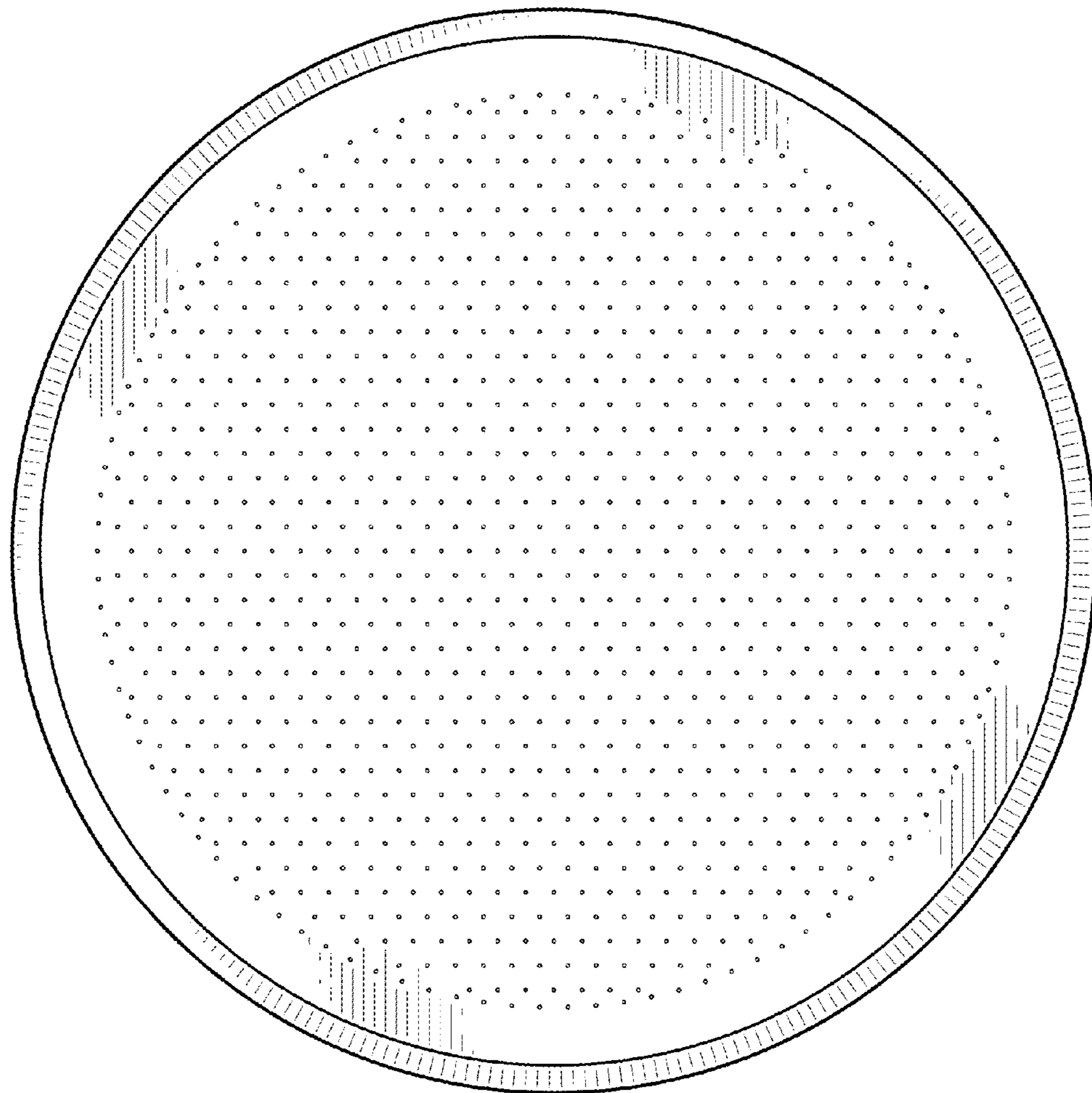
