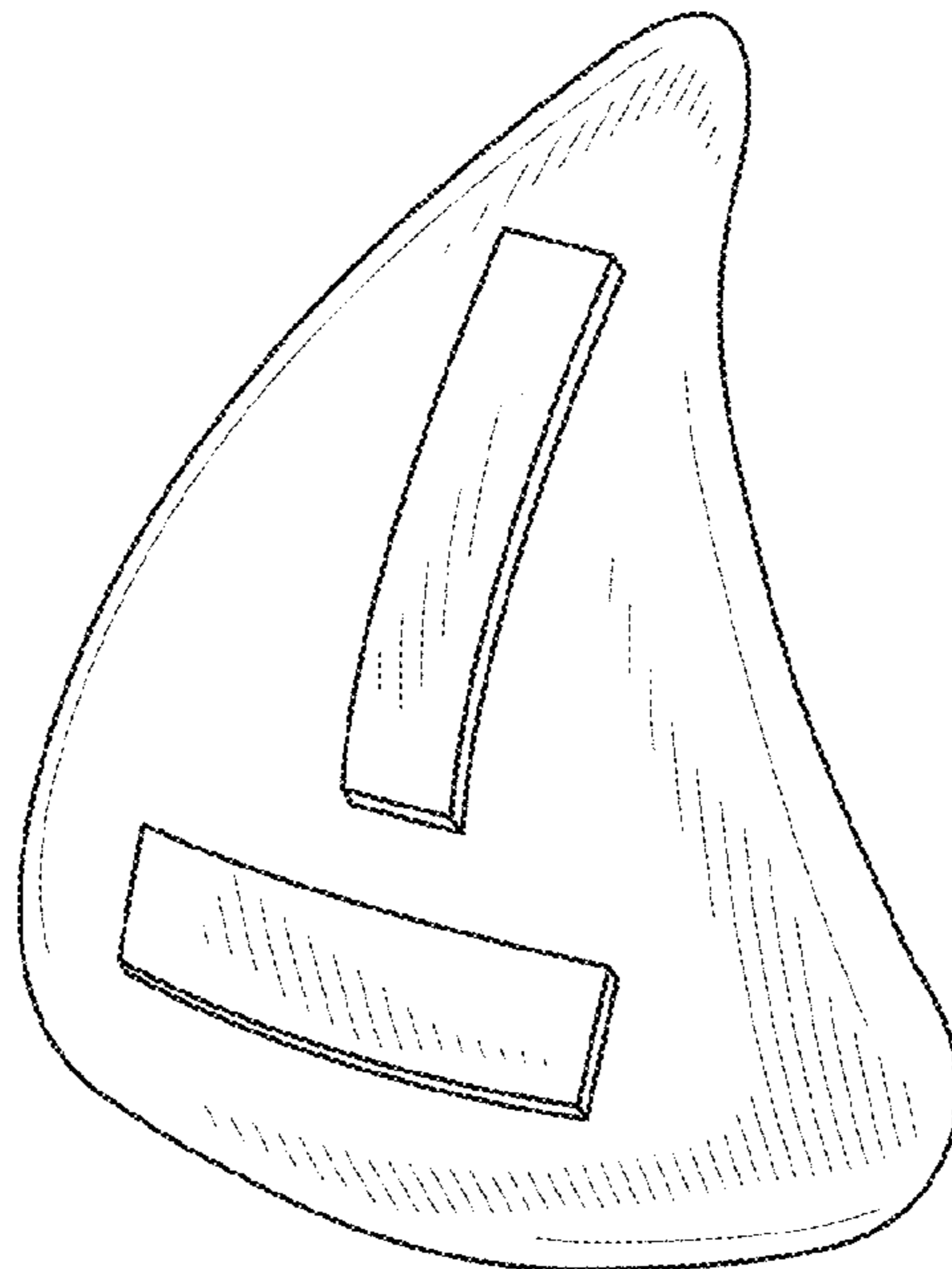

DESCRIPTION

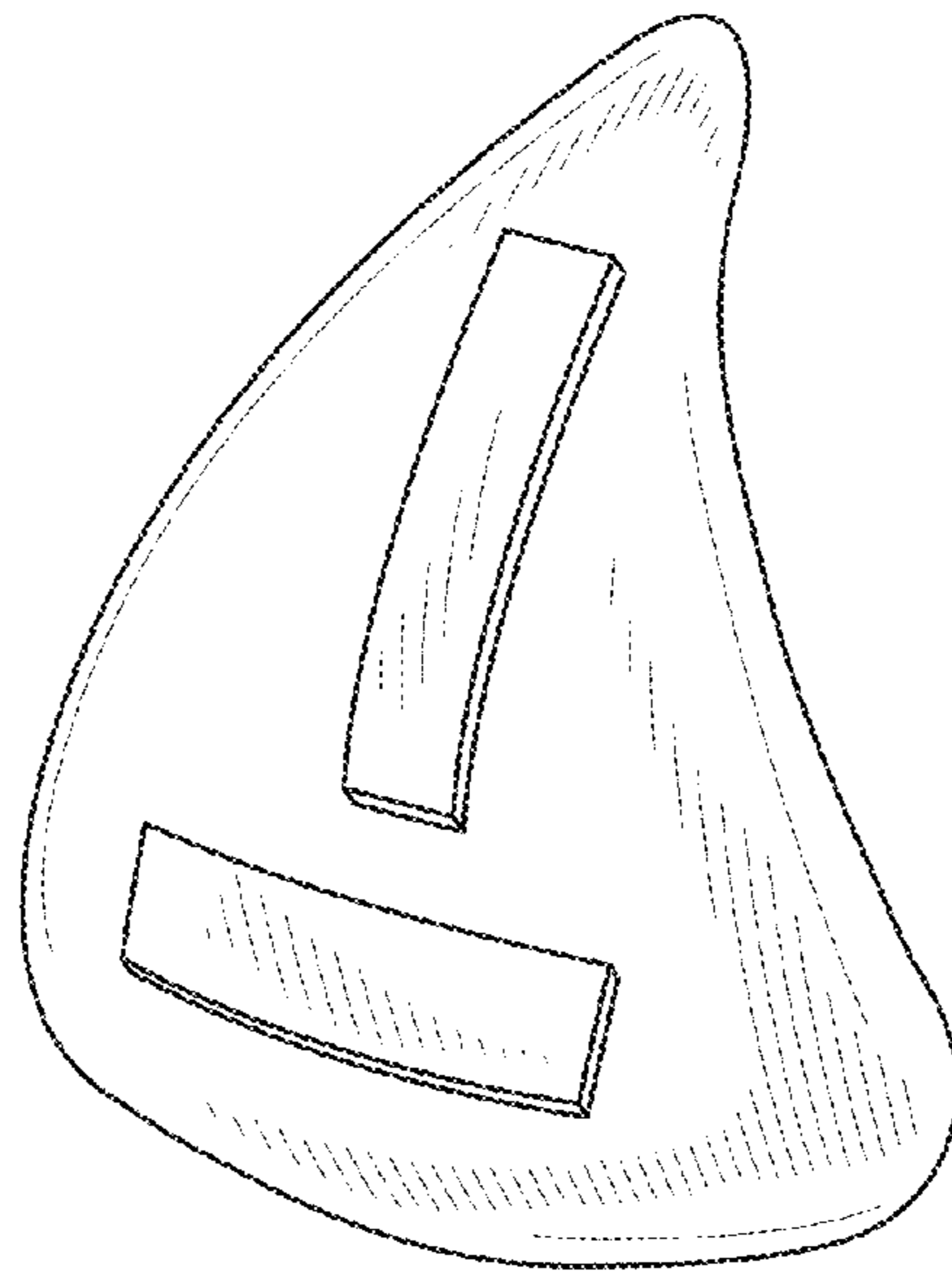

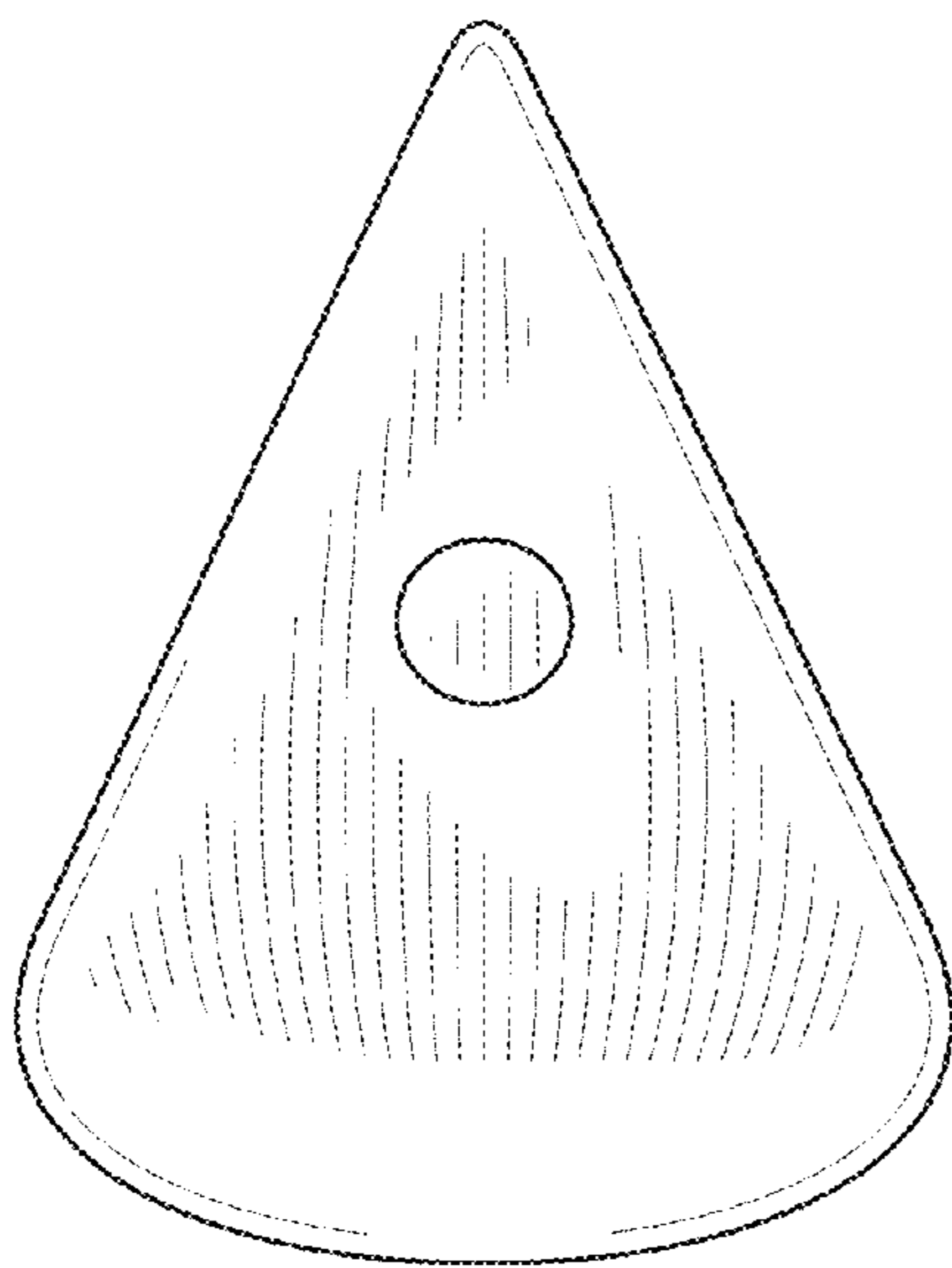

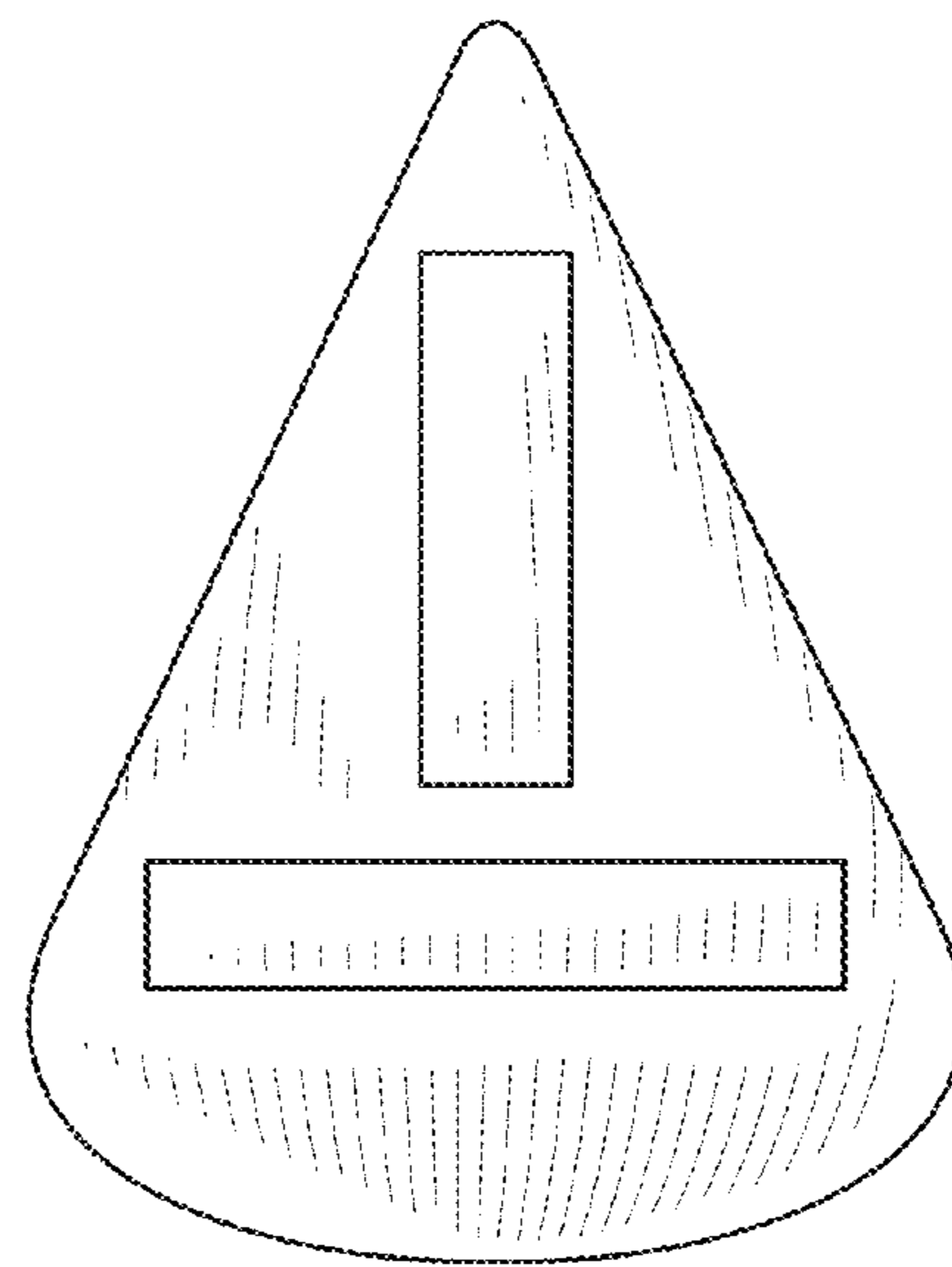

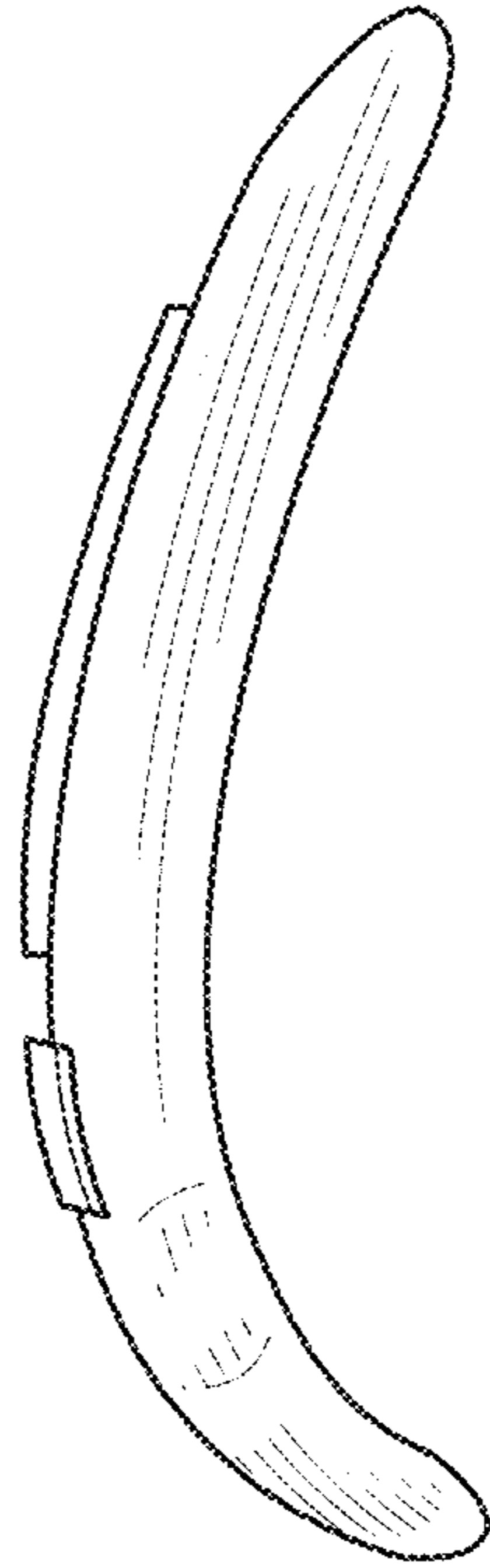

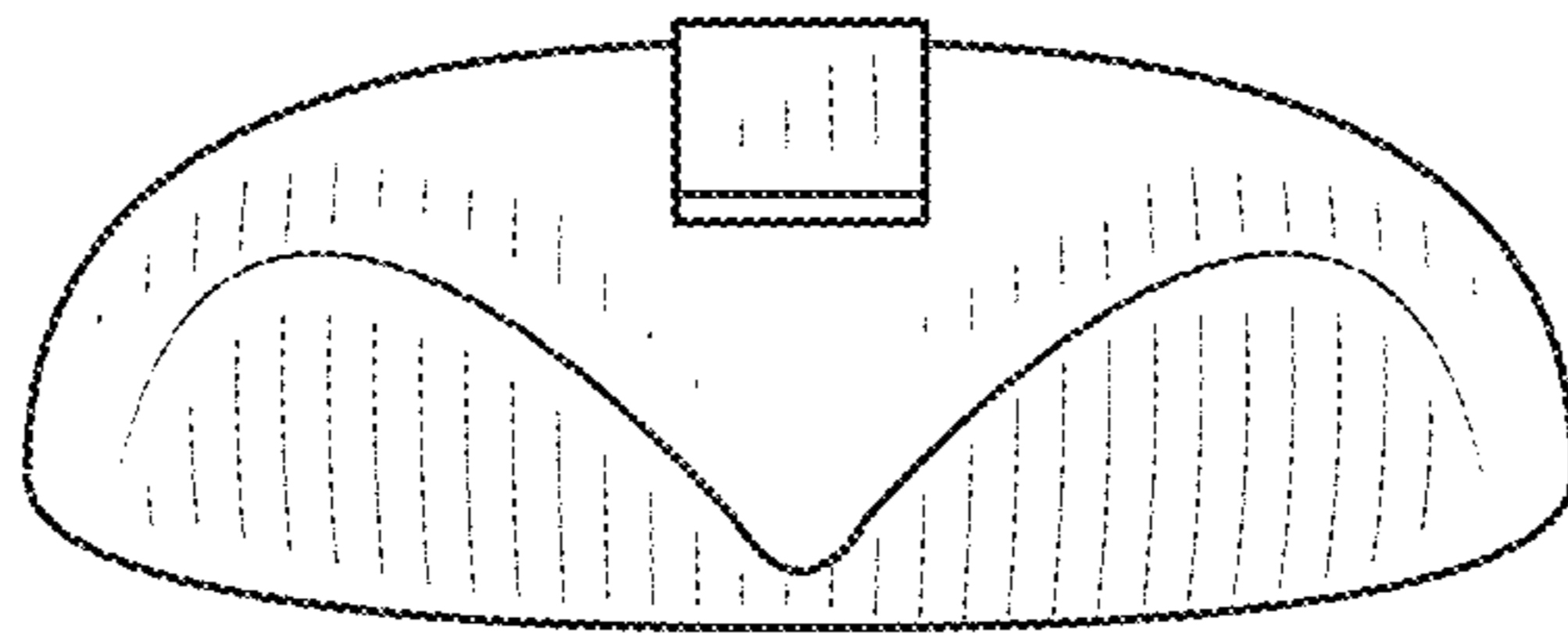

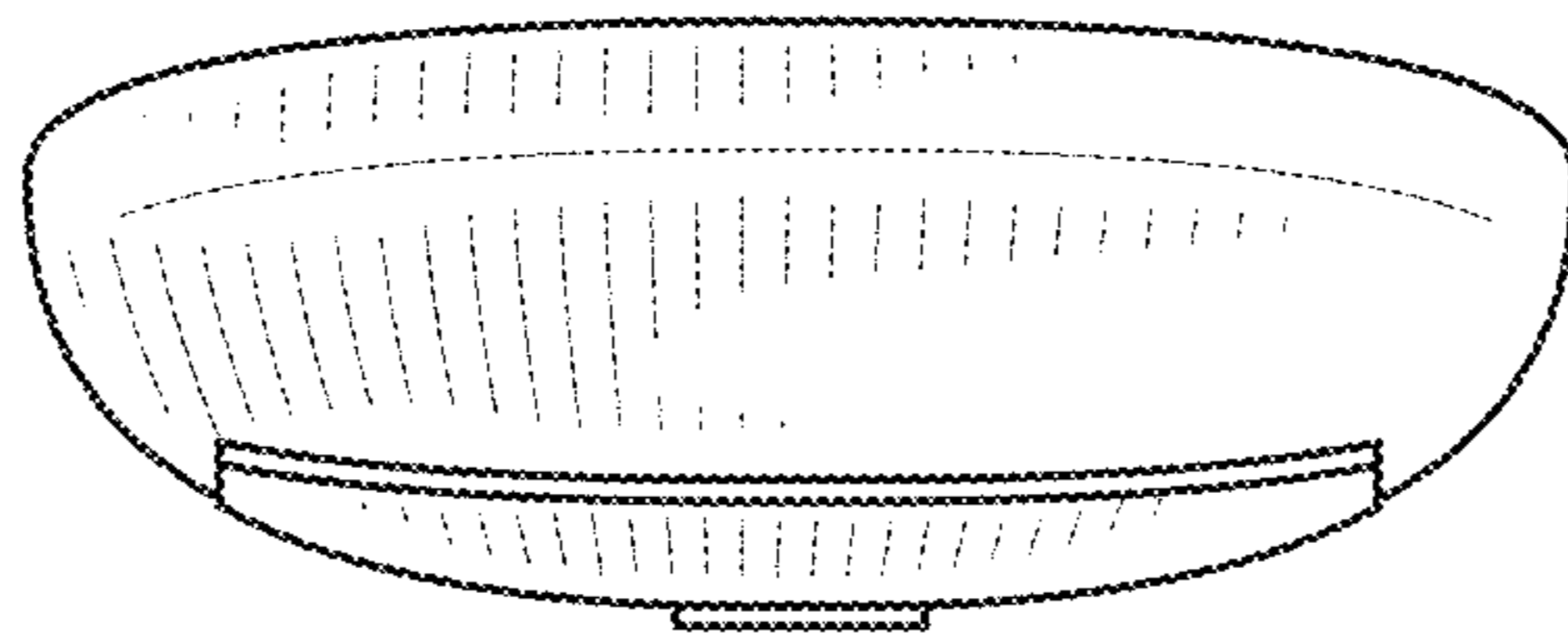
