FIG. 1 is a top perspective view of vitrectomy rehabilitation stand.

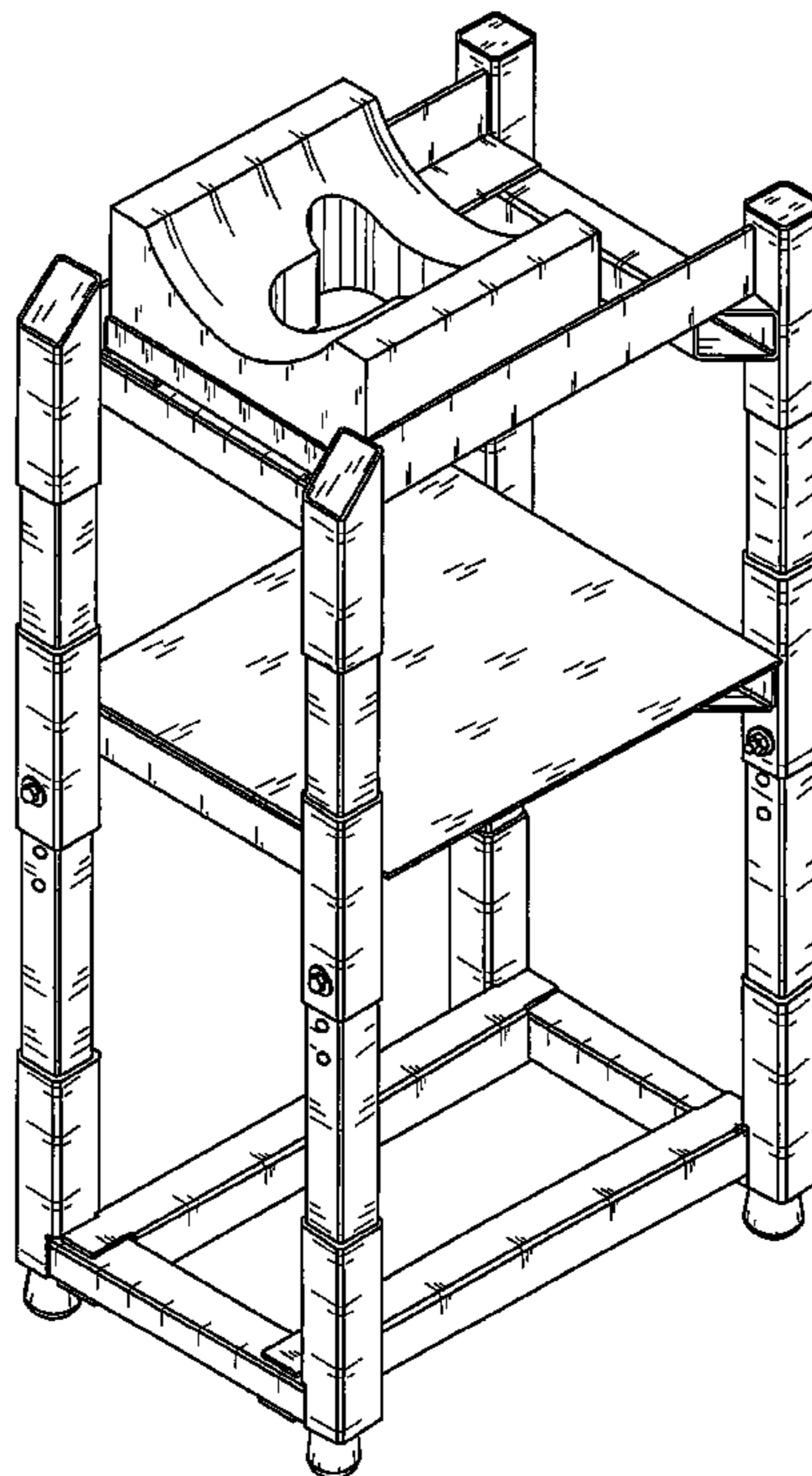
FIG. 2 is a front view thereof.

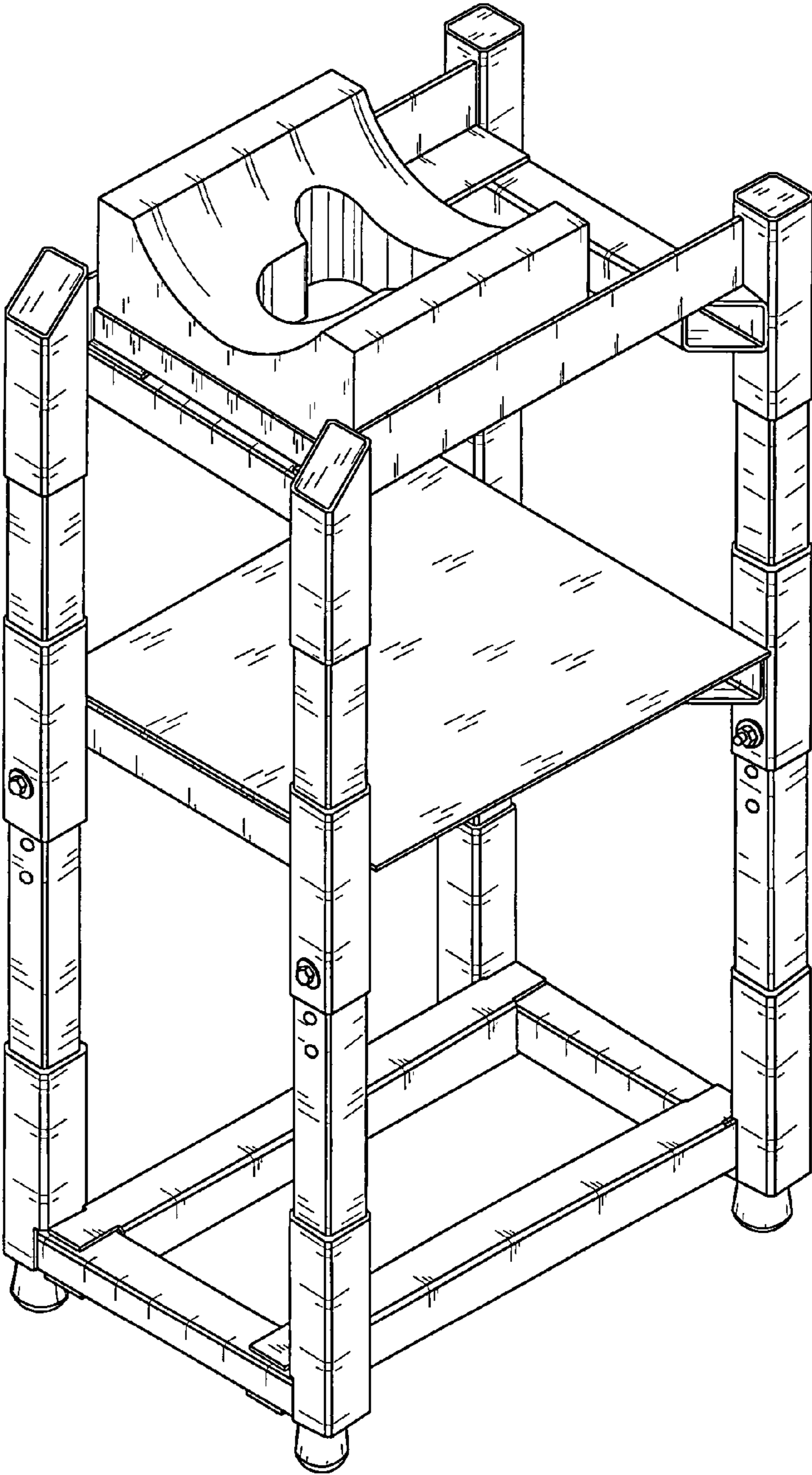

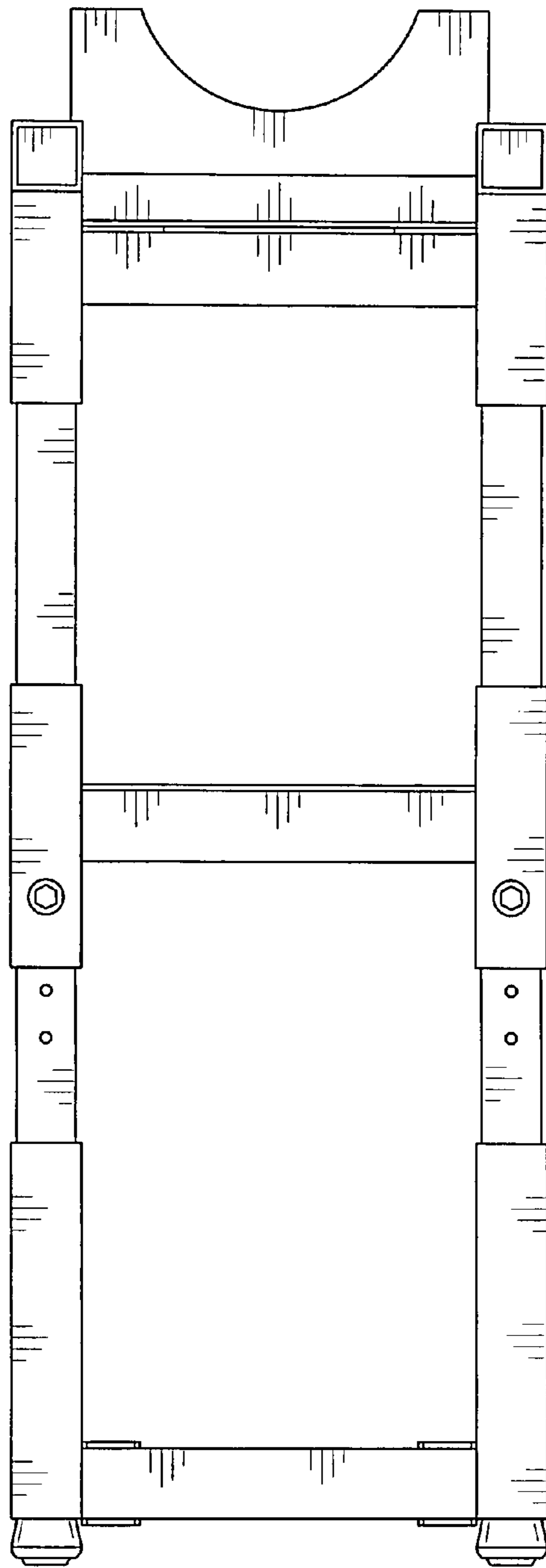

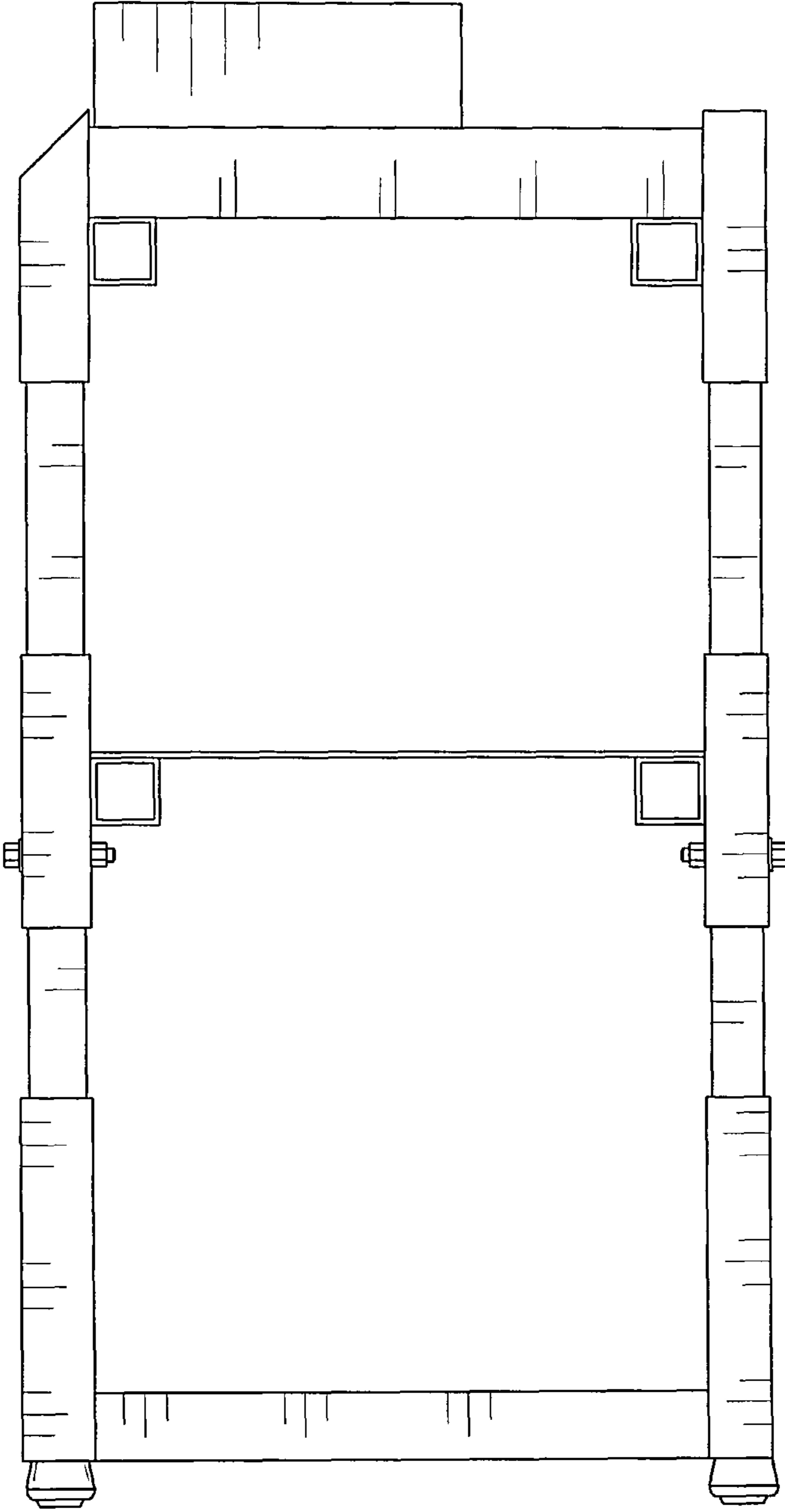

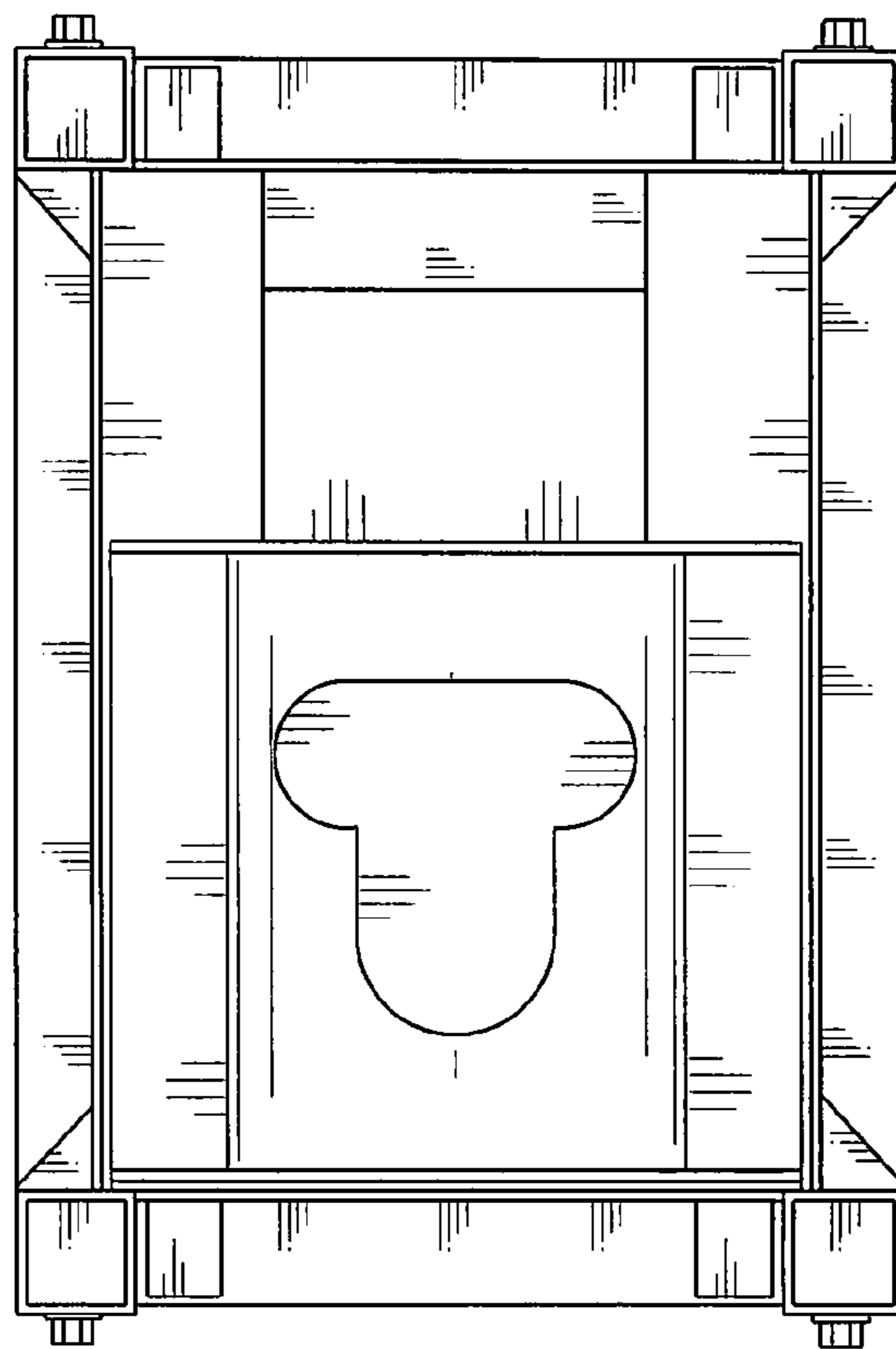

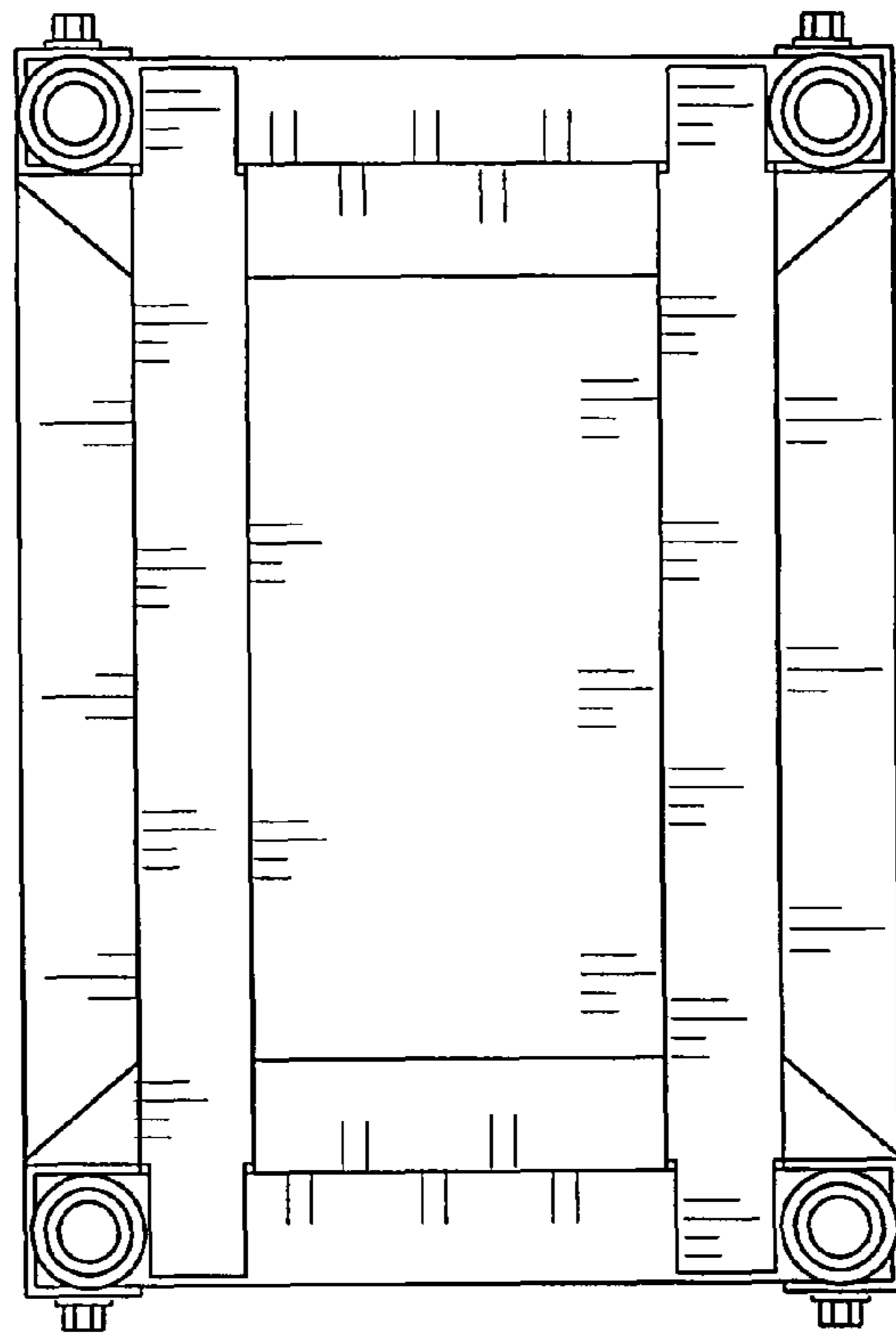
