DESCRIPTION

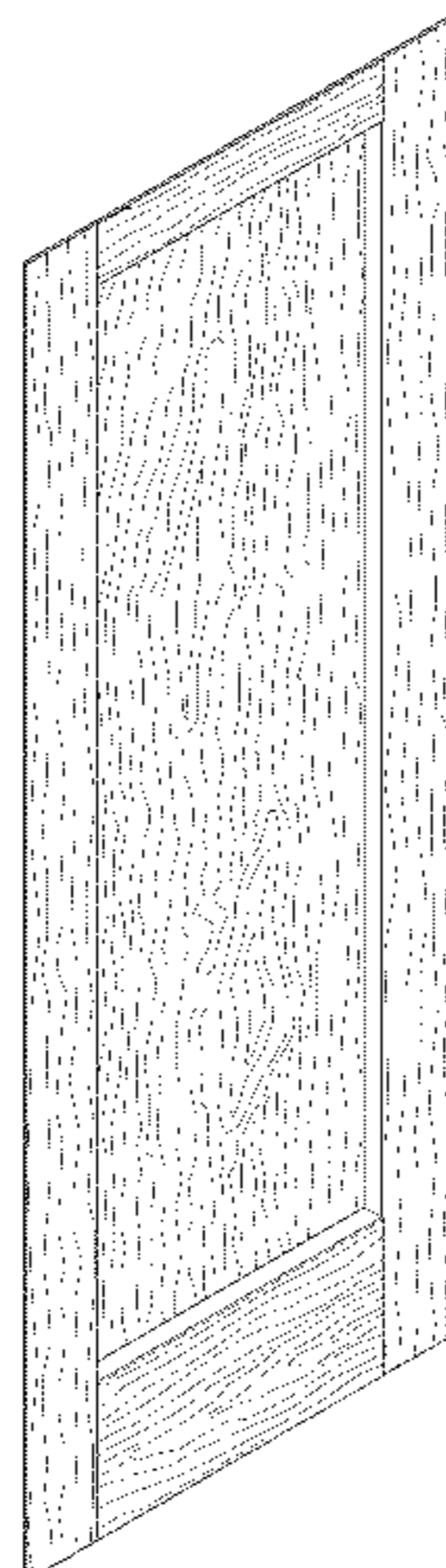

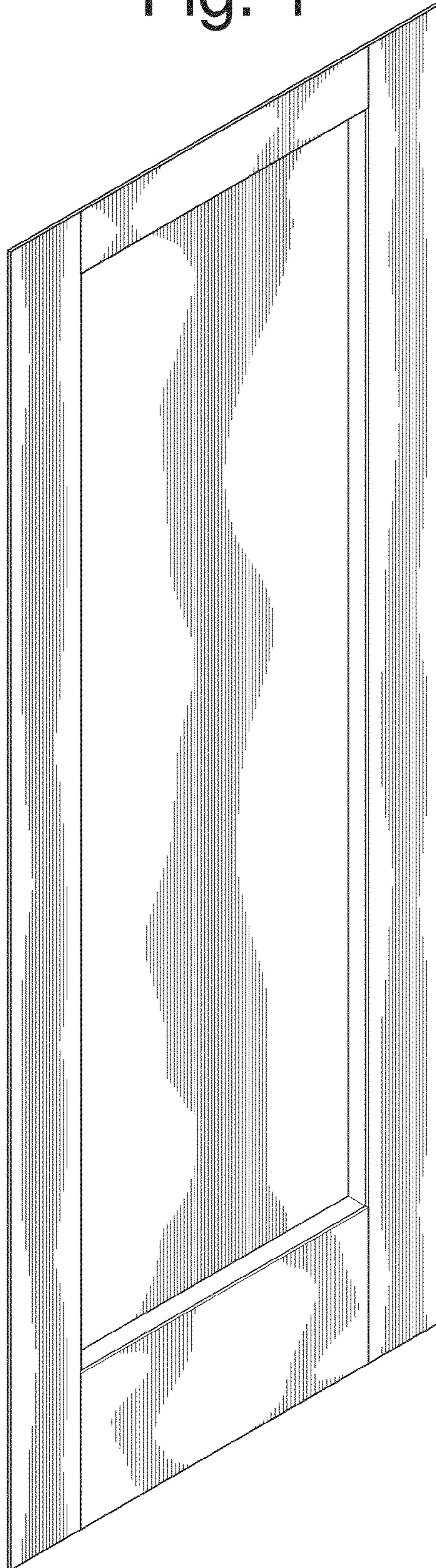

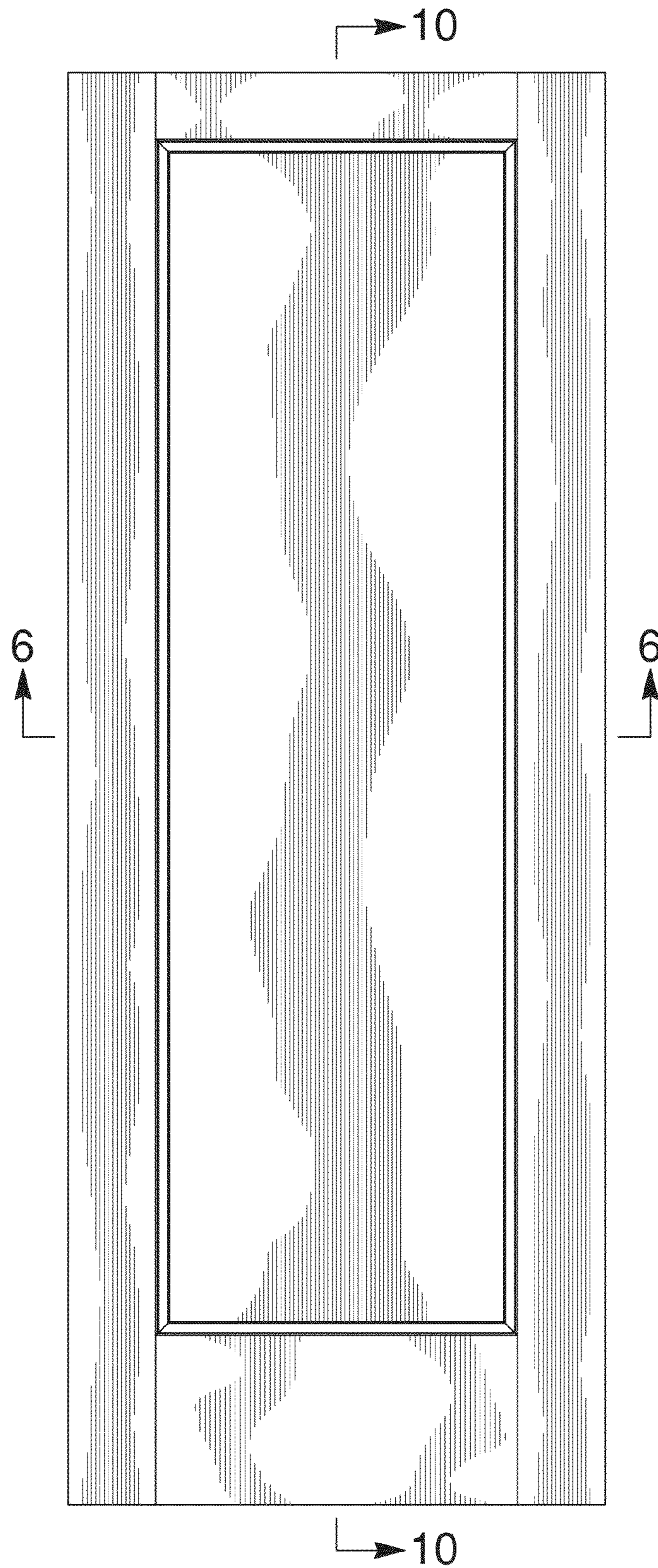

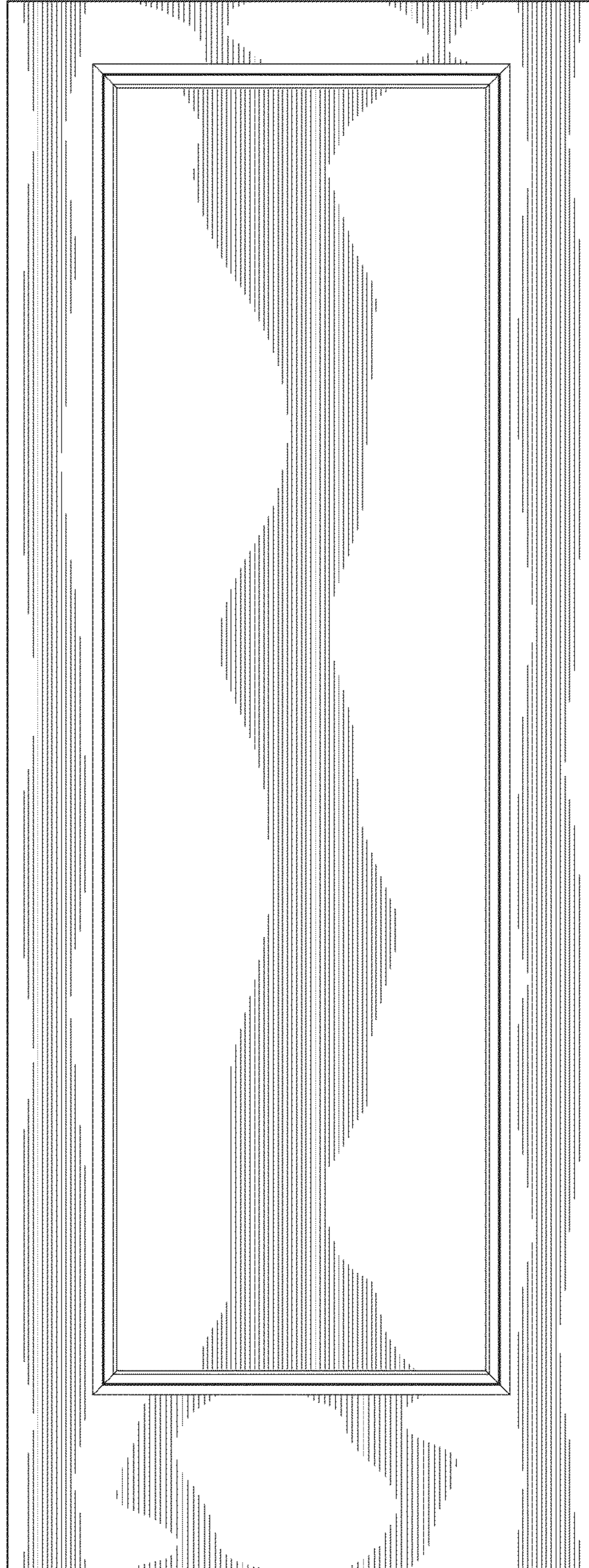

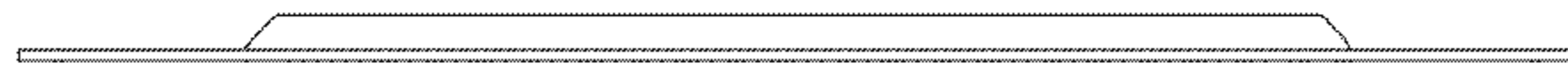

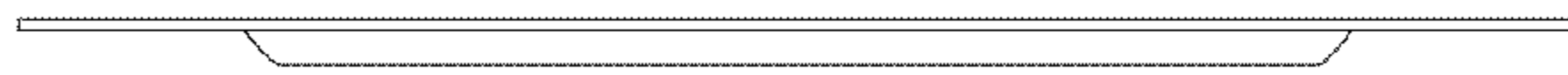

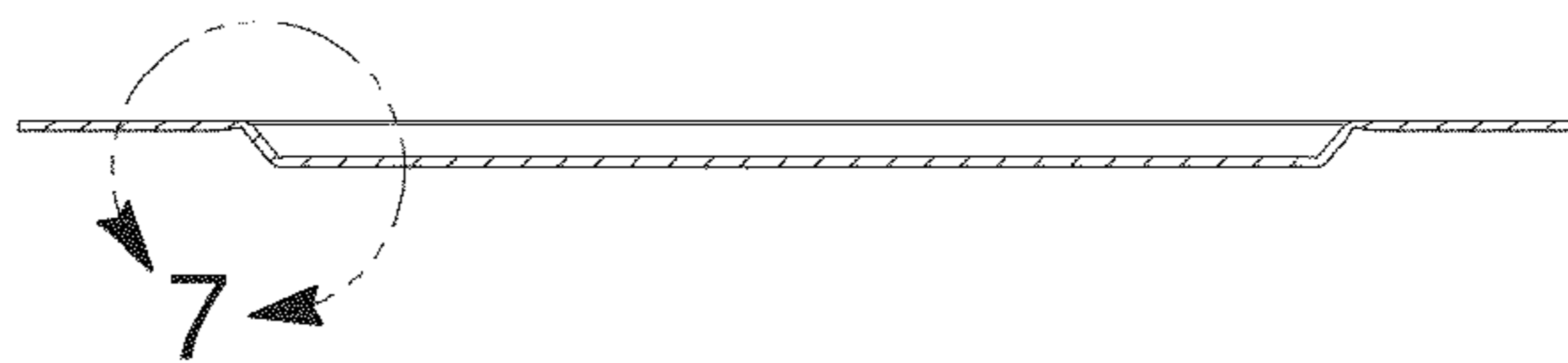

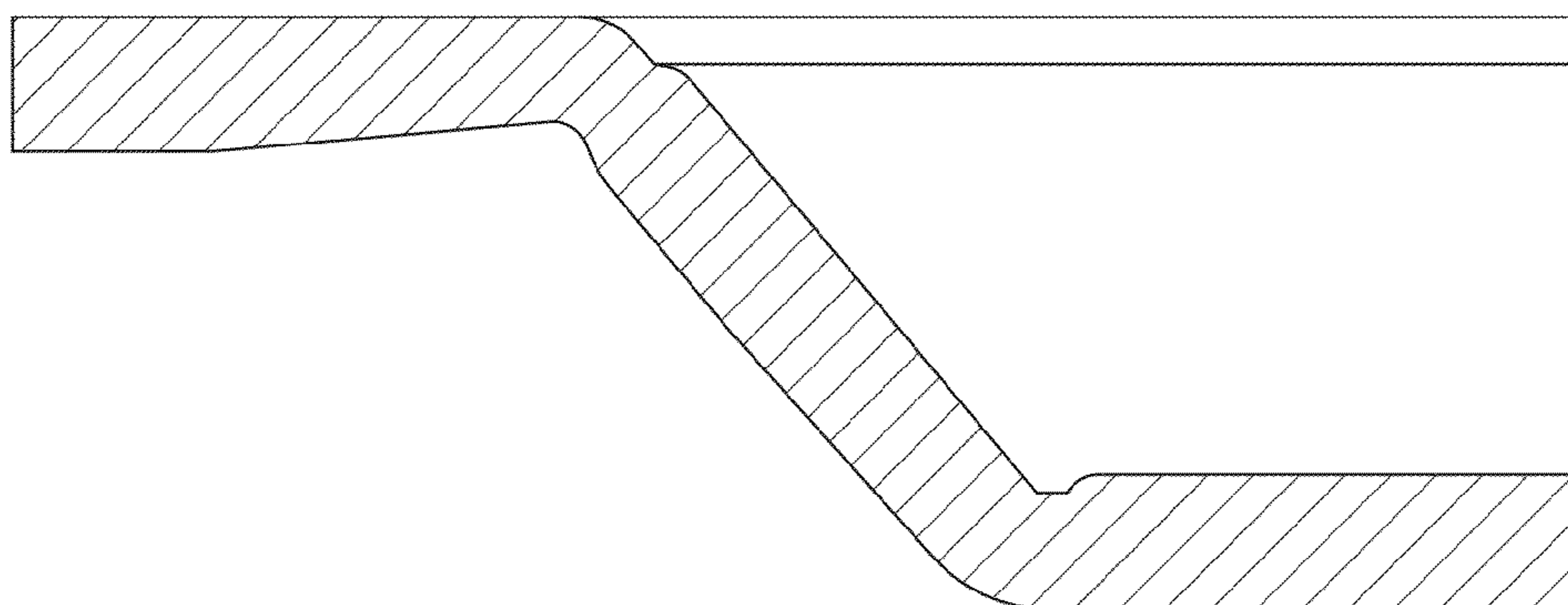

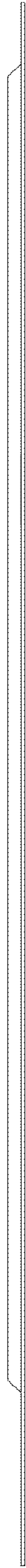

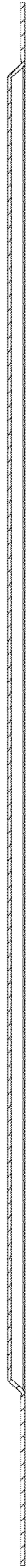

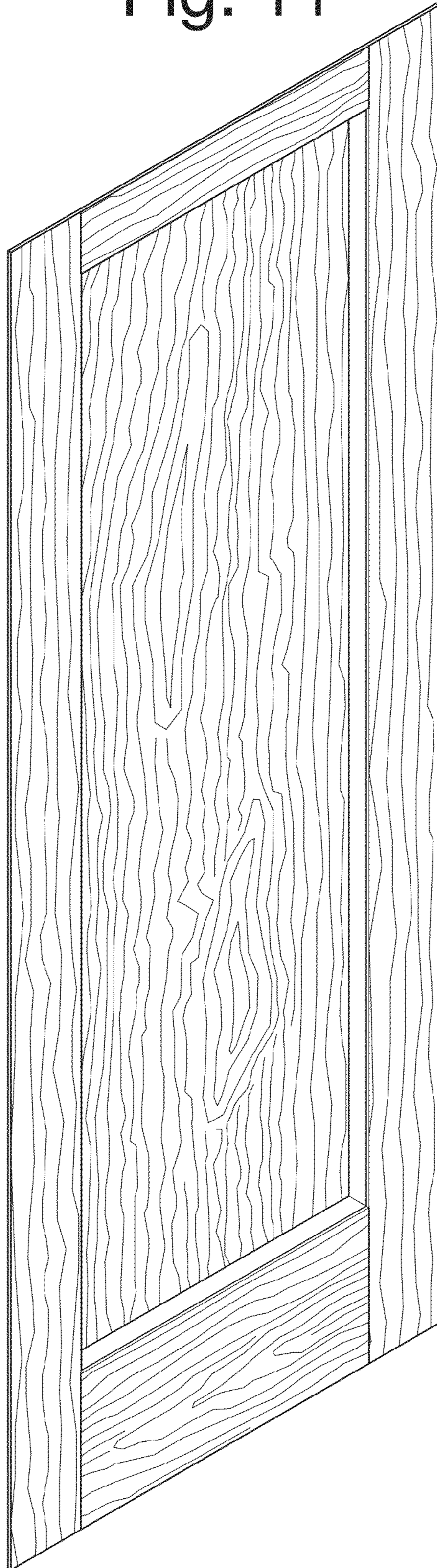

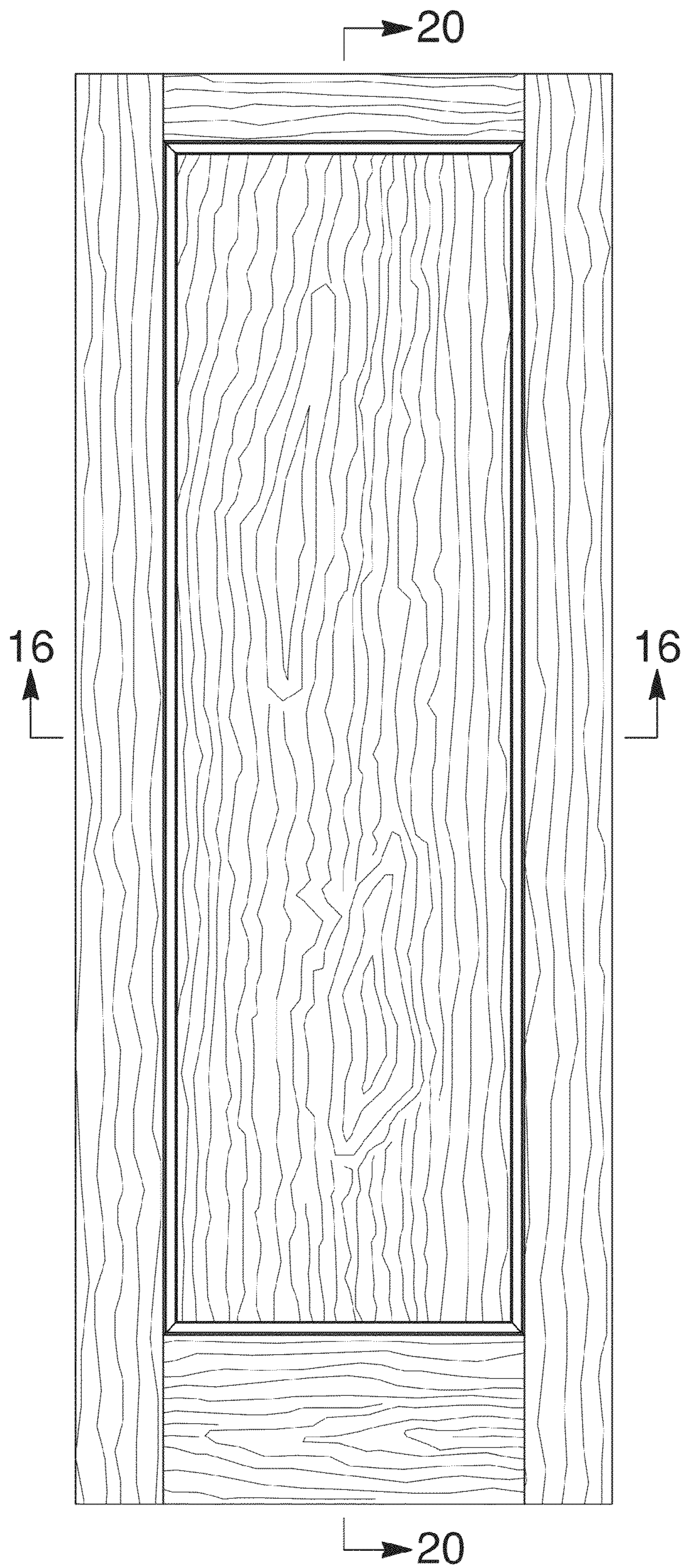

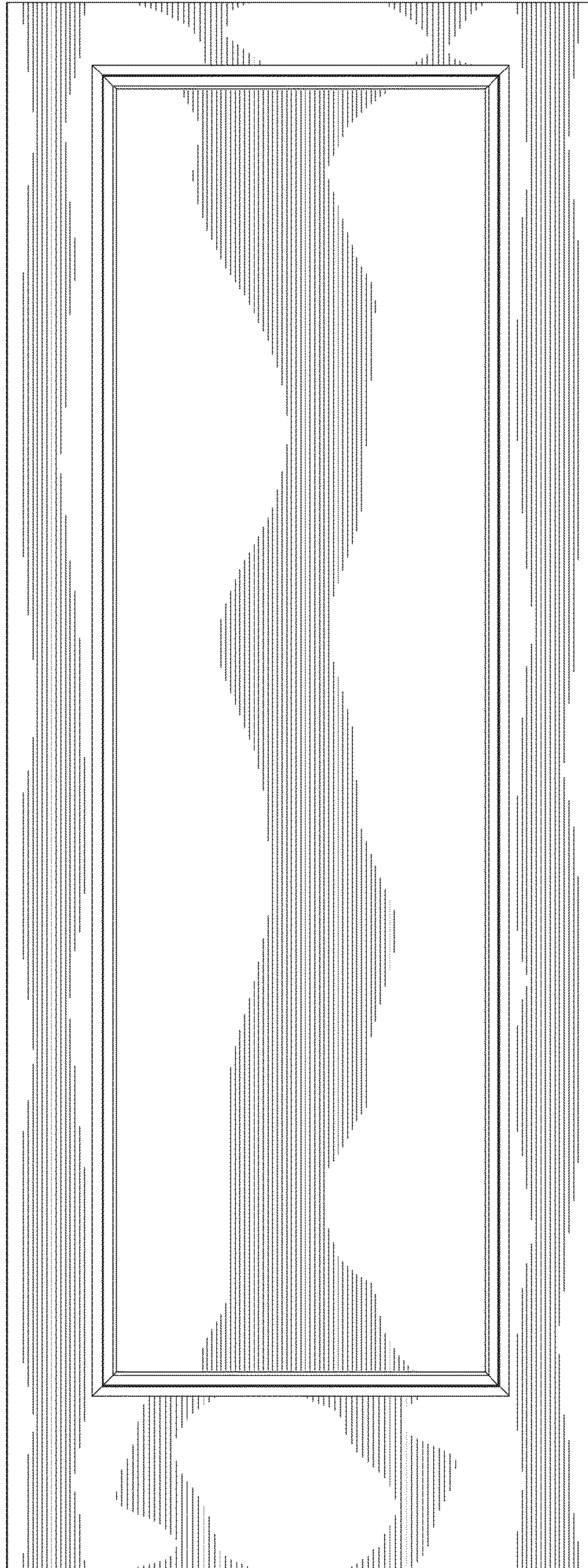

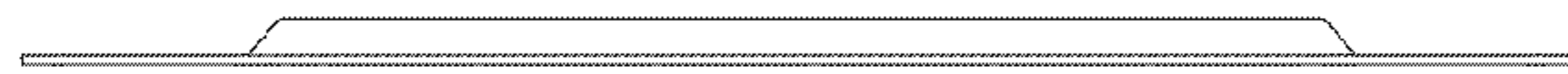

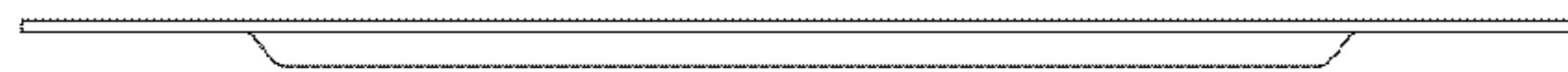

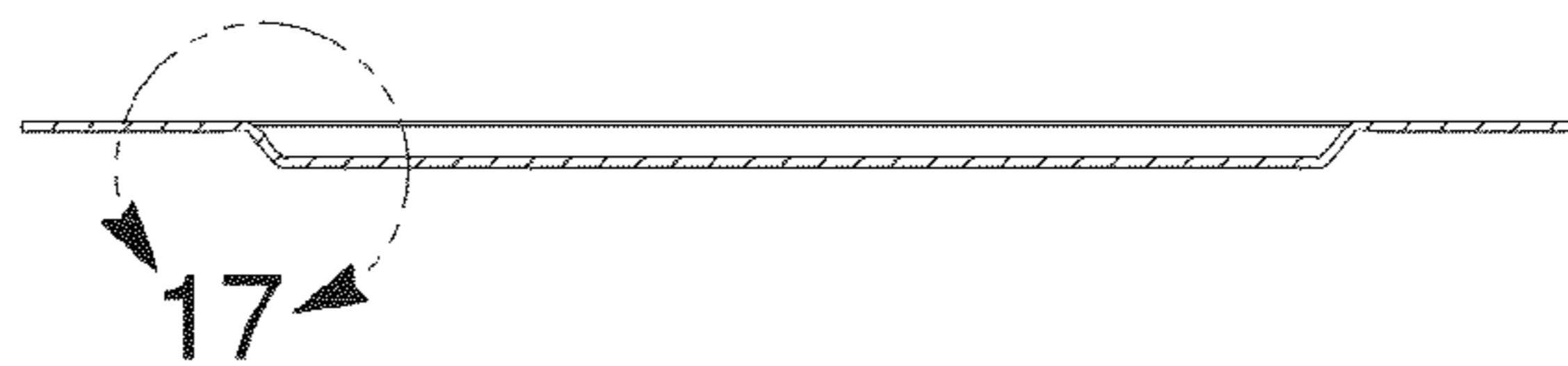

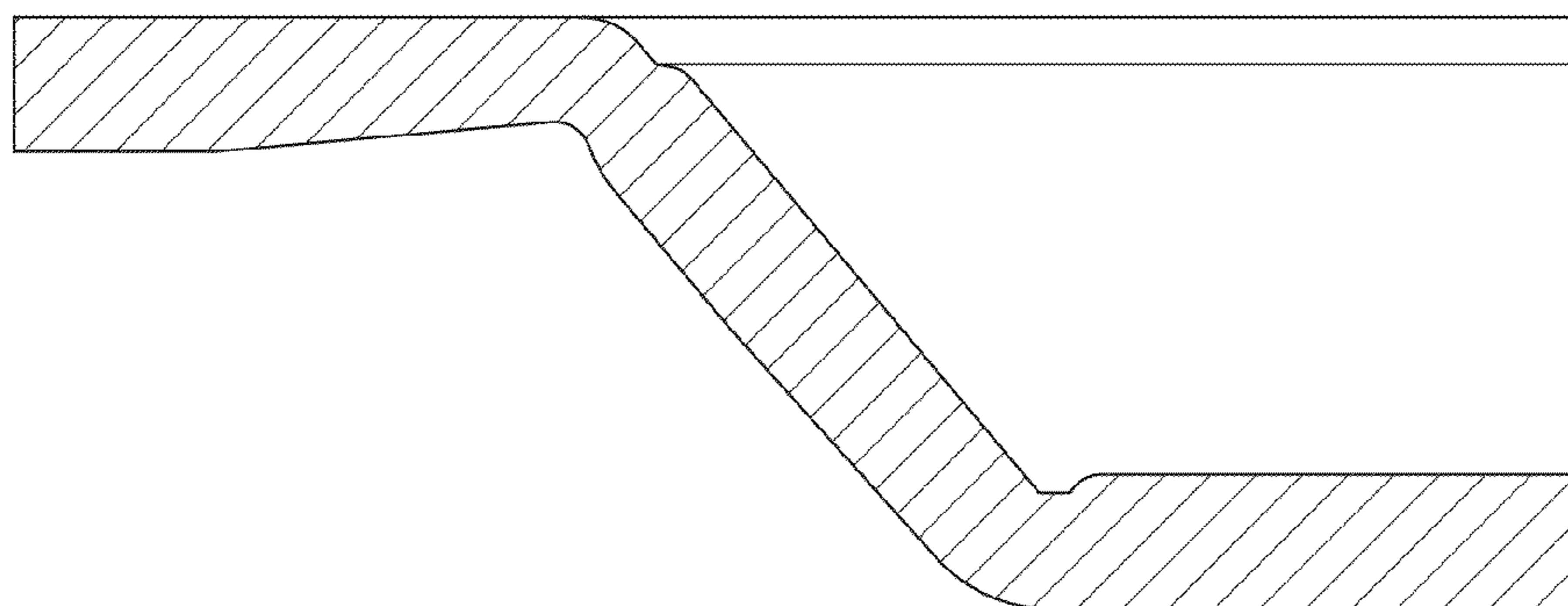

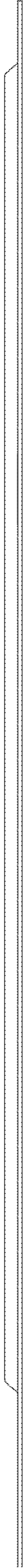
