(57) **CLAIM**

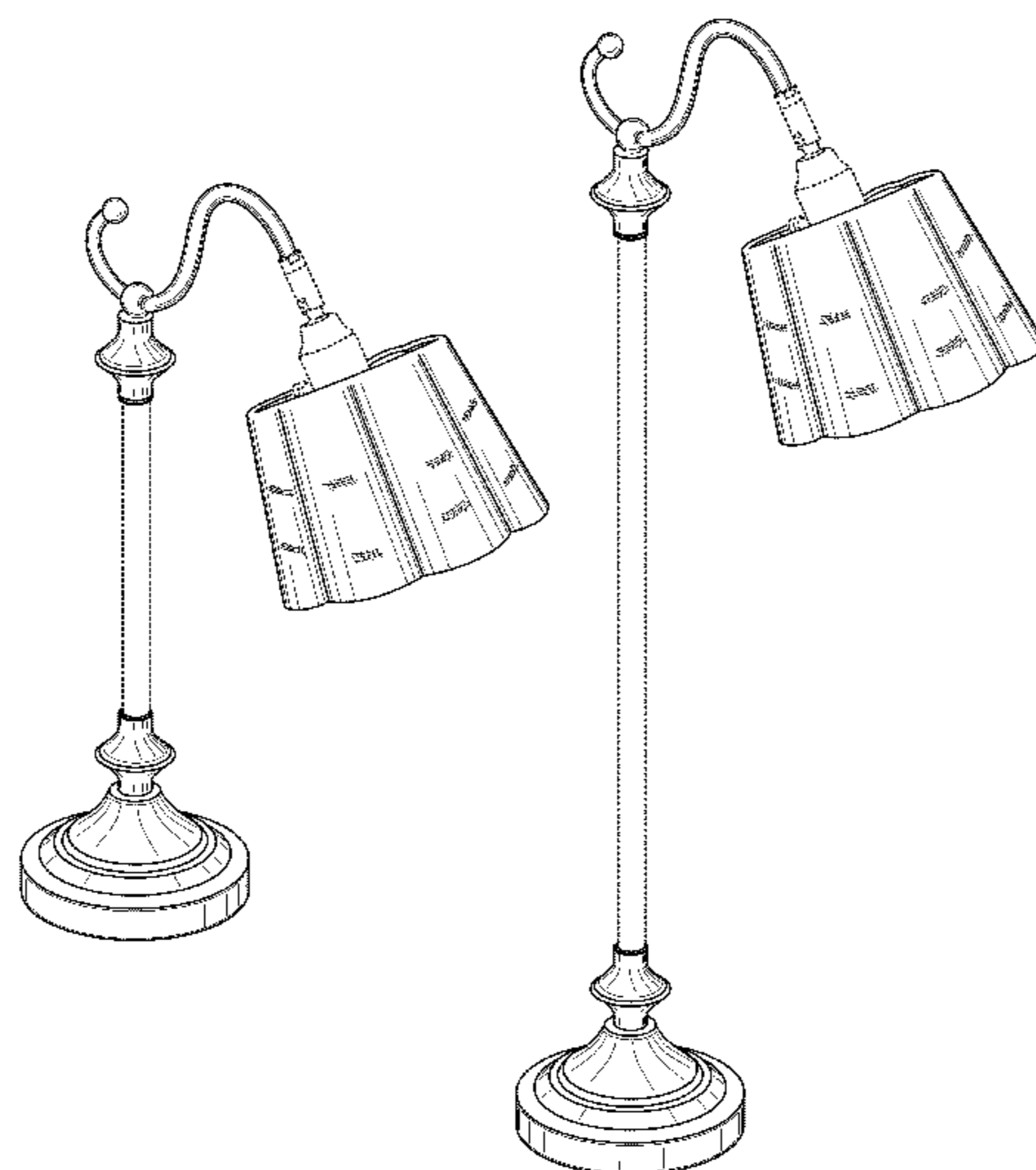
The ornamental design for a lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lamp showing our new design;
FIG. 2 is a side view thereof, the opposing side being a mirror image;
FIG. 3 is a front view thereof;
FIG. 4 is a back view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a perspective view of a second embodiment thereof;
FIG. 8 is a side view of FIG. 7, the opposing side being a mirror image;
FIG. 9 is a front view of FIG. 7;
FIG. 10 is a back view of FIG. 7;
FIG. 11 is a top view of FIG. 7; and,

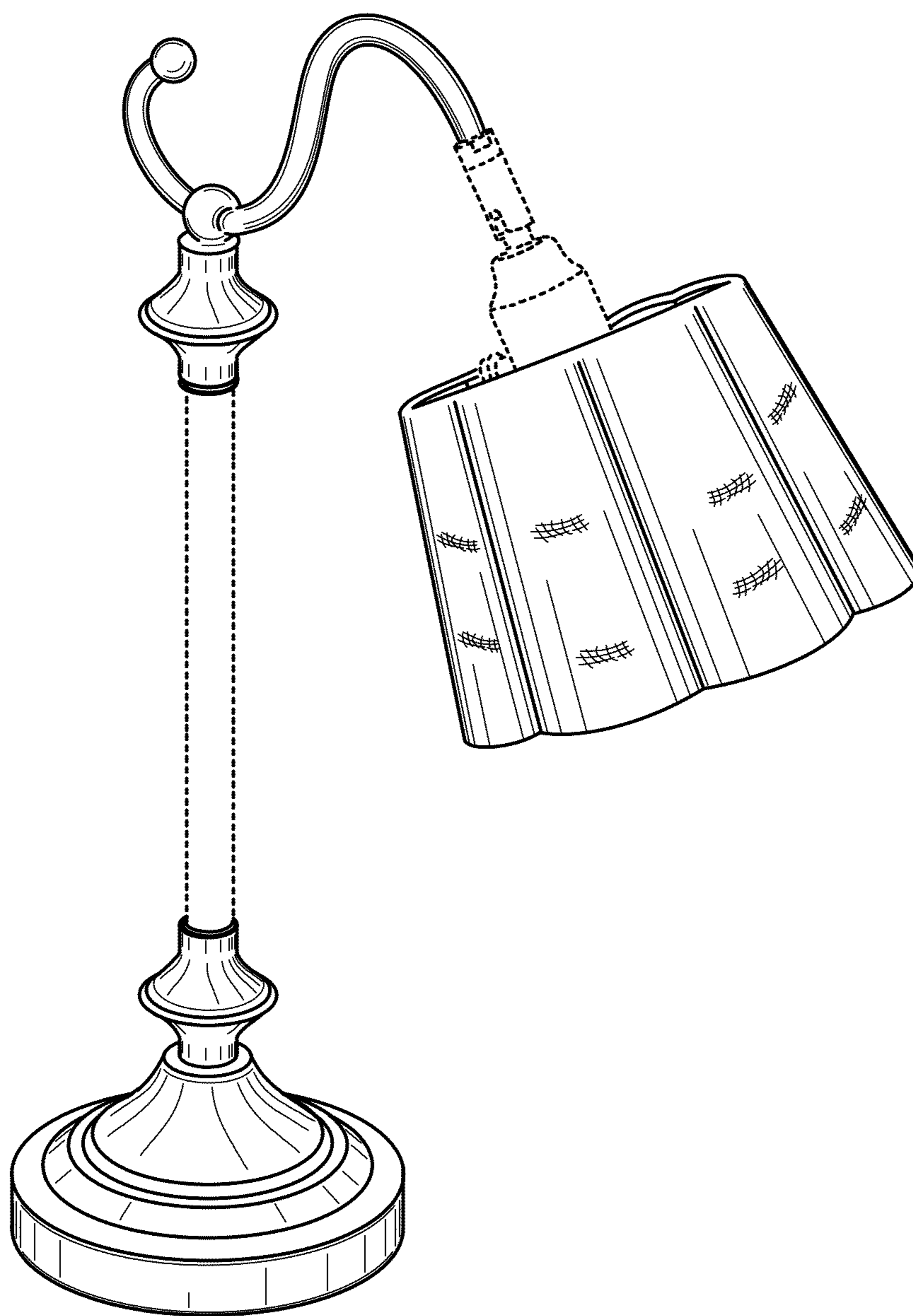

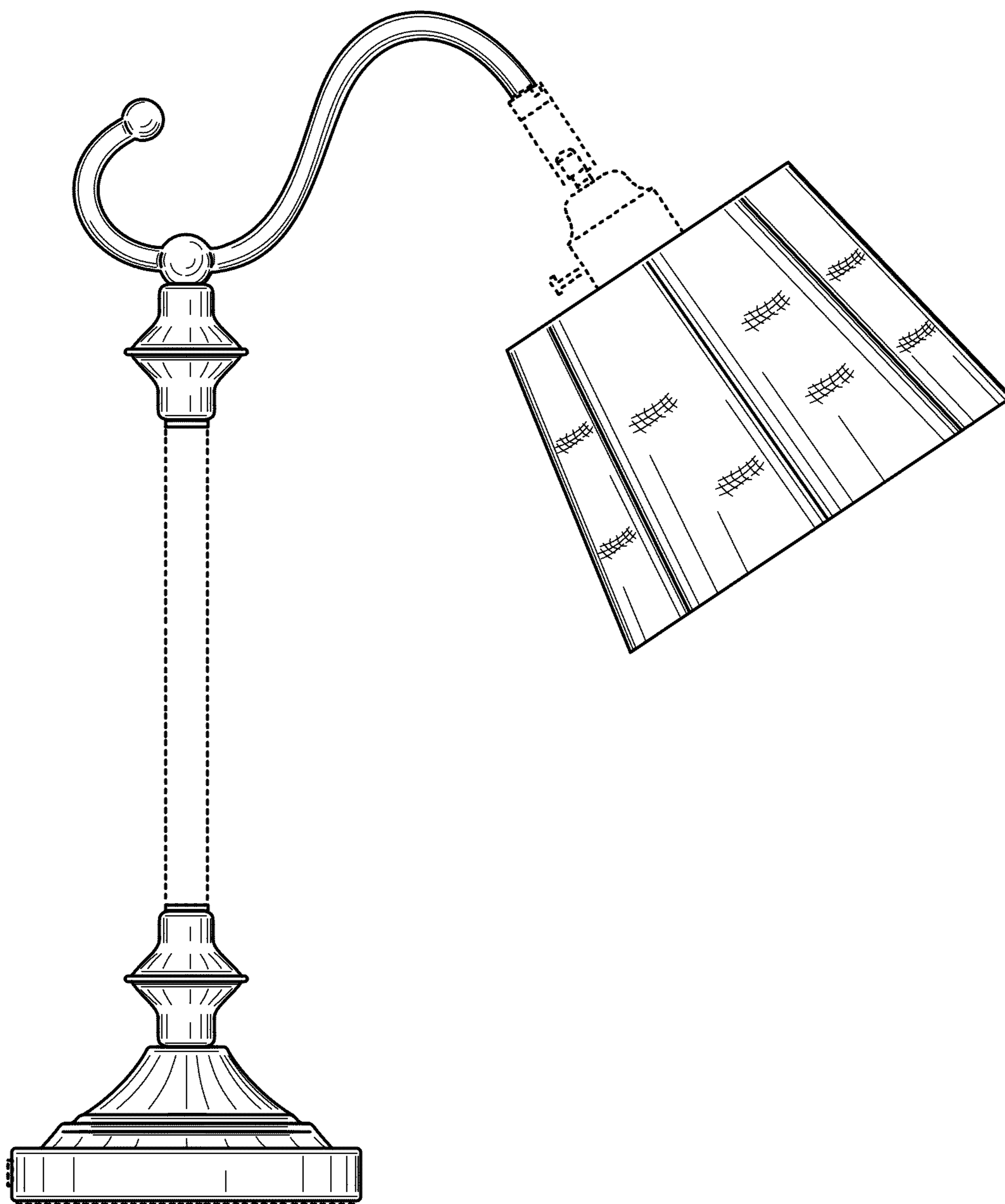

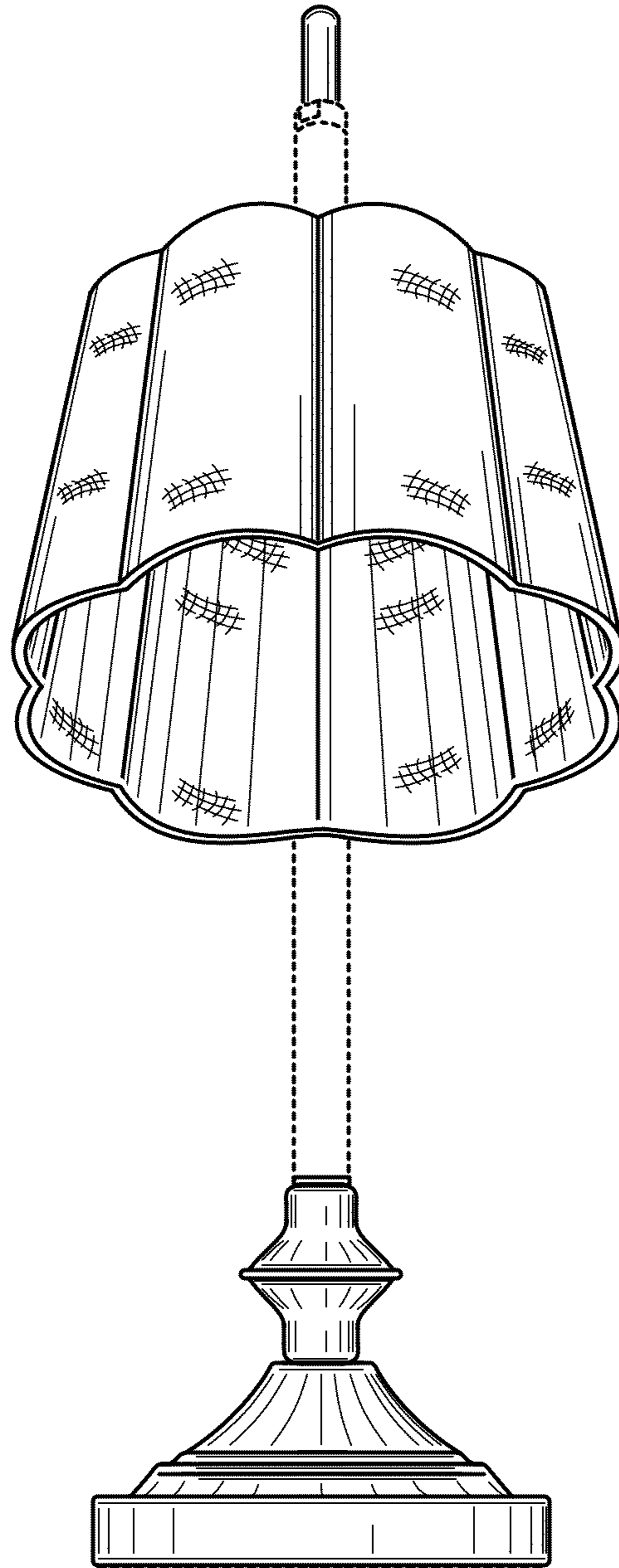

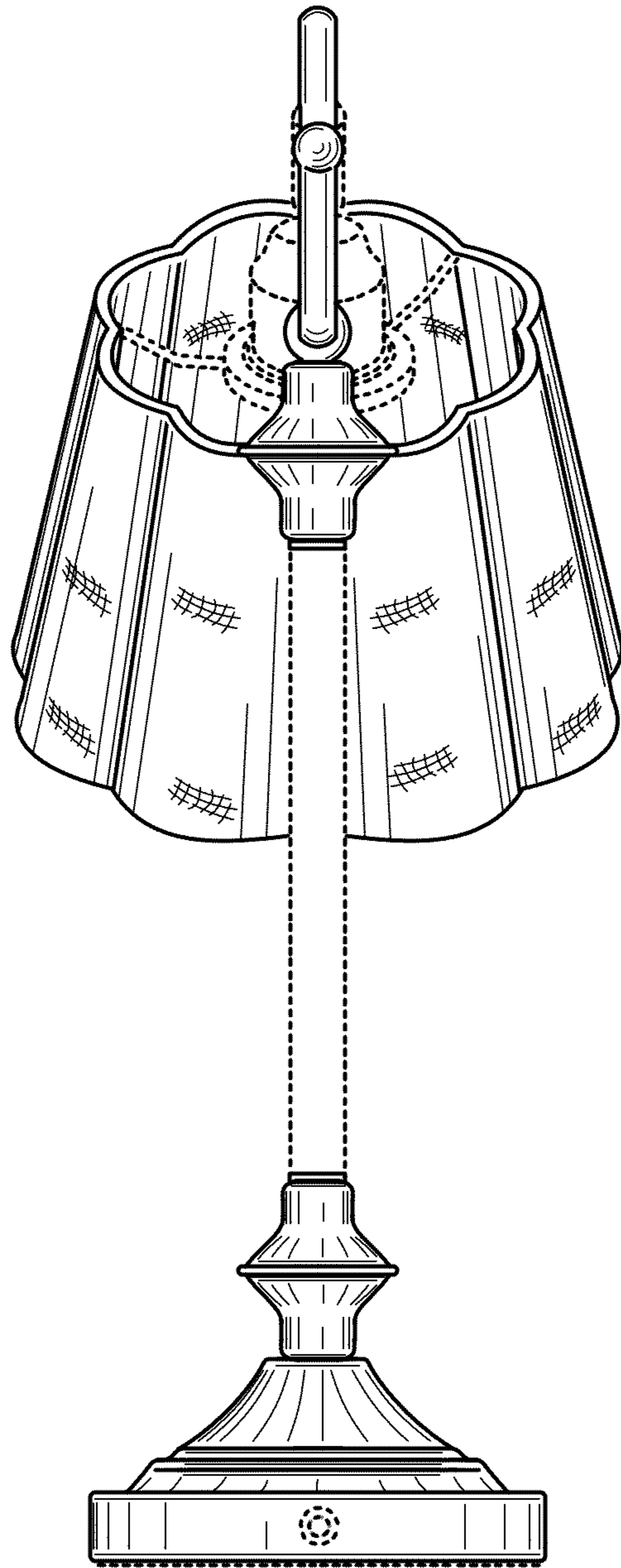

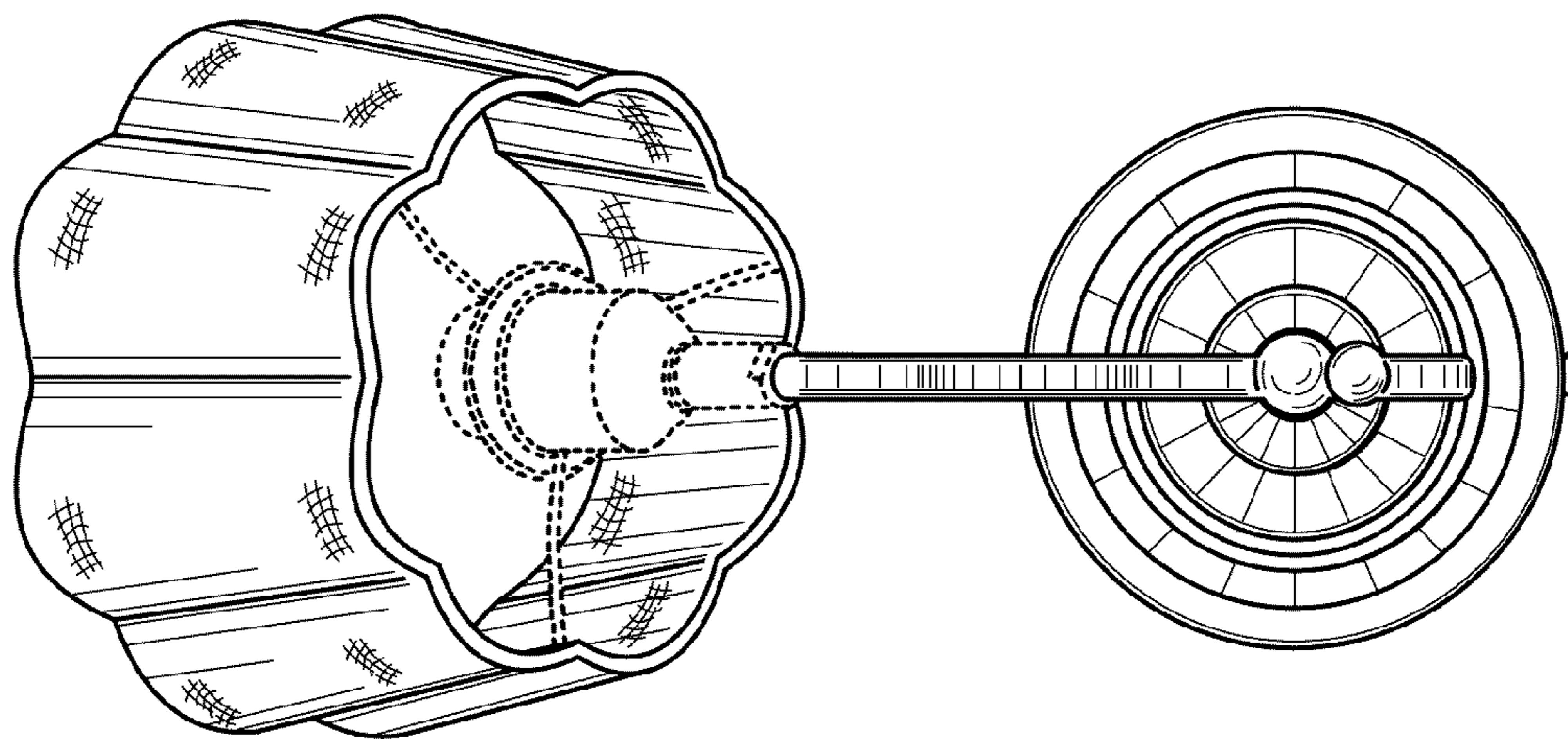

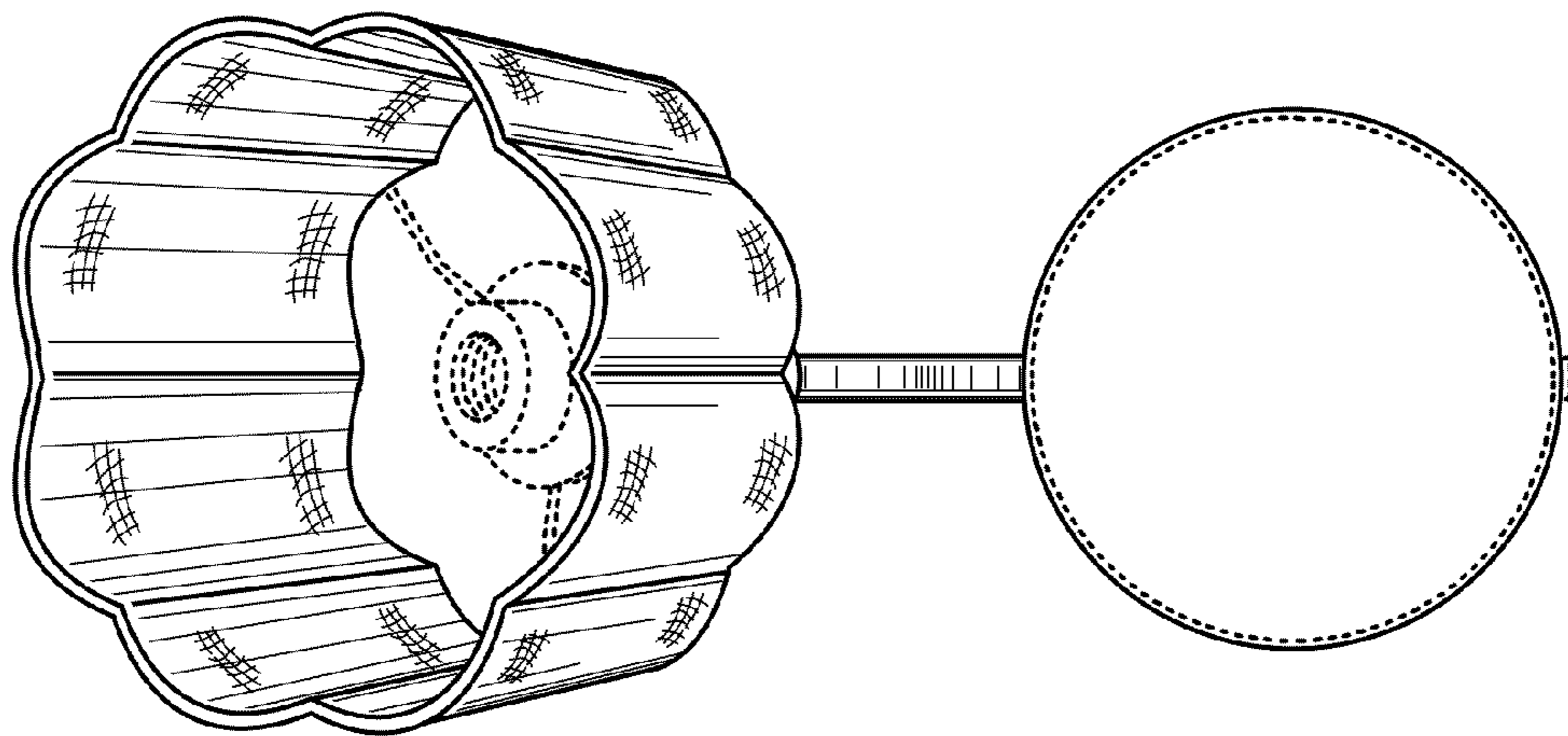

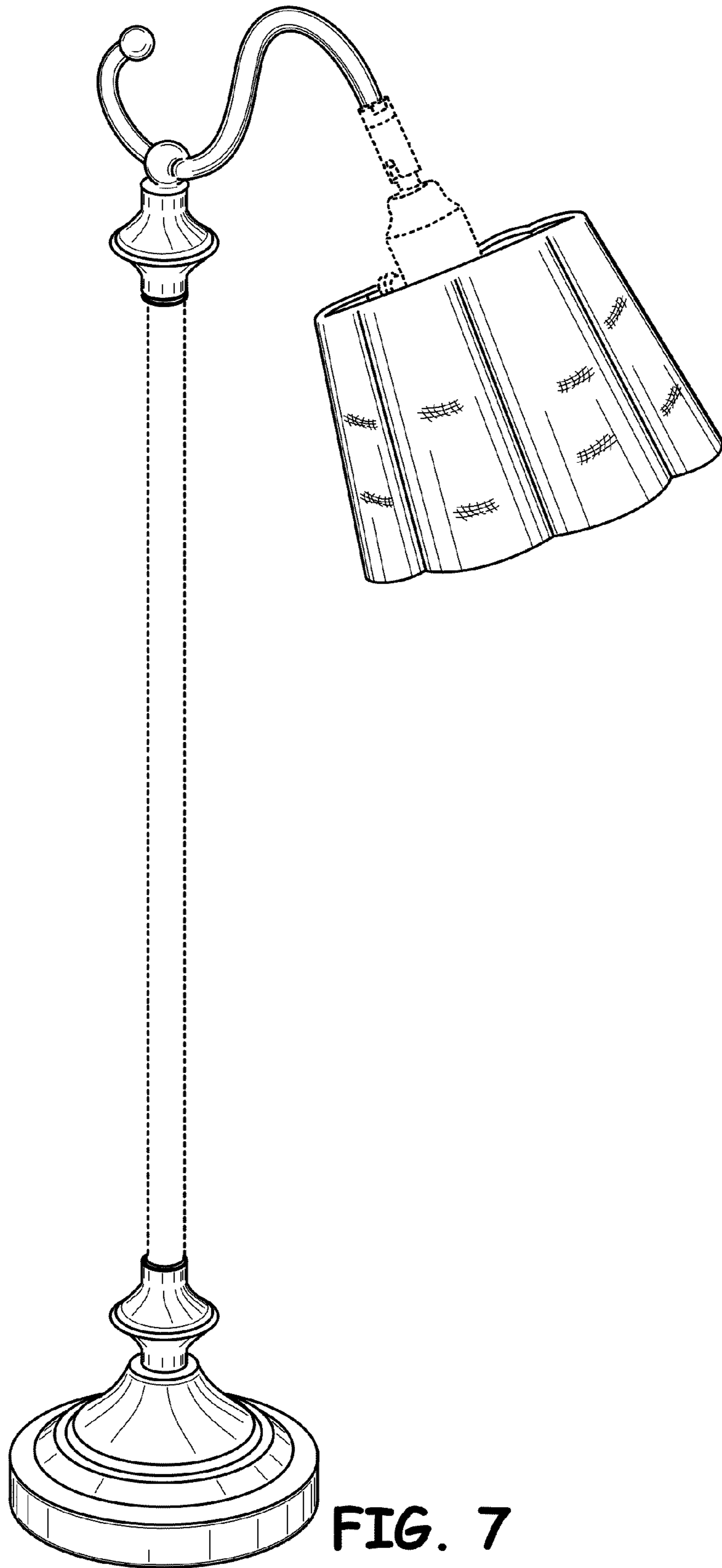

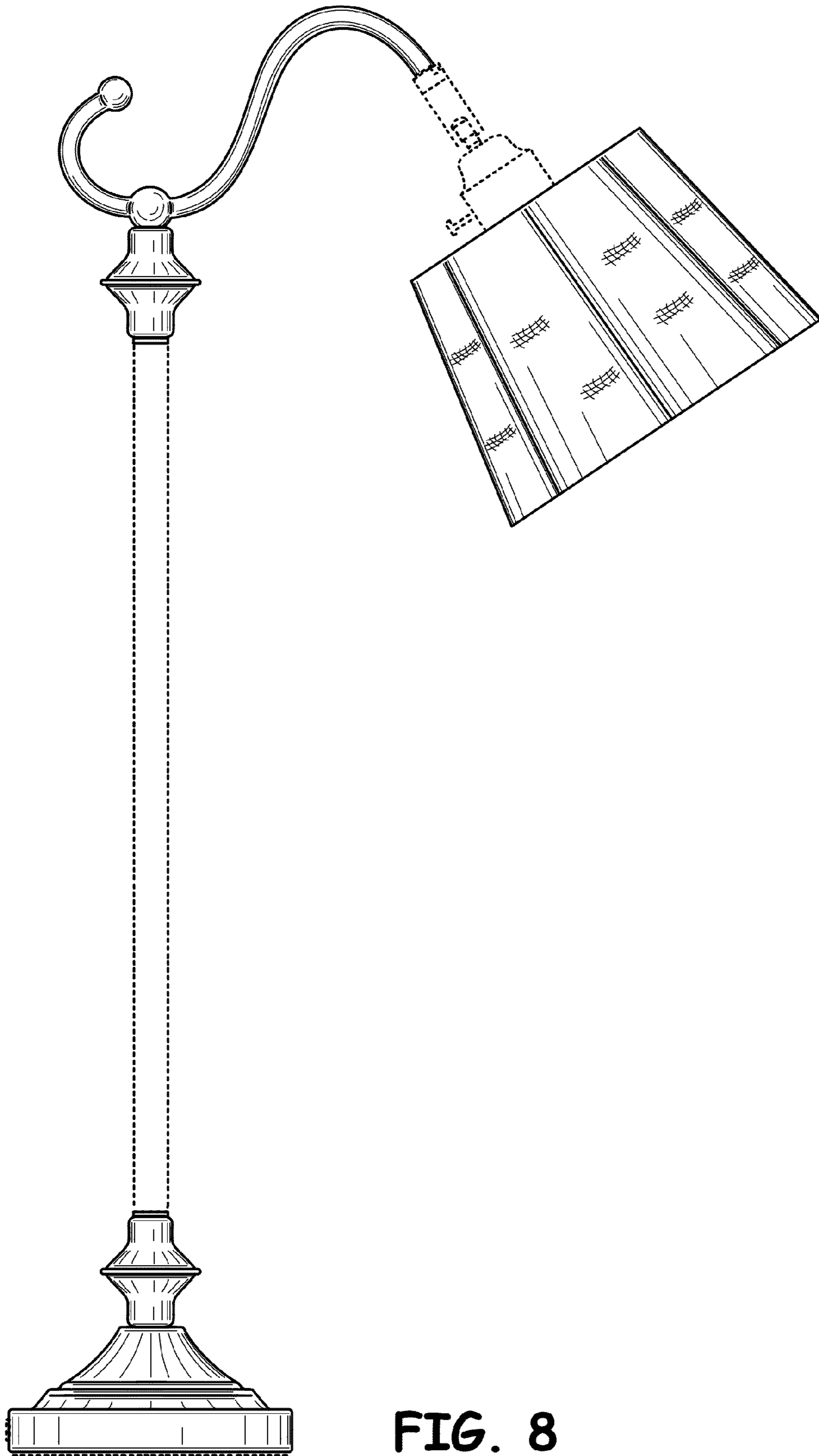

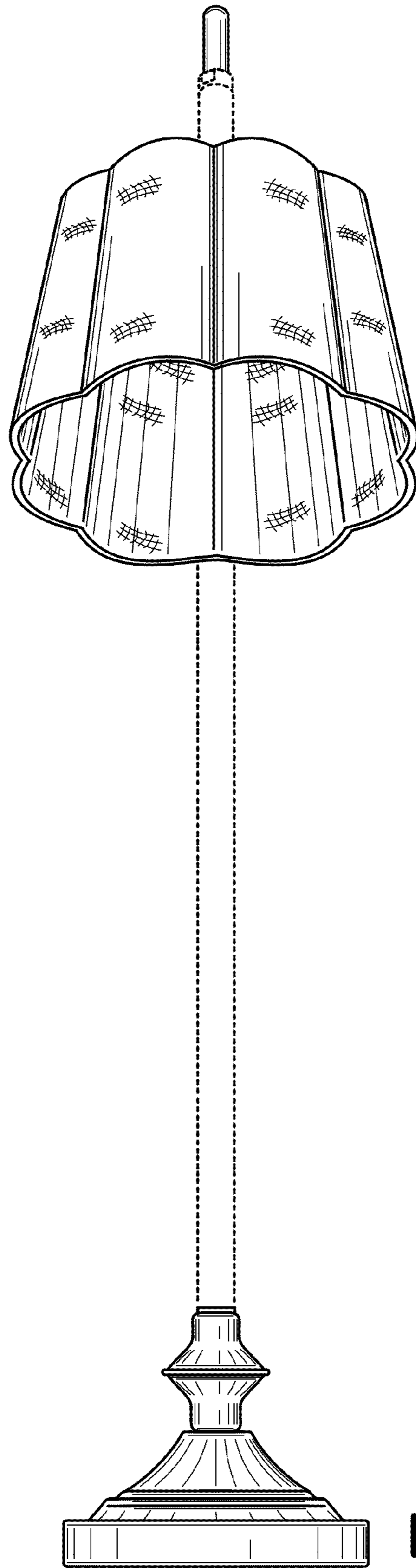

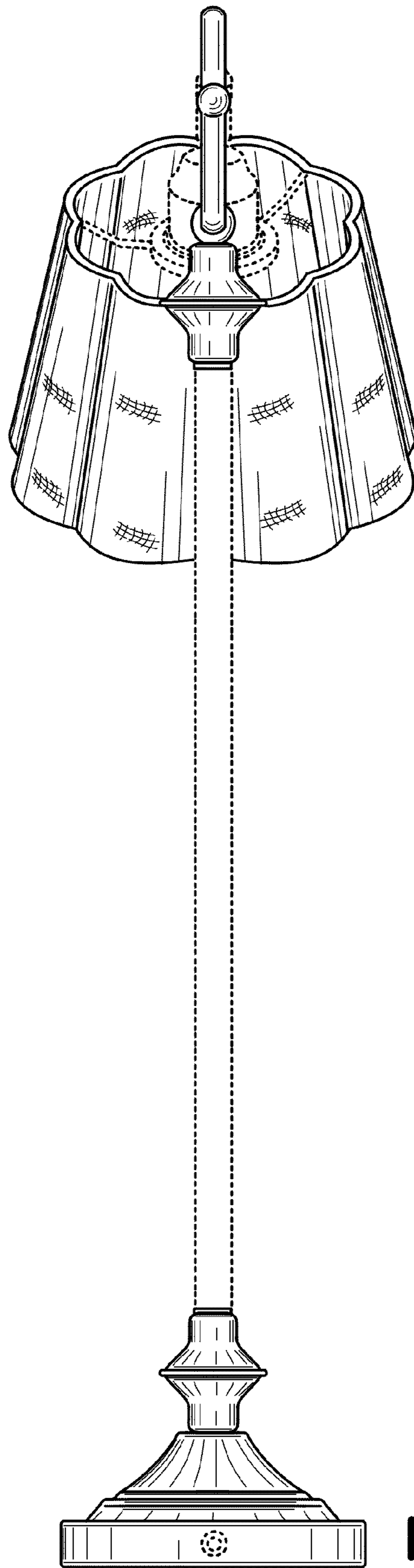

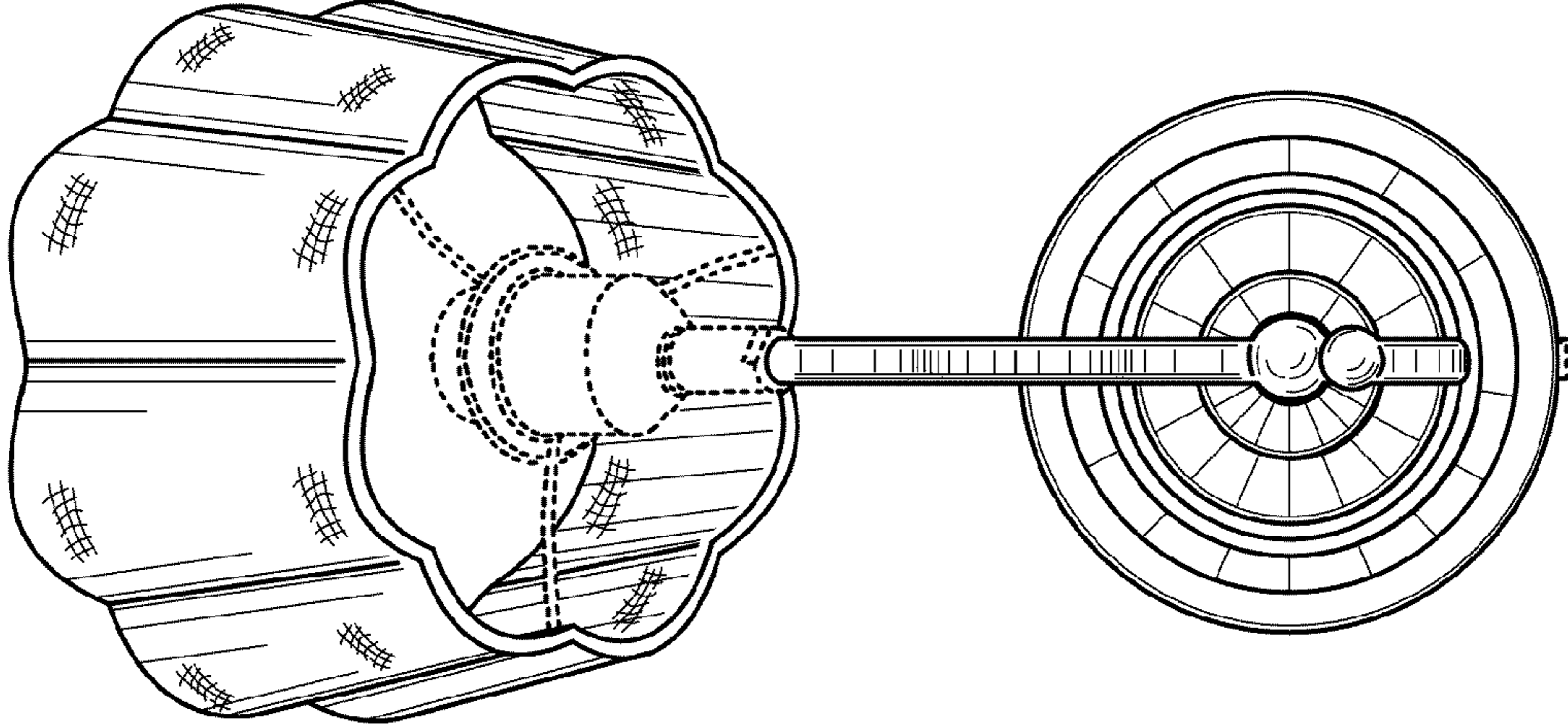

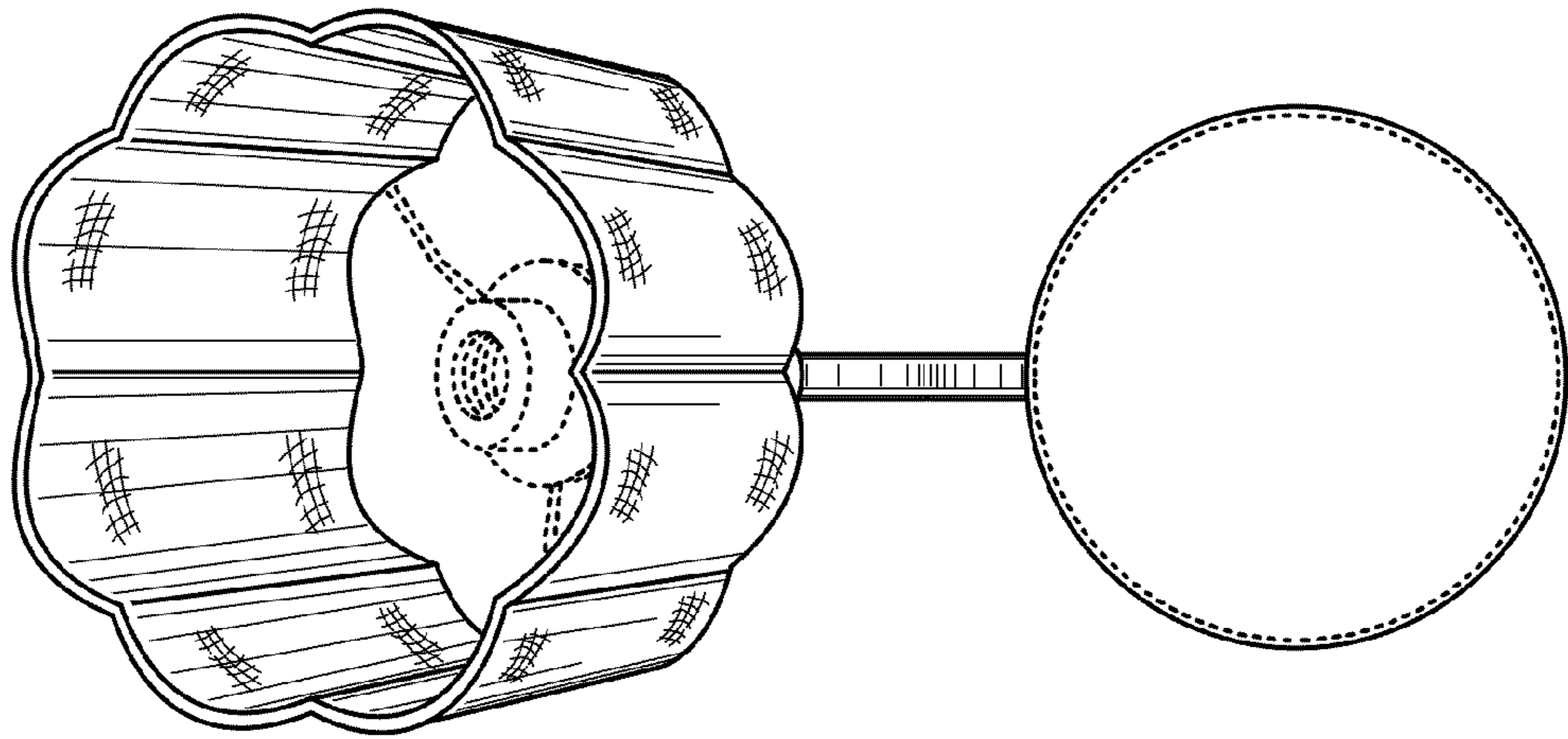
