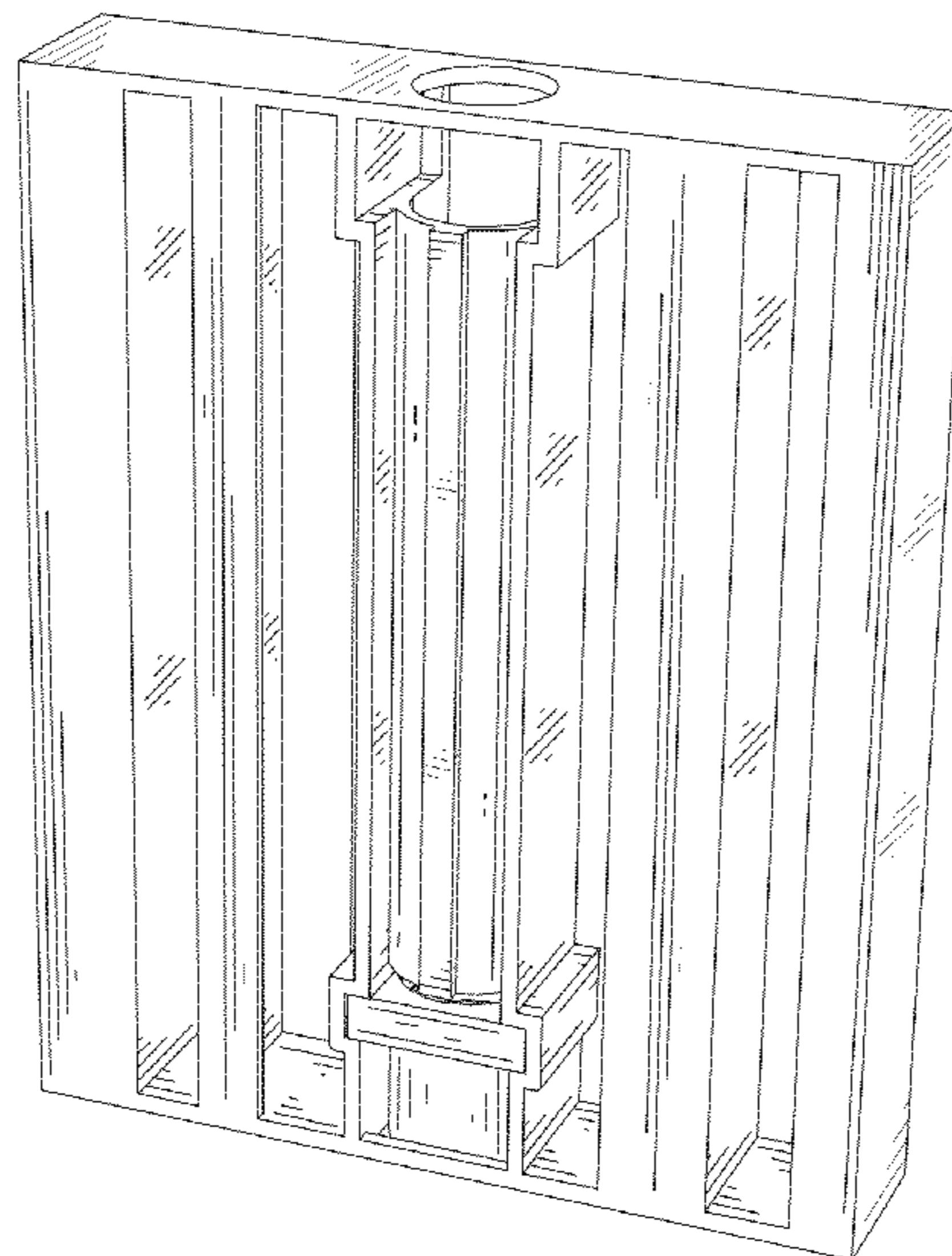
(57) **CLAIM**

The ornamental design for a “frame of electronic cigarette case,” as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a frame of electronic cigarette case showing my new design;  
FIG. 2 is a rear, top and left side perspective view of FIG. 1;  
FIG. 3 is a front elevational view of FIG. 1;  
FIG. 4 is a rear elevational view of FIG. 1;  
FIG. 5 is a left side elevational view of FIG. 1;  
FIG. 6 is a right side elevational view of FIG. 1;  
FIG. 7 is a top plan view of FIG. 1;  
FIG. 8 is a bottom plan view of FIG. 1; and,  
FIG. 9 is a rear, top and right side perspective view of FIG. 1 with an electronic cigarette therein.  
The broken lines shown in FIG. 9 depict an electronic cigarette that forms no part of the claimed design.

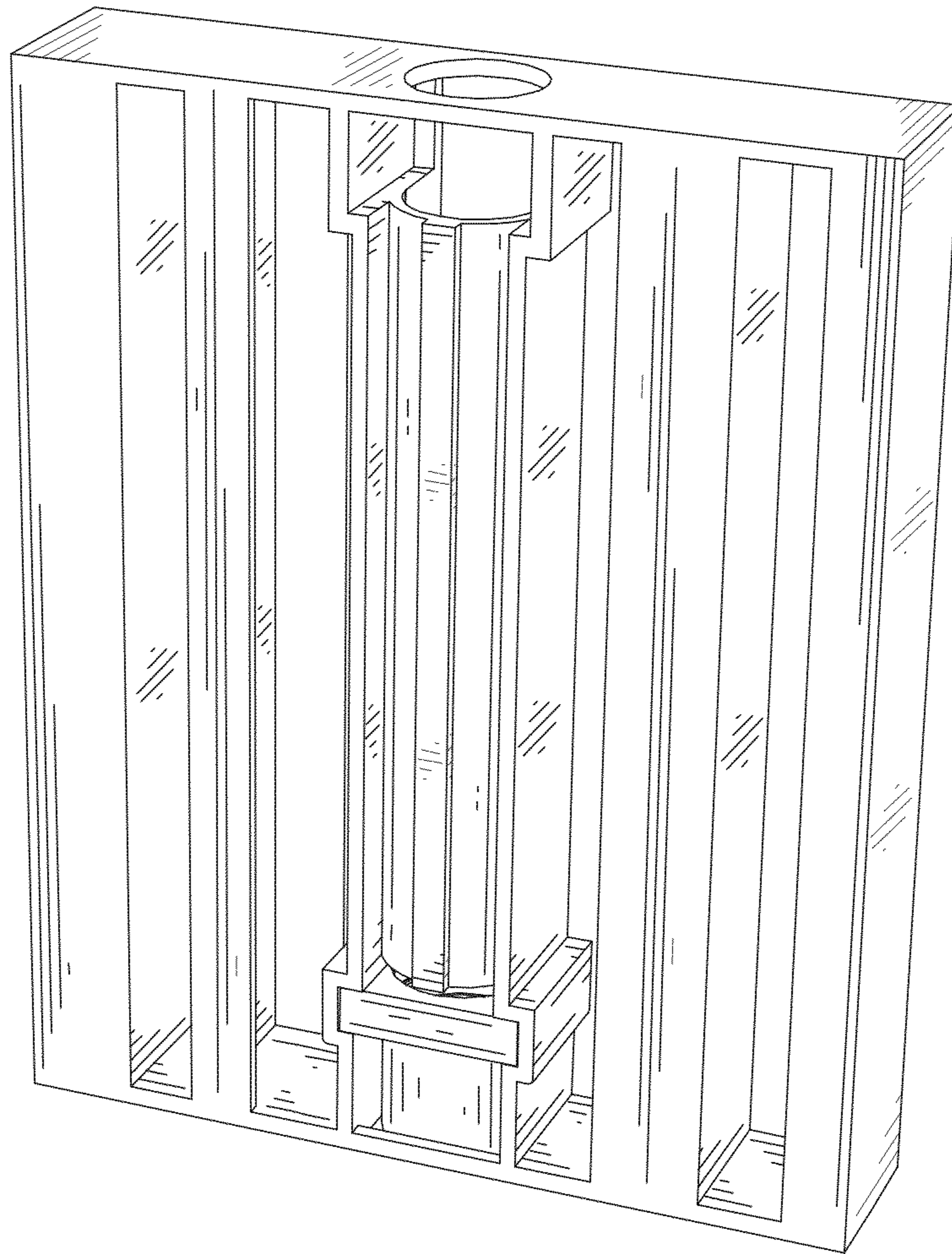

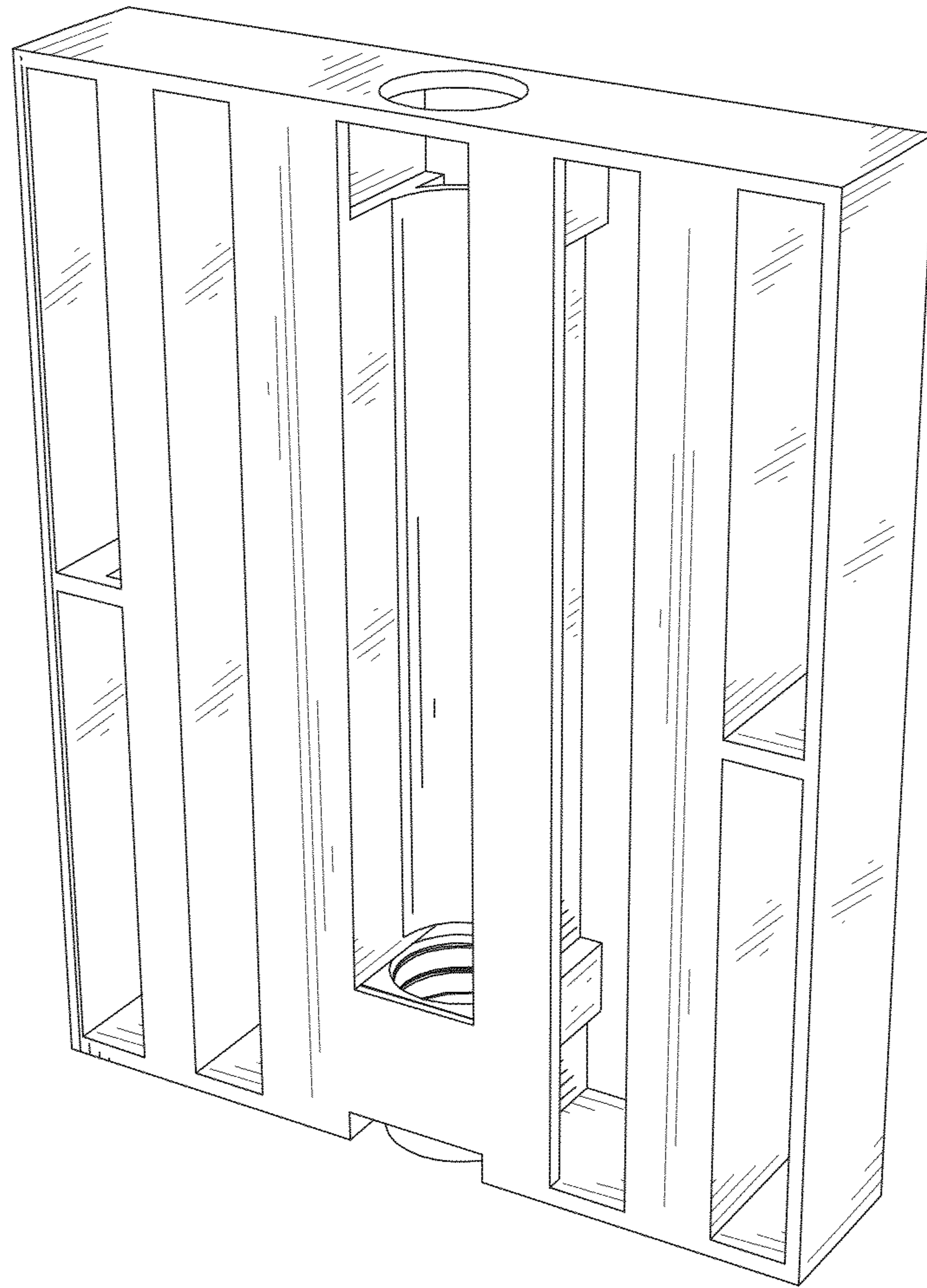

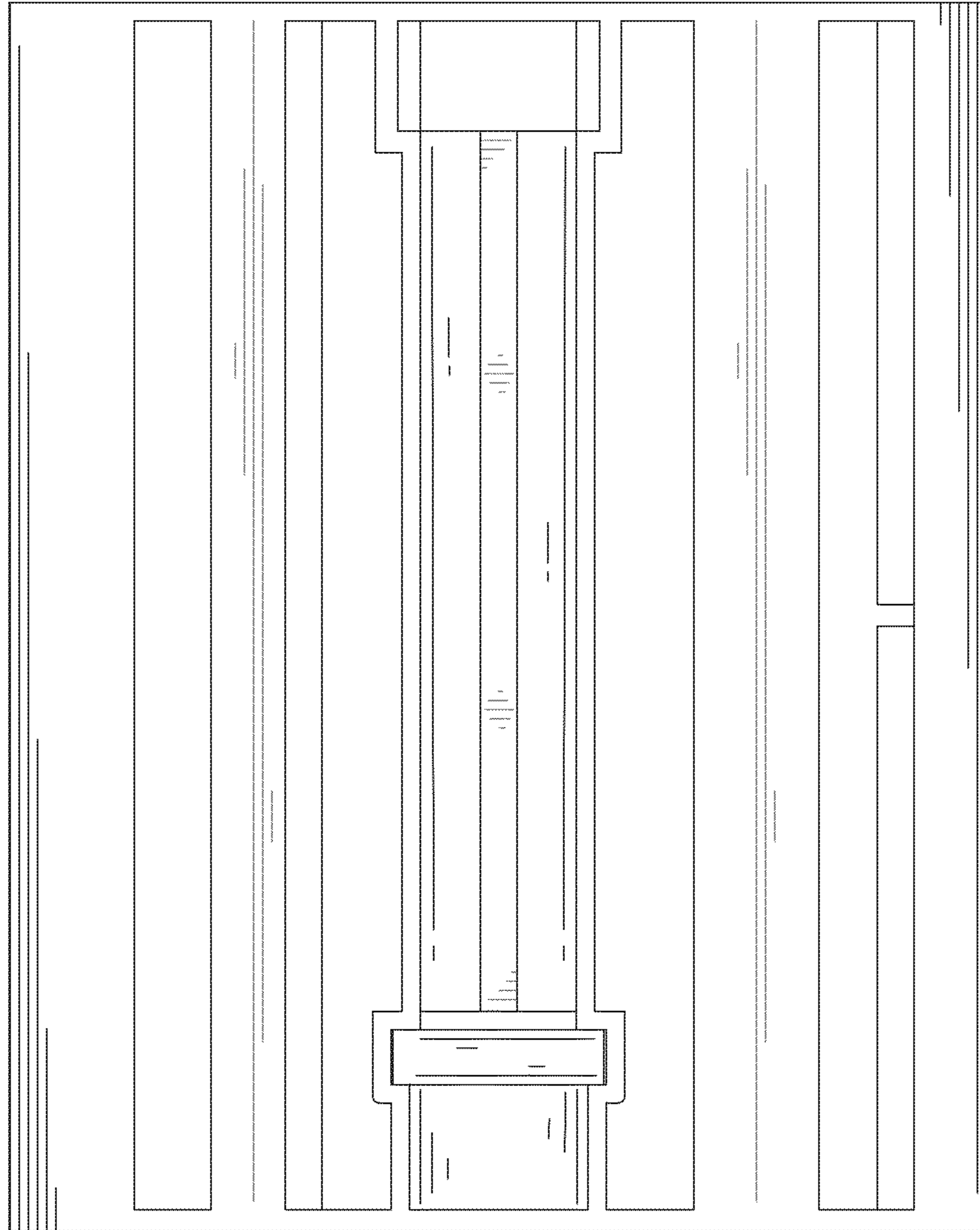

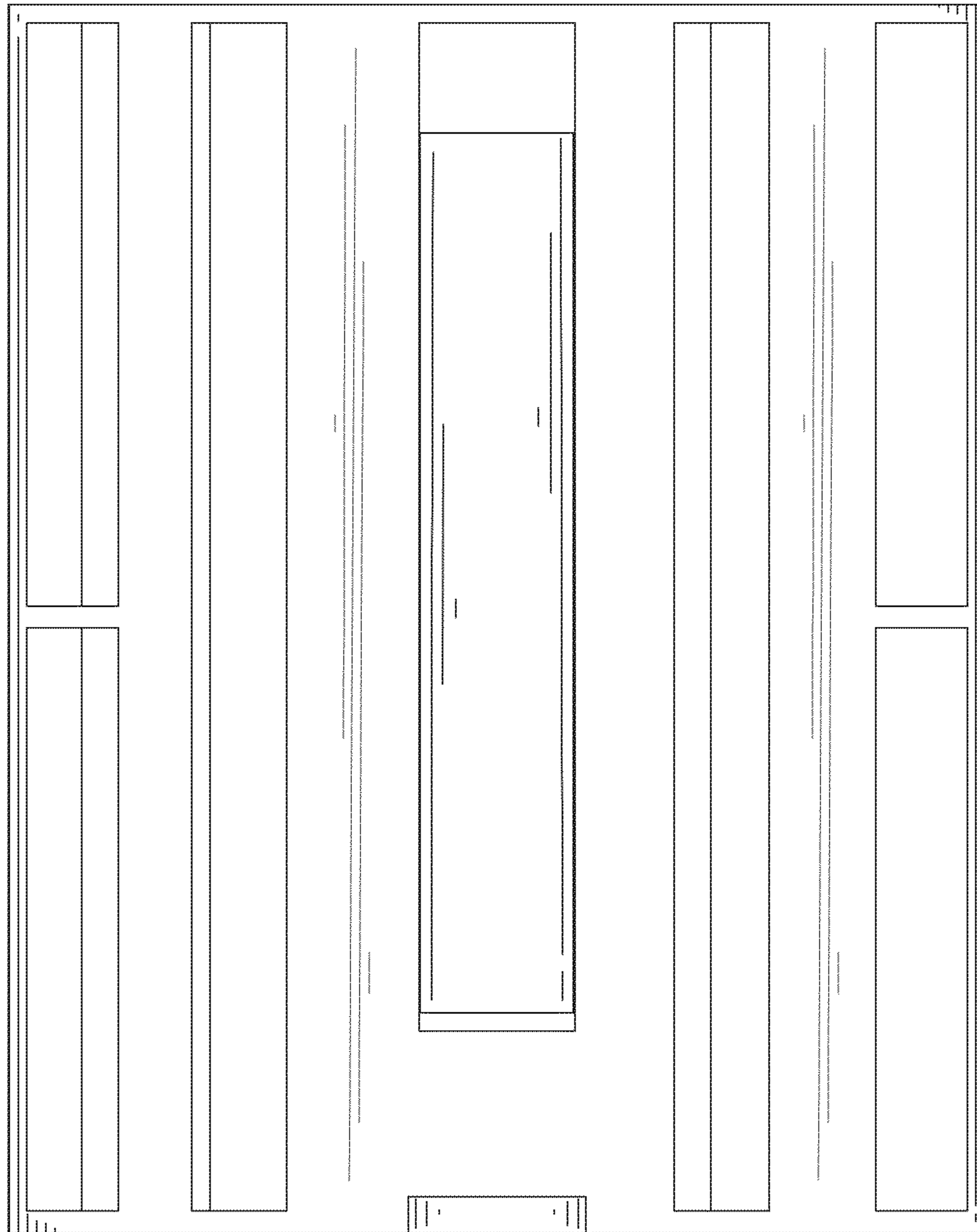

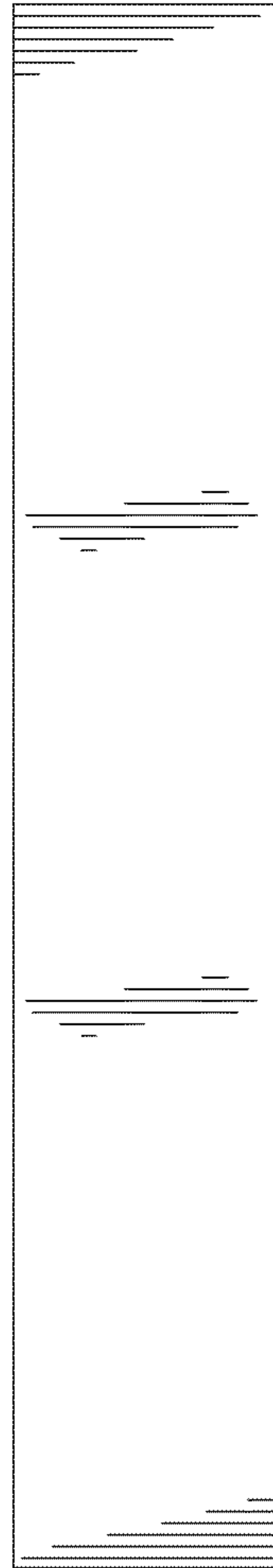

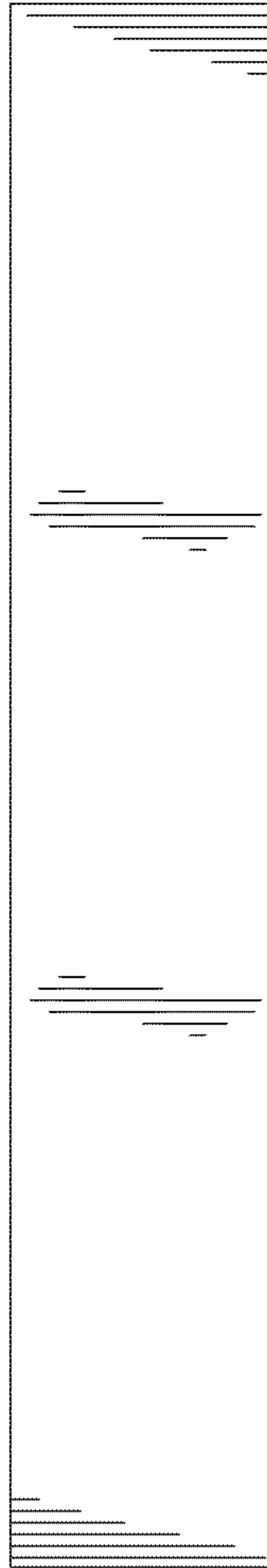

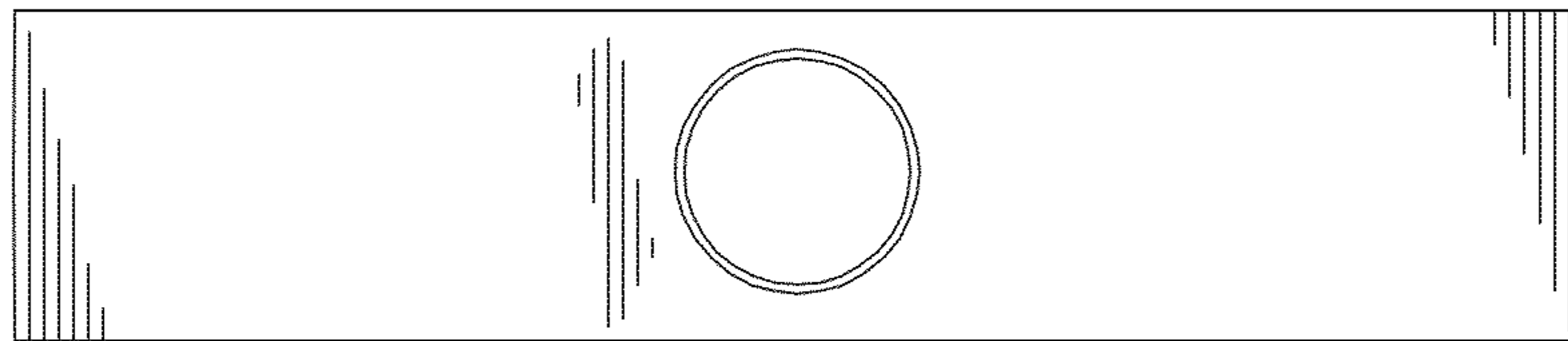

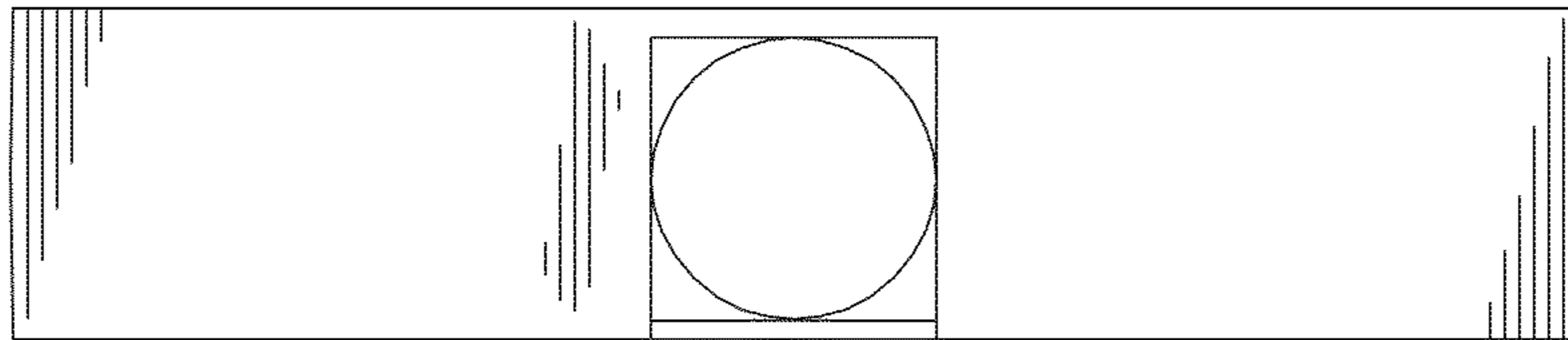

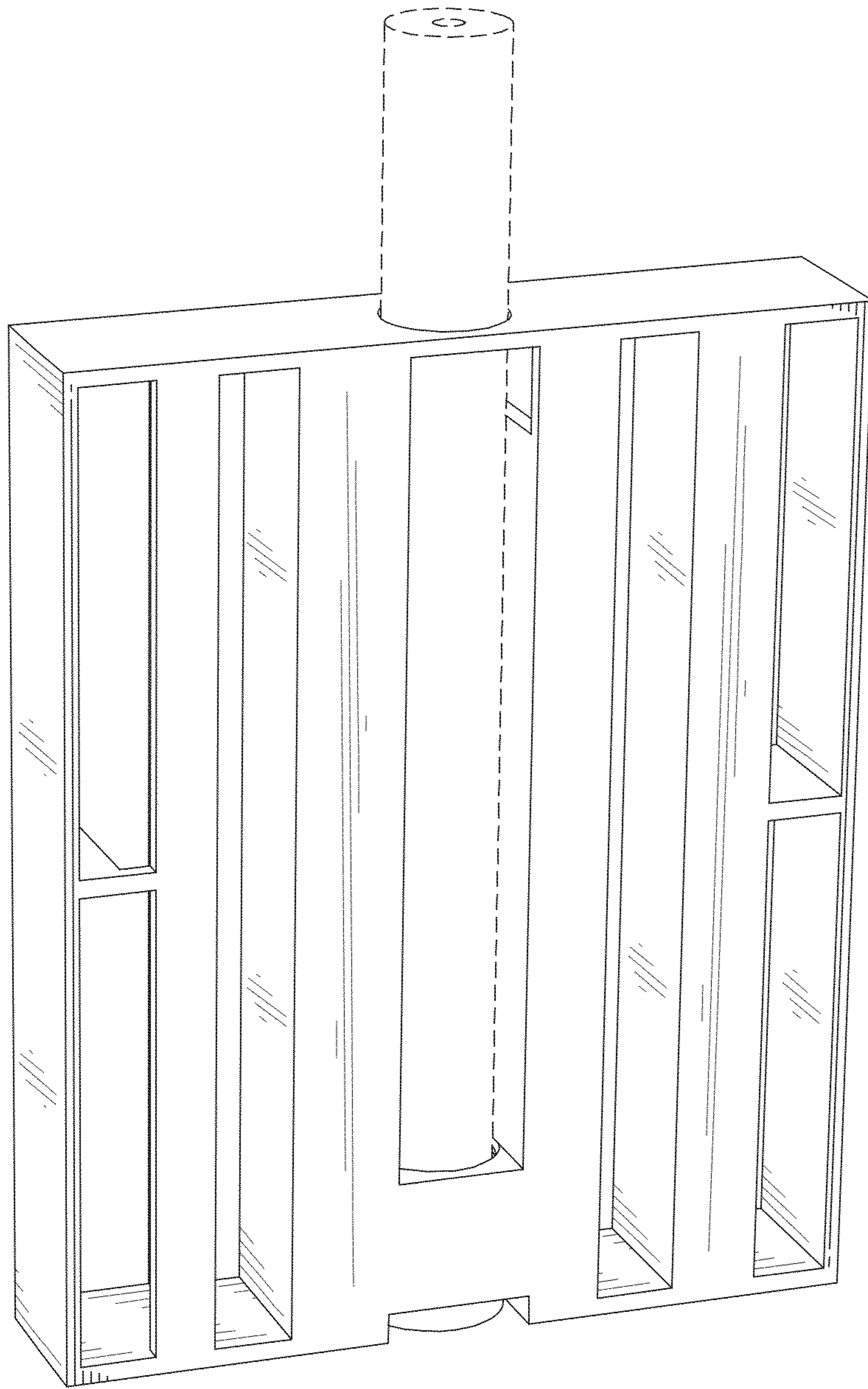
