The ornamental design for a cosmetic compact, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a cosmetic compact in accordance with the present design.

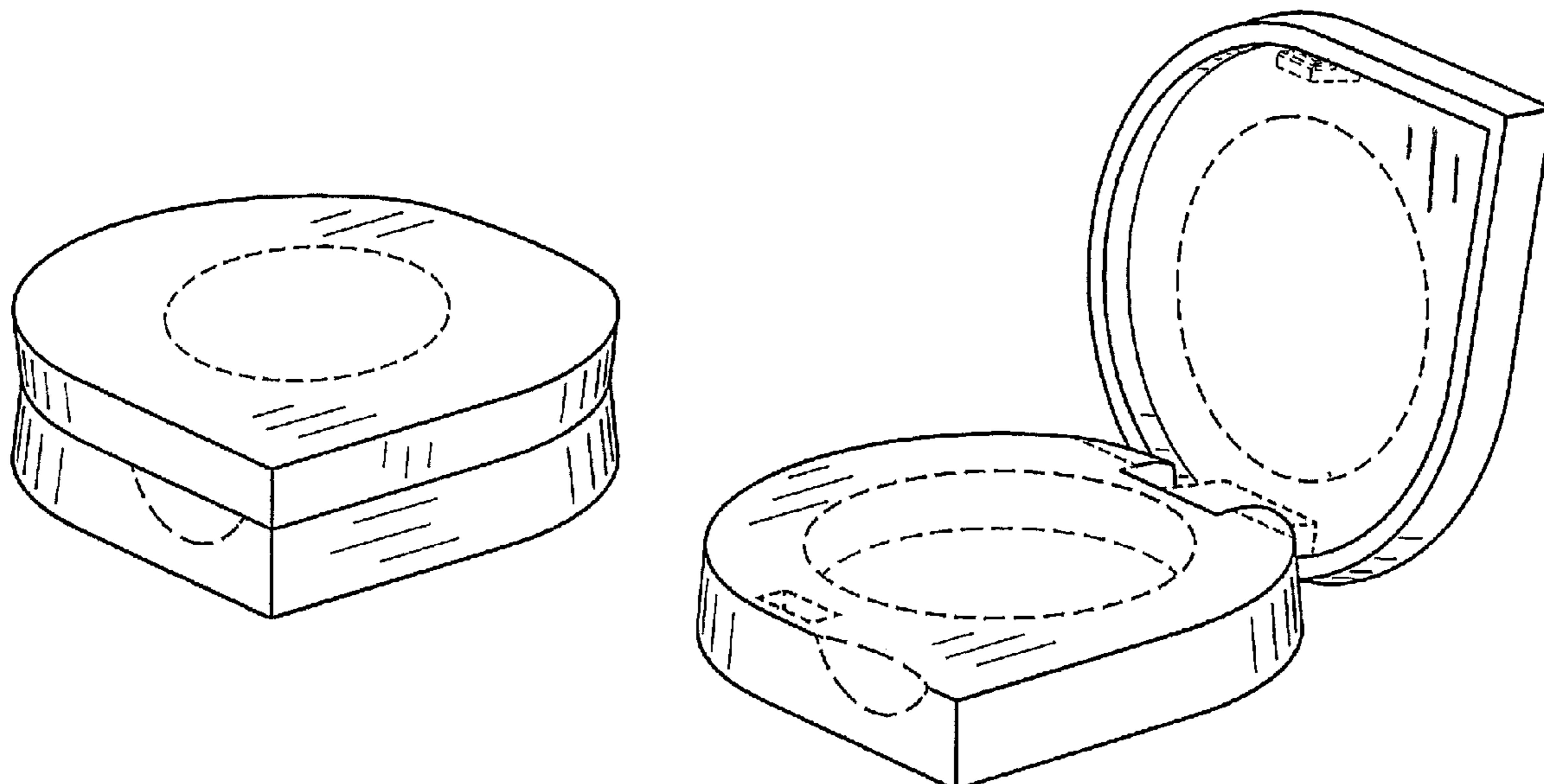

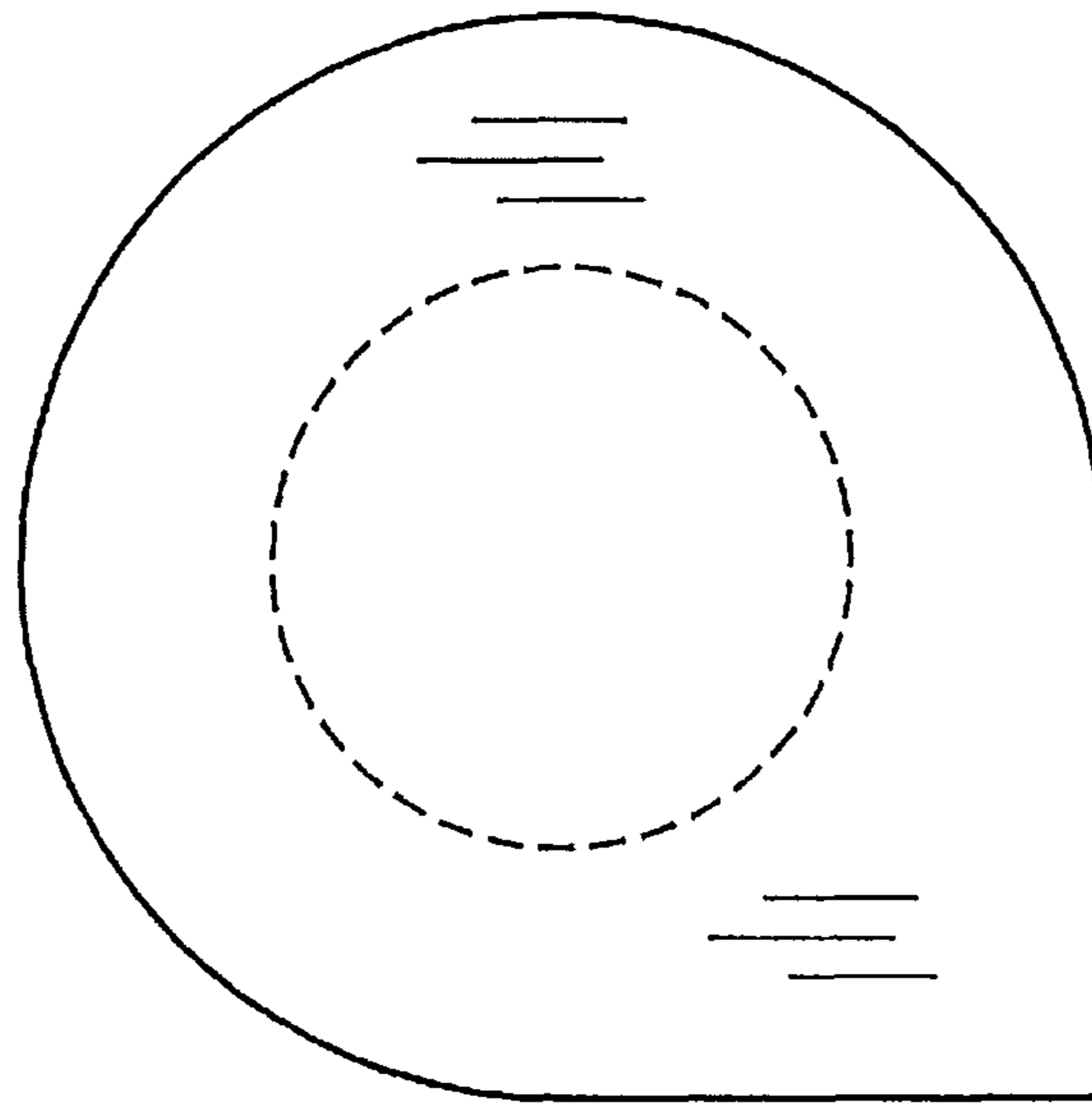

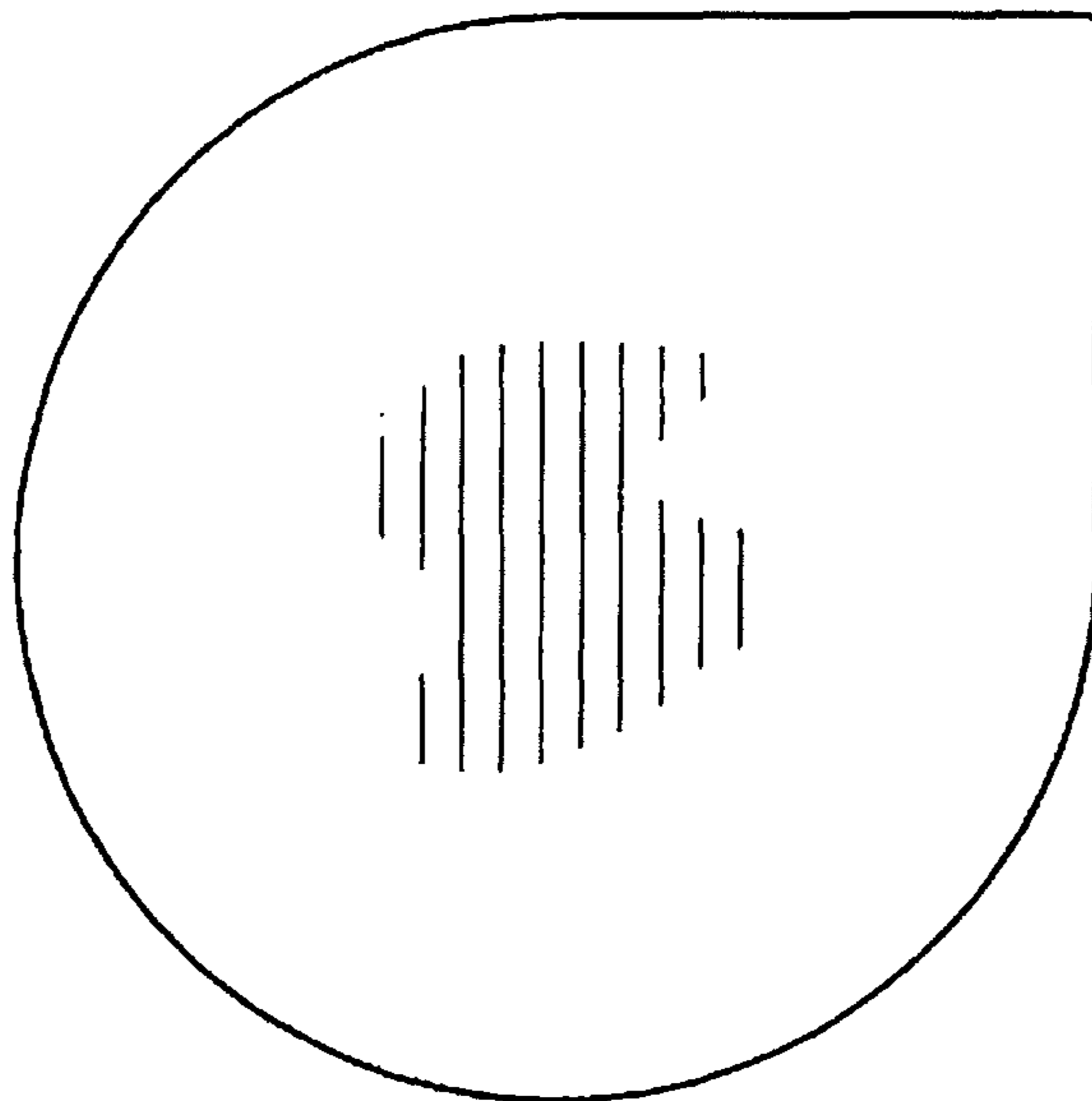

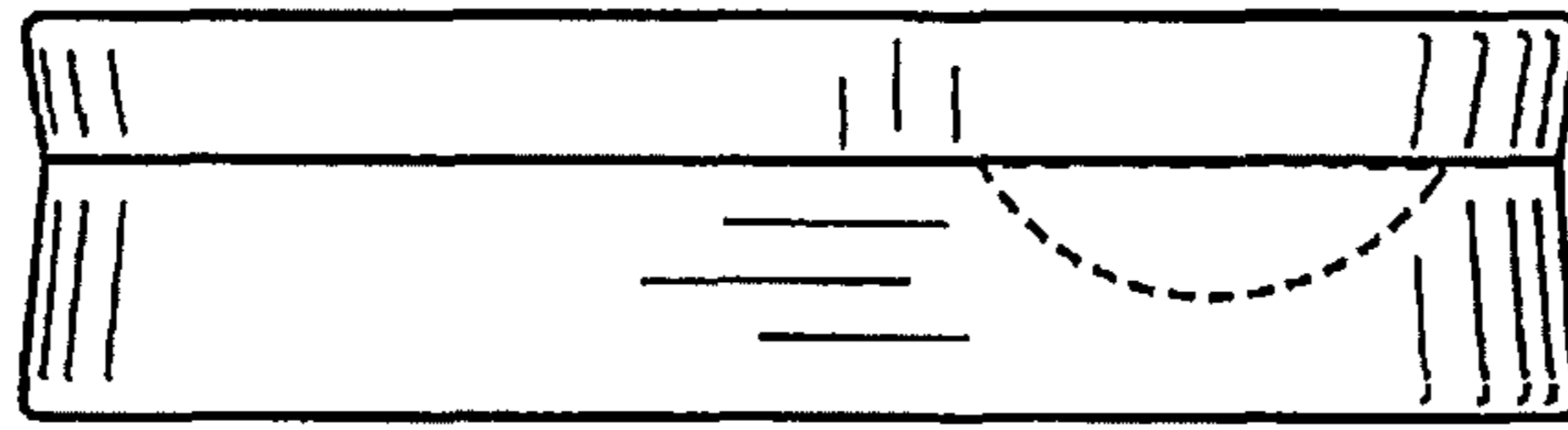

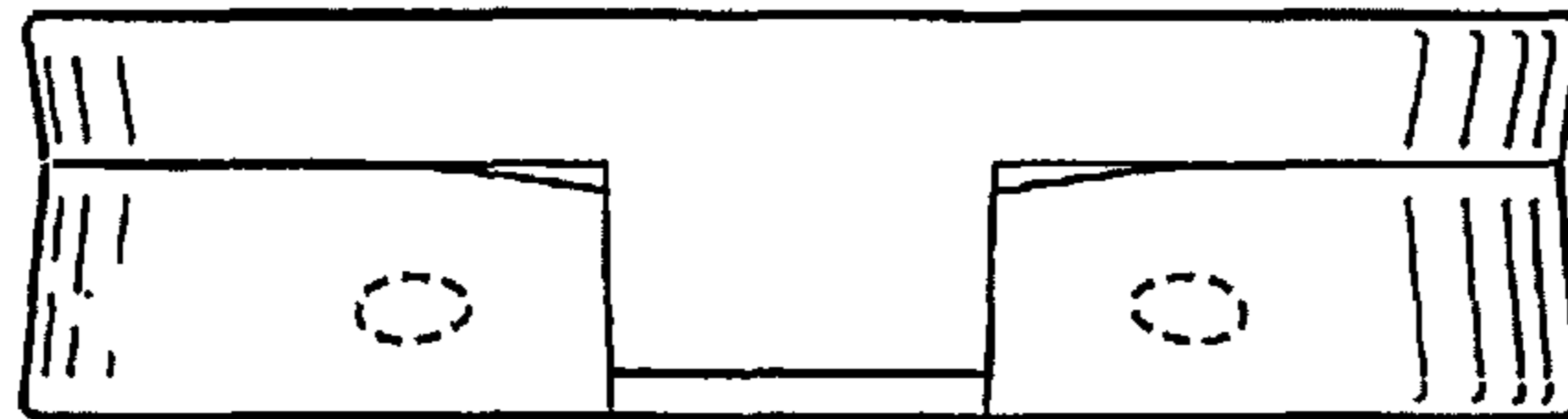

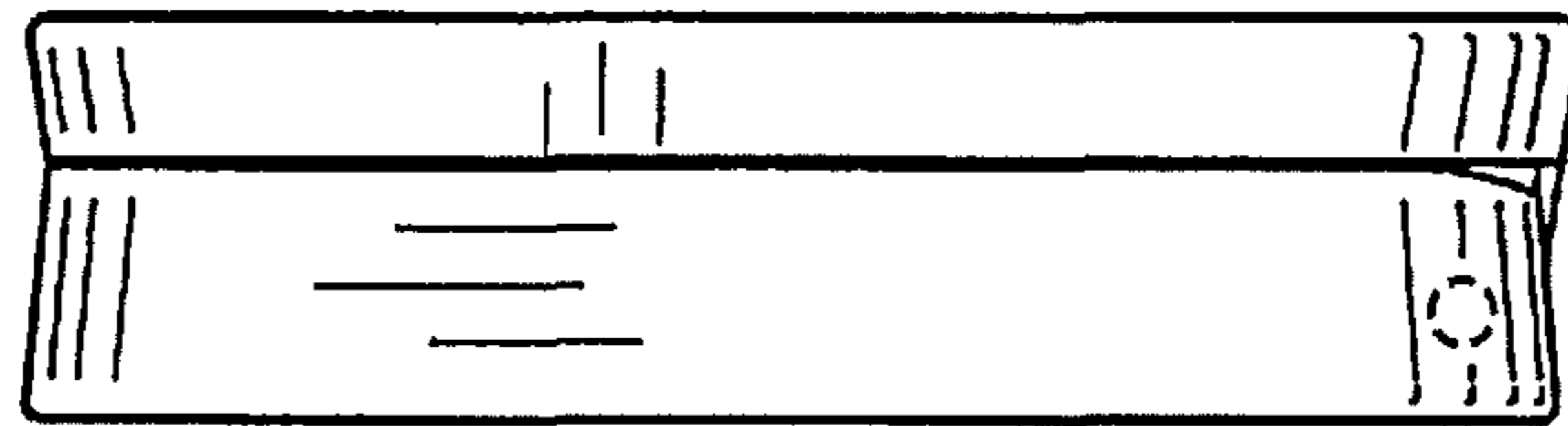

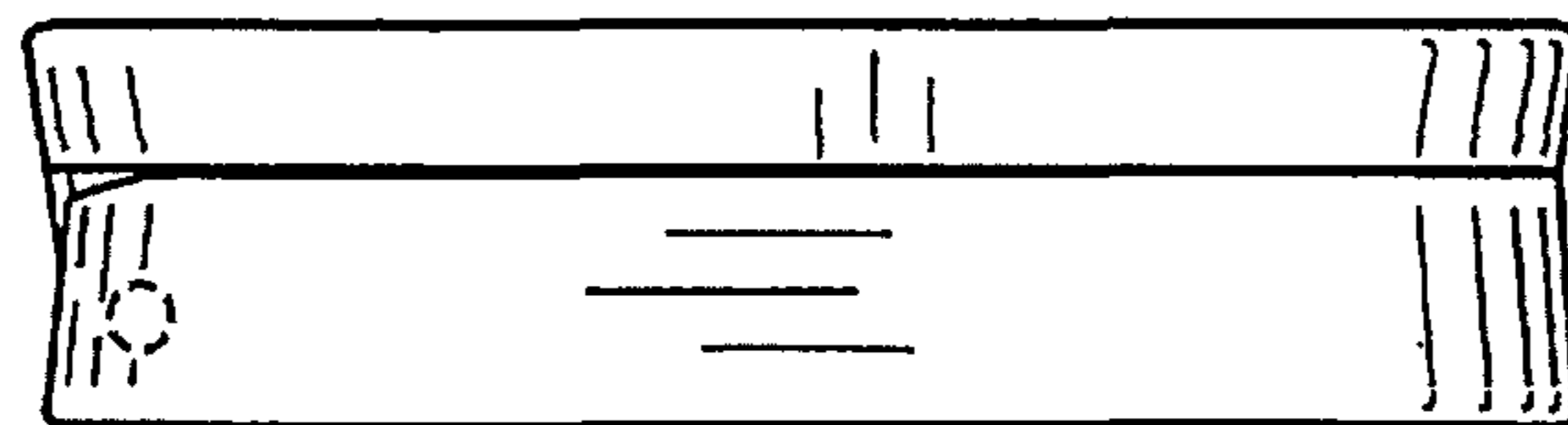

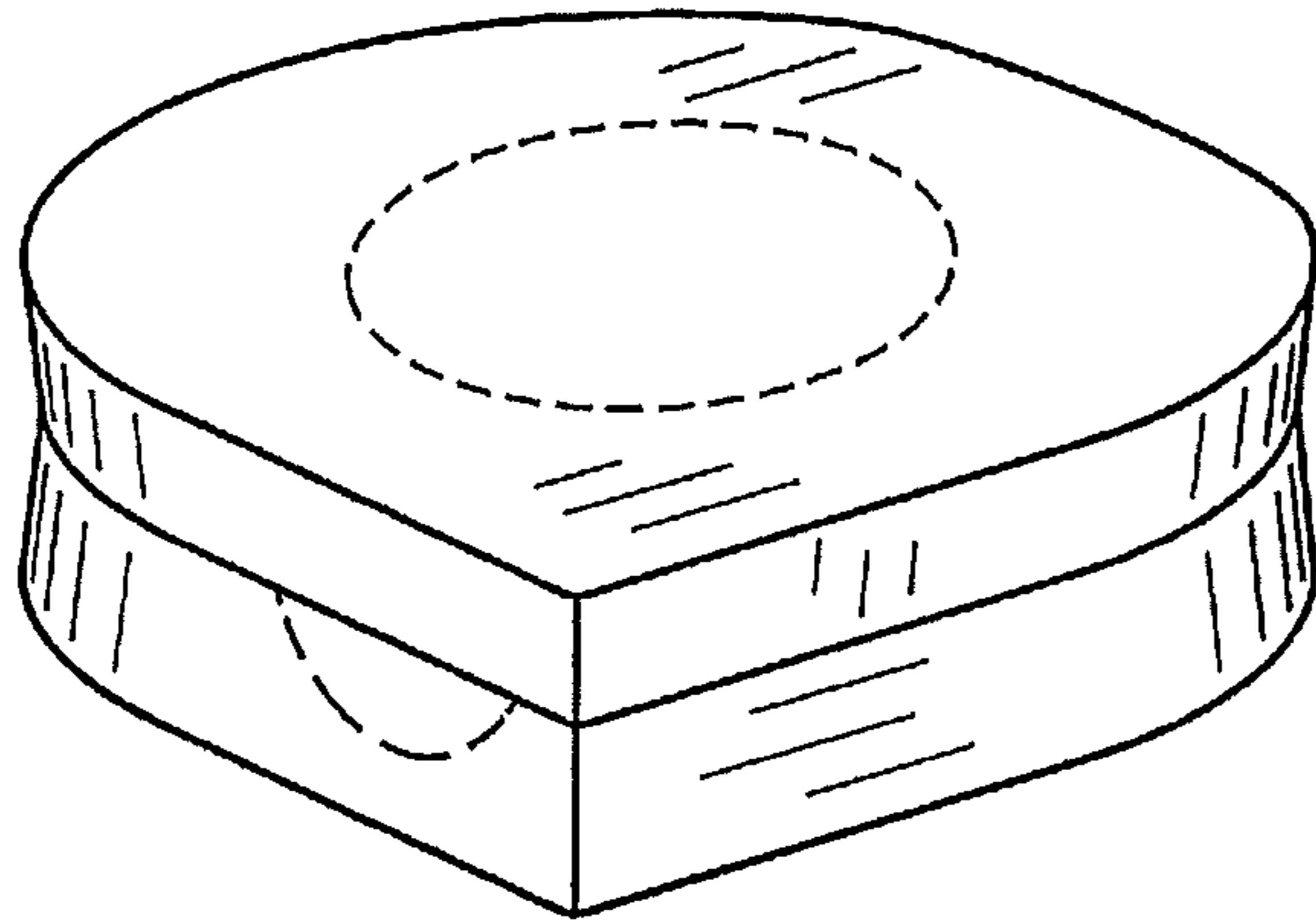
