(57) **CLAIM**

The ornamental design for a dashiki pet shirt, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the dashiki pet shirt of the present invention;

FIG. 2 is a front view of the dashiki pet shirt of FIG. 1, as worn by an exemplary pet;

FIG. 3 is a side view of the dashiki pet shirt of FIG. 1, as seen from a left side of FIG. 2, the right side being a mirror image thereof;

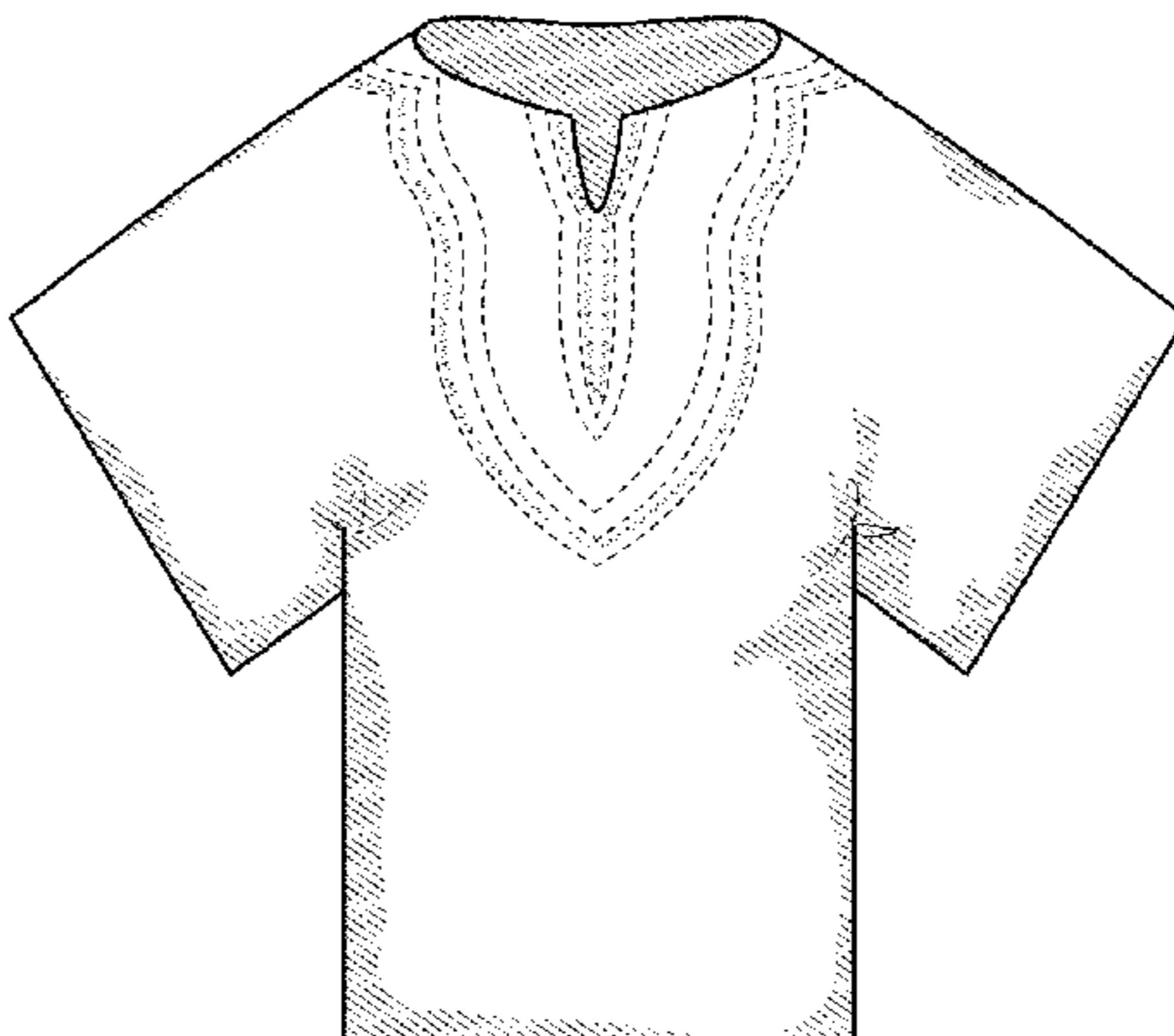
FIG. 4 is a top plan view of a second embodiment of the dashiki pet shirt of FIG. 1;

FIG. 5 is a front view of a second embodiment of the dashiki pet shirt of FIG. 4, as worn by an exemplary pet; and,

FIG. 6 is a side view of a second embodiment of the dashiki pet shirt of FIG. 4, as seen from a left side of FIG. 5, the right side being a mirror image thereof.

The broken line showing a pet is included for contextual purposes and forms no part of the claimed design. The broken lines on the dashiki pet shirt are sticking and/or fabric patterns and are part of the ornamental design.

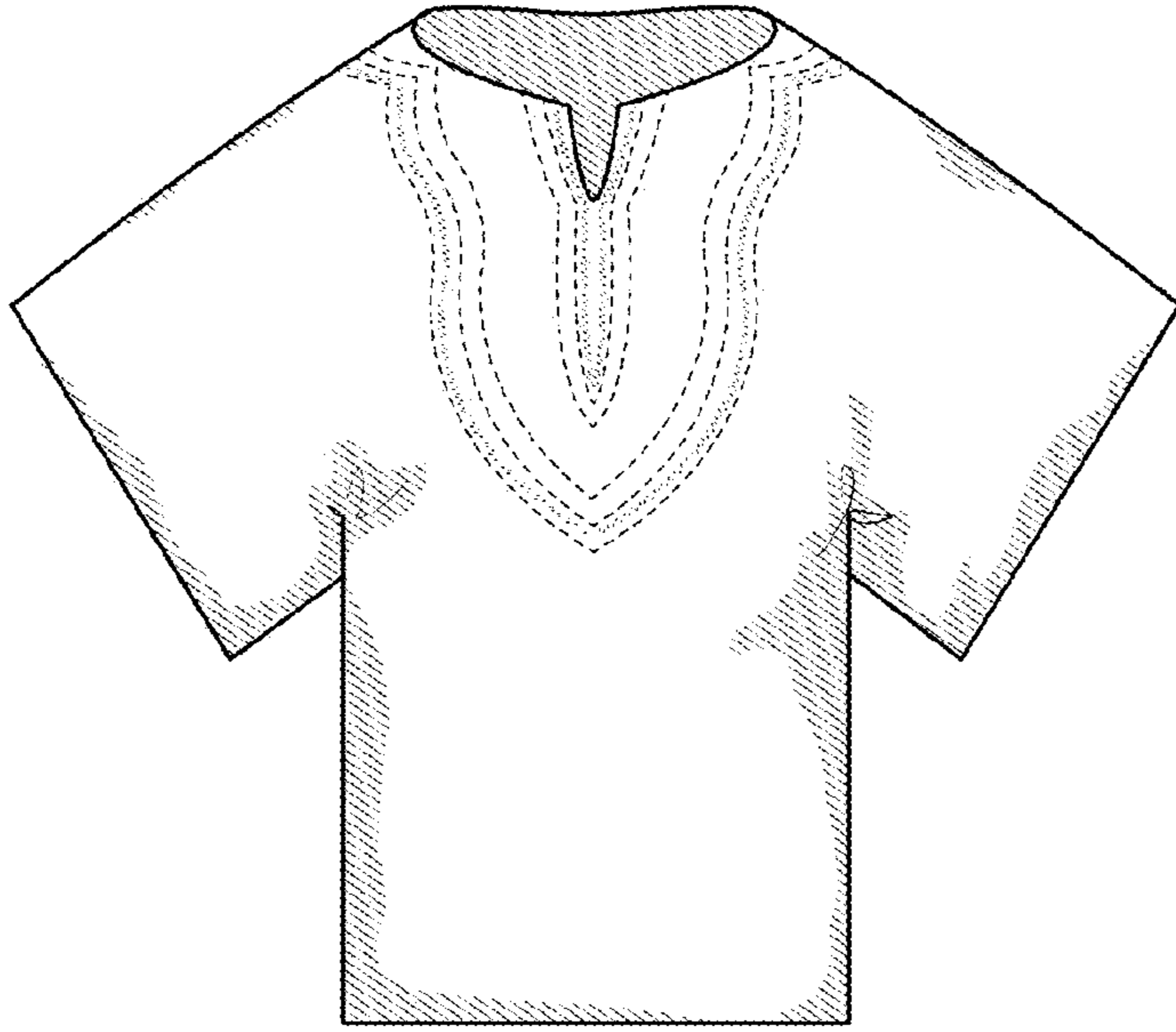

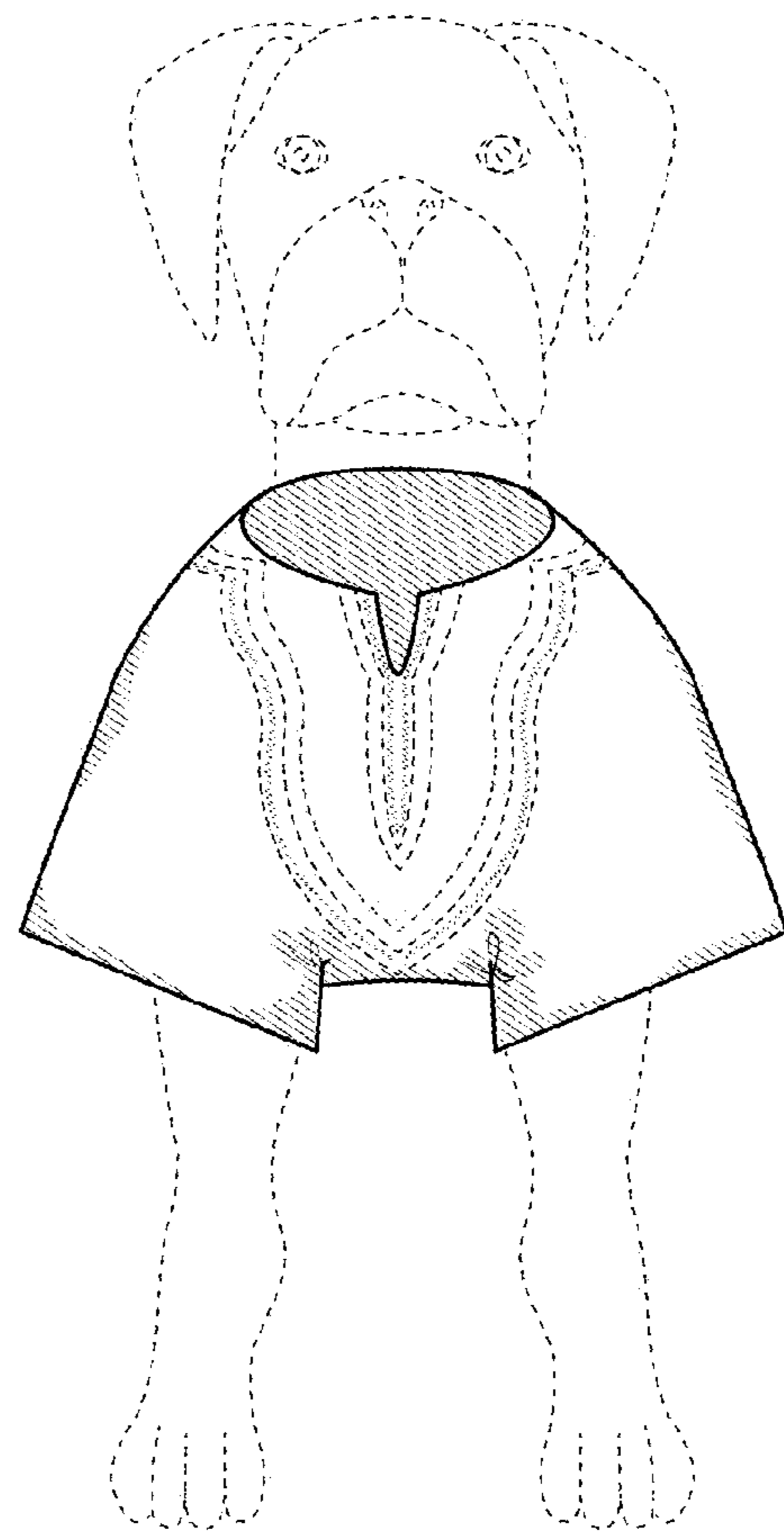

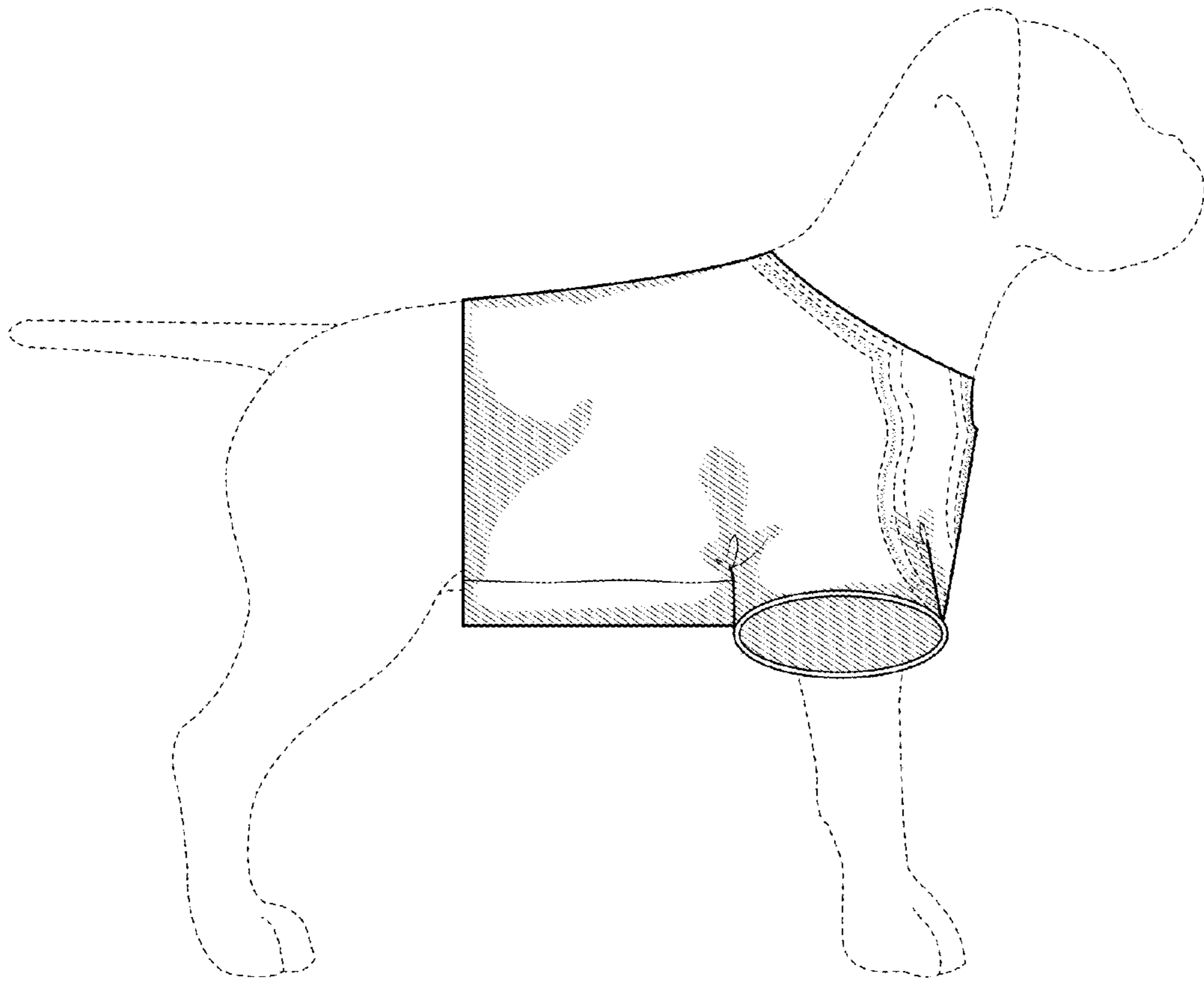

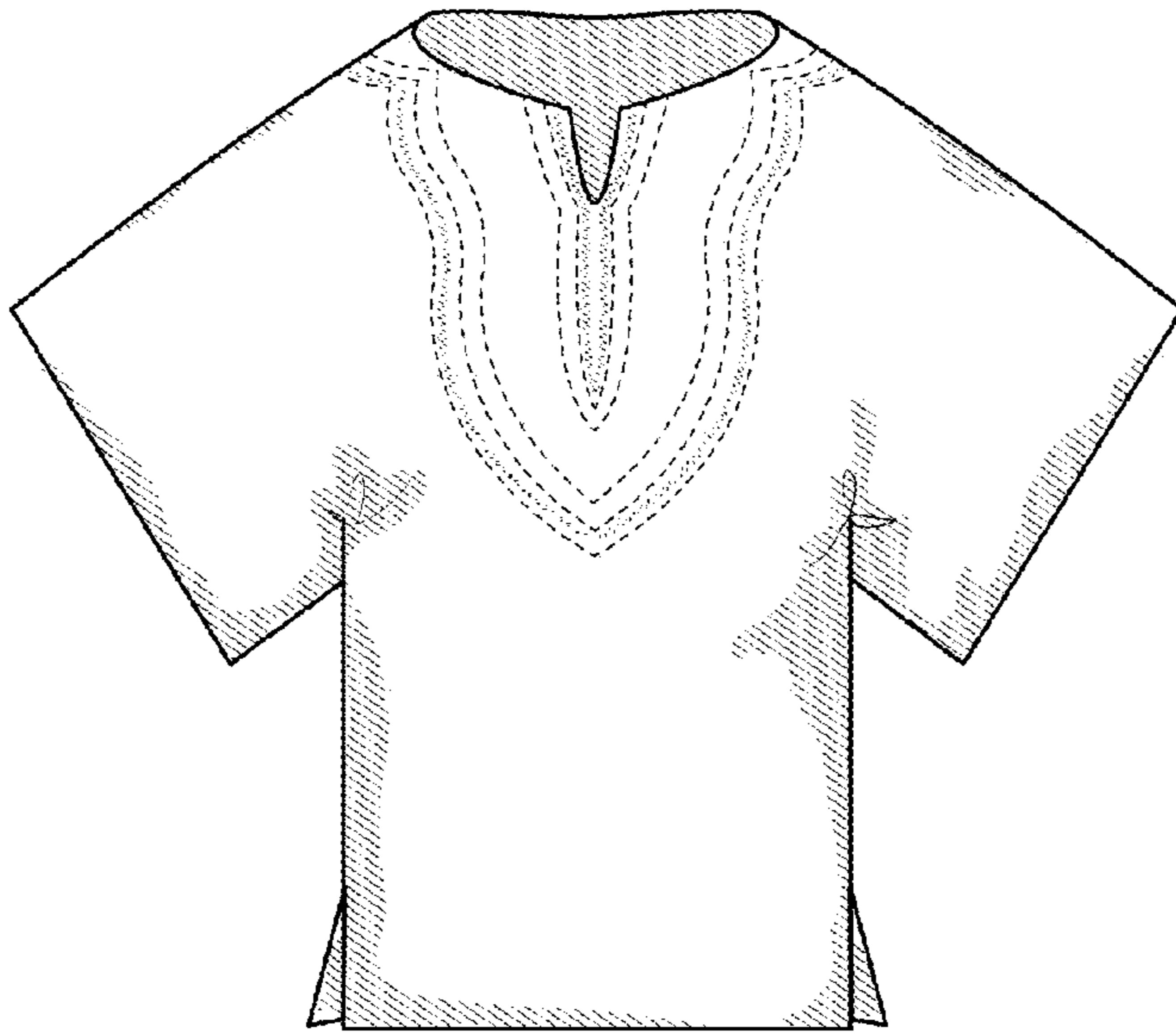

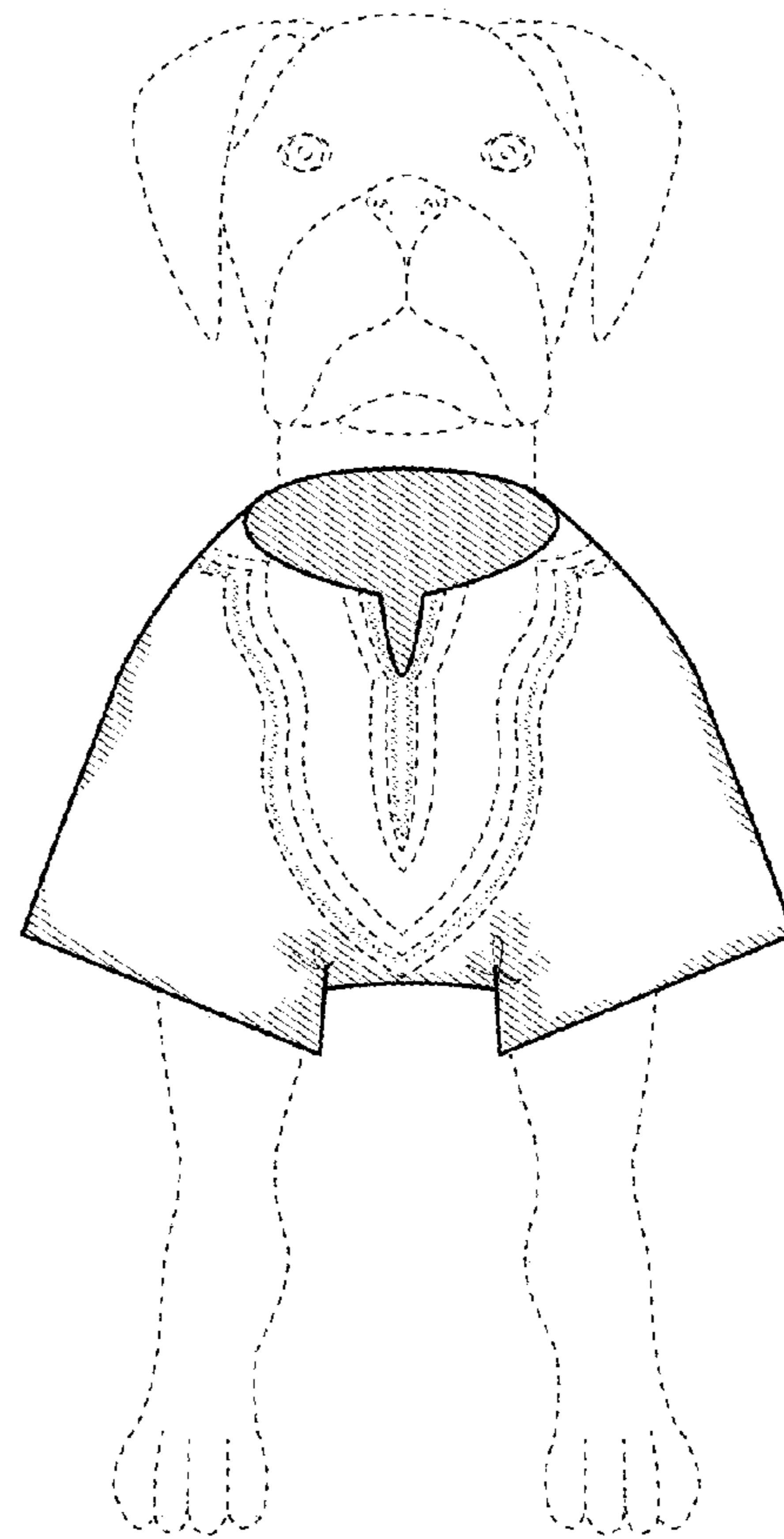

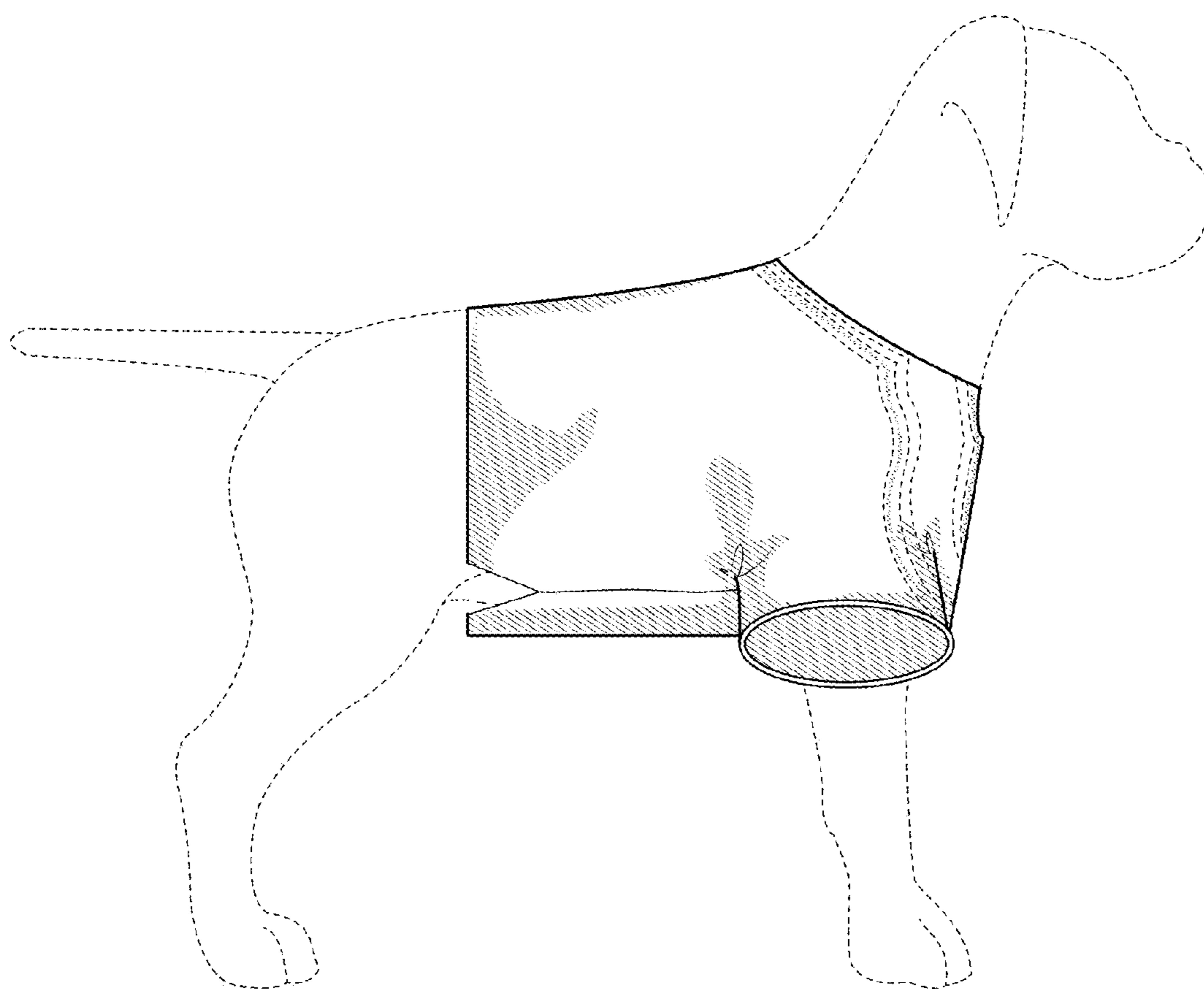
