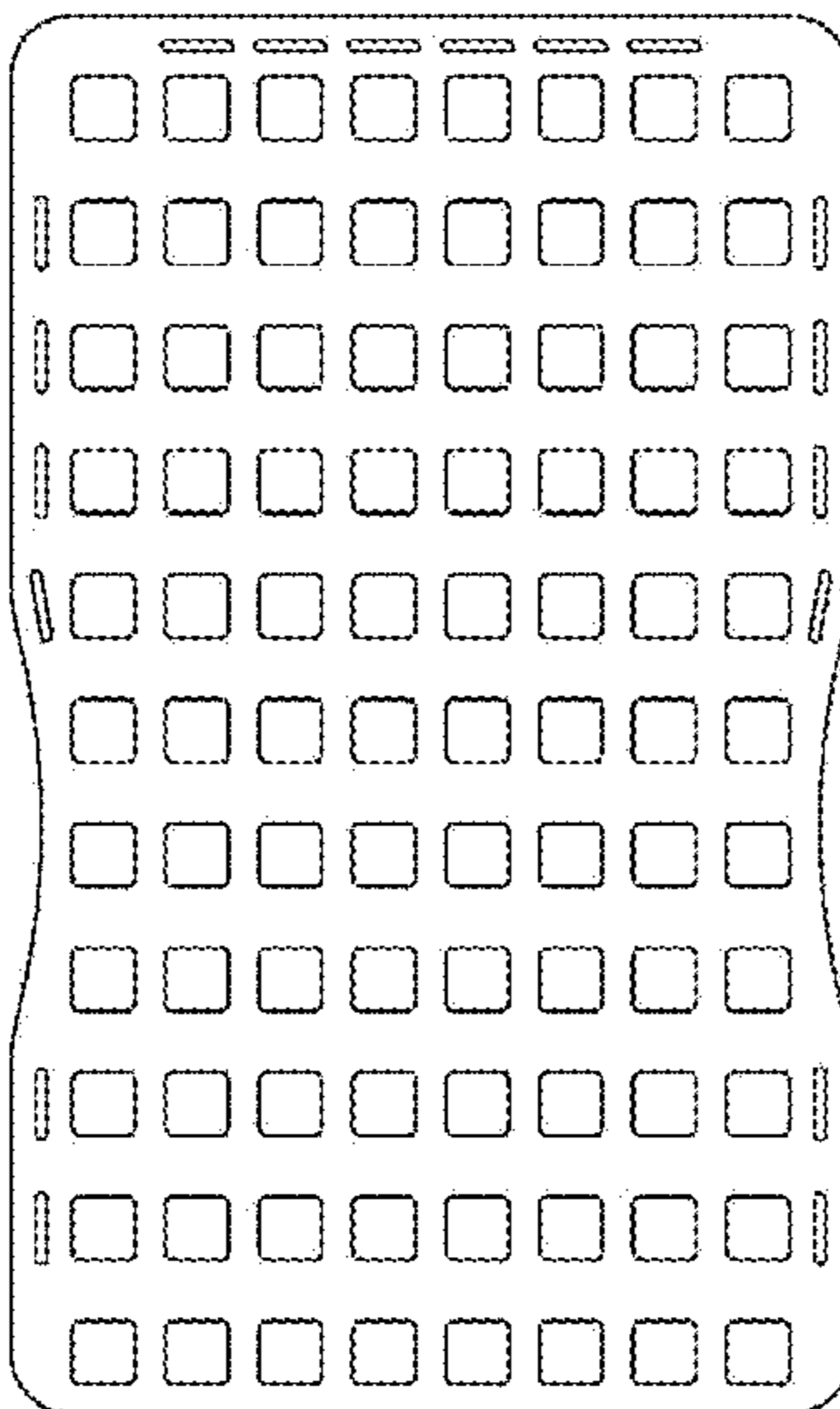

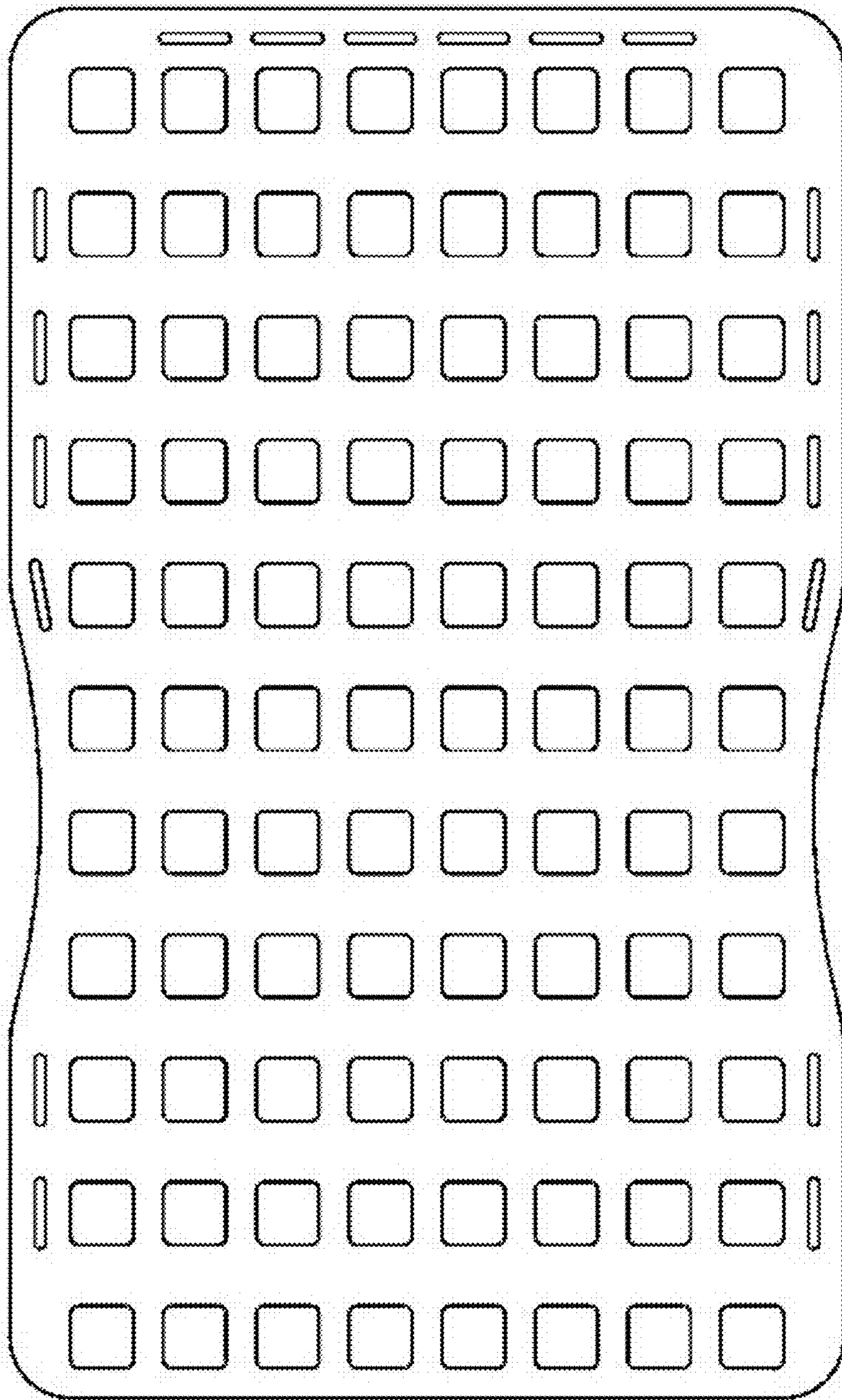
The ornamental design for a modular load carrying system, as shown and described.

**DESCRIPTION**

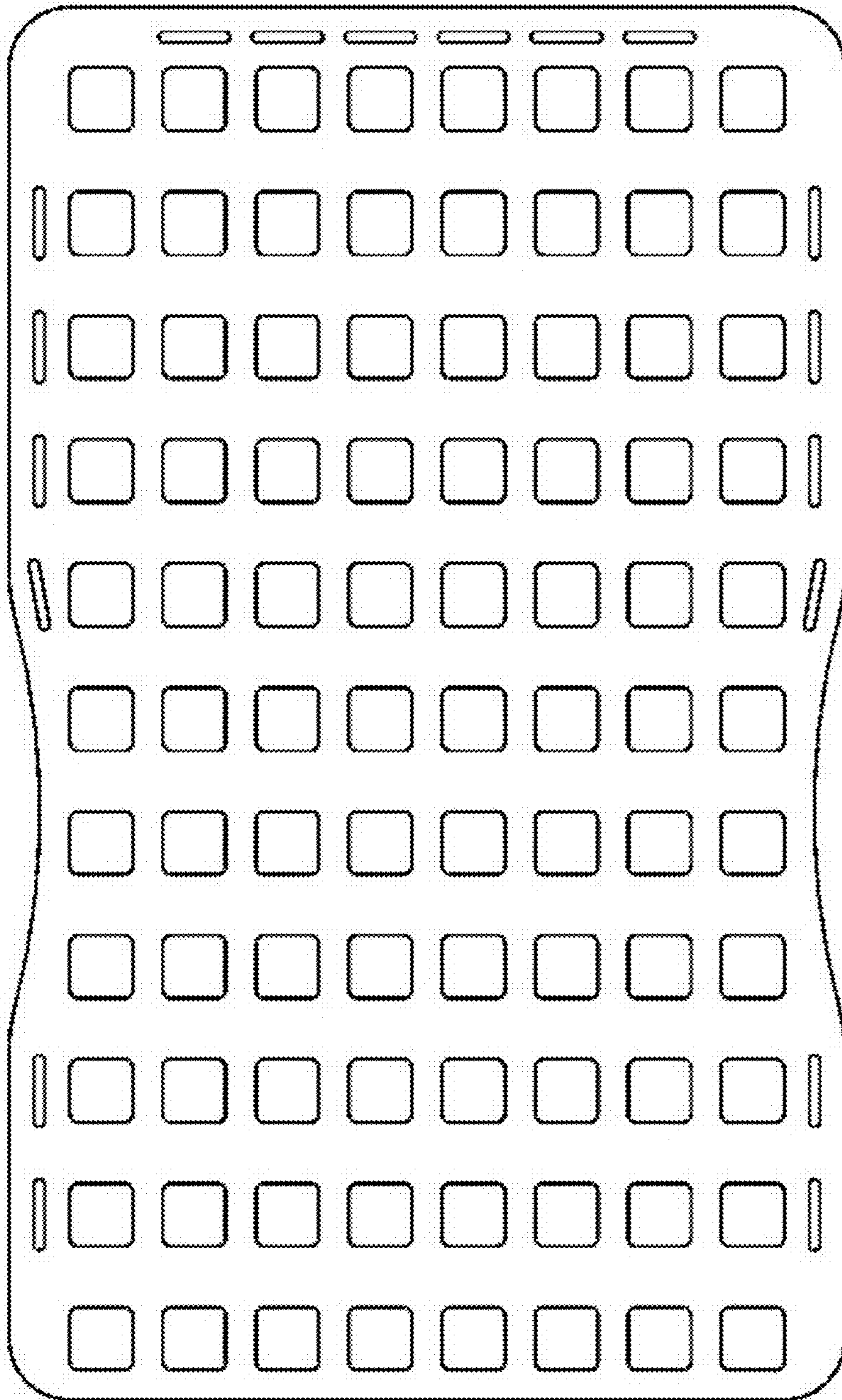

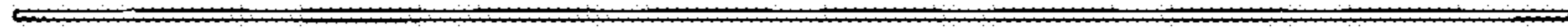




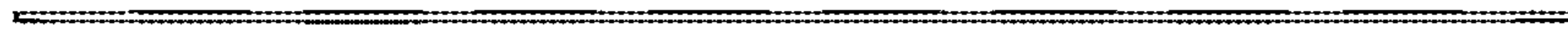

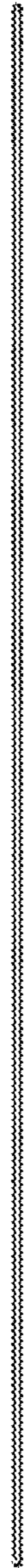
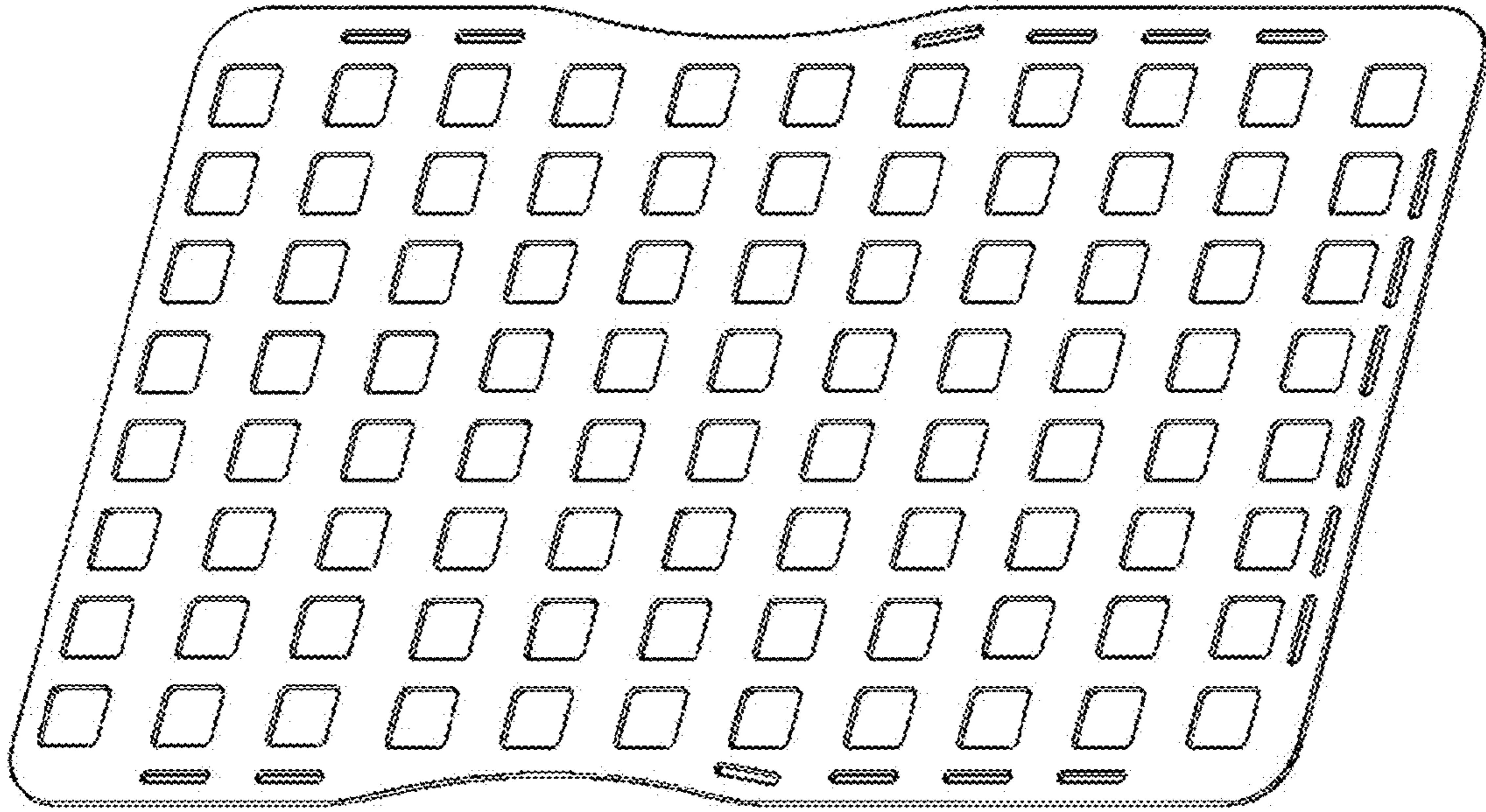


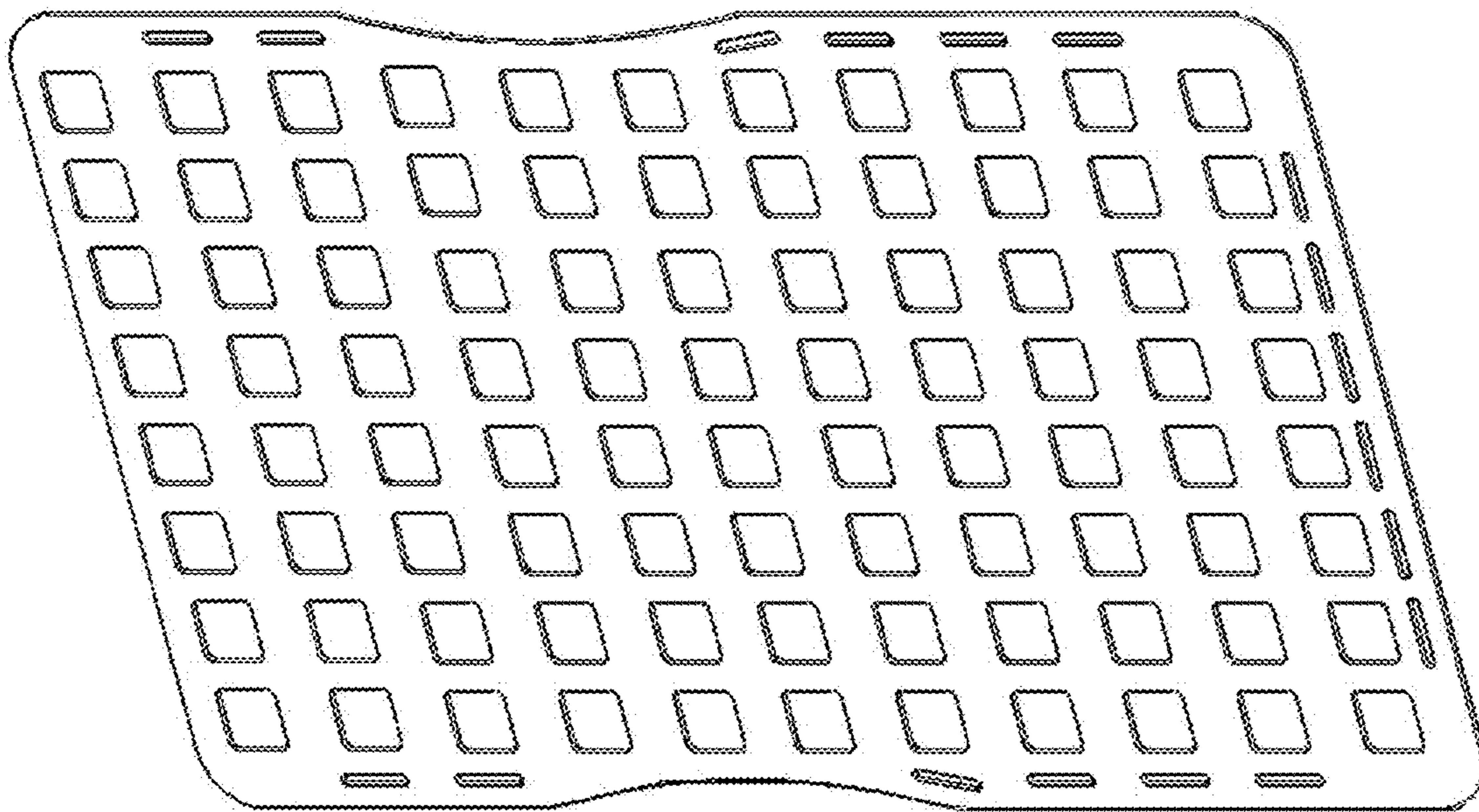
