(57) **CLAIM**

I claim the ornamental design for a pretzel cracker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pretzel cracker comprising the present invention.

FIG. 2 is a top plan view of the pretzel cracker shown in FIG. 1.

FIG. 3 is a bottom plan view of the pretzel cracker shown in FIGS. 1 and 2.

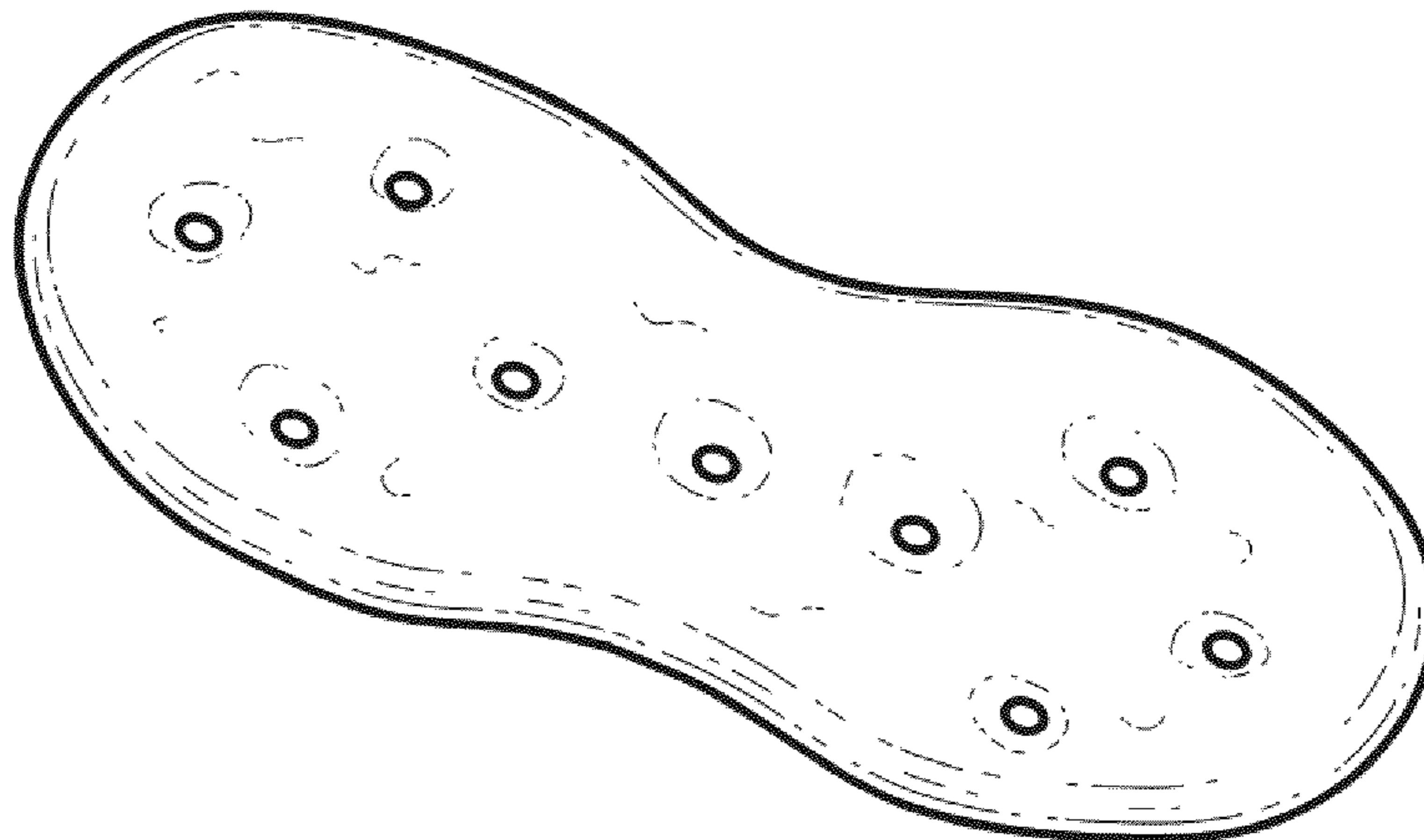
FIG. 4 is a front elevational view of the pretzel cracker shown in FIGS. 1, 2, and 3.

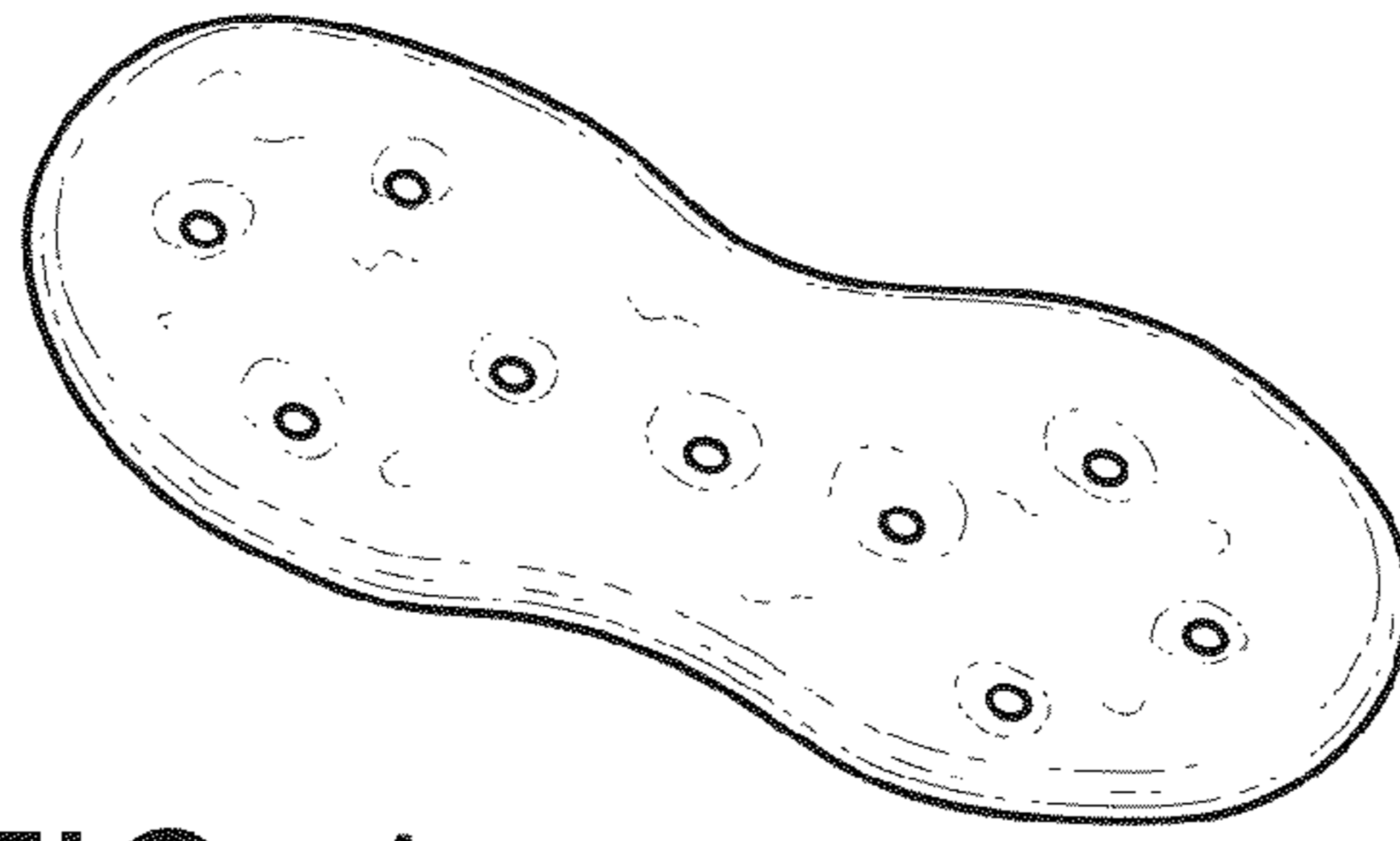

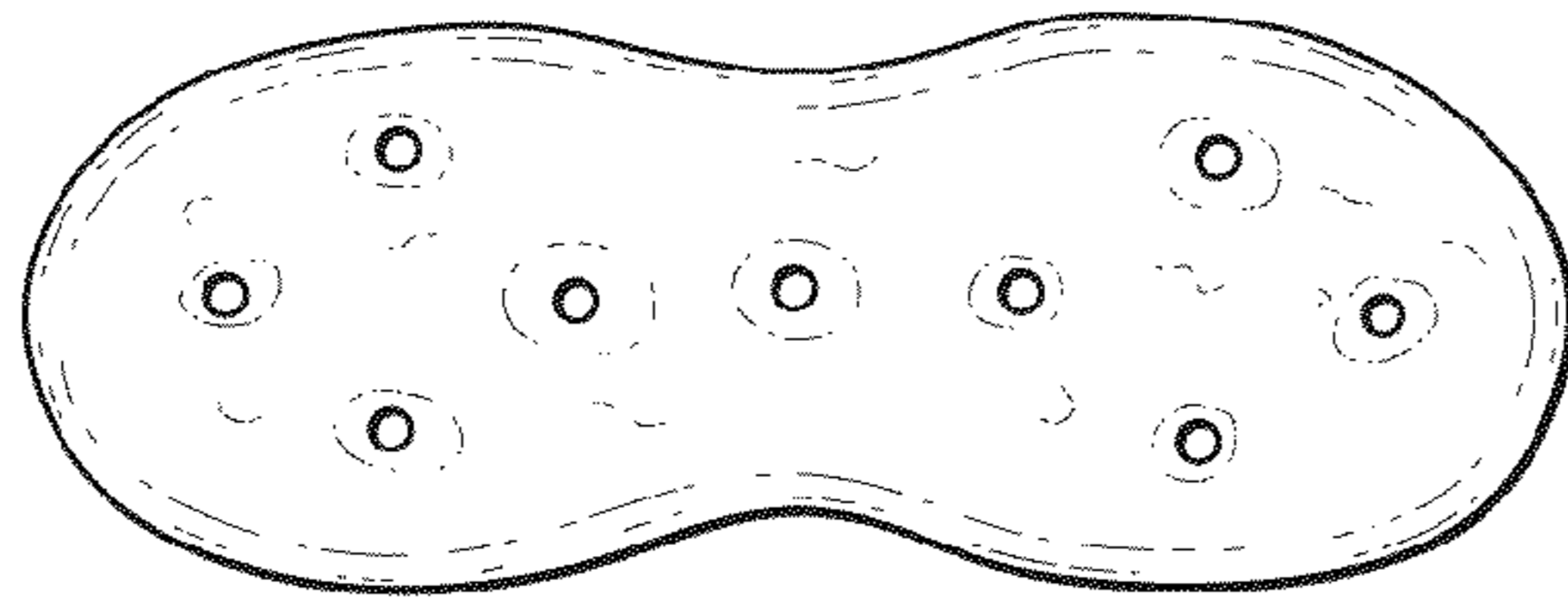

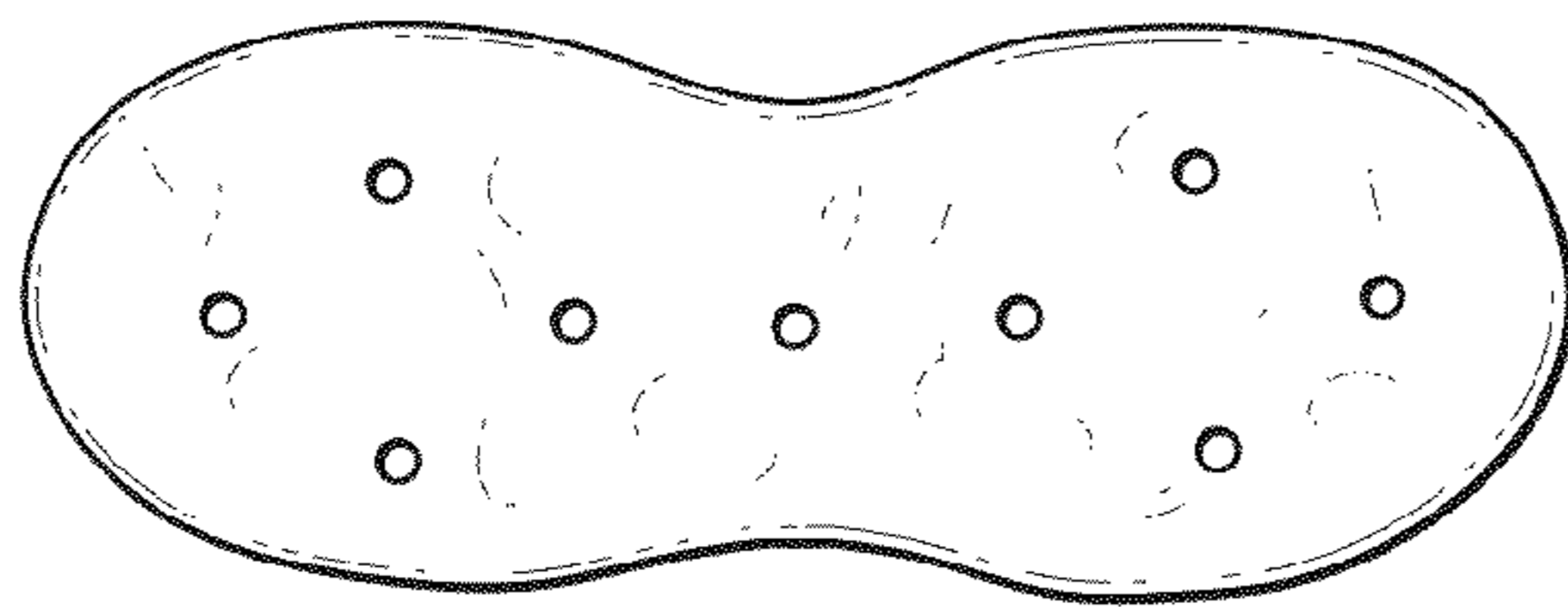

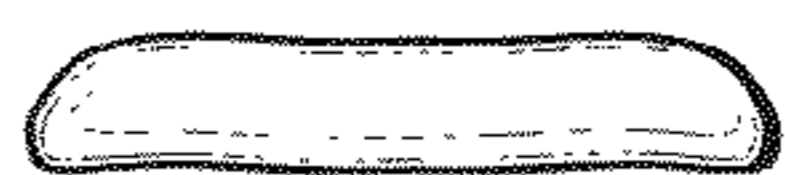
