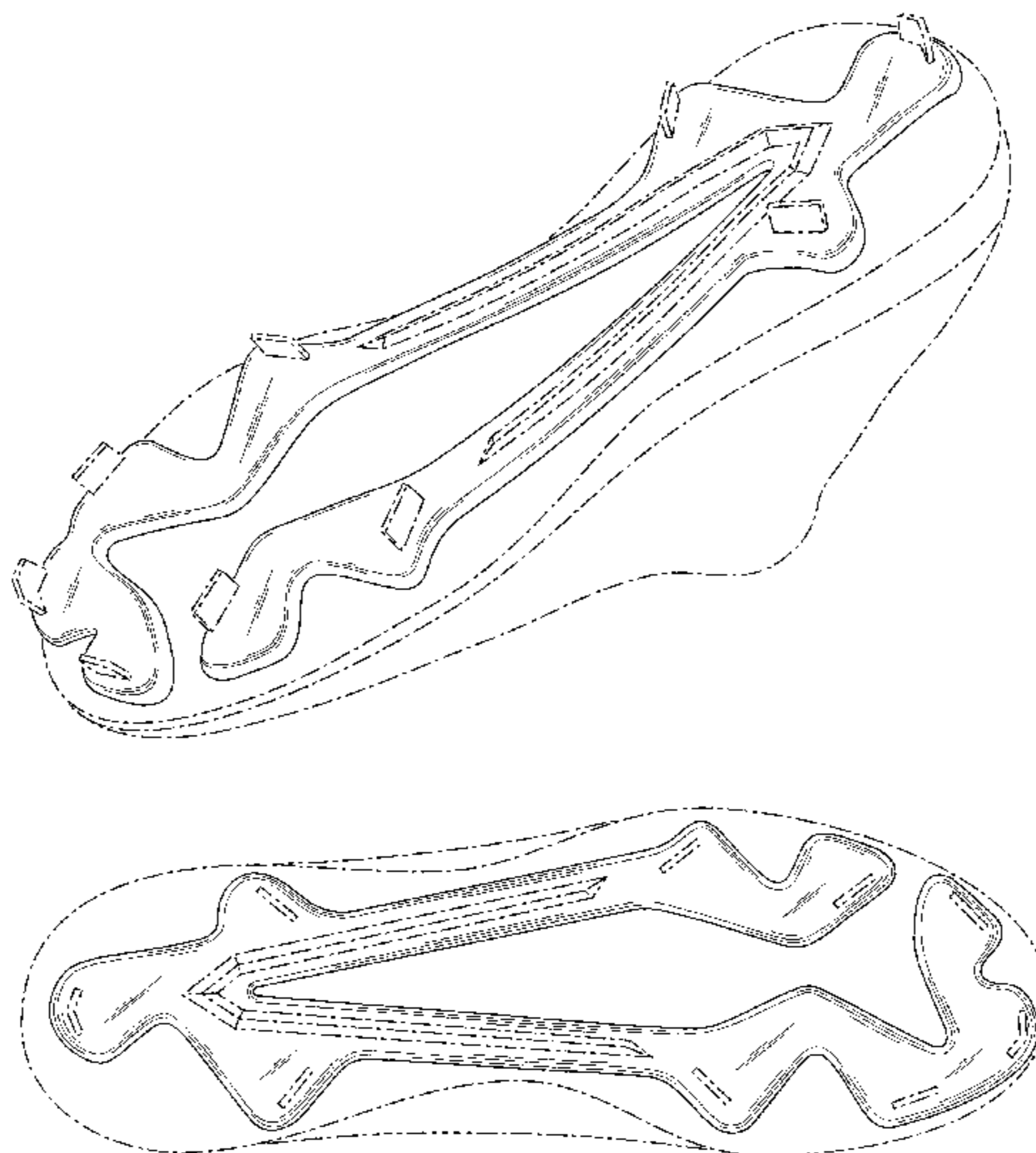
(57) **CLAIM**

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

The broken line showing of nine cleat elements, a V-shaped region, and the remainder of the shoe is for environmental purposes only and forms no part of the claimed design.

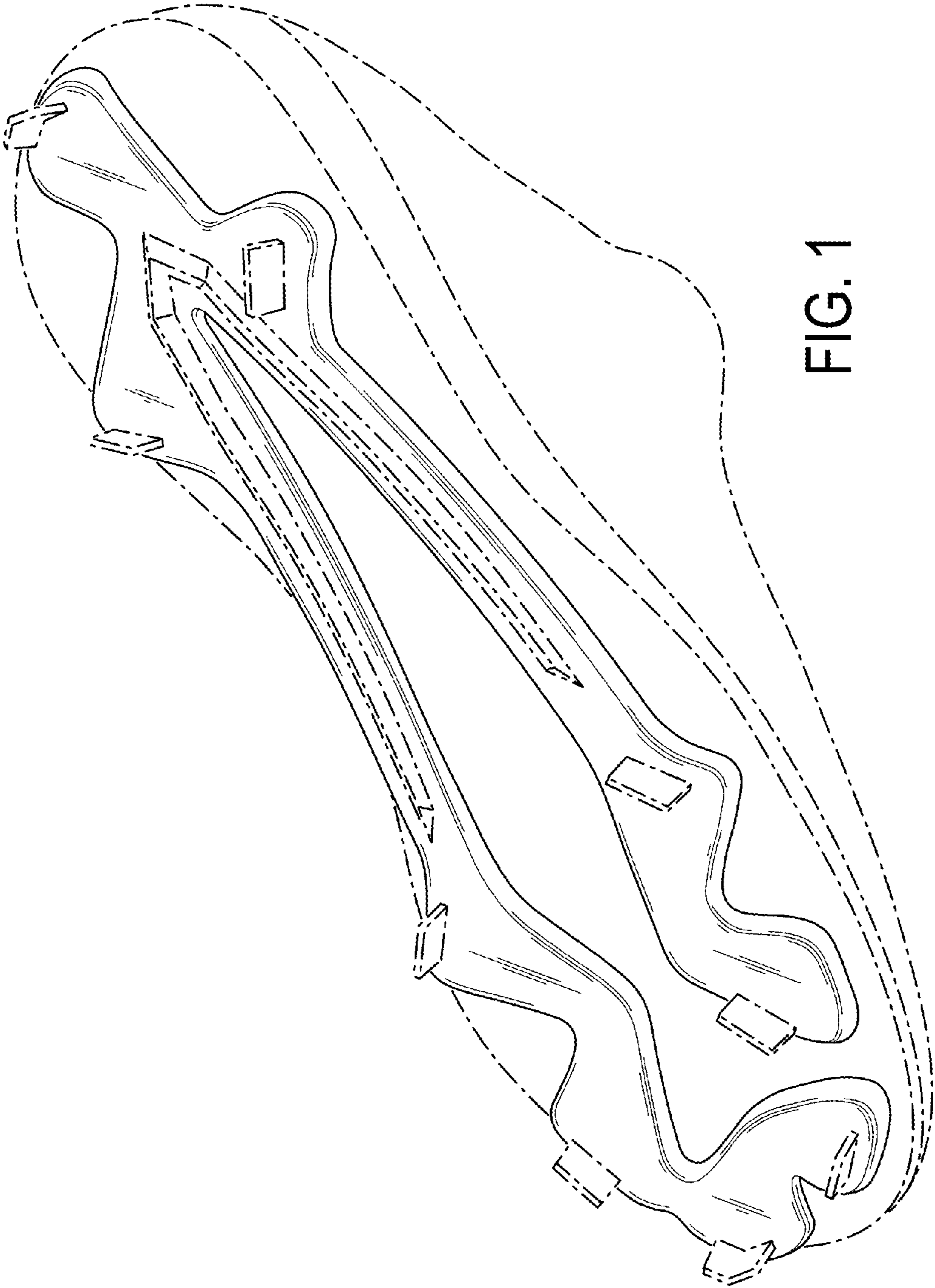

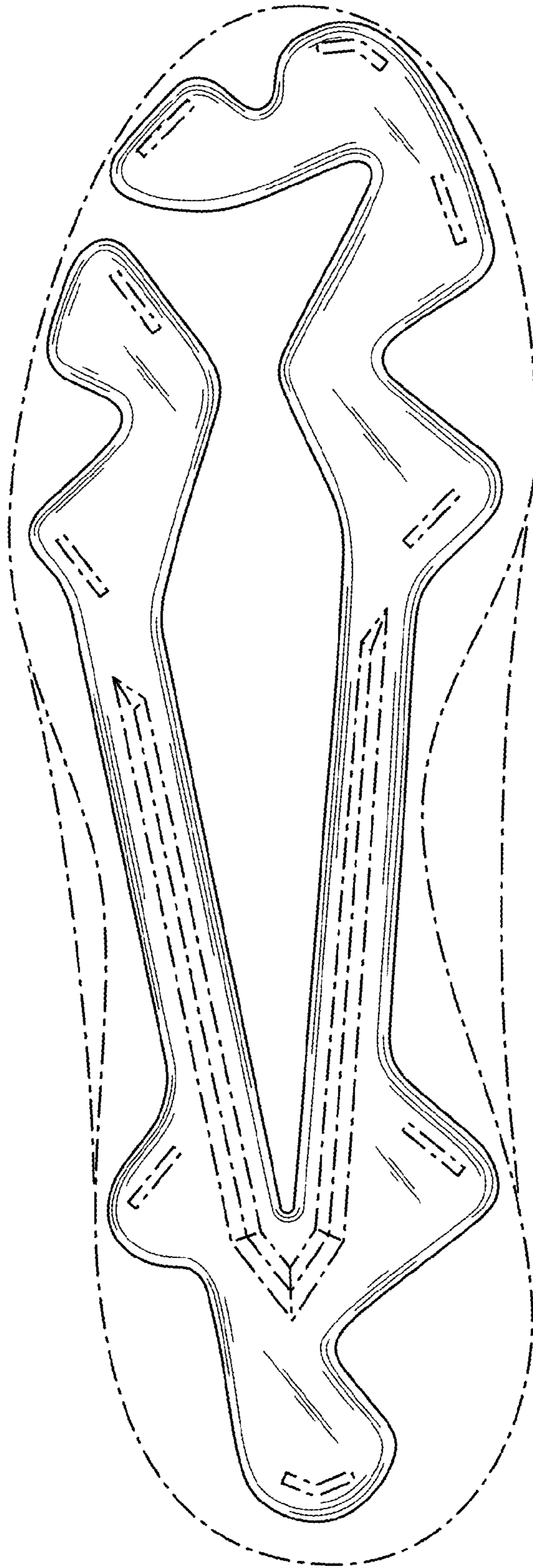

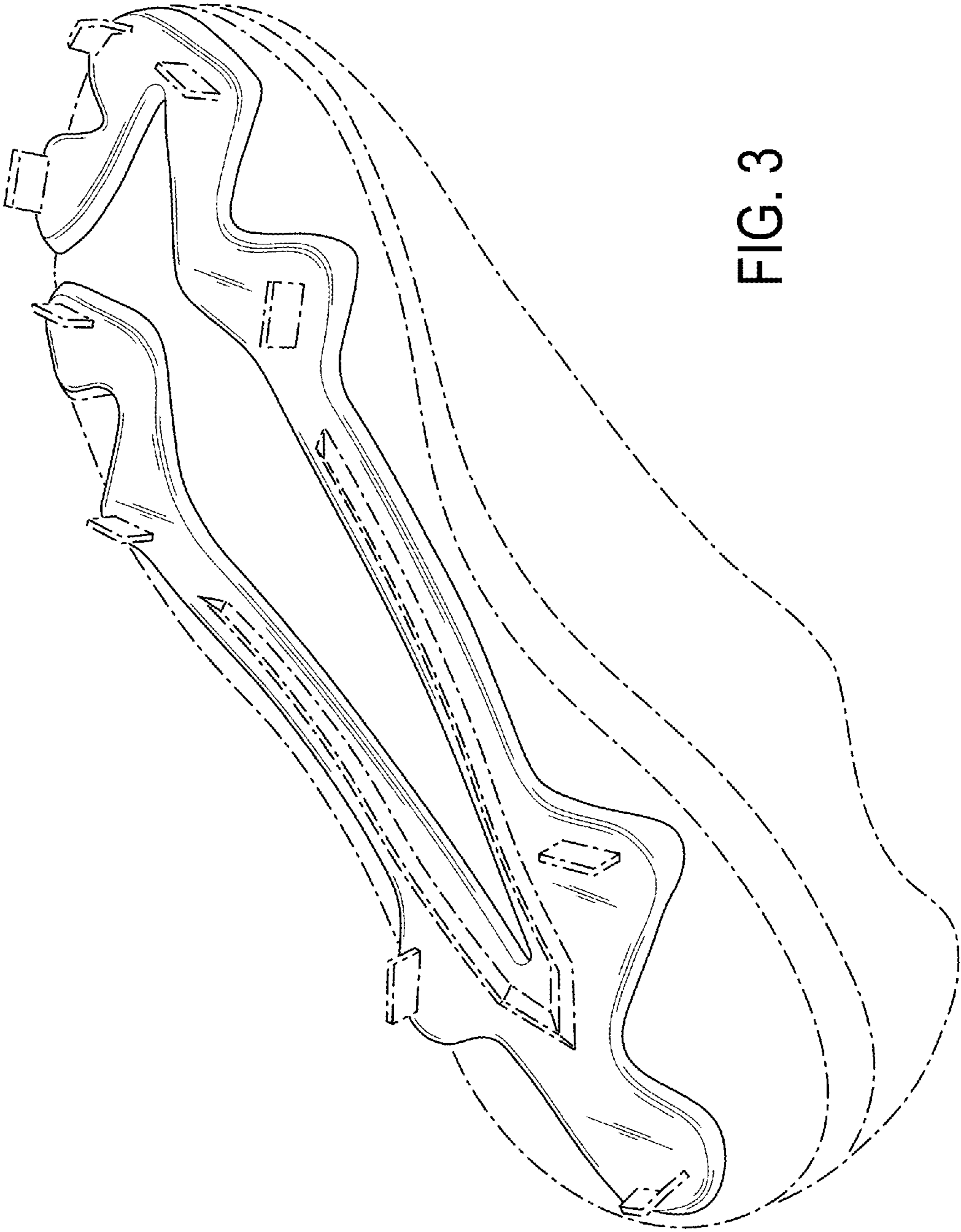
