(57) **CLAIM**

I claim the ornamental design for a multi-compartment travel container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a multi-compartment travel container showing my new design.

FIG. 2 is a bottom perspective view of the multi-compartment travel container of FIG. 1.

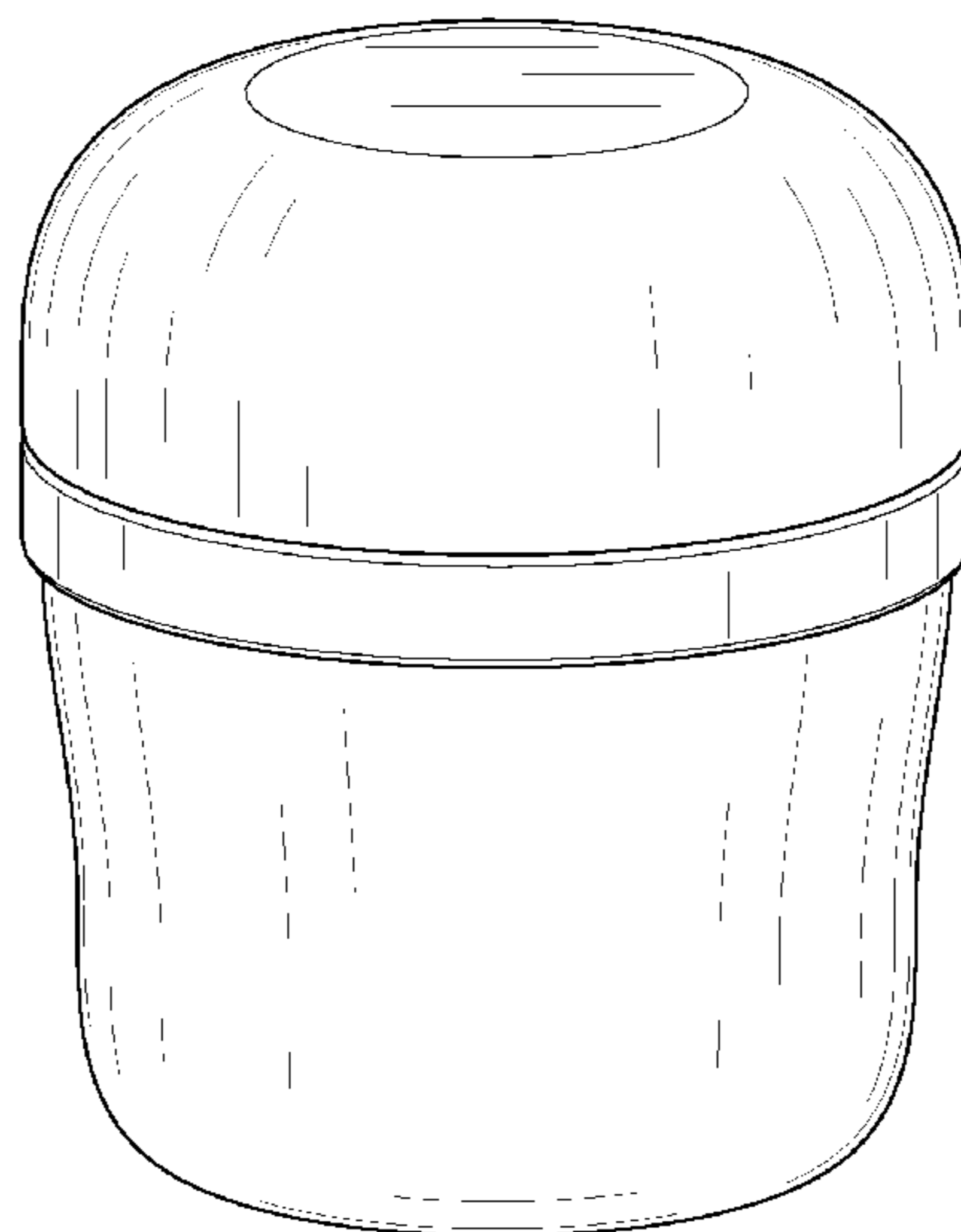
FIG. 3 is a front view of the multi-compartment travel container of FIG. 1, the rear view, the left-side view and the right-side view being identical thereto.

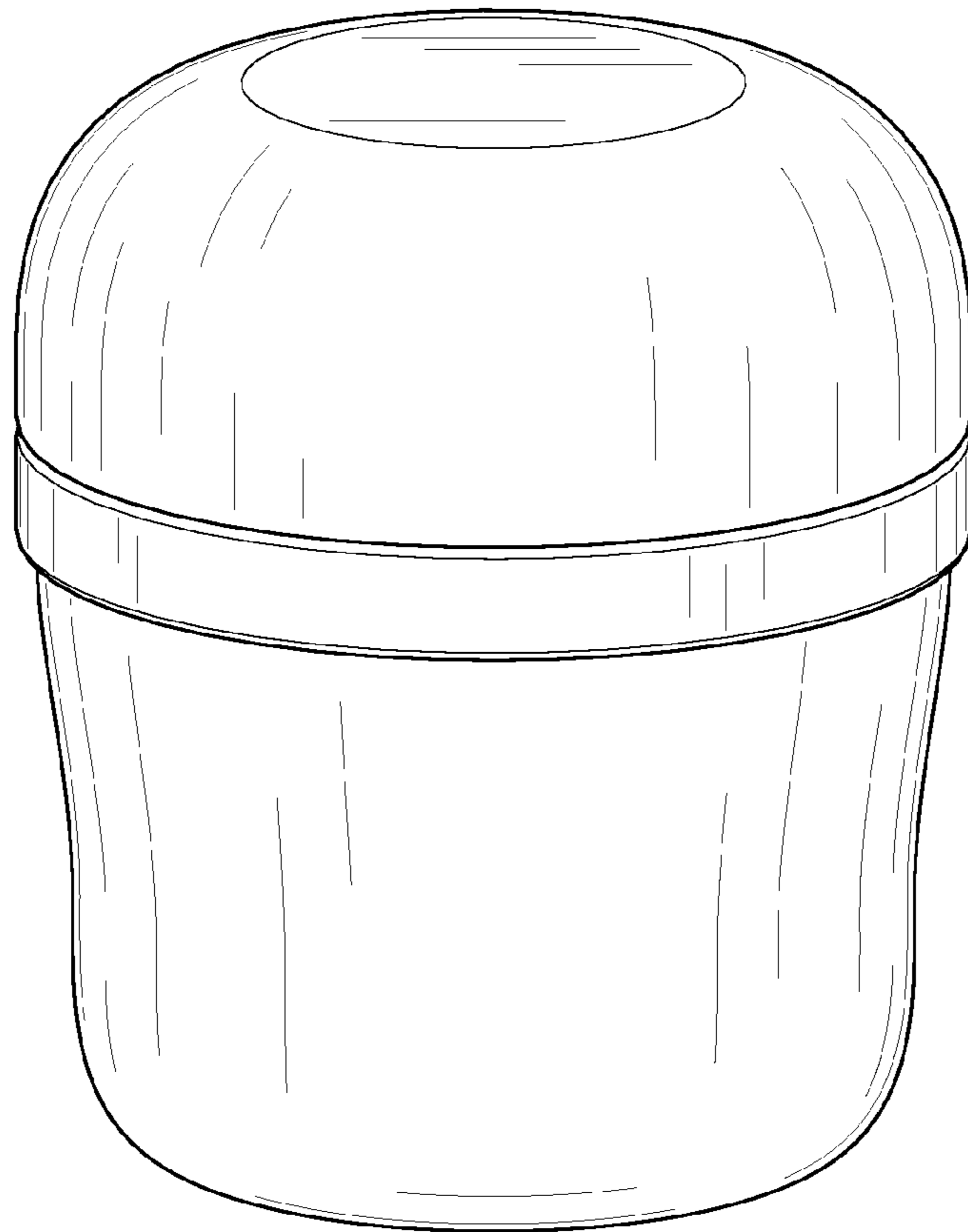

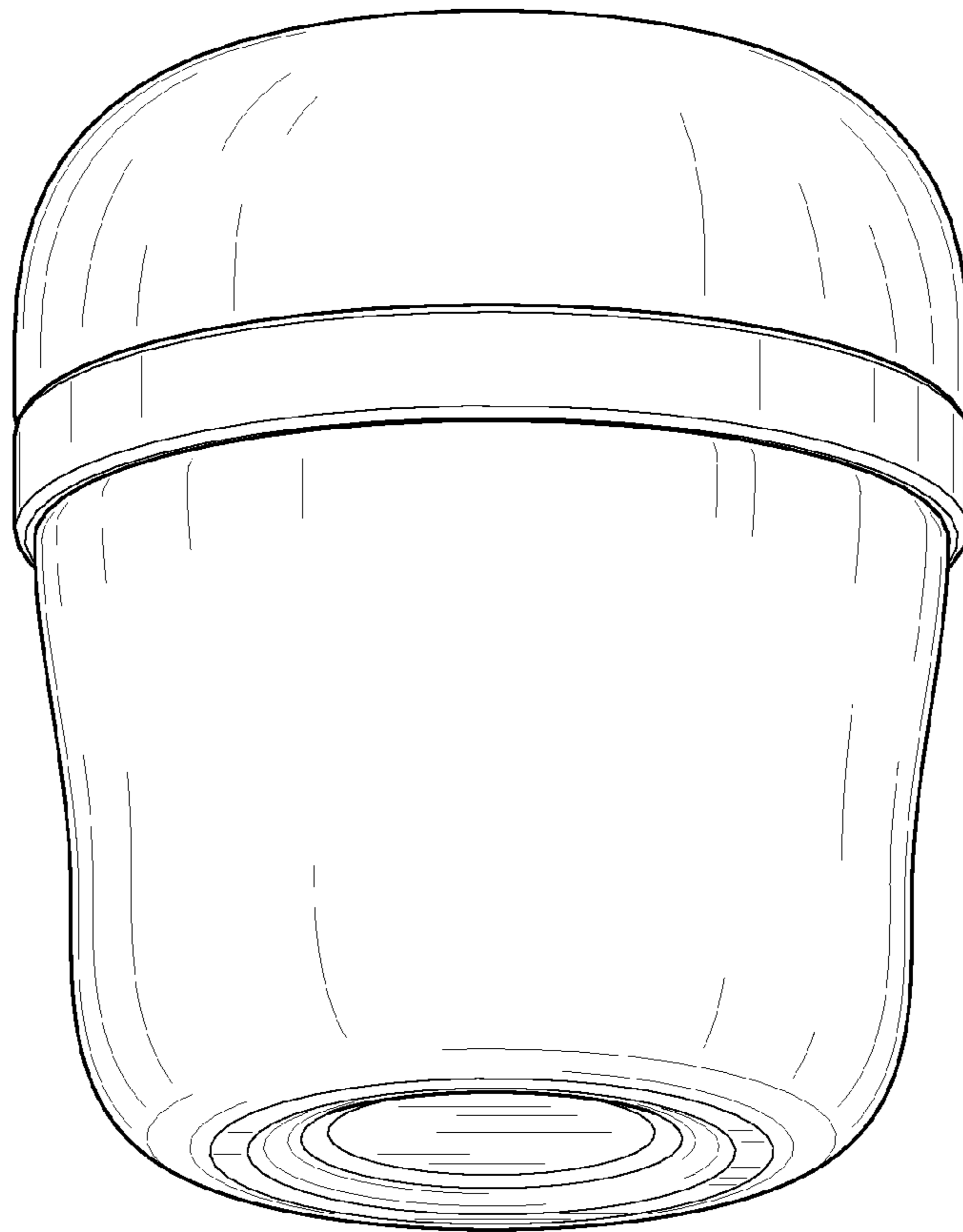

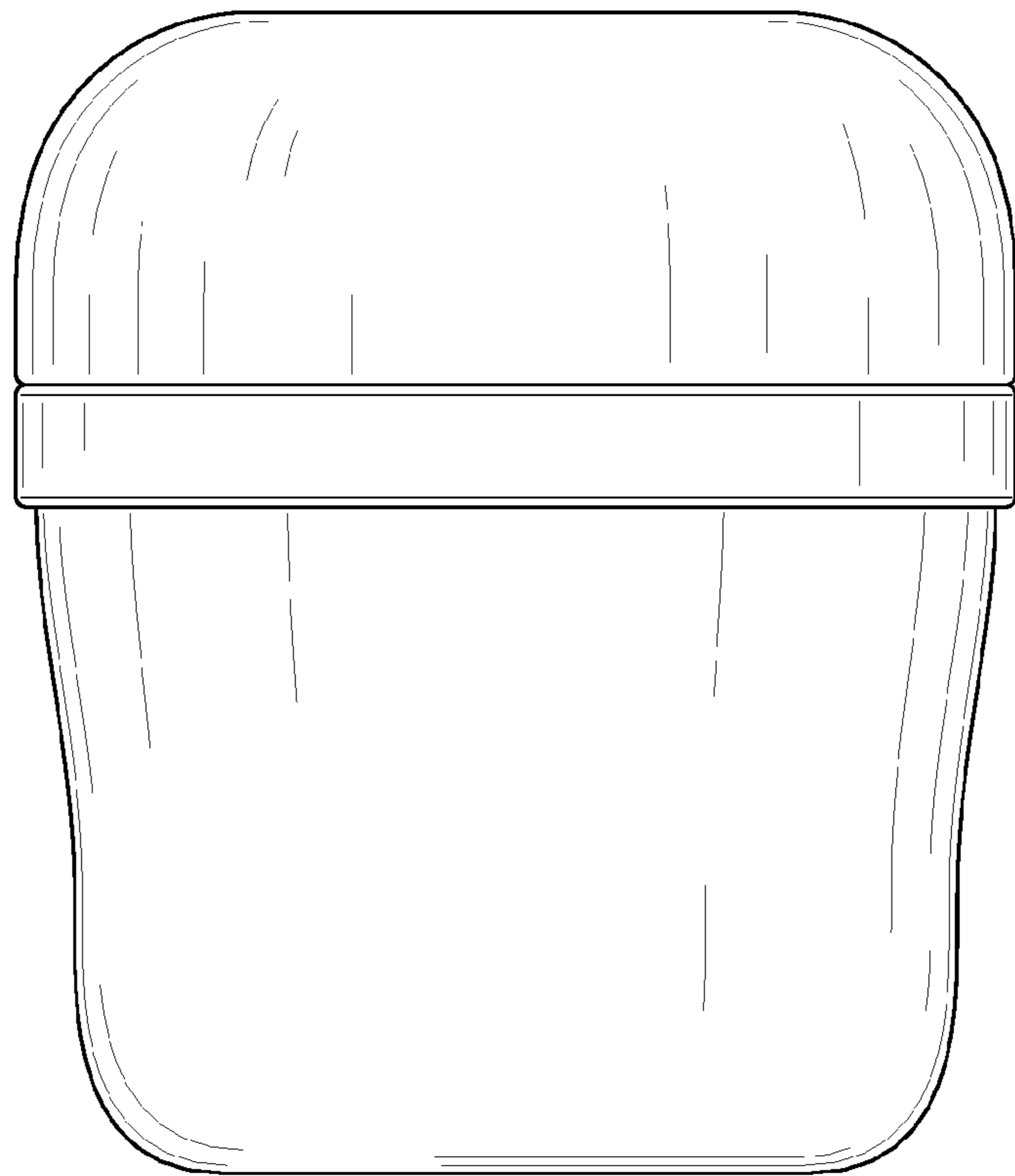

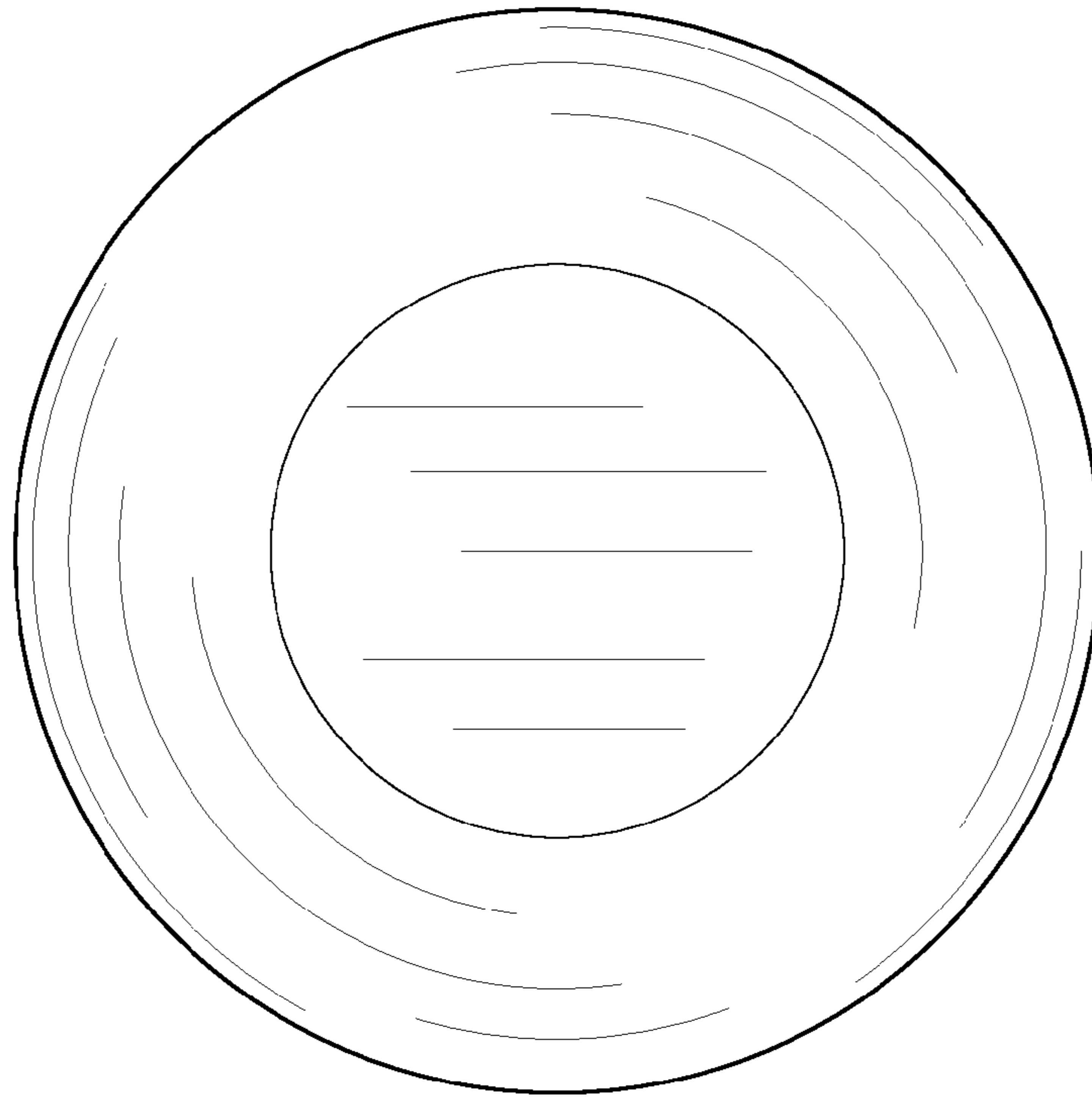

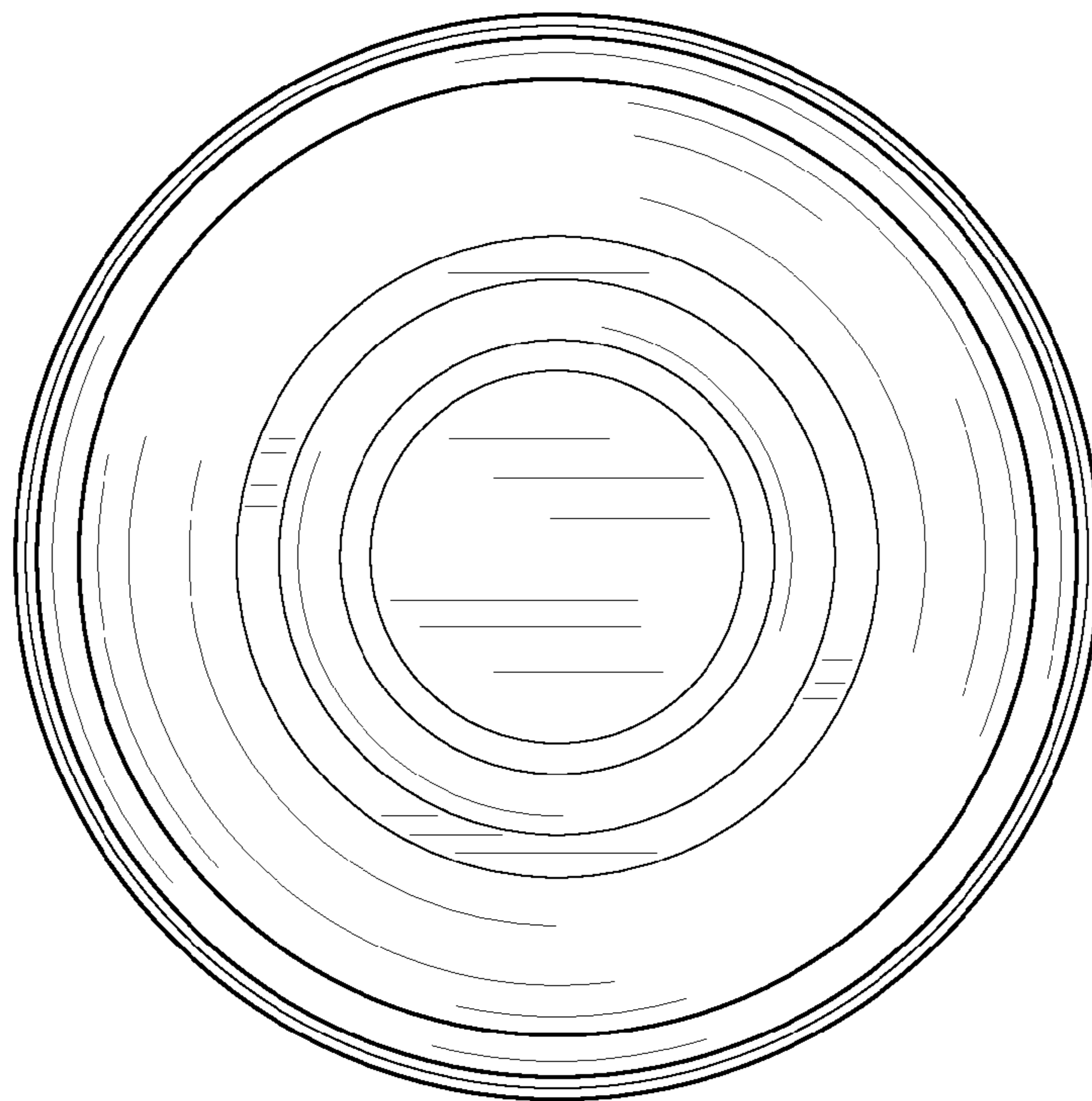

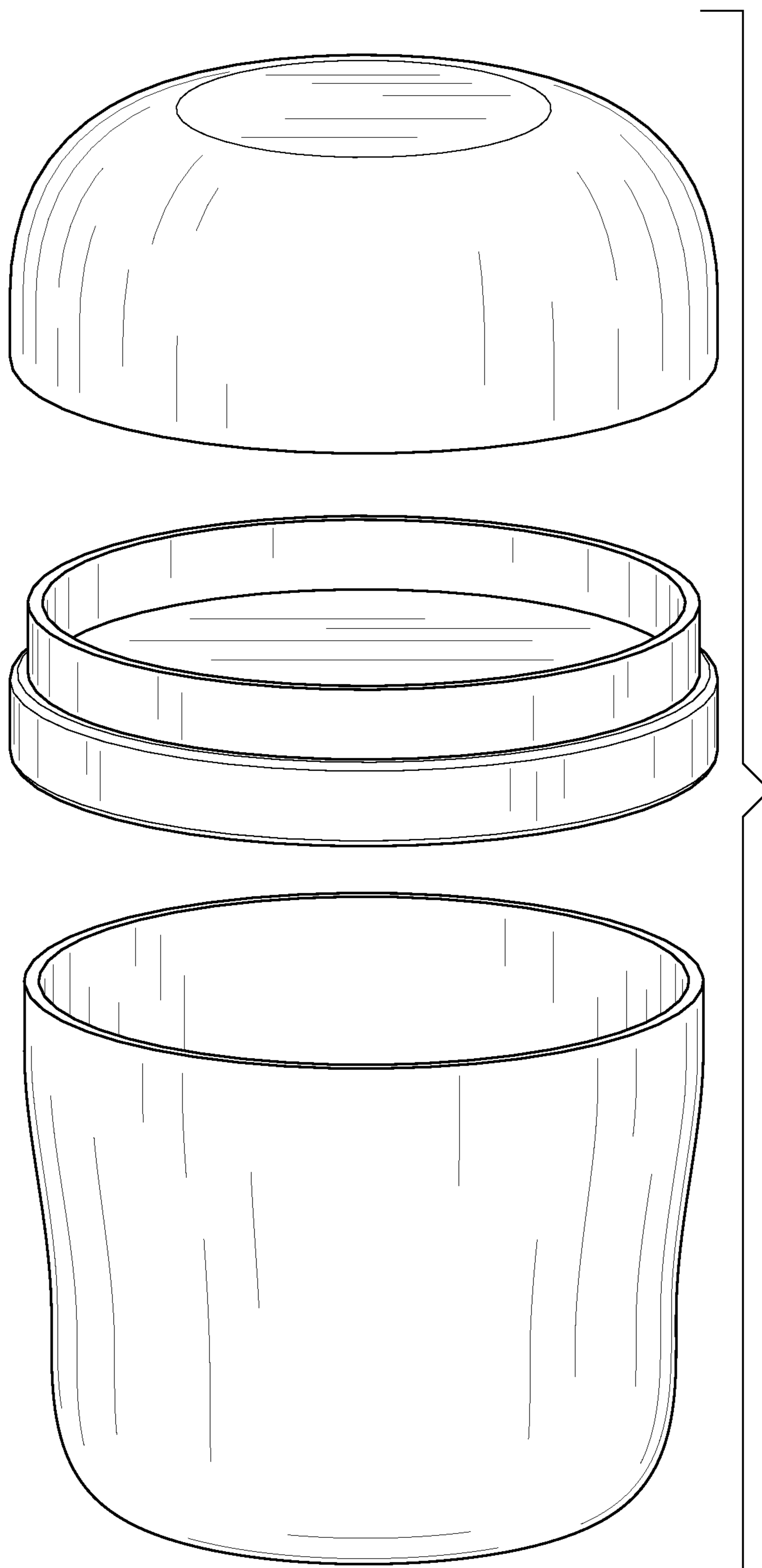
