(57) **CLAIM**

The ornamental design for an ornament attachment clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, perspective view of an ornament attachment clip showing our new design in a closed position;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof; and

FIG. 7 is a bottom view thereof.

FIG. 8 is a front, perspective view of the ornament attachment clip of FIG. 1 with additional environmental subject matter illustrated in broken lines.

FIG. 9 is a front, perspective view of the ornament attachment clip of FIG. 1 in an open position;

FIG. 10 is a front view thereof;

FIG. 11 is a rear view thereof;

FIG. 12 is a right side view thereof;

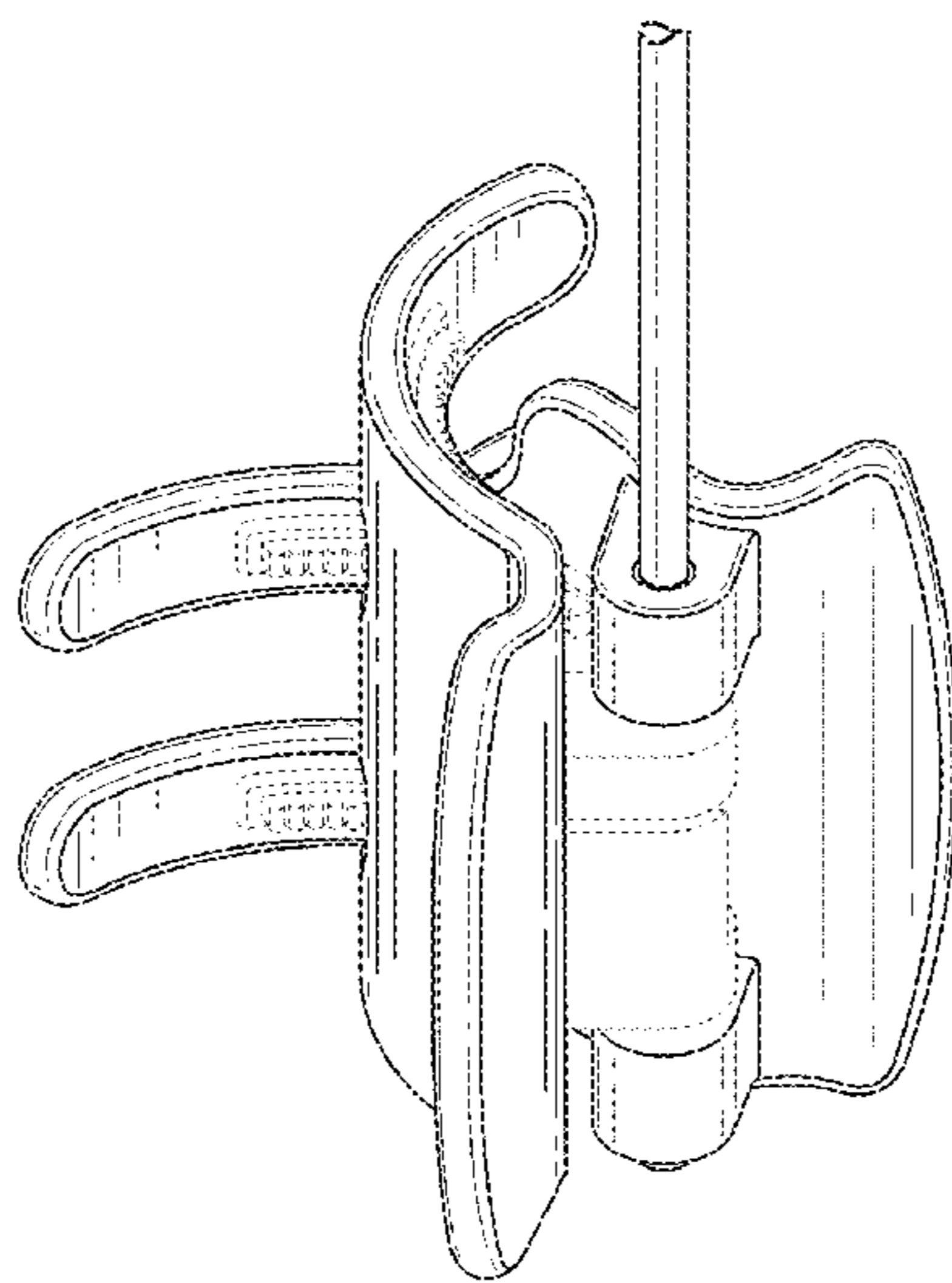
FIG. 13 is a left side view thereof;

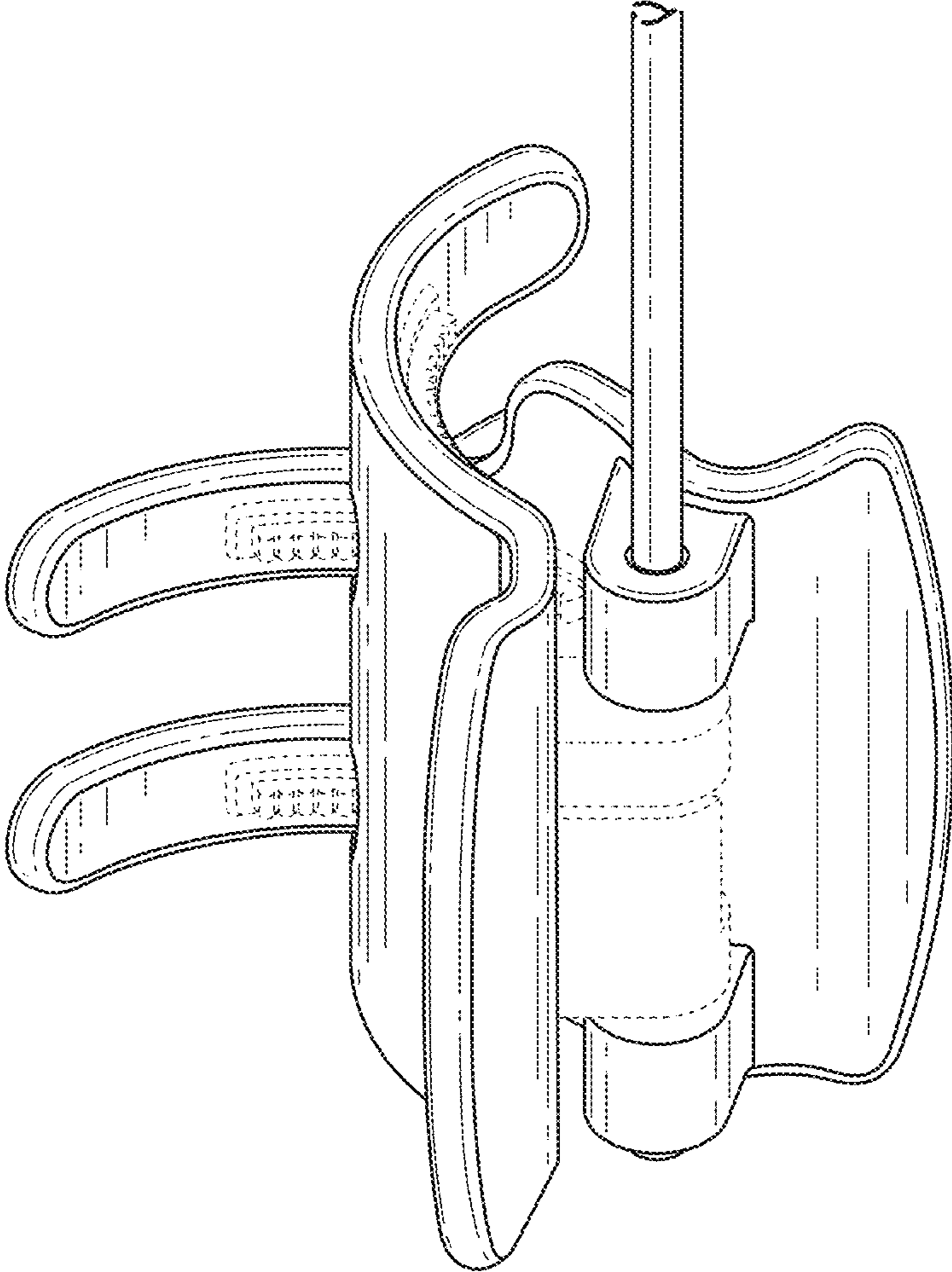

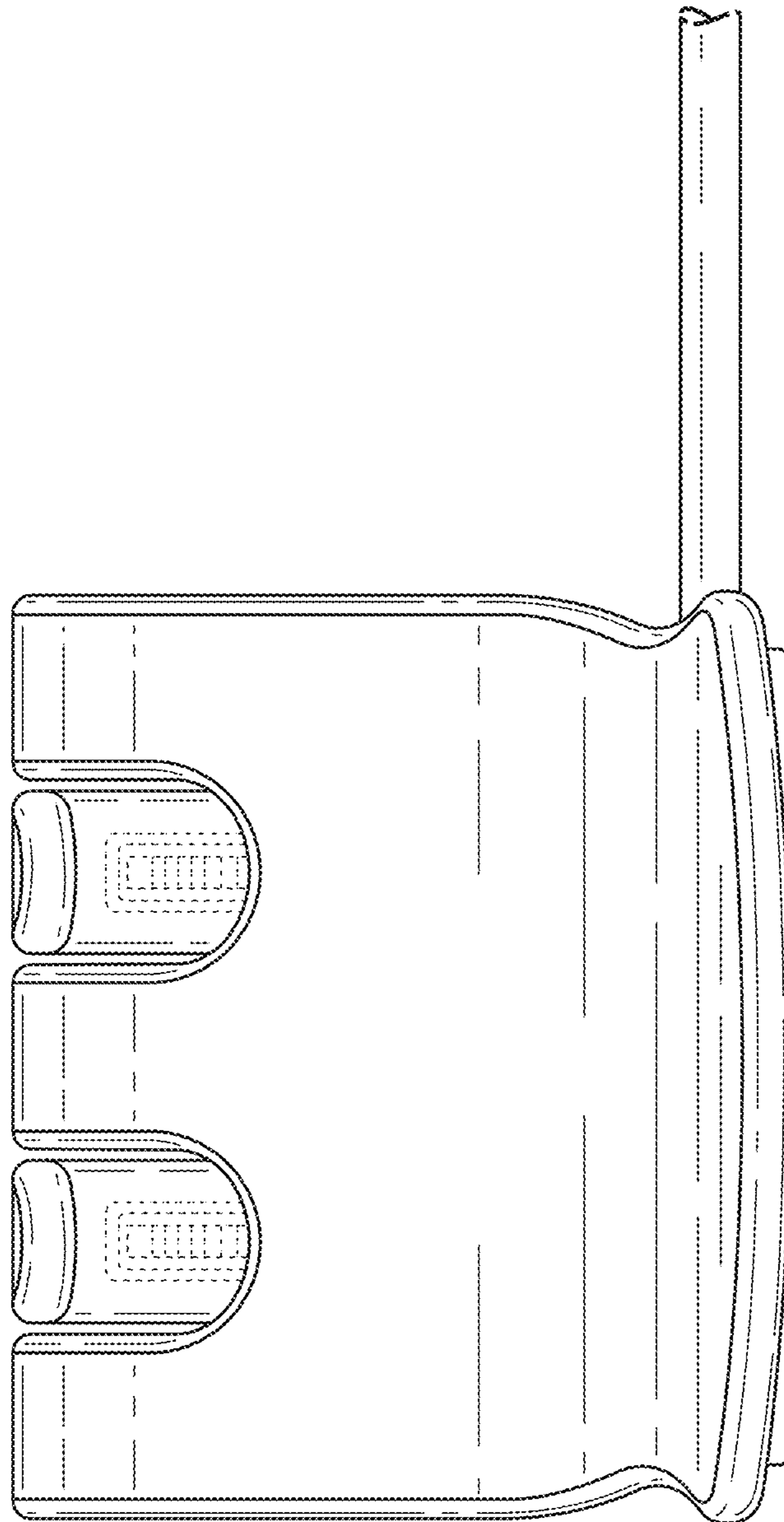

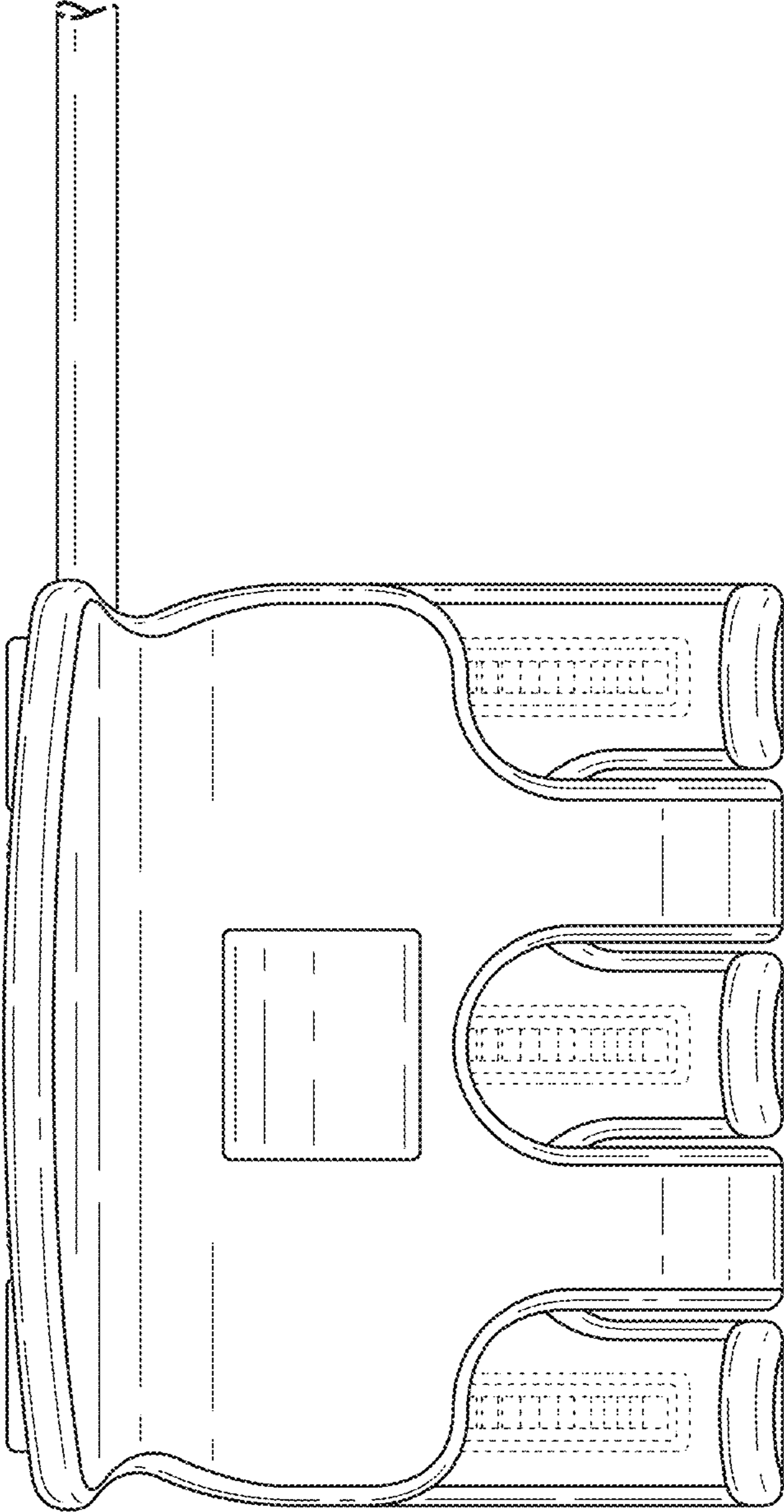

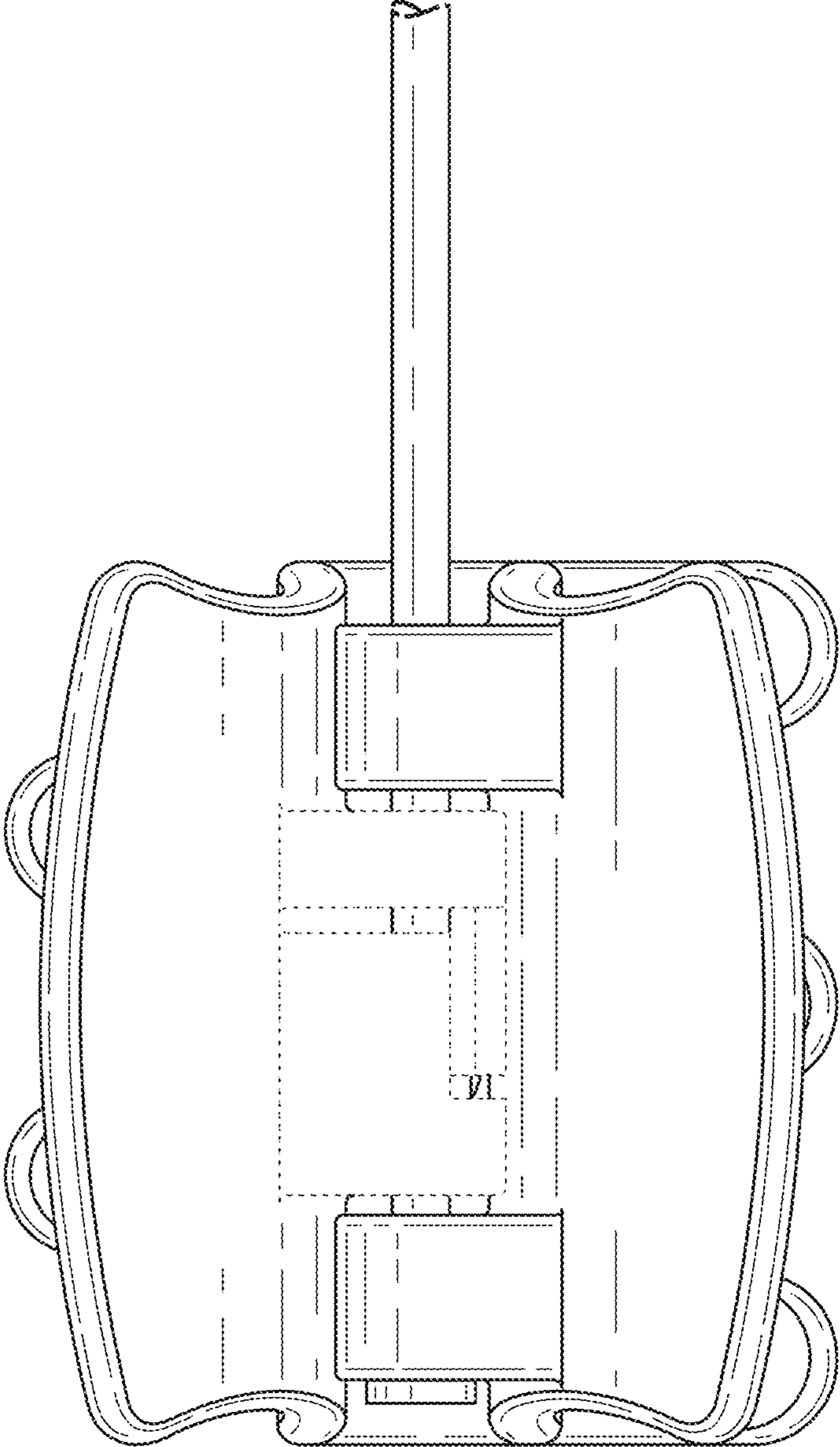

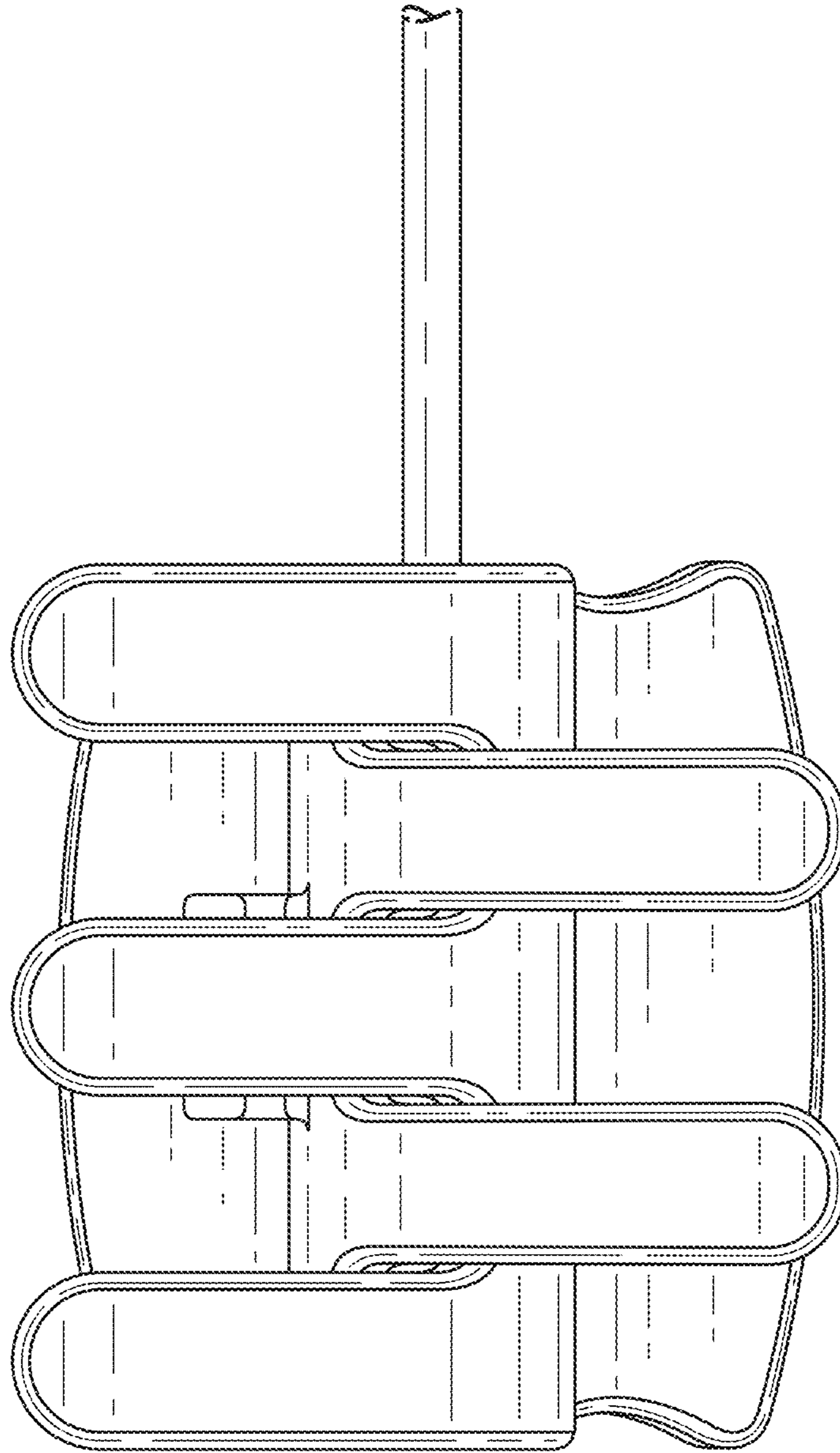

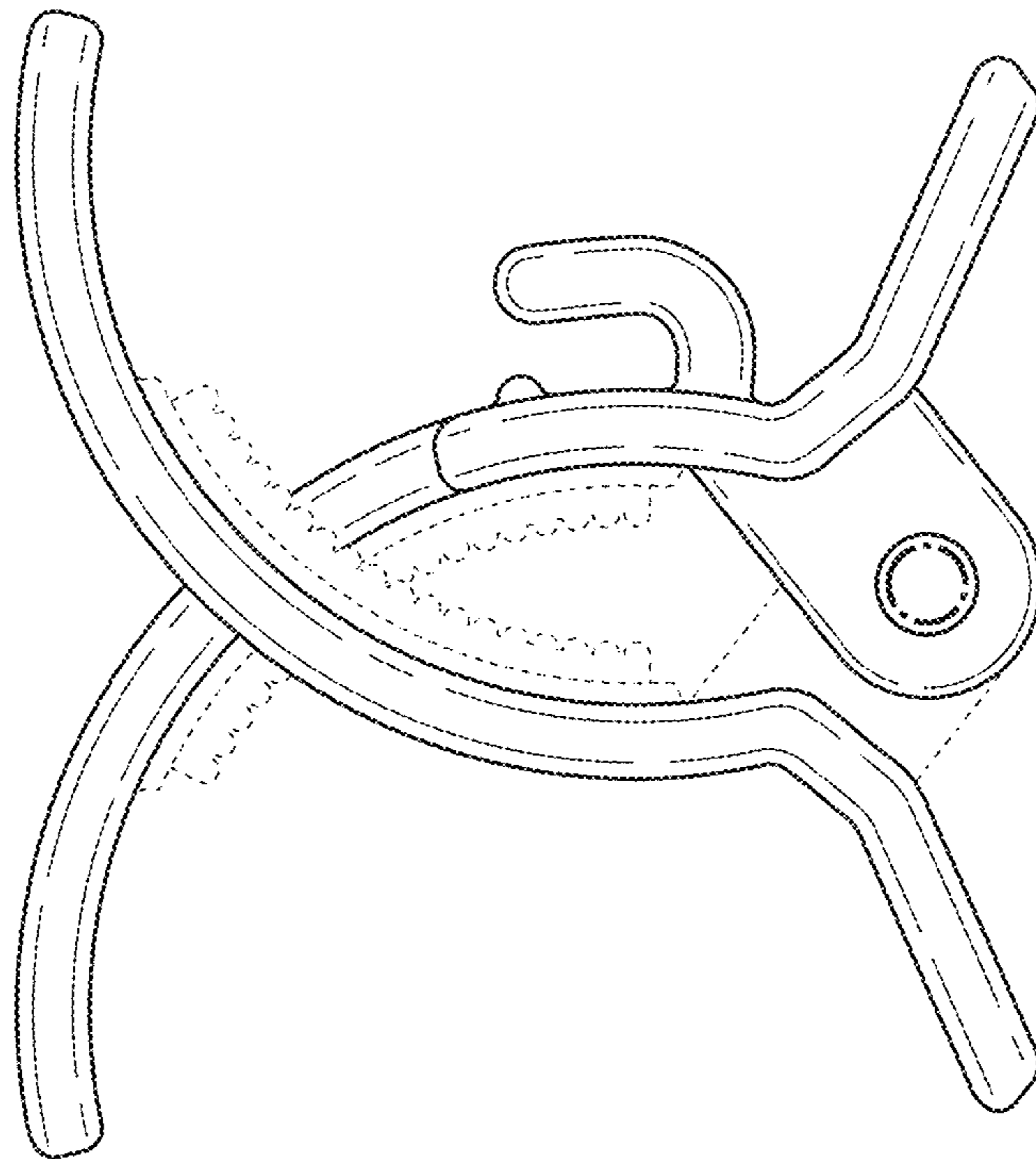

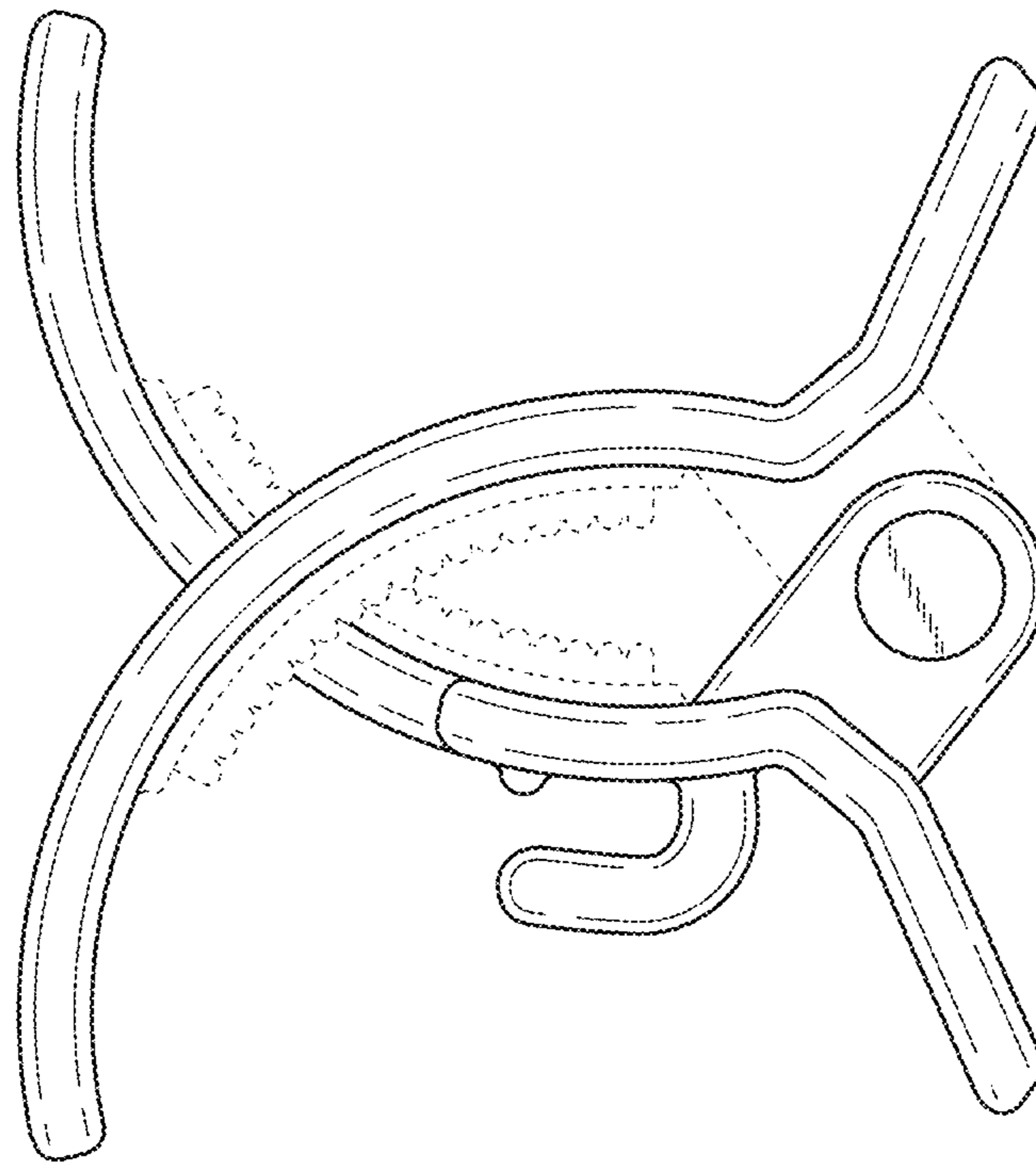

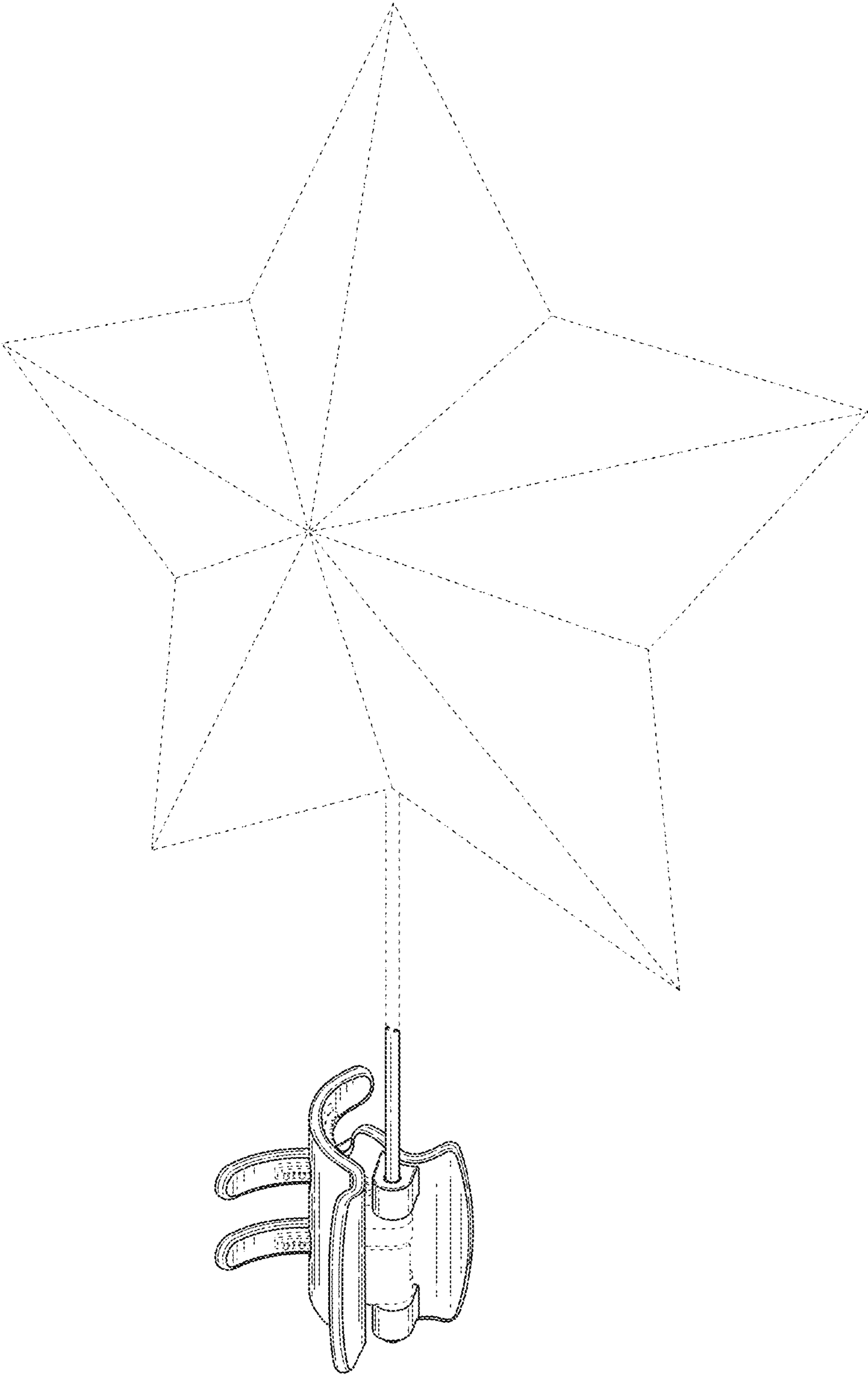

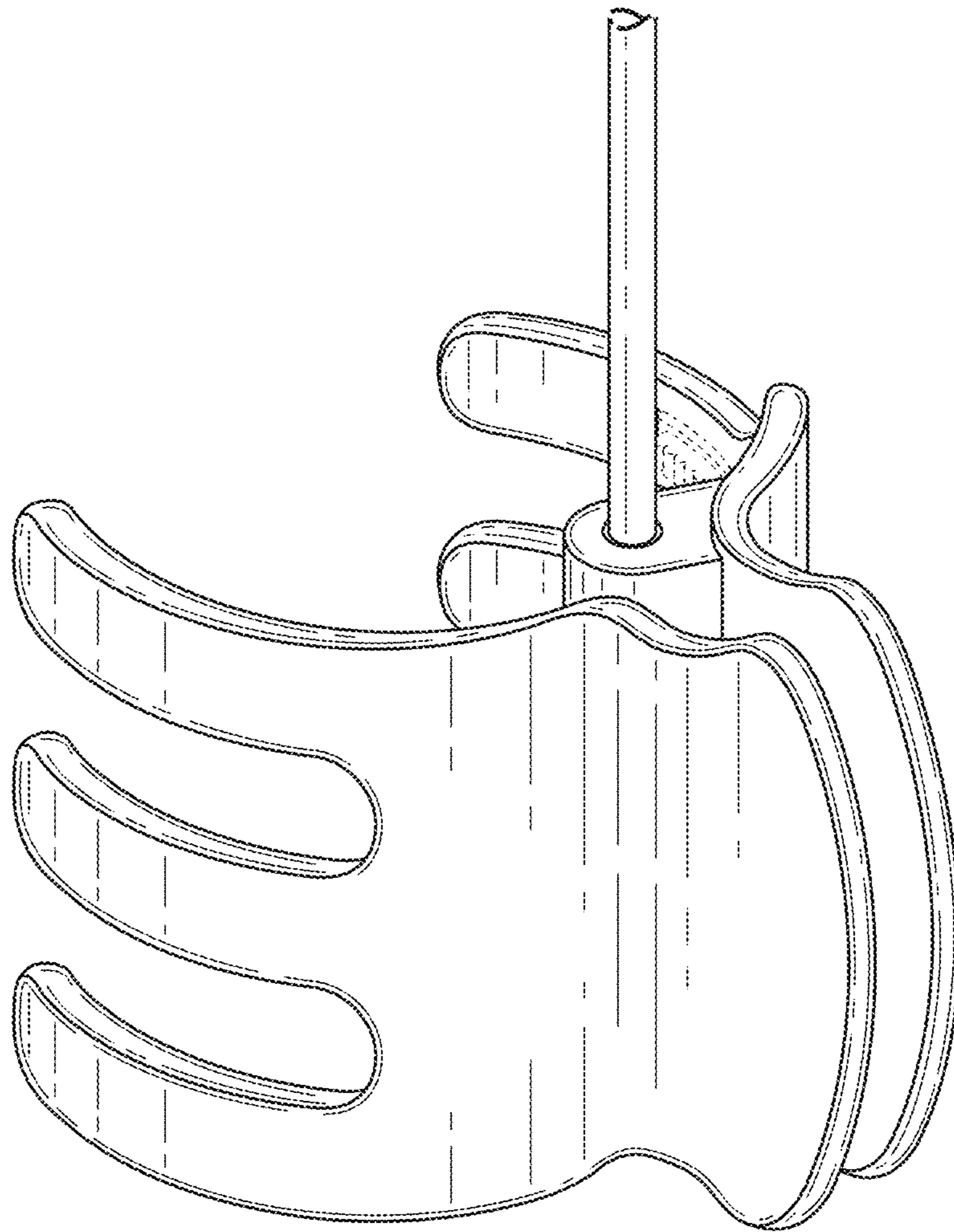

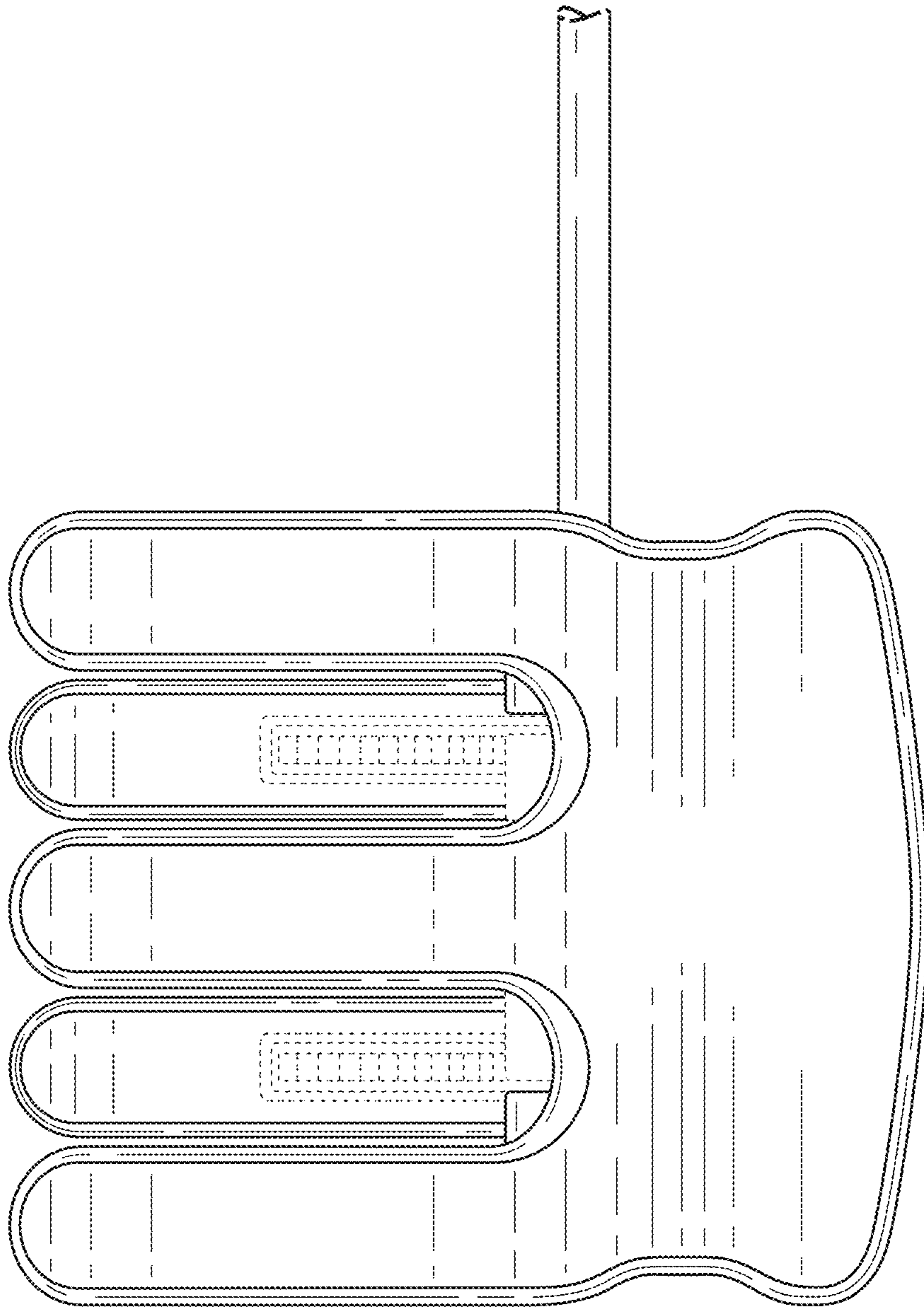

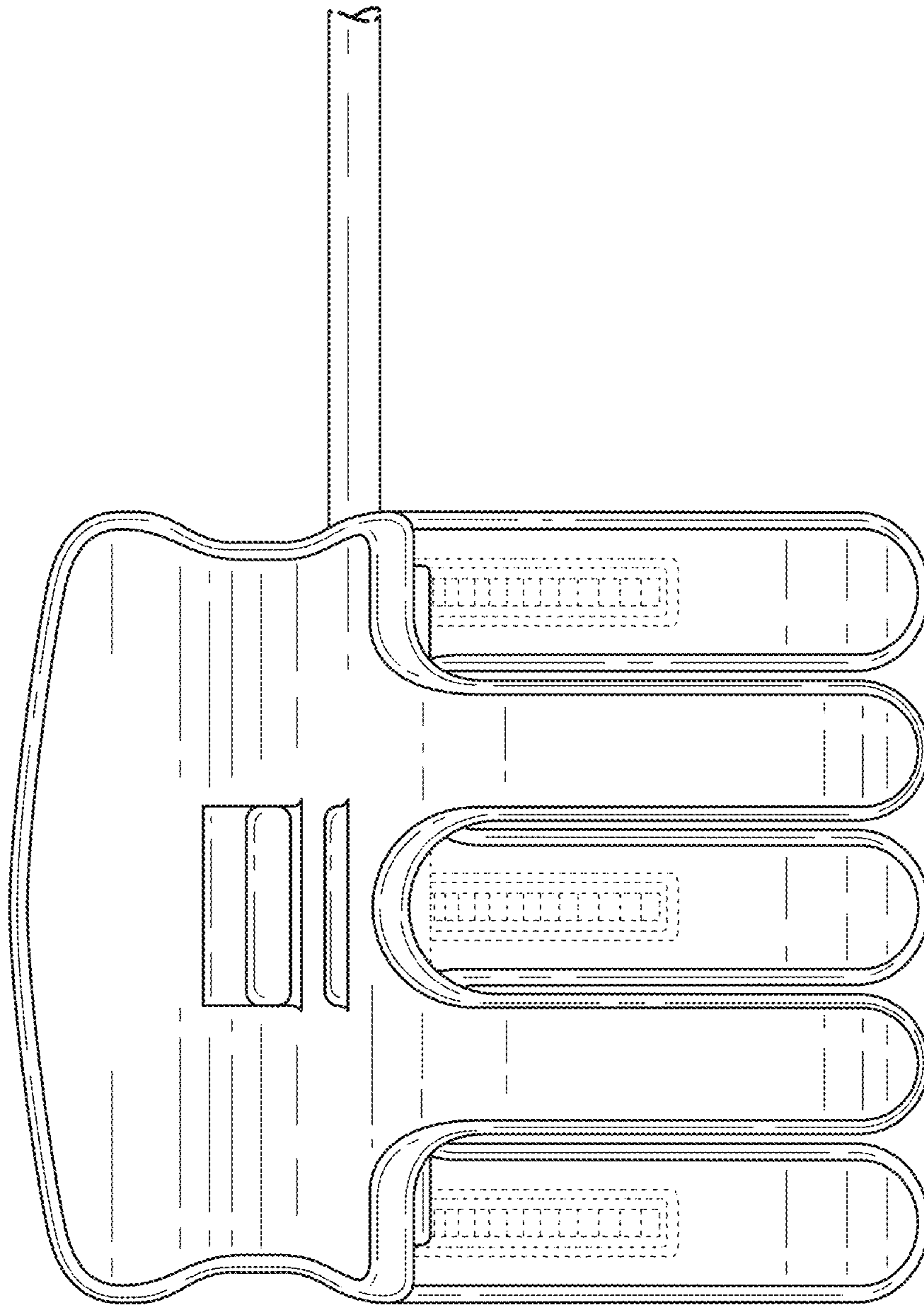

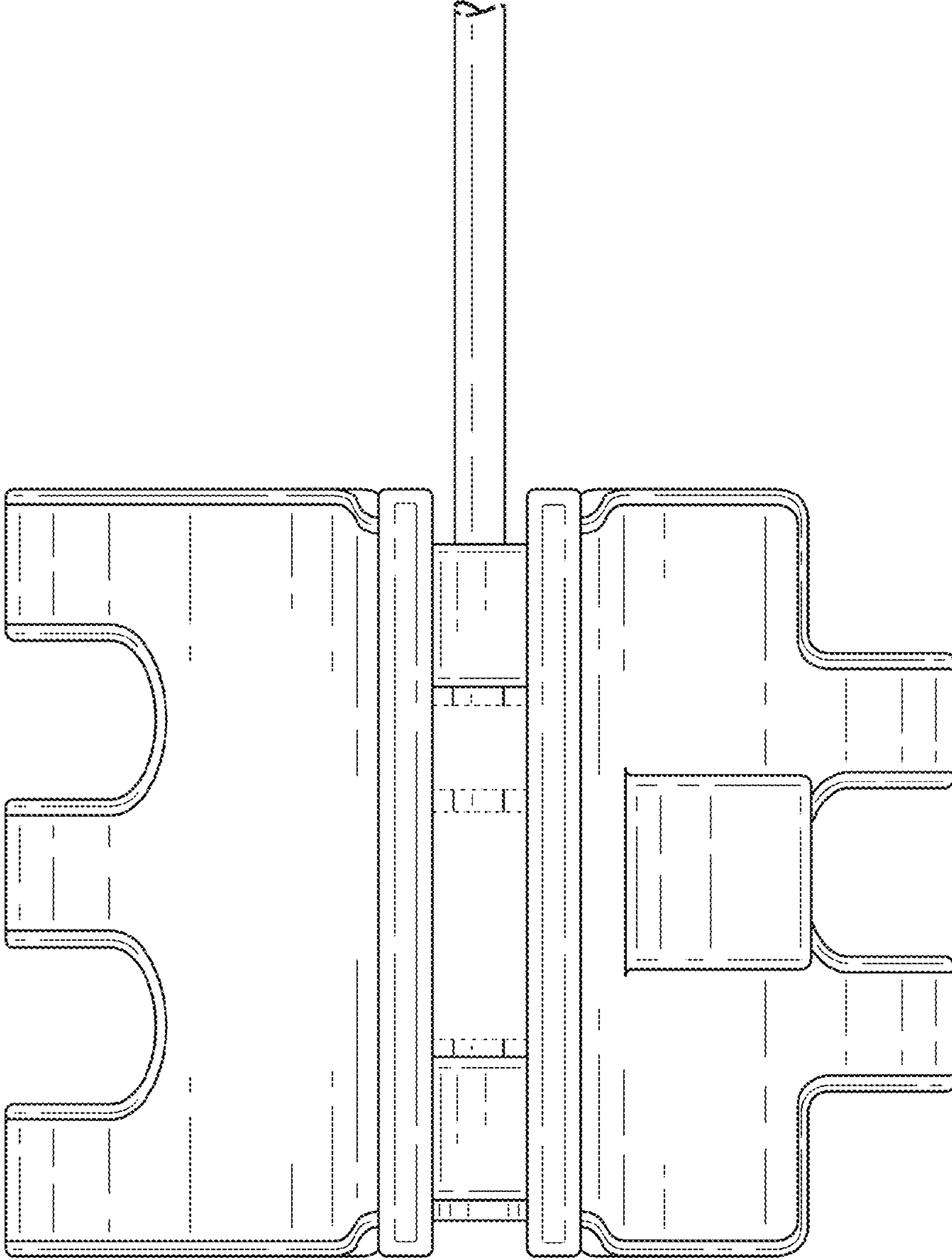

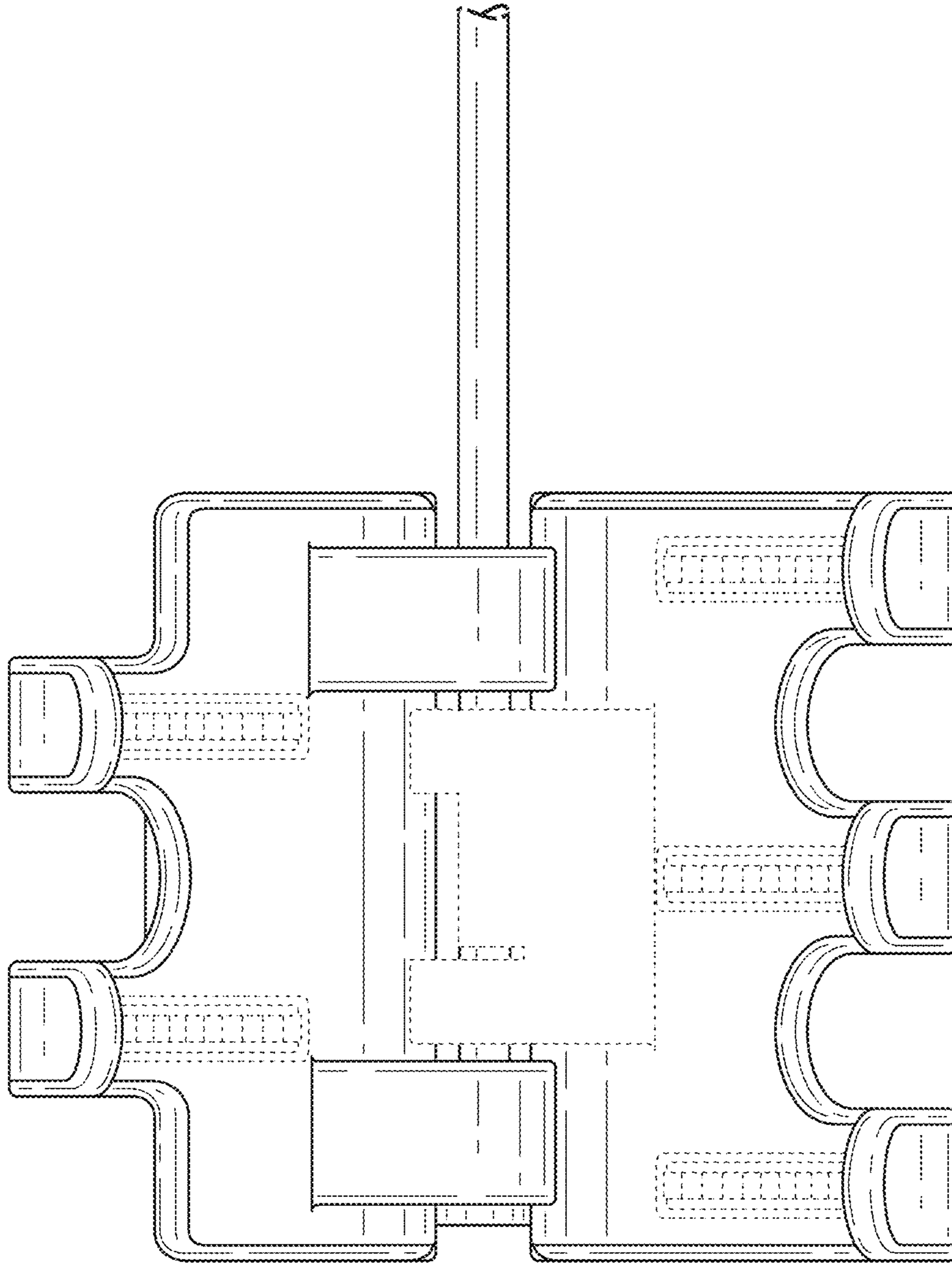

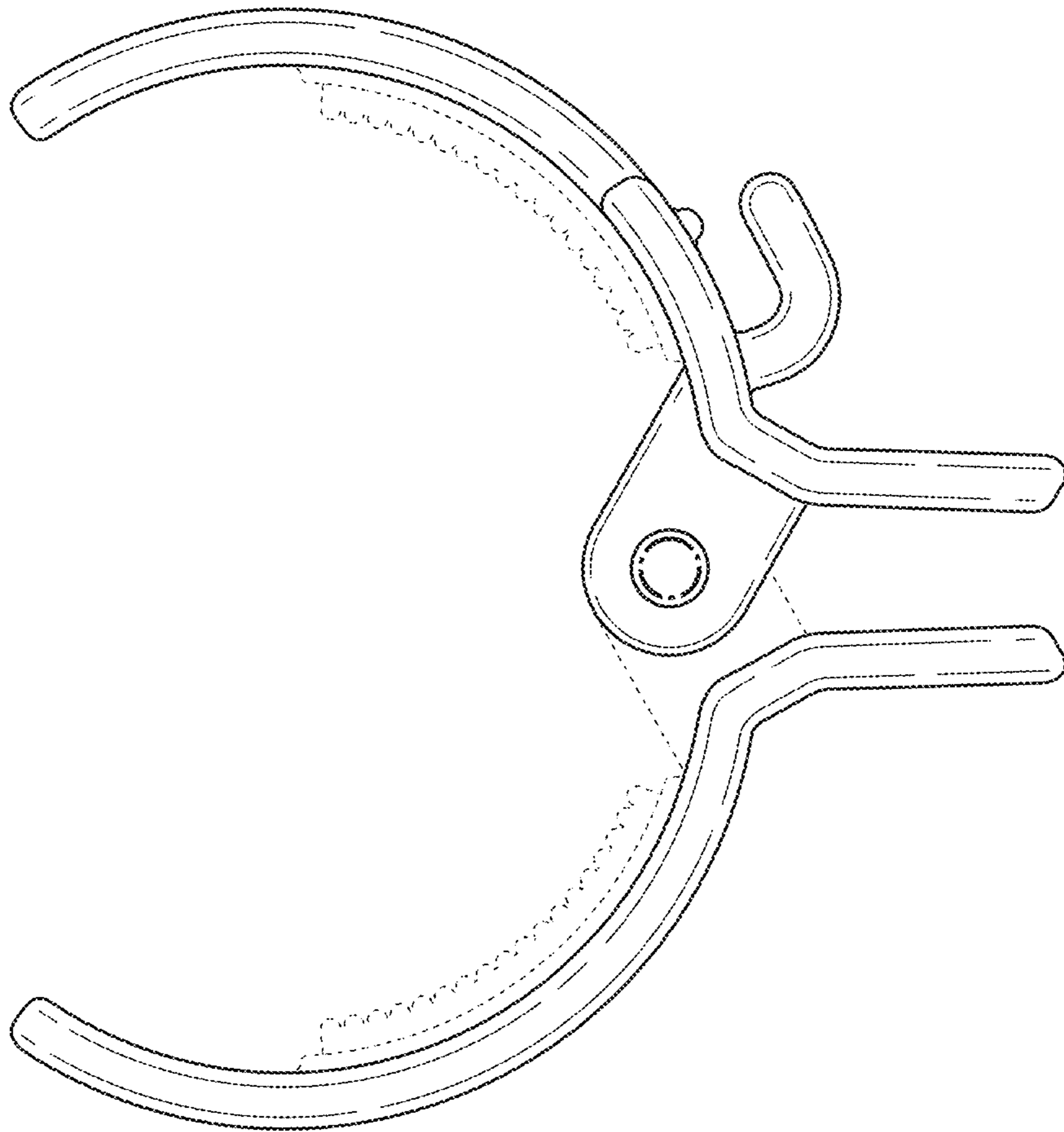

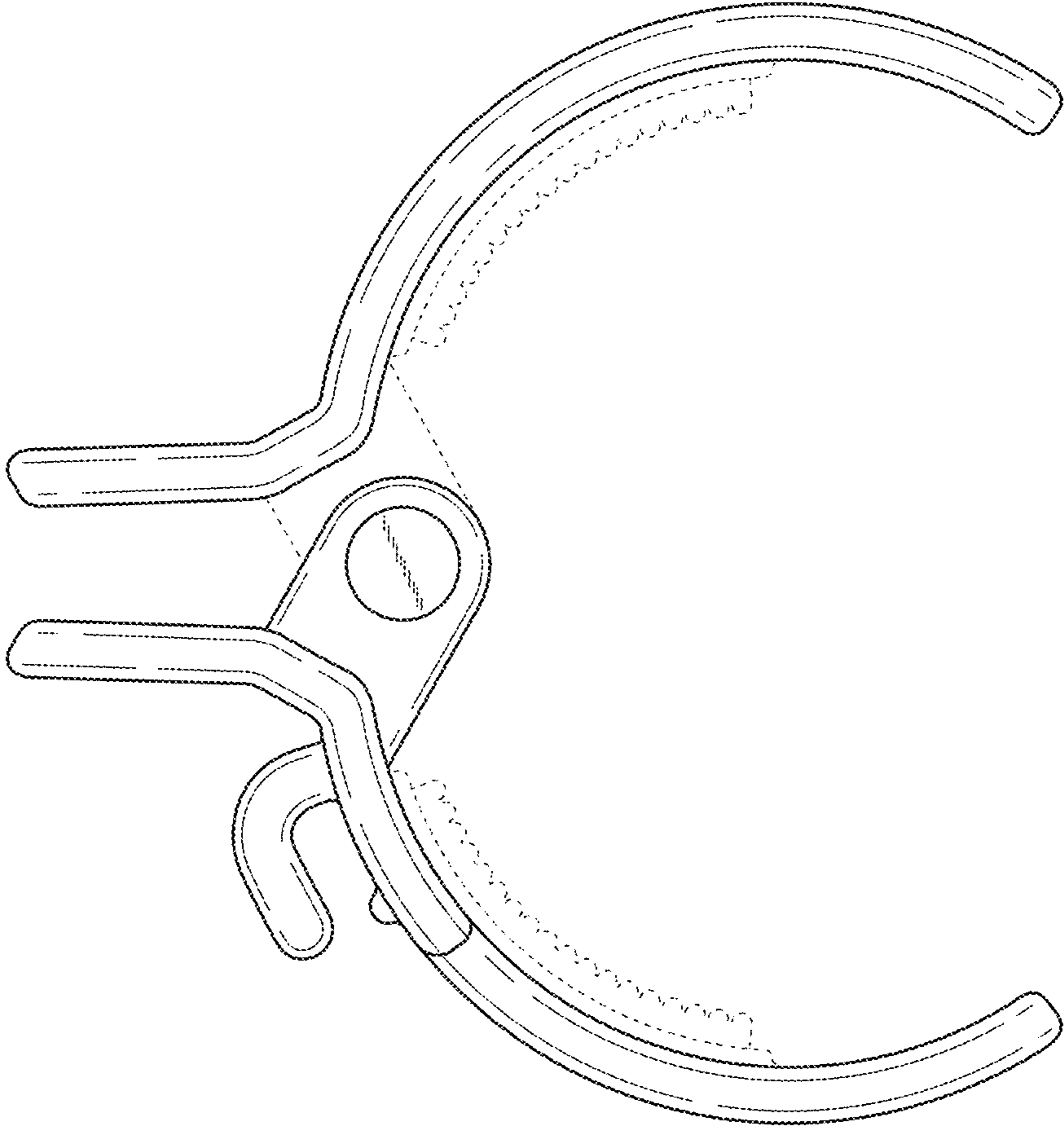
