The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof; the left side being a mirror image thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a perspective view of a bottle when the cap is removed, wherein the broken lines depict portions of the bottle that form no part of claimed design.

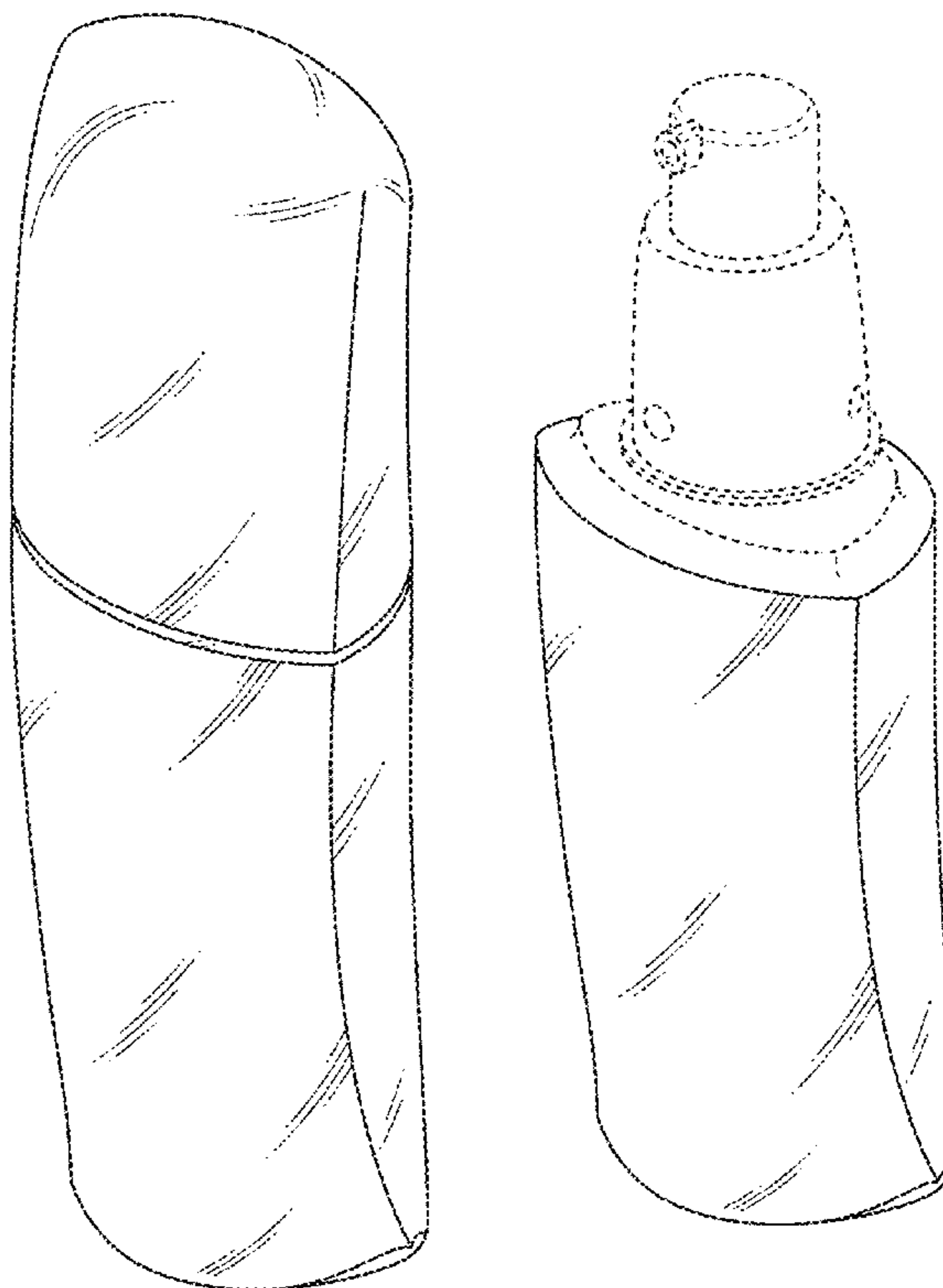

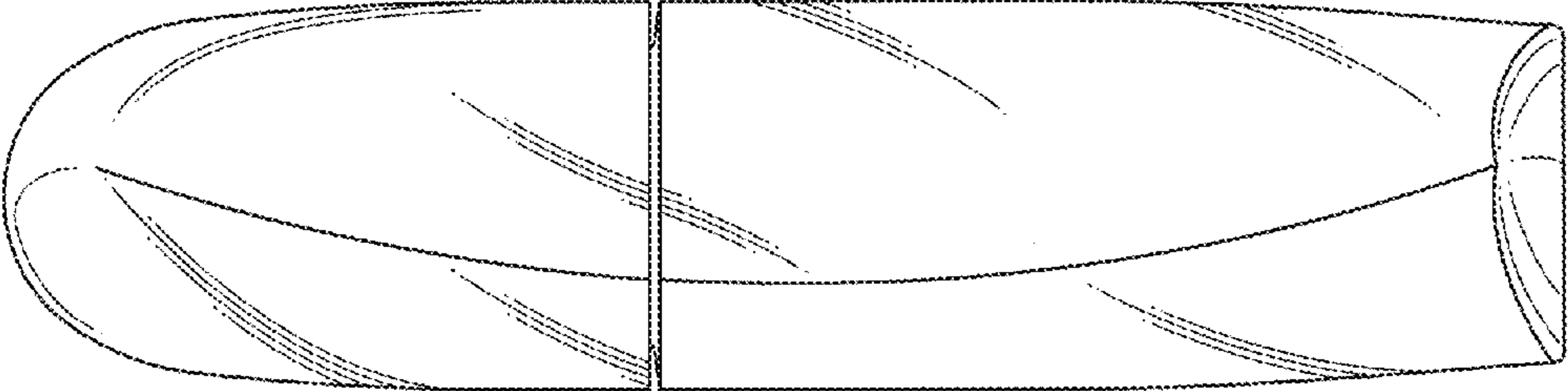

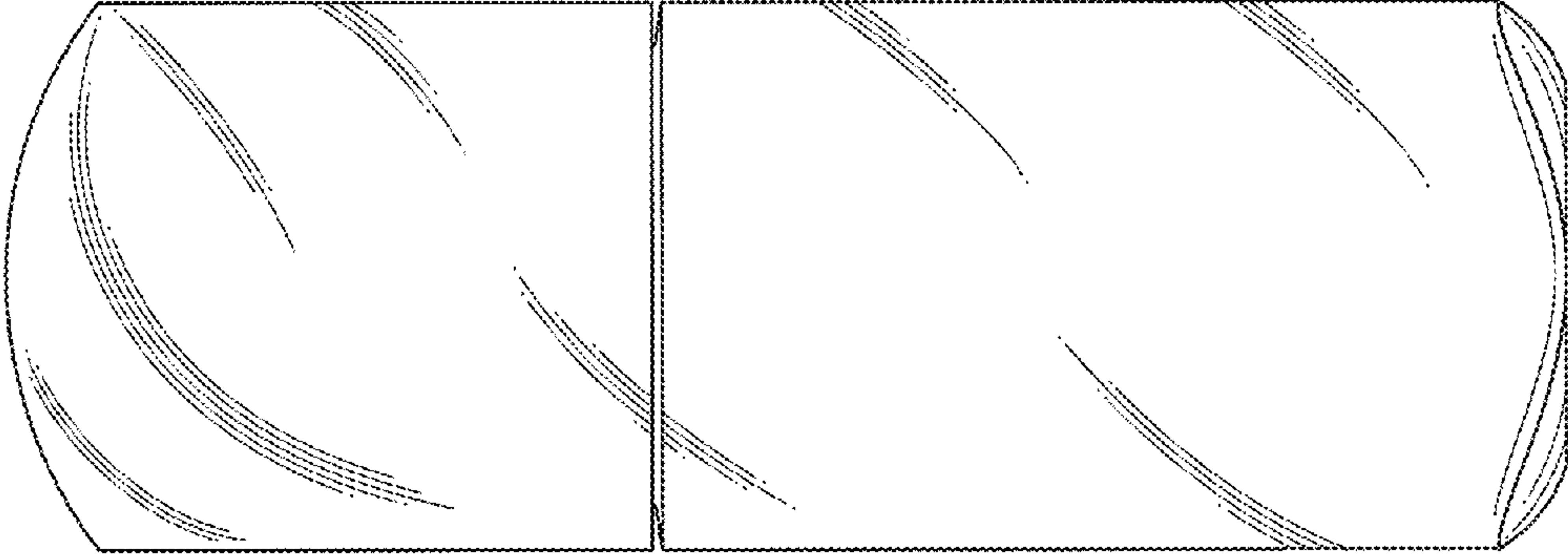

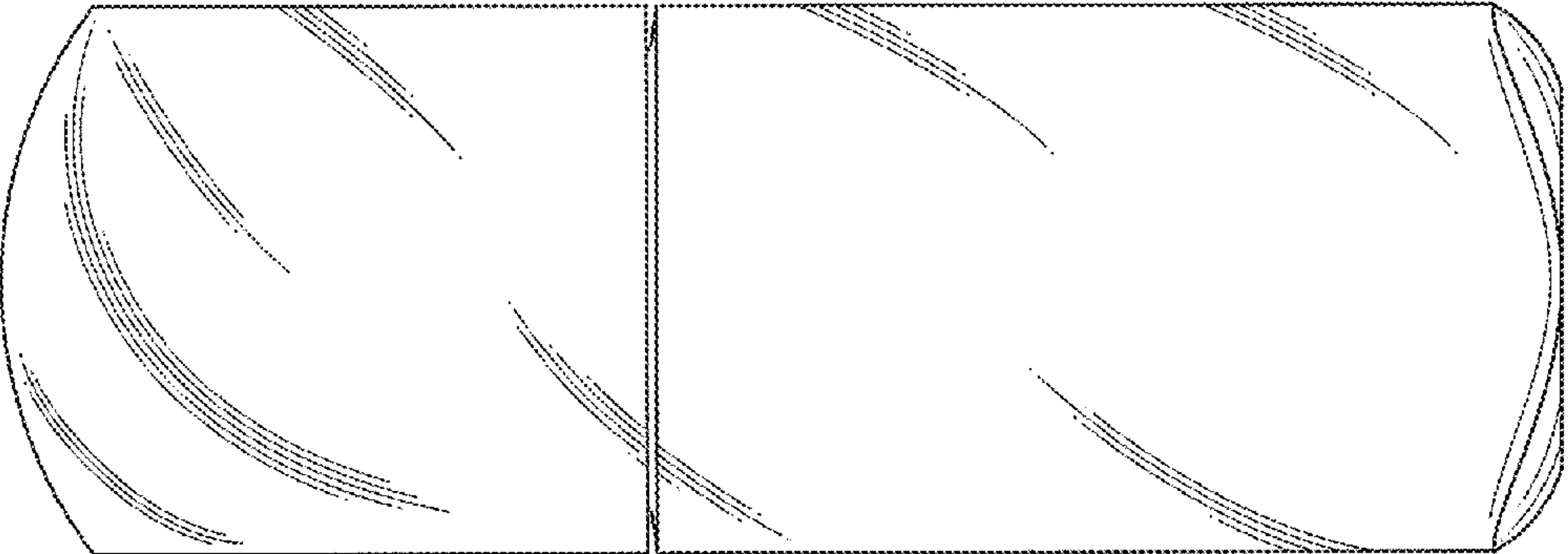

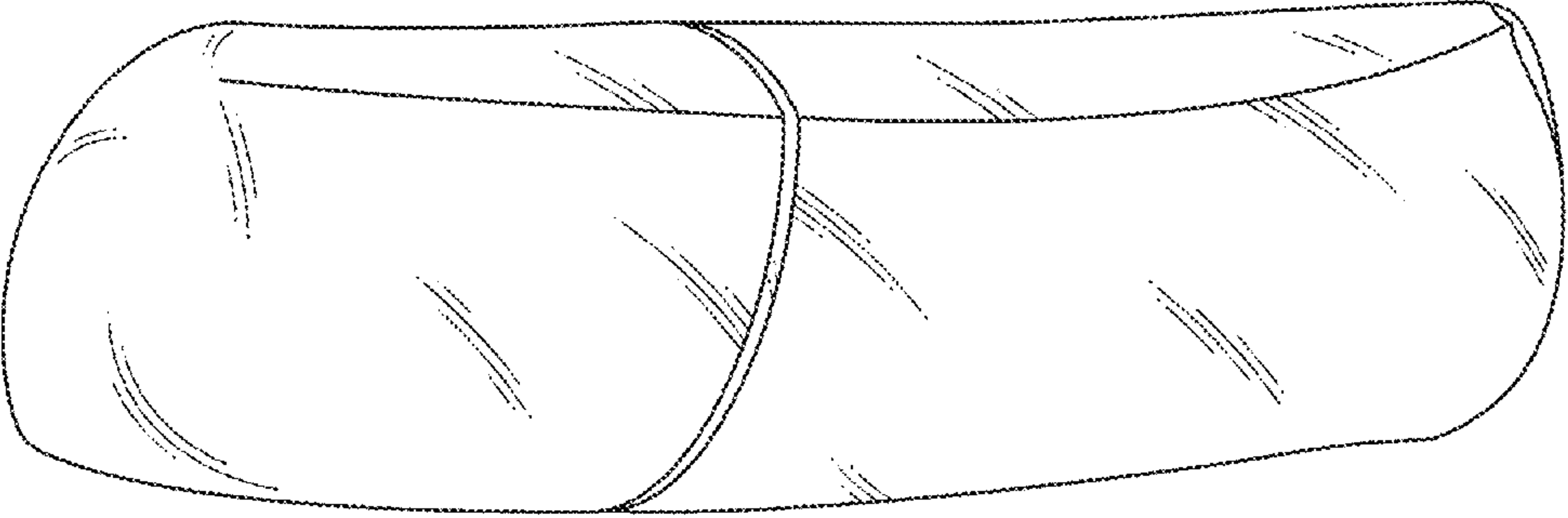

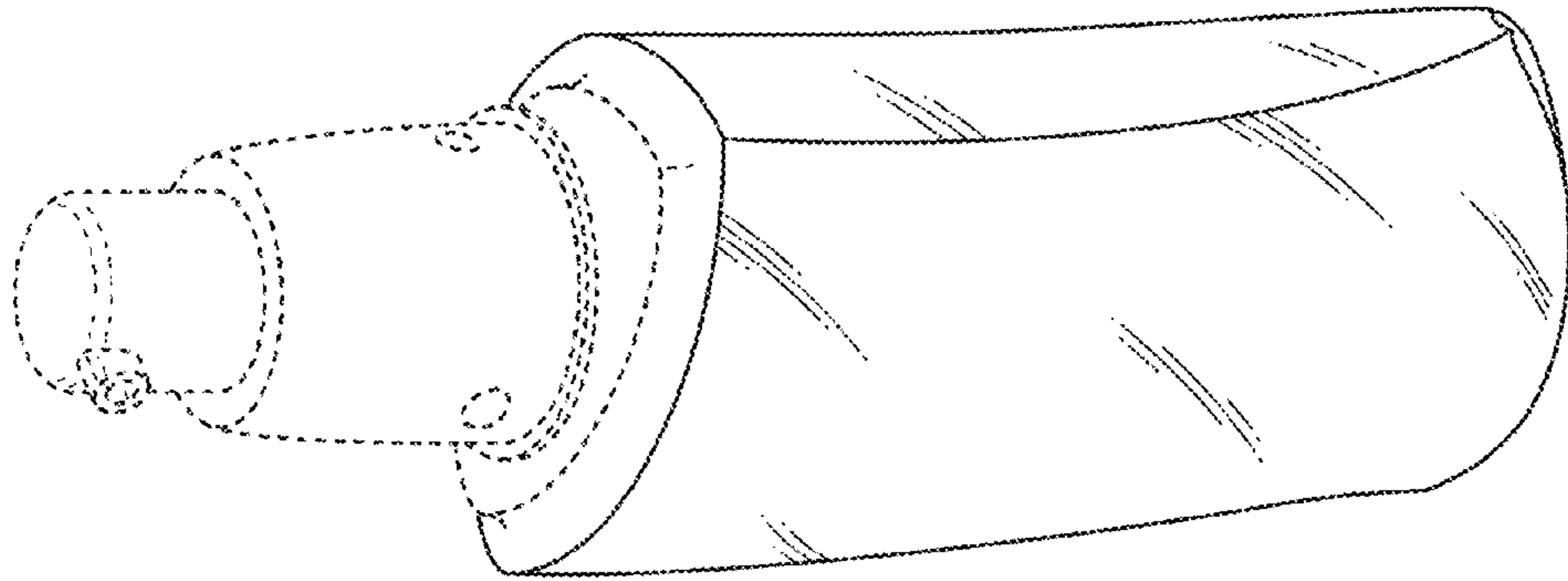

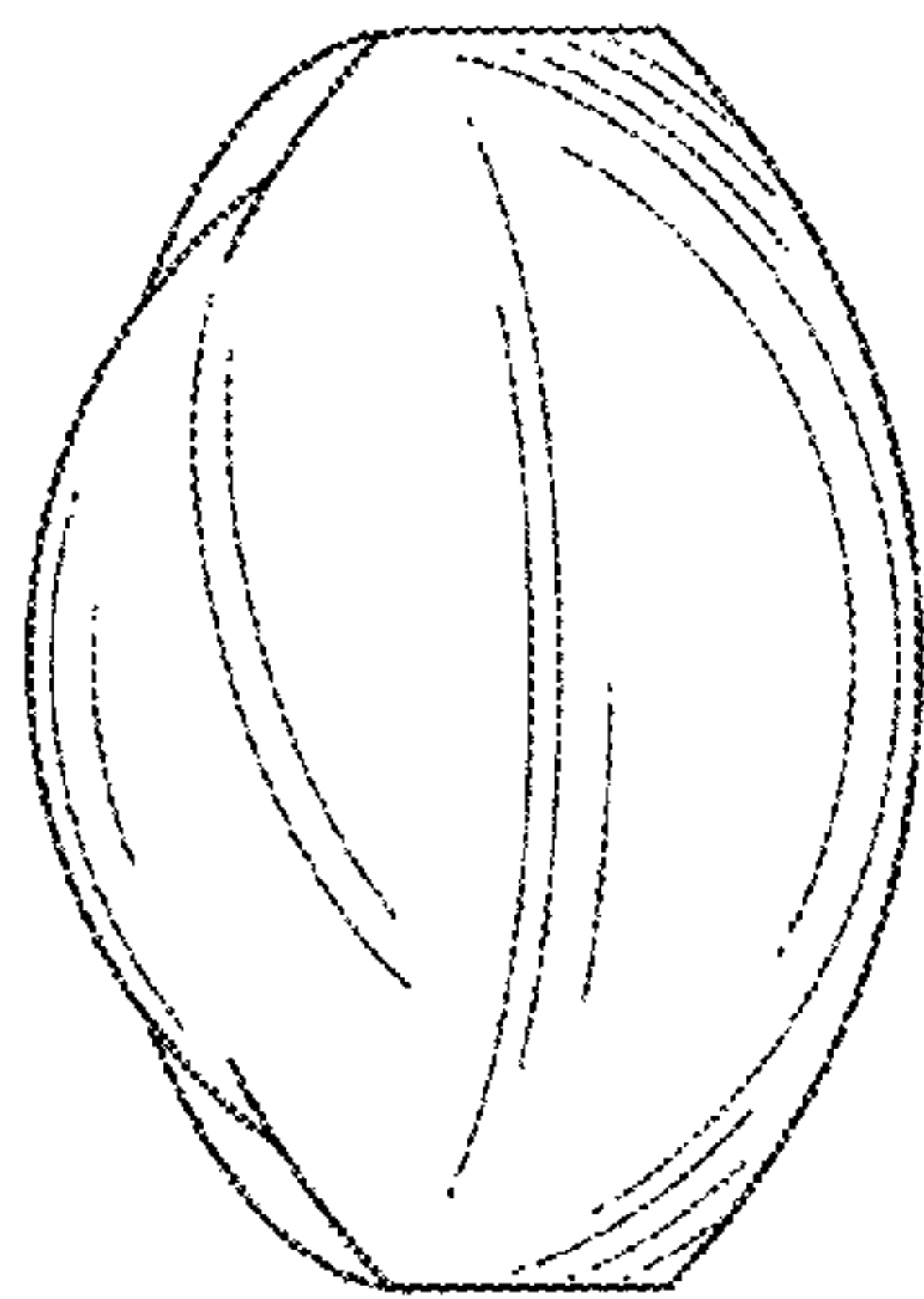
