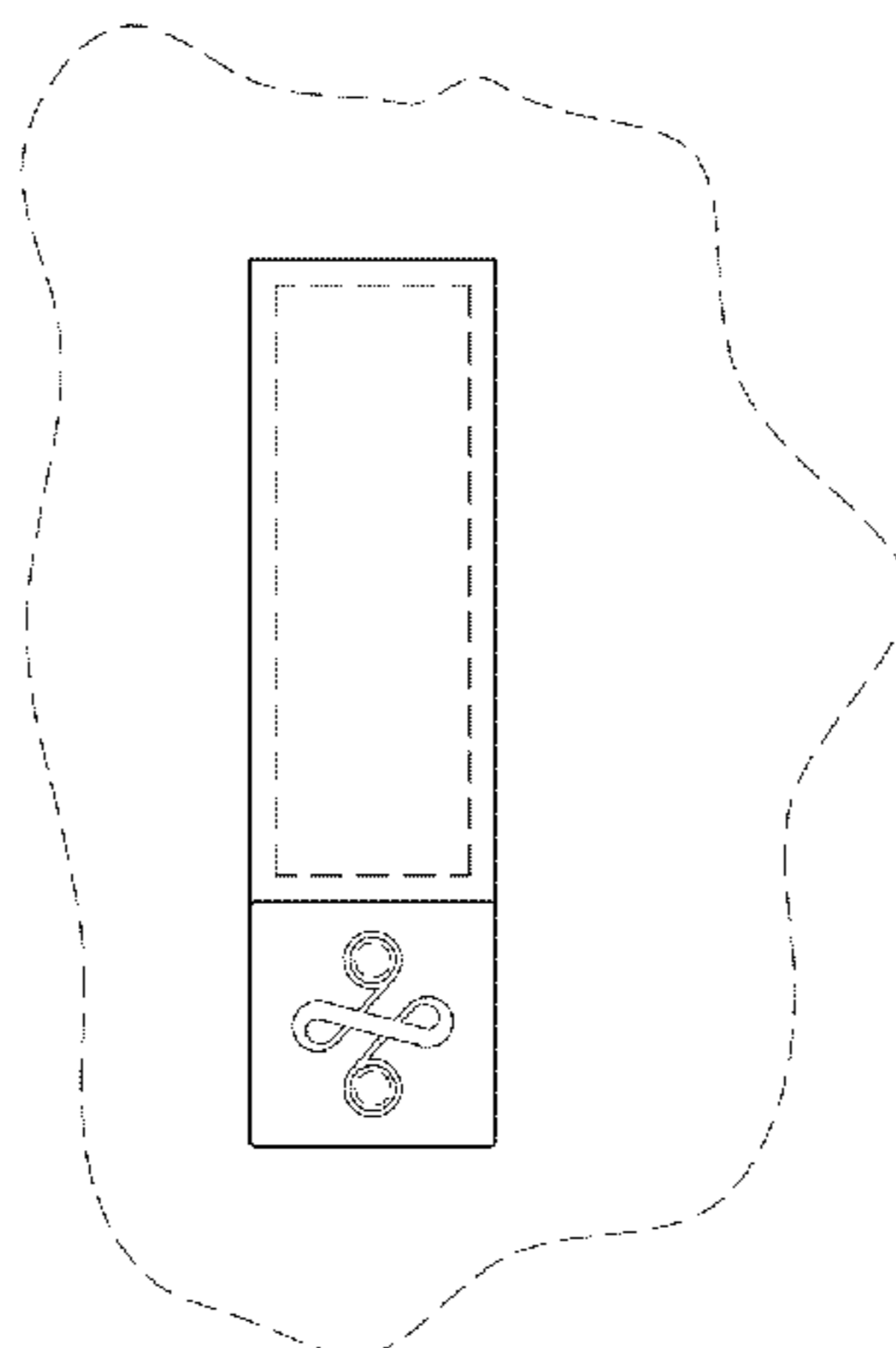
(57) **CLAIM**

We claim the ornamental design for a connection assembly, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a connection assembly showing our new design;

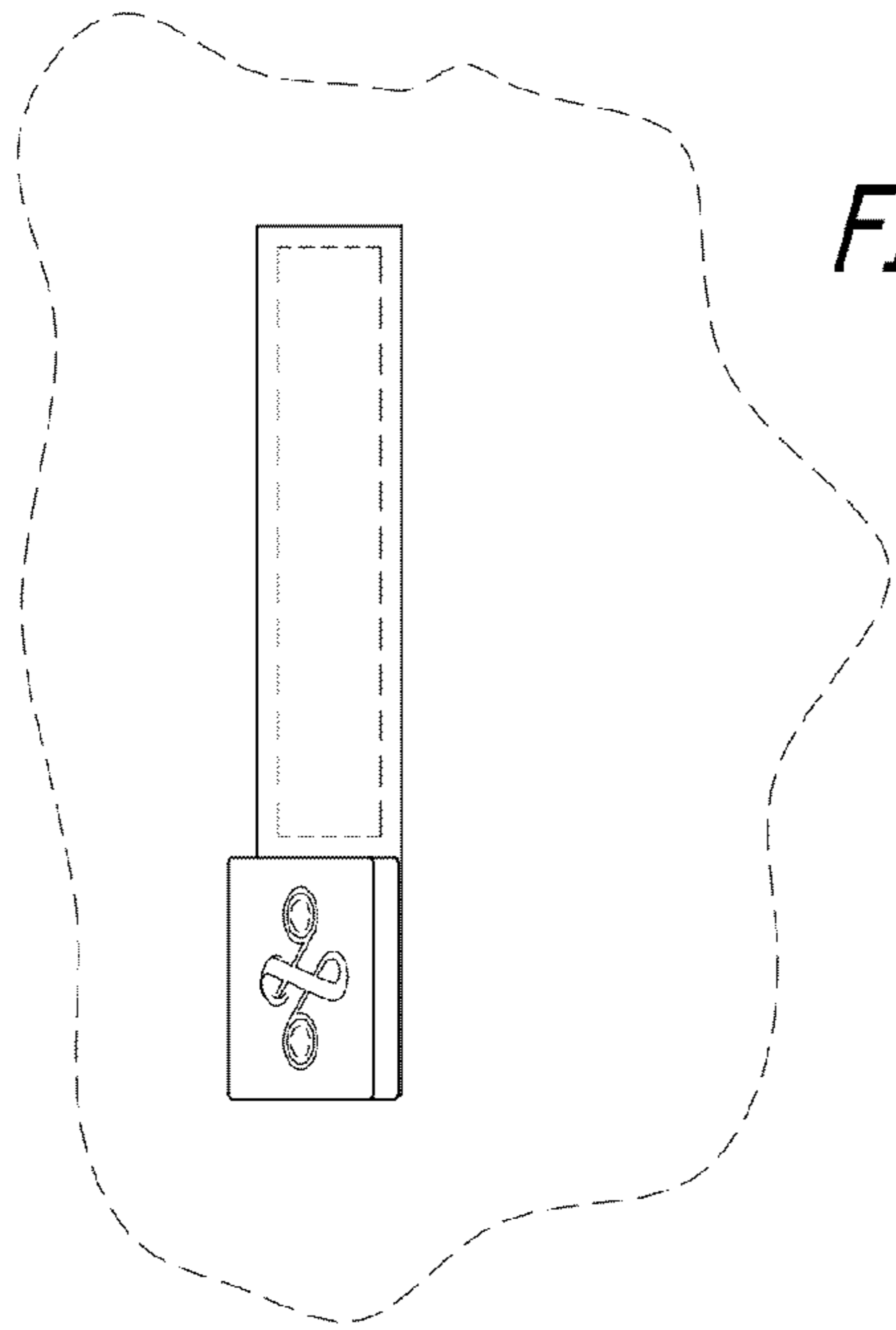

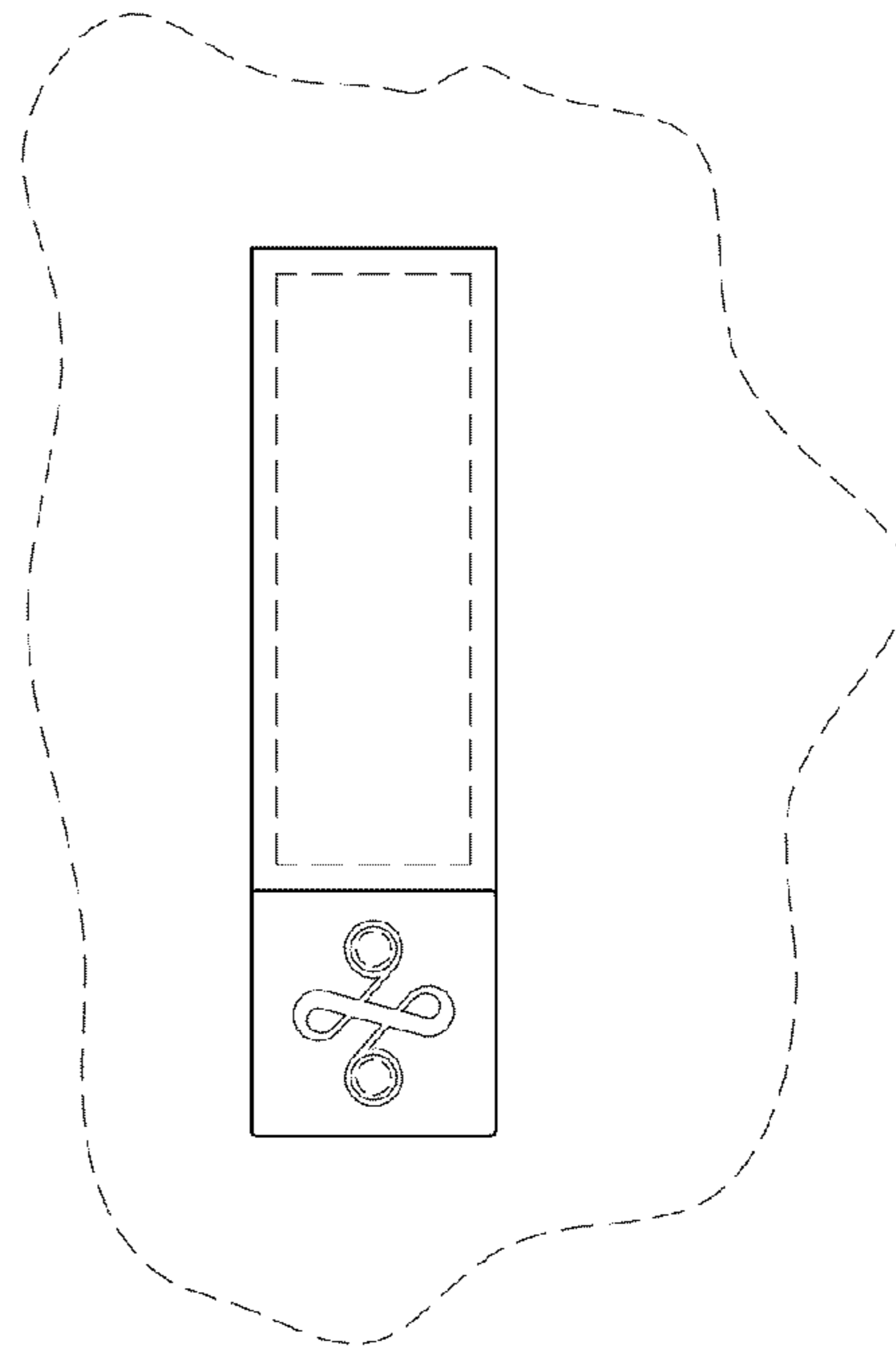

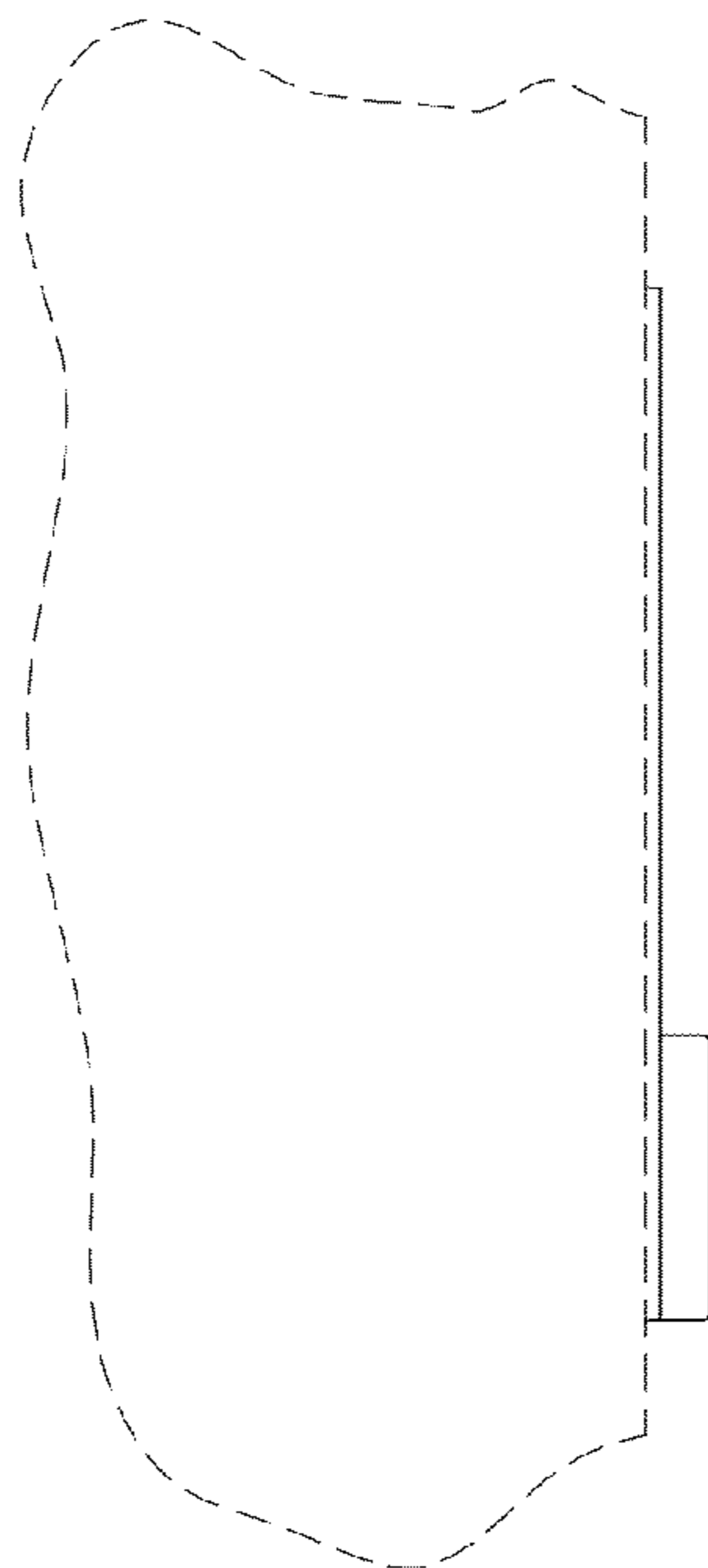

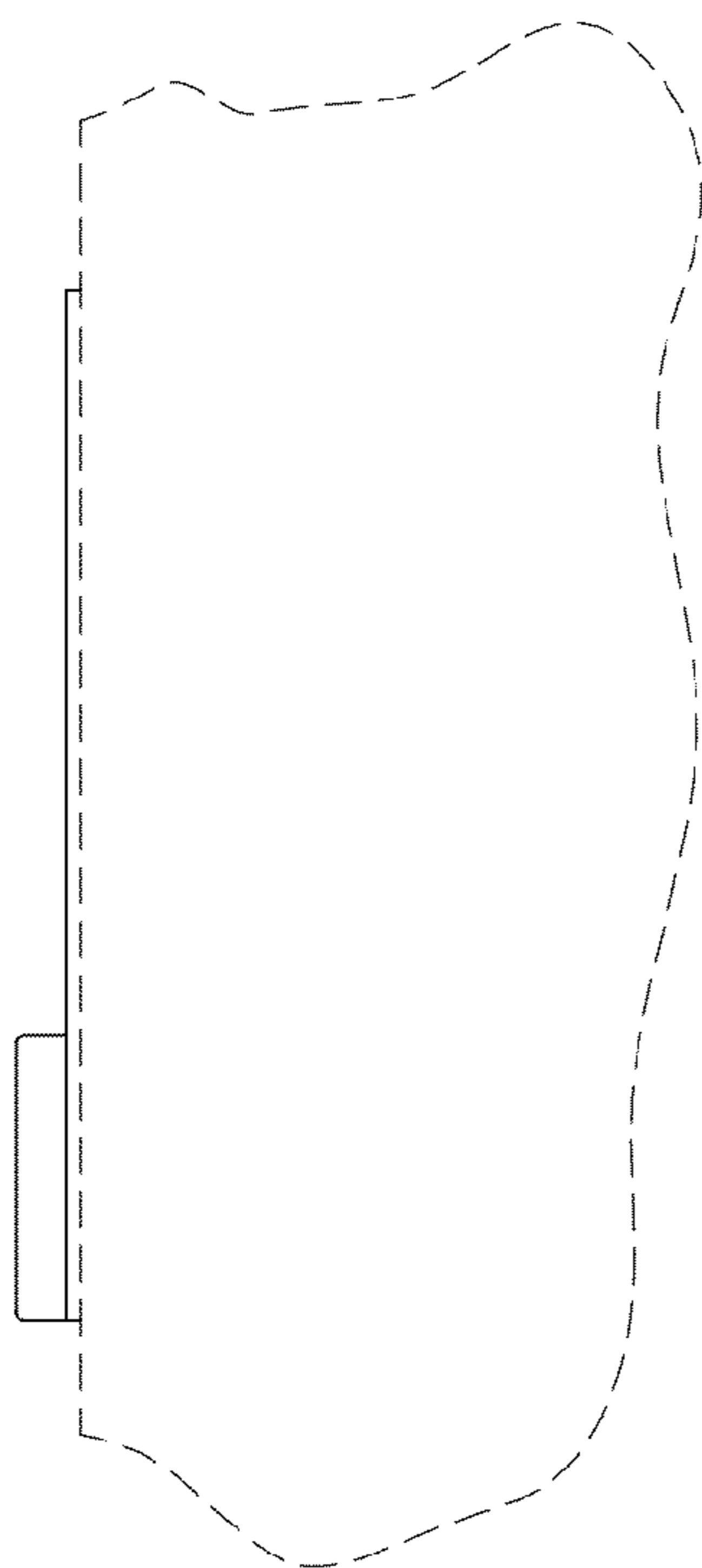

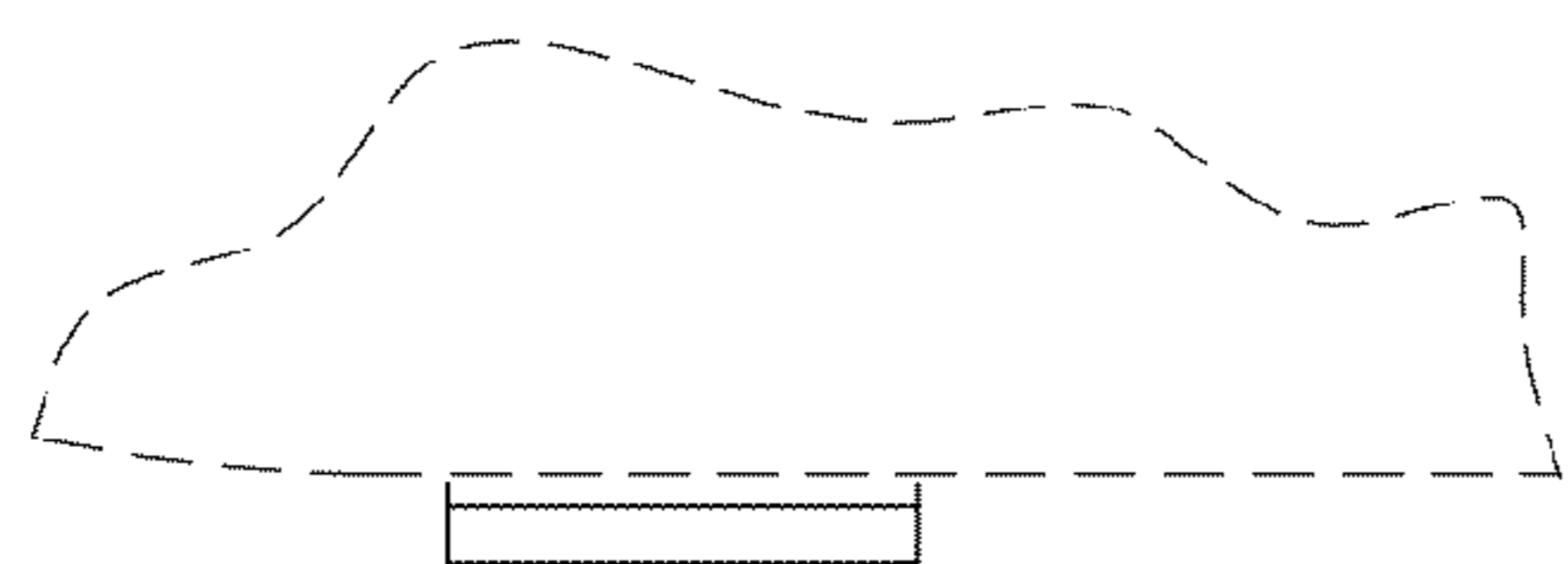
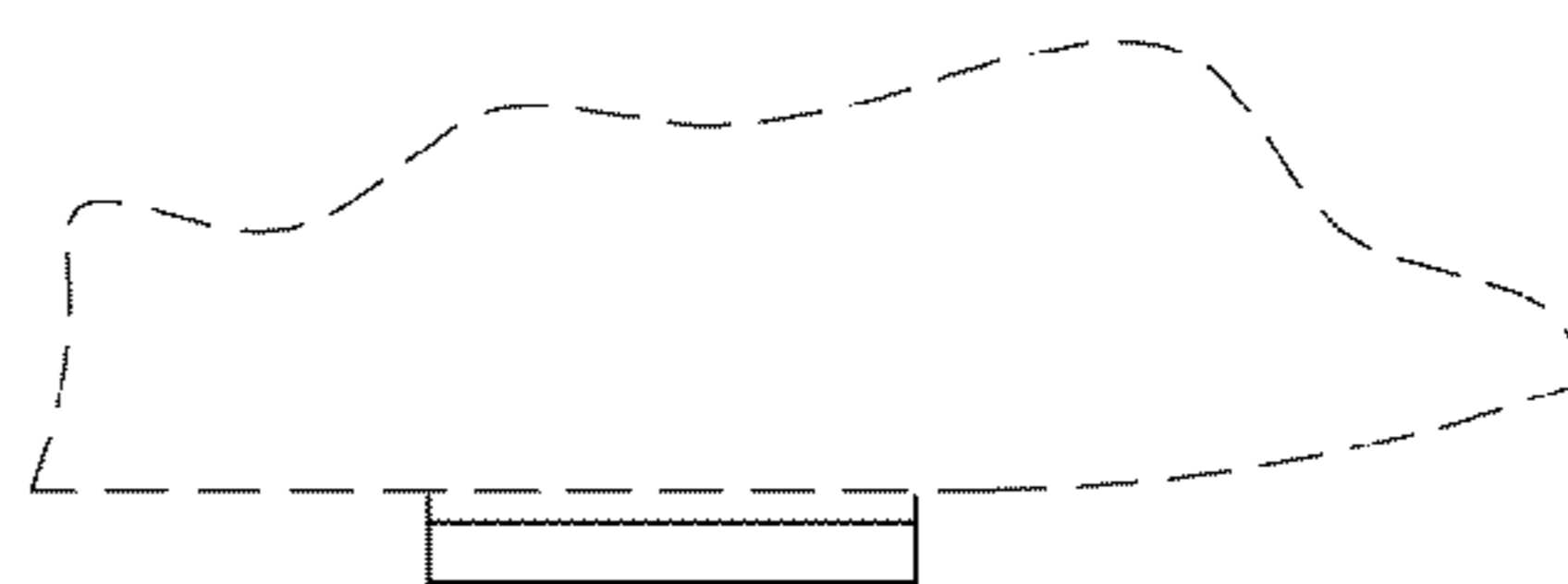

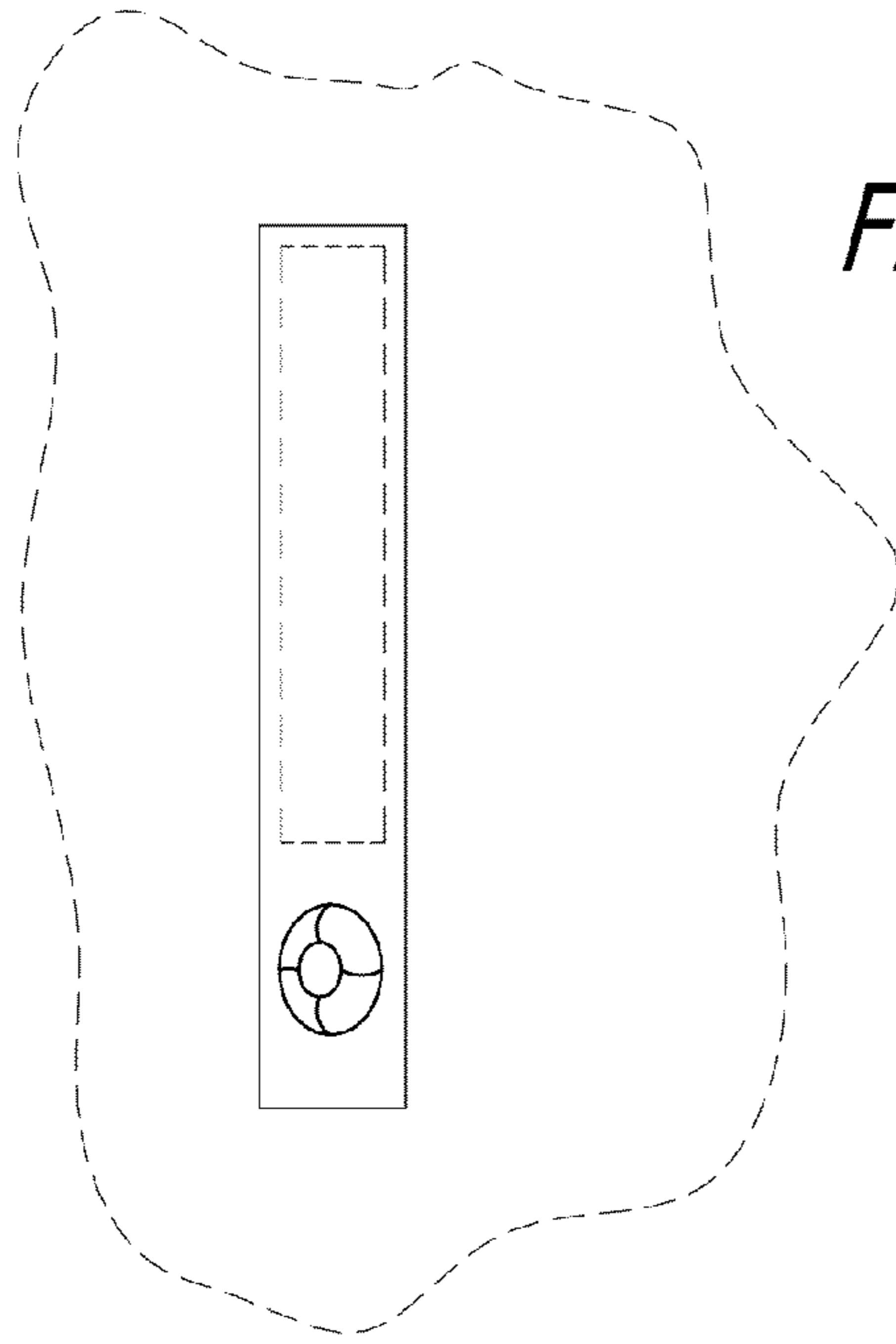

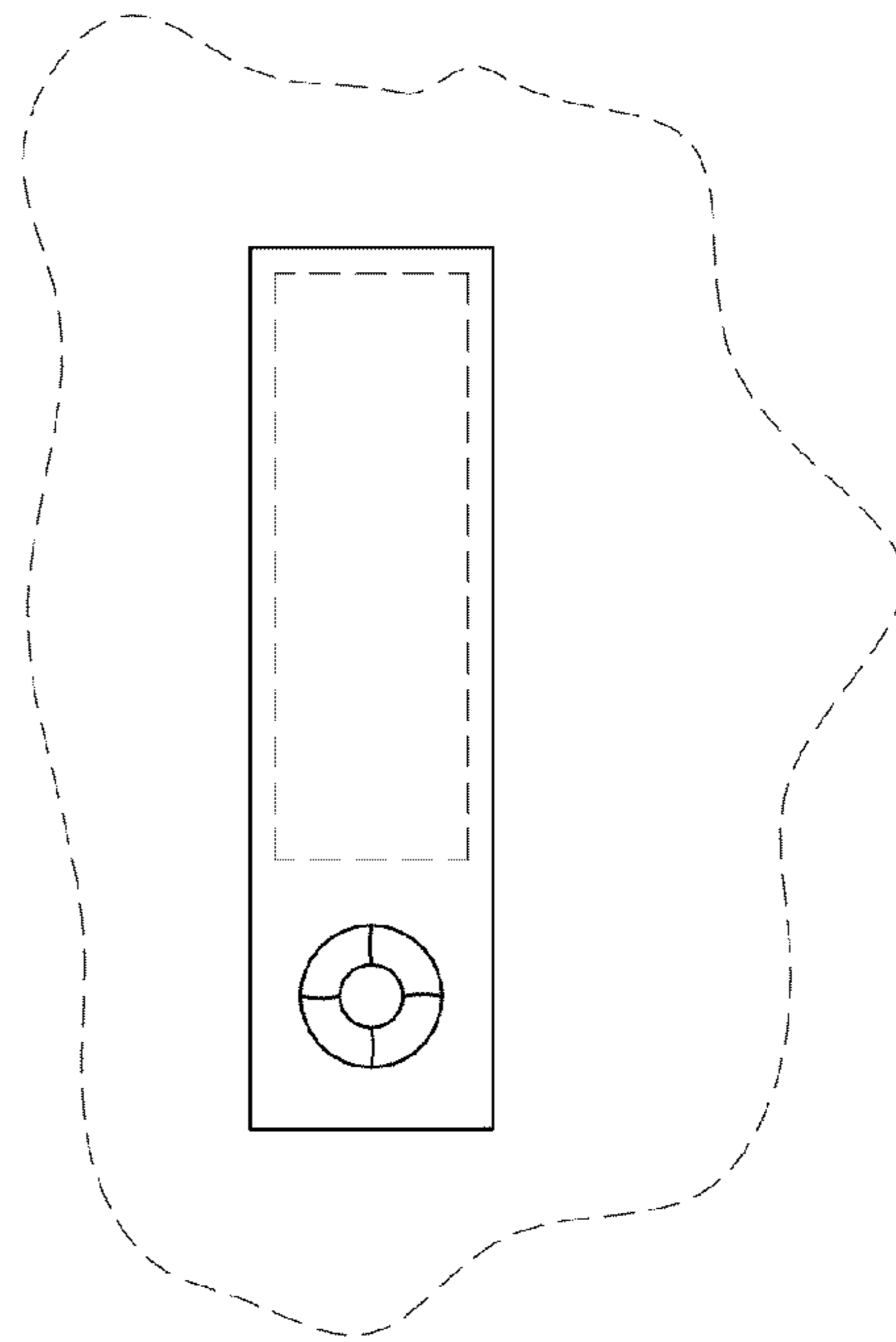

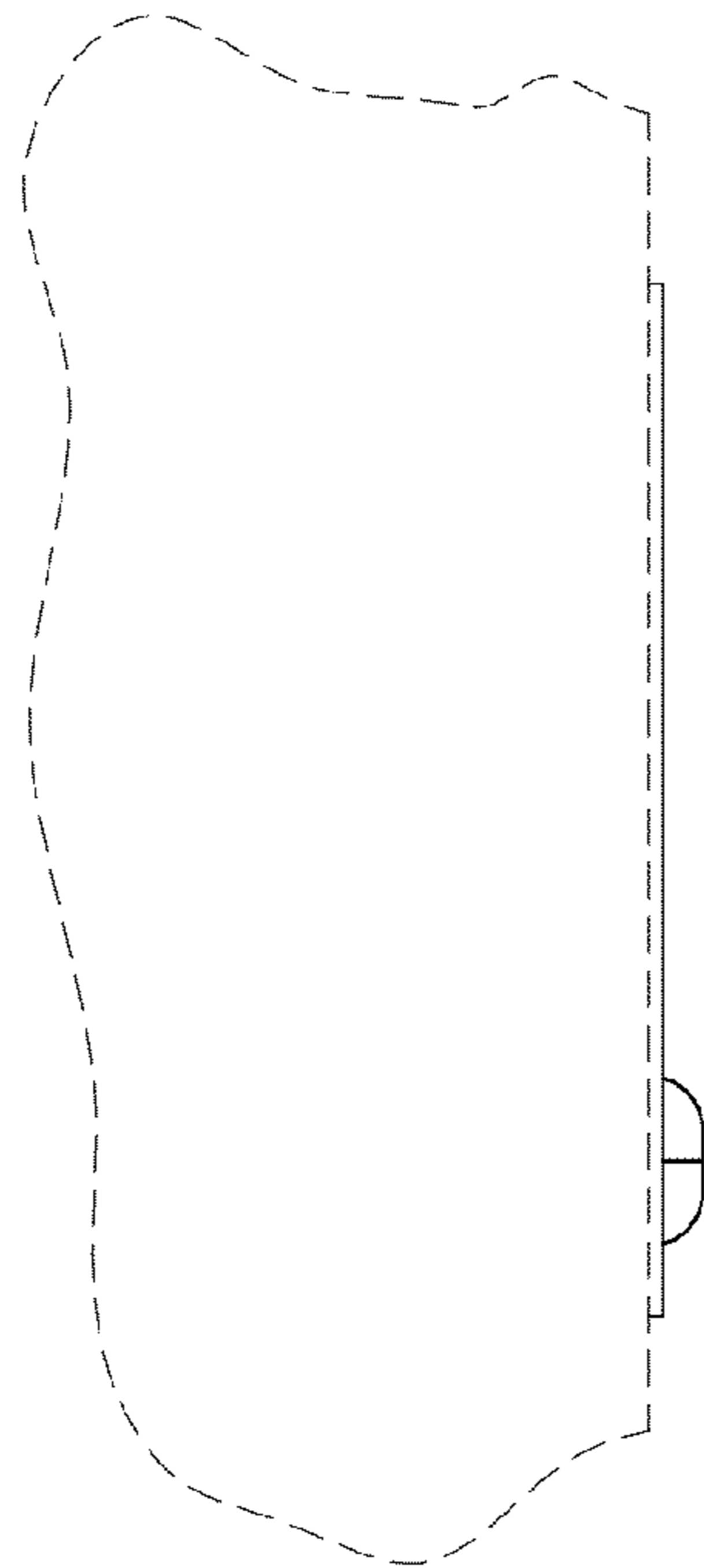

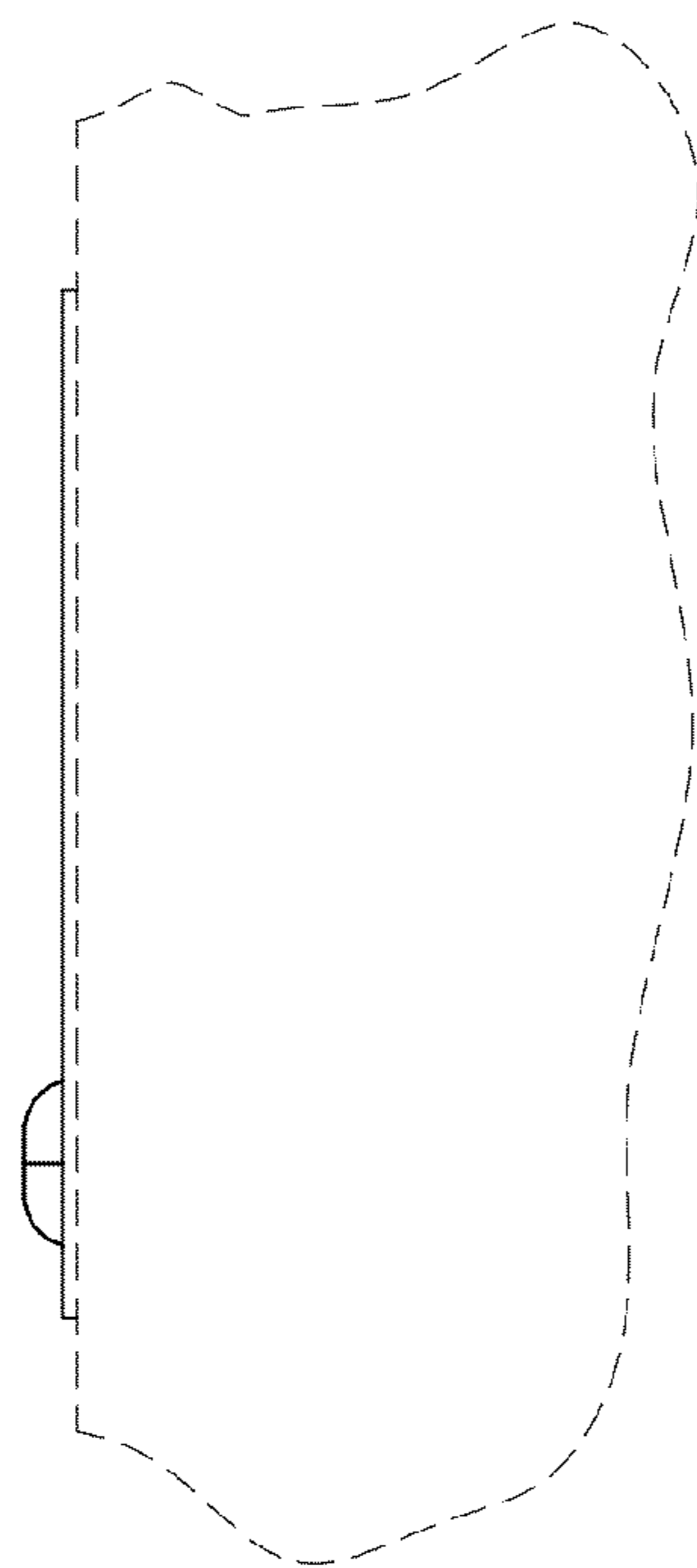

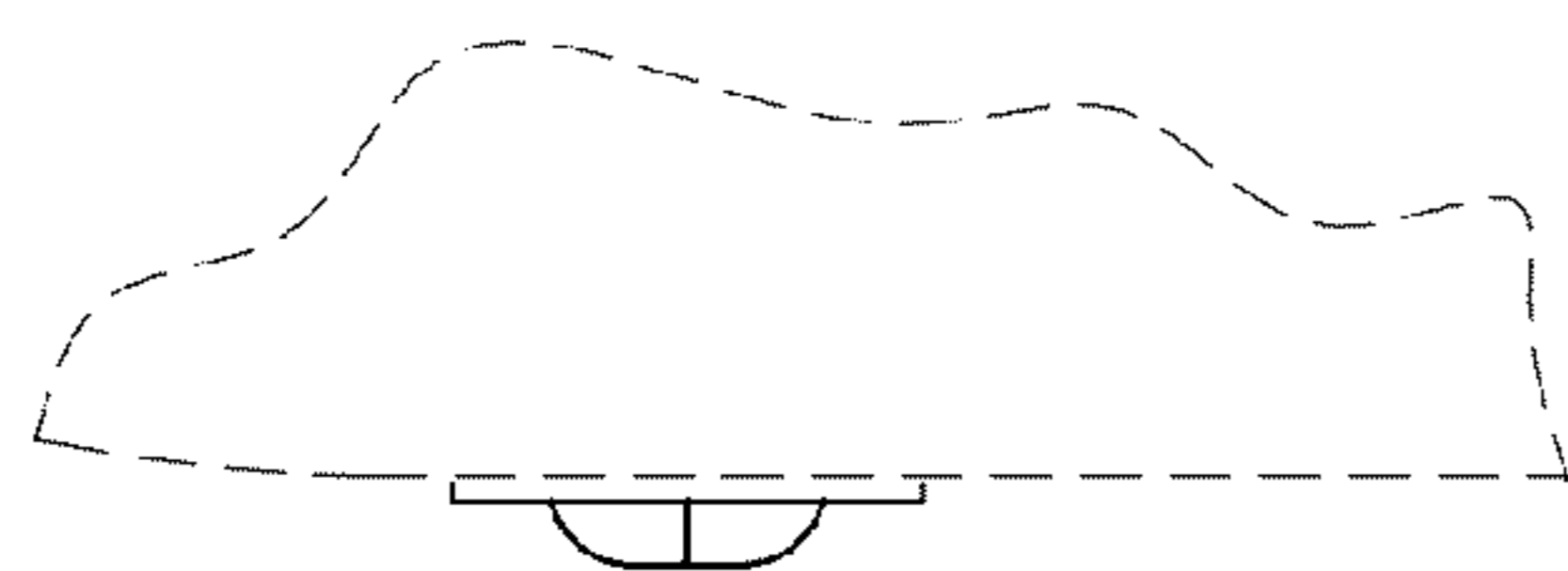
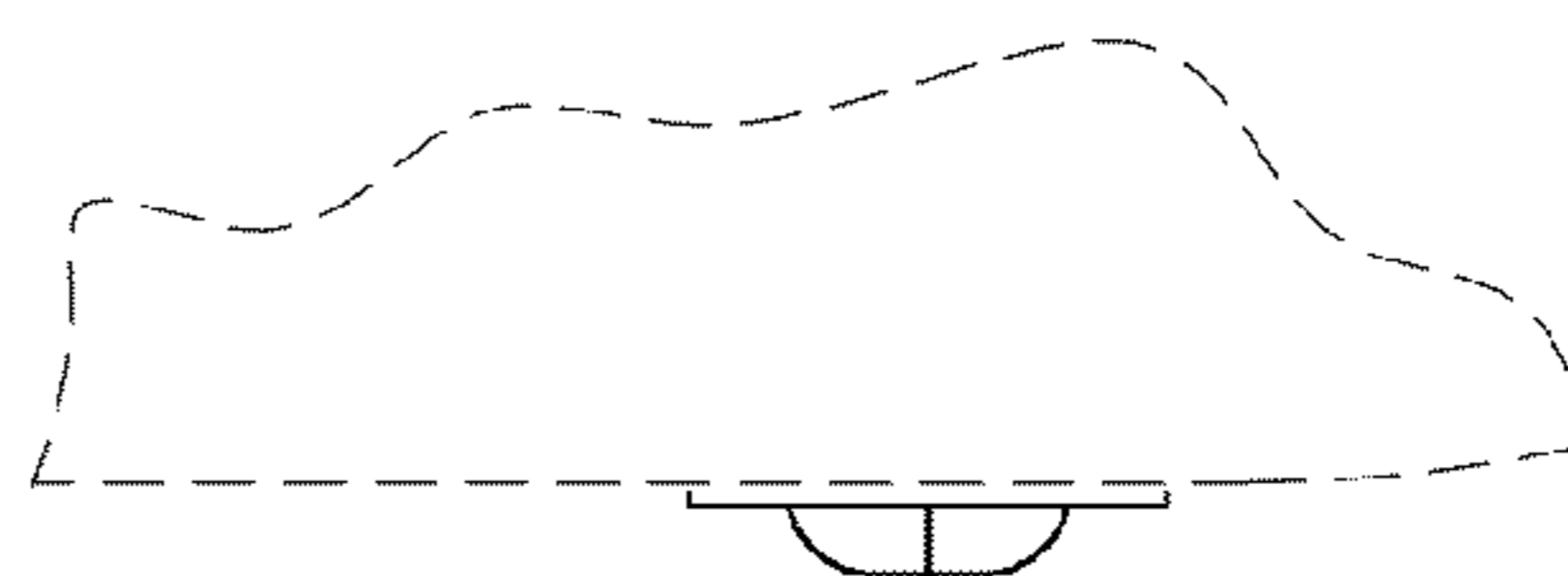

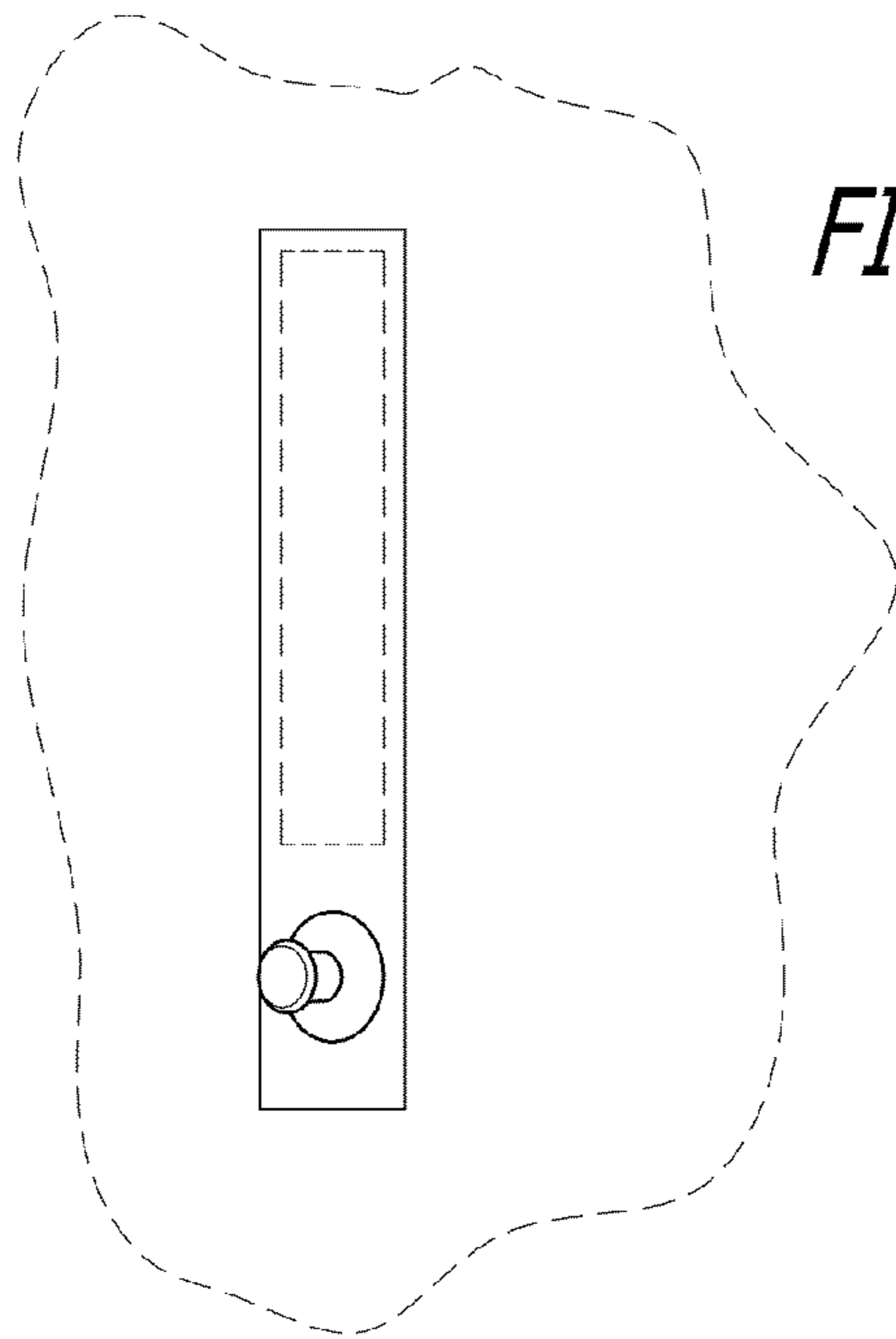

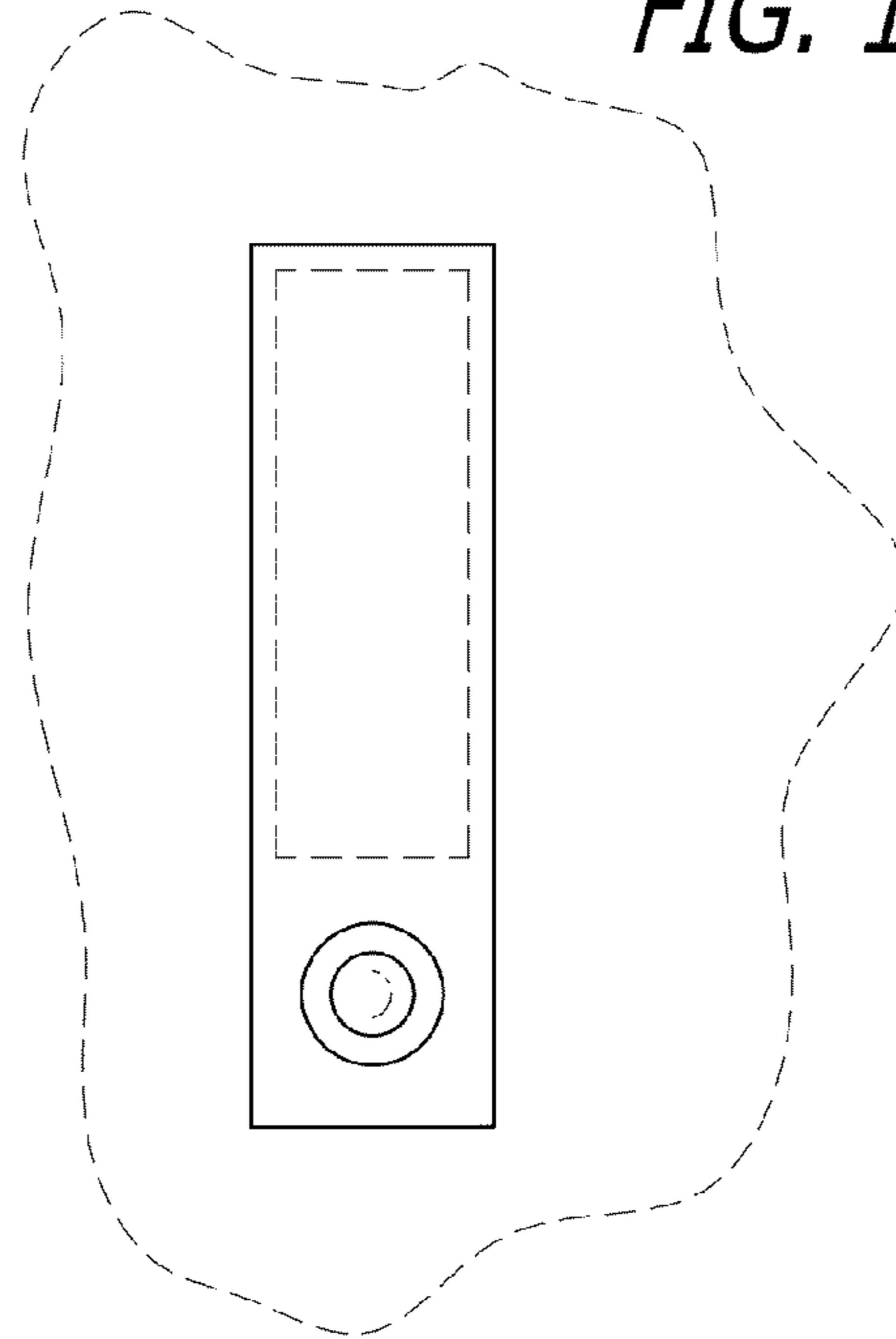

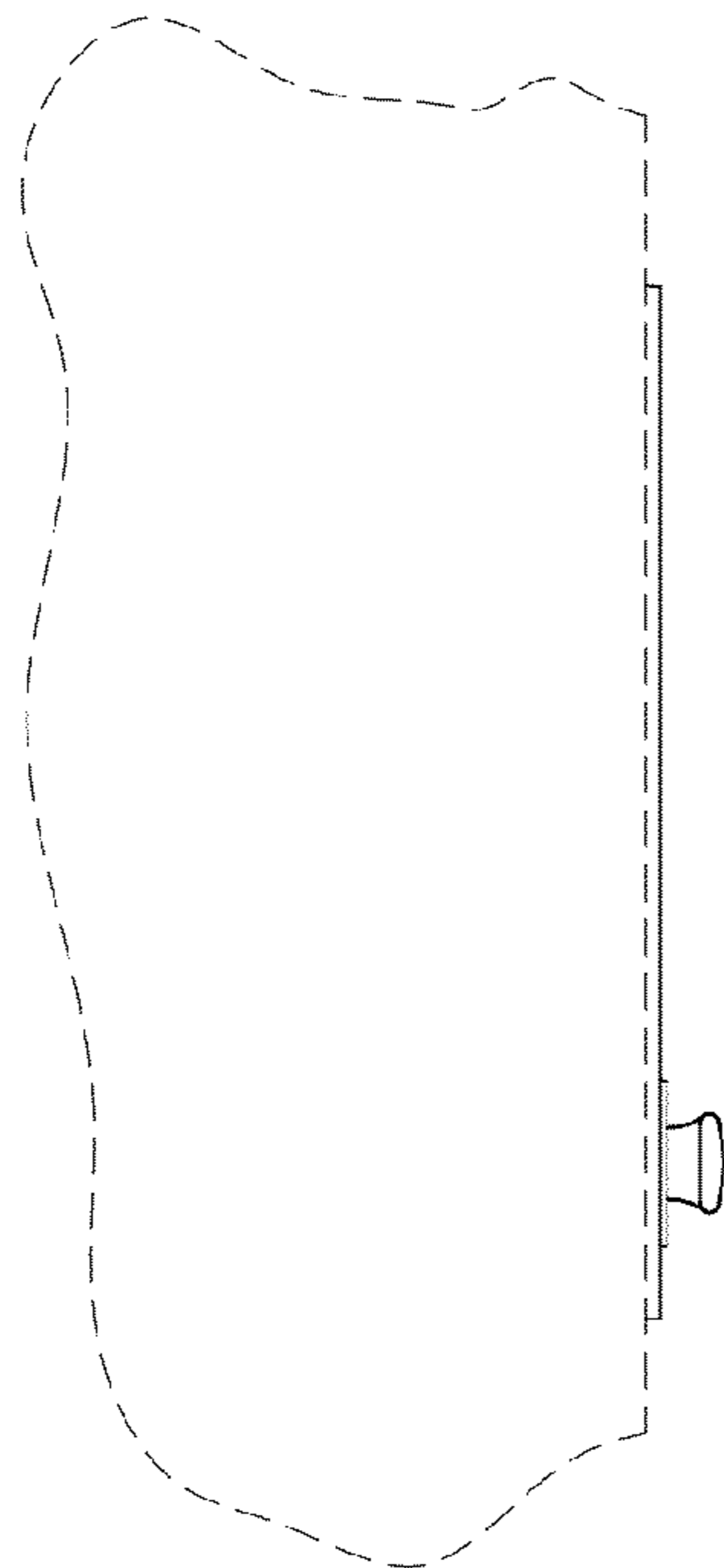

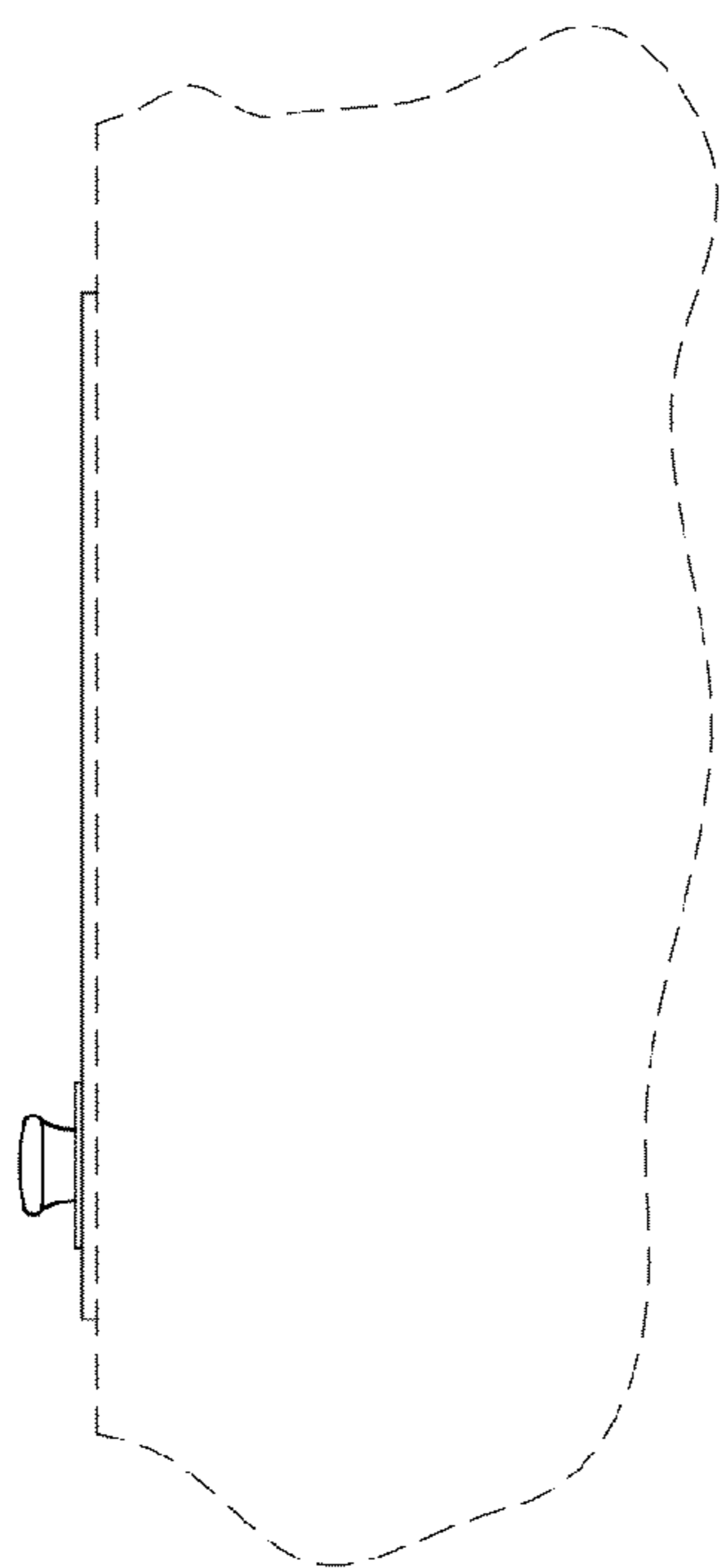

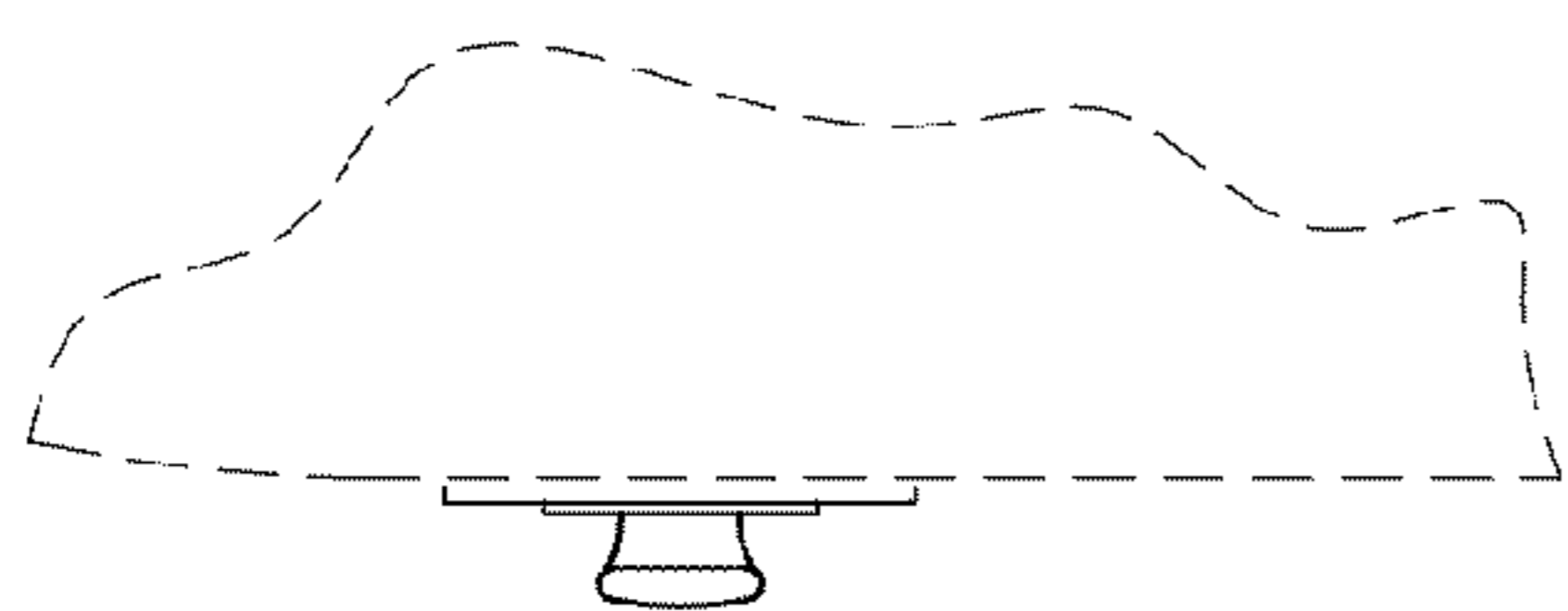
