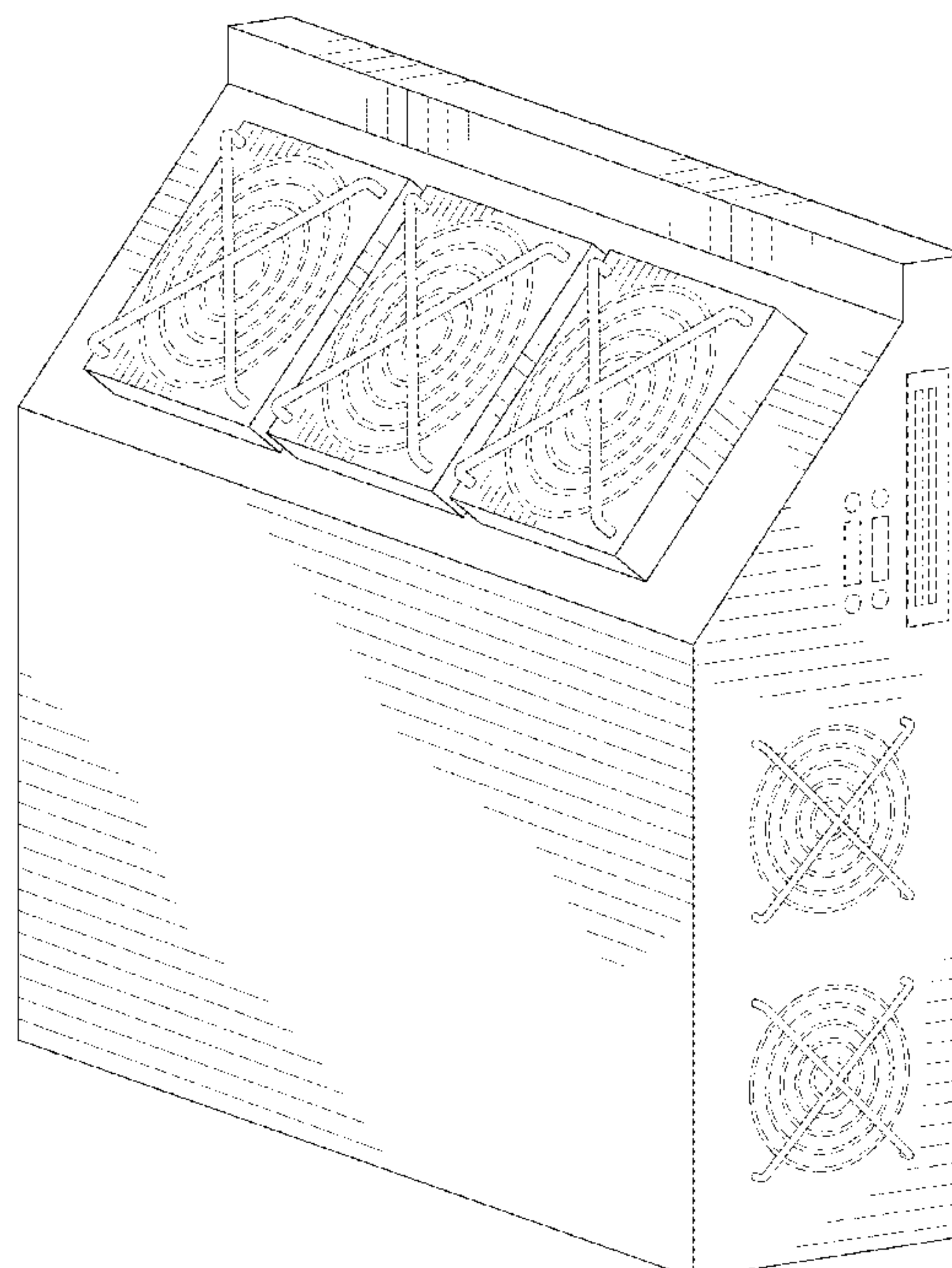
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a wall mounted computer case incorporating my new design;

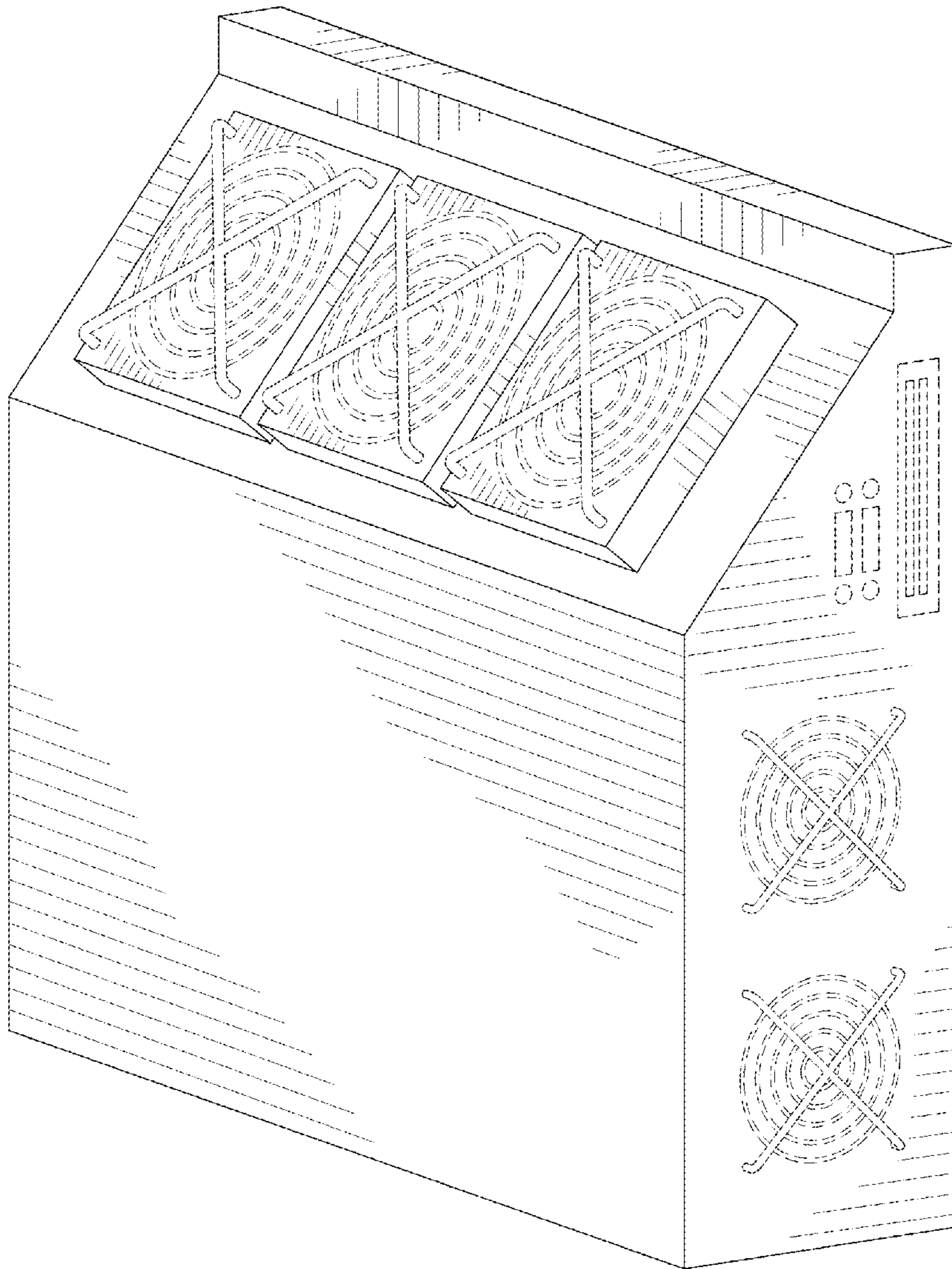

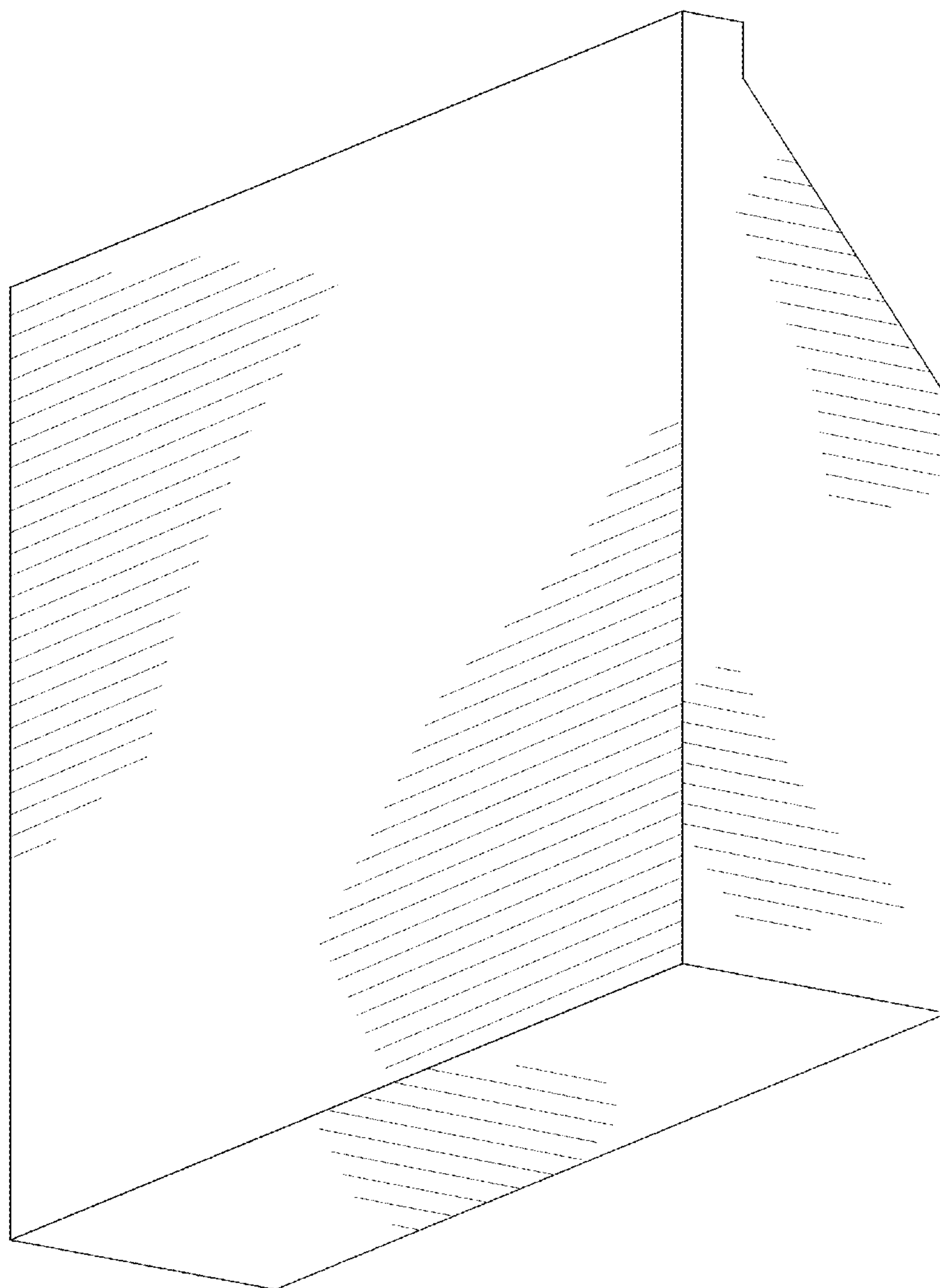

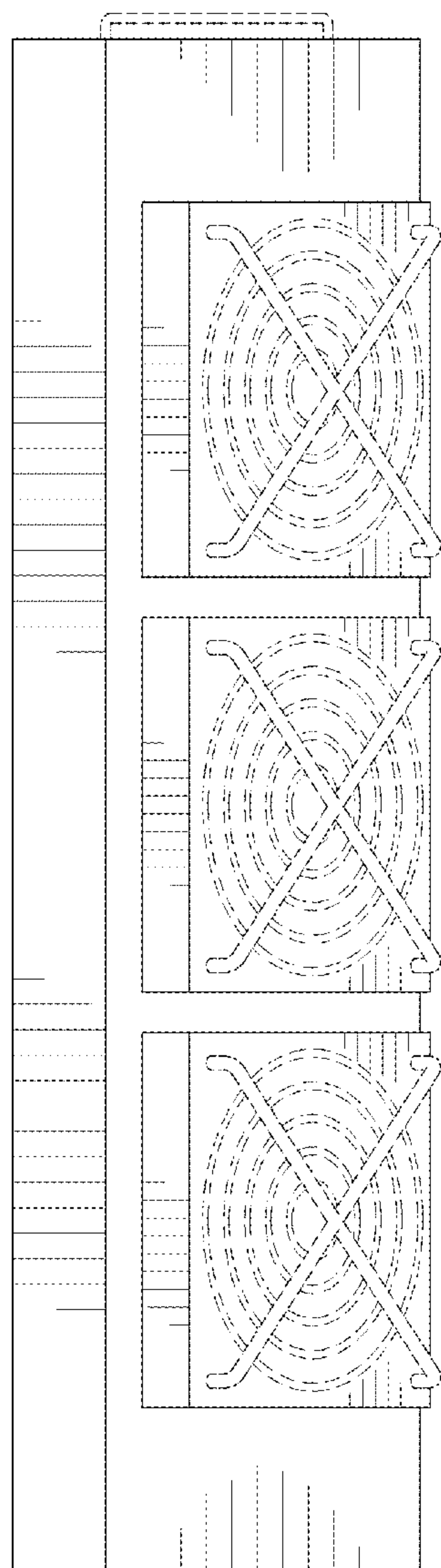

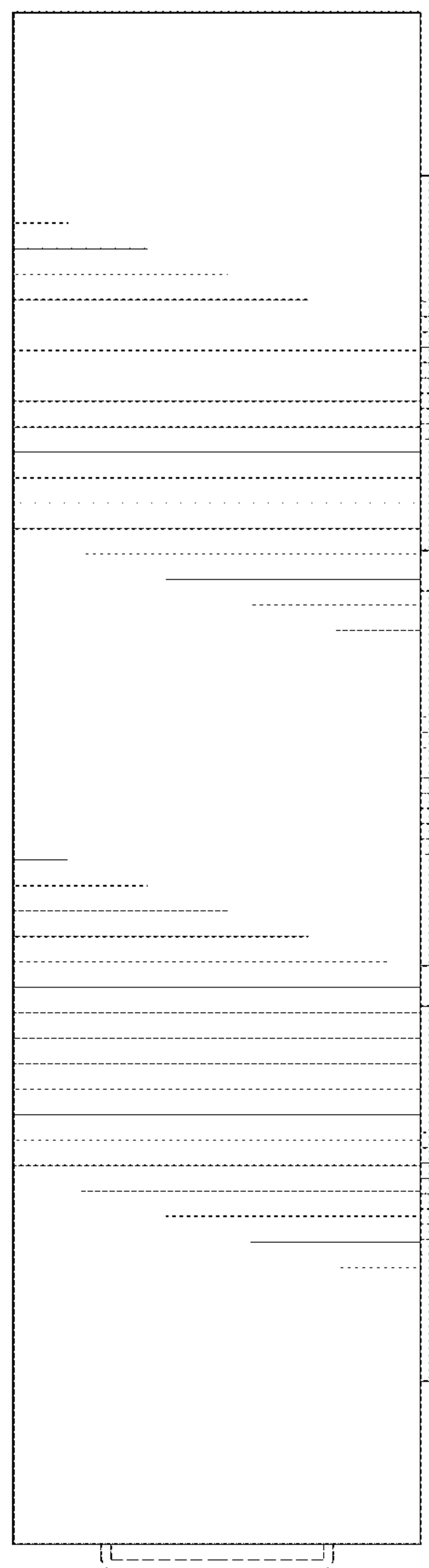
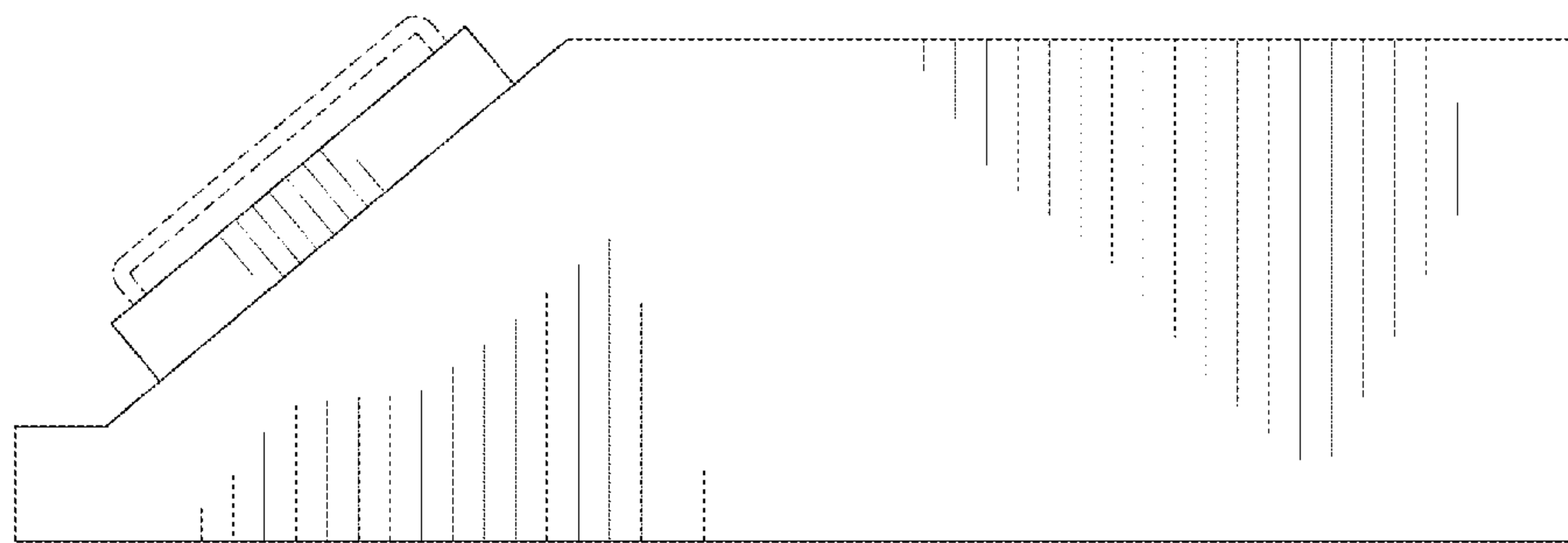
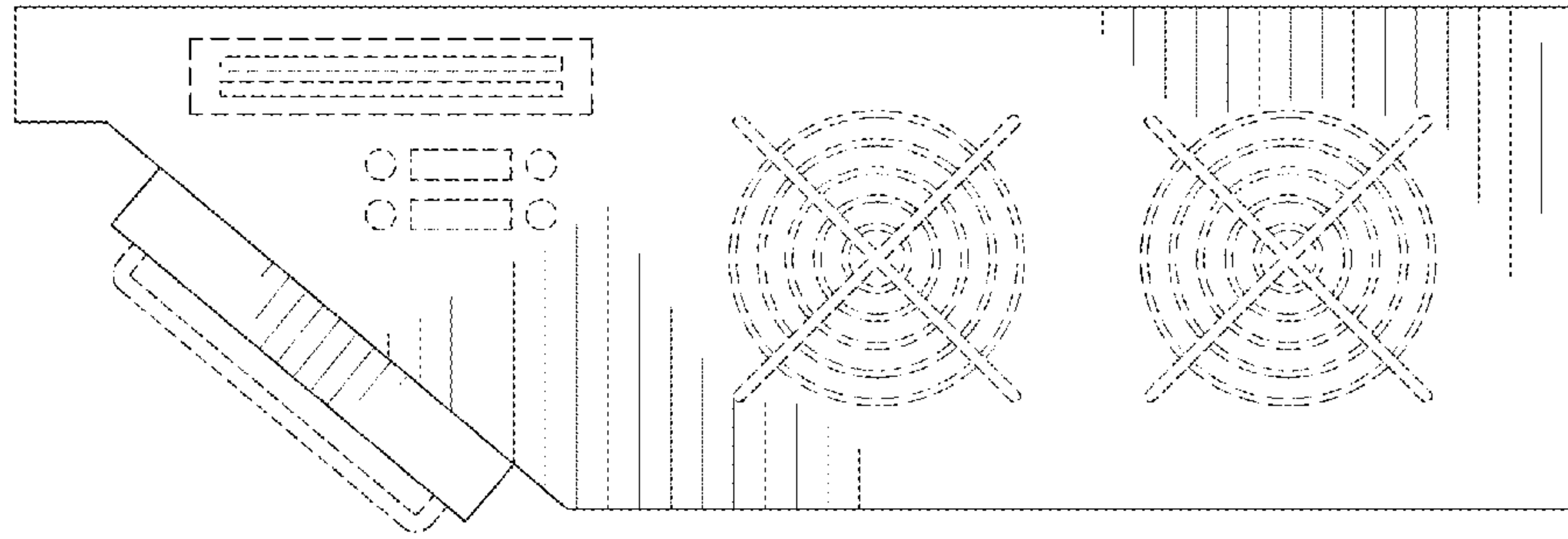

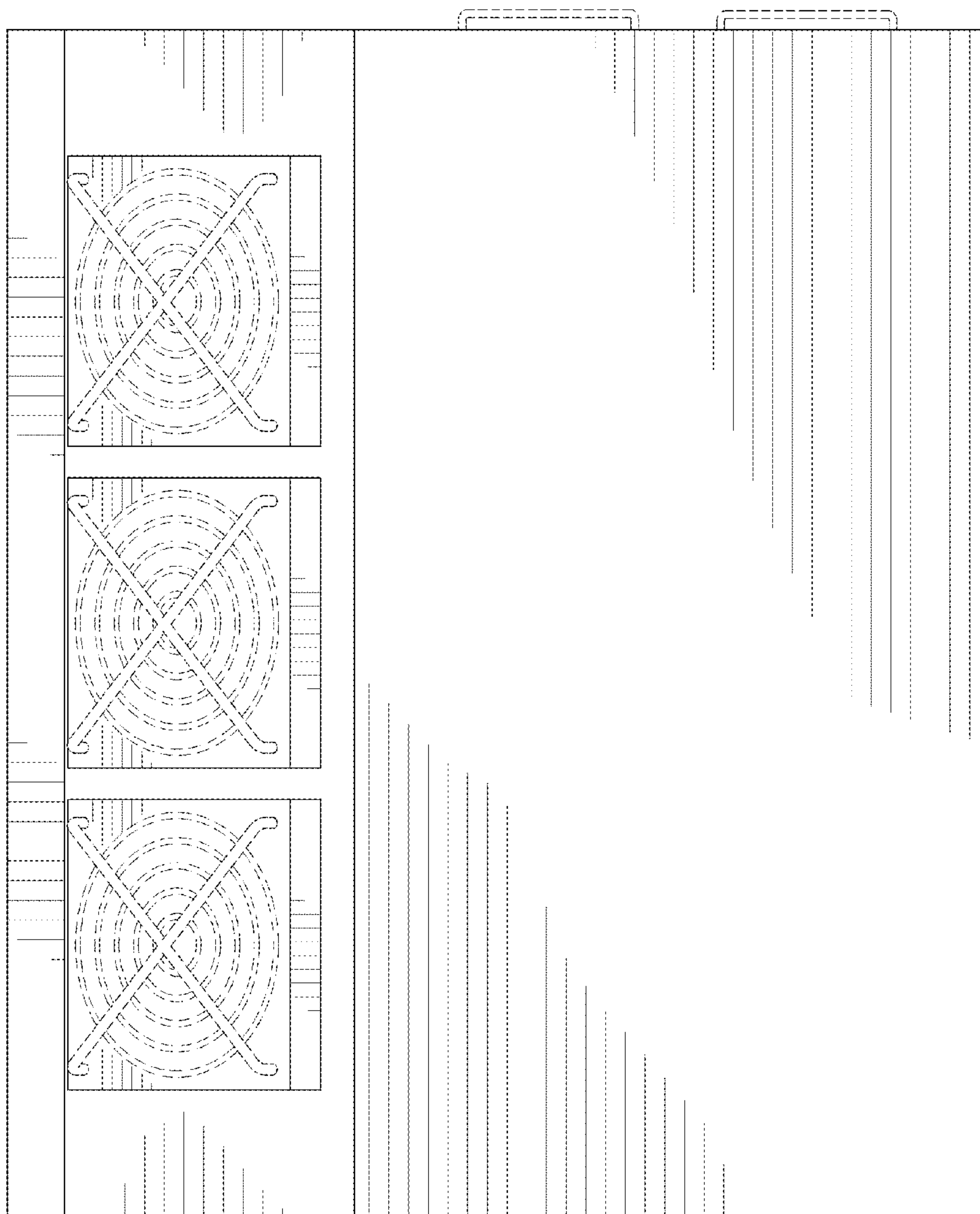

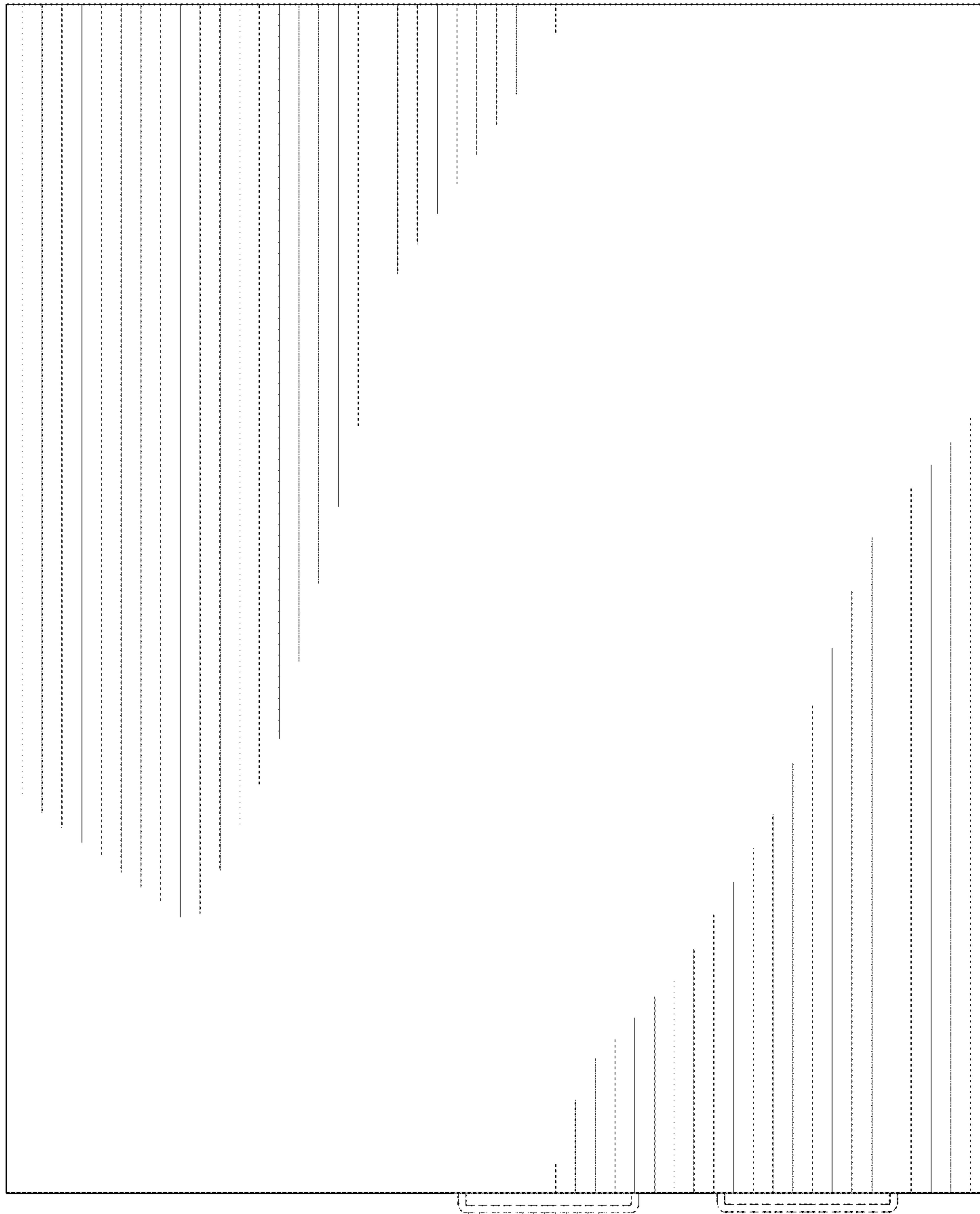
