The ornamental design for a computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a computer showing the new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a left side elevational view thereof; and,  
 FIG. 4 is an enlarged partial cross sectional view thereof taken along the lines 4-4 and 4'-4' of FIG. 2.

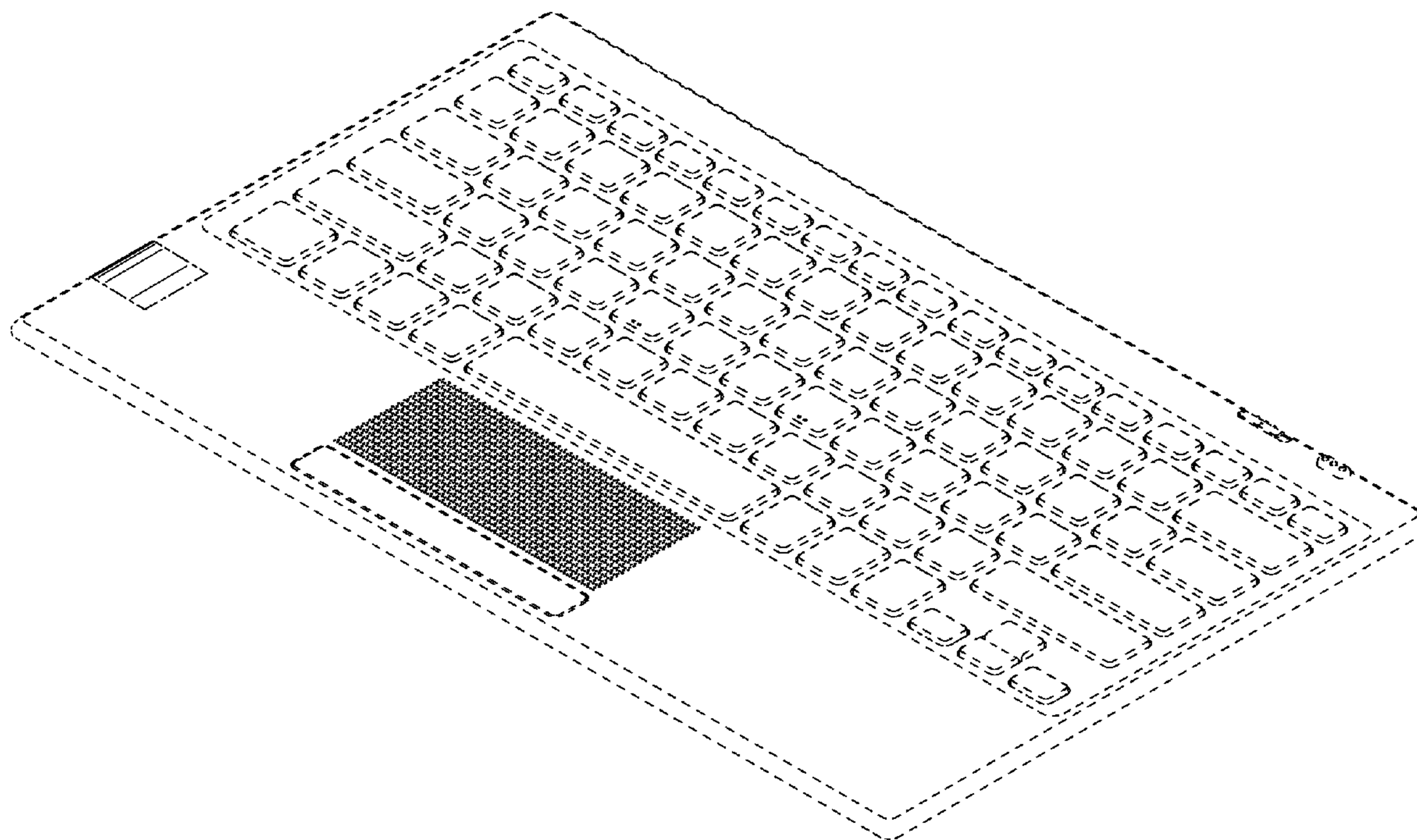

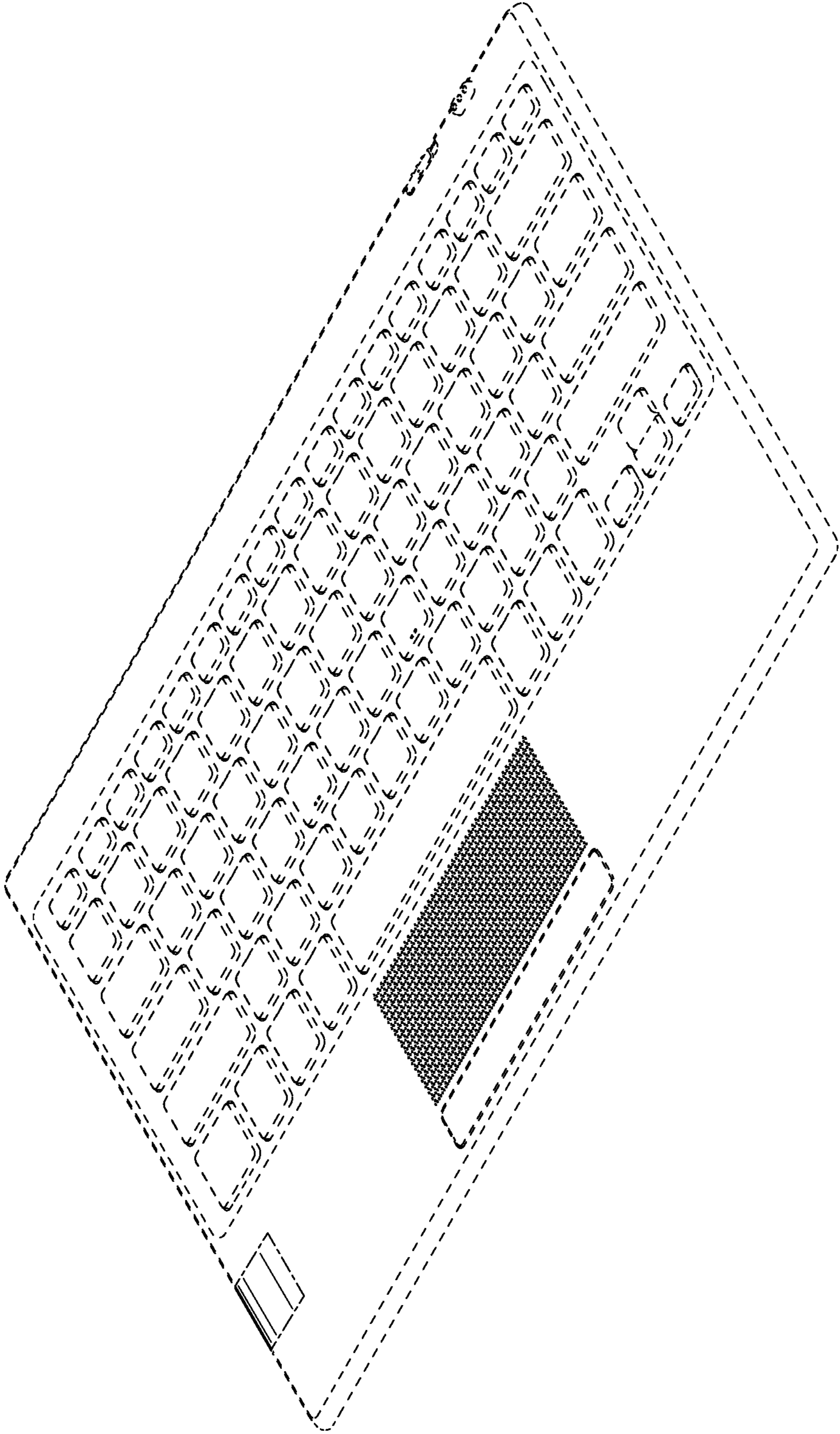

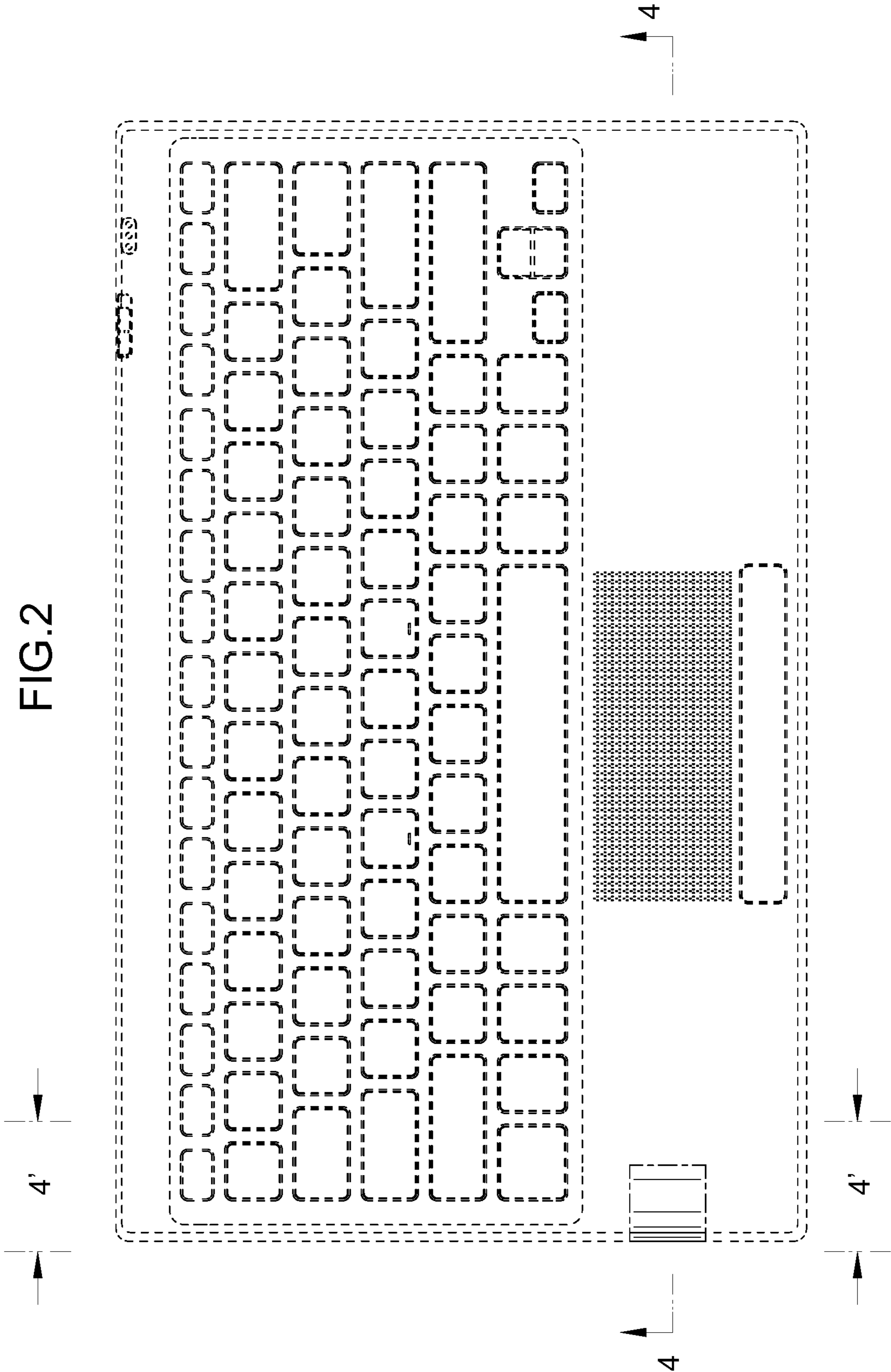

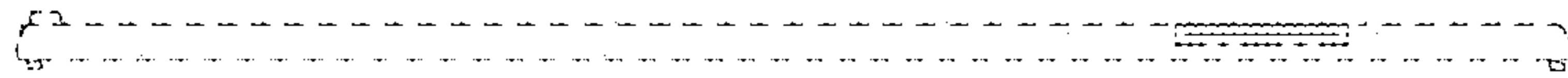
