(57) **CLAIM**

The ornamental design for a digital clipboard holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a digital clipboard holder; FIG. 2 is a front view of the digital clipboard holder of FIG. 1; FIG. 3 is a rear view of the digital clipboard holder of FIG. 1; FIG. 4 is a left-side view of the digital clipboard holder of FIG. 1; FIG. 5 is a right-side view of the digital clipboard holder of FIG. 1; FIG. 6 is a top plan view of the digital clipboard holder of FIG. 1; FIG. 7 is a bottom plan view of the digital clipboard holder of FIG. 1; and, FIG. 8 is a perspective view of the digital clipboard holder of FIG. 1, shown with an example environment. Features shown in broken lines in FIGS. 1, 2, 4, 5, 6, and 8, form no part of the claimed design.

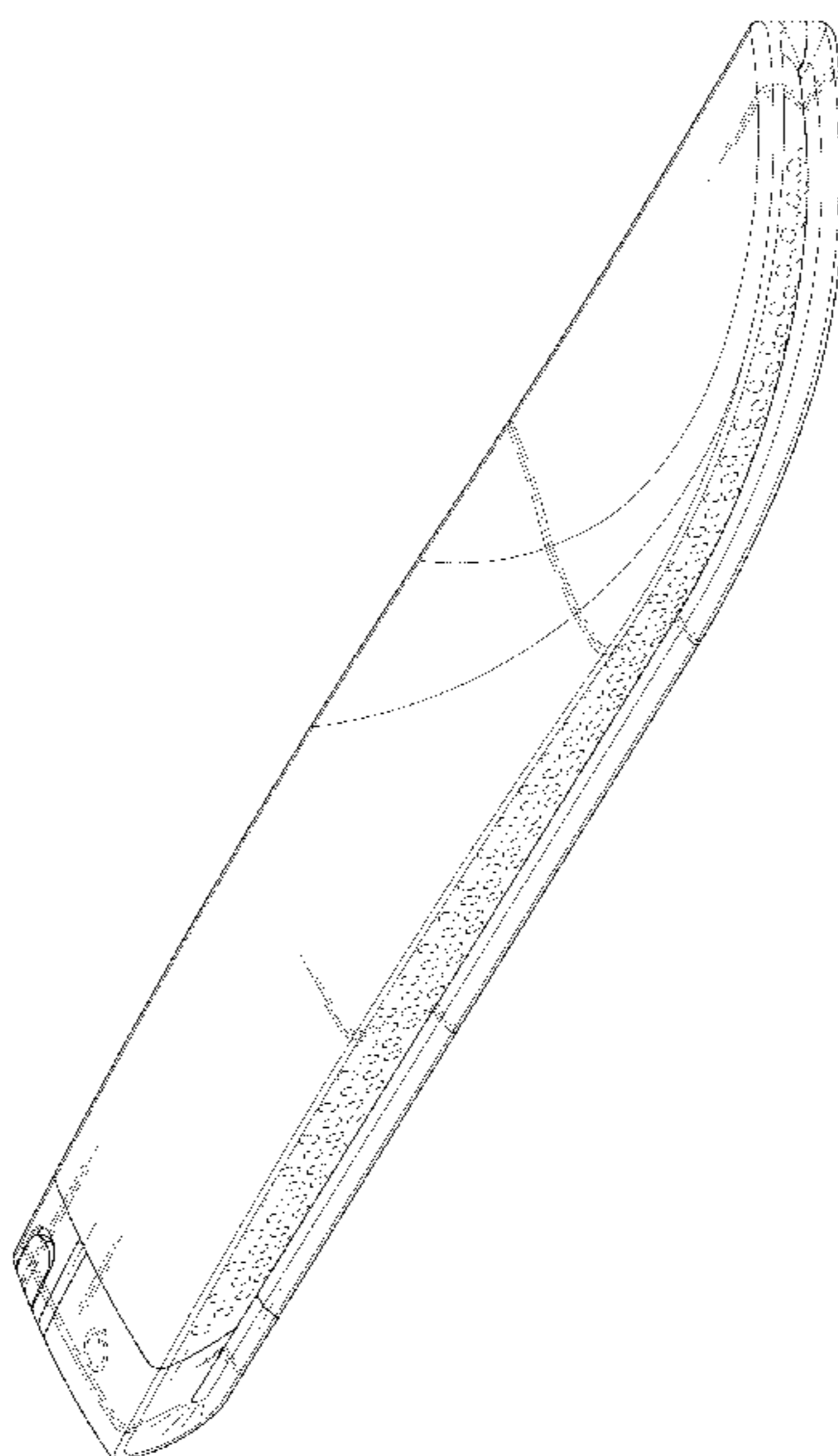

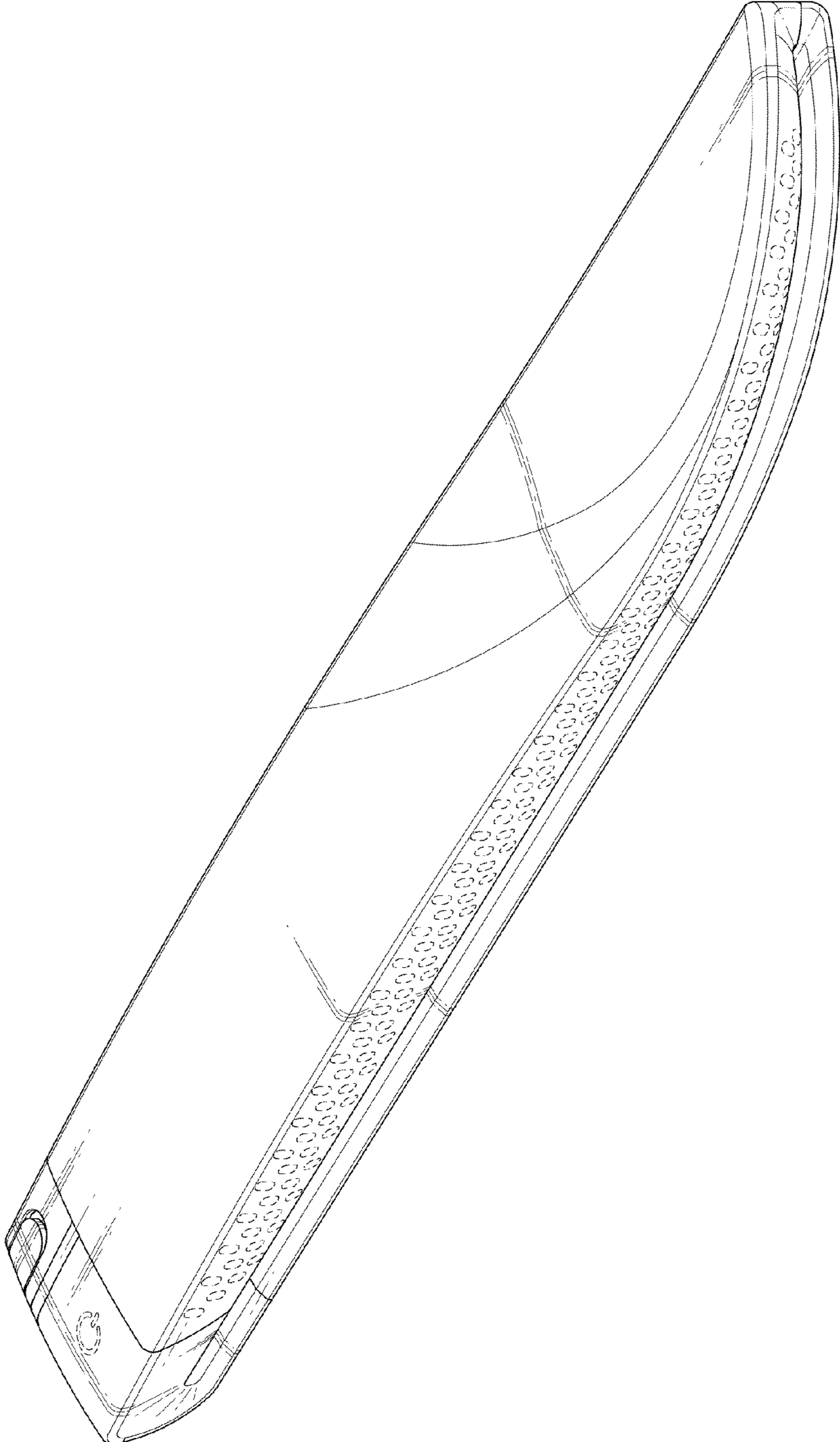

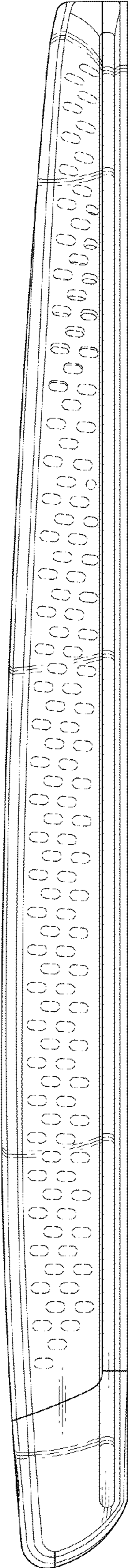

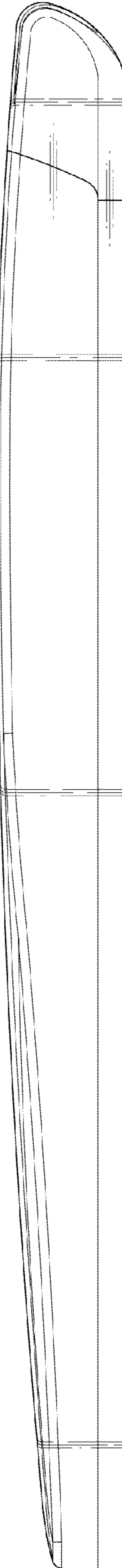

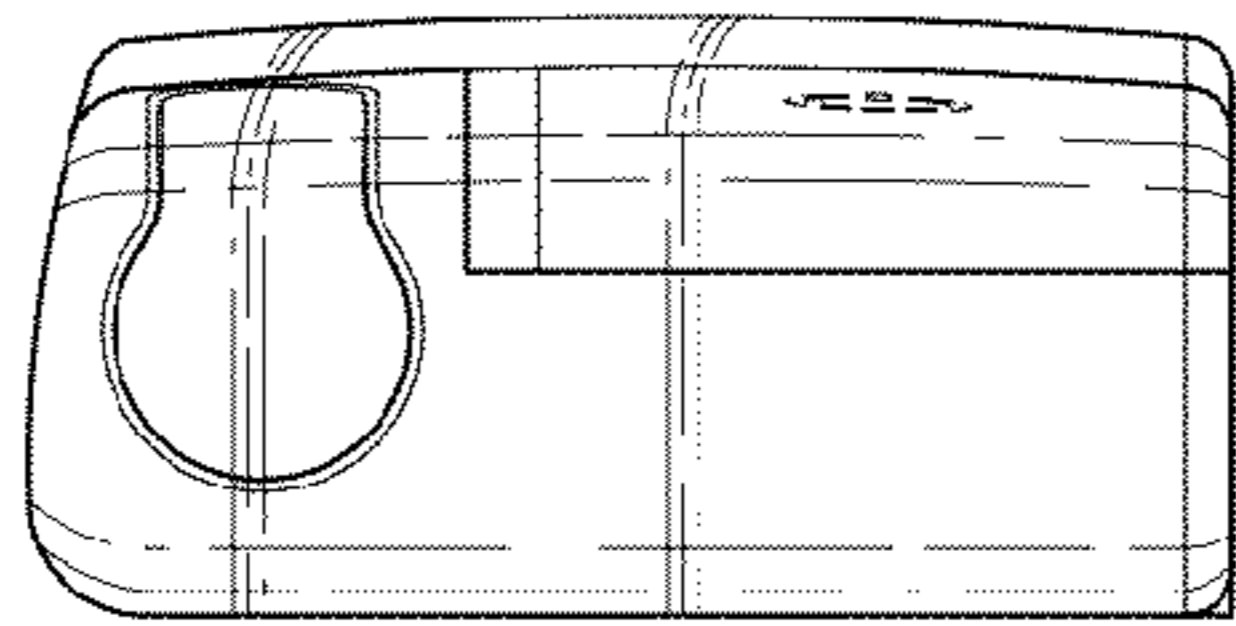

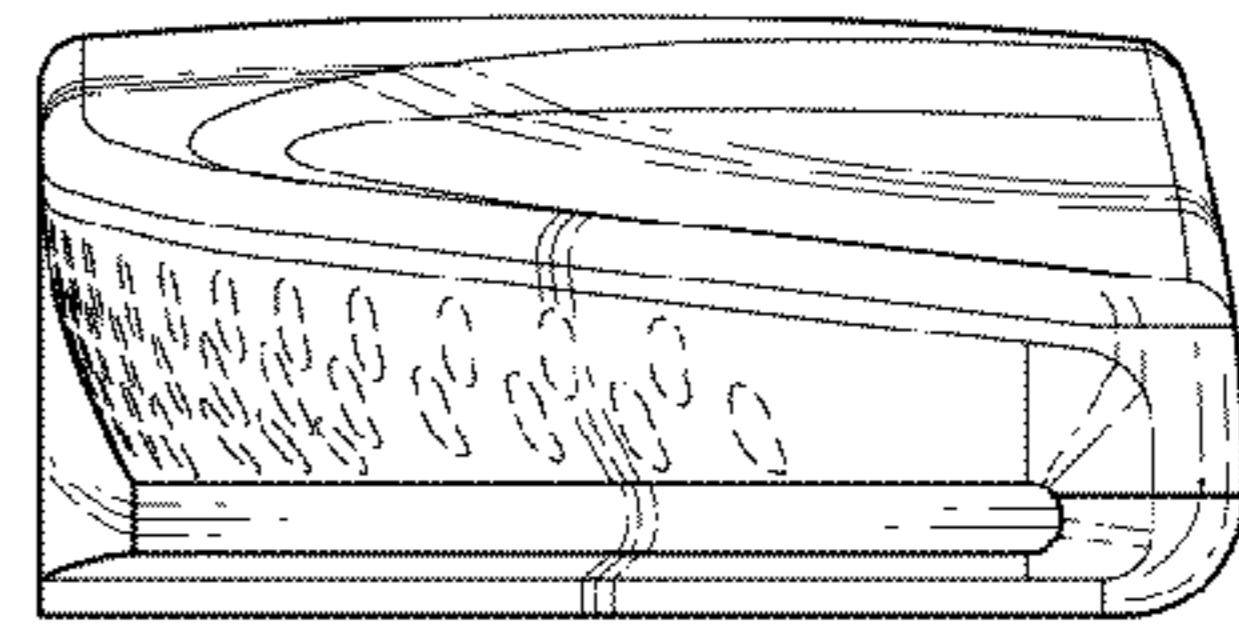

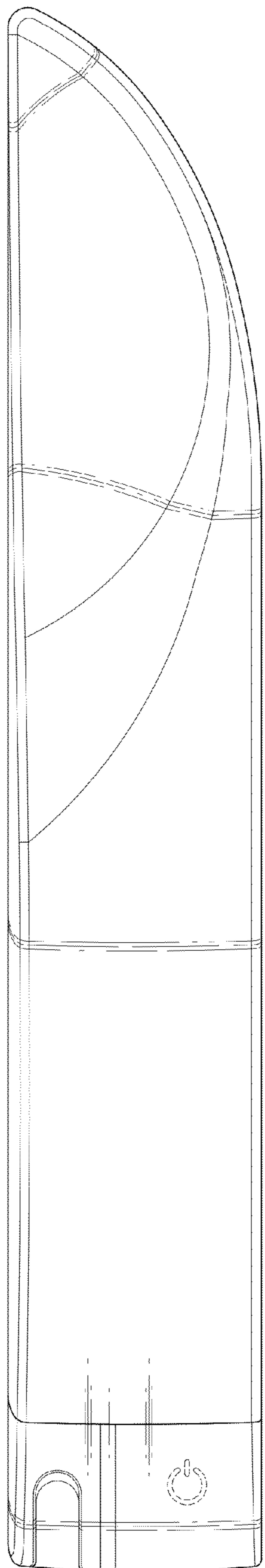

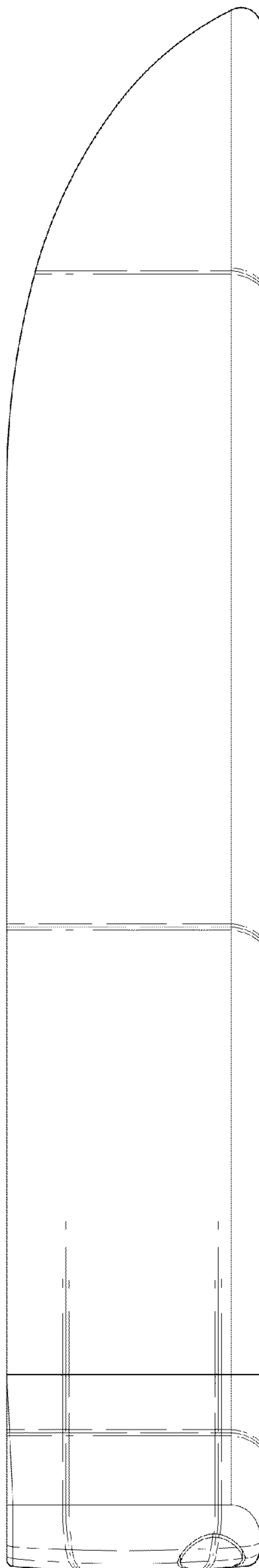
