(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing my new design; and, FIG. 2 is a front view of the generated image of FIG. 1, in which a mobile terminal in broken lines is provided to illustrate an example environment.

The broken line drawing of the mobile terminal, the display screen and portion of a display screen as well as the numbers and symbols illustrate environmental subject matter and form no part of the claimed design.

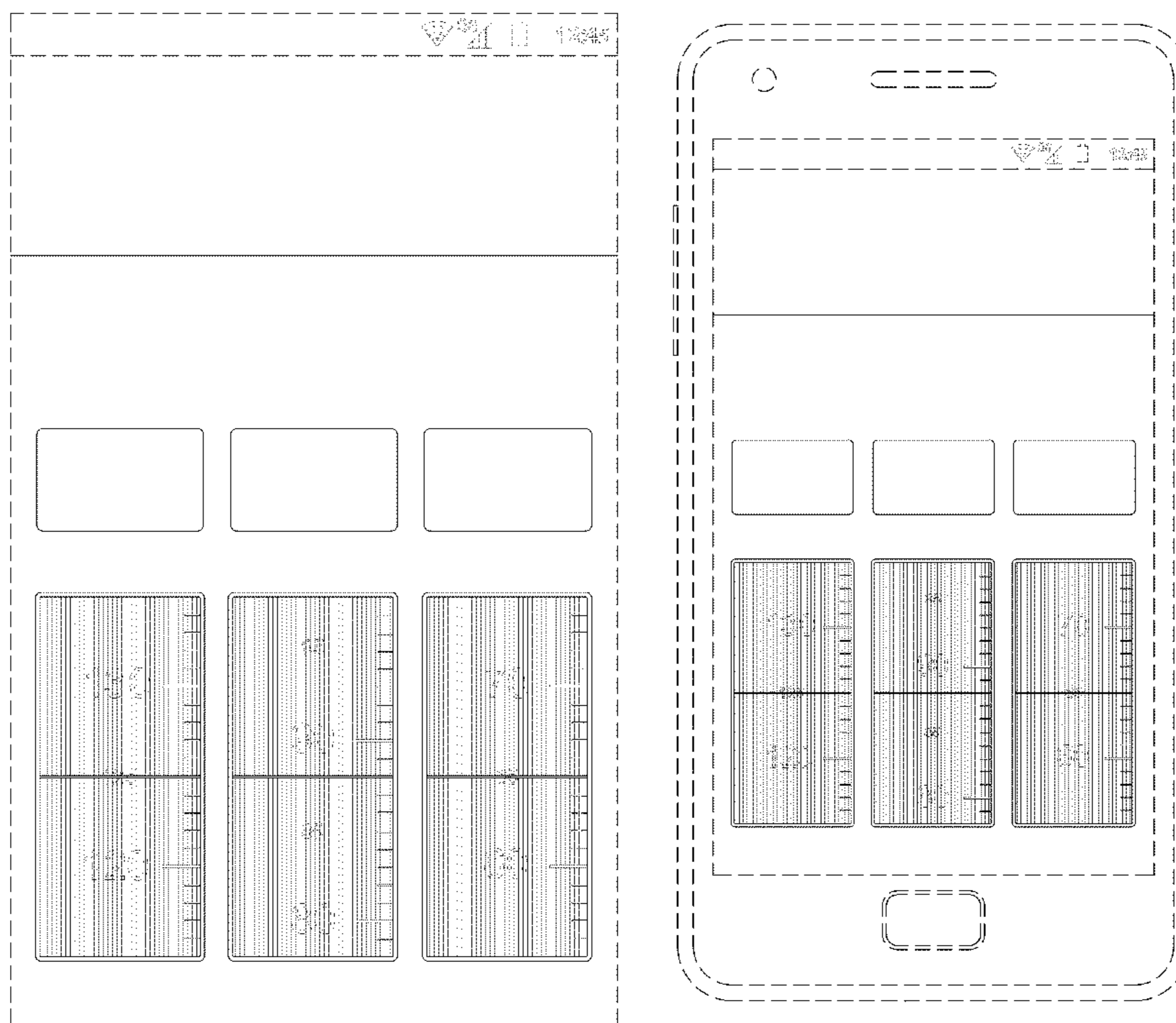

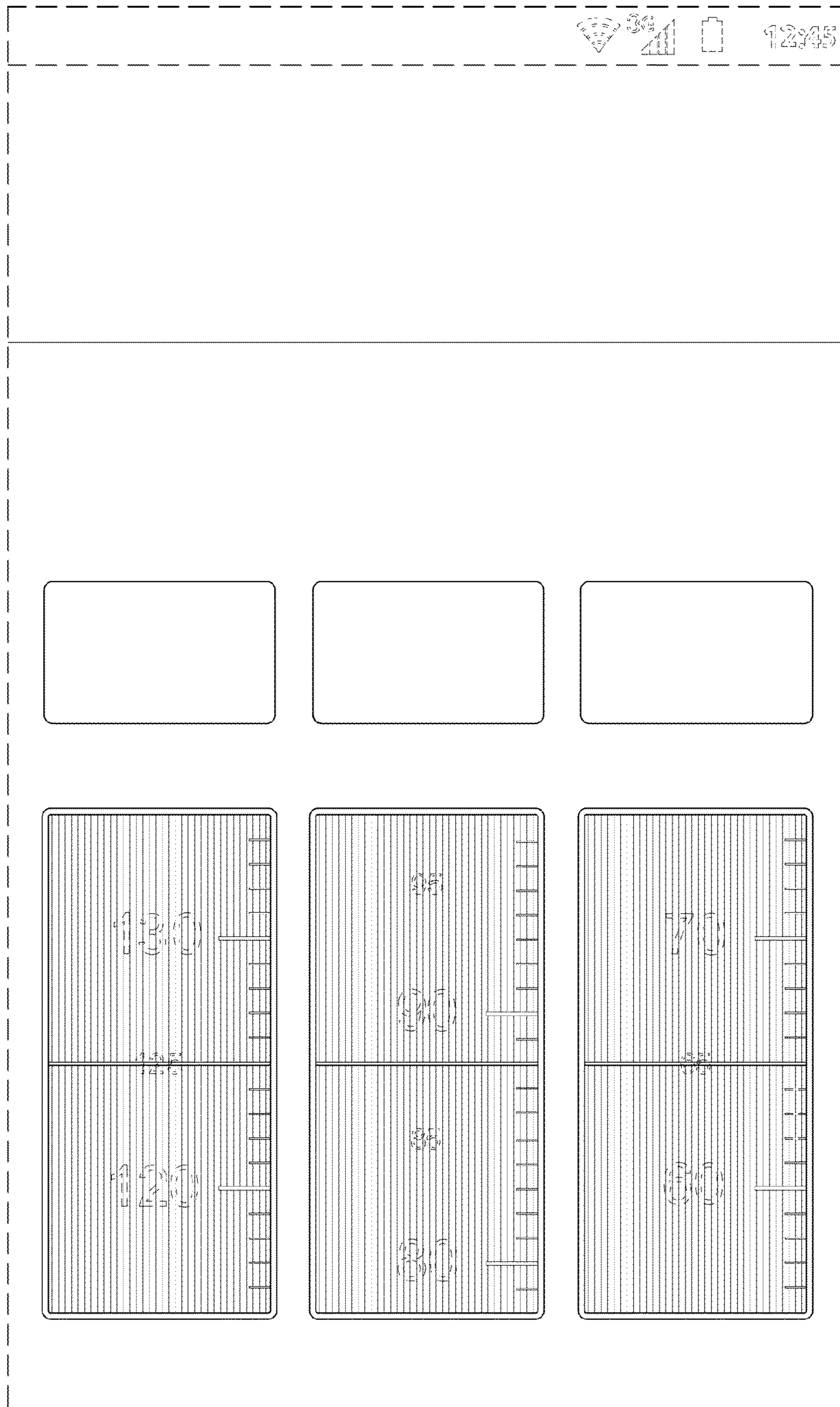
