FIG. 10 is a tenth image thereof; and,

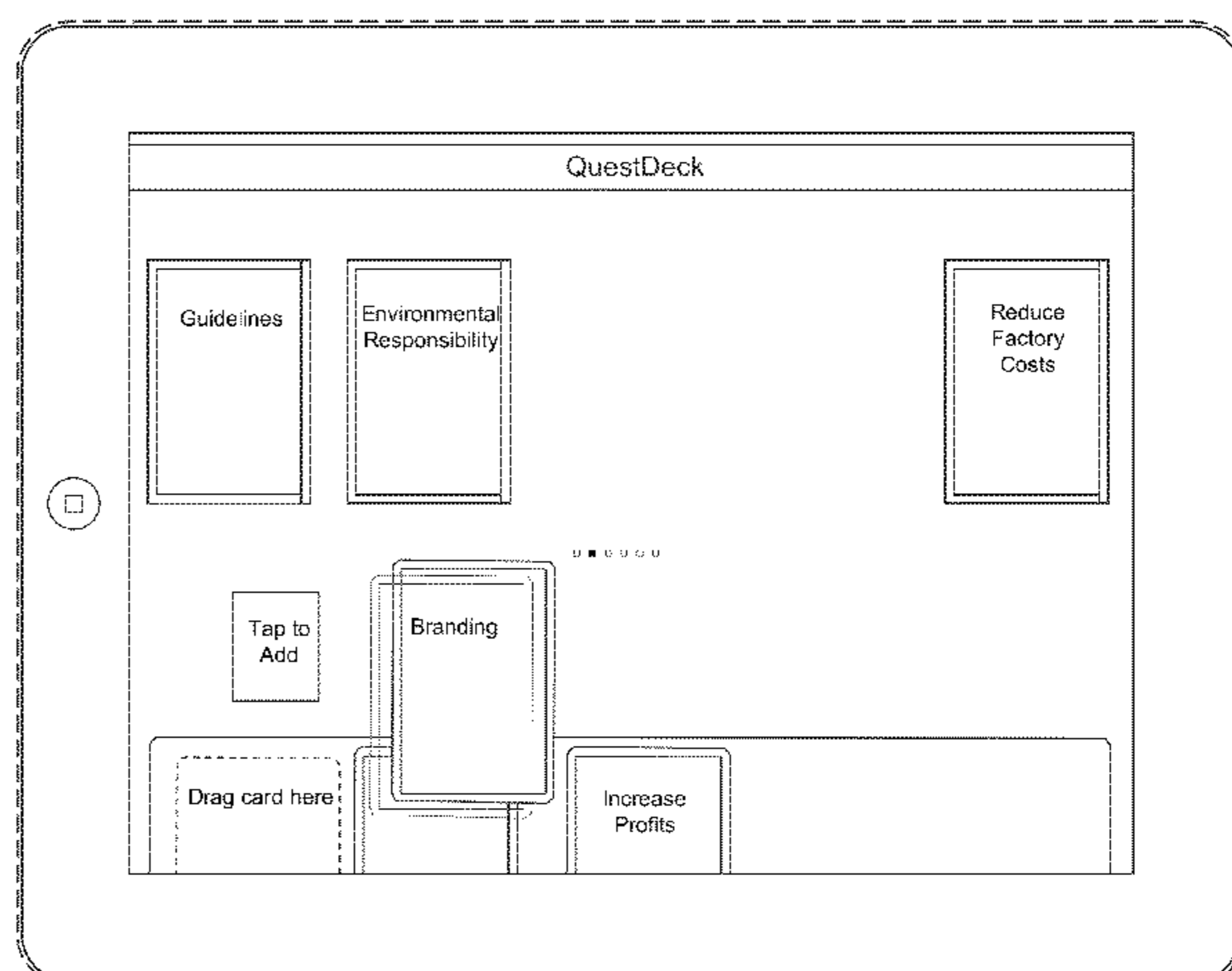
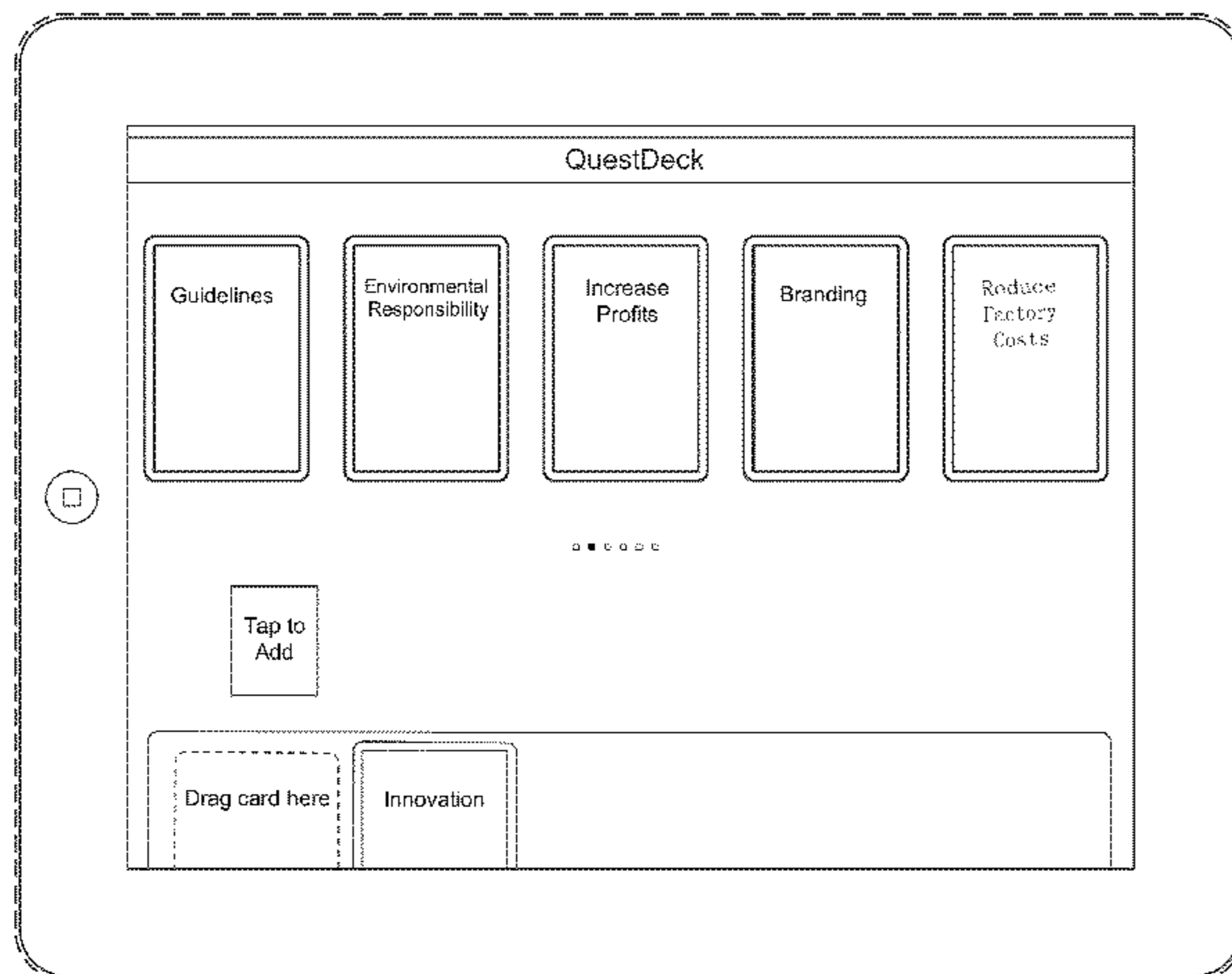
FIG. 11 is an eleventh image thereof.

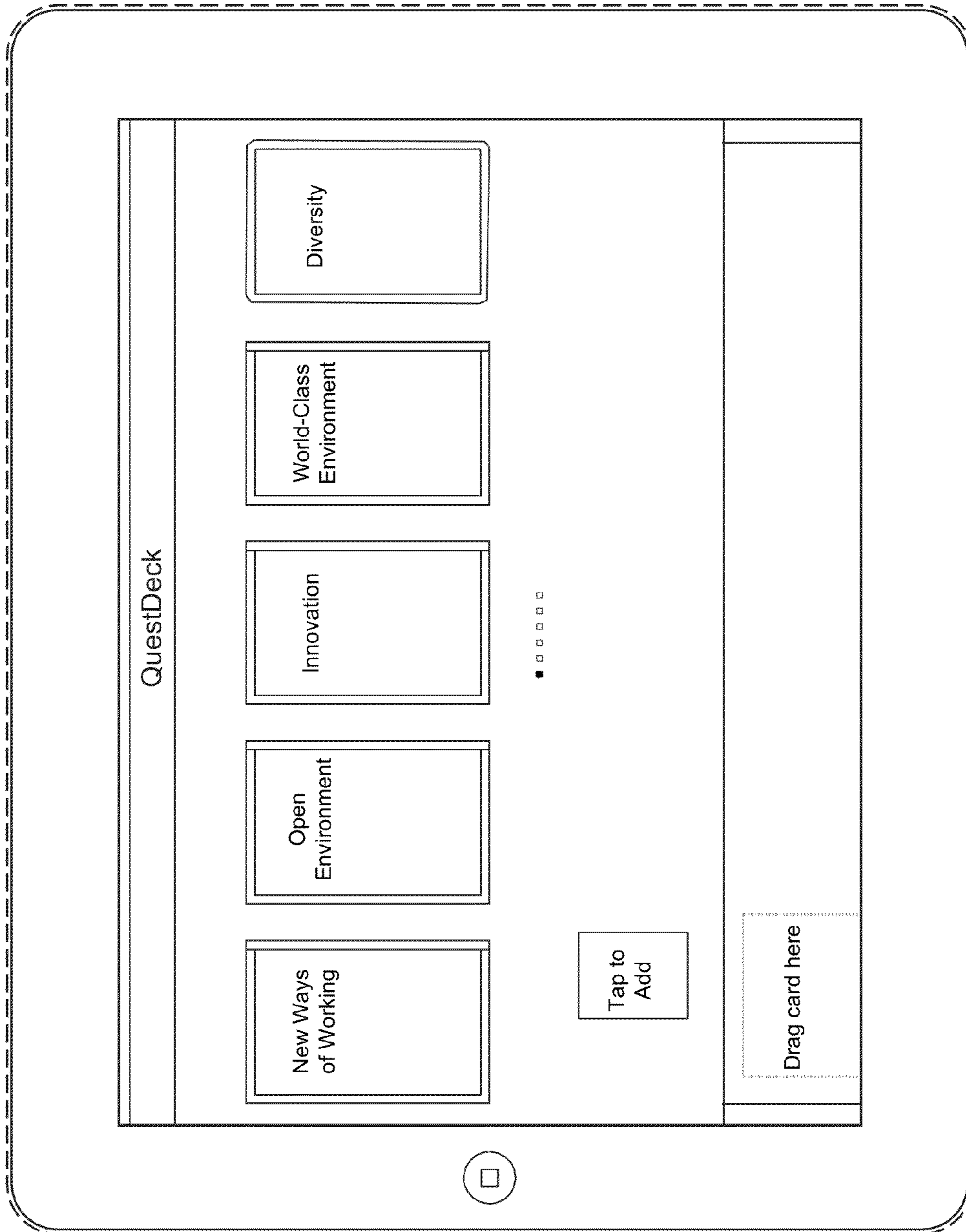

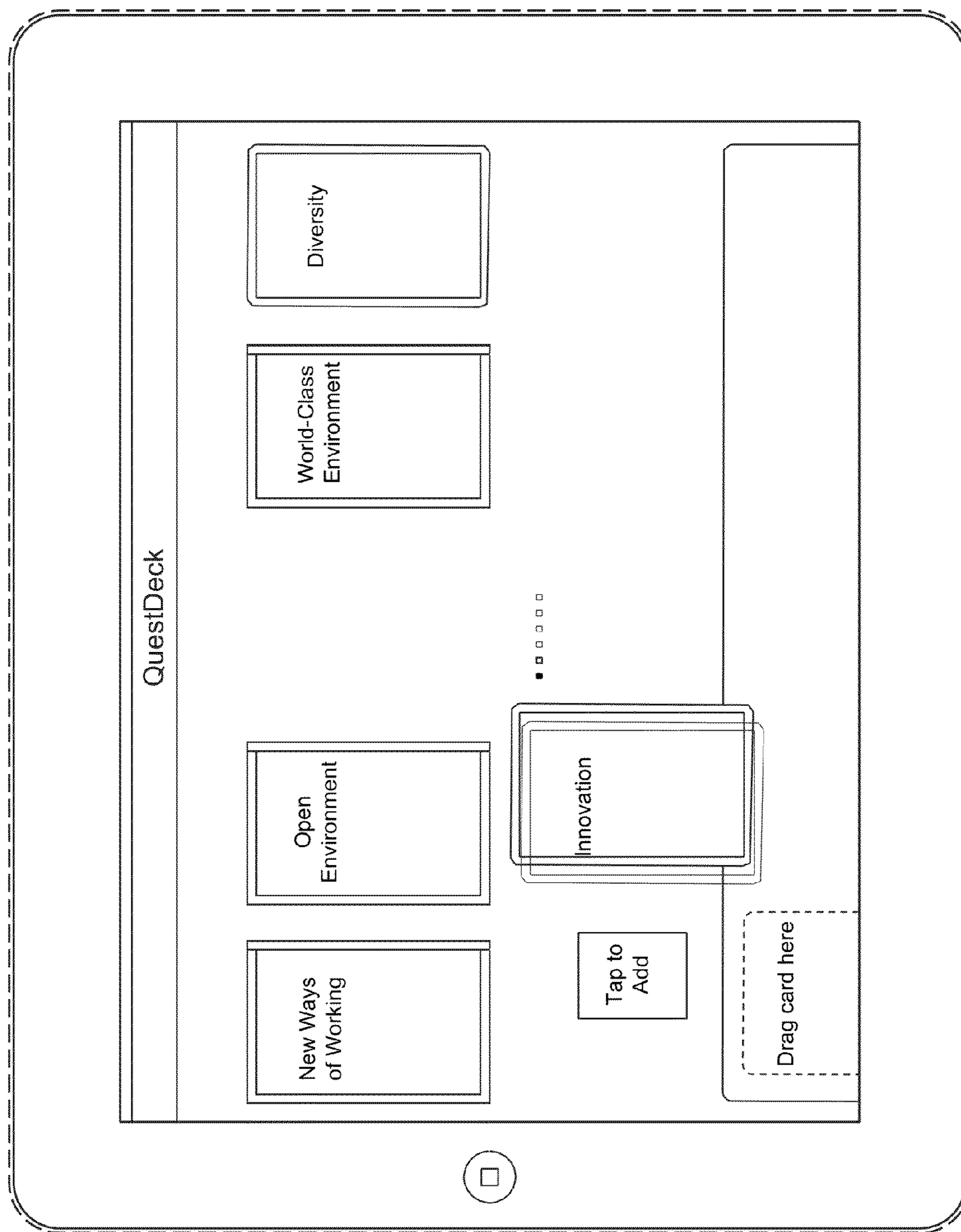

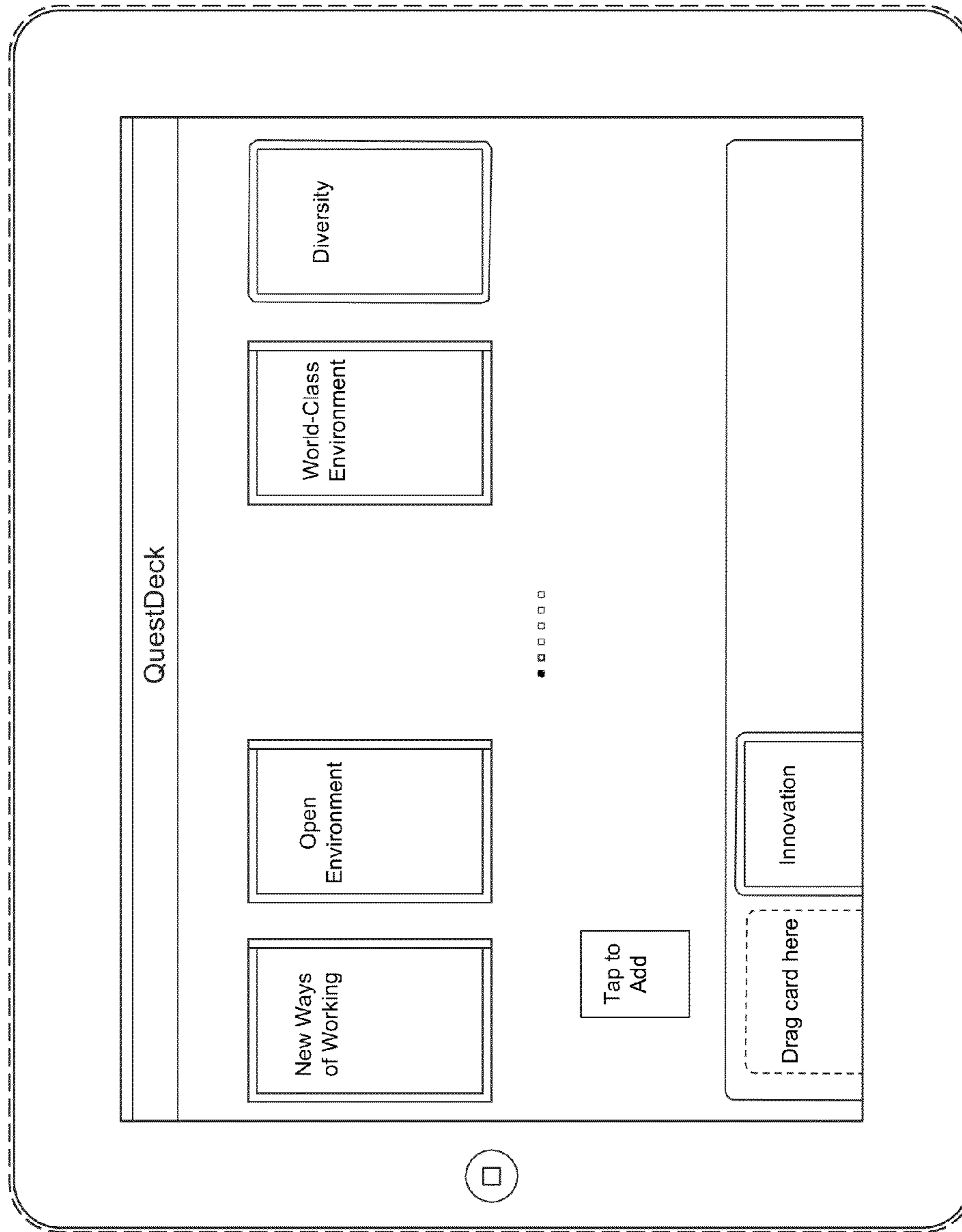

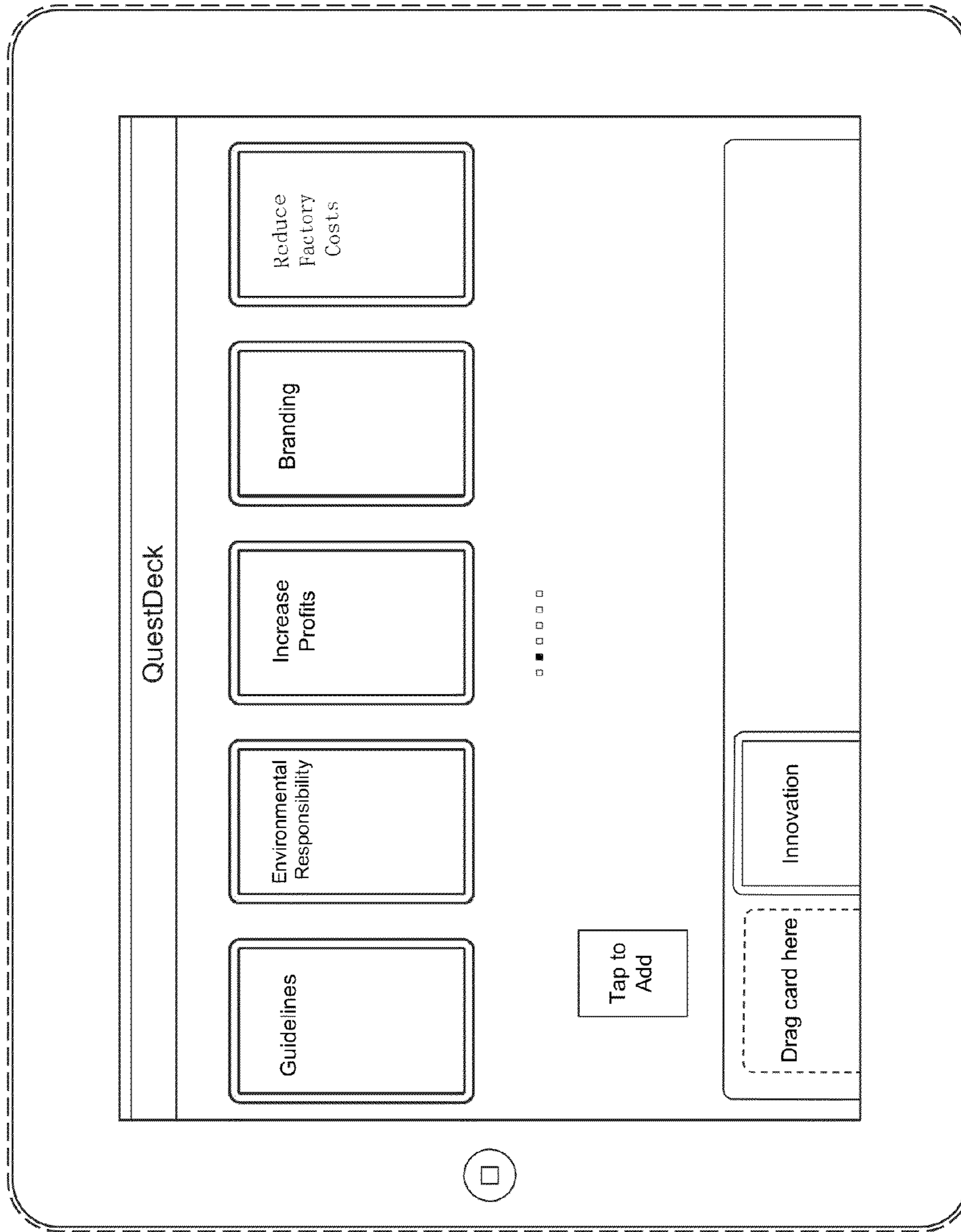

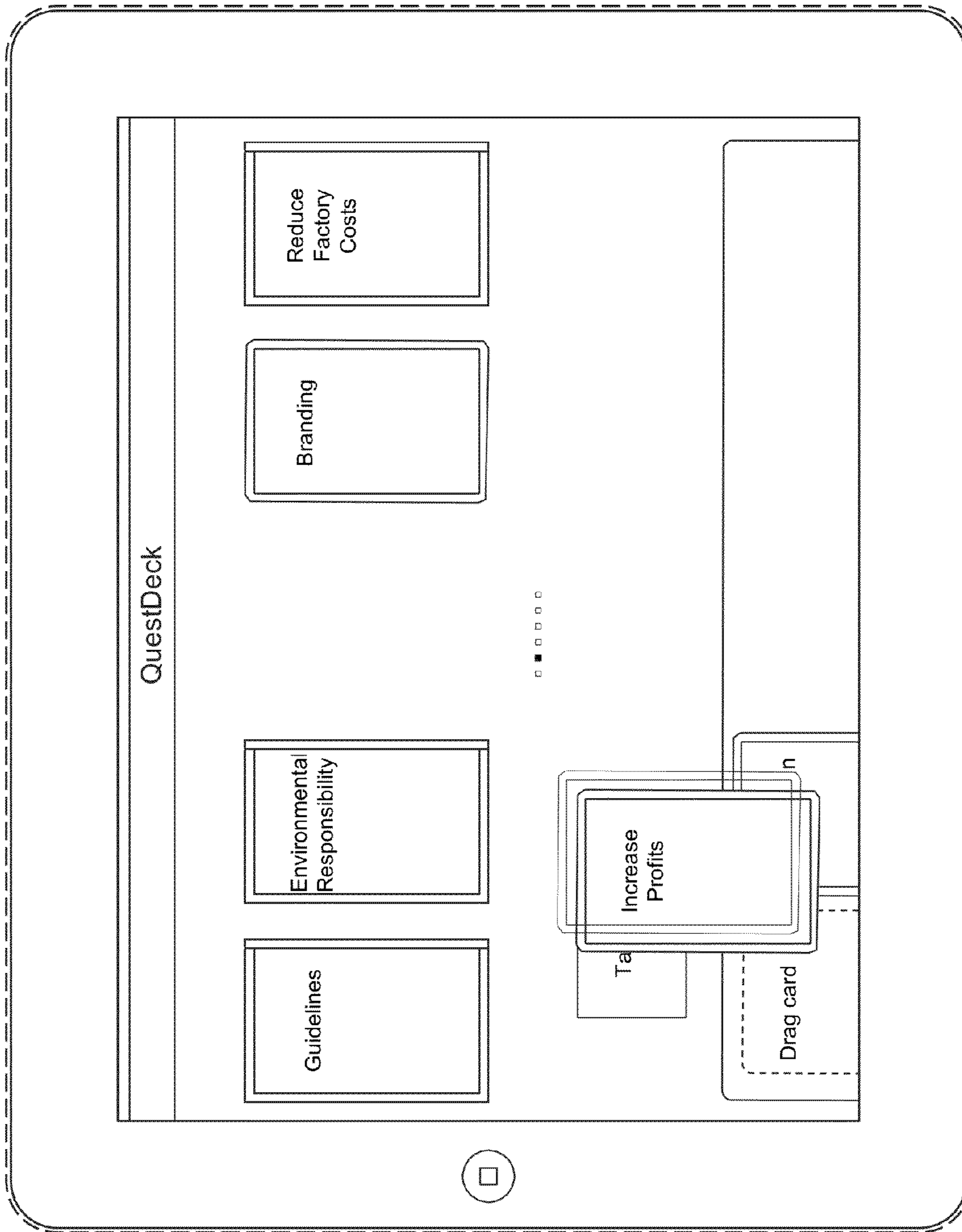

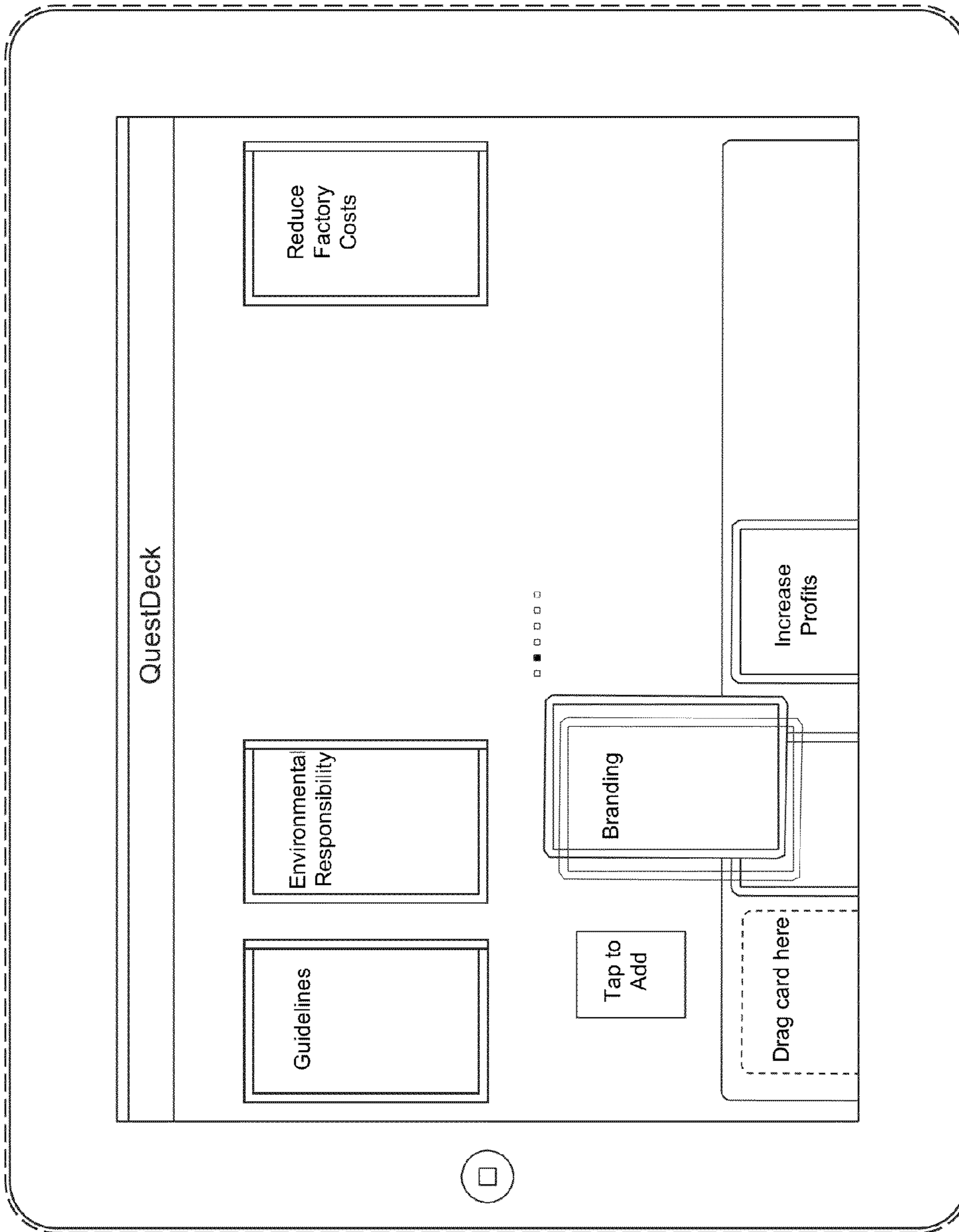

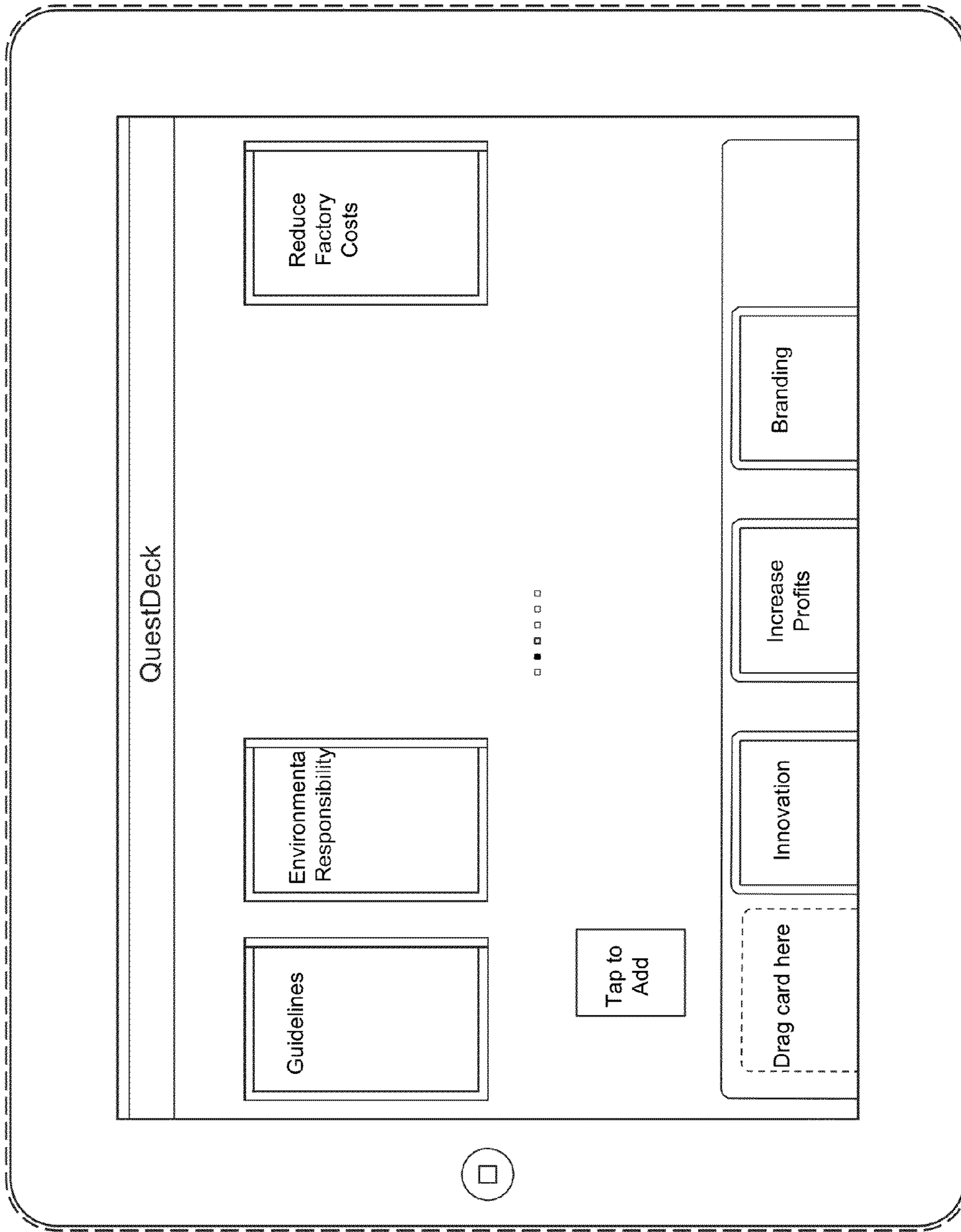

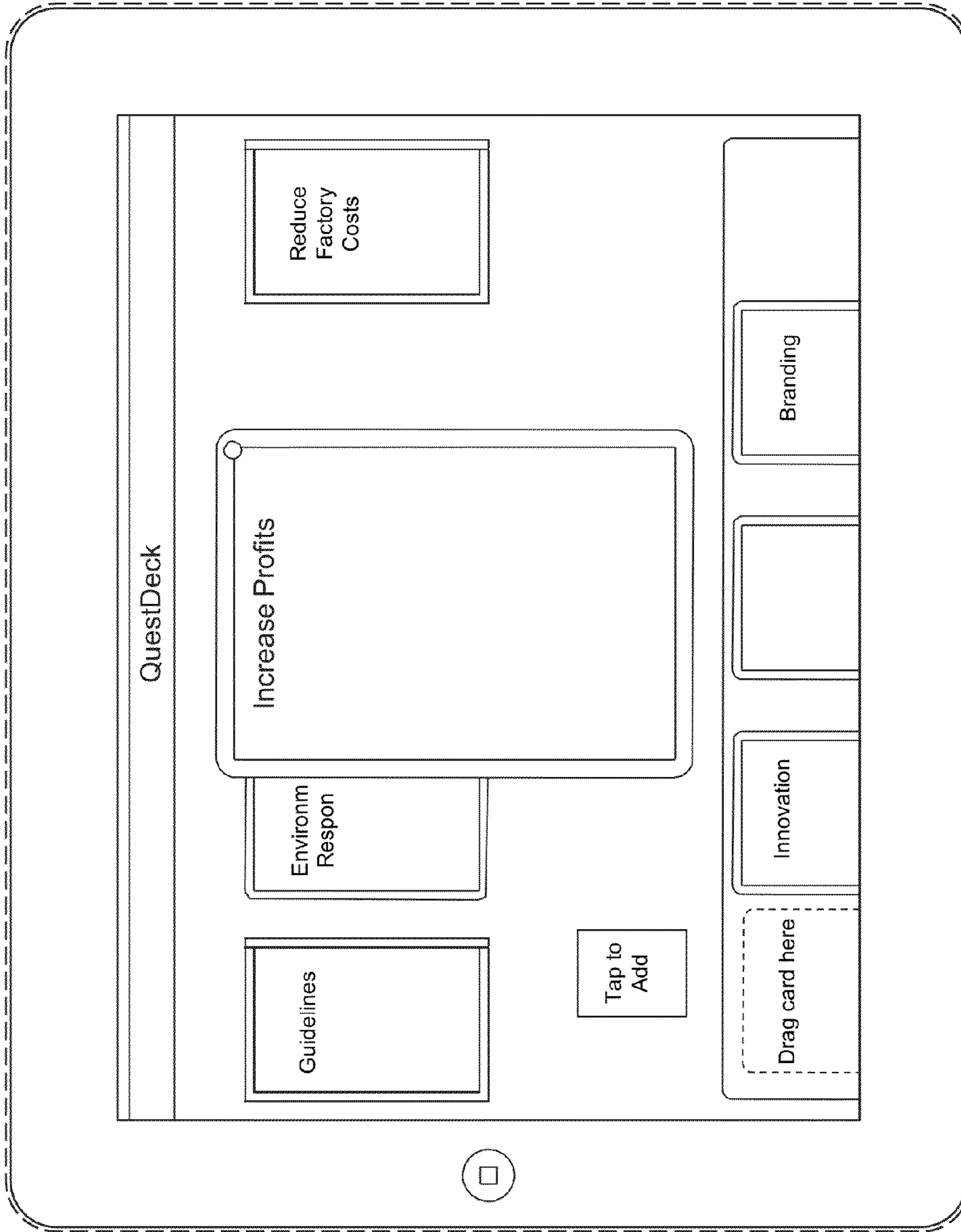

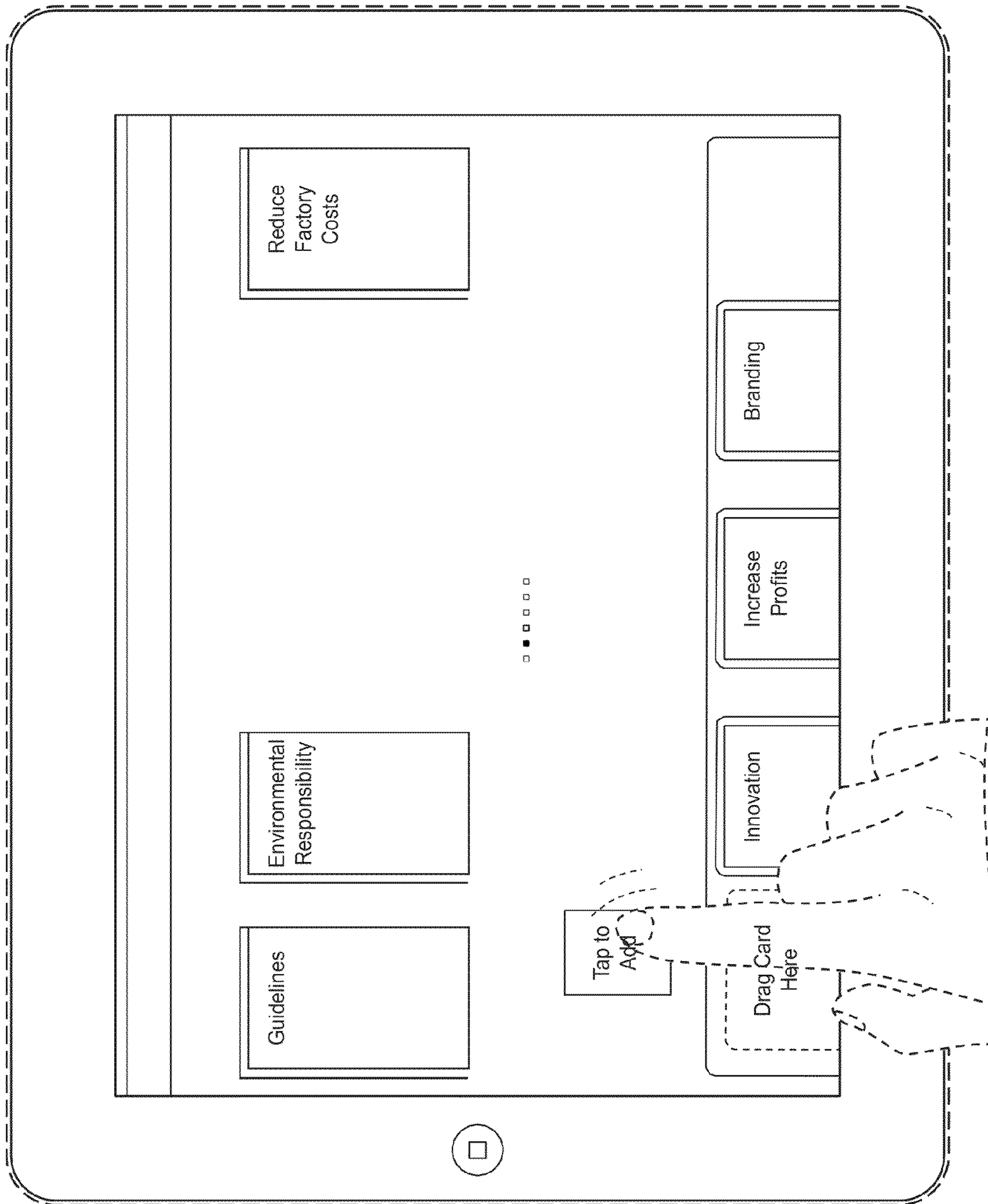

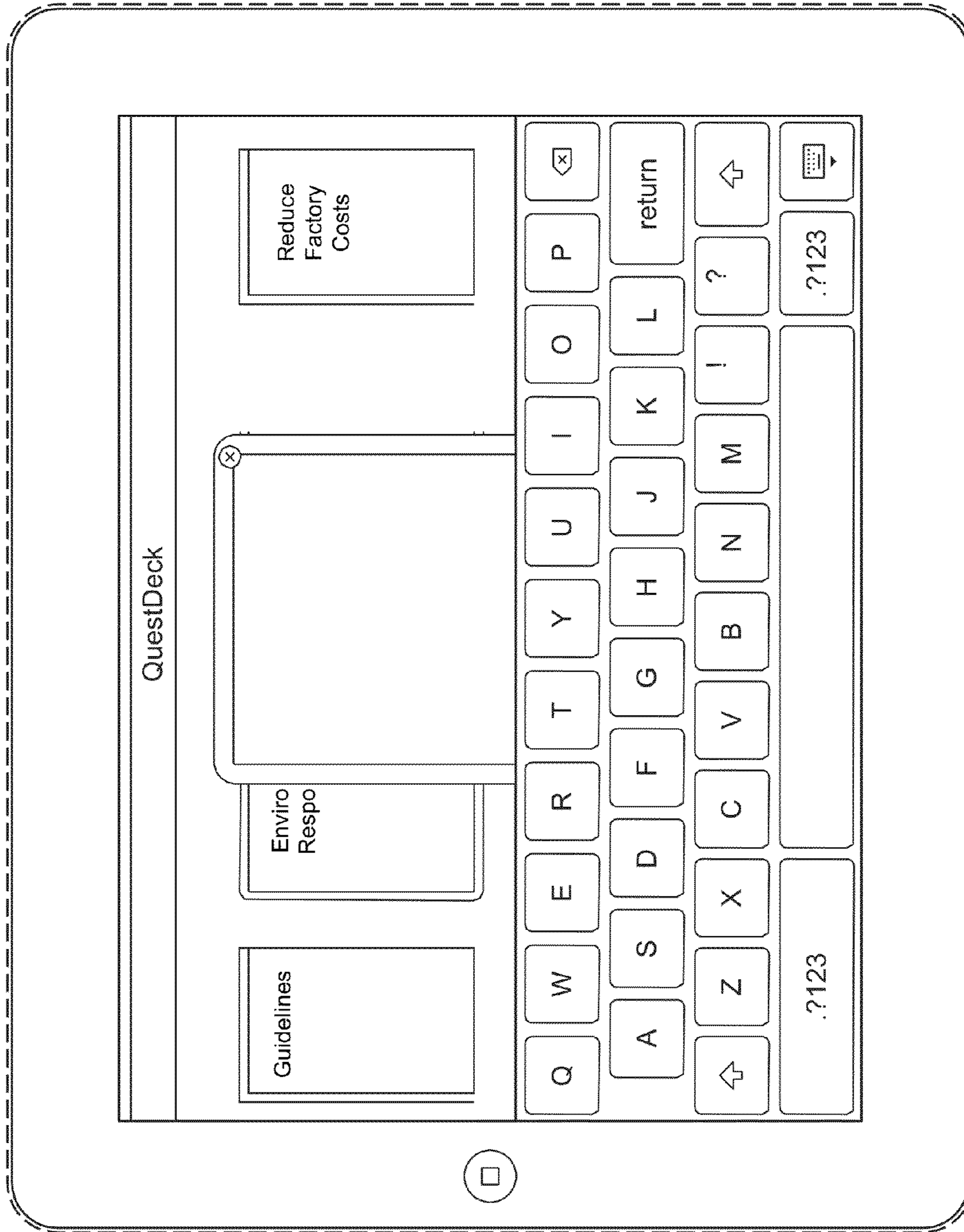

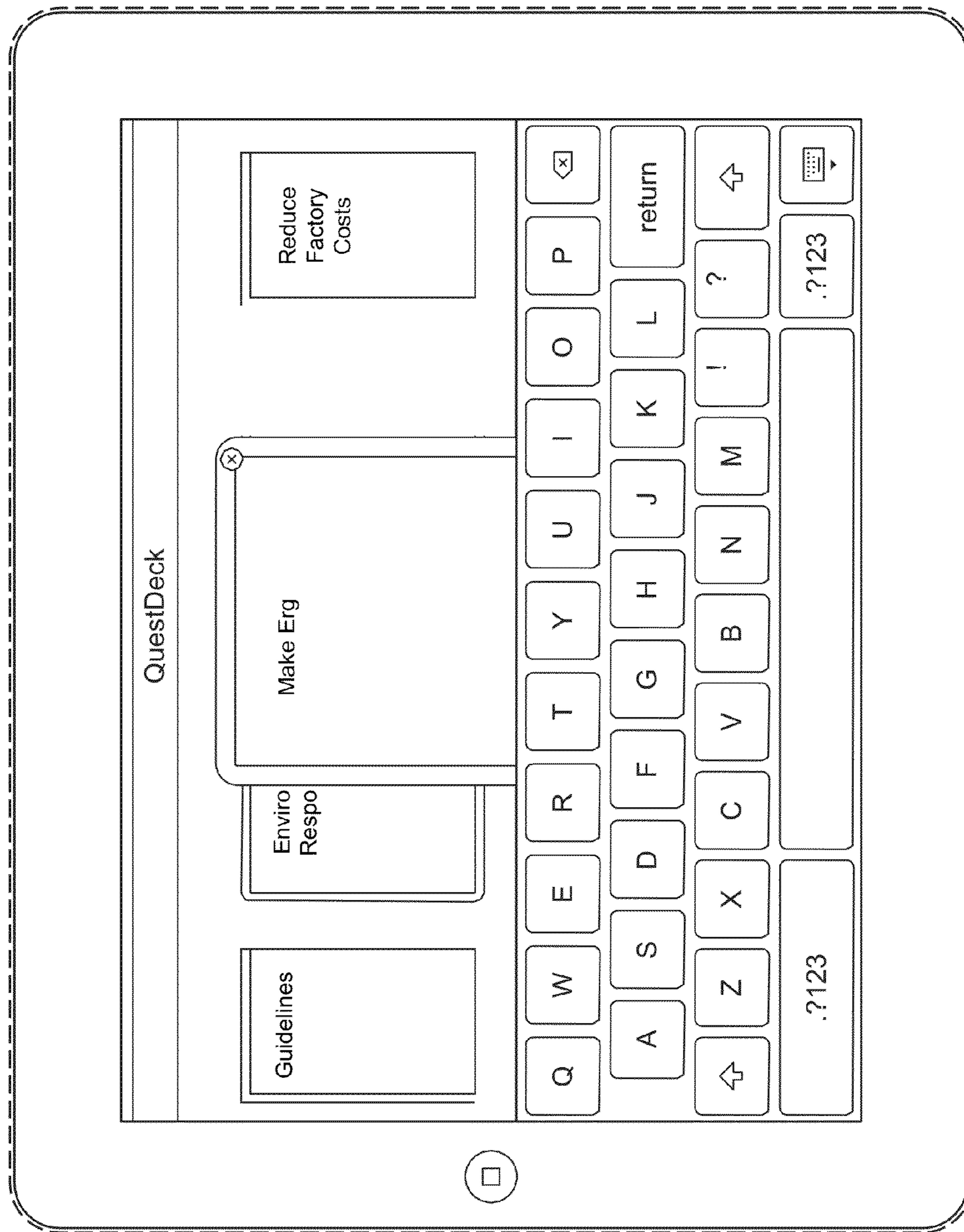
