The ornamental design for an obround pin, as shown and described.

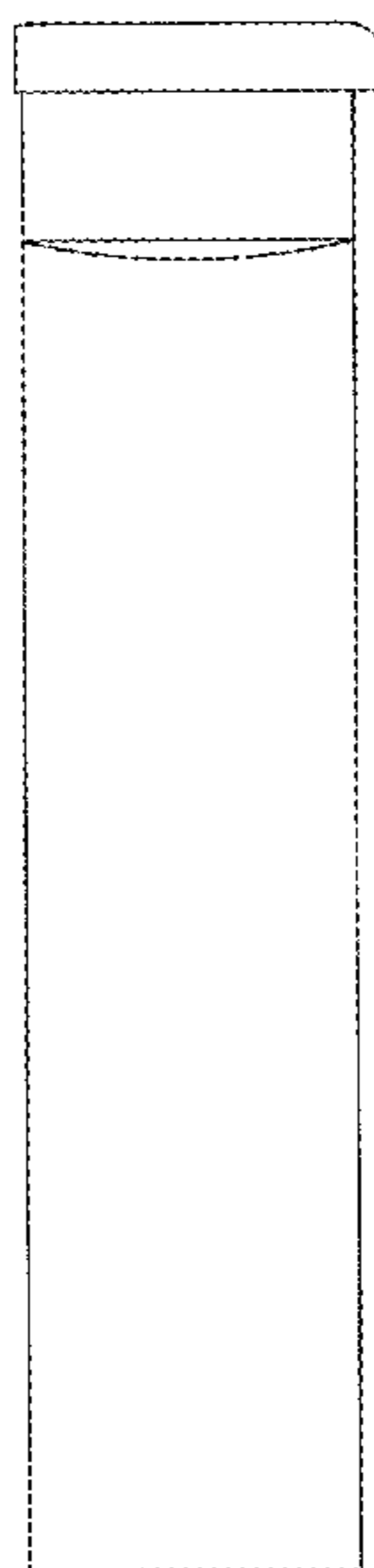
DESCRIPTION

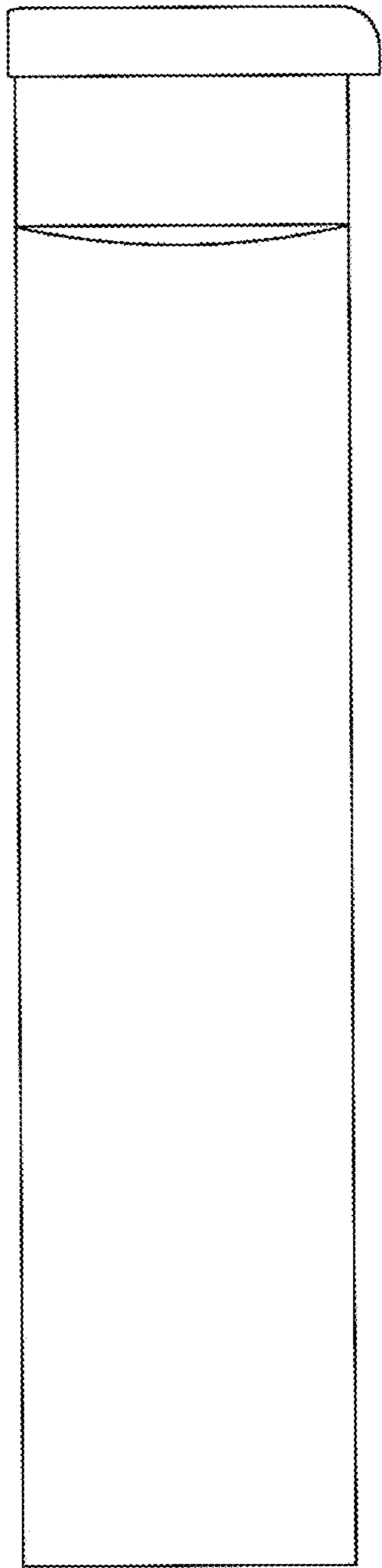

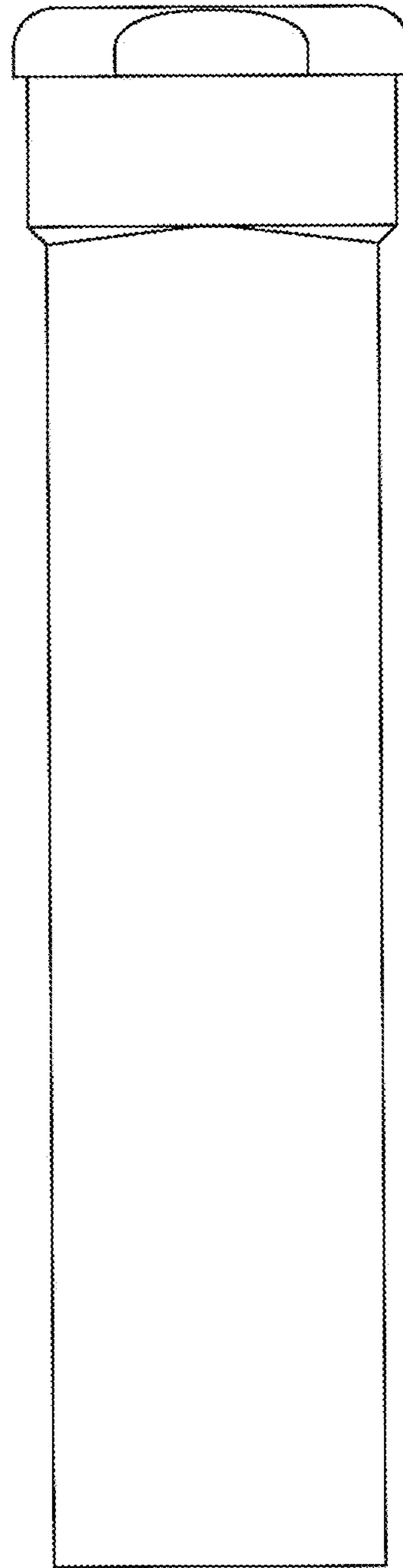

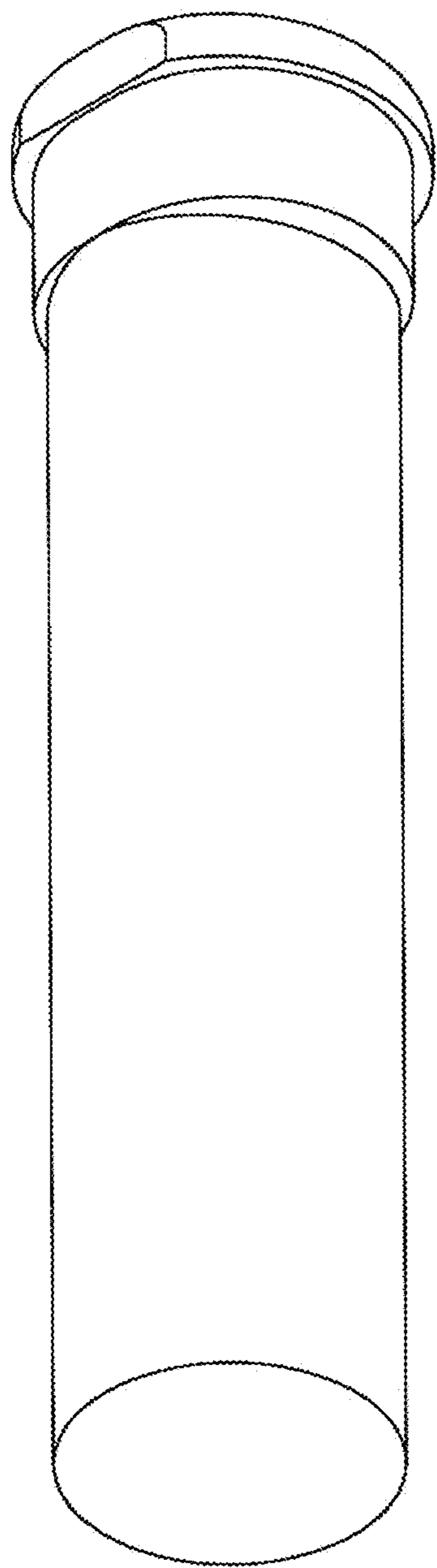

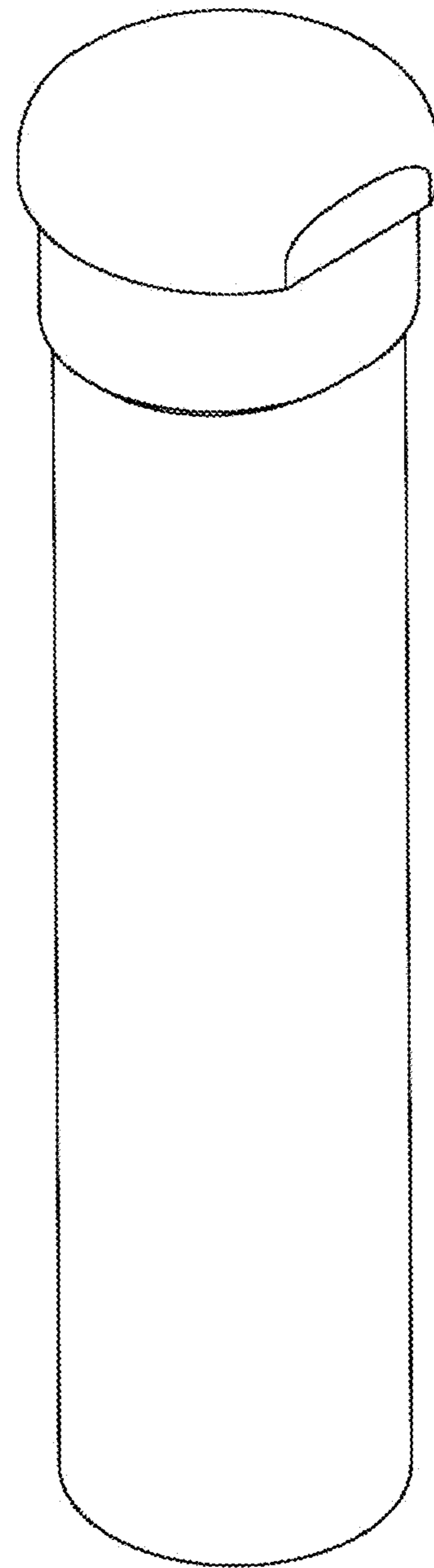

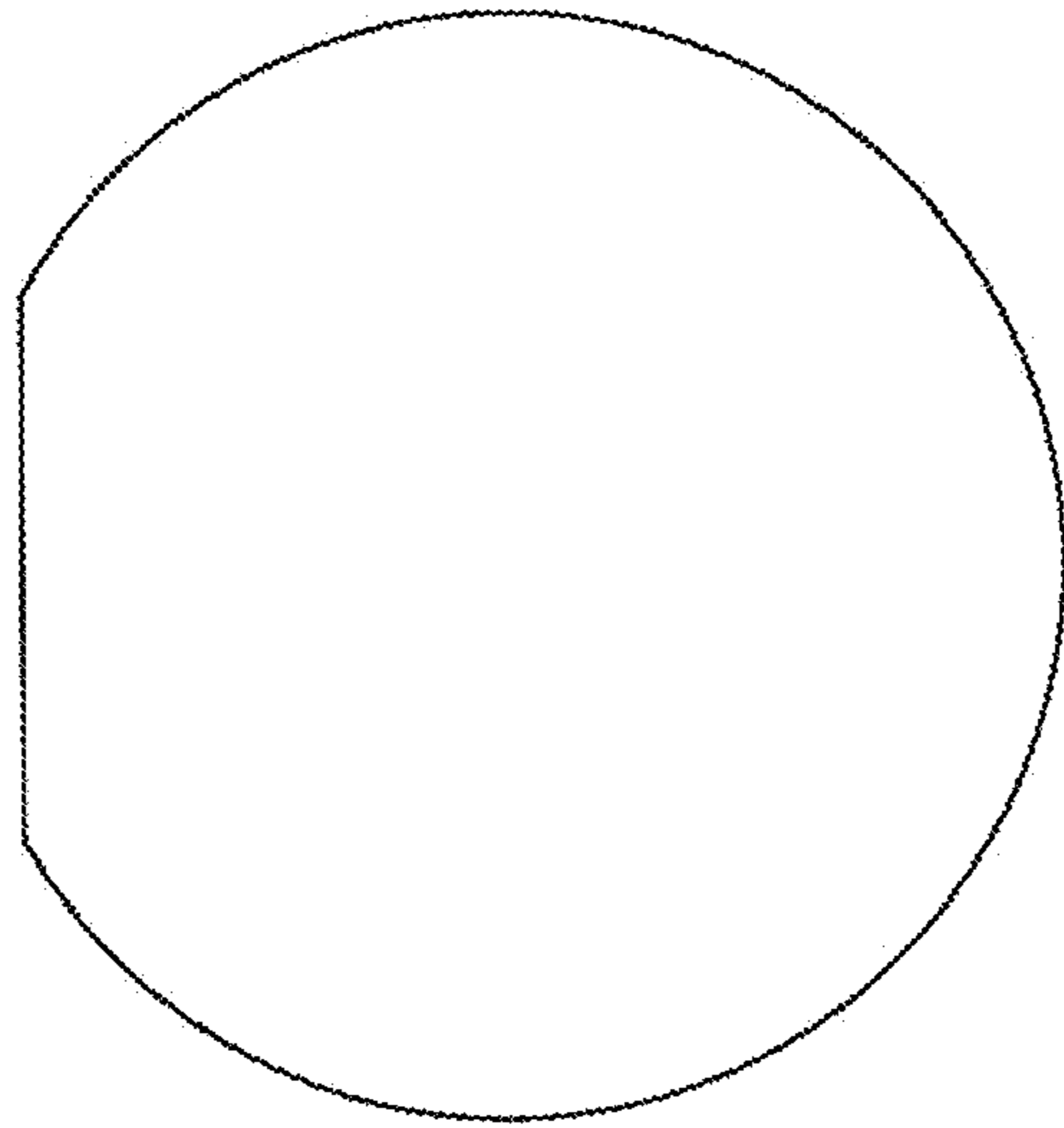

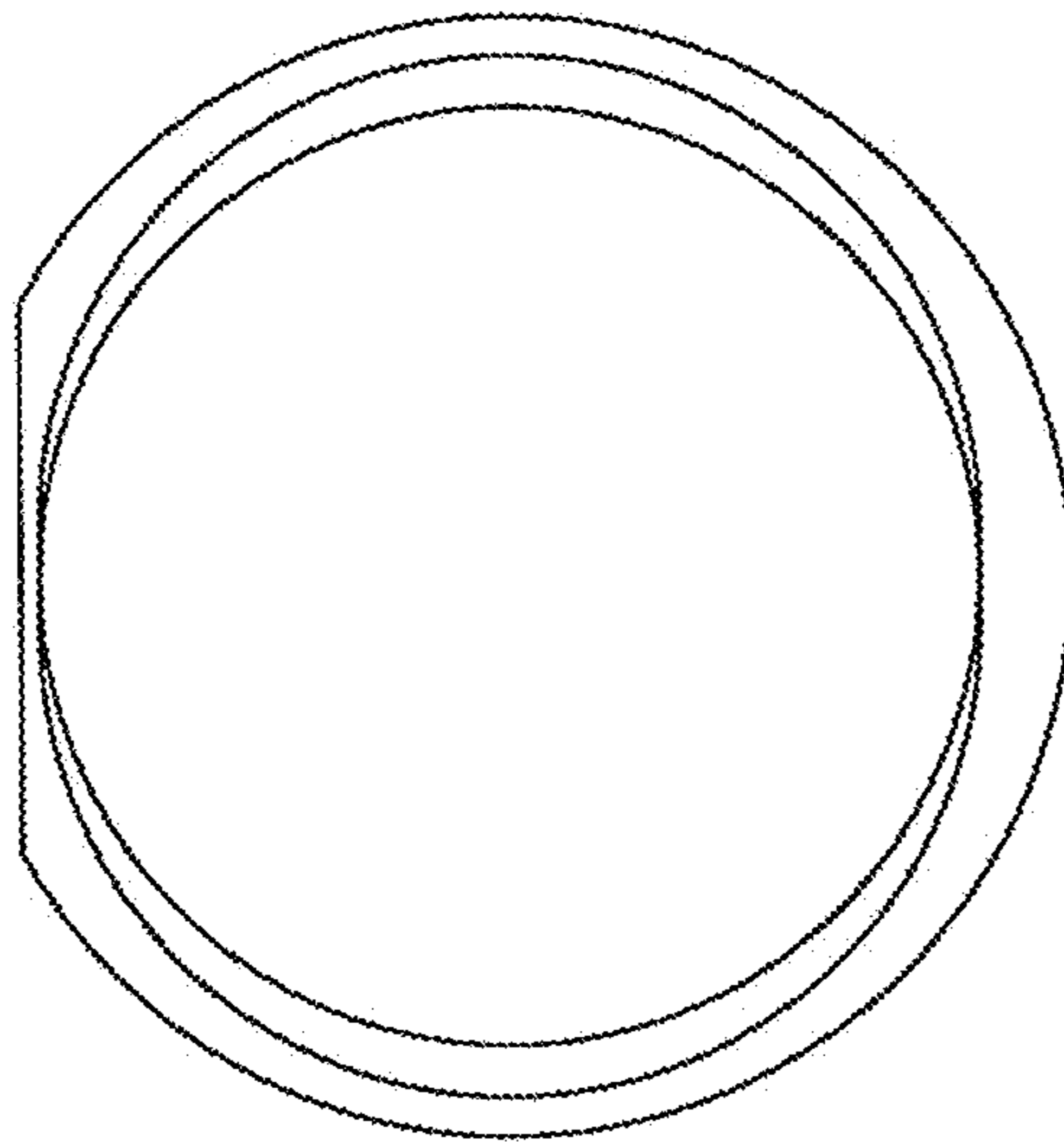
