(57) **CLAIM**

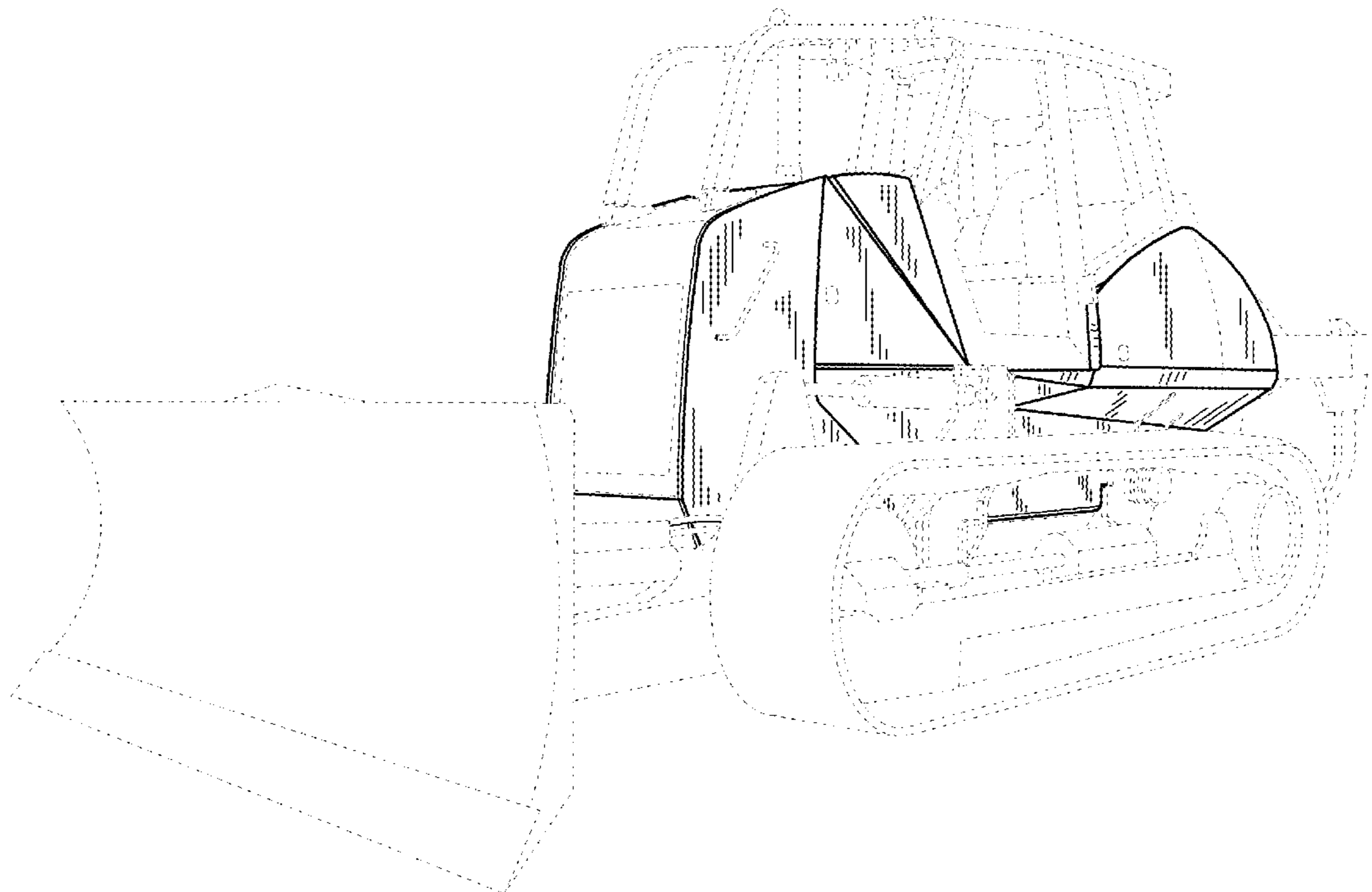
The ornamental design for a work vehicle body, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a work vehicle body showing an embodiment of our new design;

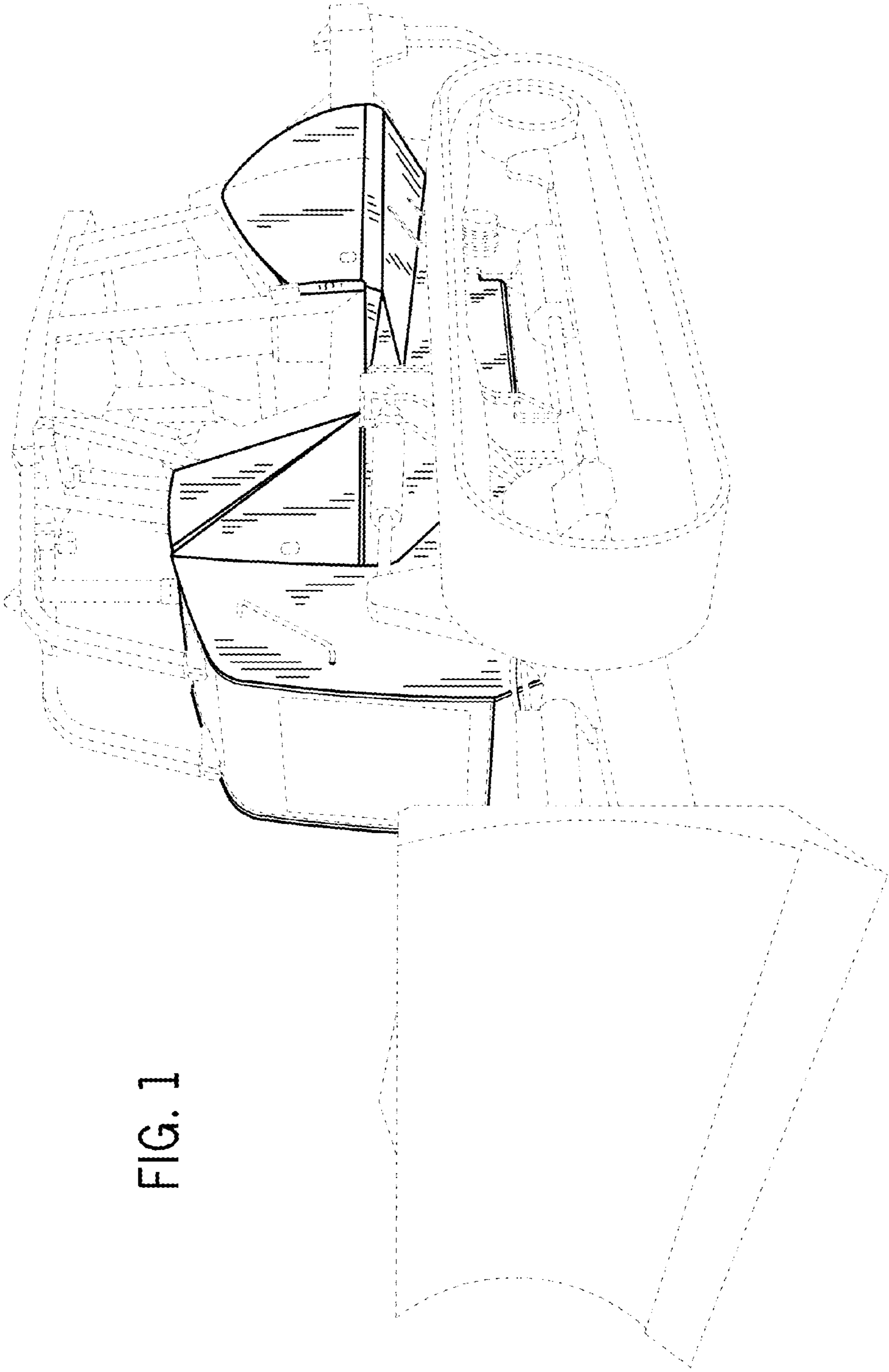

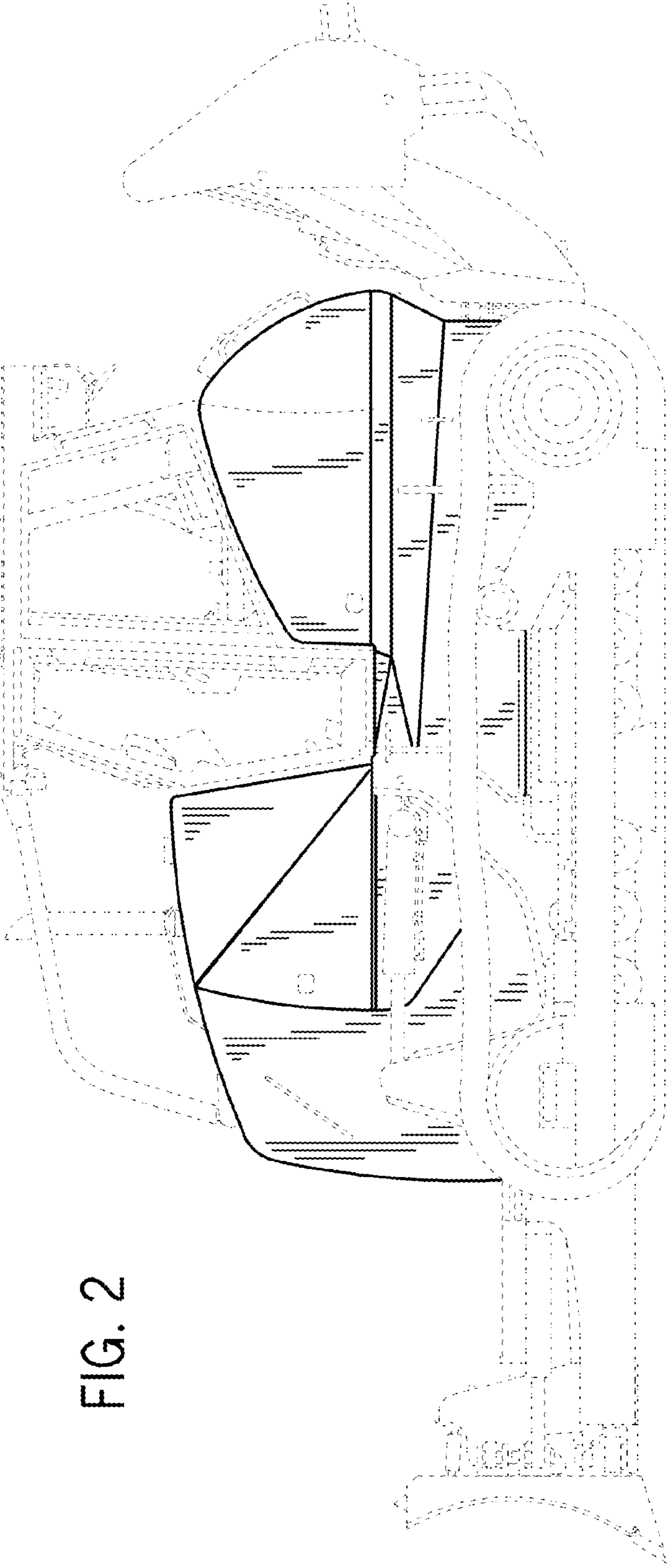

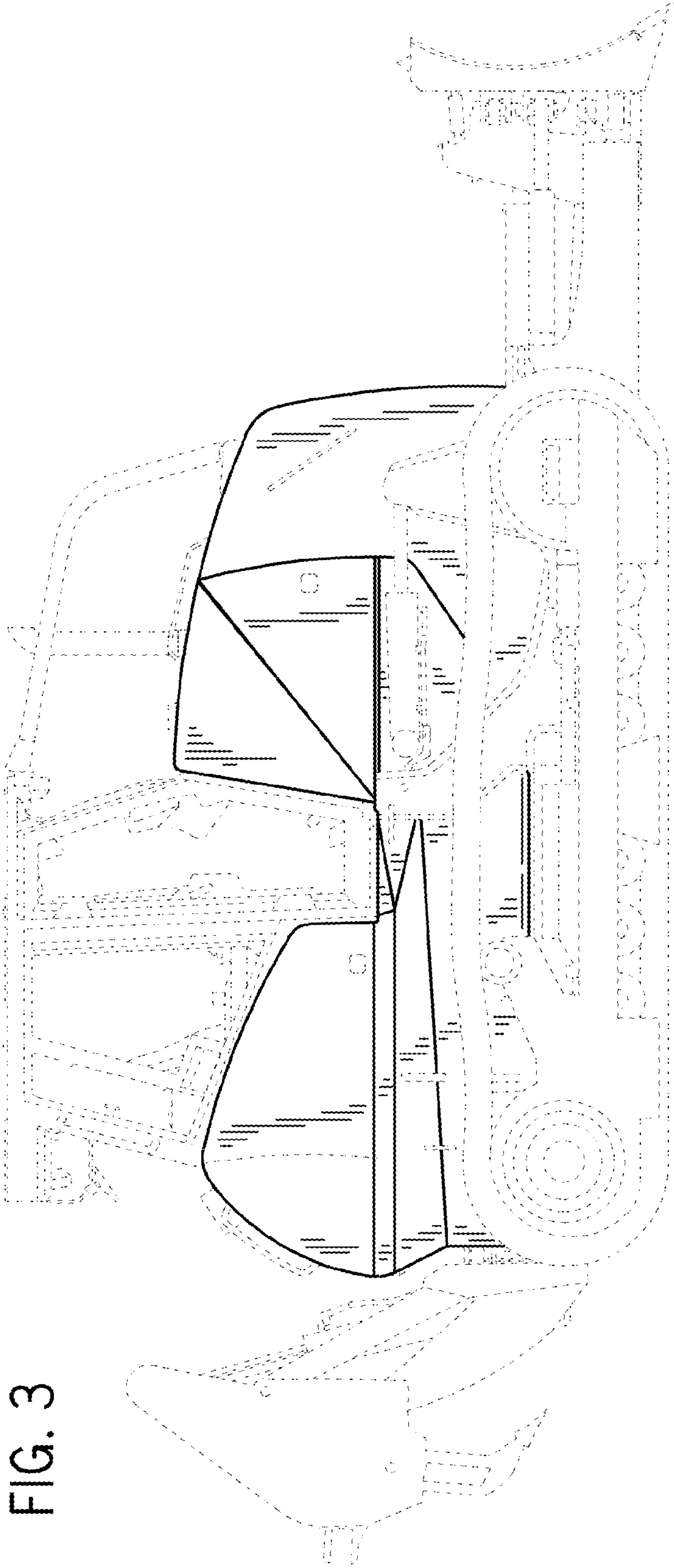

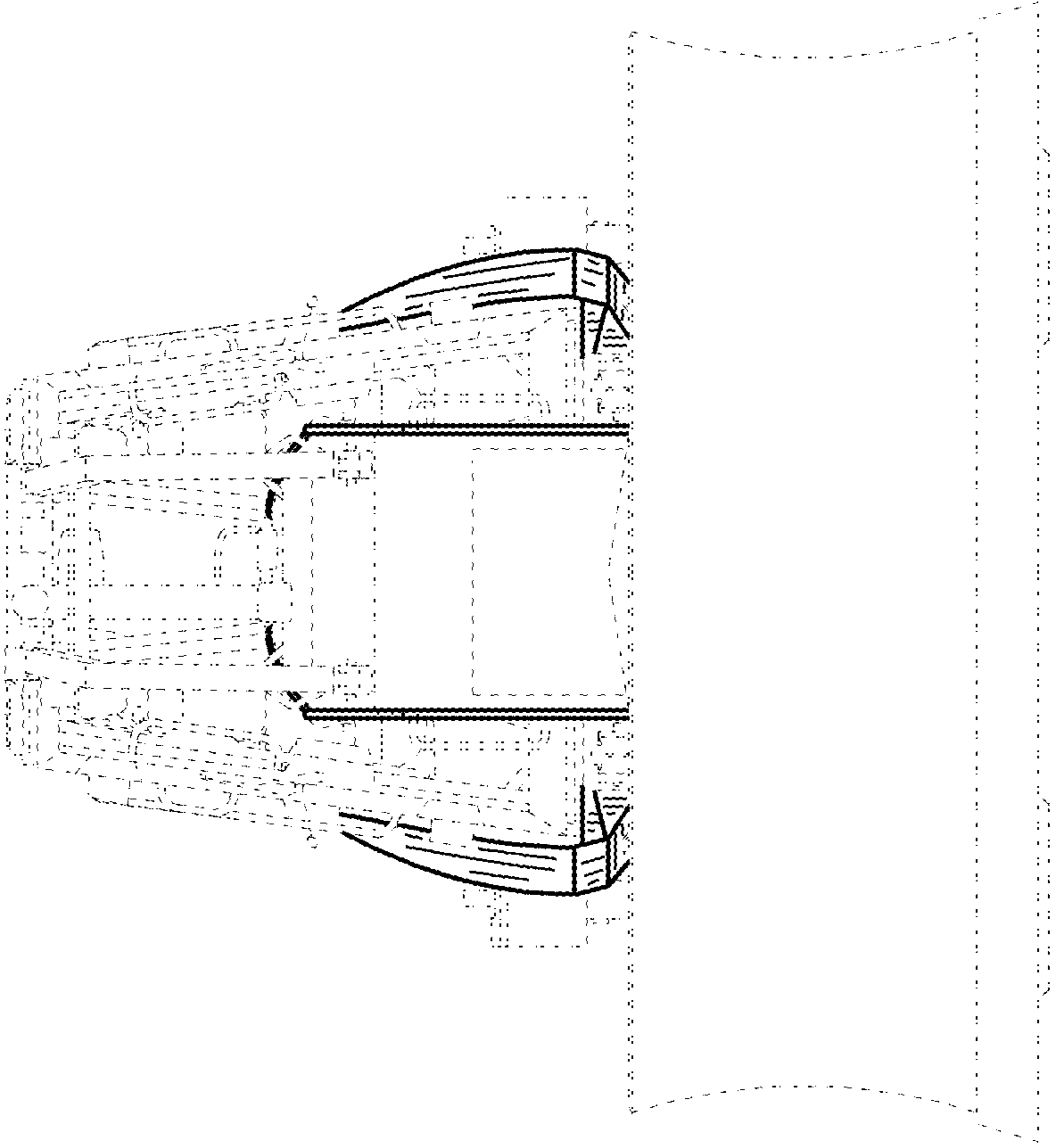

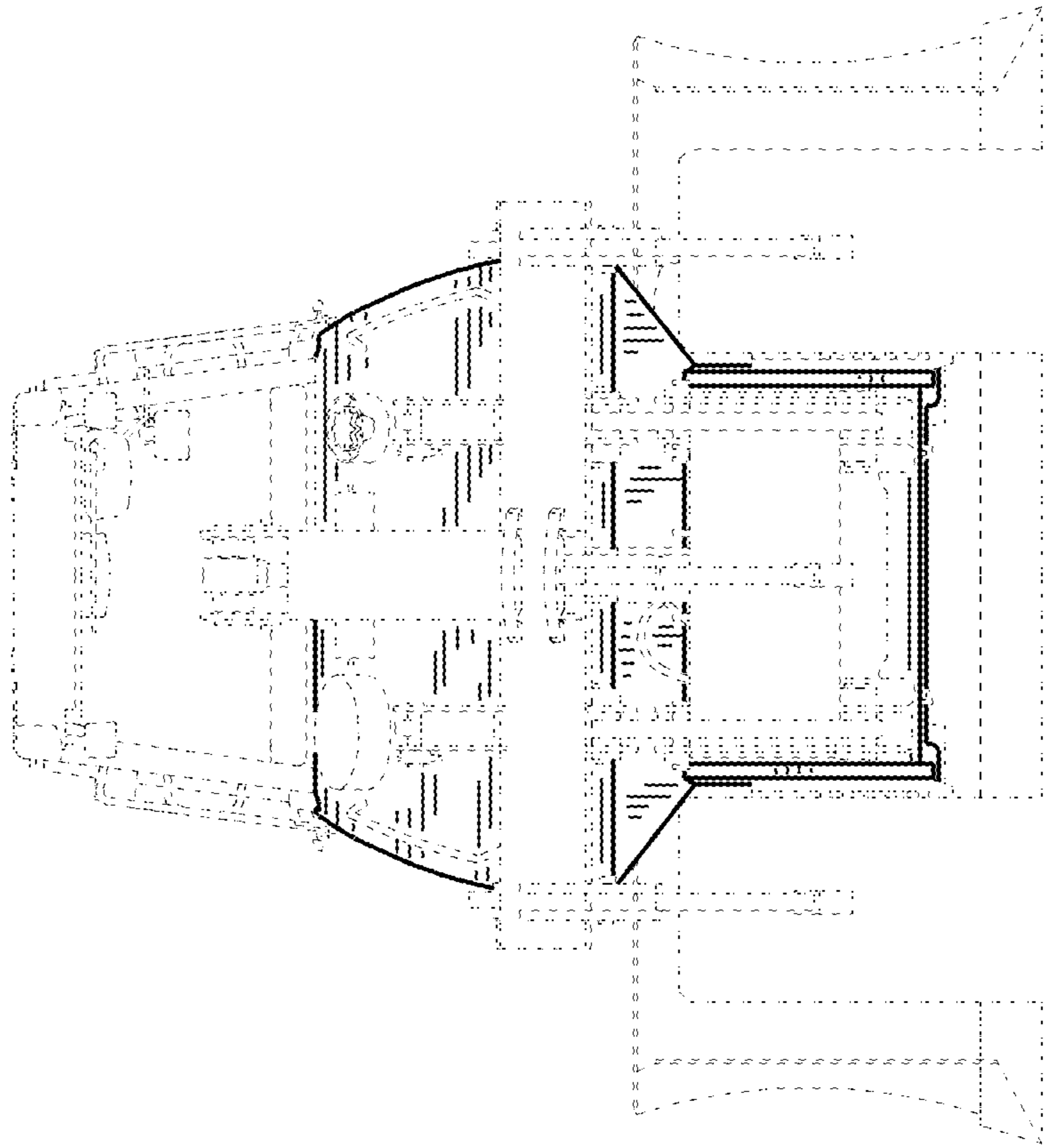

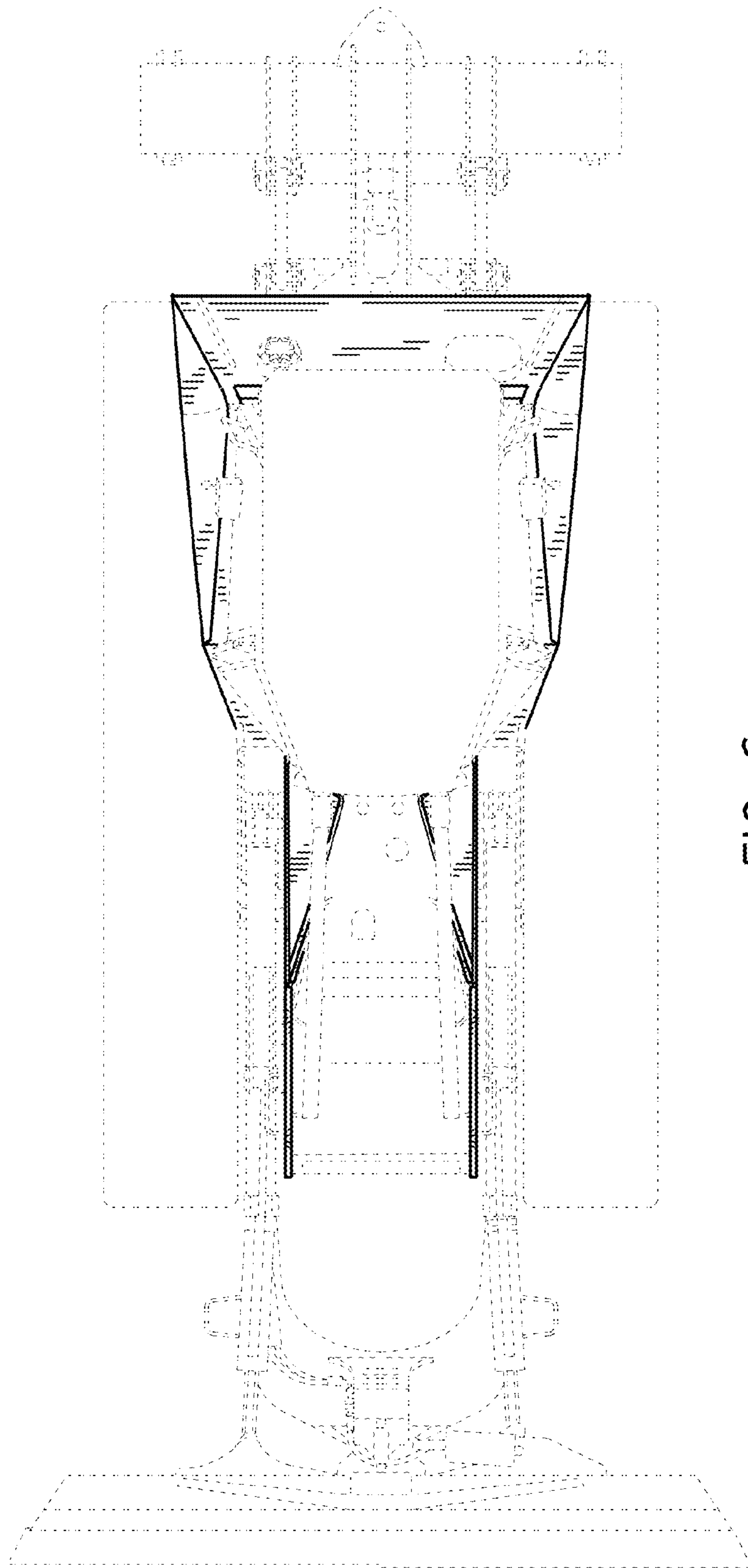

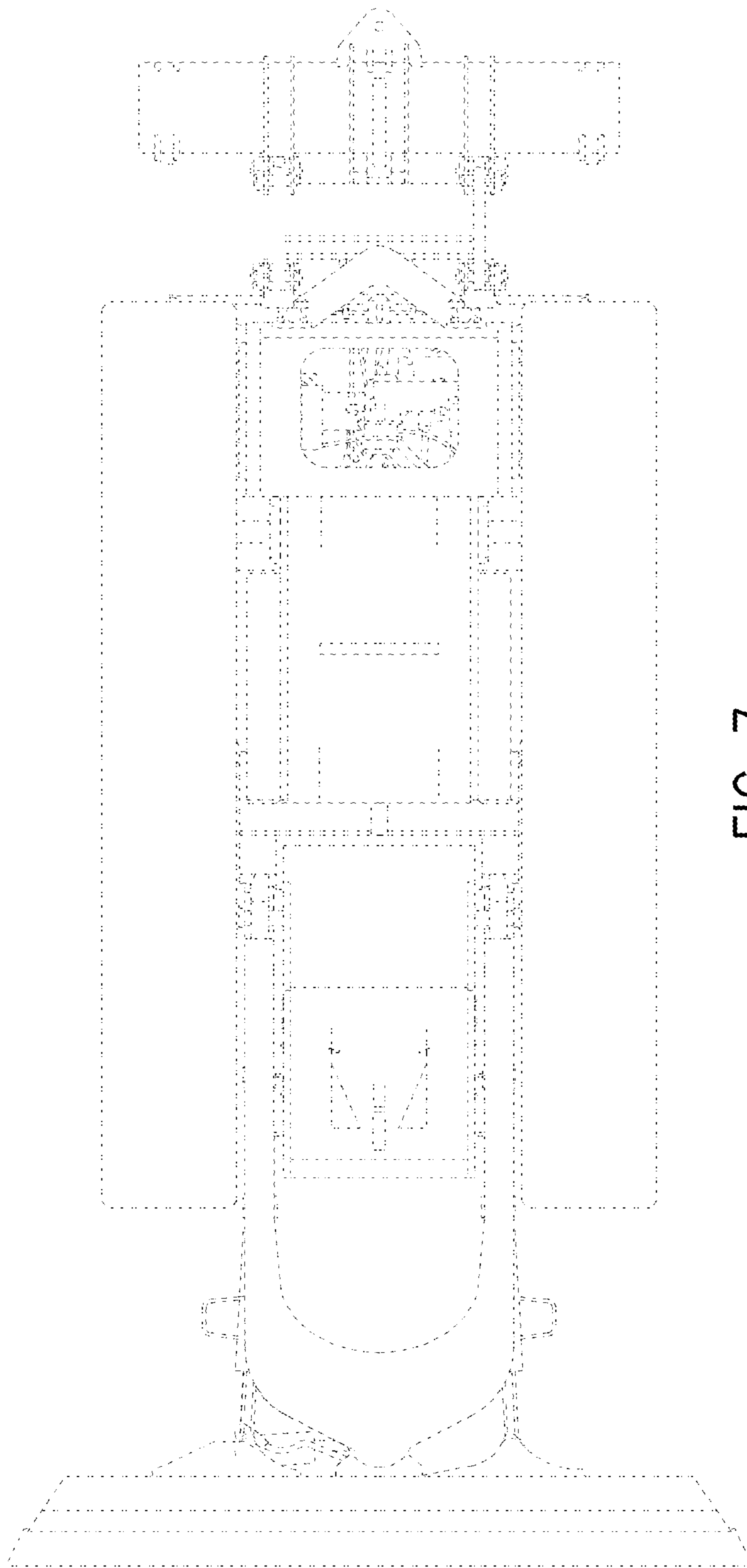
