FIG. 2 is a back view of the design of the precious stone of FIG. 1.

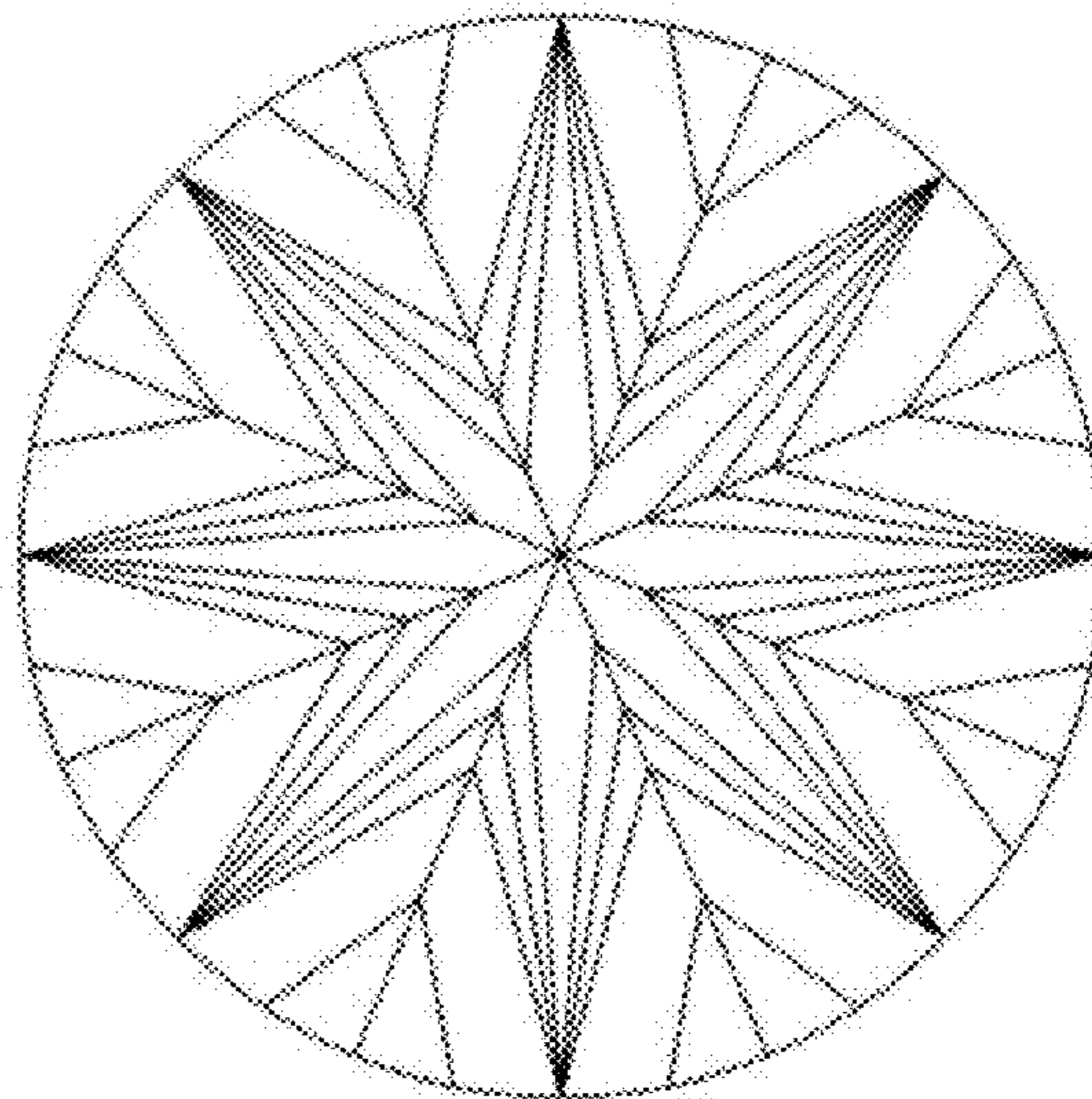
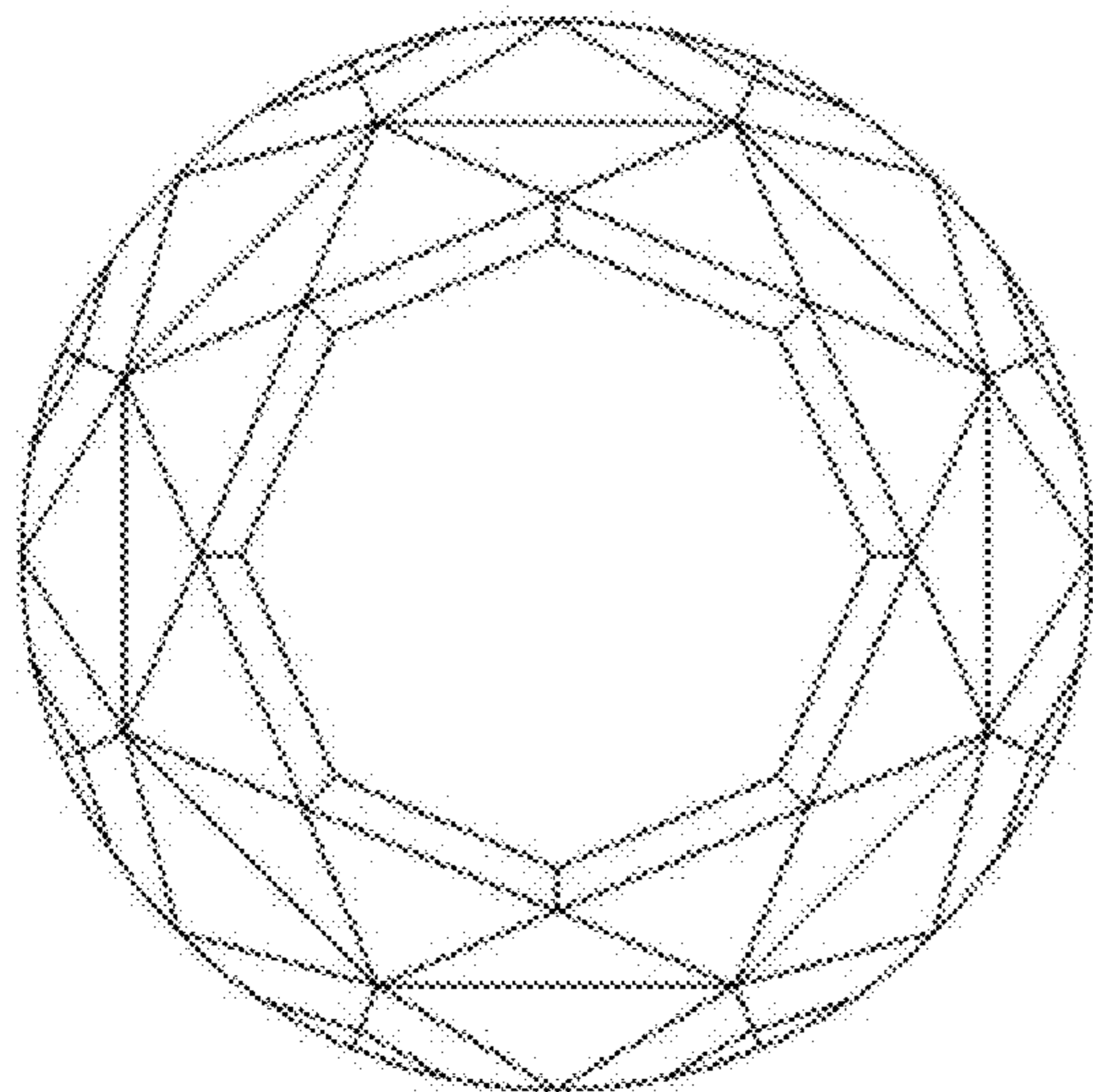
FIG. 3 is a left side view of the design of the precious stone of FIG. 1.

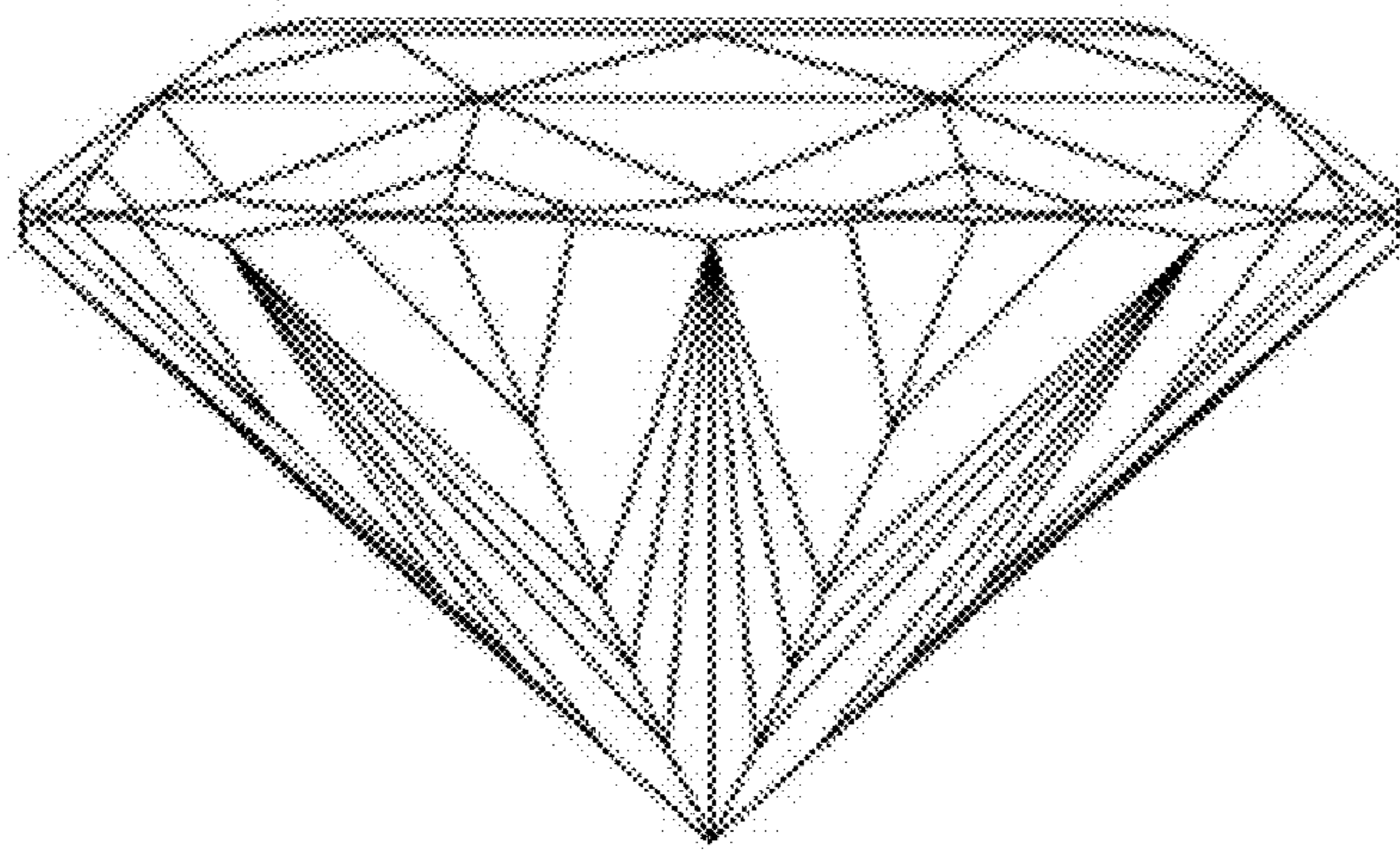

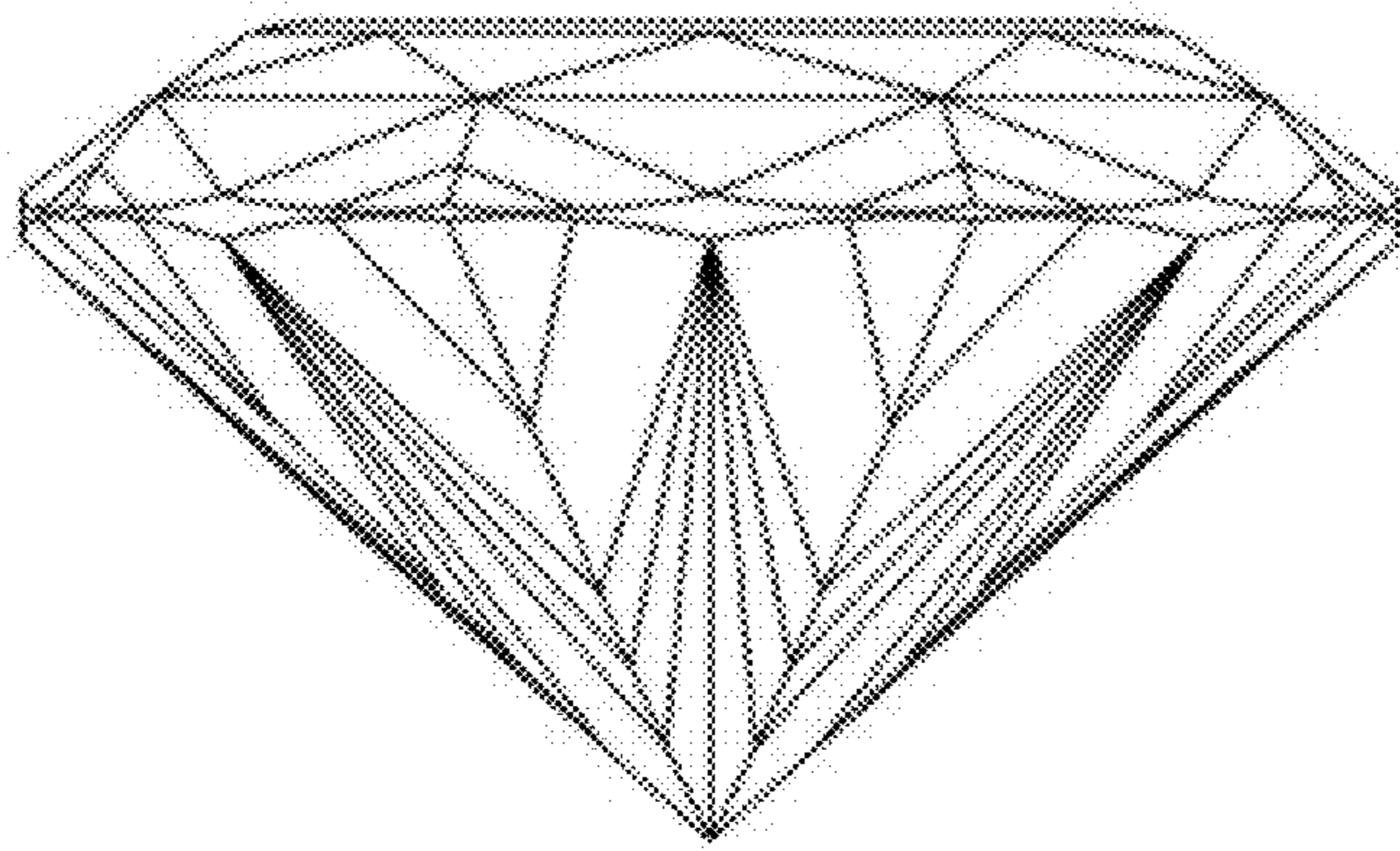

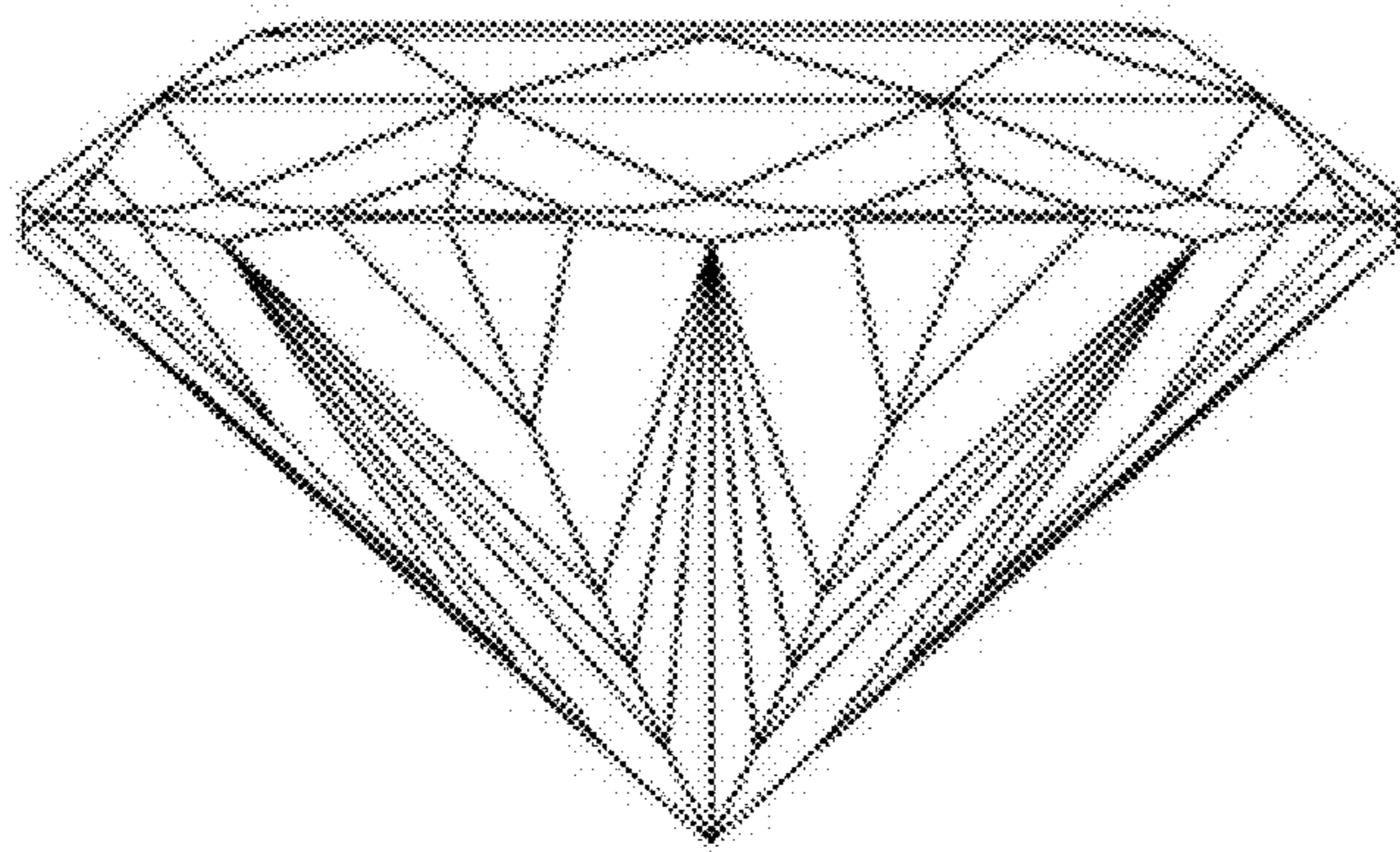

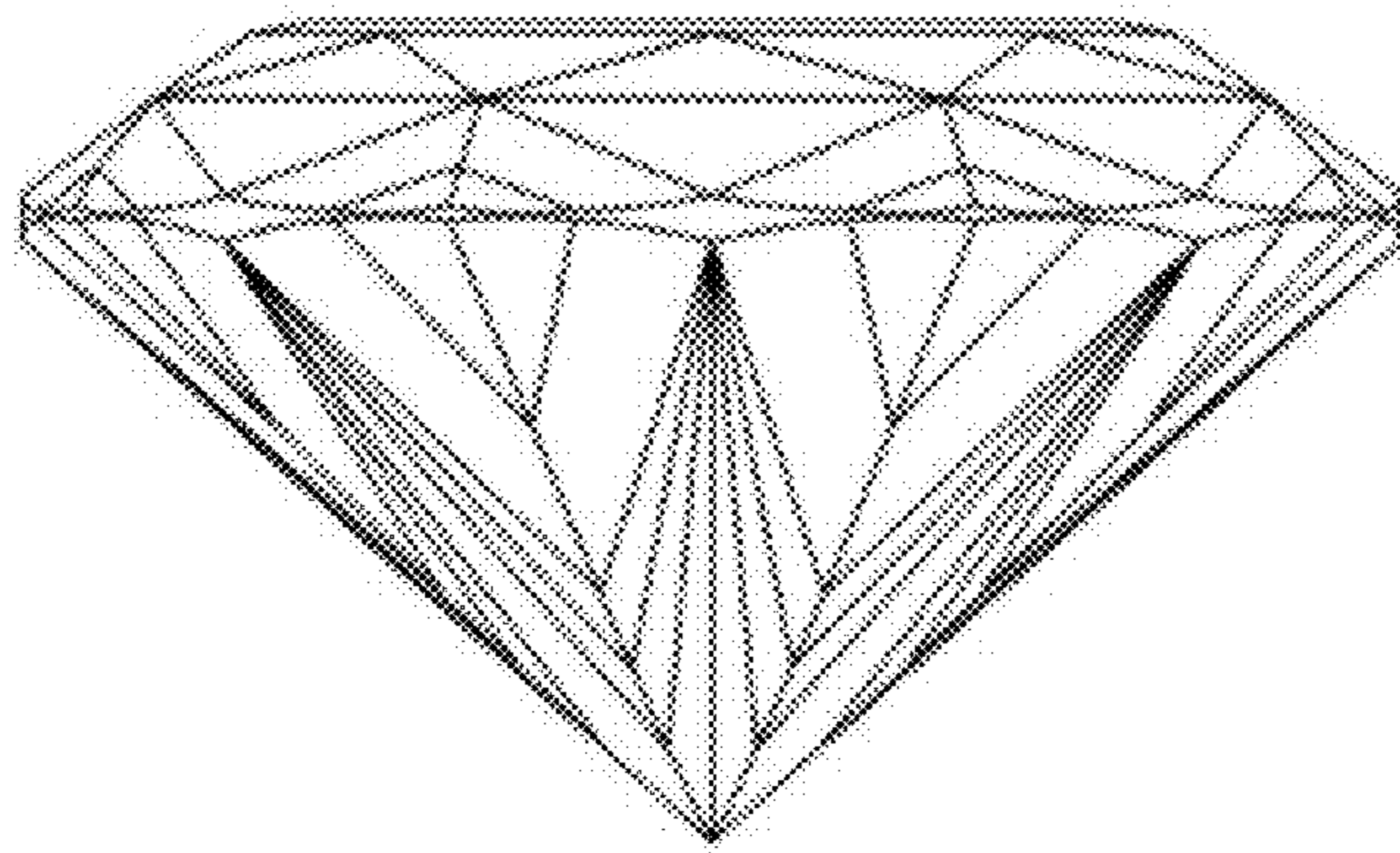

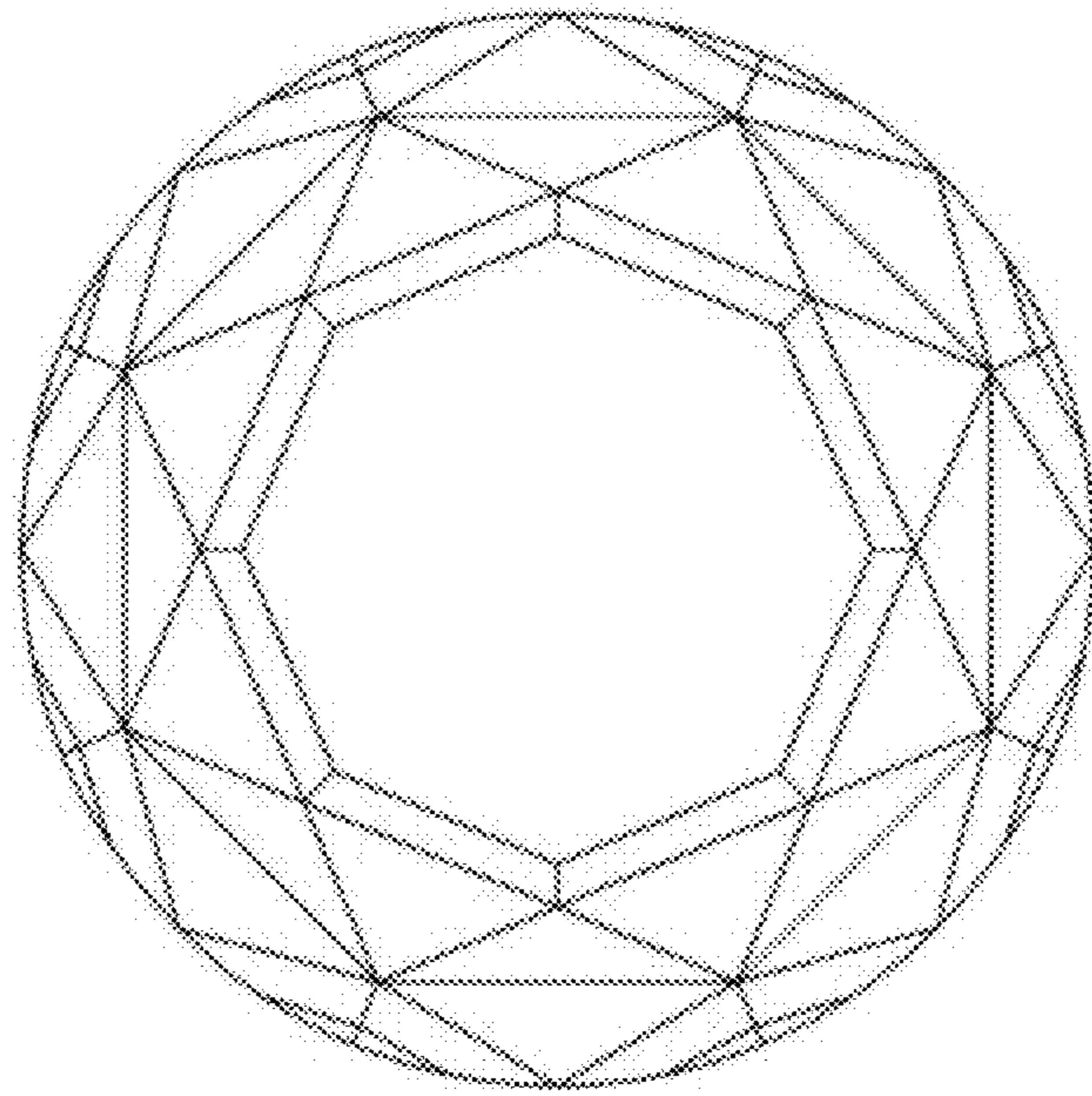

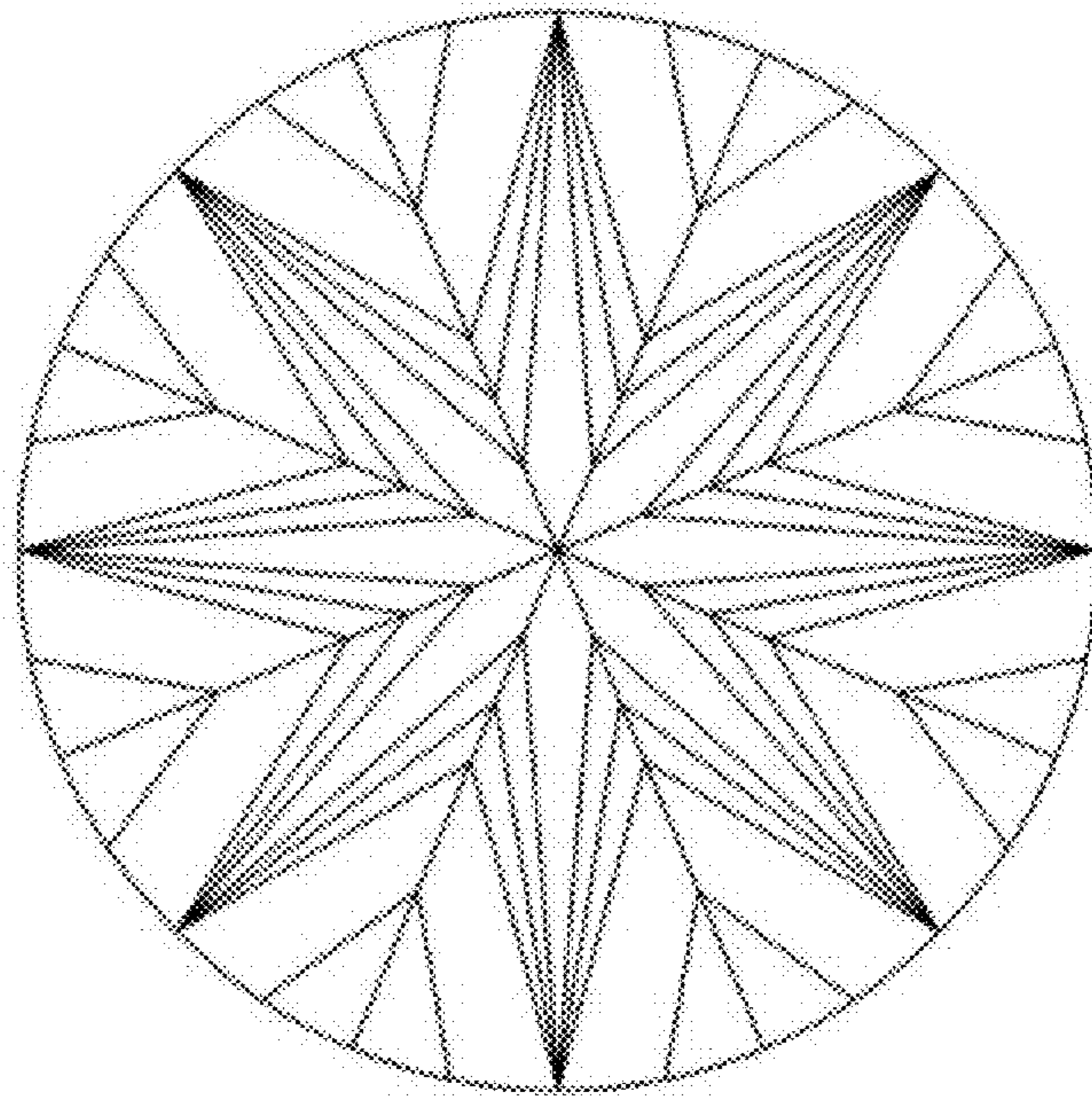
