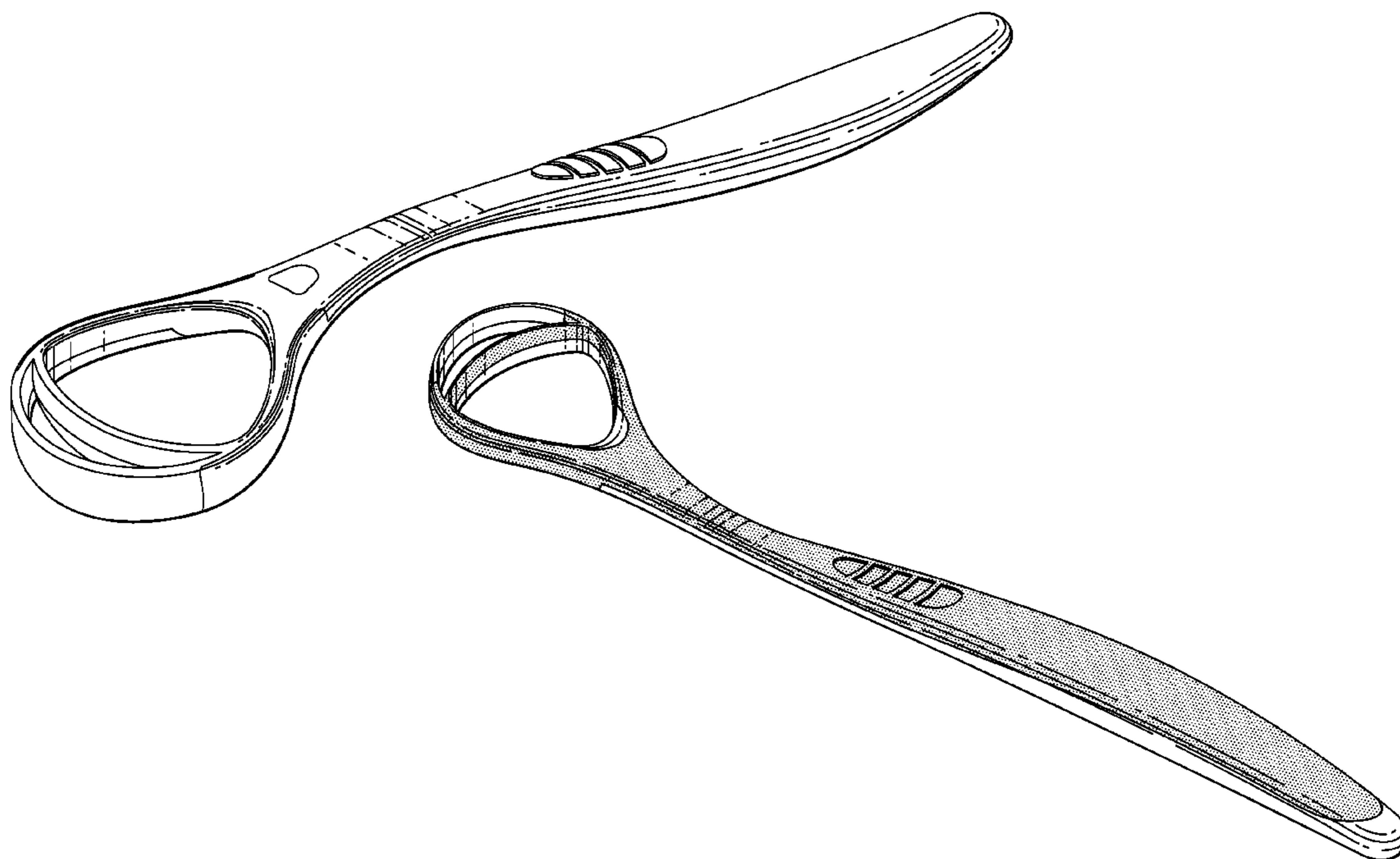
(57) **CLAIM**

The ornamental design for a tongue scraper, as shown and described.

DESCRIPTION

FIG. 1 is a top, left side perspective view of my tongue scraper;
 FIG. 2 is a rear perspective view thereof;

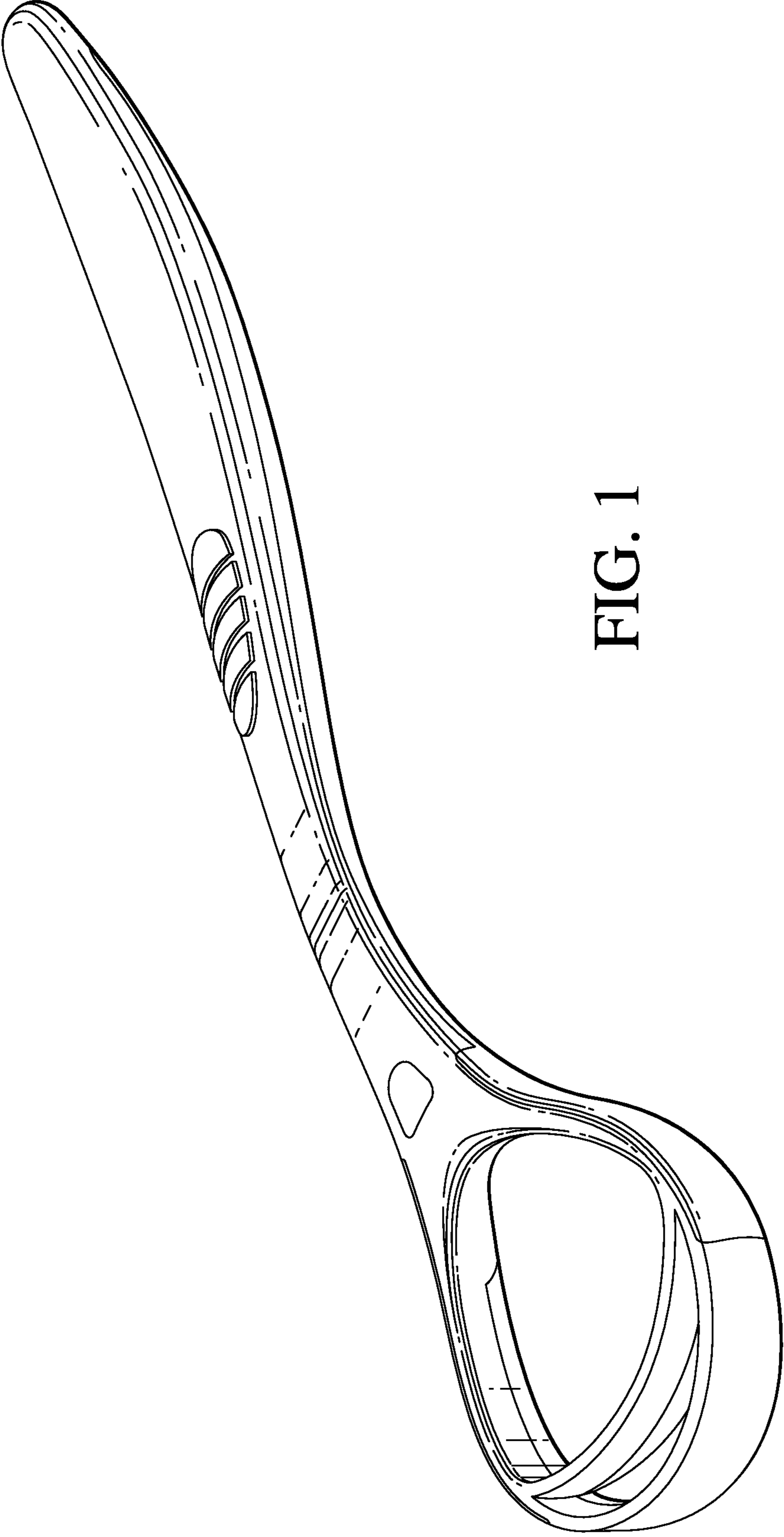

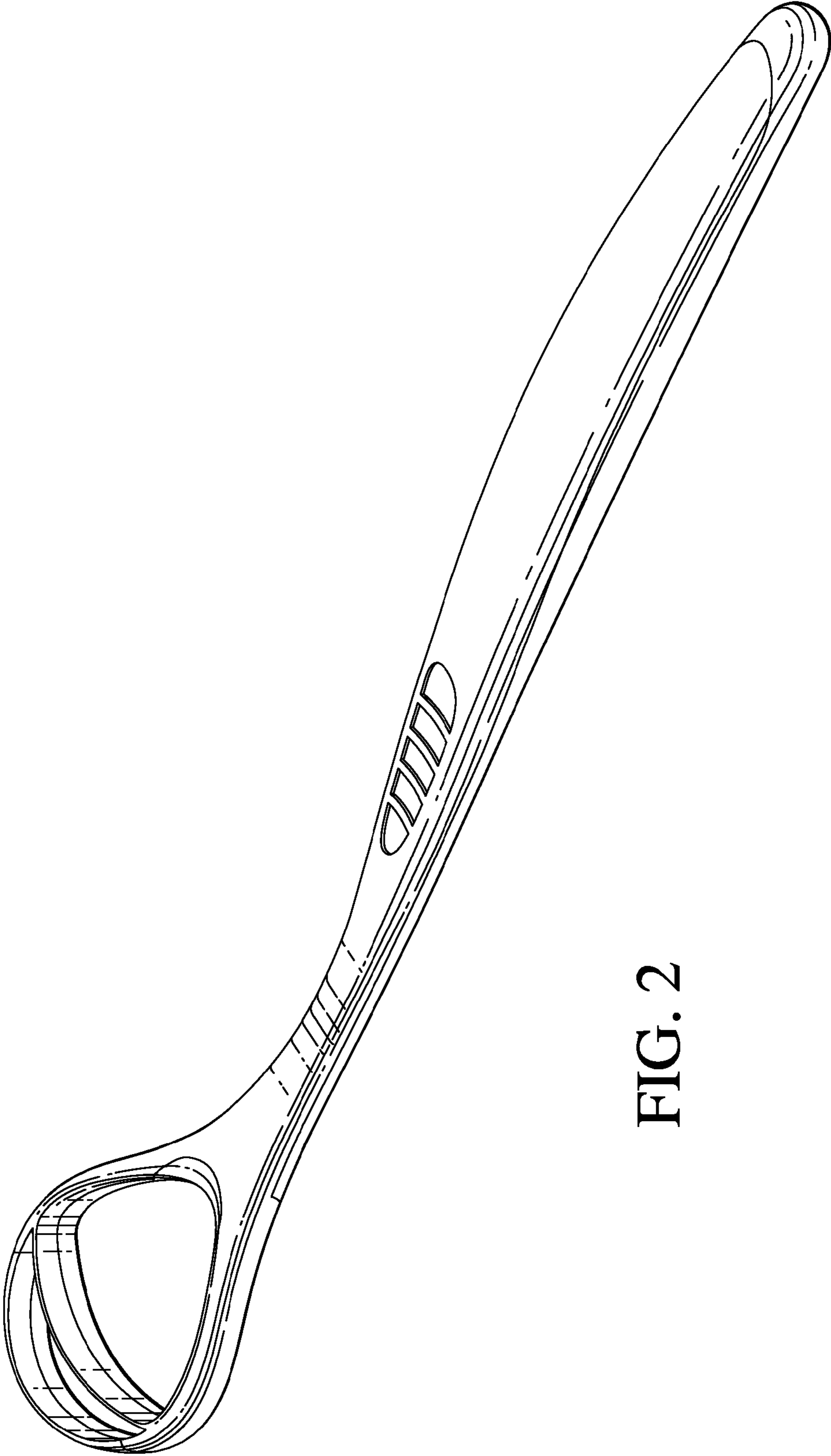

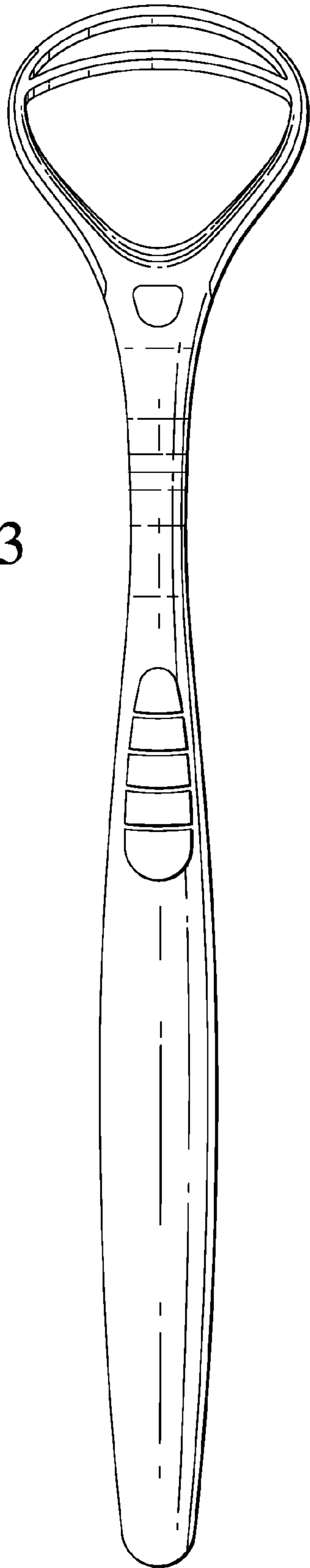

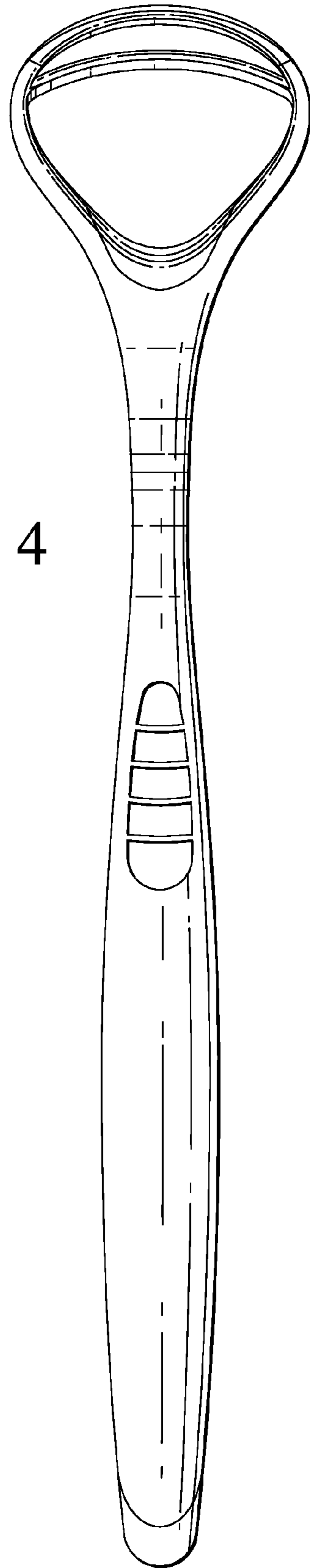

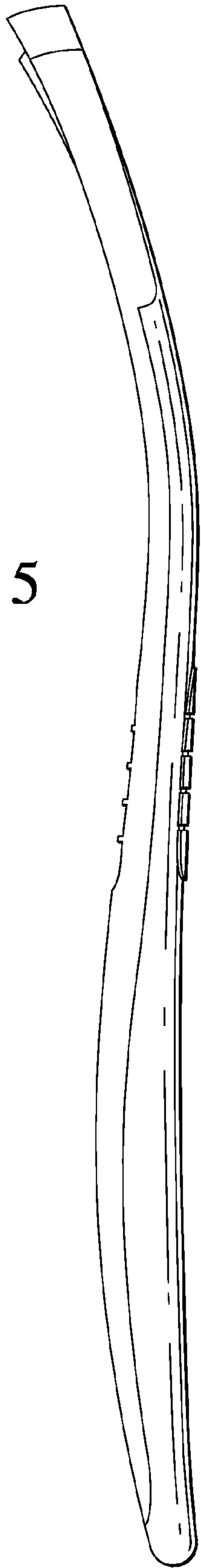
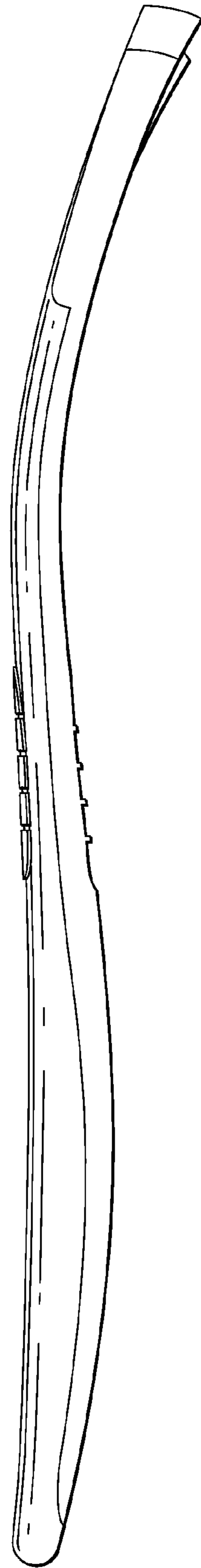

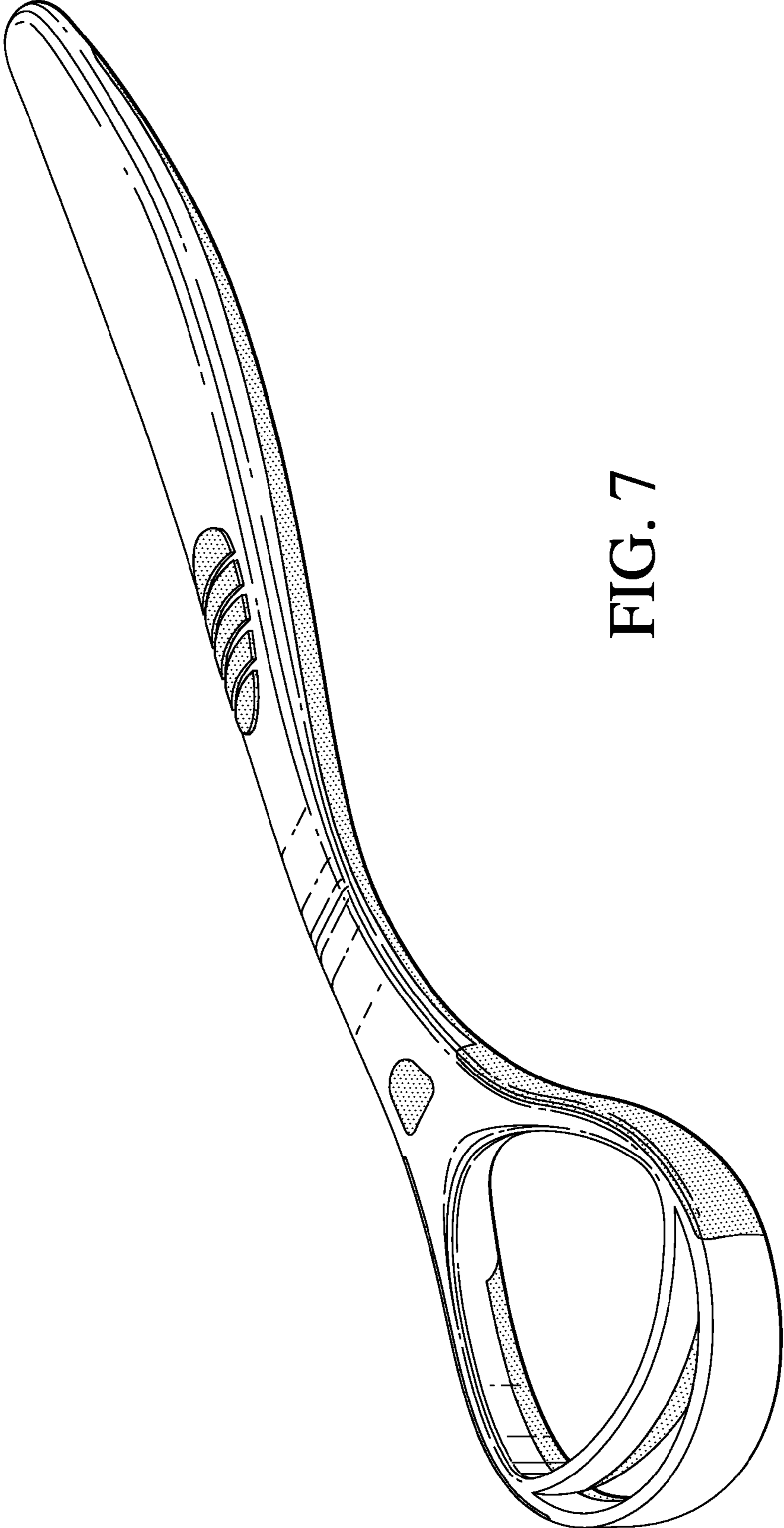

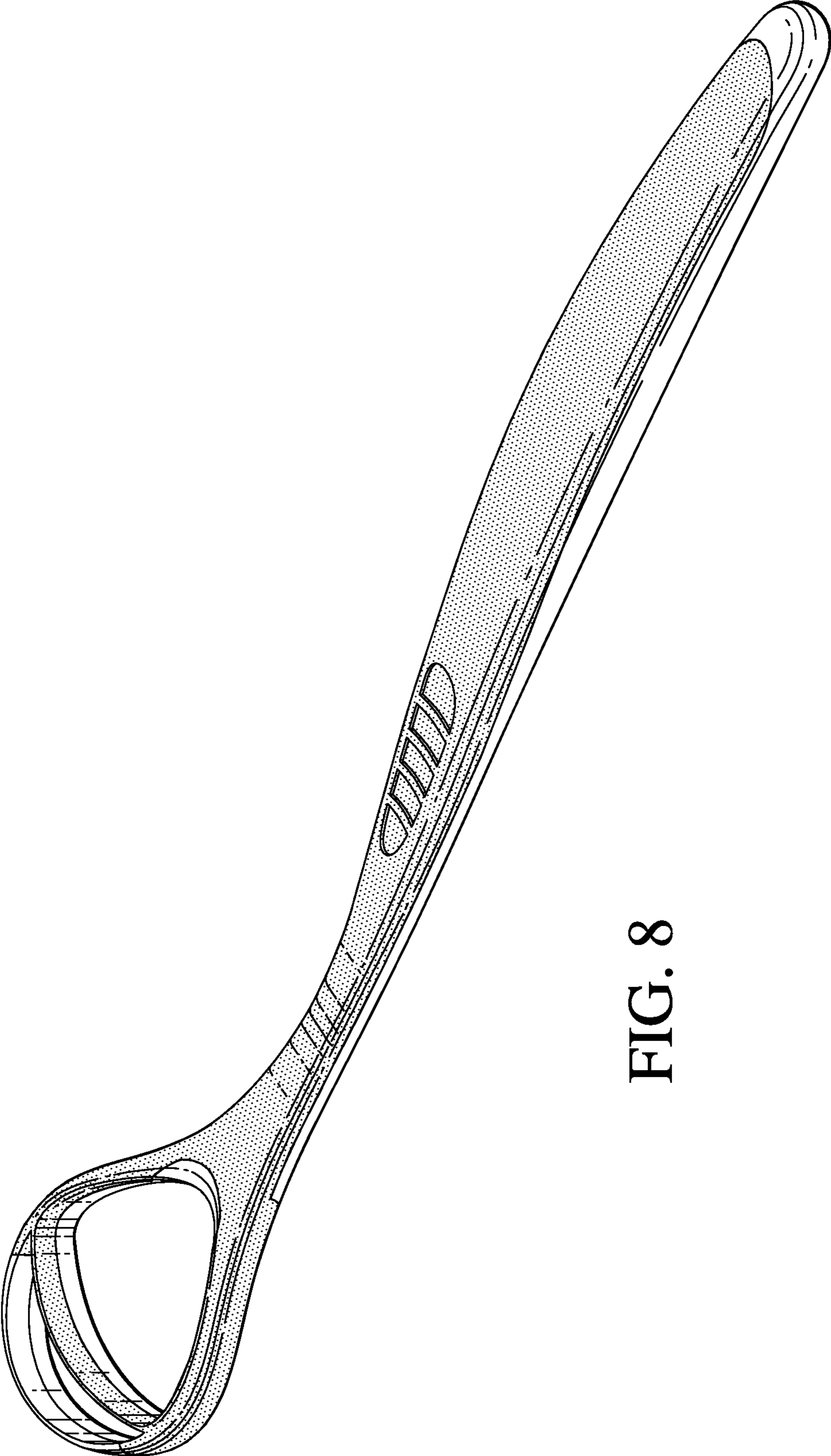

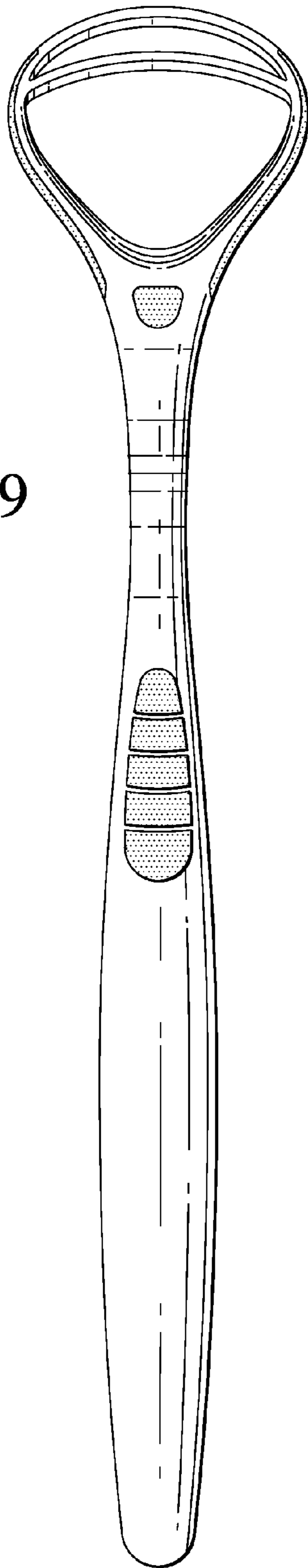

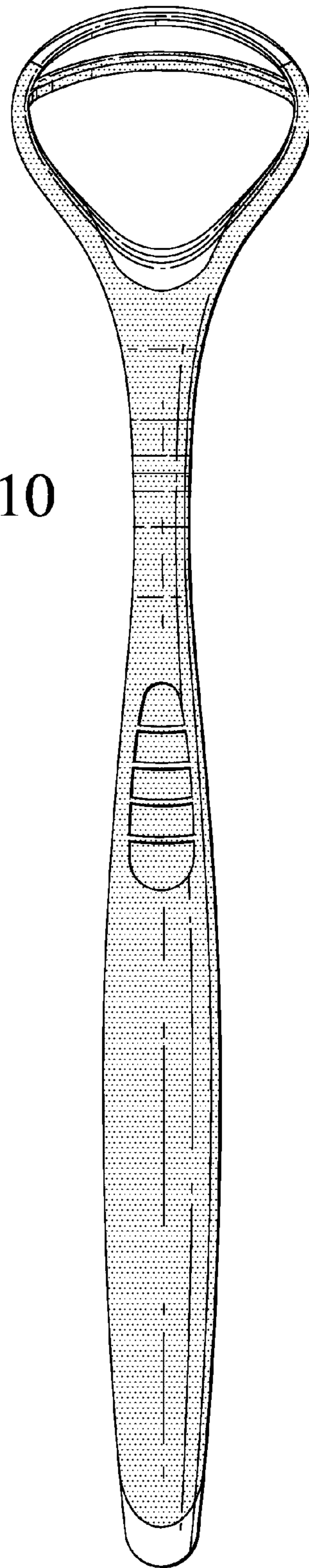

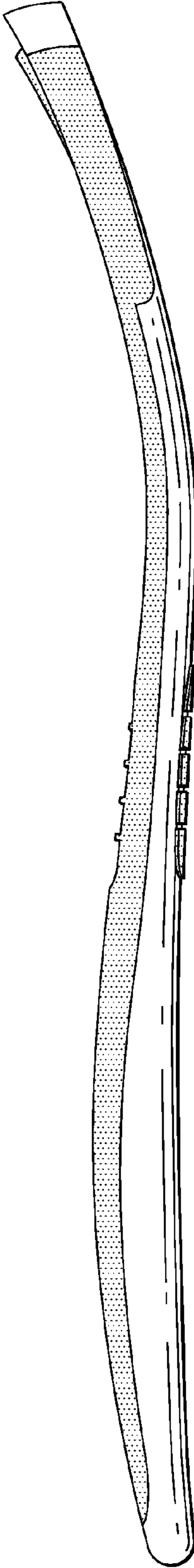

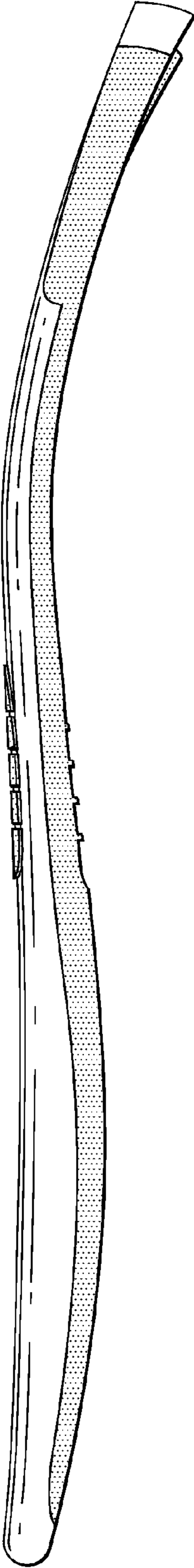
