What is claimed is the ornamental design for a handheld facial  
massage and microcurrent therapy device, as shown and  
described.

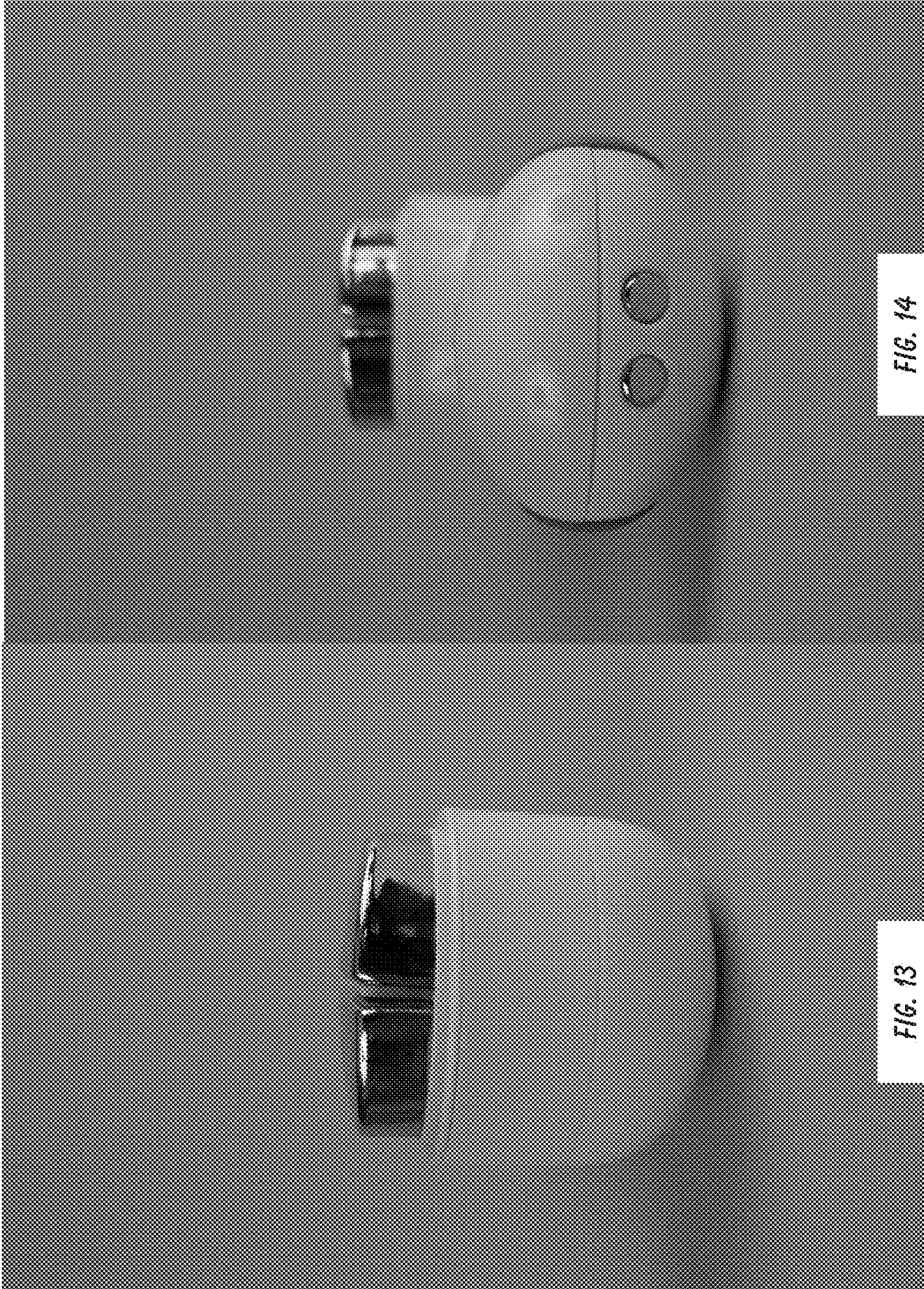
