DESCRIPTION

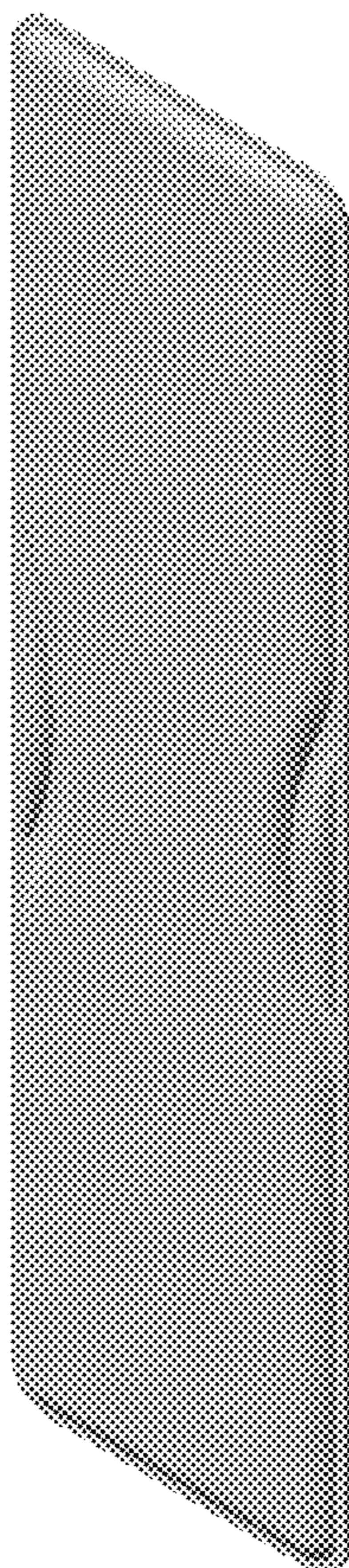
FIG. 1 is a front perspective view of a sound absorbing panel

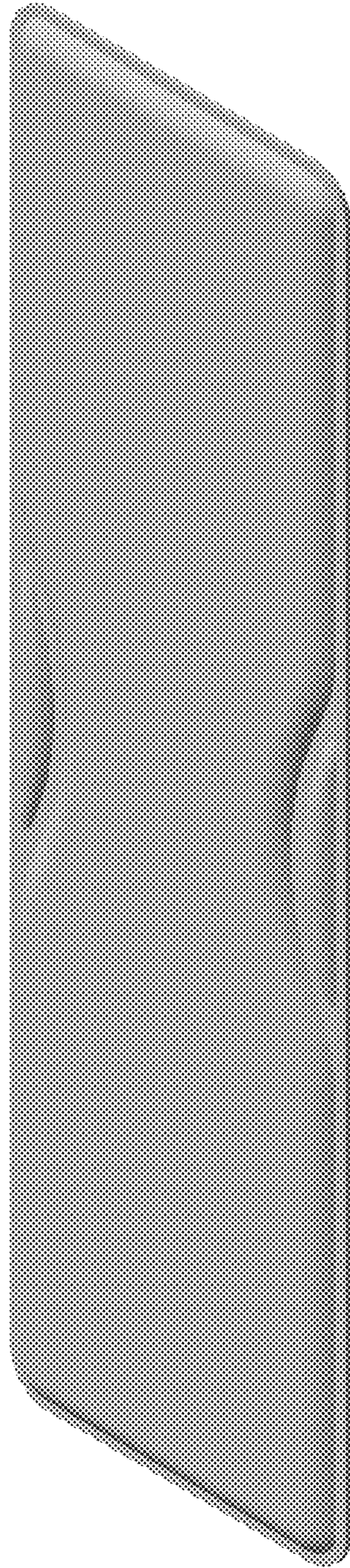

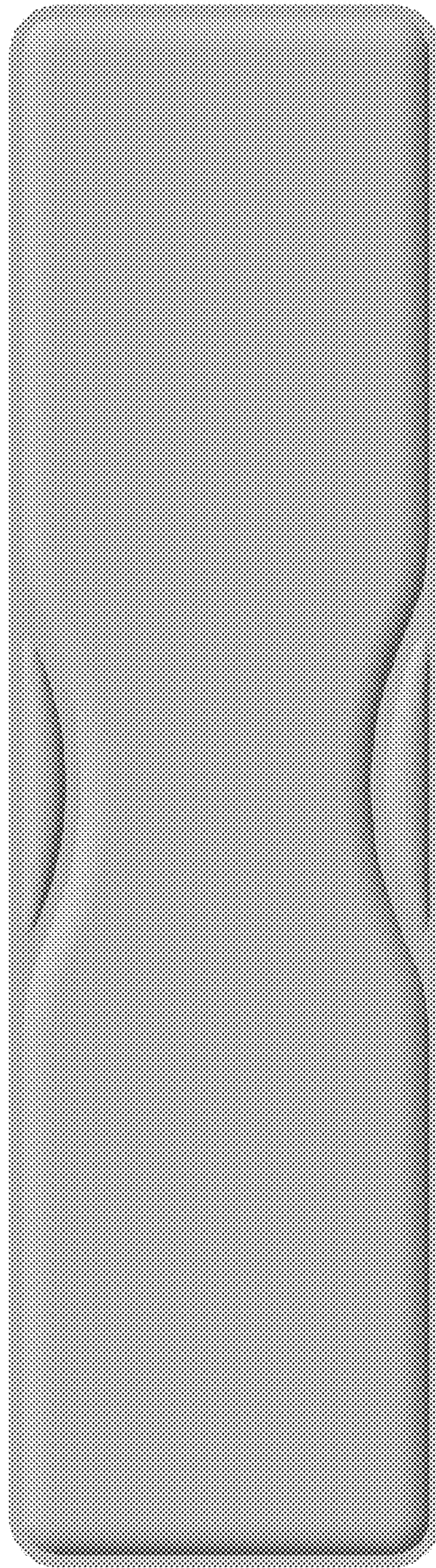
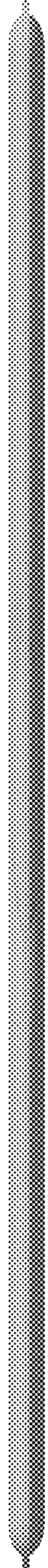

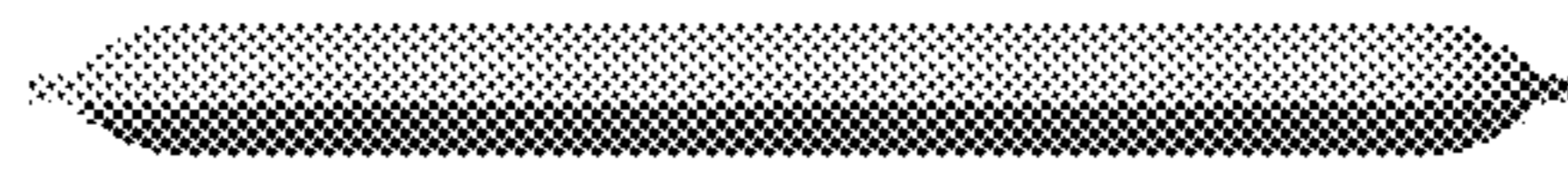
