FIG. 4 is a bottom view of the hair accessory for voluminous hair.

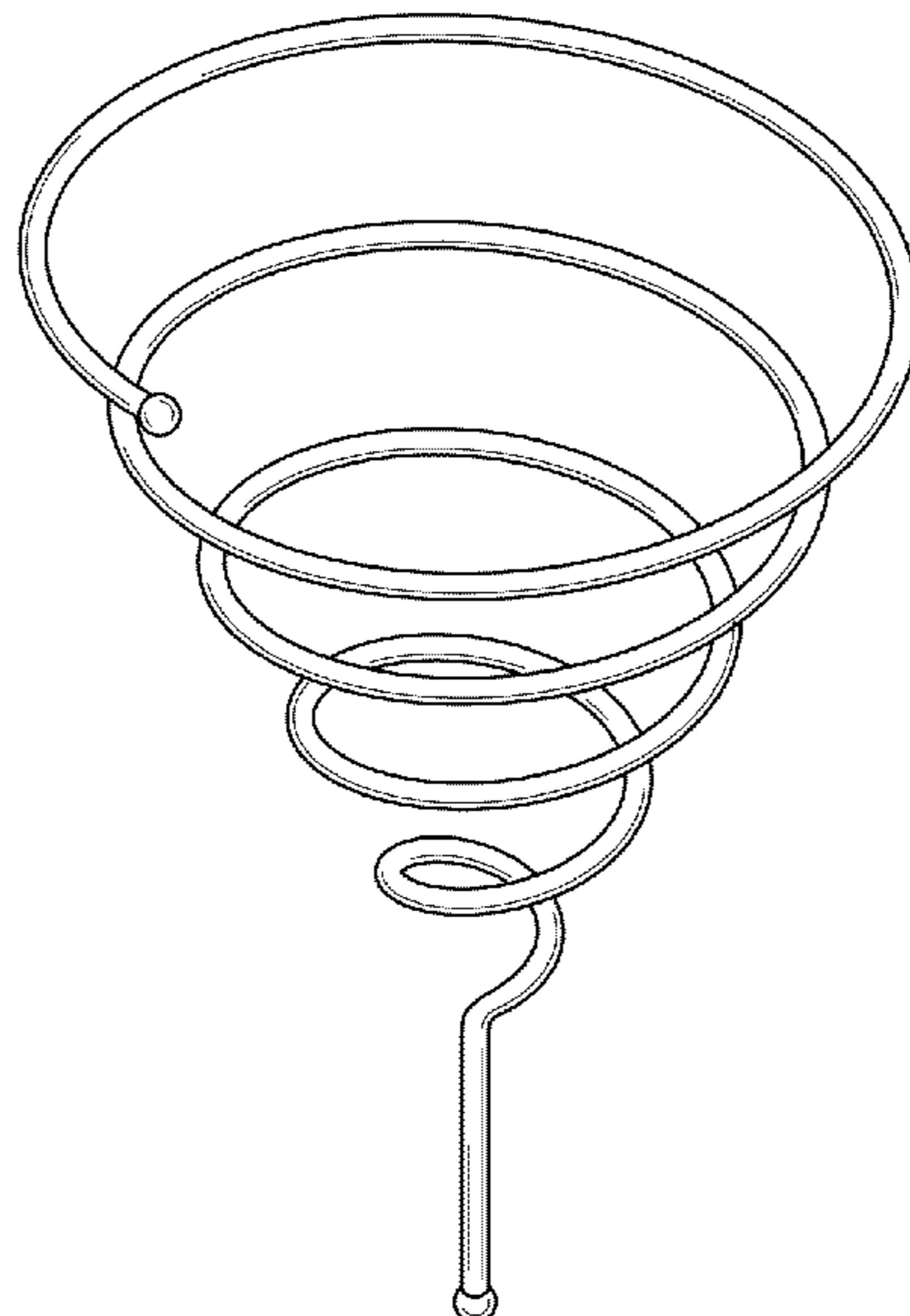
FIG. 5 is a front elevation view of the hair accessory for voluminous hair.

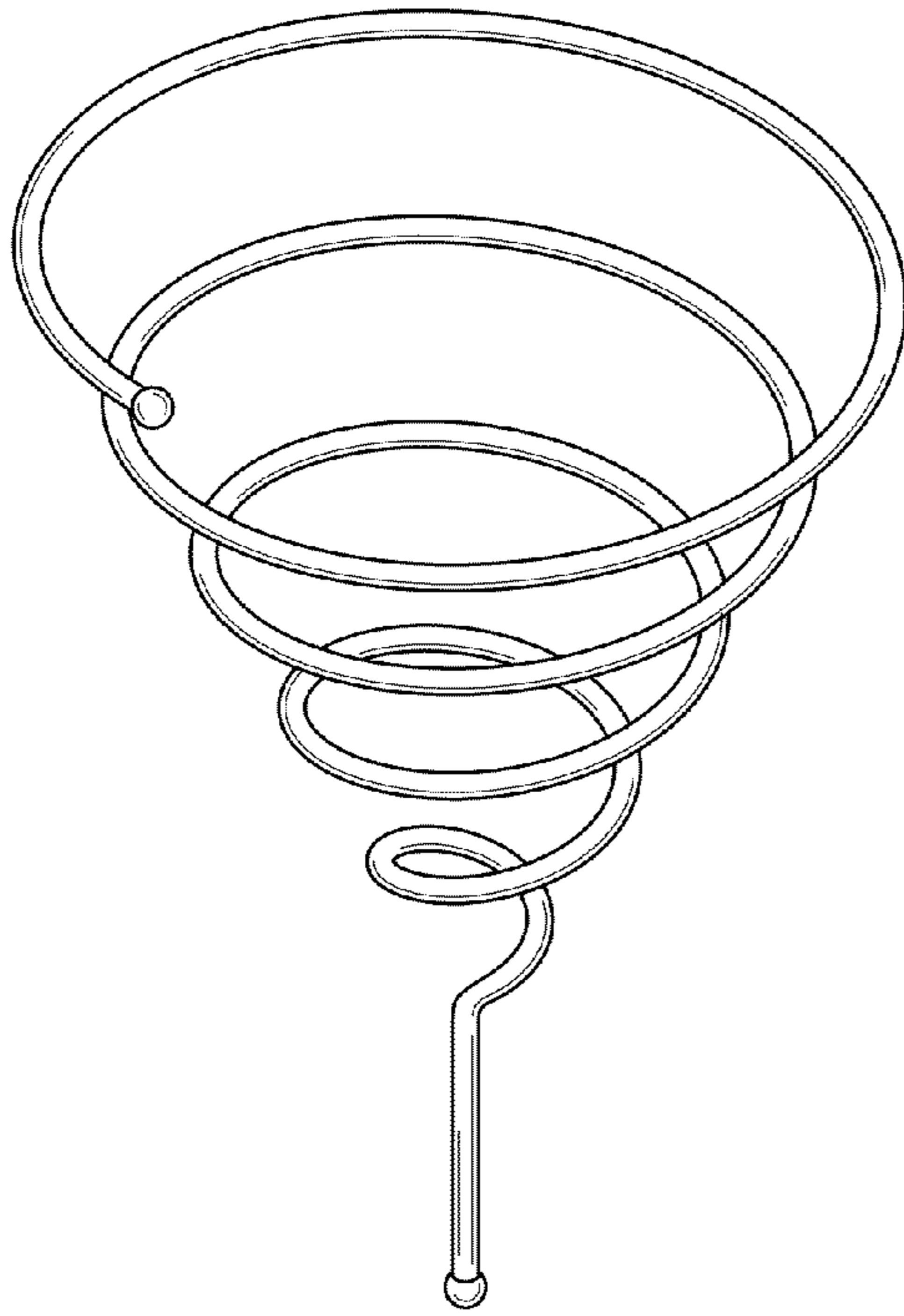

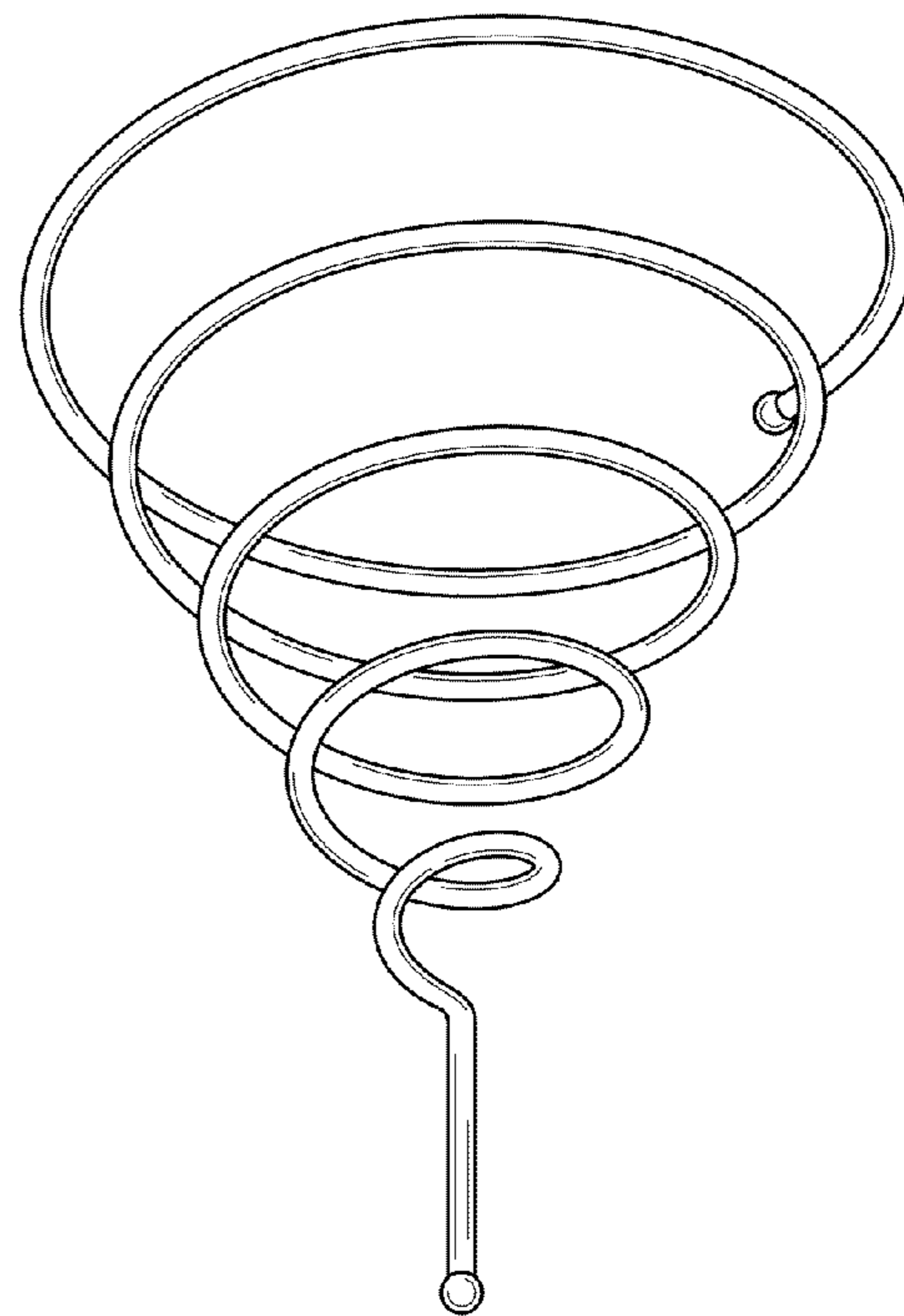

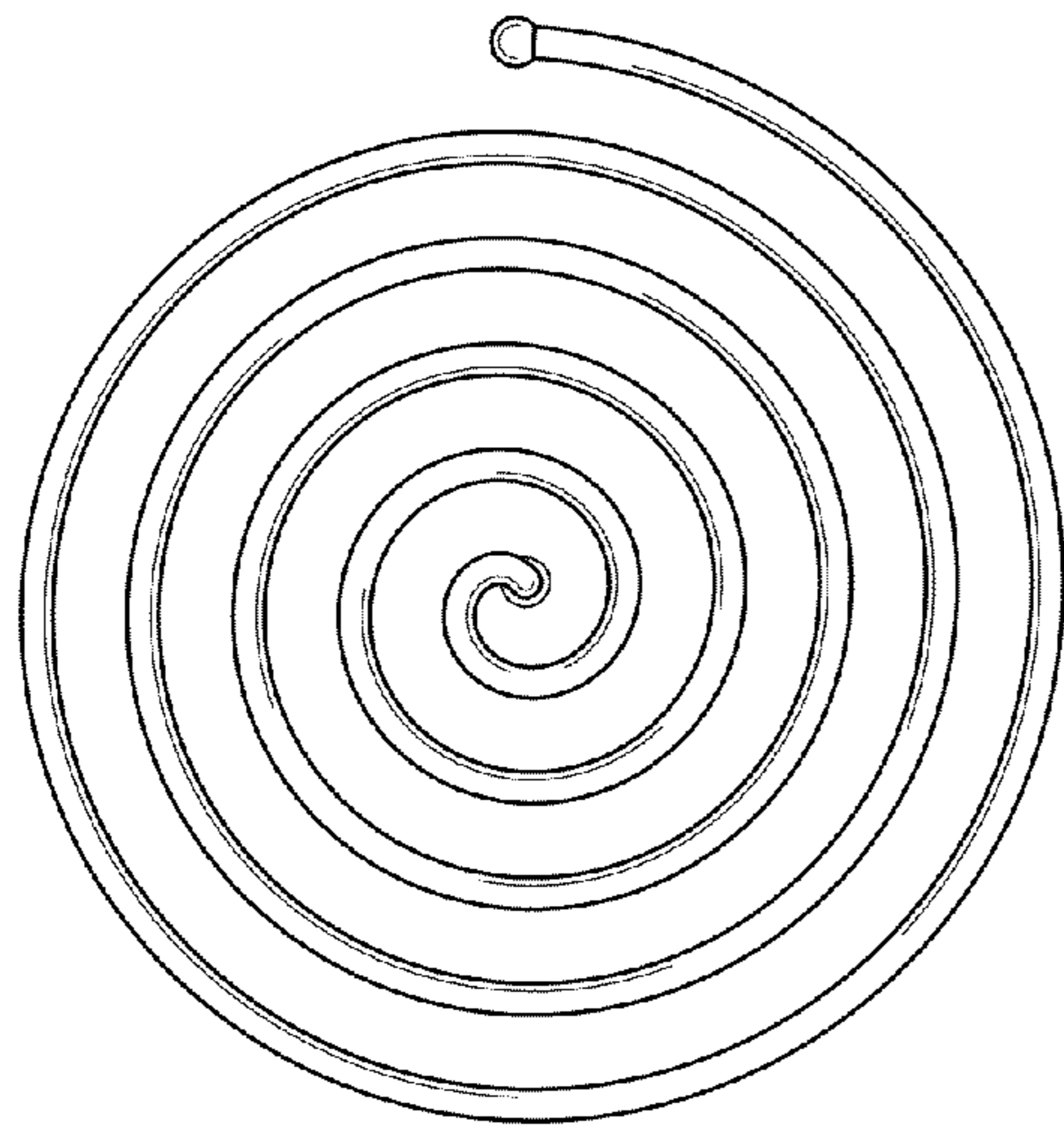

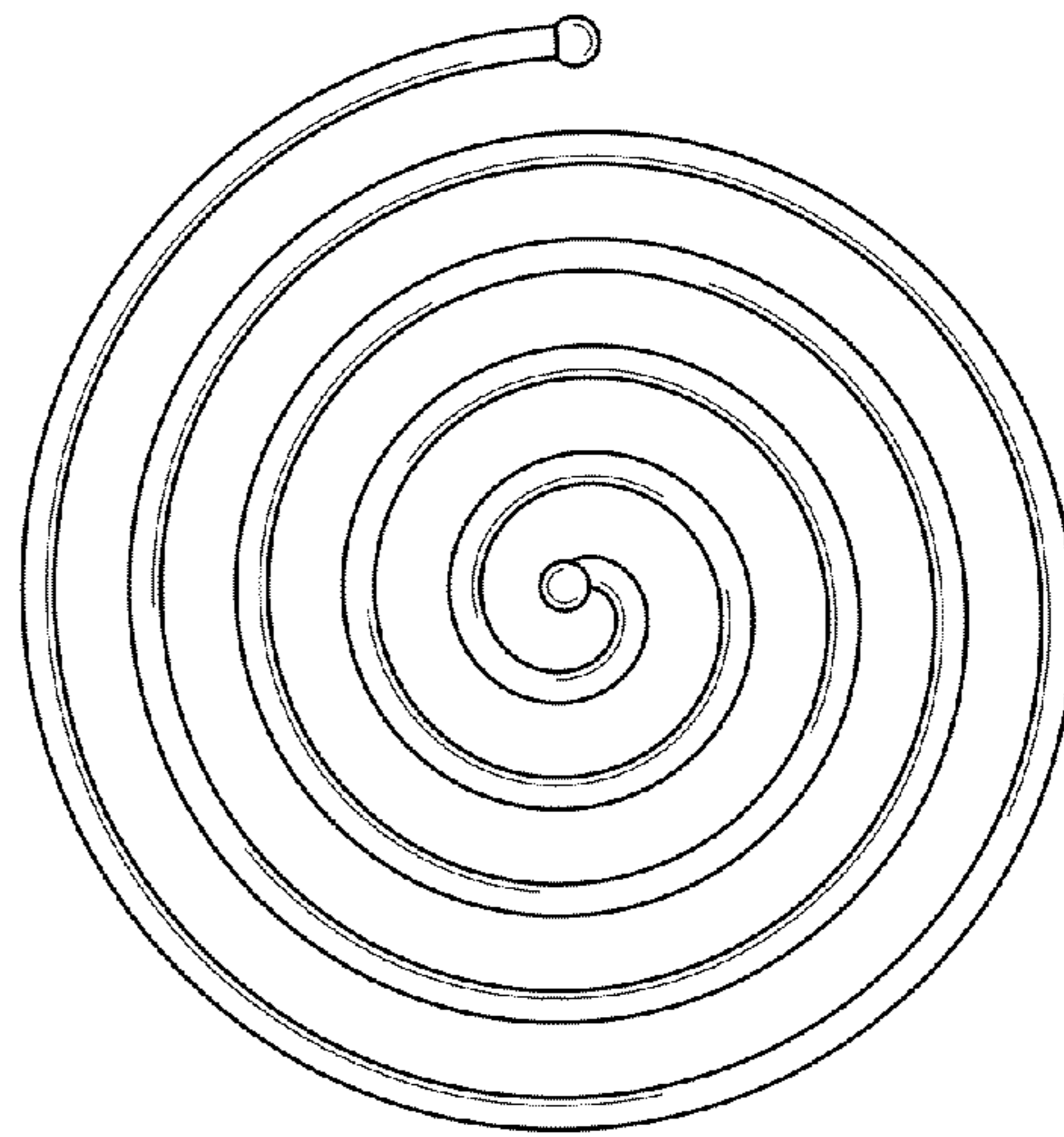

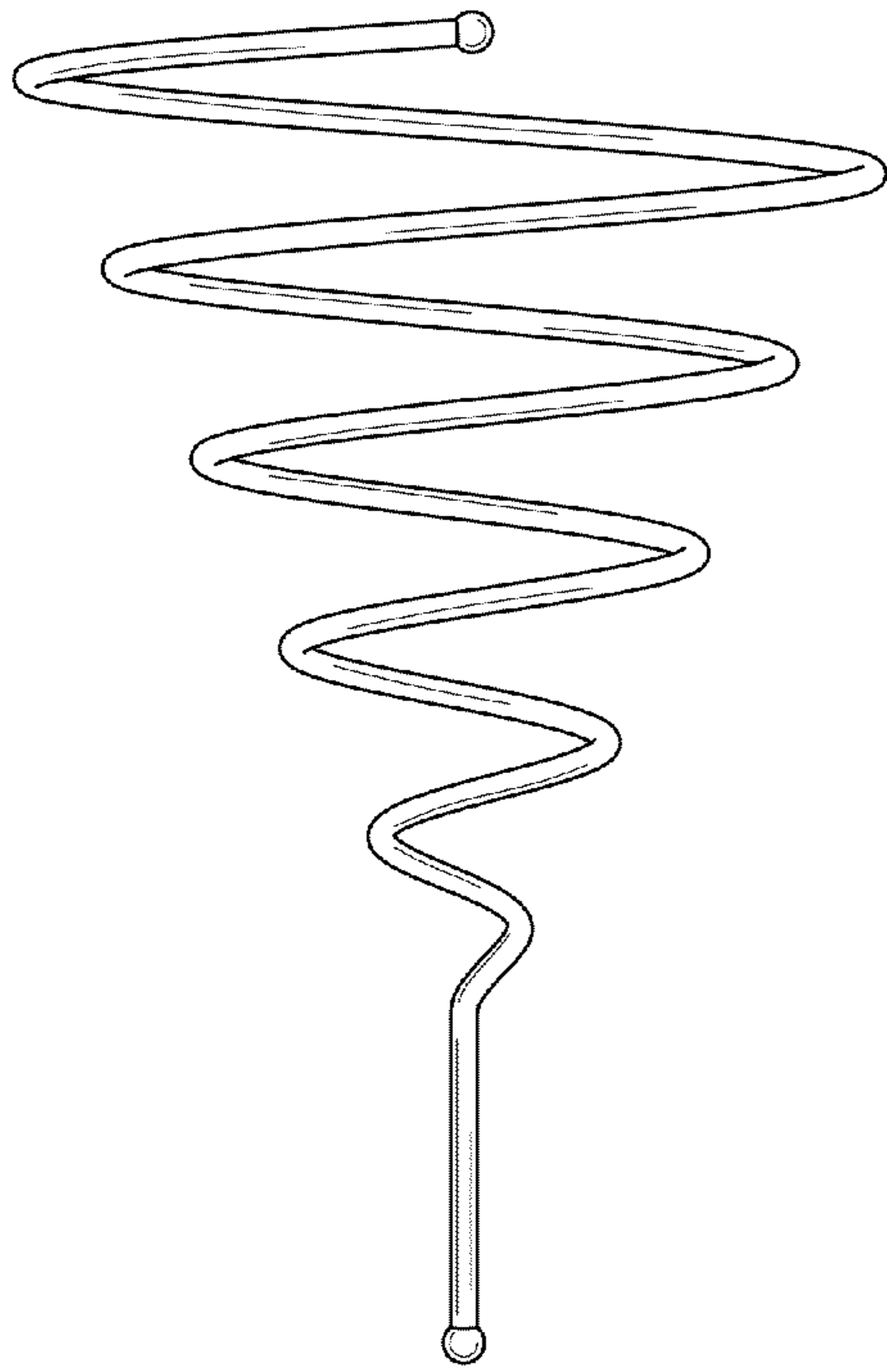

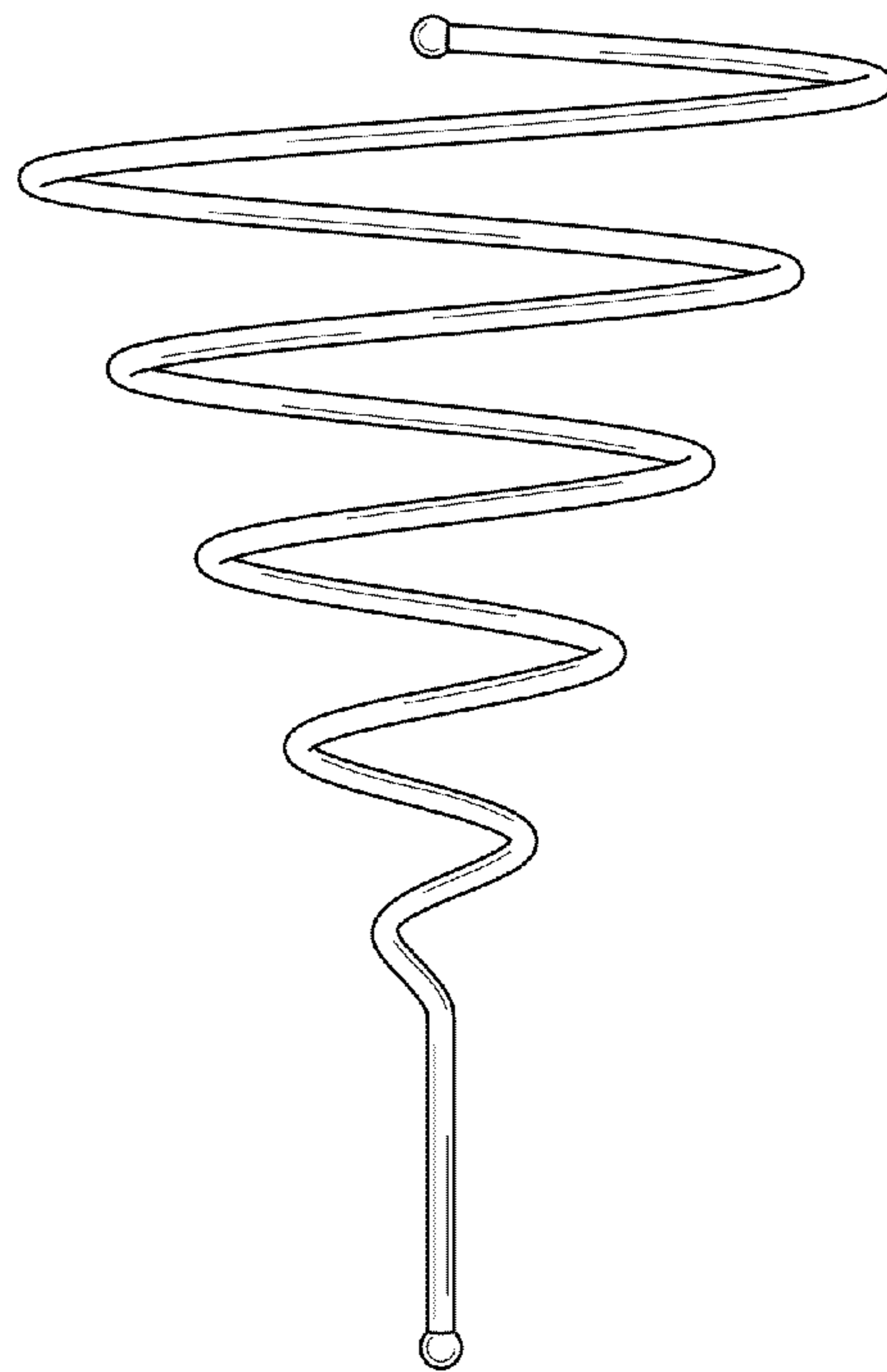

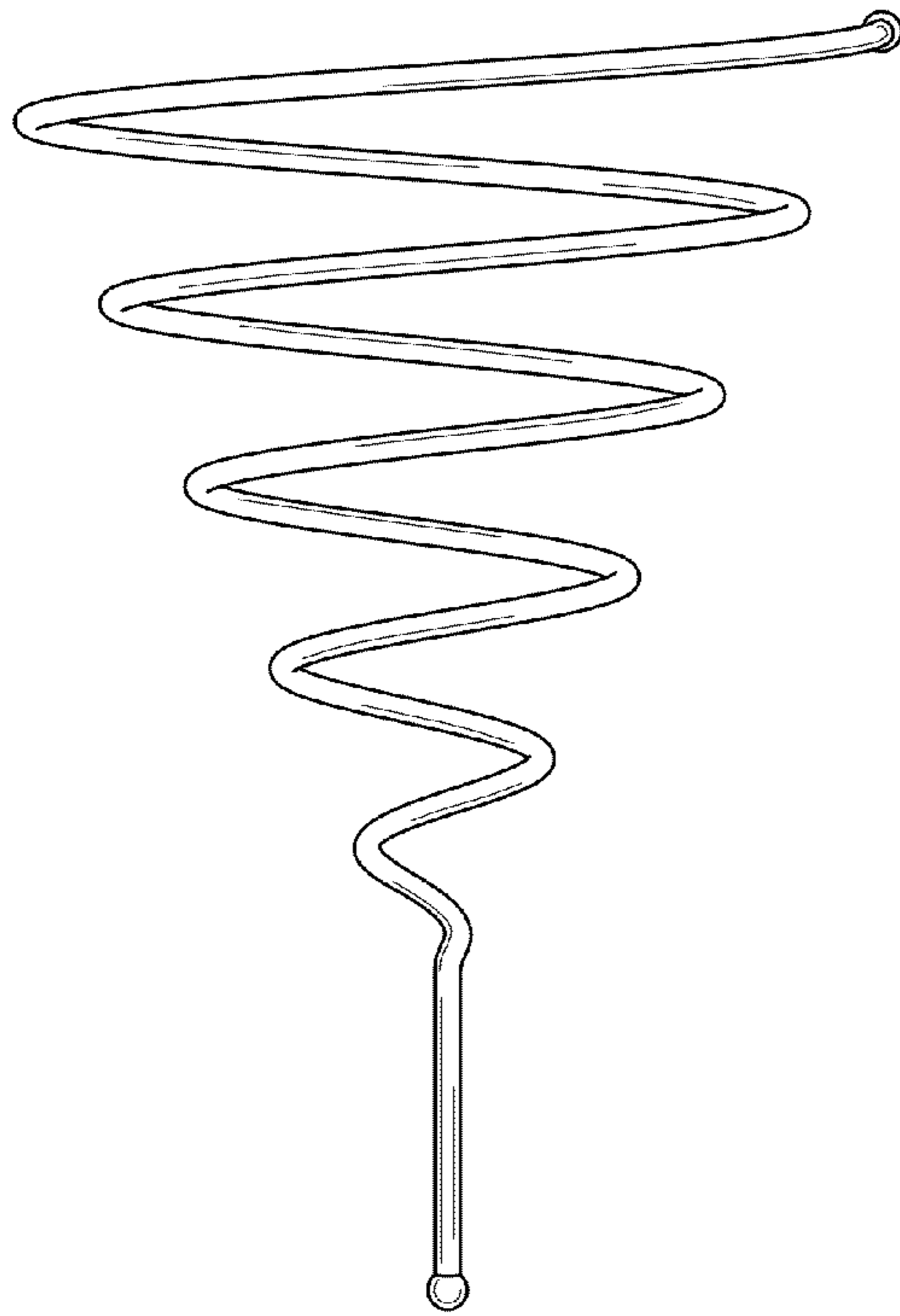

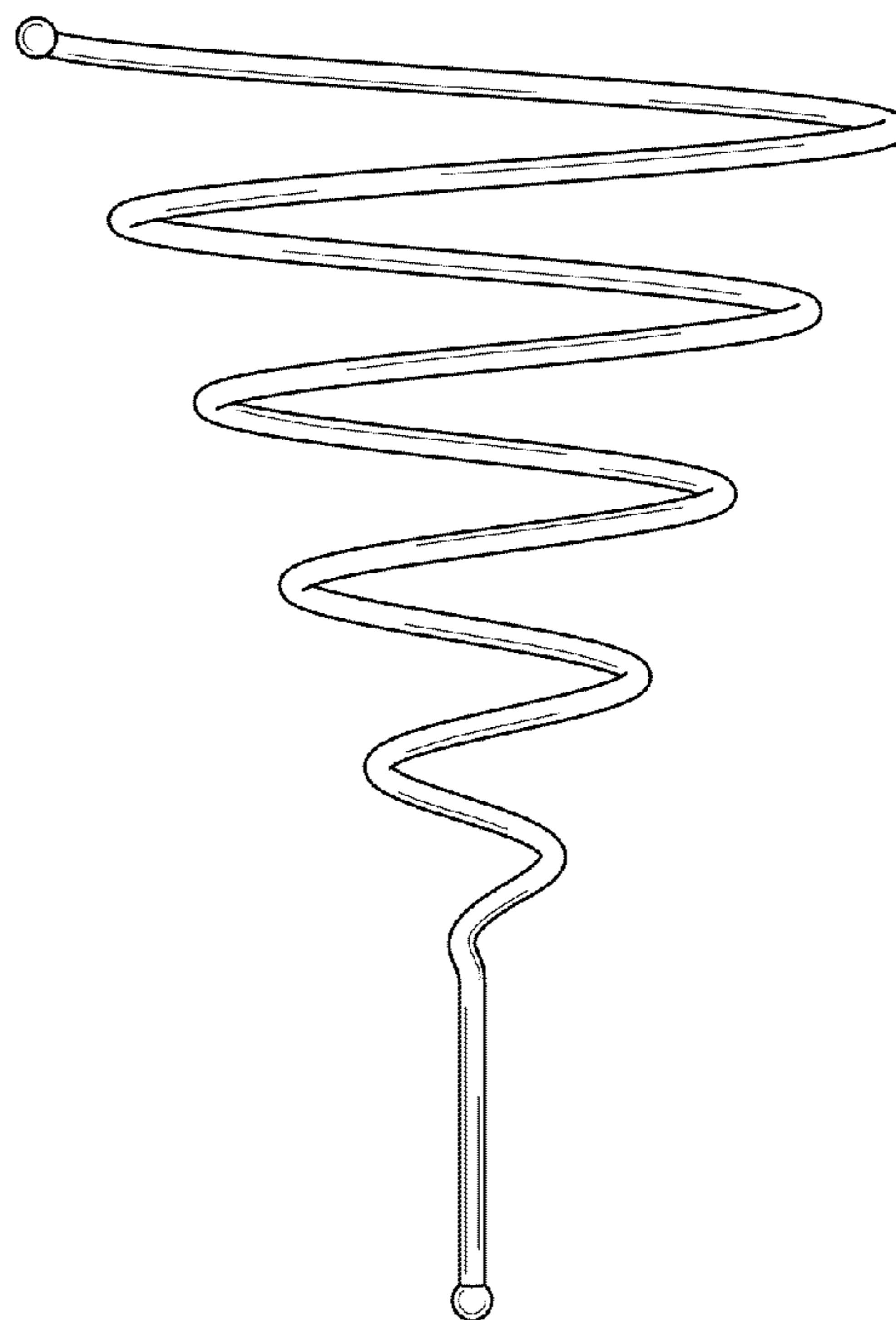
