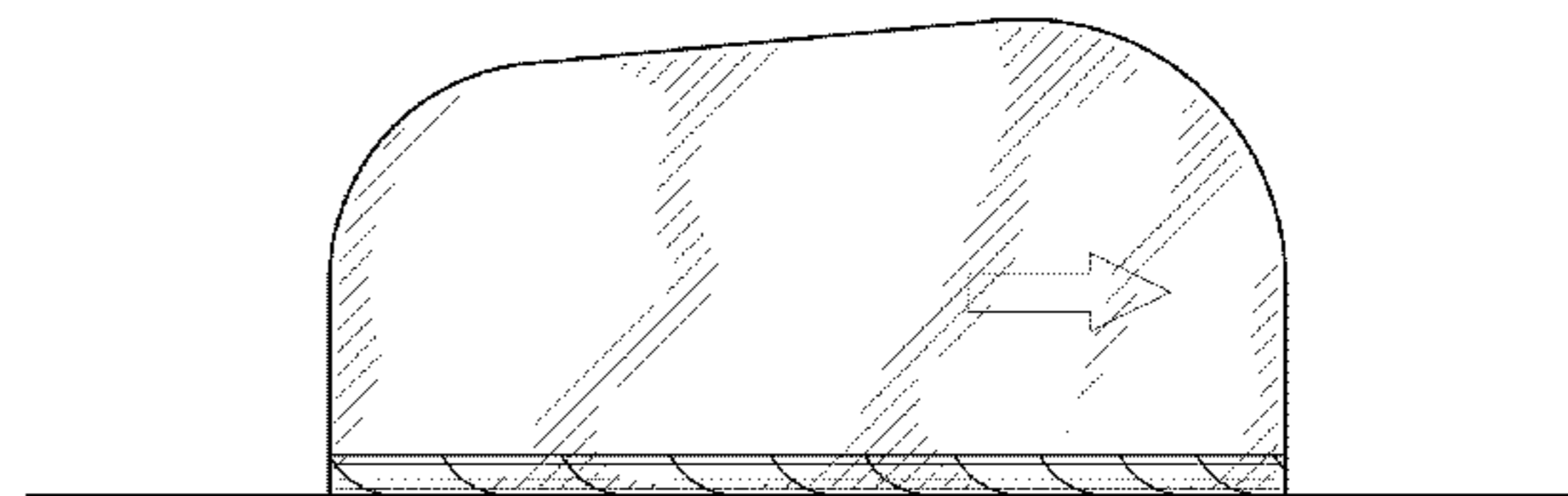
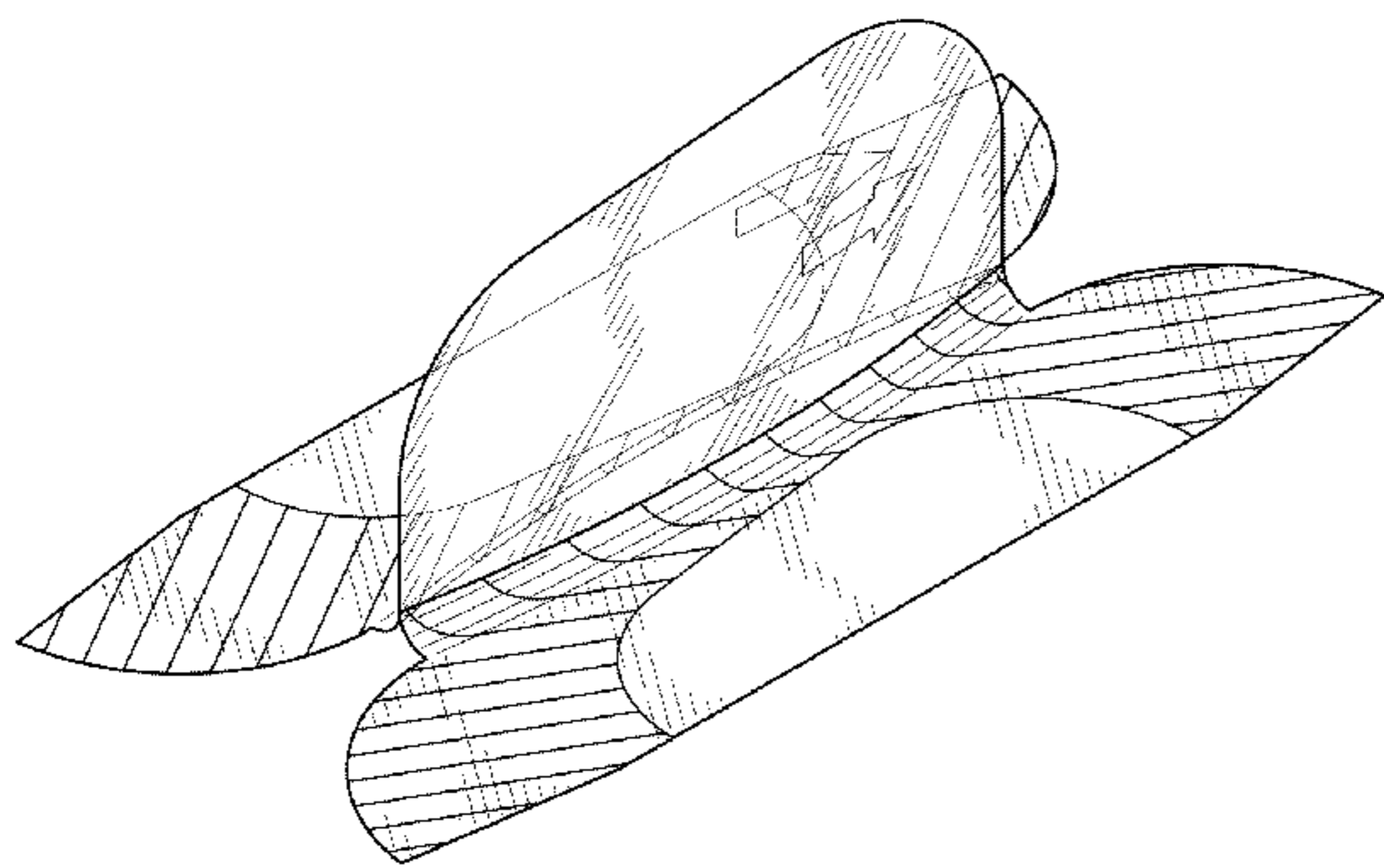
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an ear cover showing my new design;
FIG. 2 is a first side view thereof;
FIG. 3 is a second side view thereof;

FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,

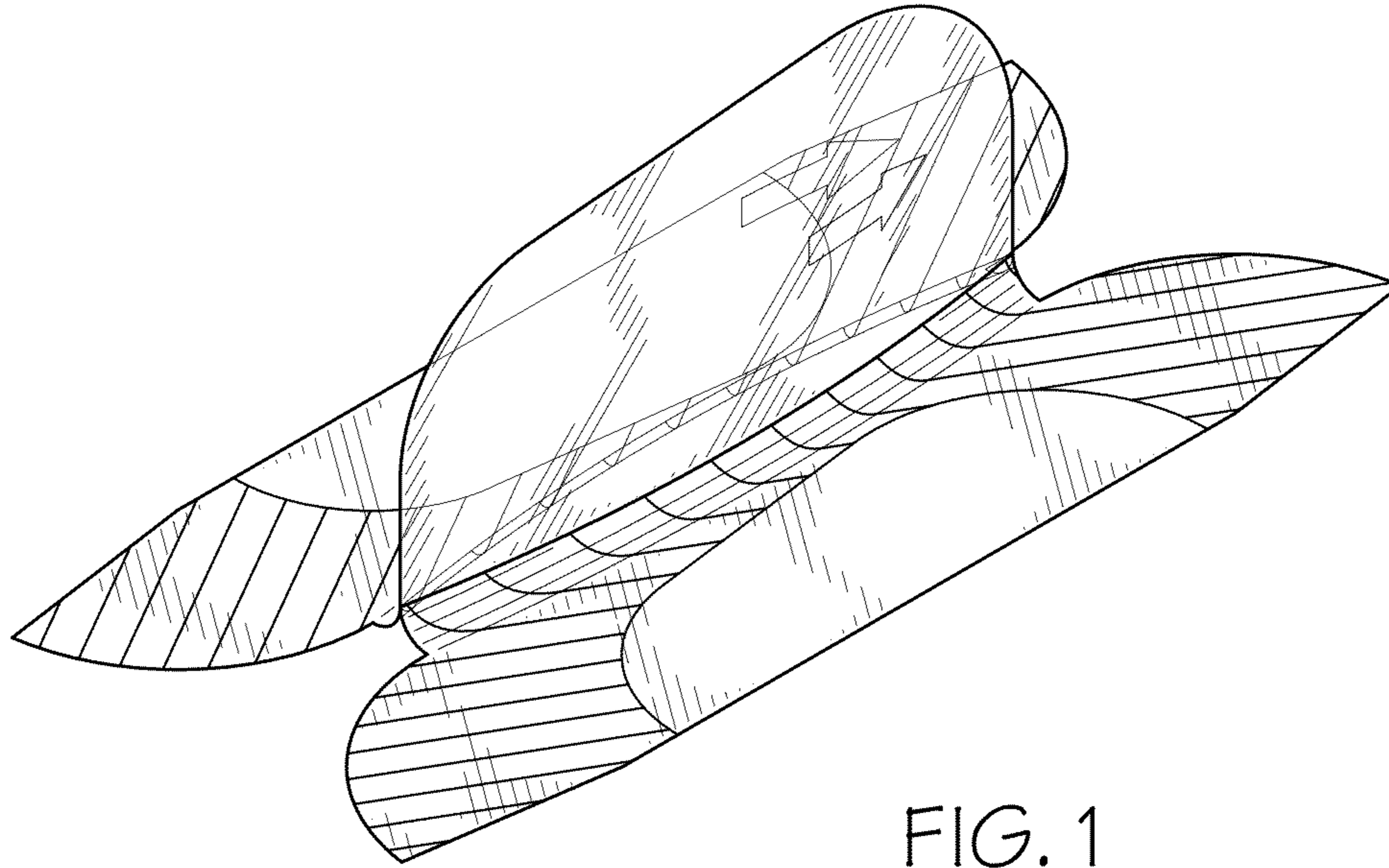

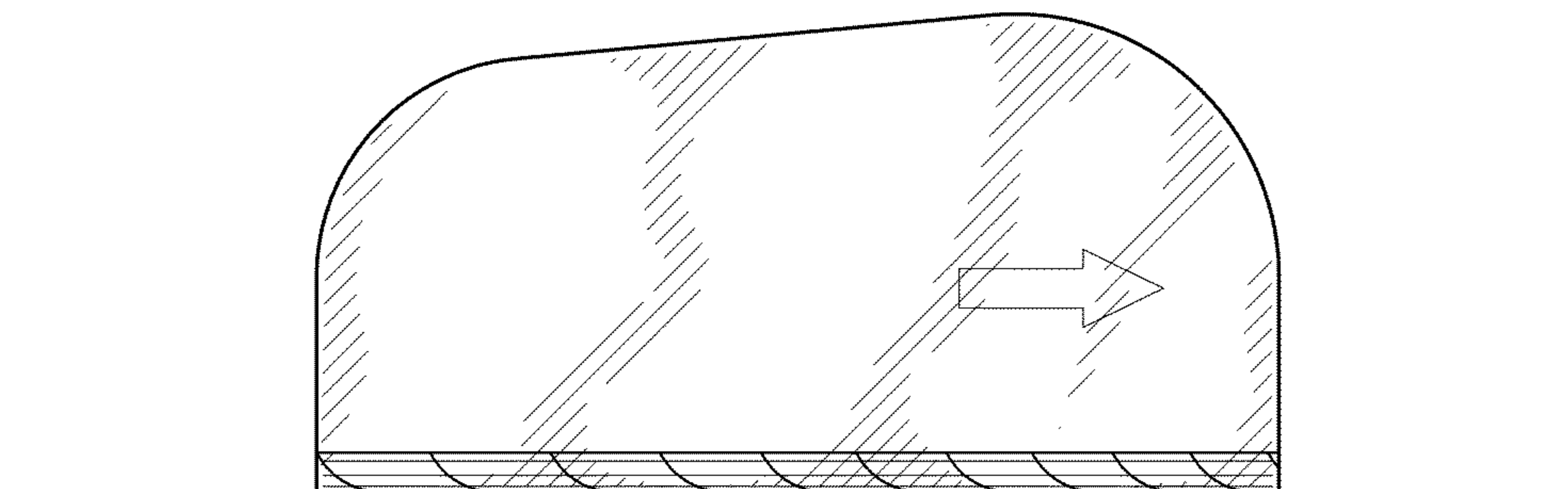

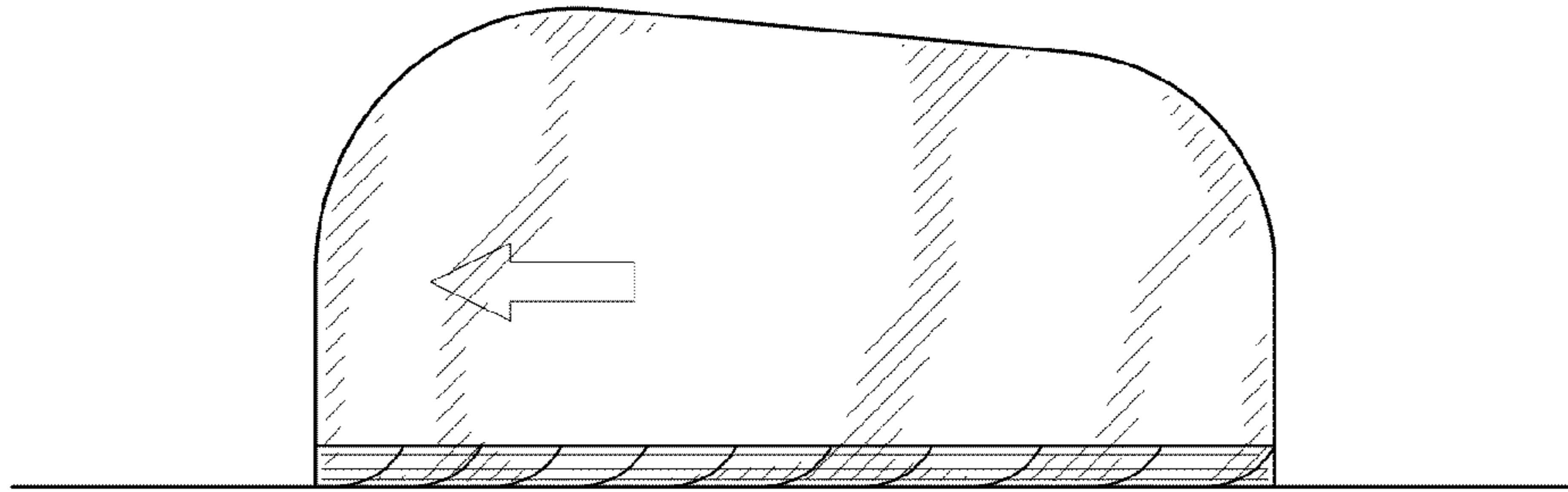

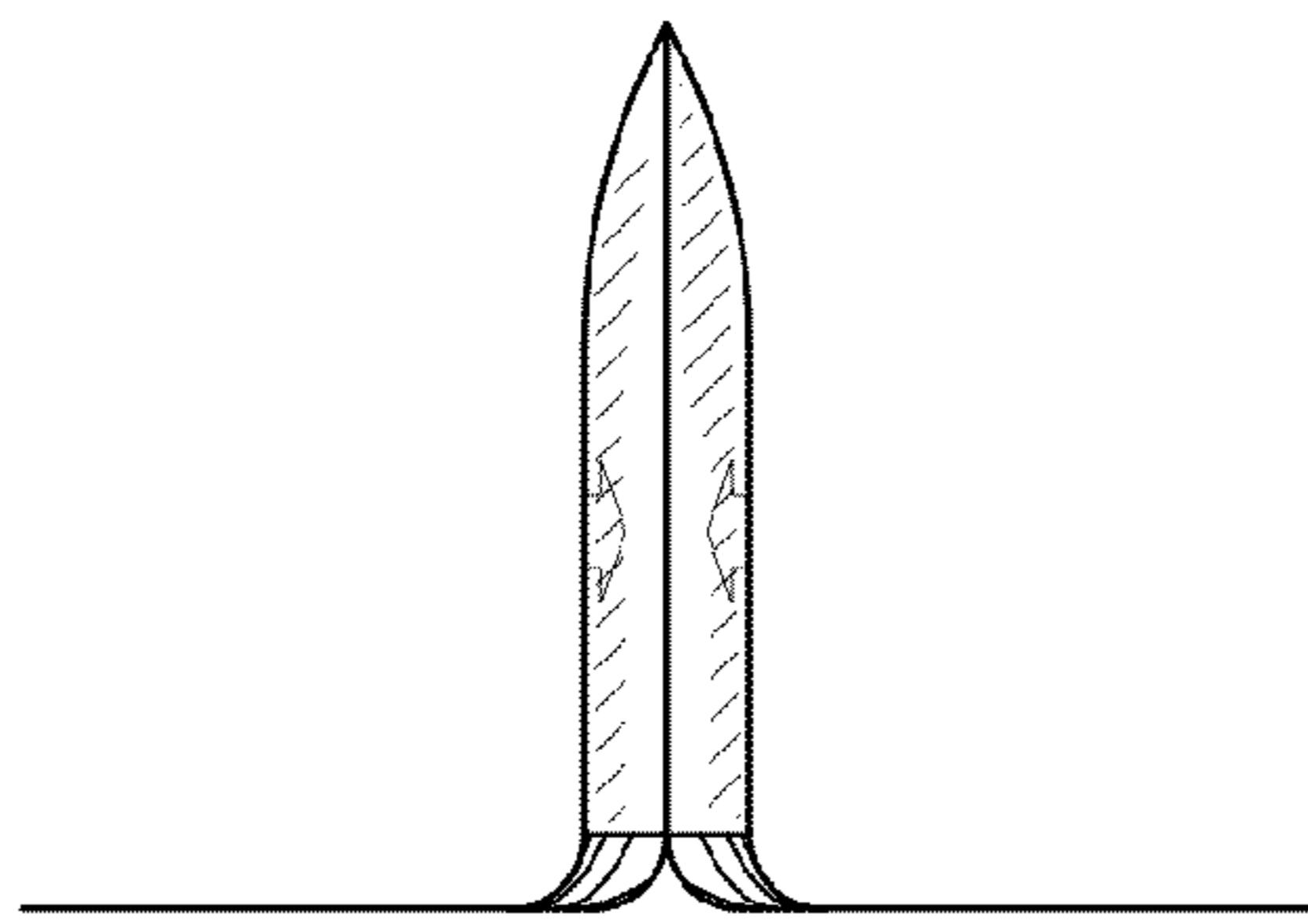

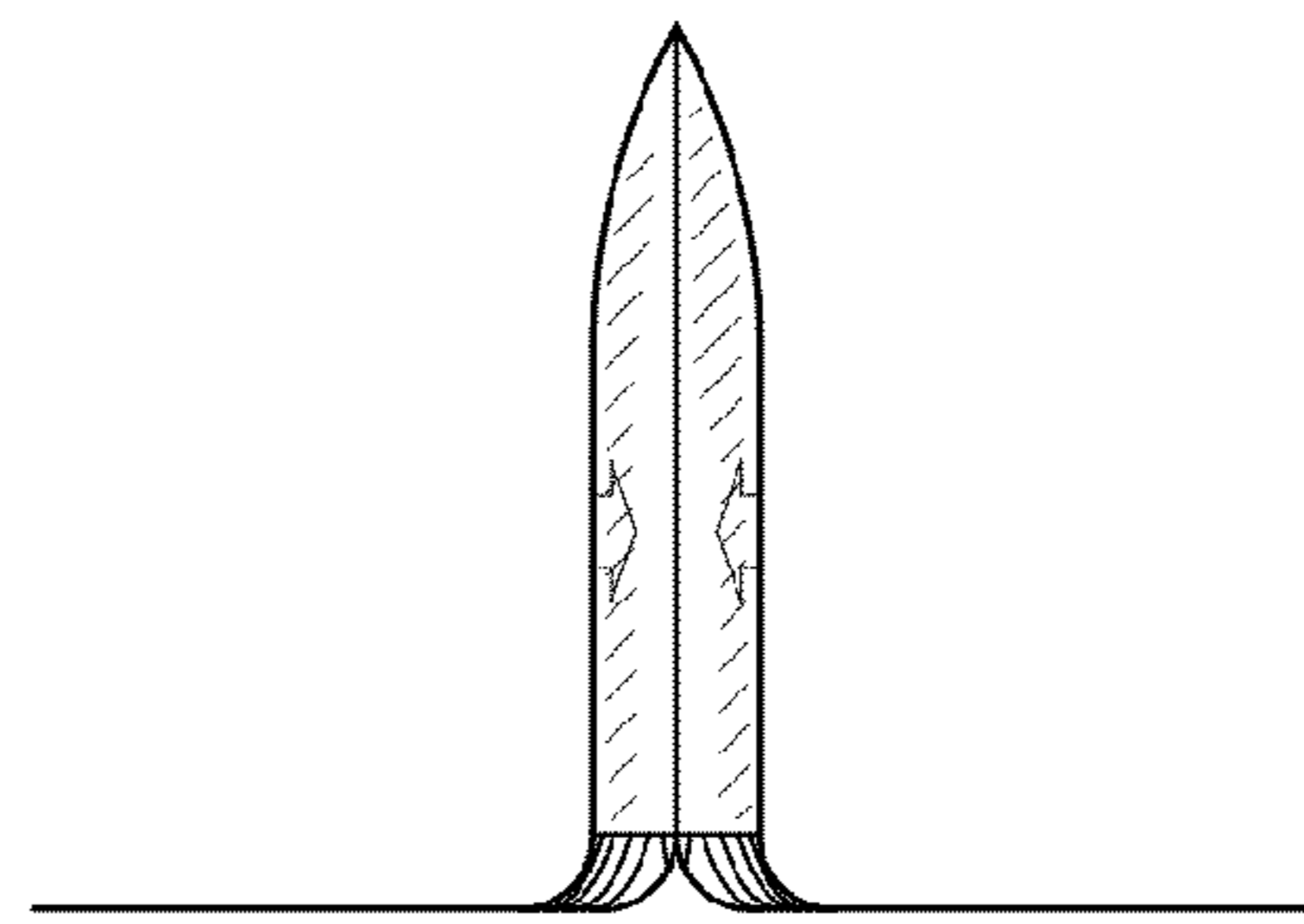

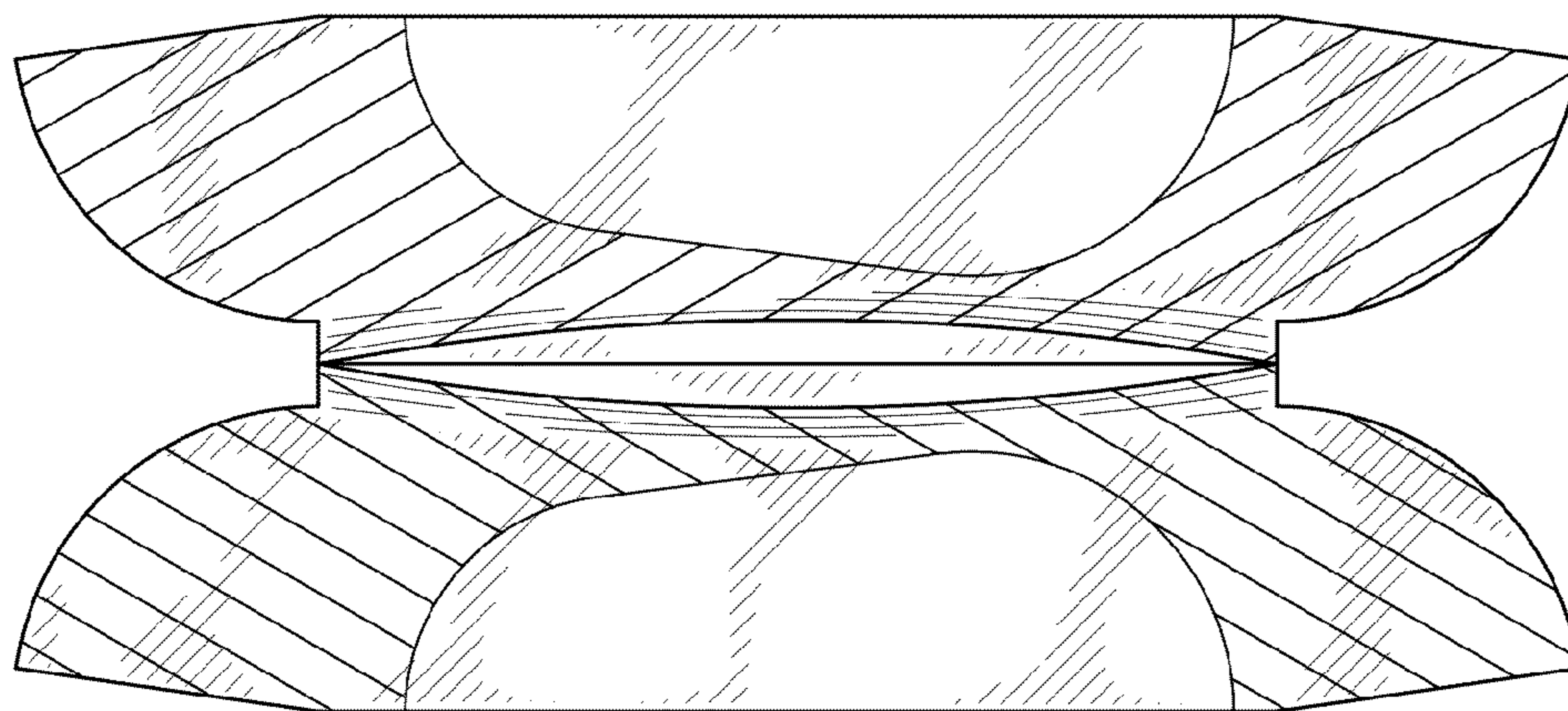

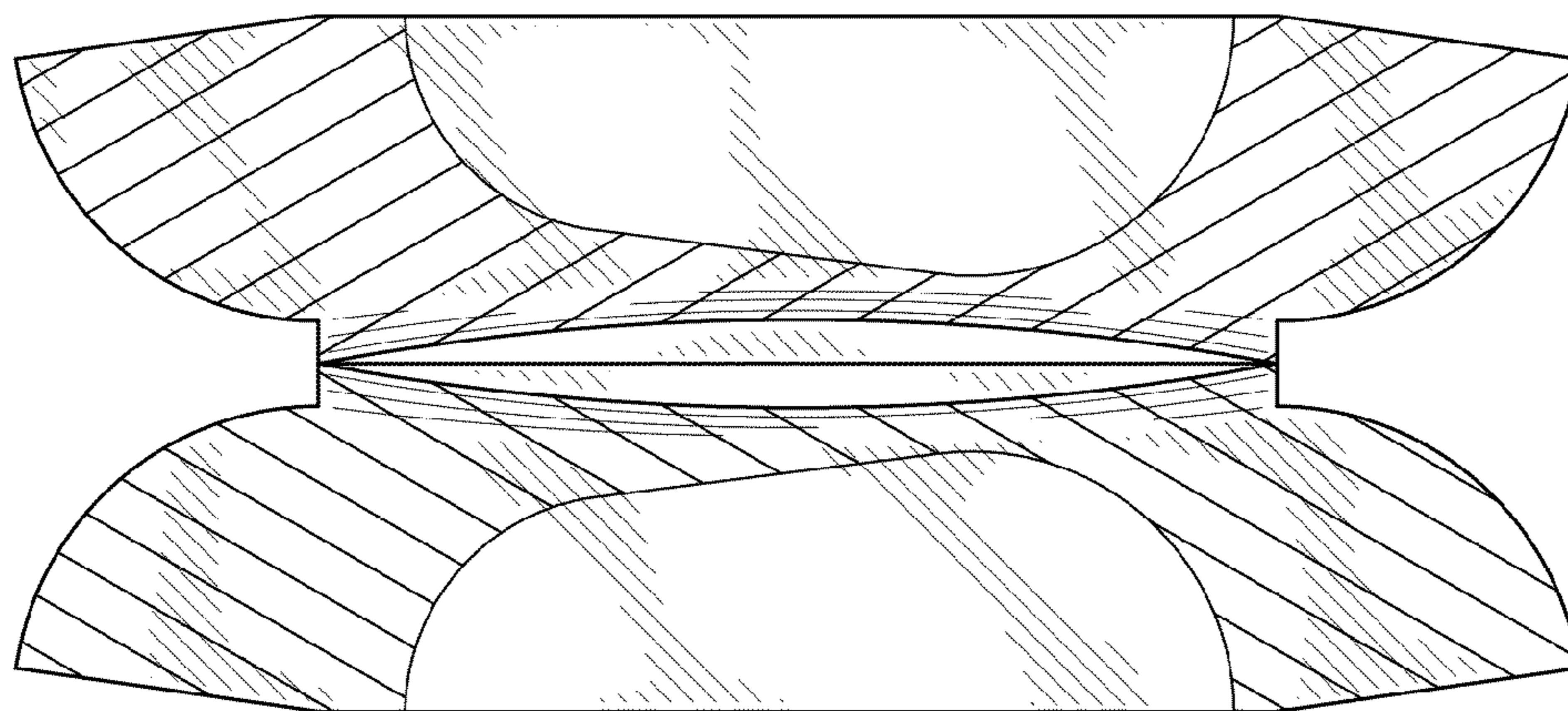
