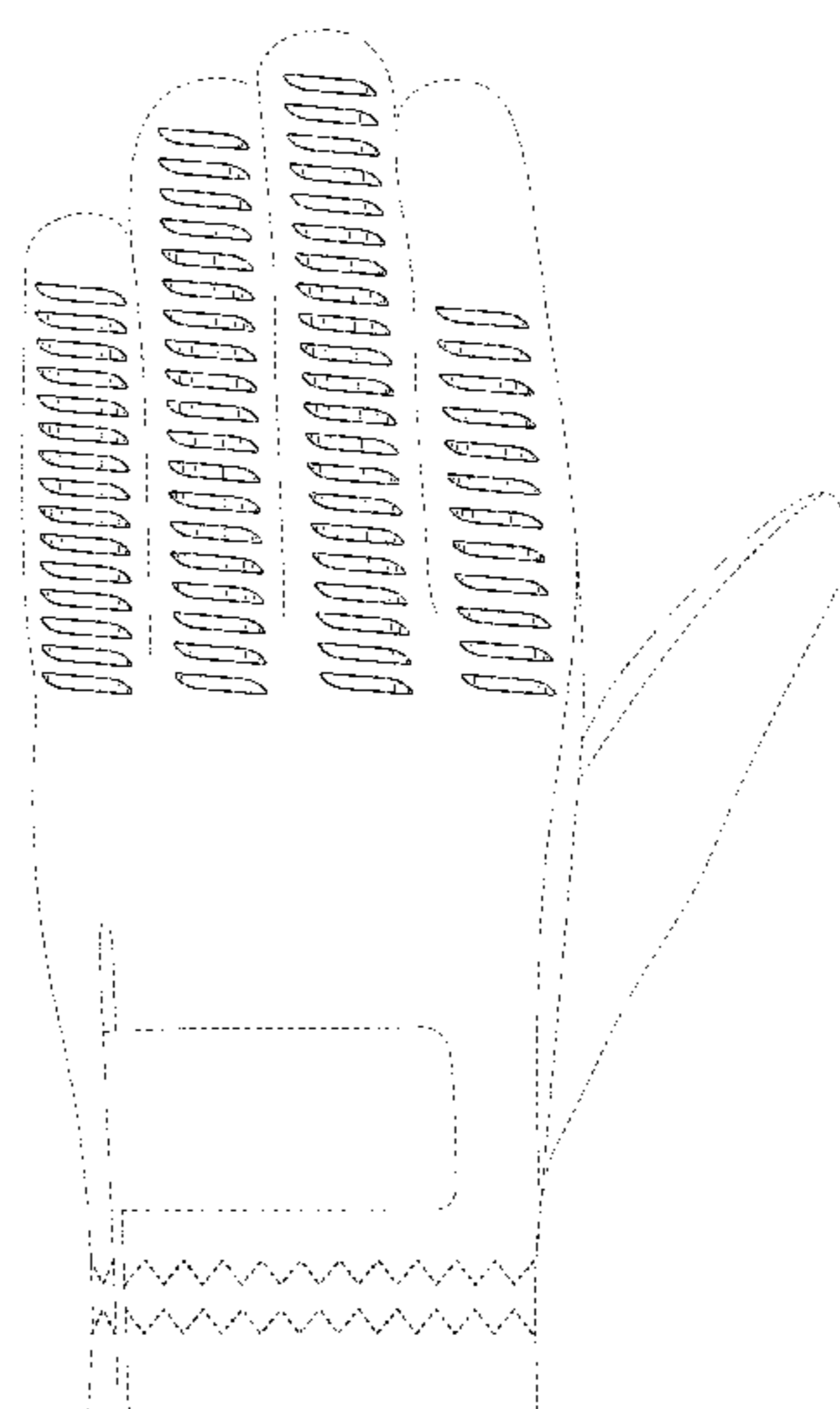
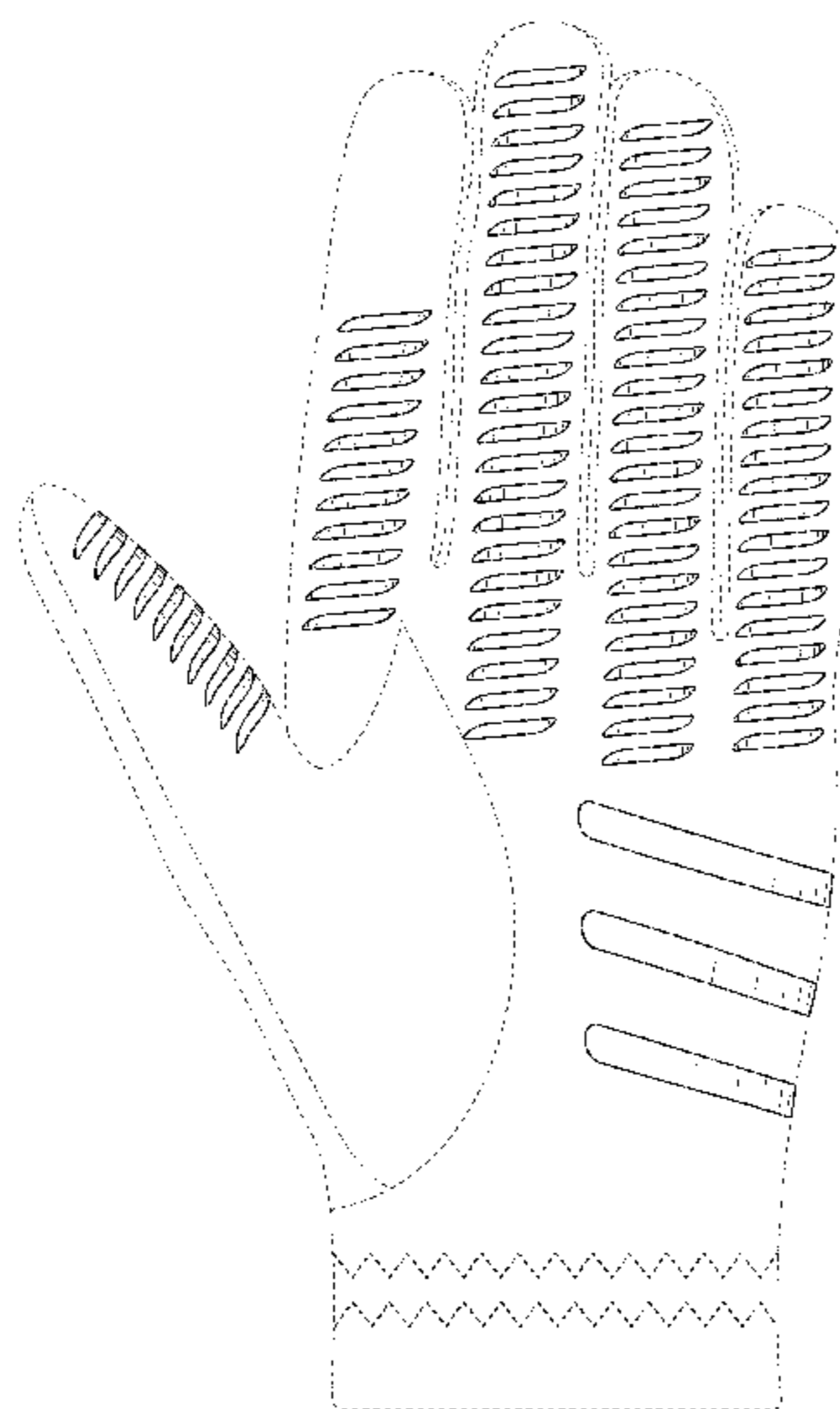
(57) **CLAIM**

The ornamental design for a pair of gloves for a handgun shooter, as shown and described.

DESCRIPTION

FIG. 1 is a palm, left-hand perspective view of an embodiment for a pair of gloves for handgun shooters; FIG. 2 is a palm elevational view thereof; FIG. 3 is a back elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The unshown right-hand glove embodiment is a mirror-image of the left-hand glove embodiment. The broken lines illustrating a glove depict those features of the article of manufacture that form no part of the claimed design.

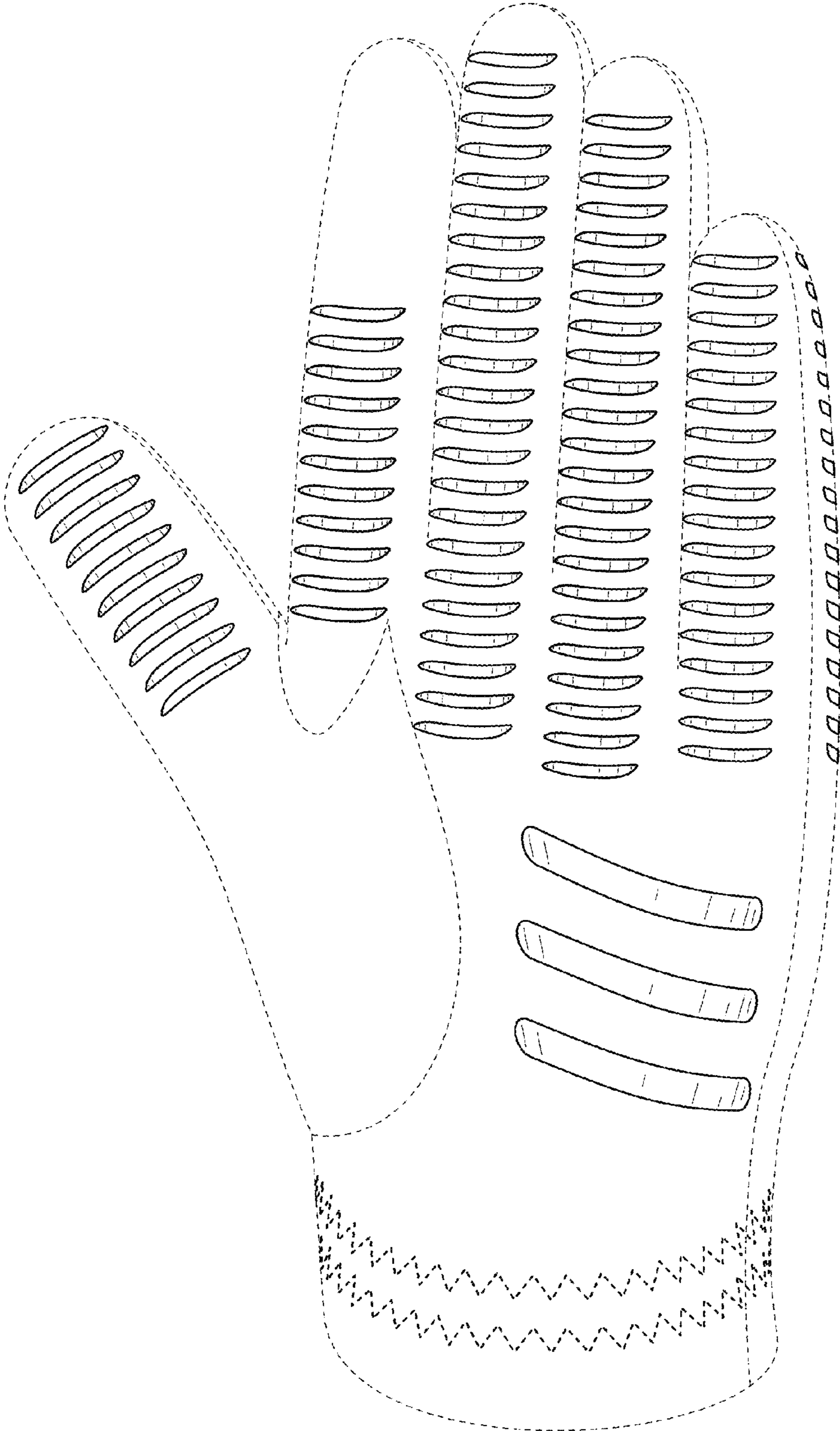

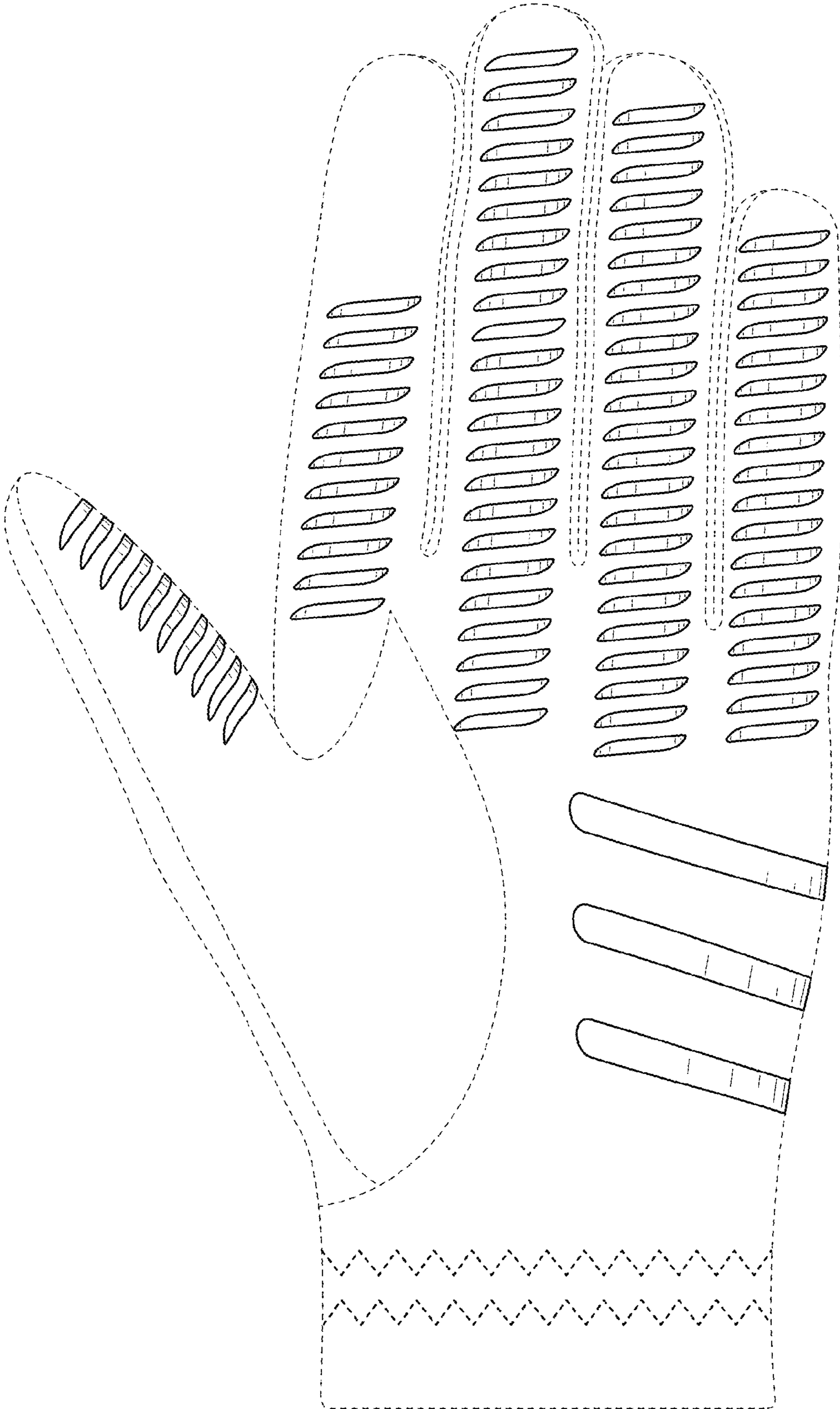

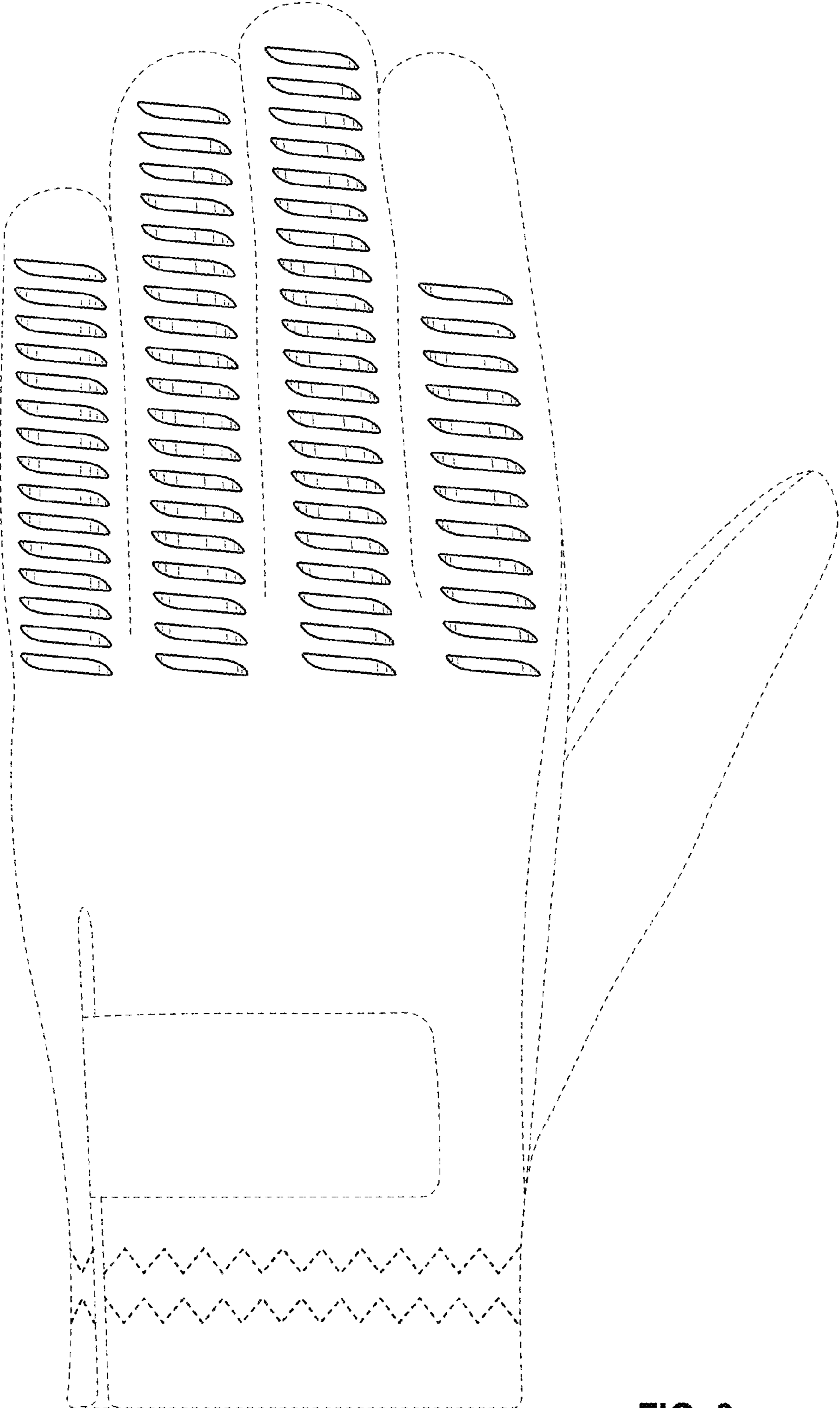

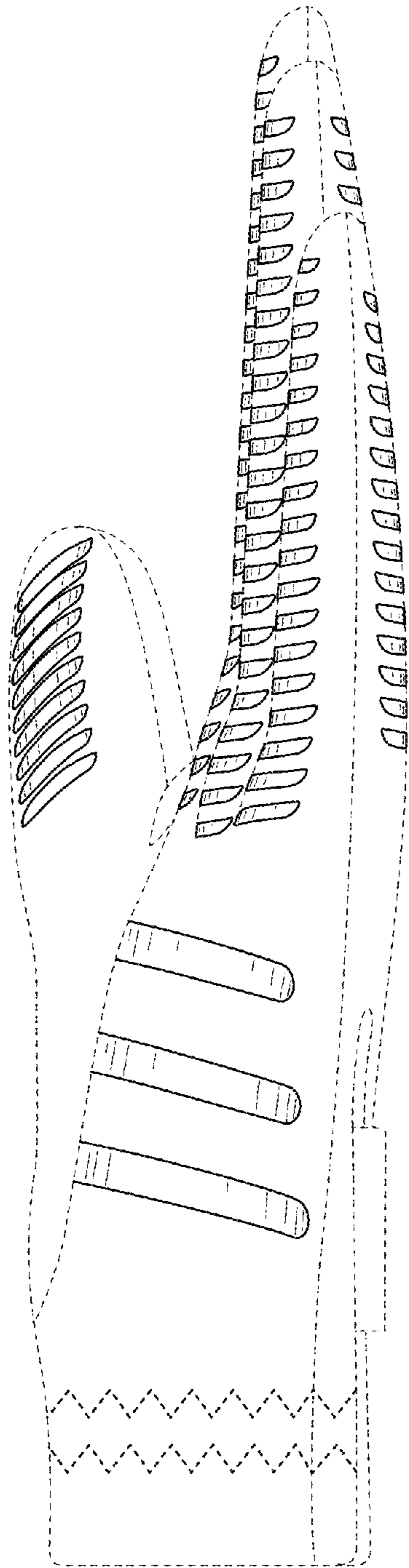

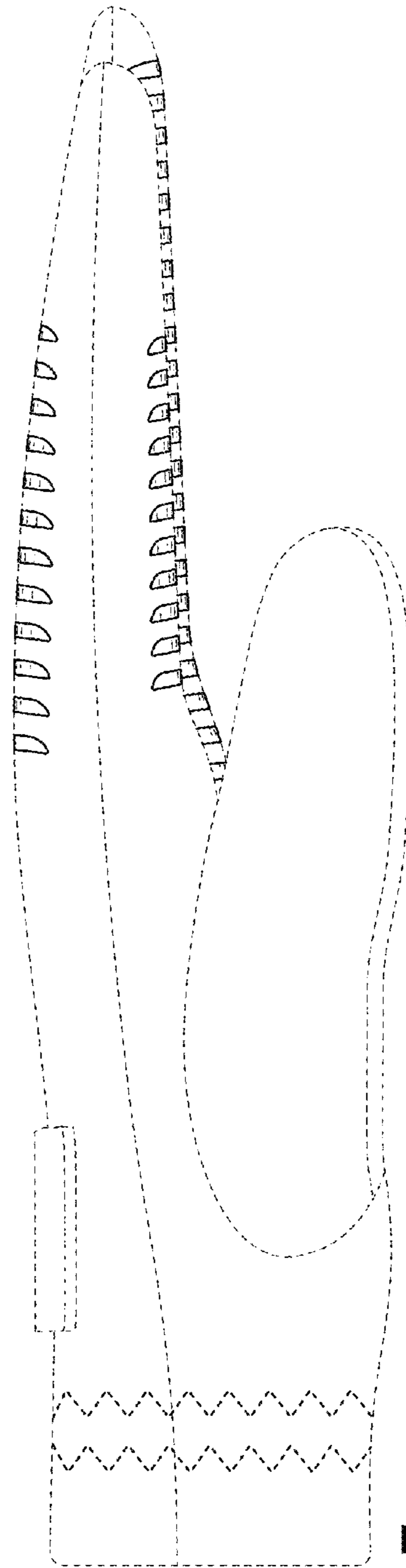

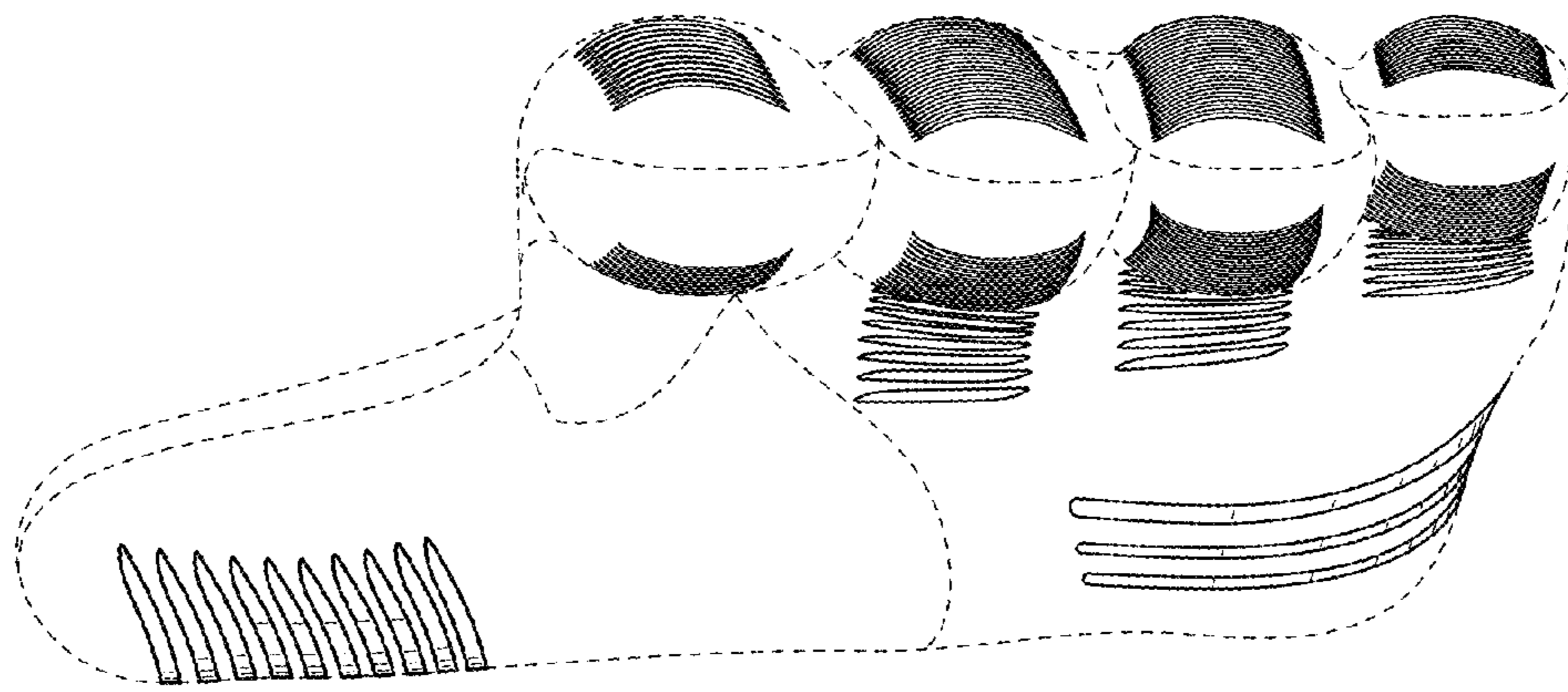

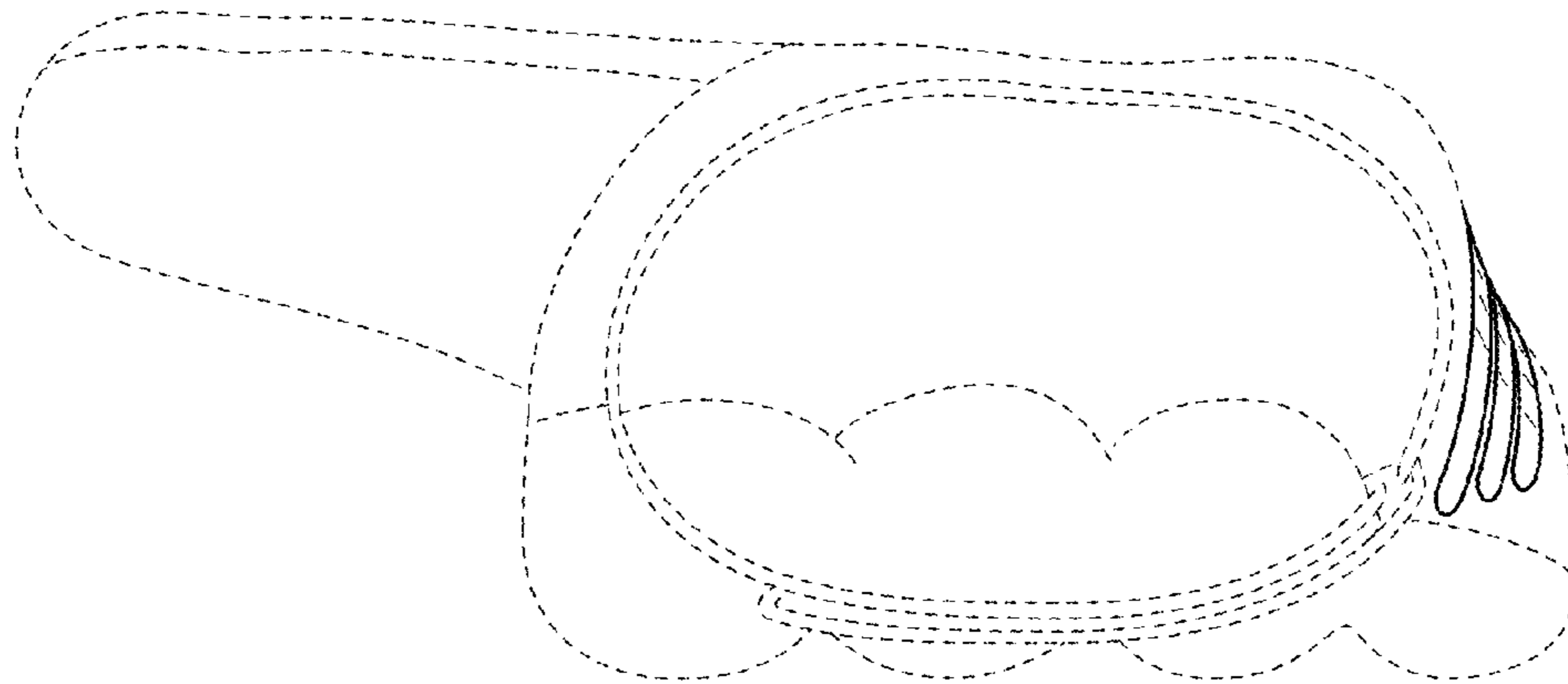
