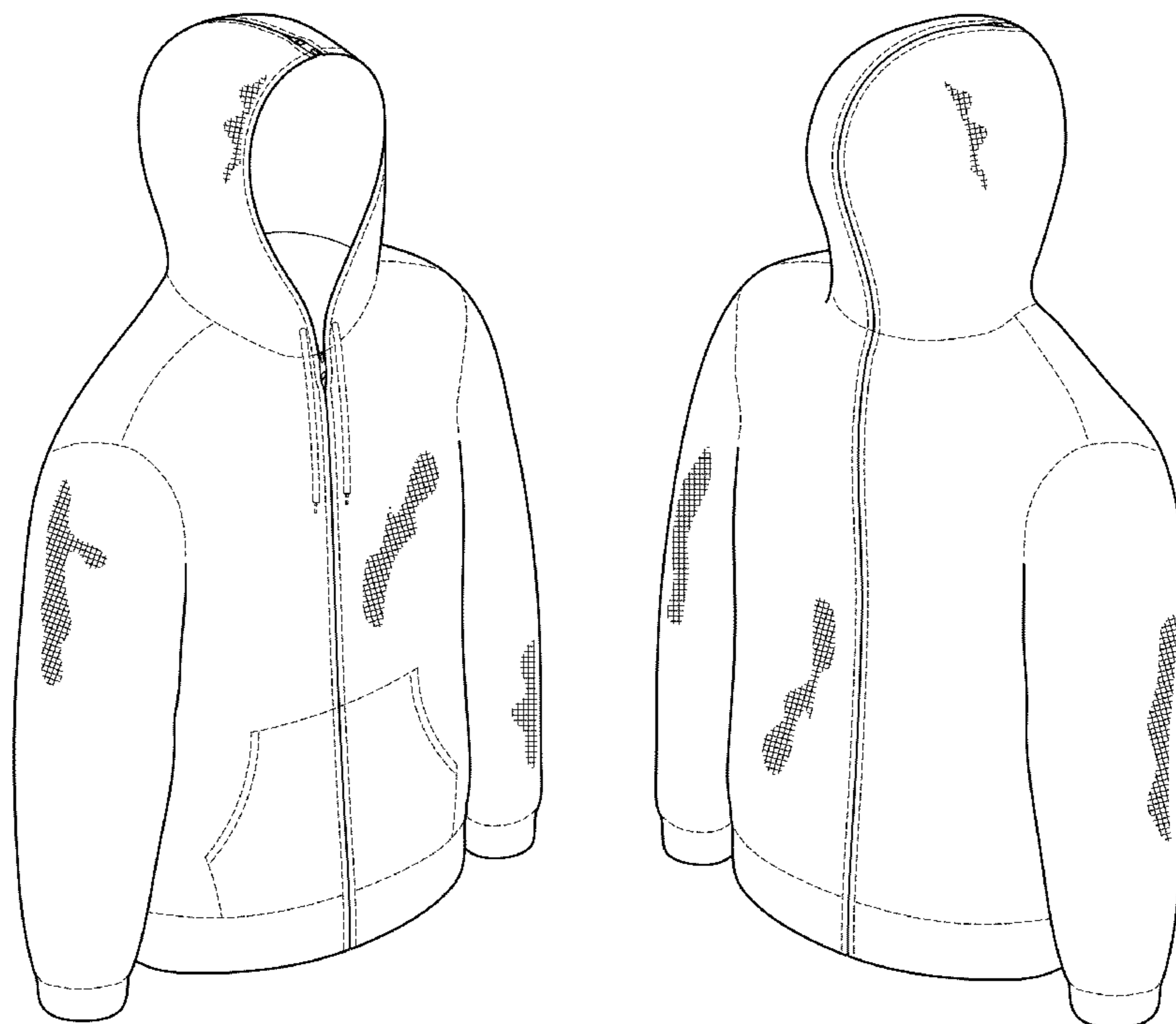
(57) **CLAIM**

An ornamental design for a zippered hooded sweatshirt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of the hooded sweatshirt.
 FIG. 2 is a perspective rear view of the hooded sweatshirt.
 FIG. 3 is front view of the hooded sweatshirt.
 FIG. 4 is a rear view of the hooded sweatshirt.
 FIG. 5 is a left side elevational view of the hooded sweatshirt.
 FIG. 6 is a top plan view of the hooded sweatshirt.
 FIG. 7 is a perspective view of the left side portion of the hooded sweatshirt disengaged from the right side portion of the hooded sweatshirt depicted in FIG. 8; and,
 FIG. 8 is a perspective of the right side portion of the hooded sweatshirt disengaged from the left side portion of the hooded sweatshirt depicted in FIG. 7.

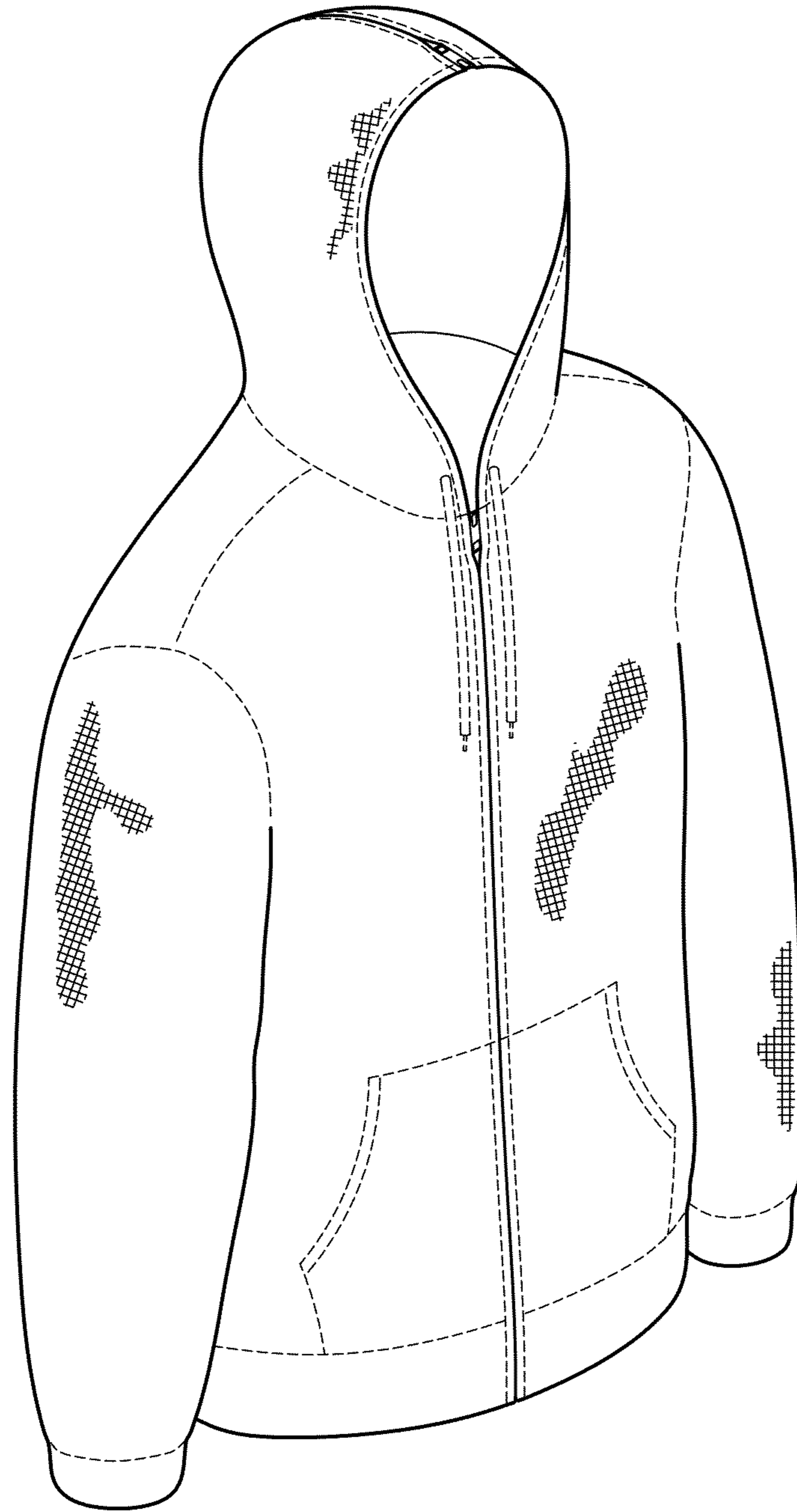

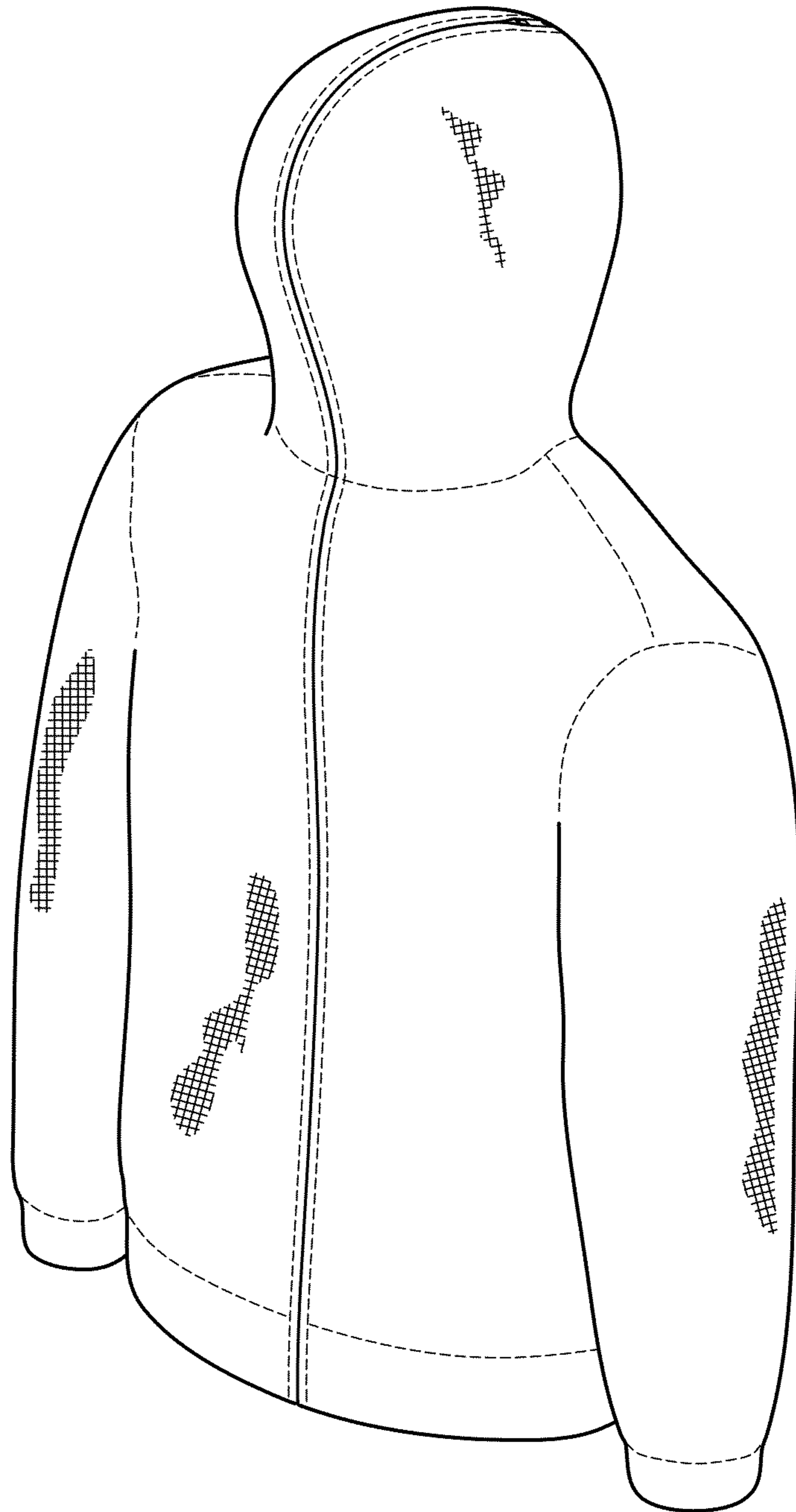

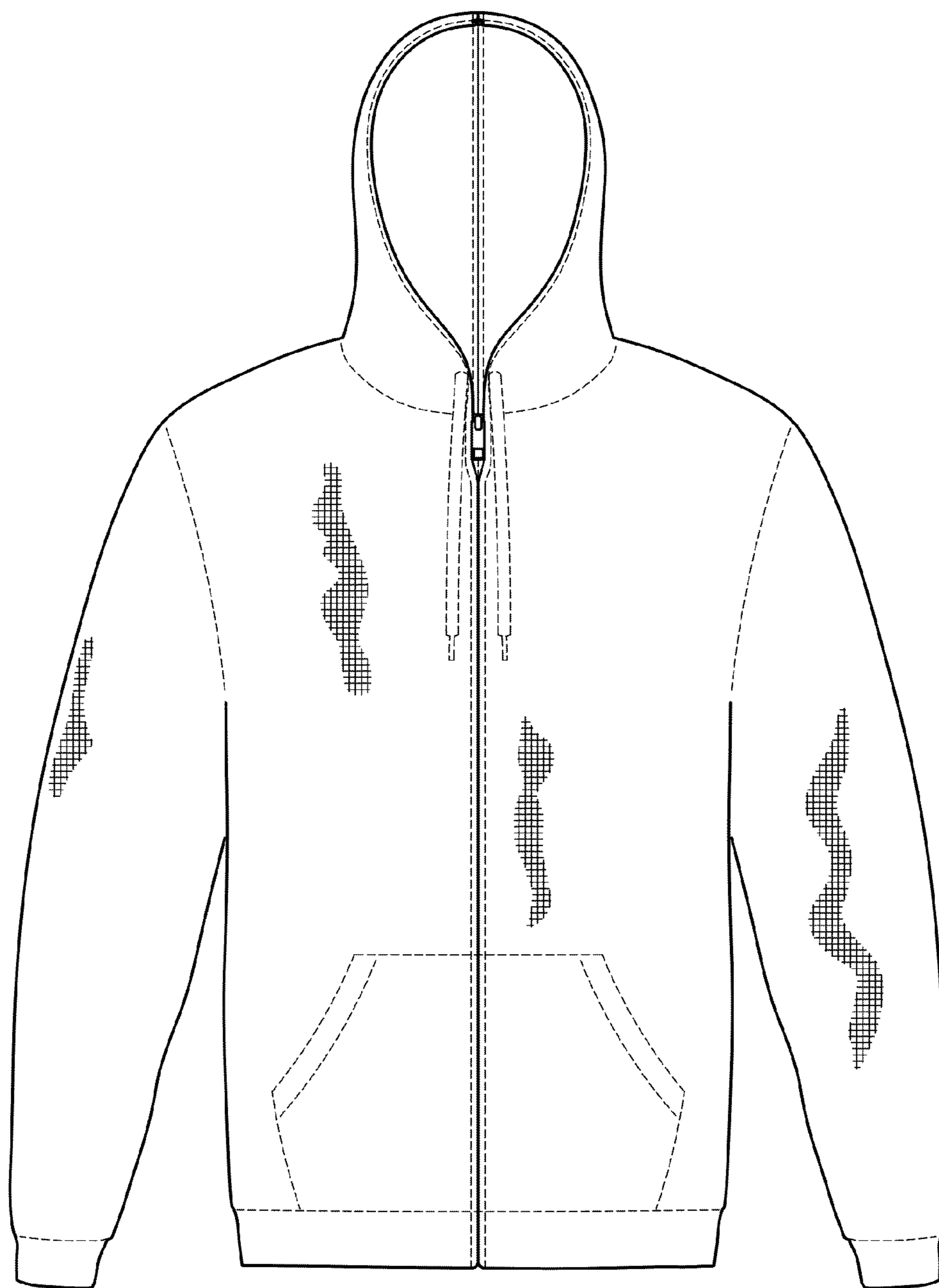

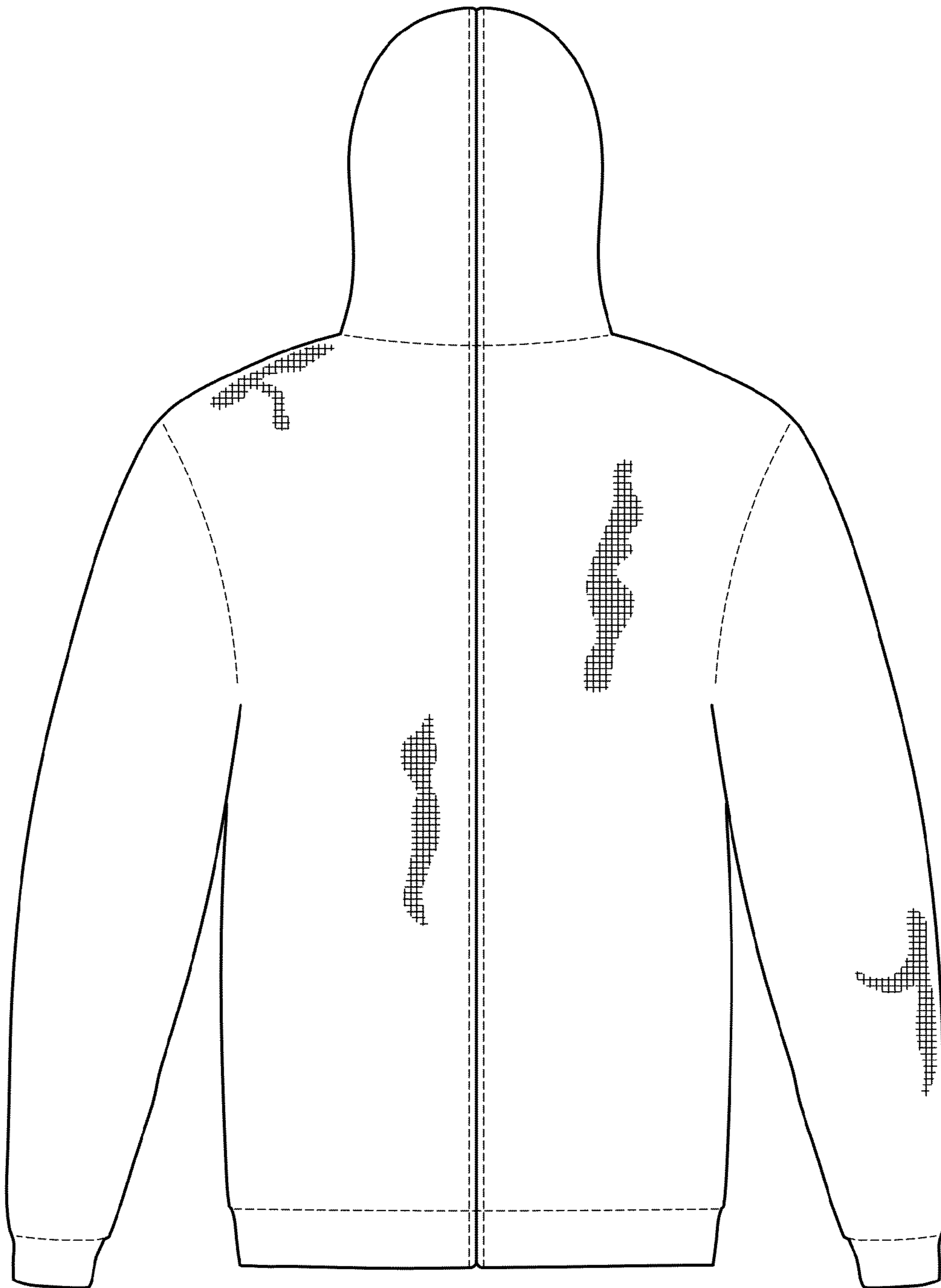

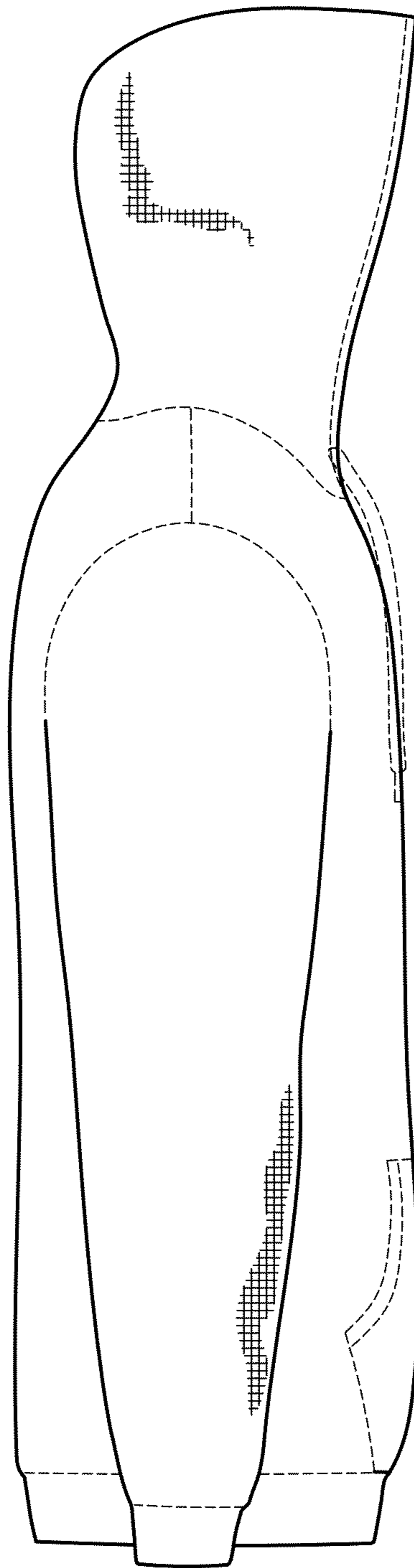

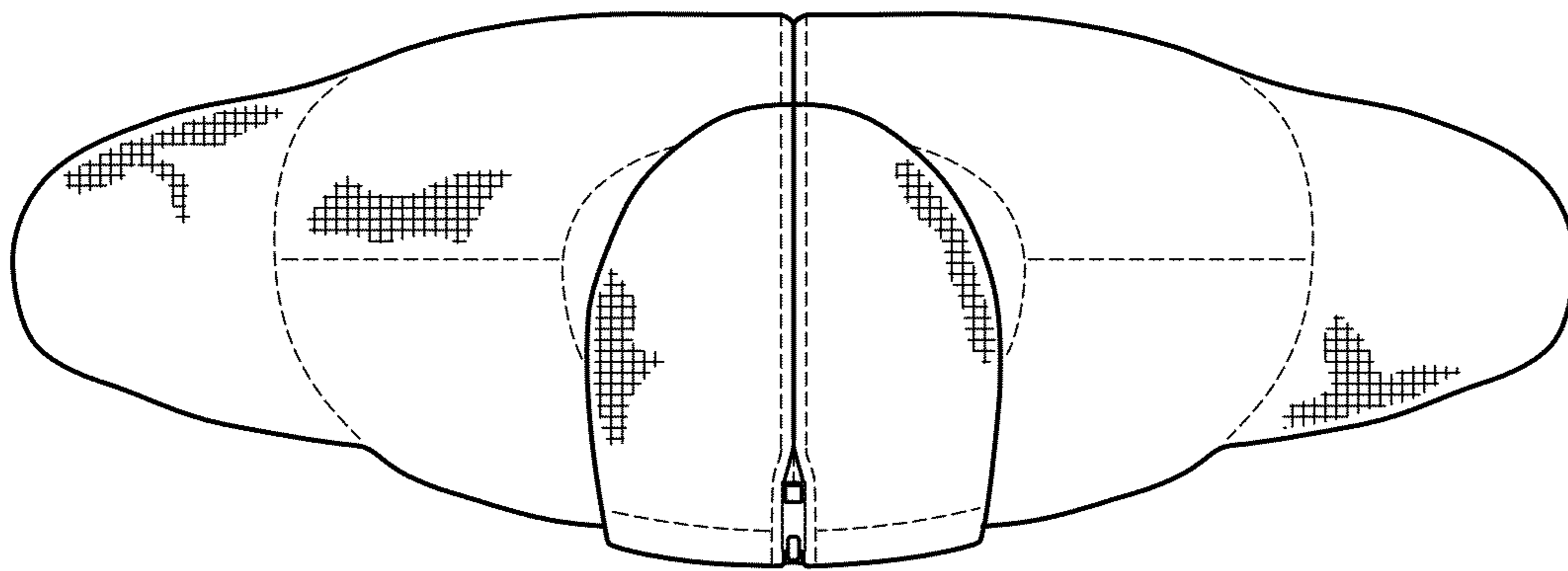

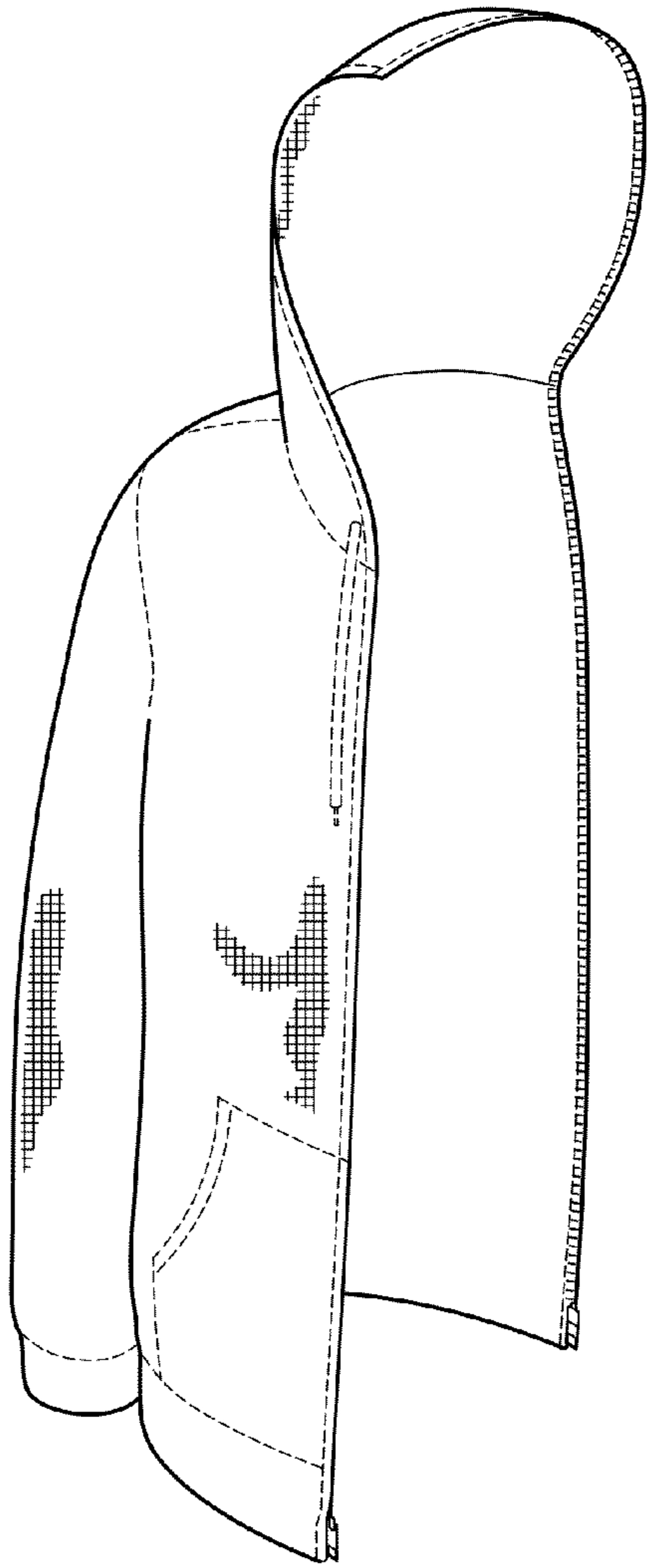

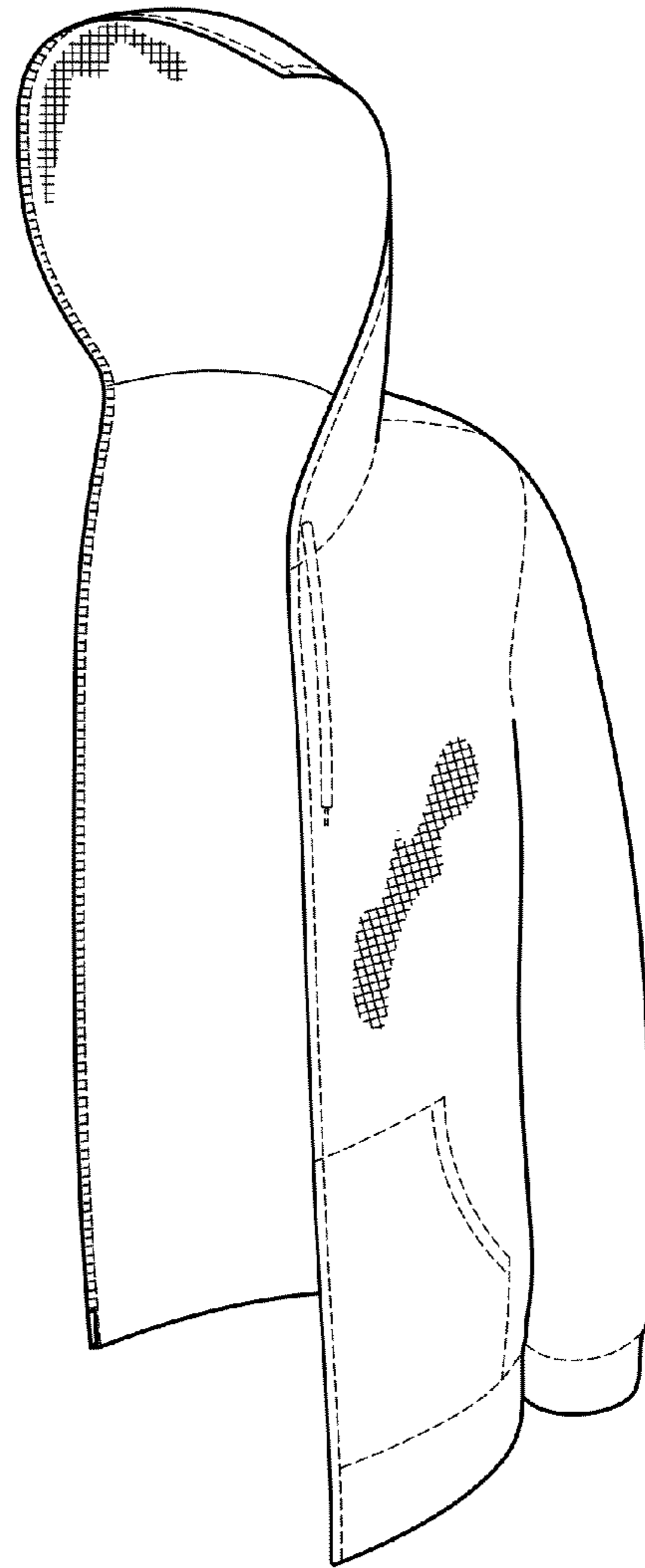
