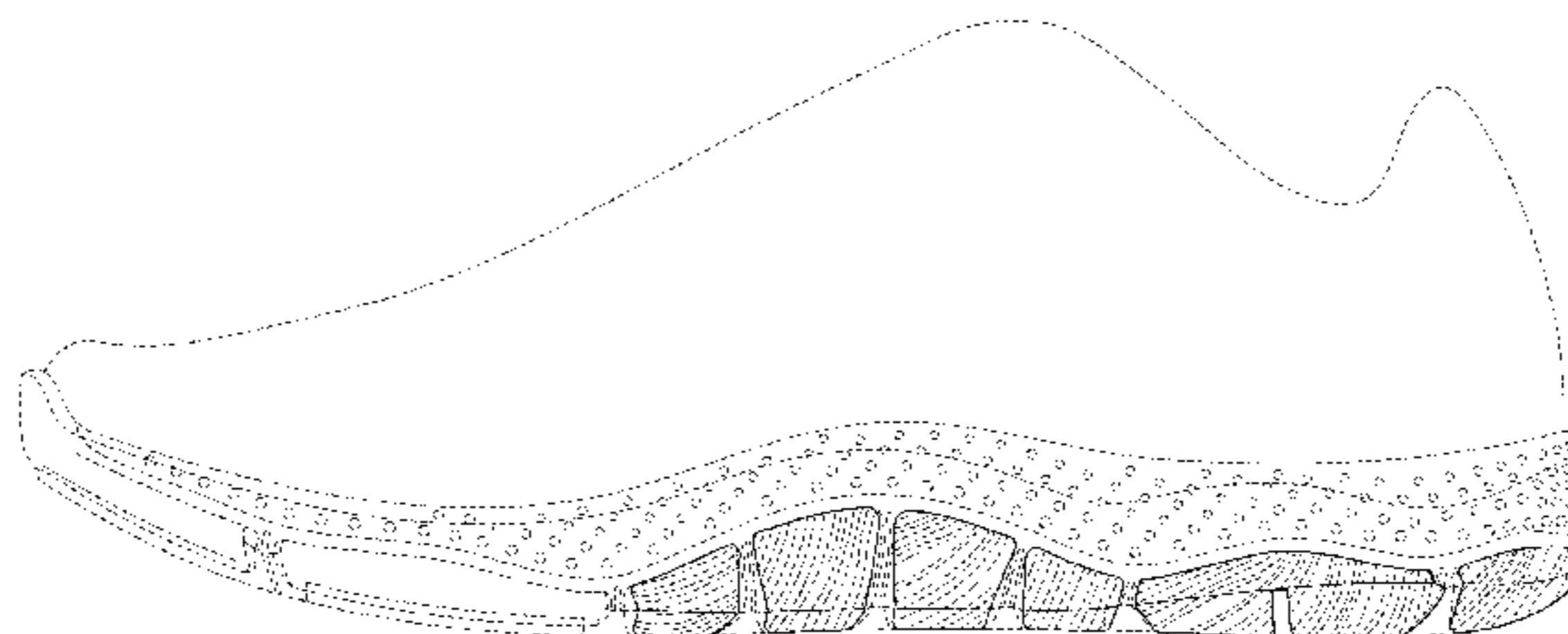
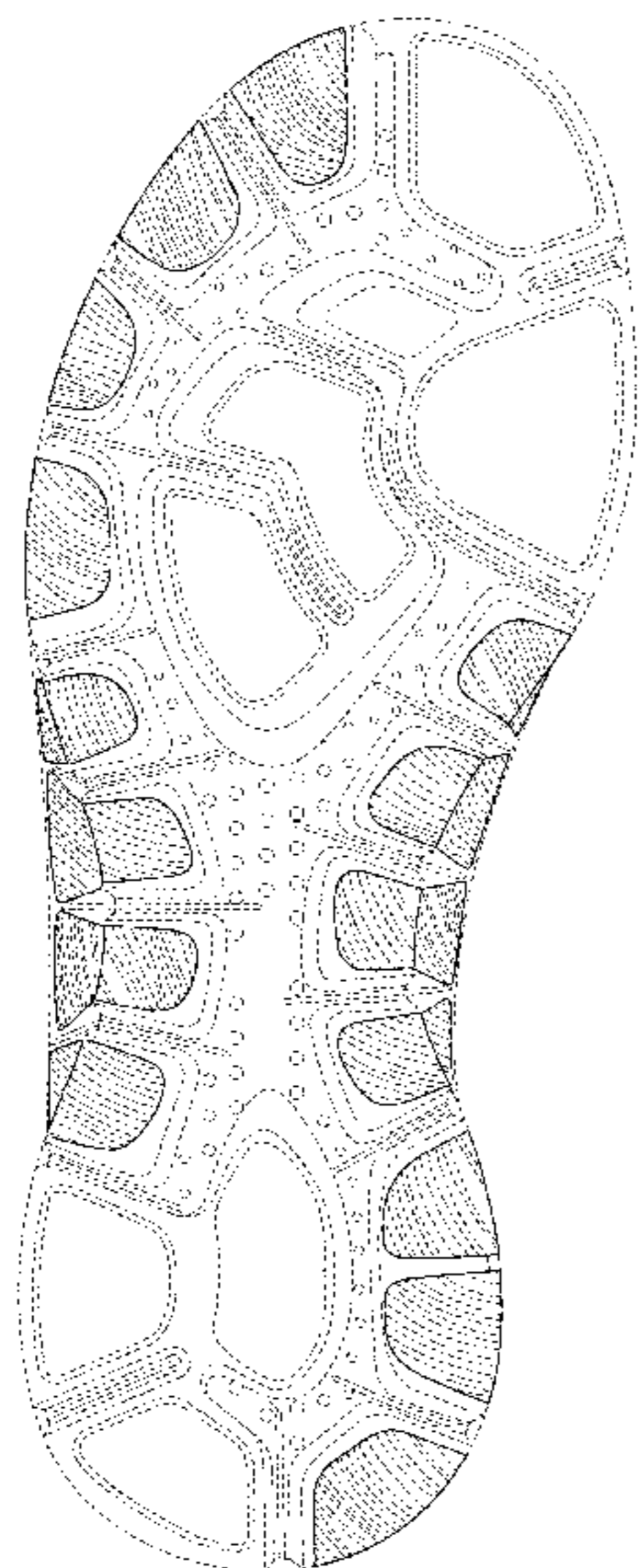

**DESCRIPTION**

FIG. 1 is a perspective view of an outsole for a shoe showing our new design;

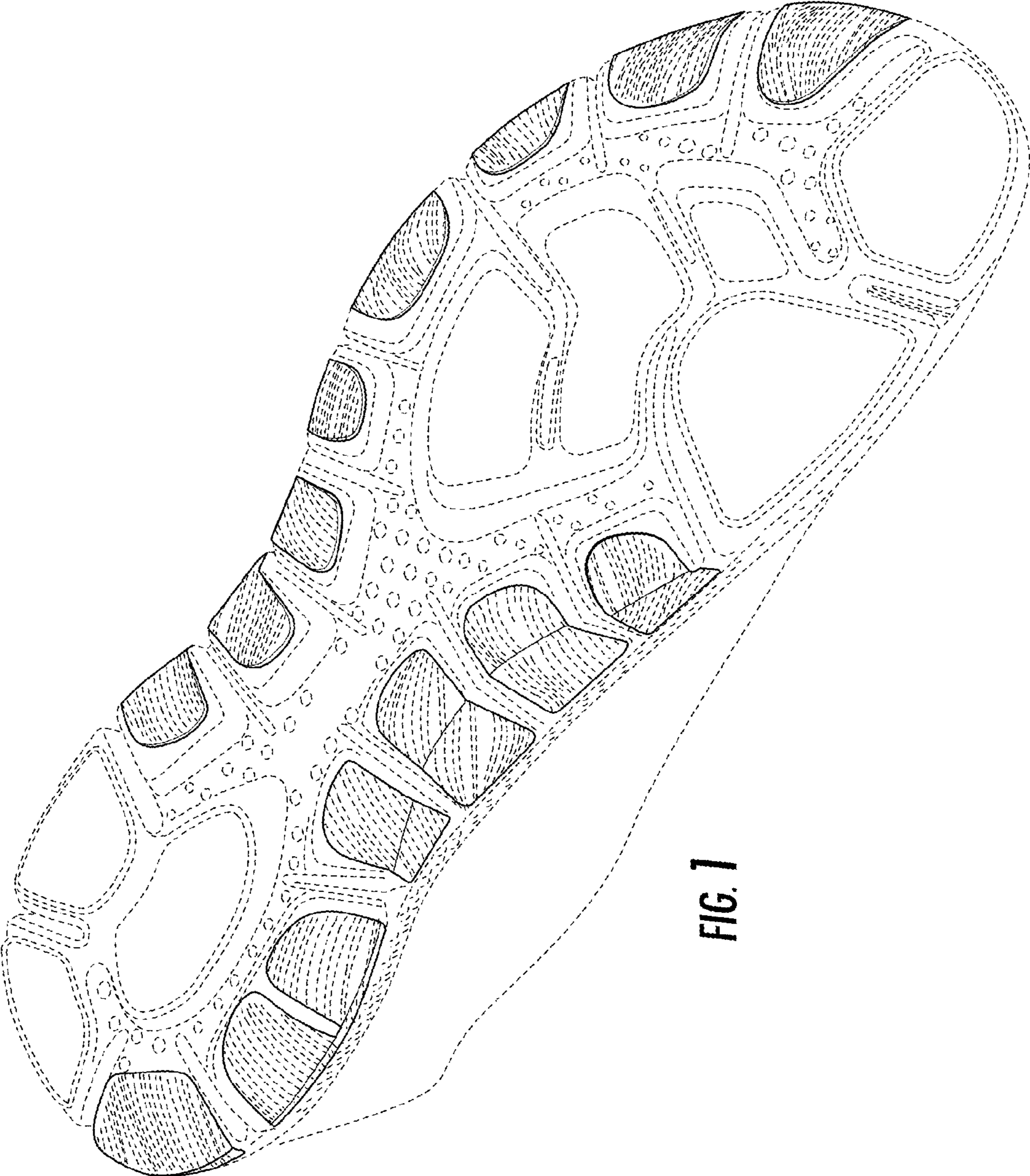

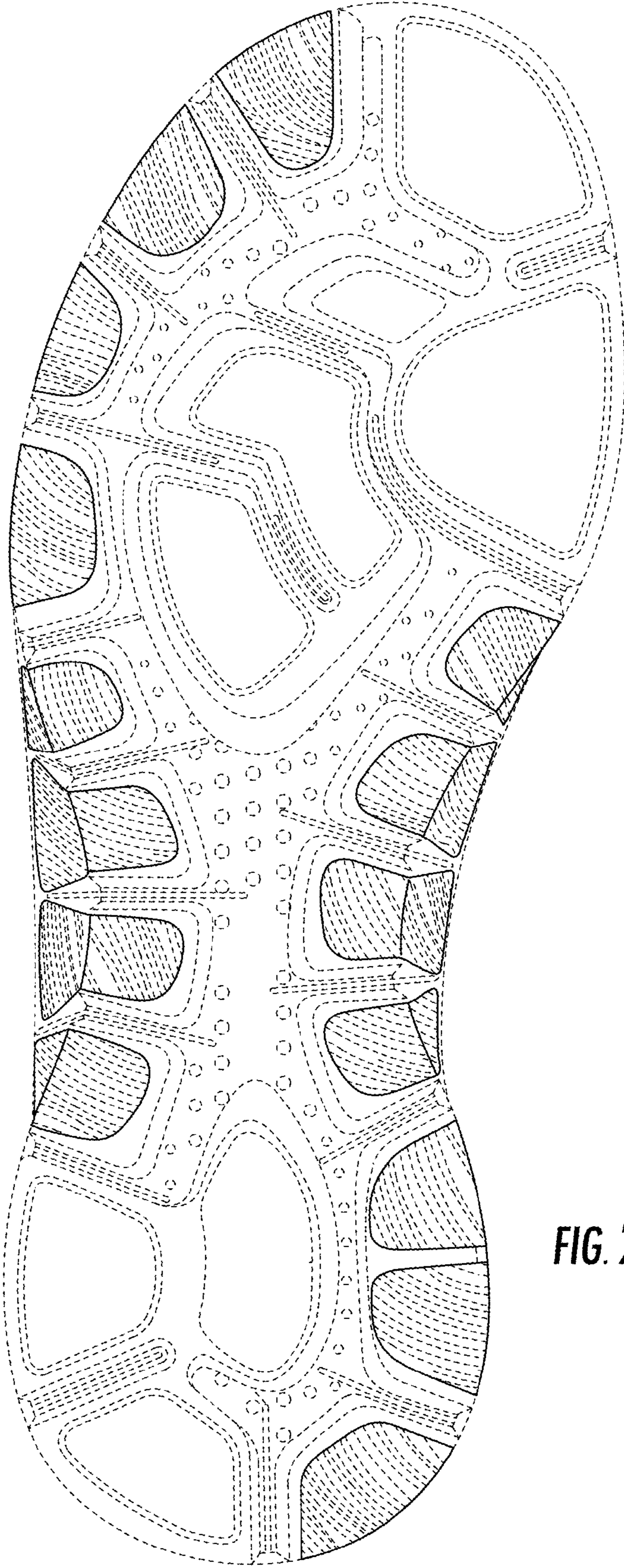

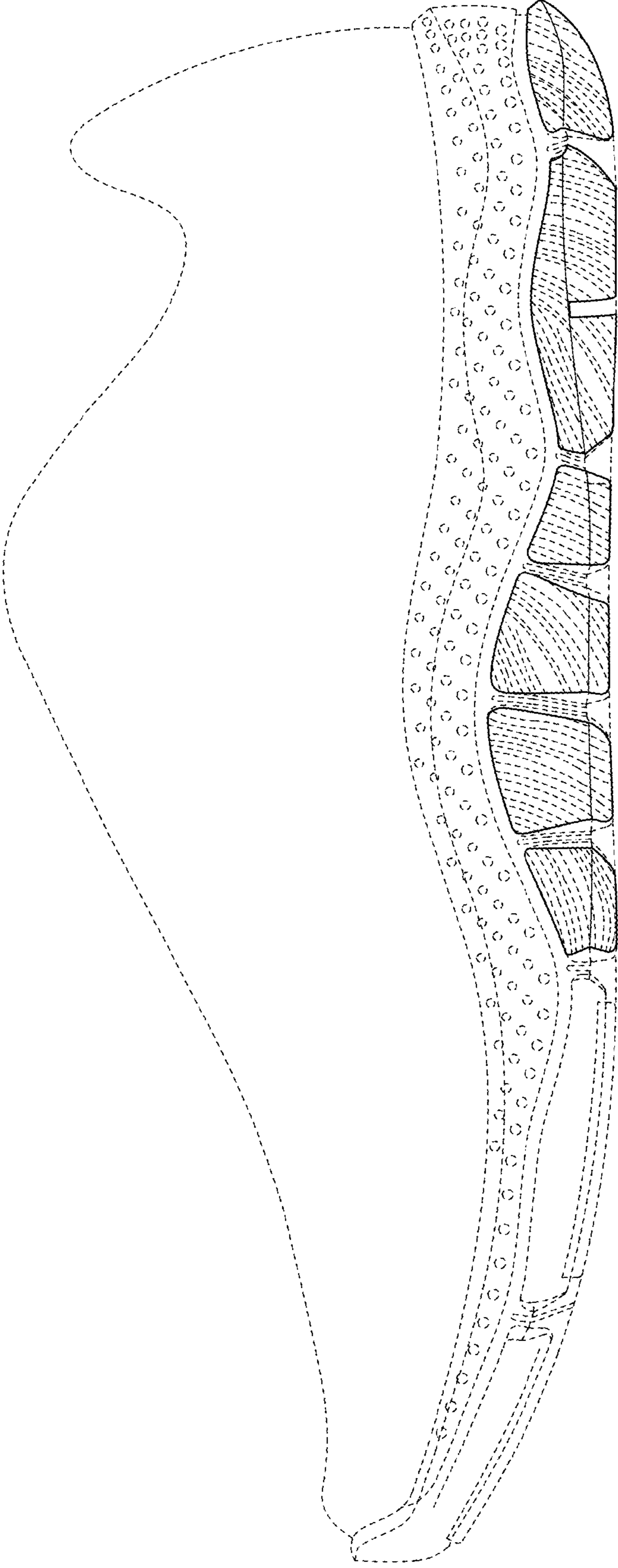

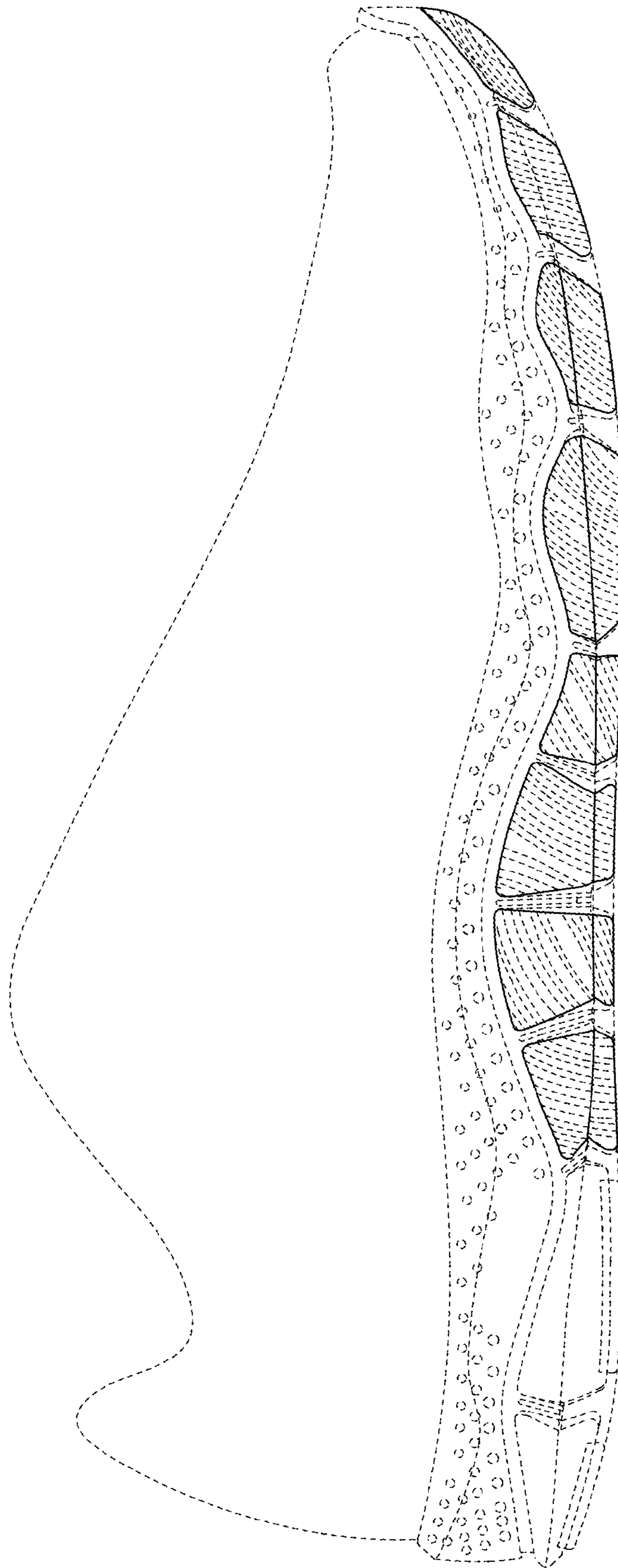

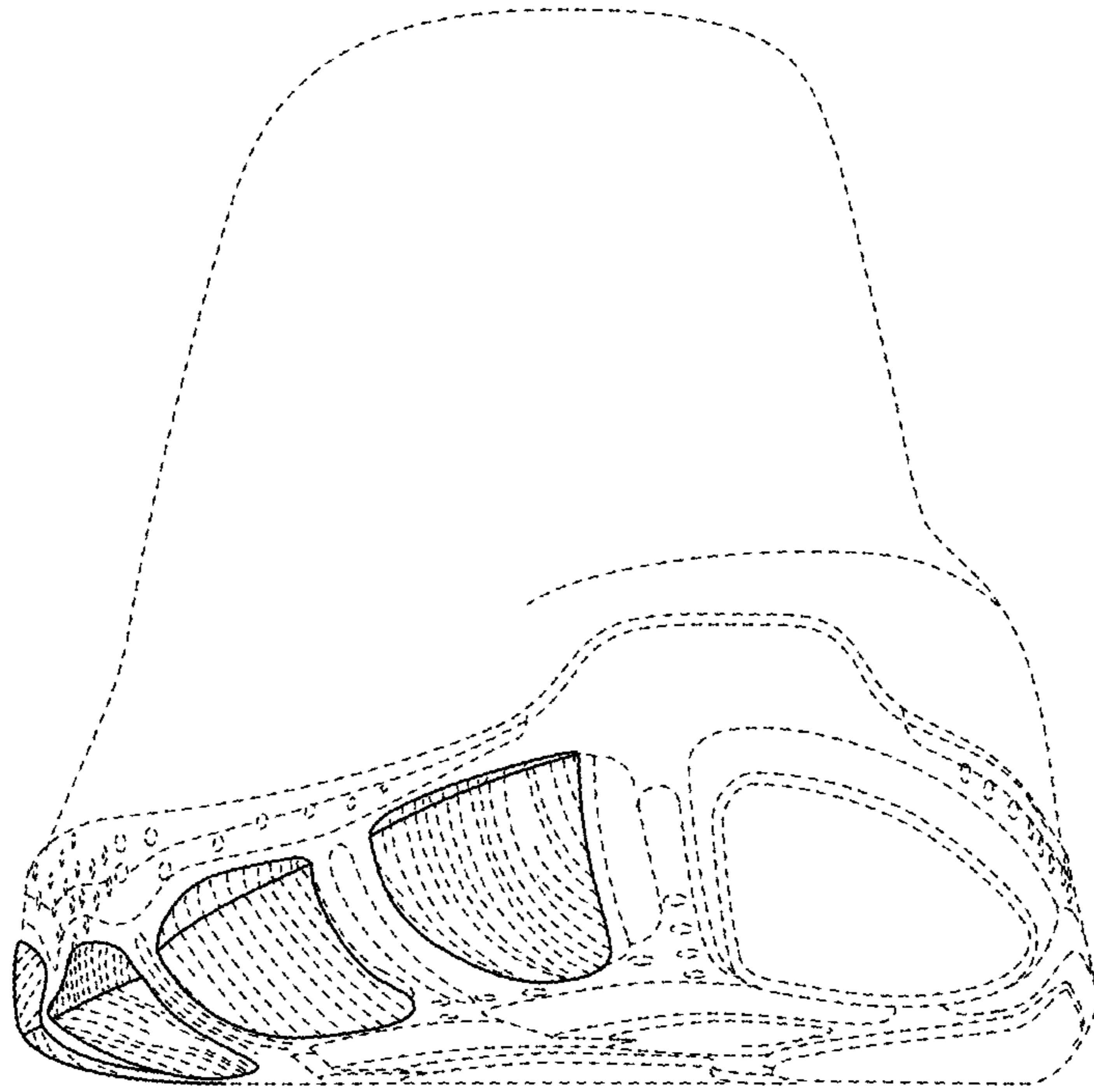

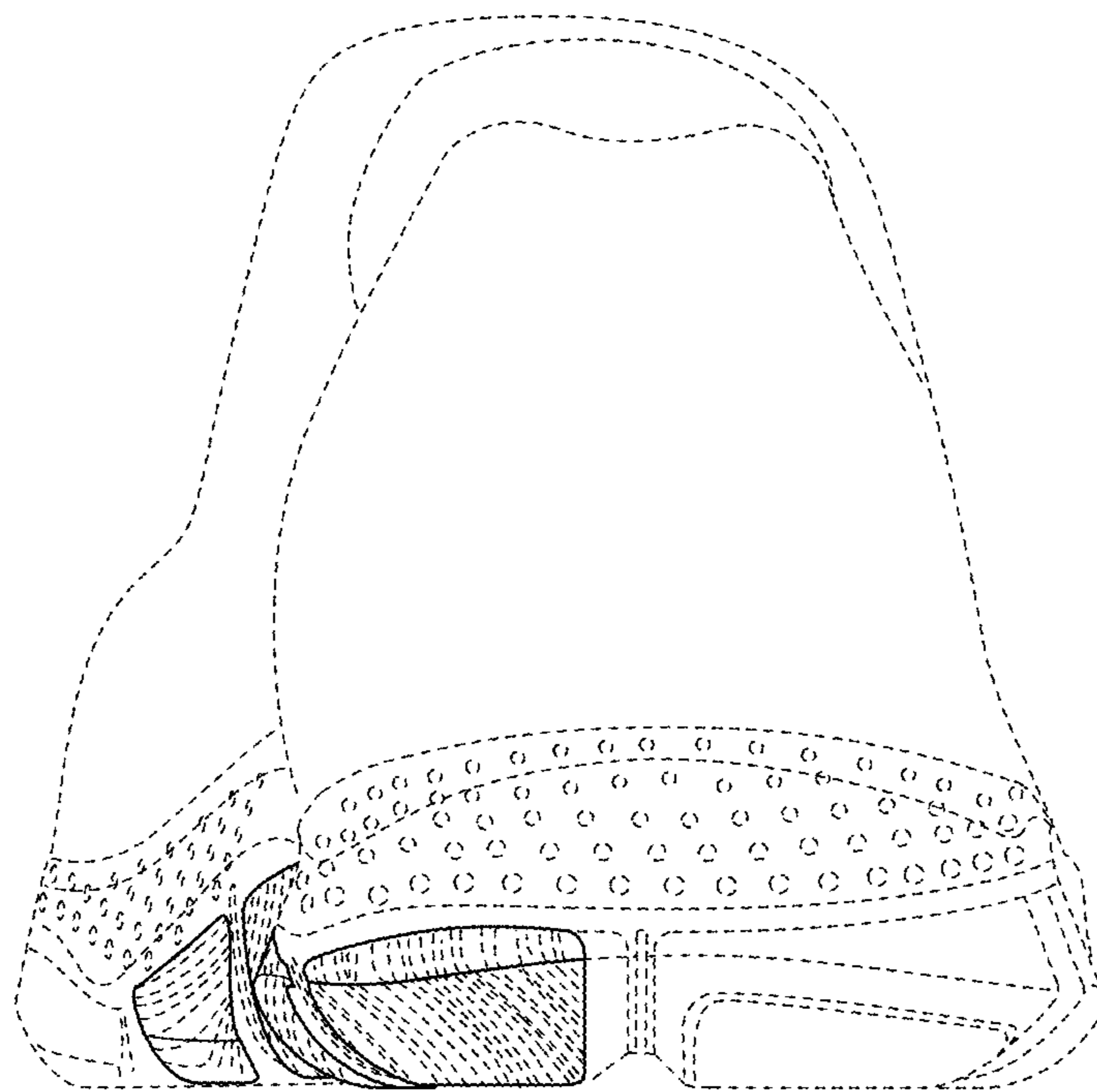
