DESCRIPTION

FIG. 1 is a front perspective view of a chair showing my new design;

FIG. 2 is a front view of the chair shown in FIG. 1;

FIG. 3 is a right side view of the chair shown in FIG. 1;

FIG. 4 is a rear view of the chair shown in FIG. 1;

FIG. 5 is a perspective view of an alternative embodiment of the chair shown in FIGS. 1-4;

FIG. 6 is a front perspective view of the chair shown in FIG. 5;

FIG. 7 is a right side view of the chair shown in FIG. 5; and,

FIG. 8 is a rear perspective view of the chair shown in FIG. 5.

The underside of the chair is plain and unornamented and is not claimed.

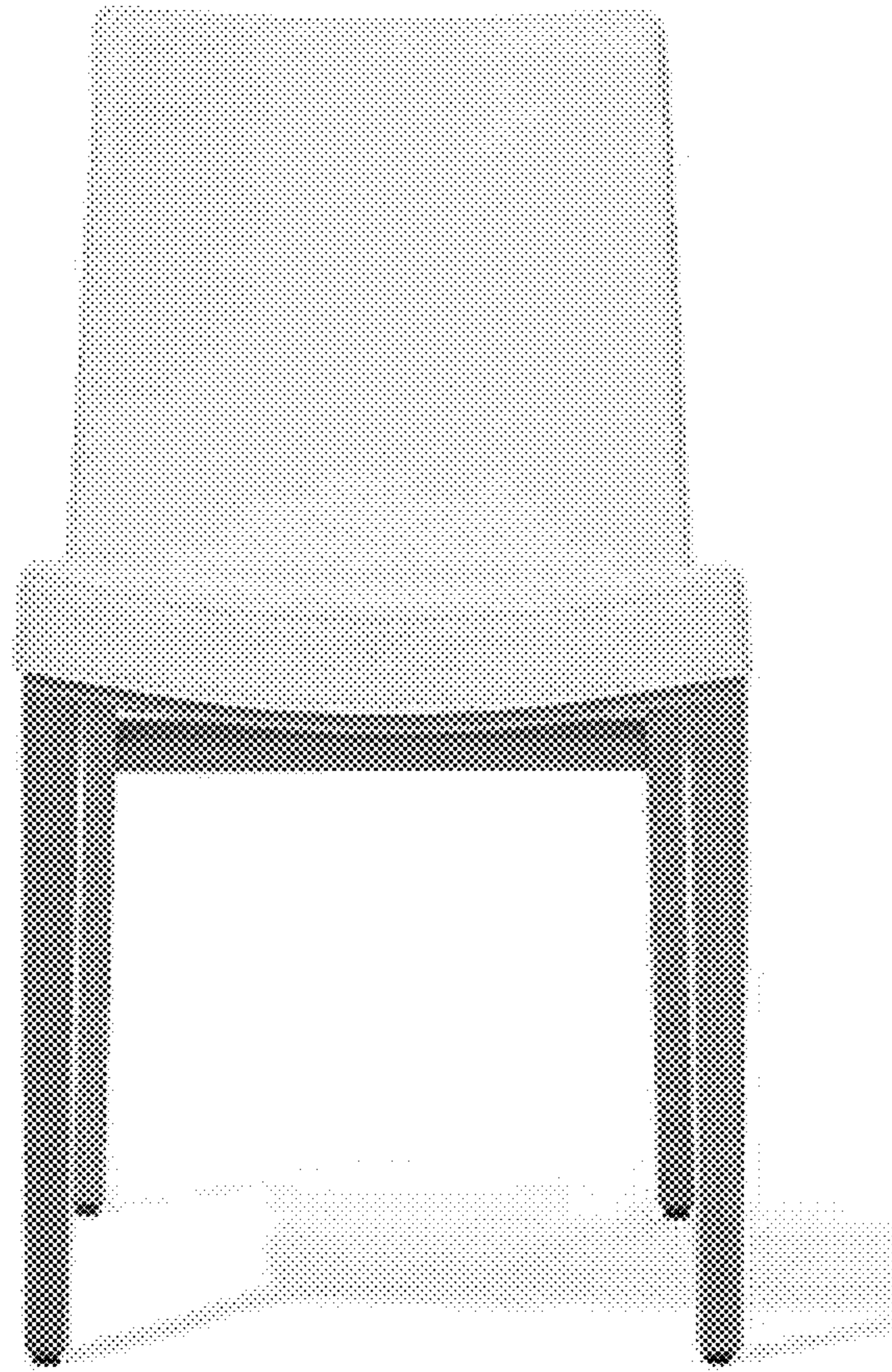

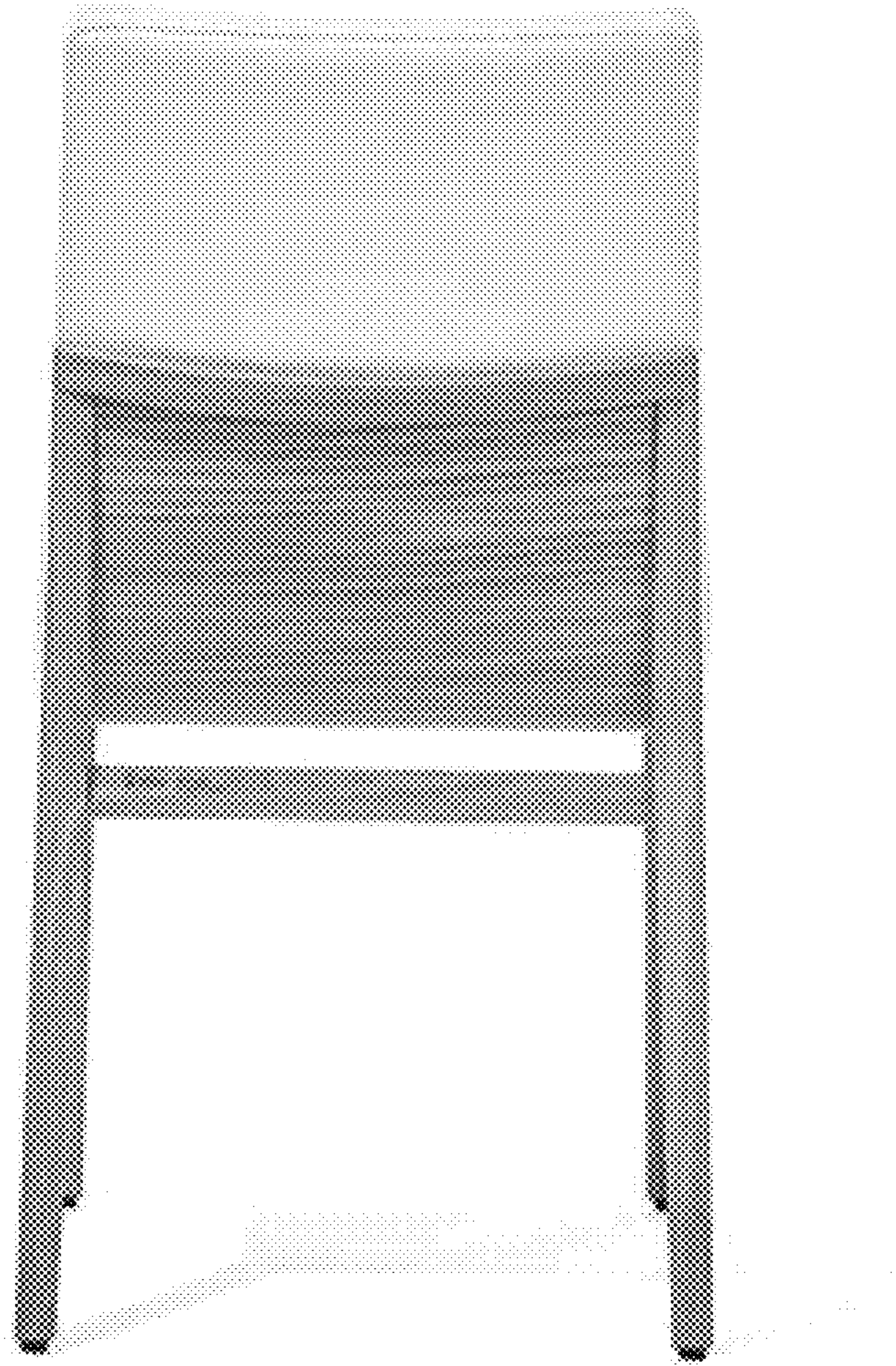
