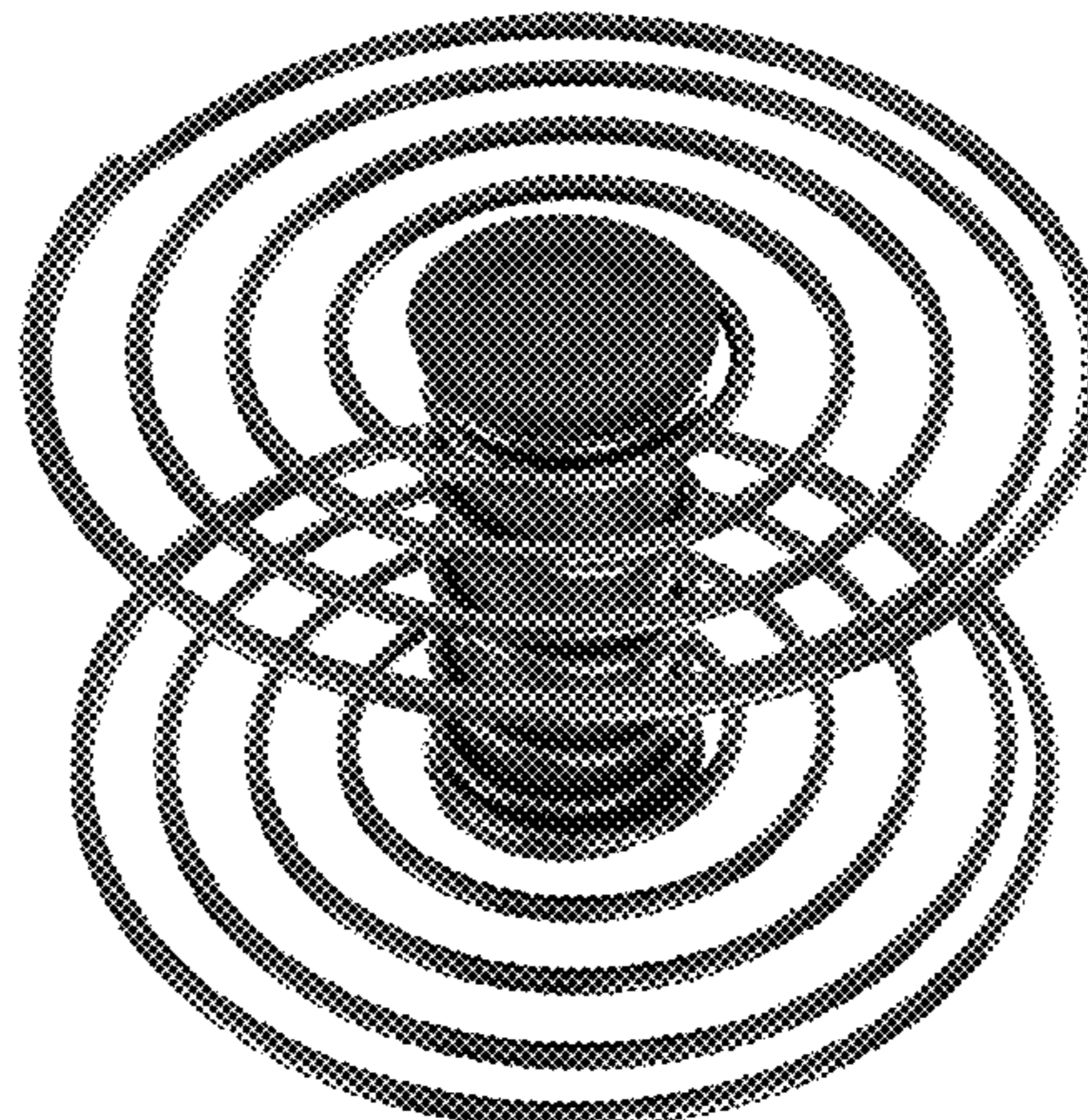
(57) **CLAIM**

The ornamental design for a mixing element for a beverage shaker, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a mixing element for a beverage shaker showing my new design; FIG. 2 is a front view thereof; and, FIG. 3 is a front view of a central portion thereof with an outer spiral portion thereof omitted for ease of illustration.

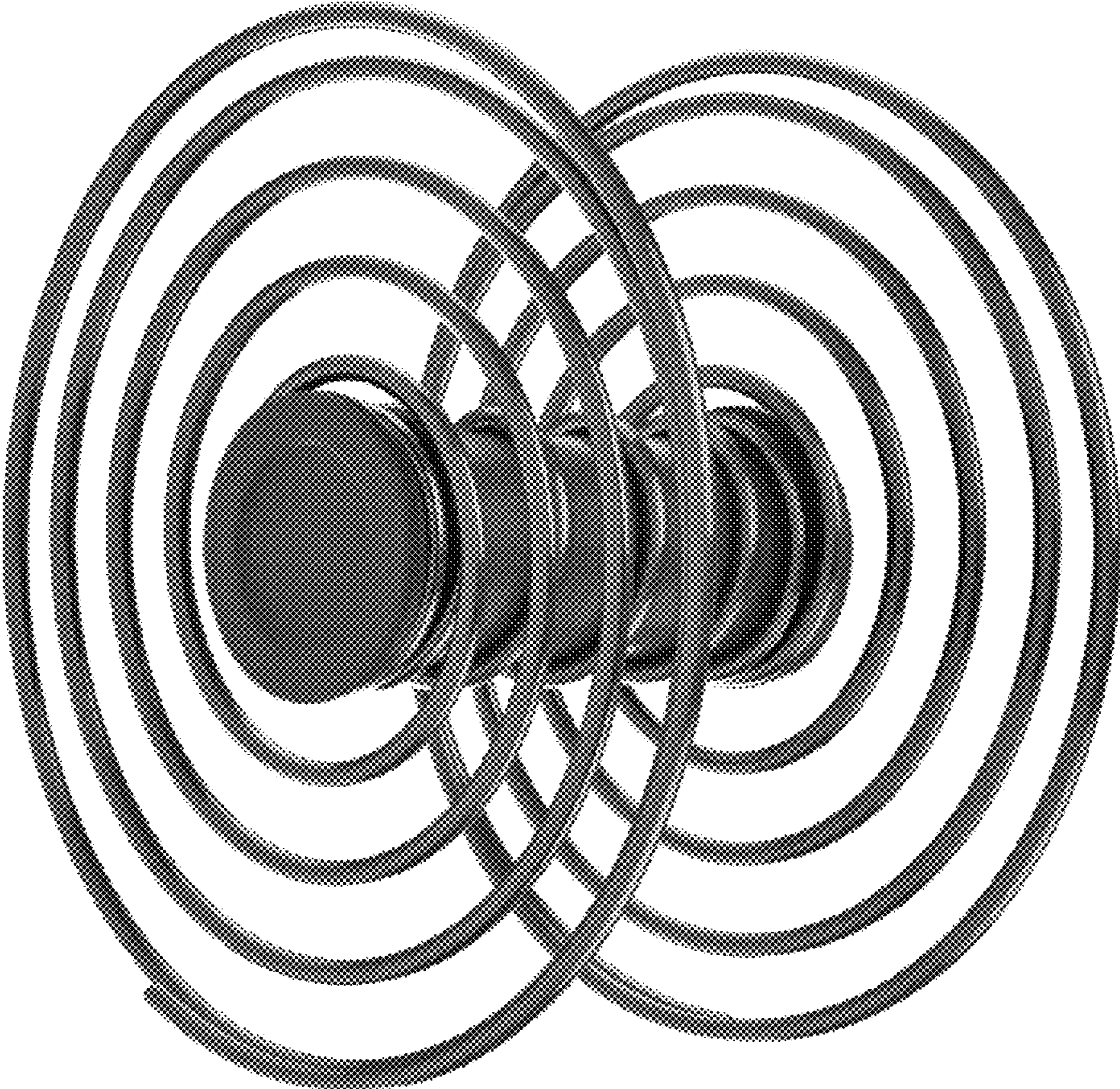

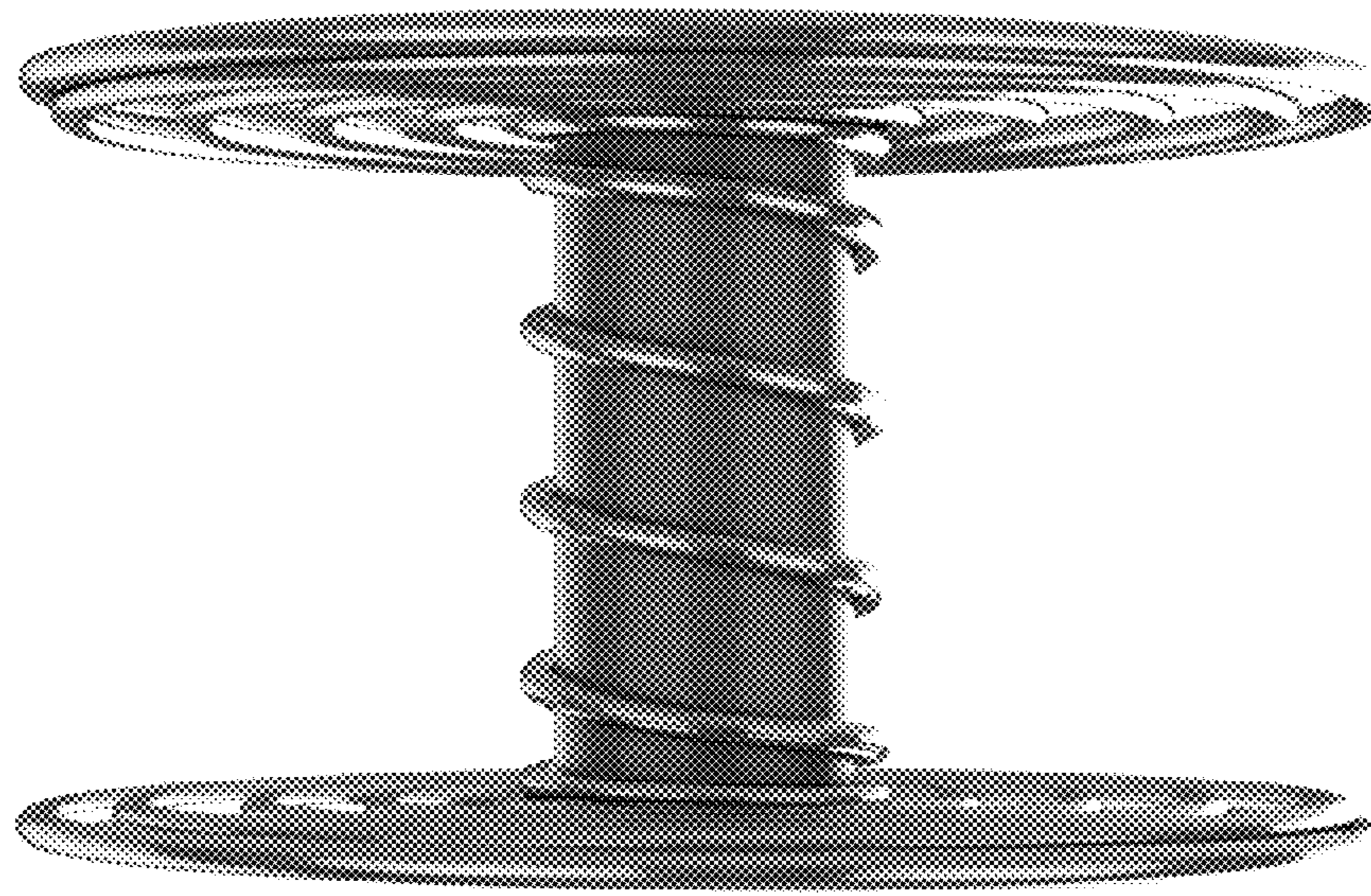

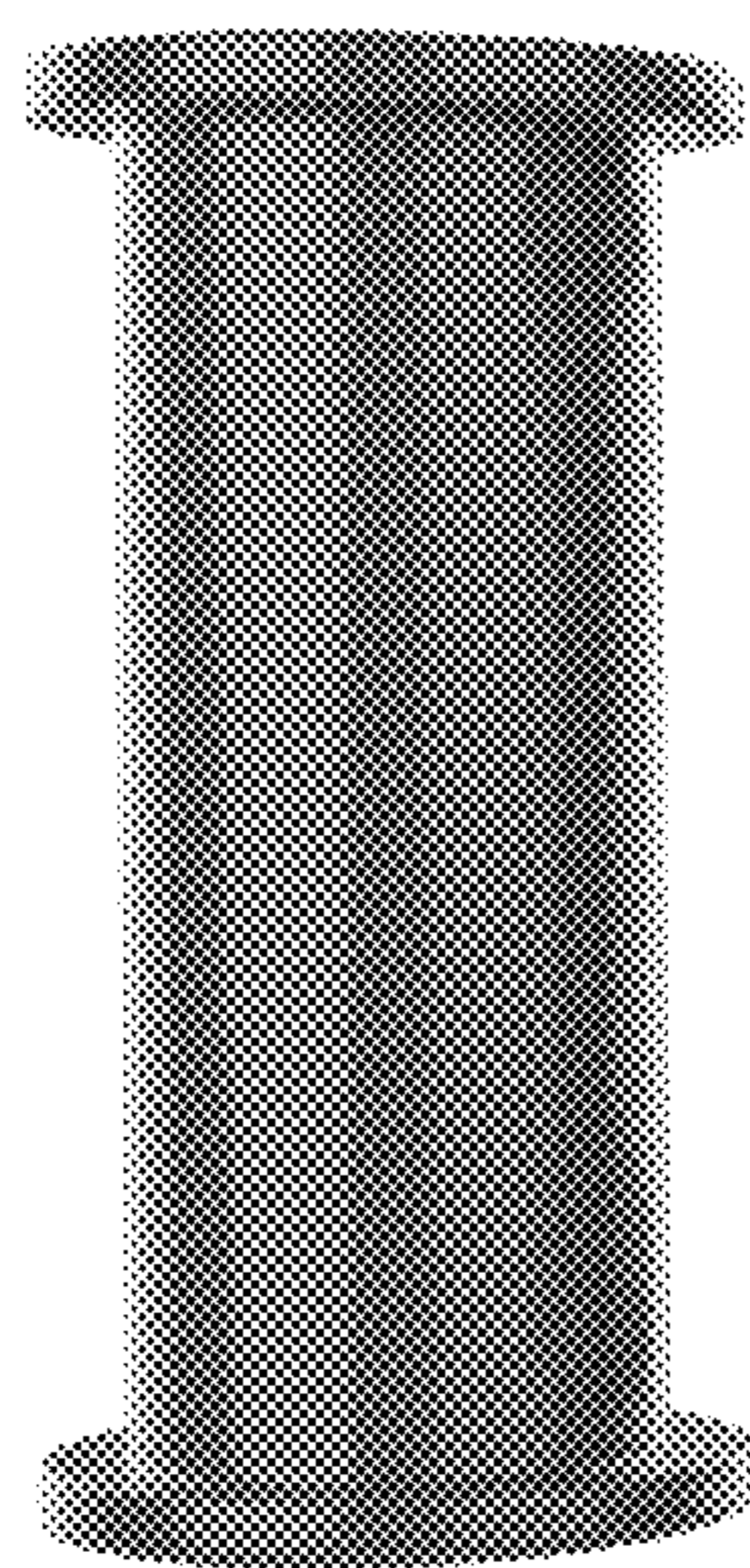
