(57) **CLAIM**

I claim the ornamental design for an trophy mount, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a trophy mount showing my new design.

FIG. 2 is a right side elevation view of FIG. 1.

FIG. 3 is a front elevation view of FIG. 1.

FIG. 4 is a left side elevation view of FIG. 1.

FIG. 5 is a top plan view of FIG. 1.

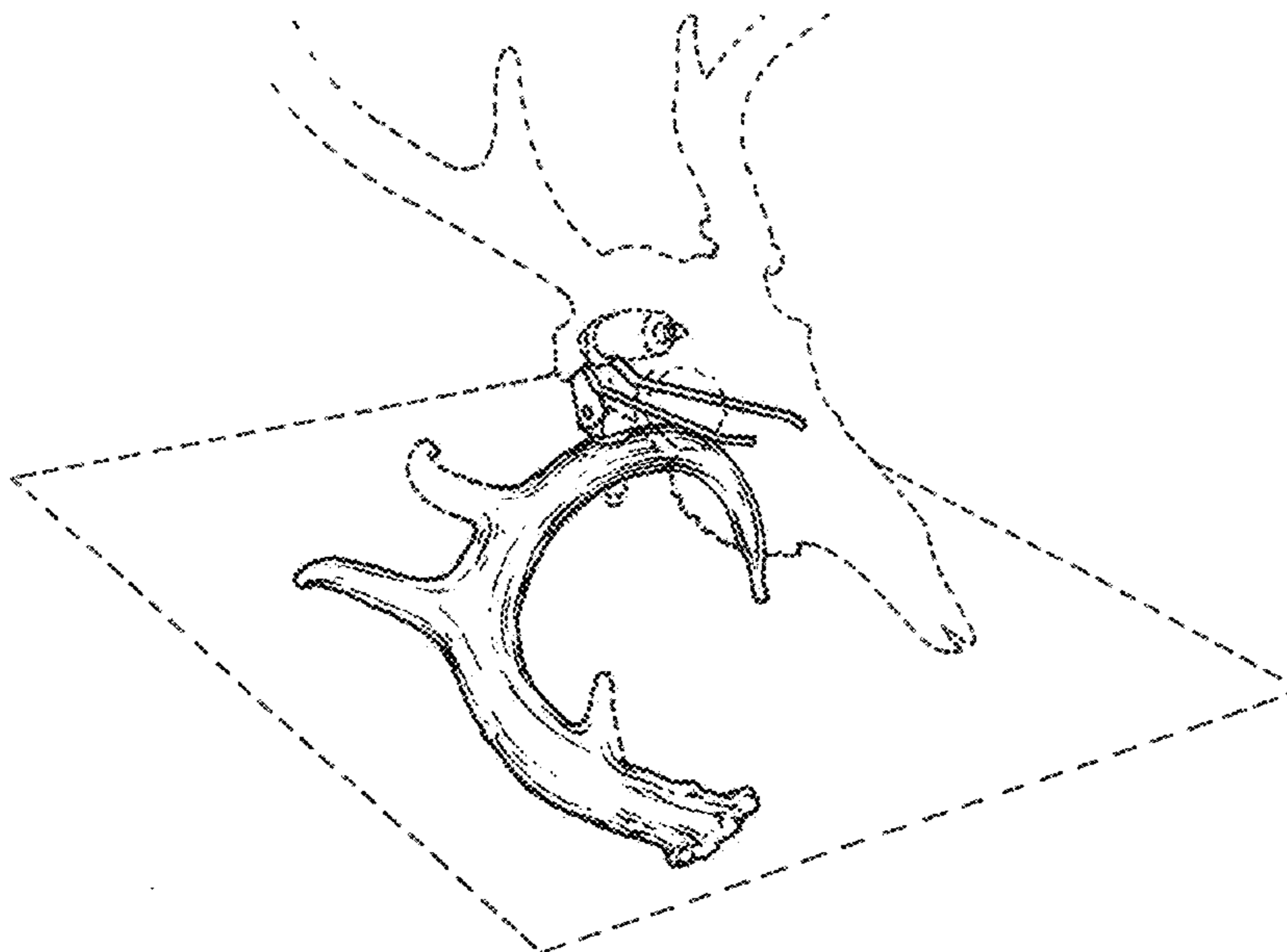
FIG. 6 is a back elevation view of FIG. 1.

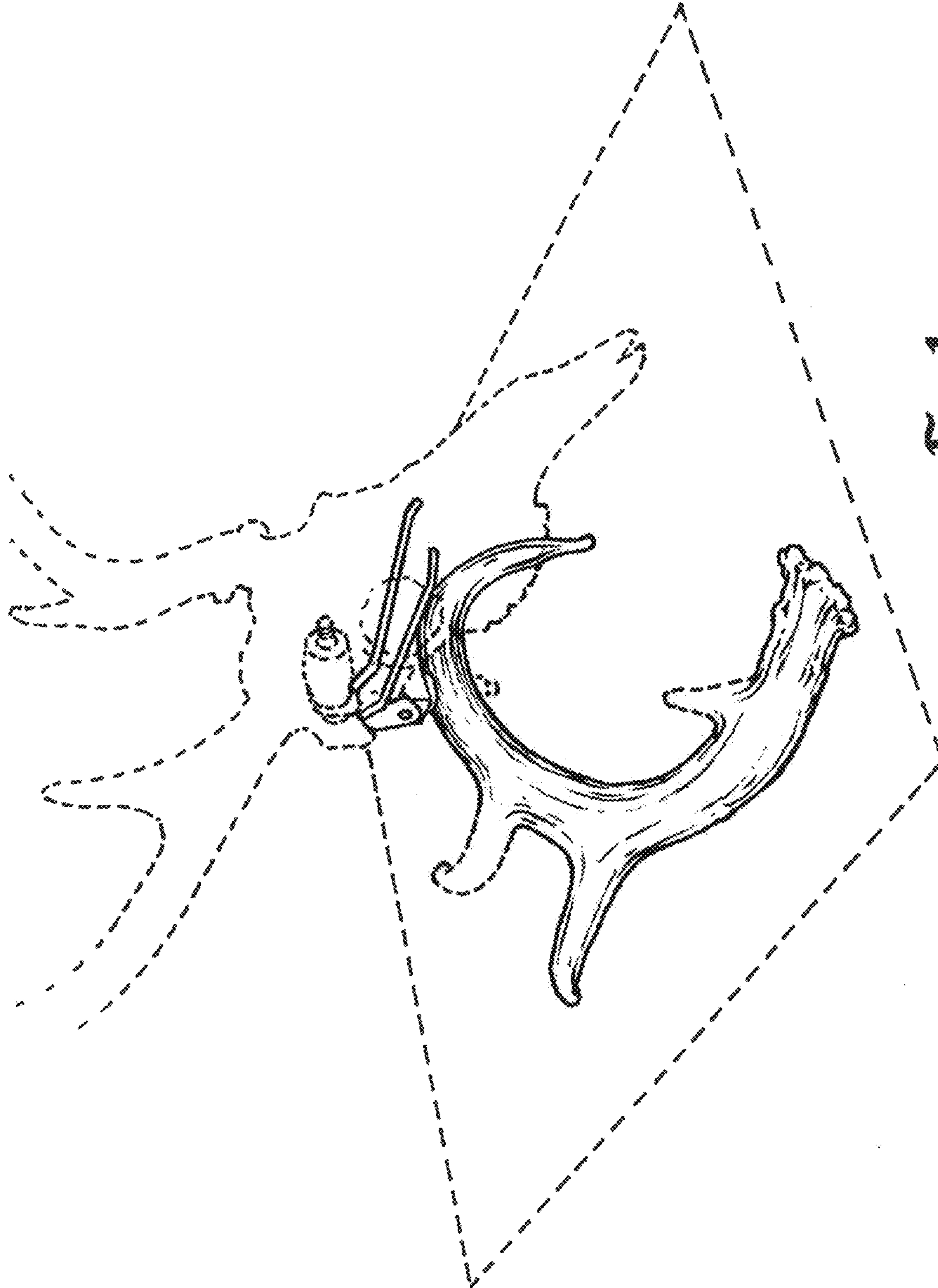

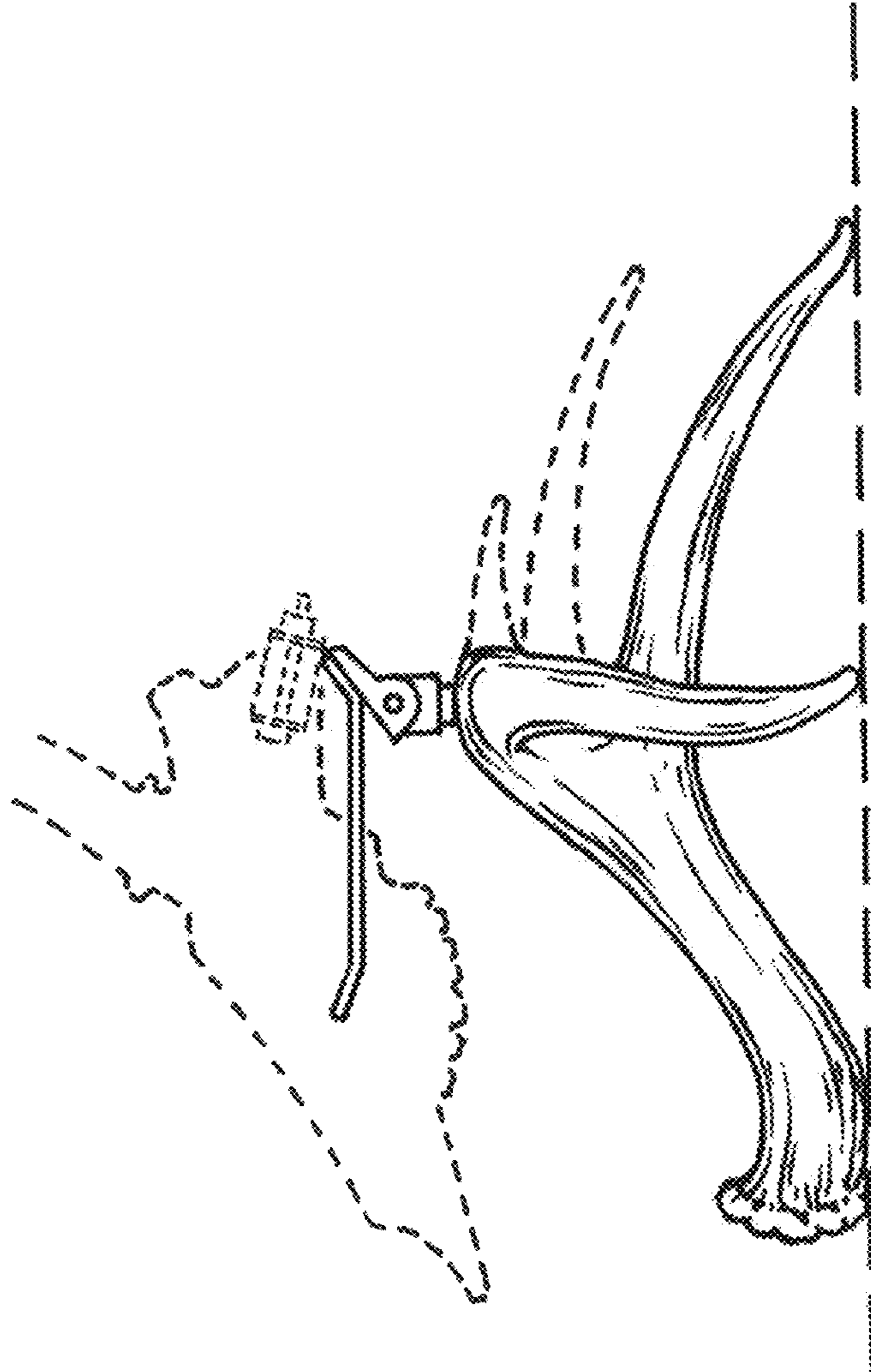

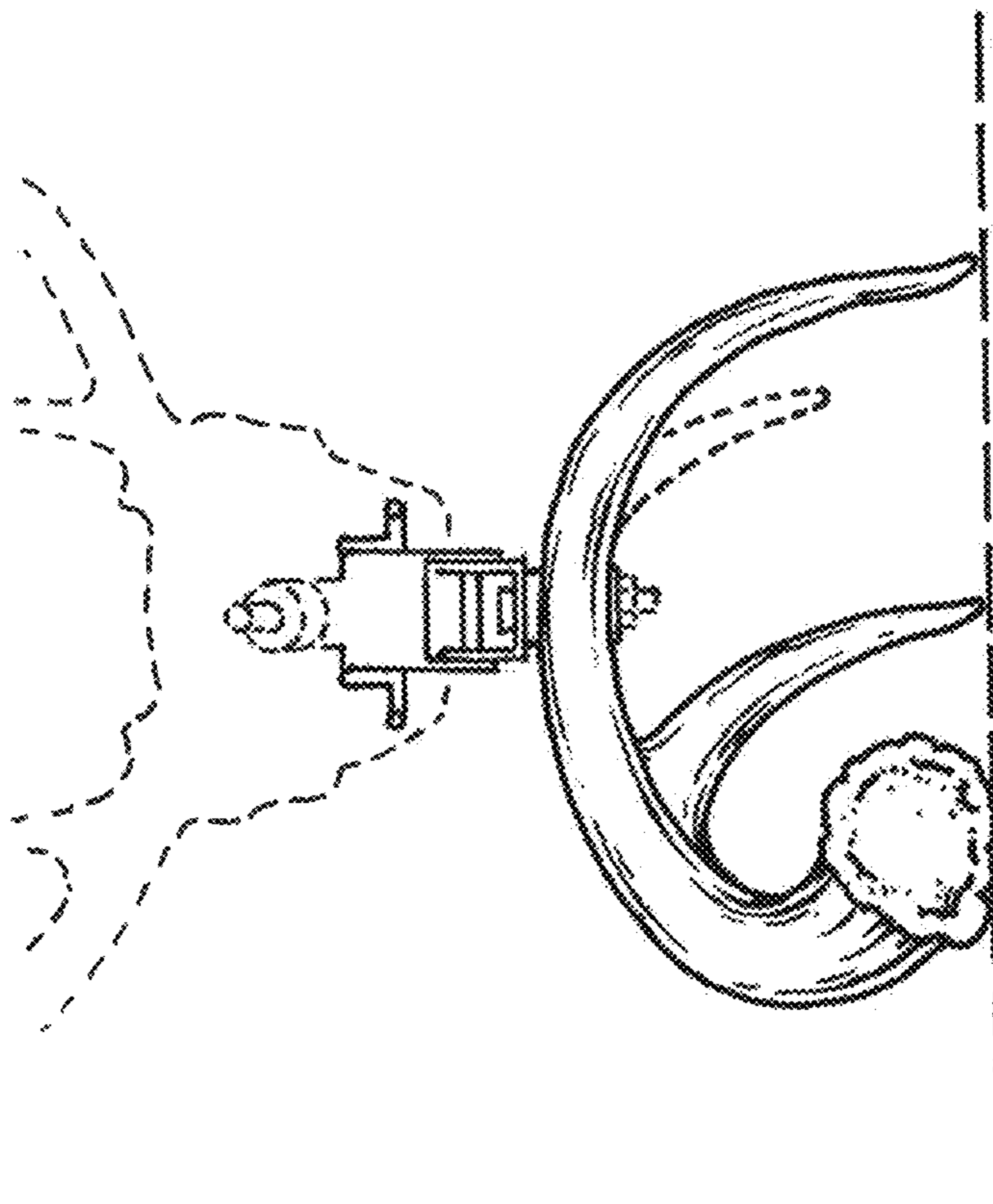

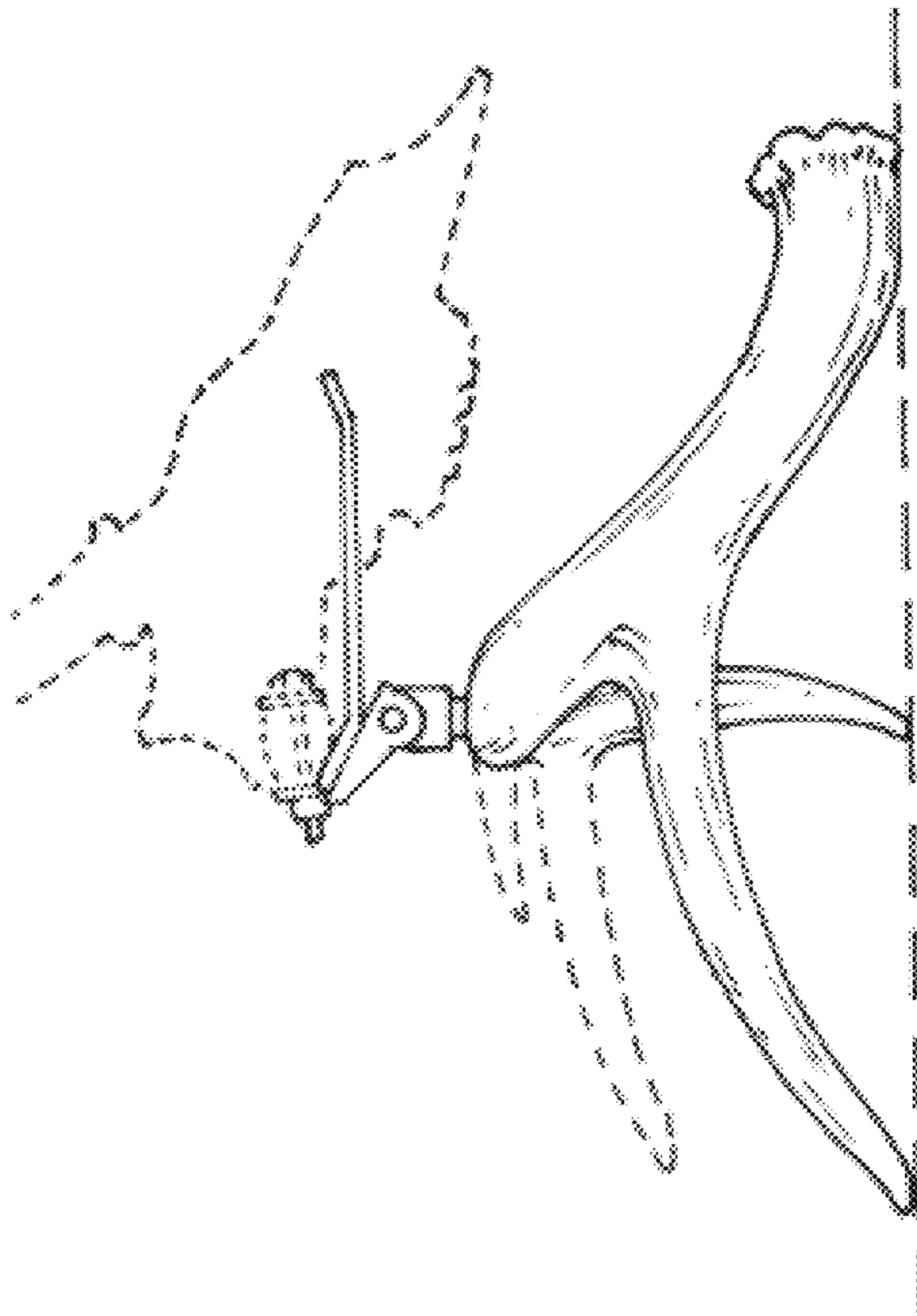

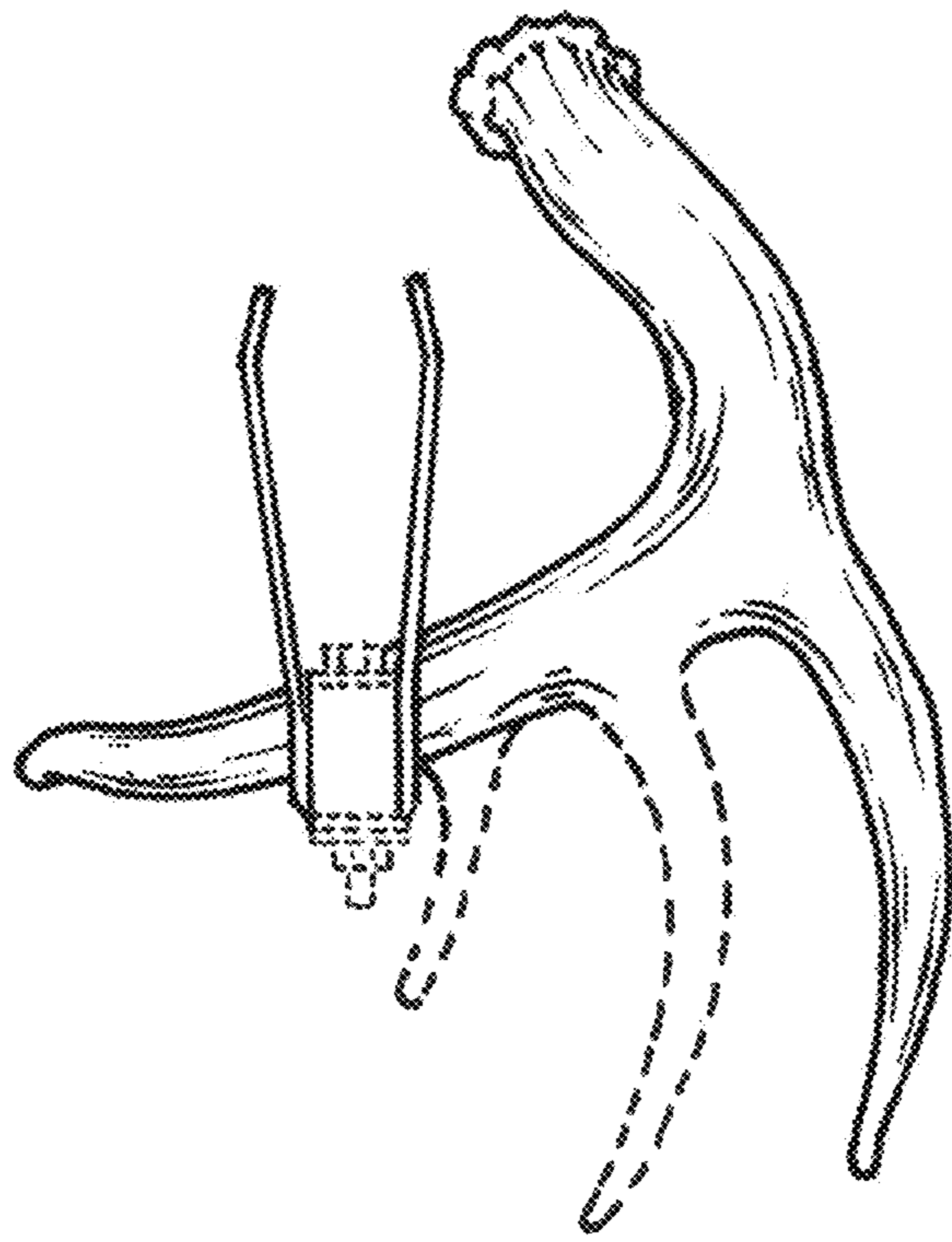

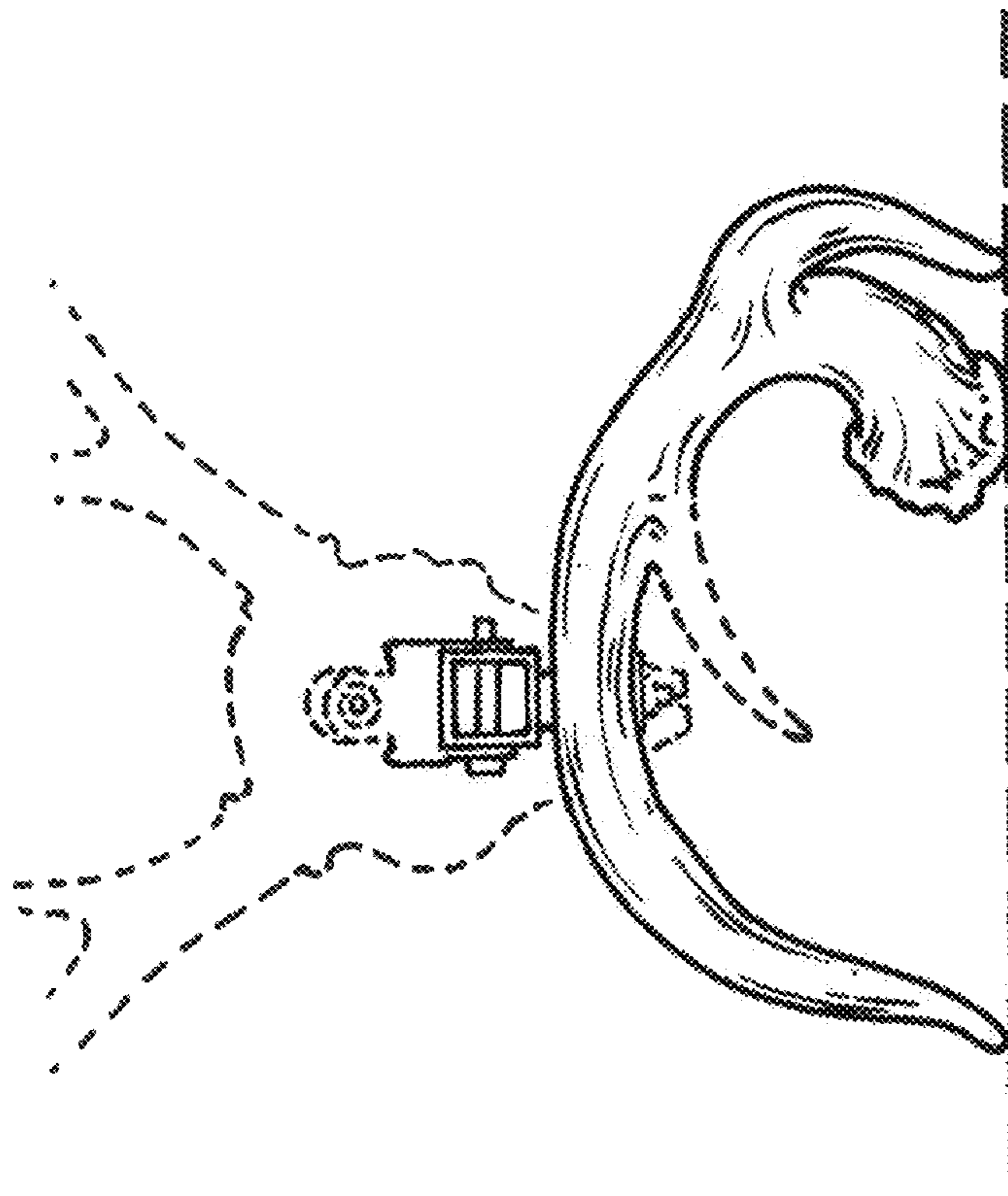

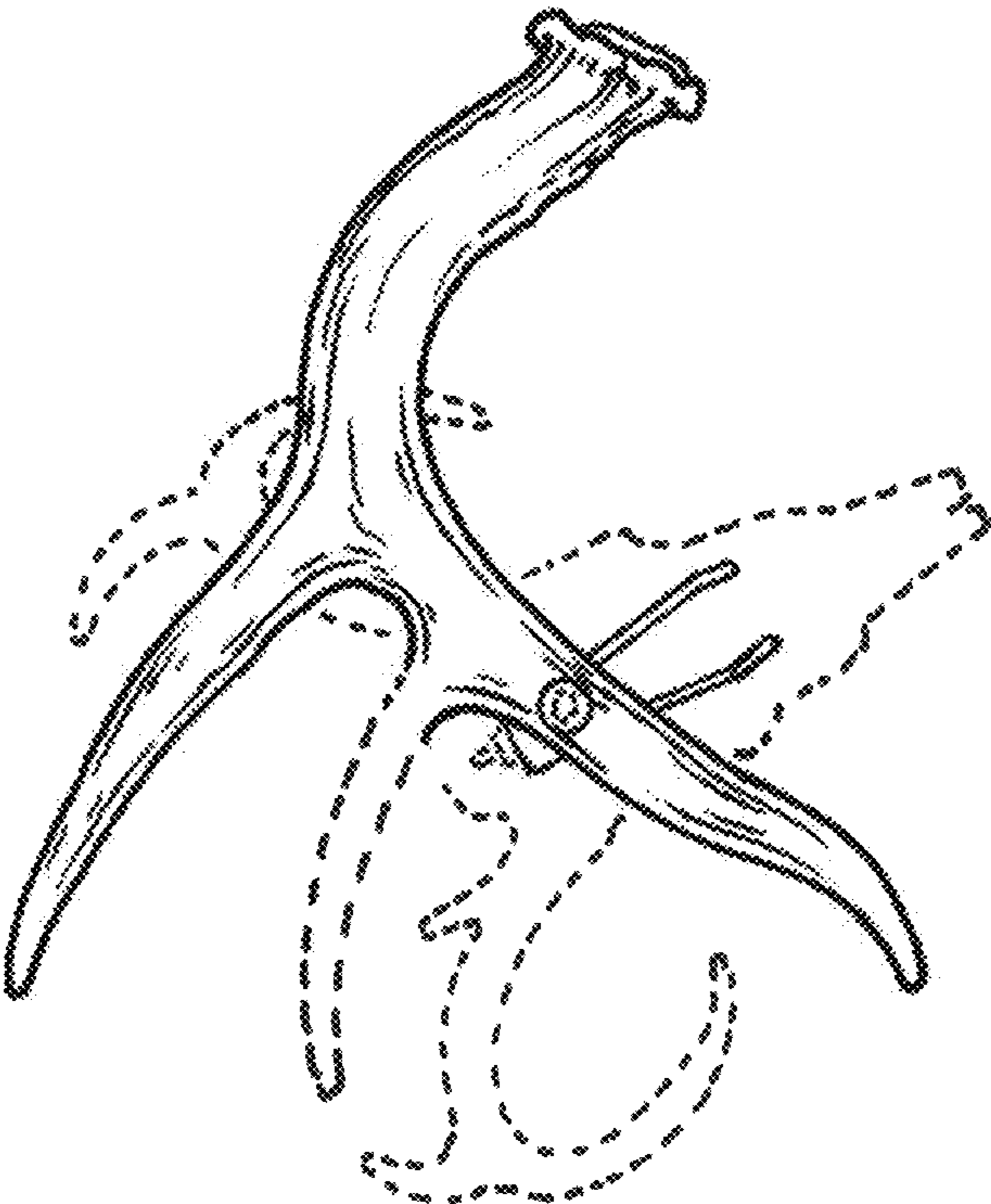

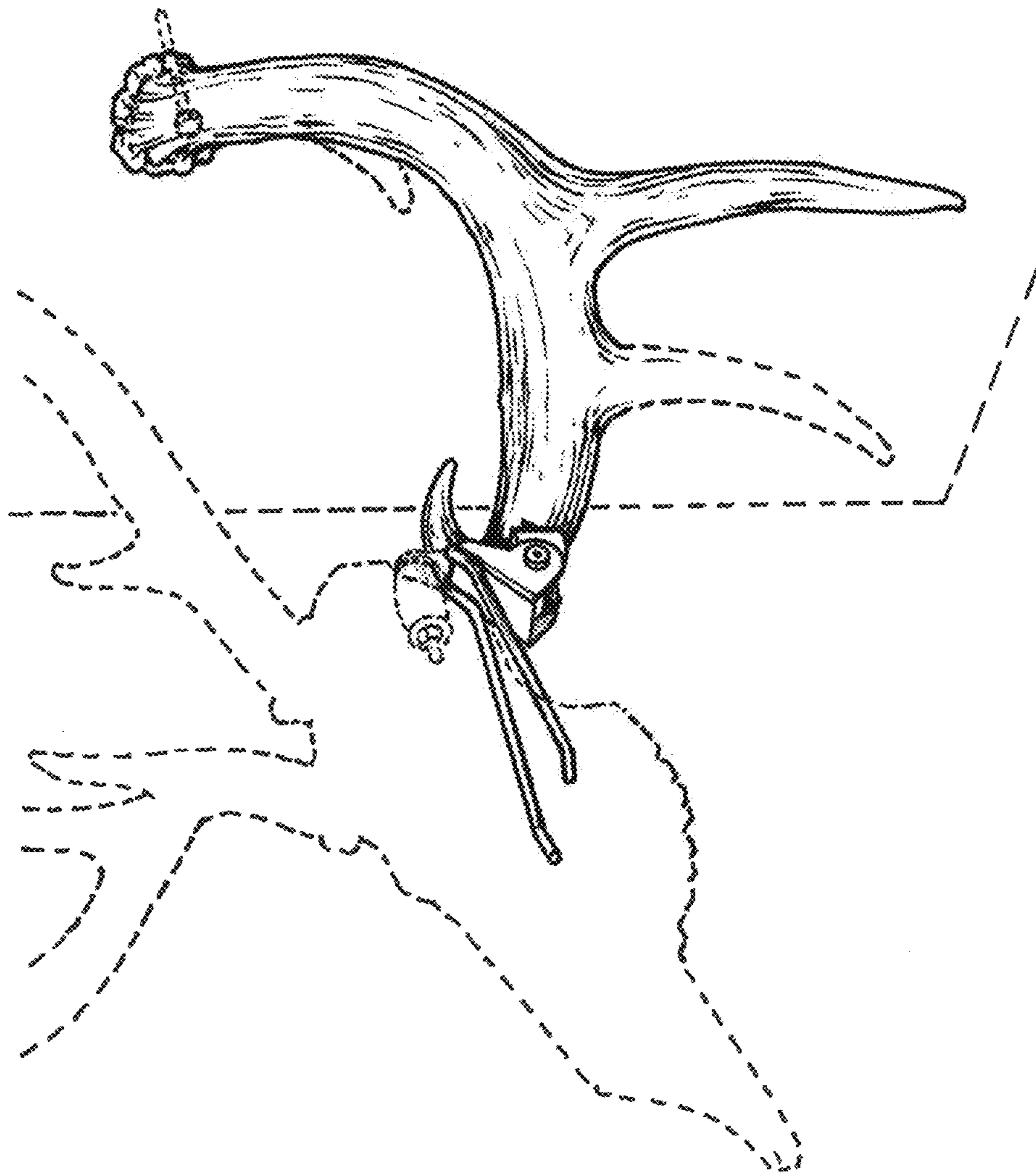
