FIG. 5 is a top view of the camelot lock escutcheon; and,

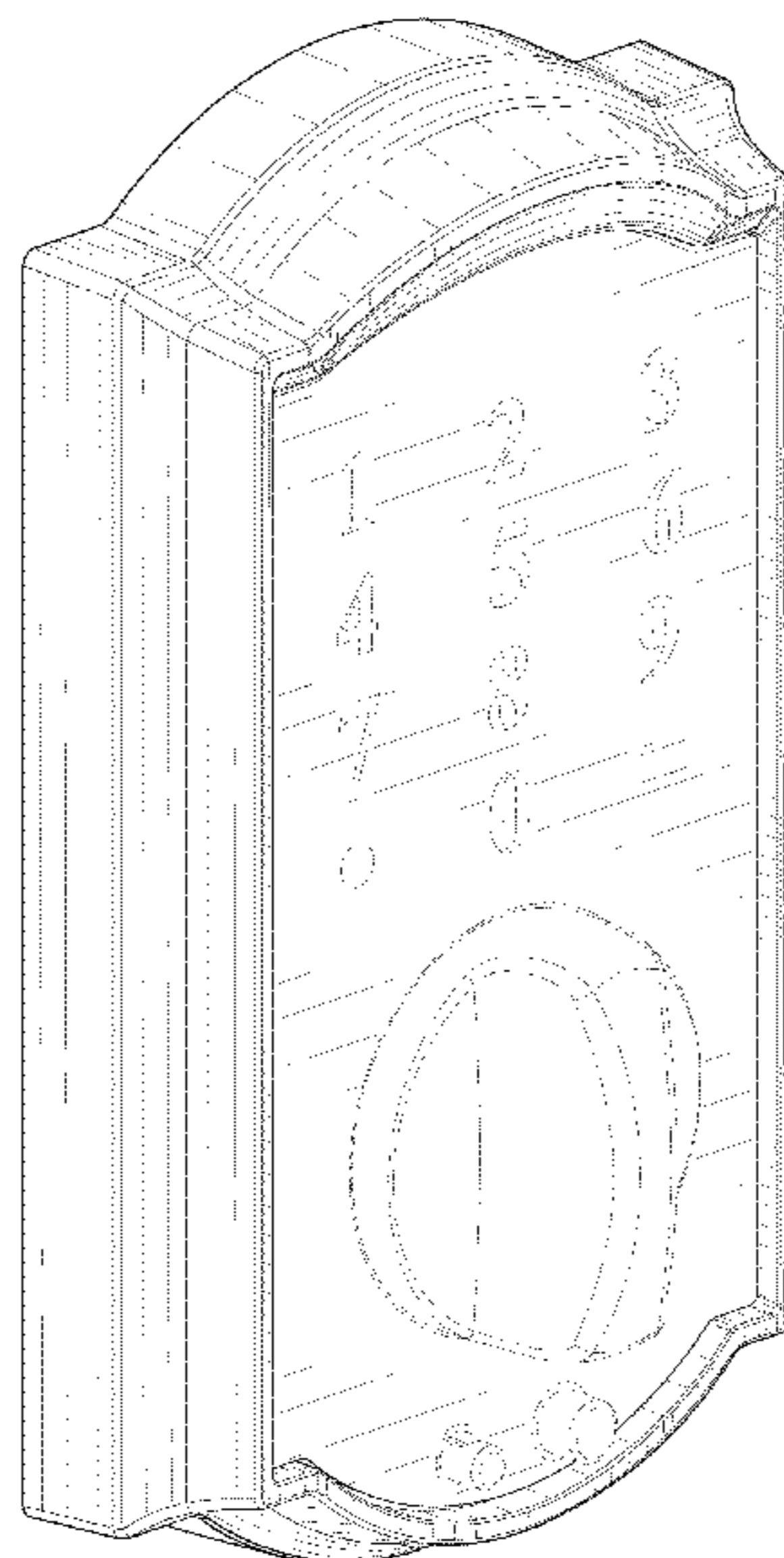
FIG. 6 is a bottom view of the camelot lock escutcheon.

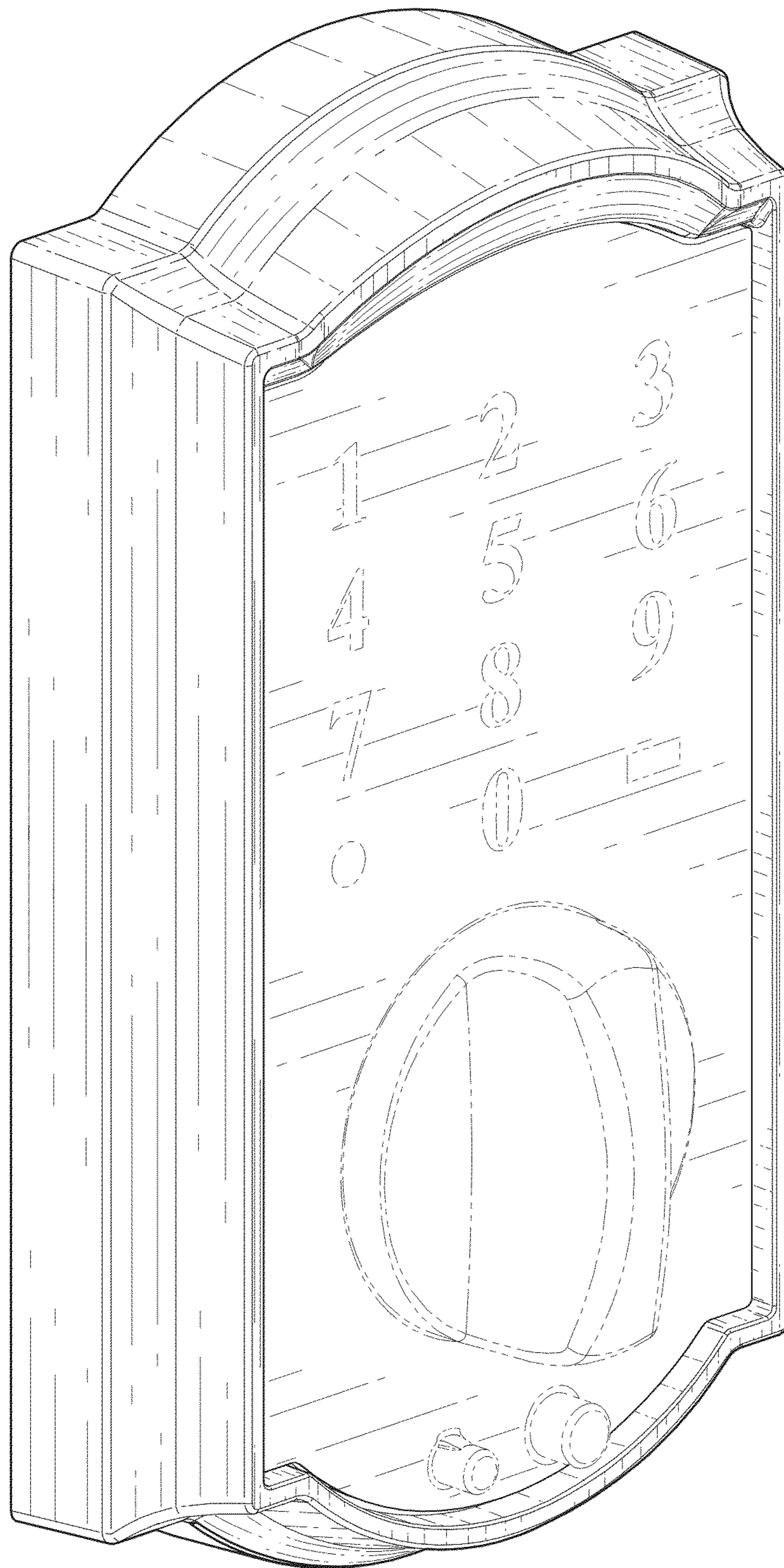
The broken lines are for the purpose of showing exemplary indicia and hardware associated with the camelot lock escutcheon, and they form no part of the claimed design.

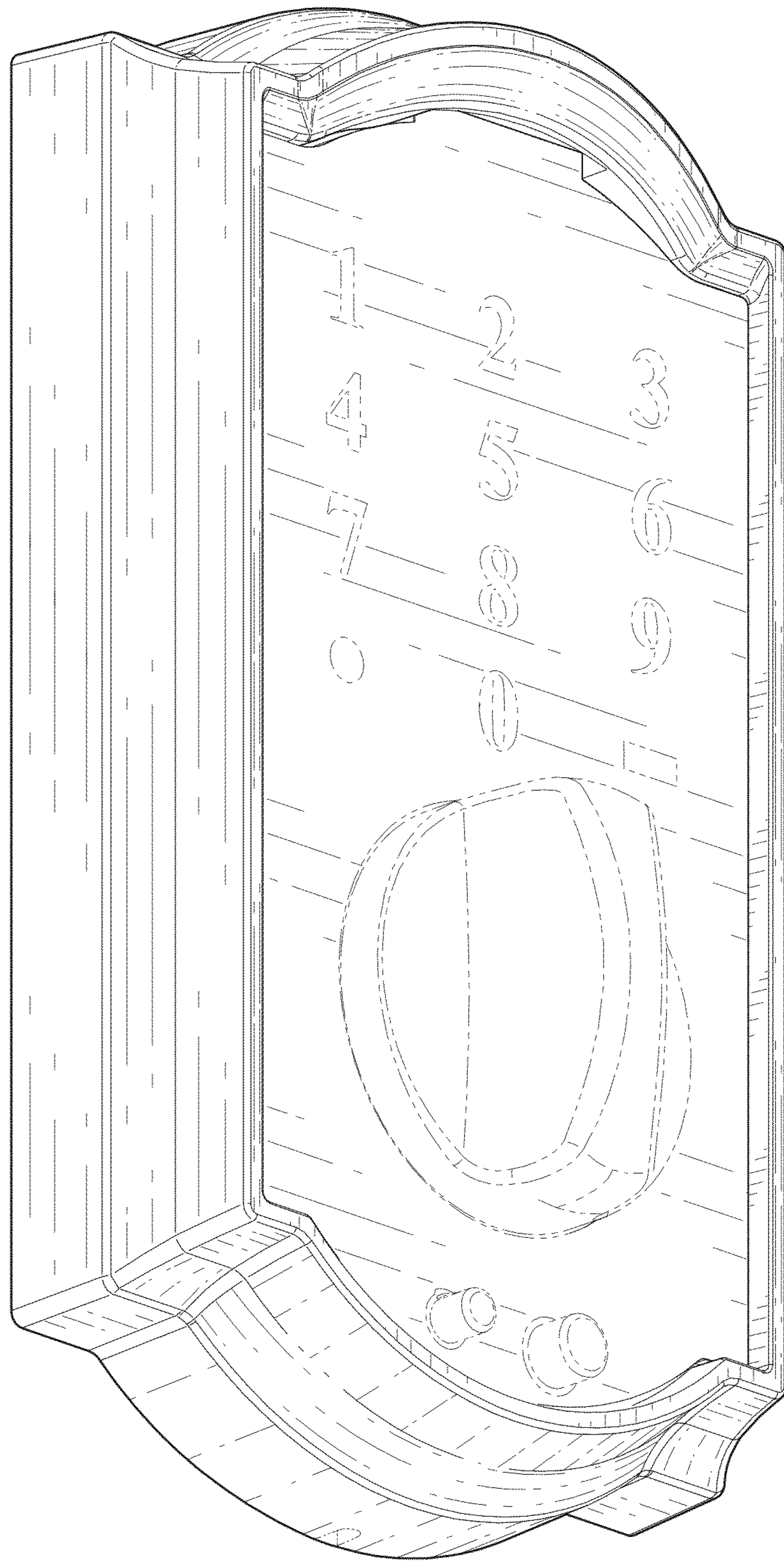

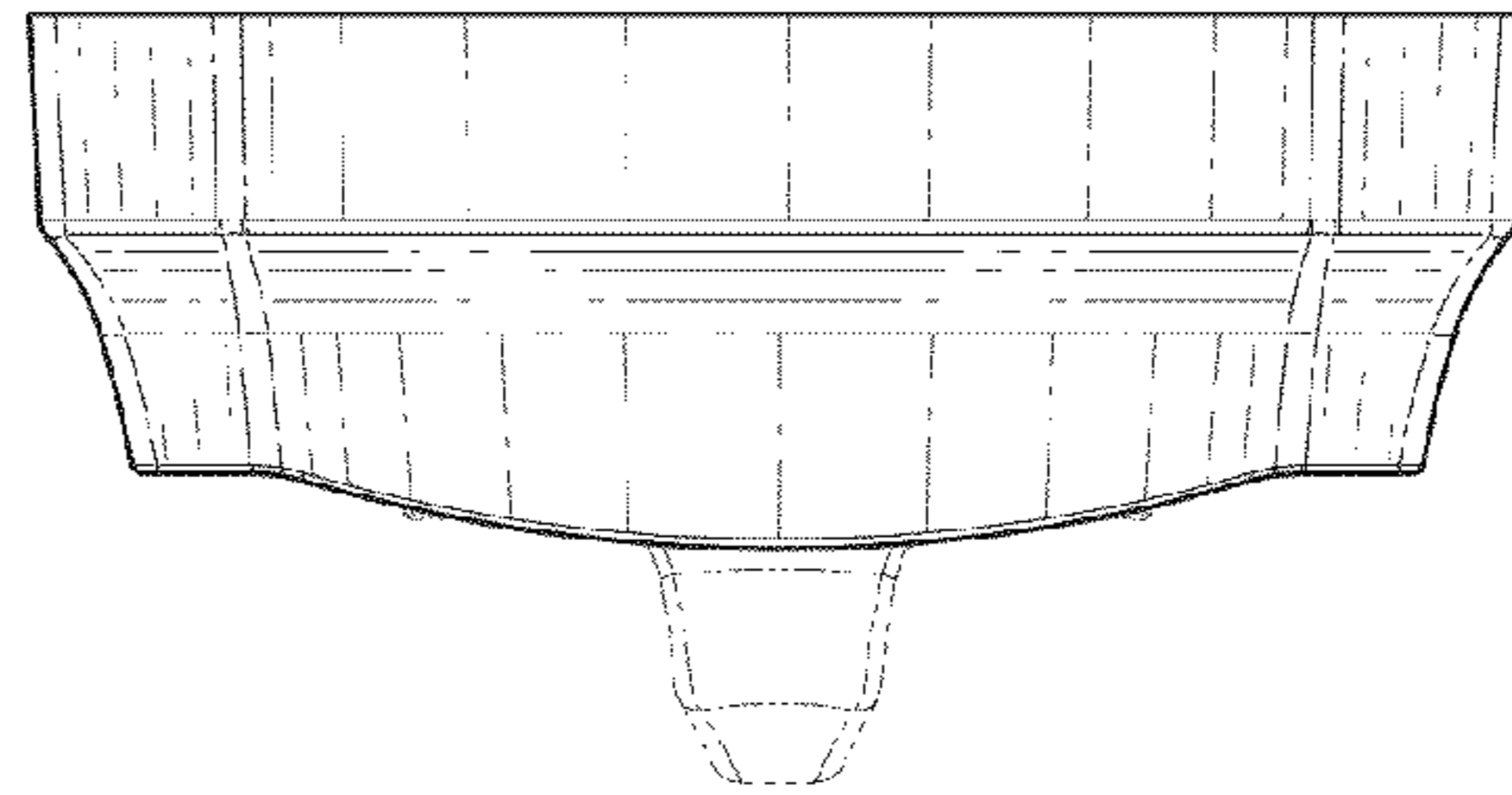




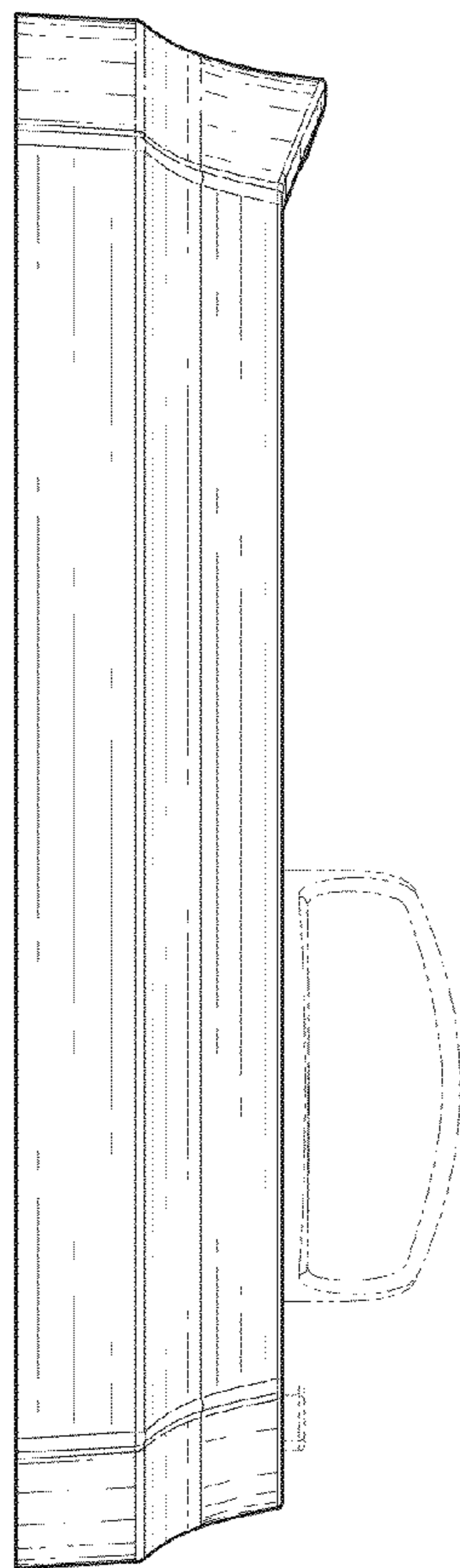

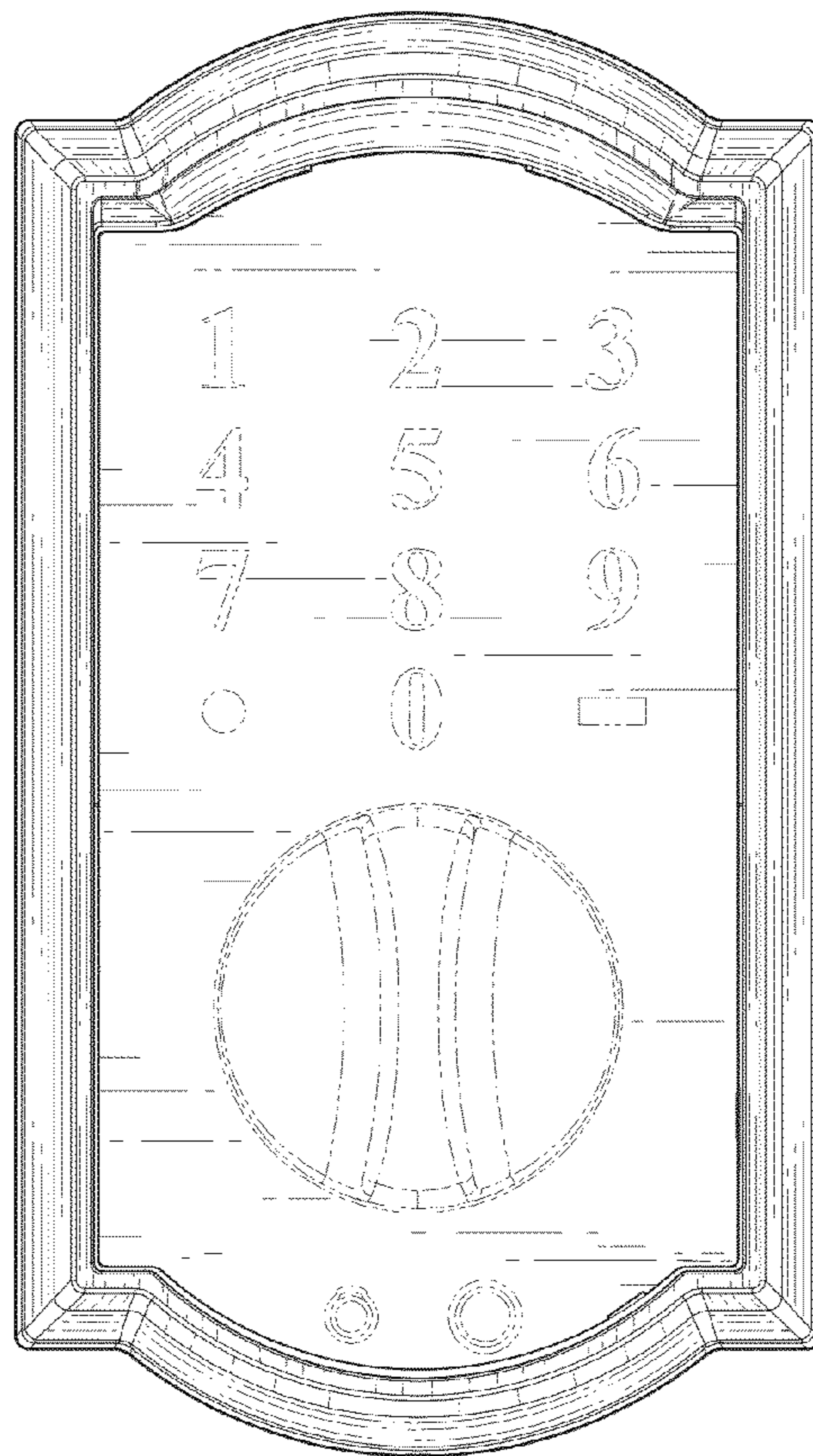

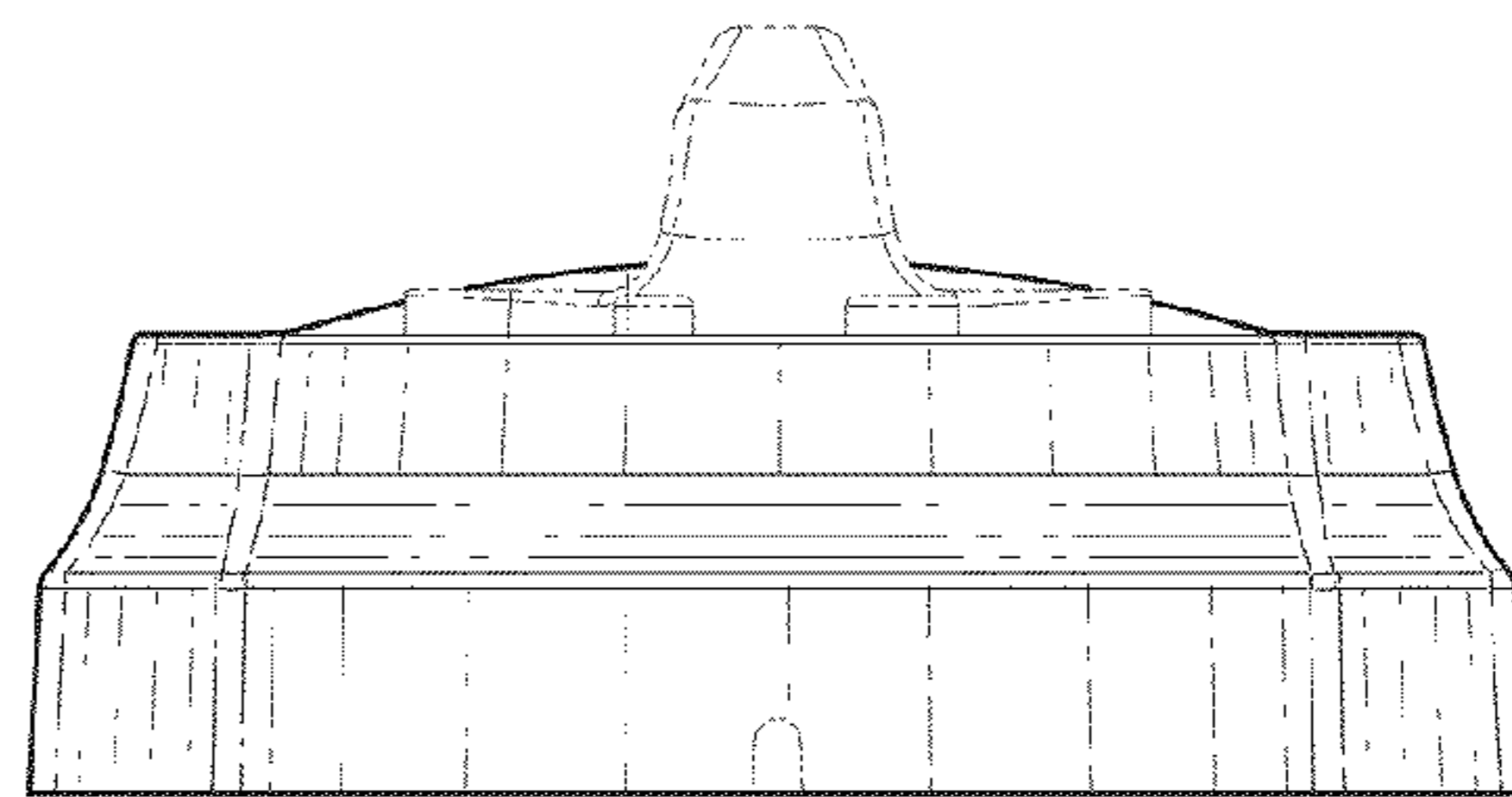
