The ornamental design for a plastic container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a plastic container showing our new design;

FIG. 4 is a left side elevational view of FIG. 1;

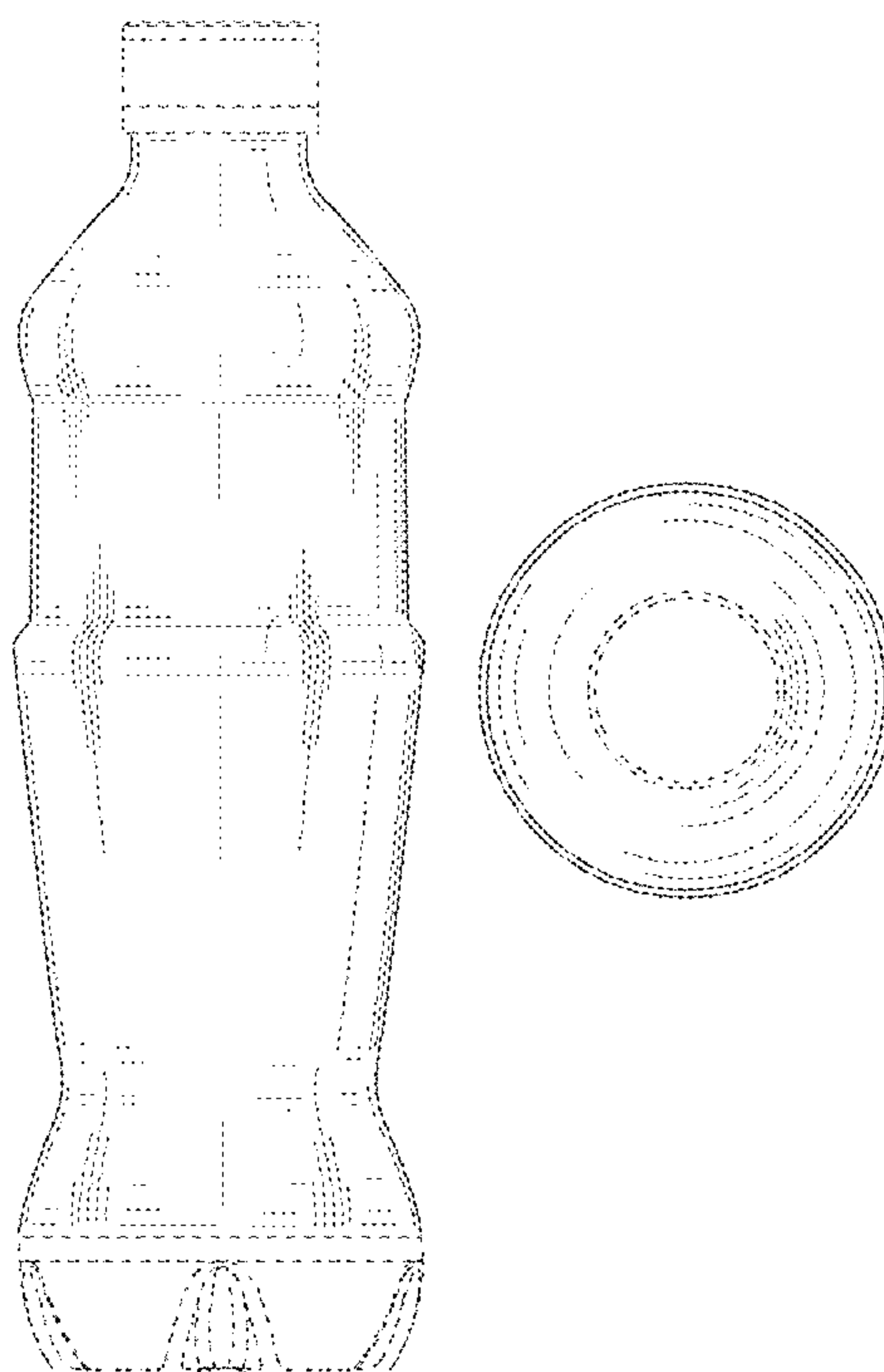
FIG. 5 is a right side elevational view of FIG. 1;

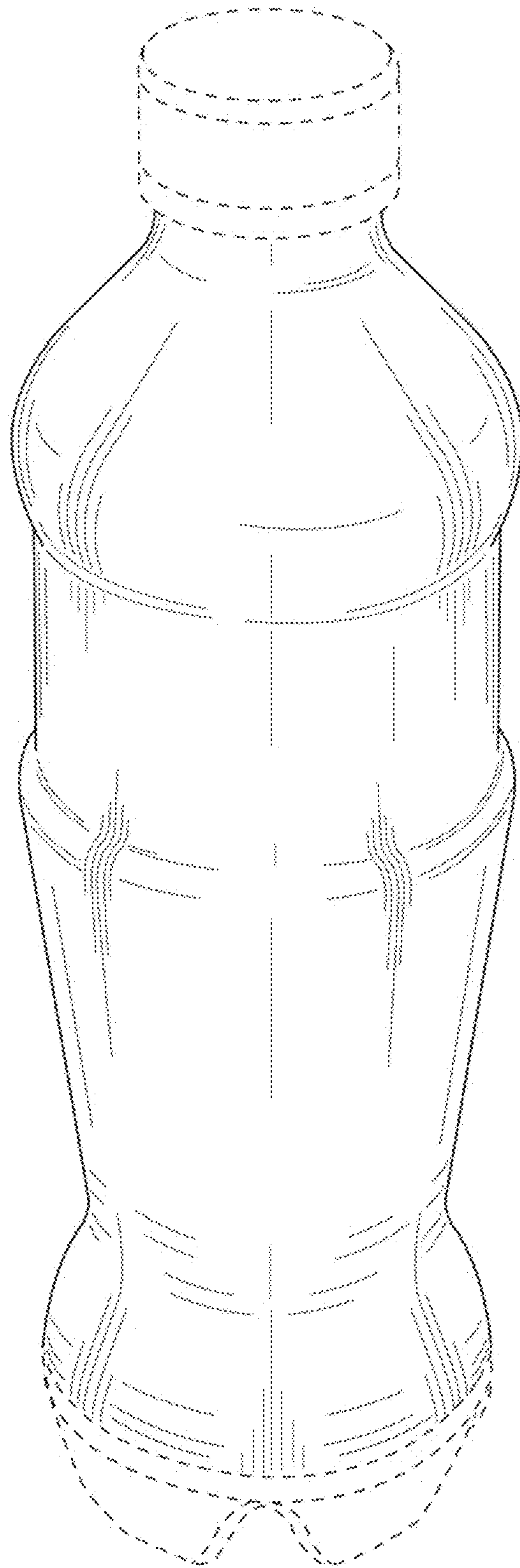

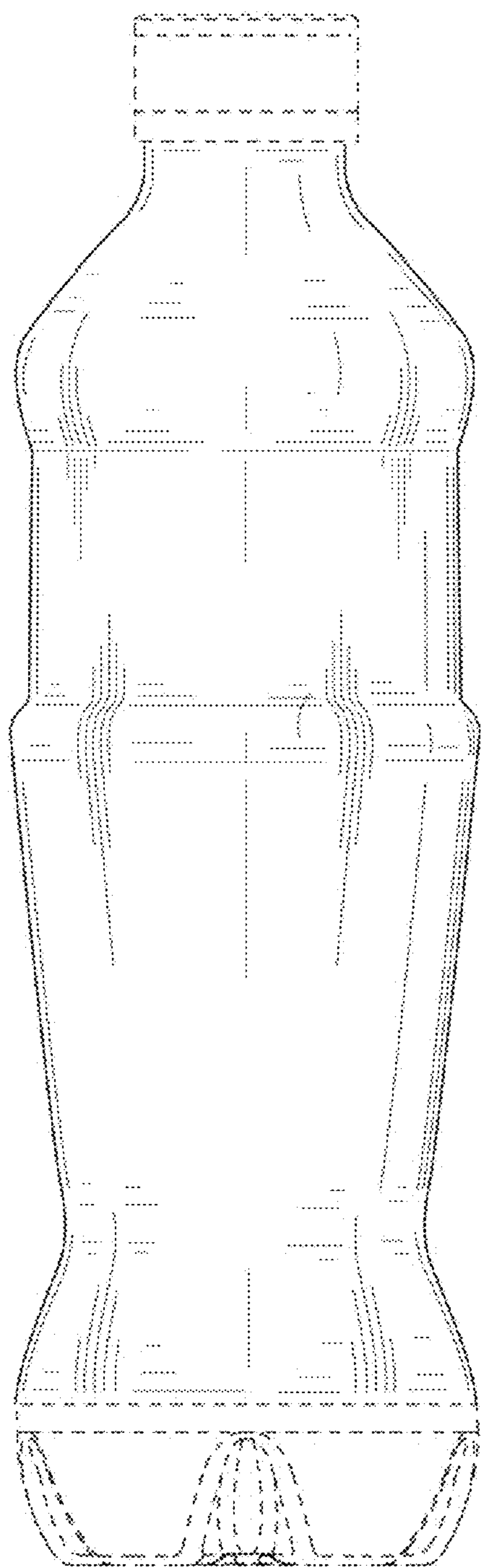

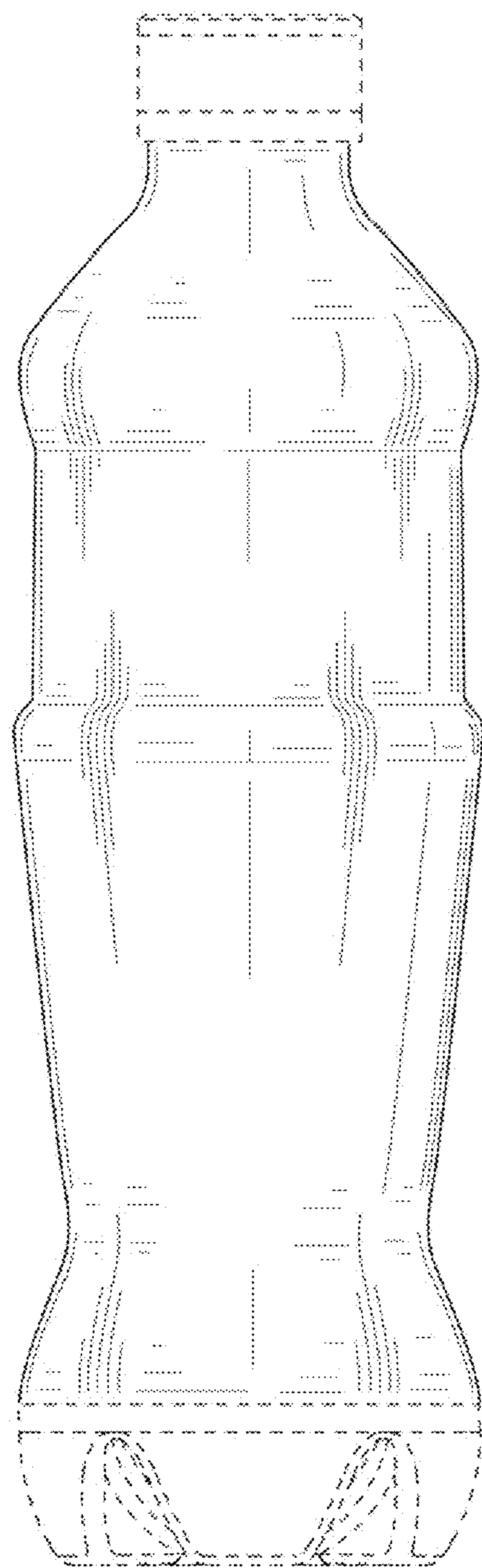

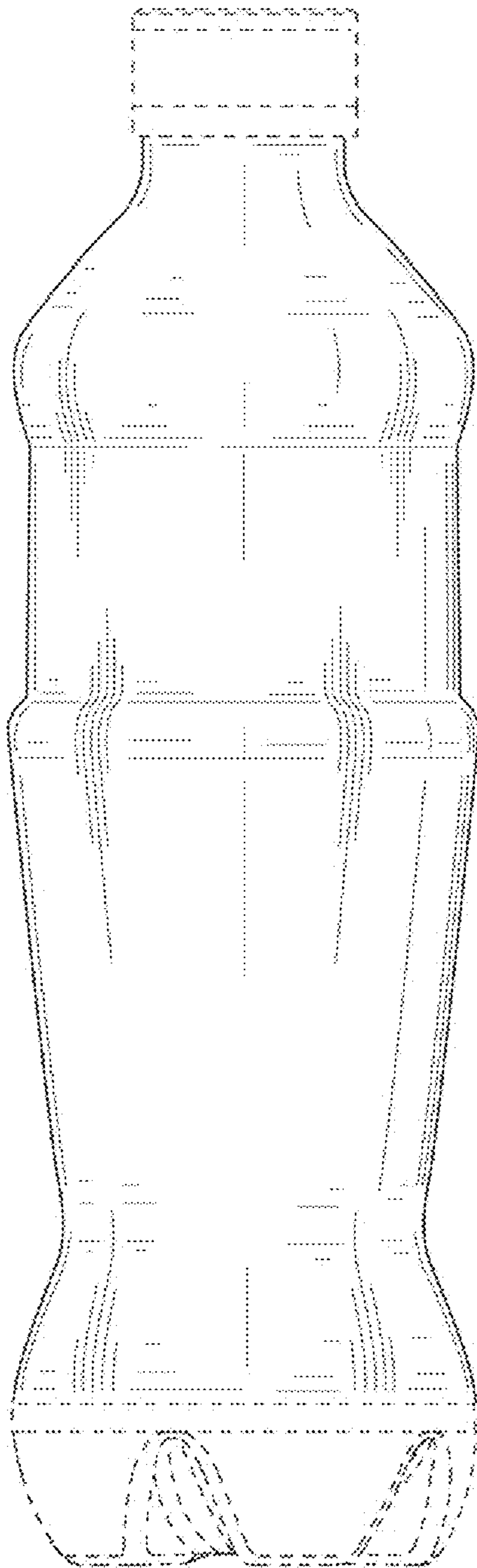

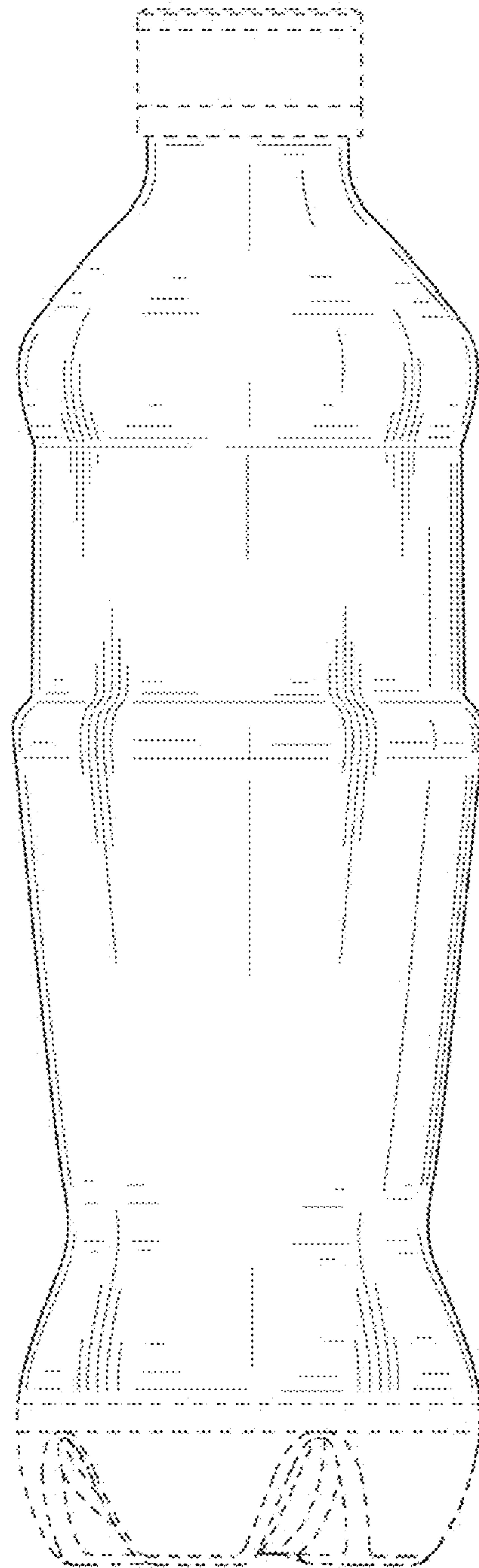

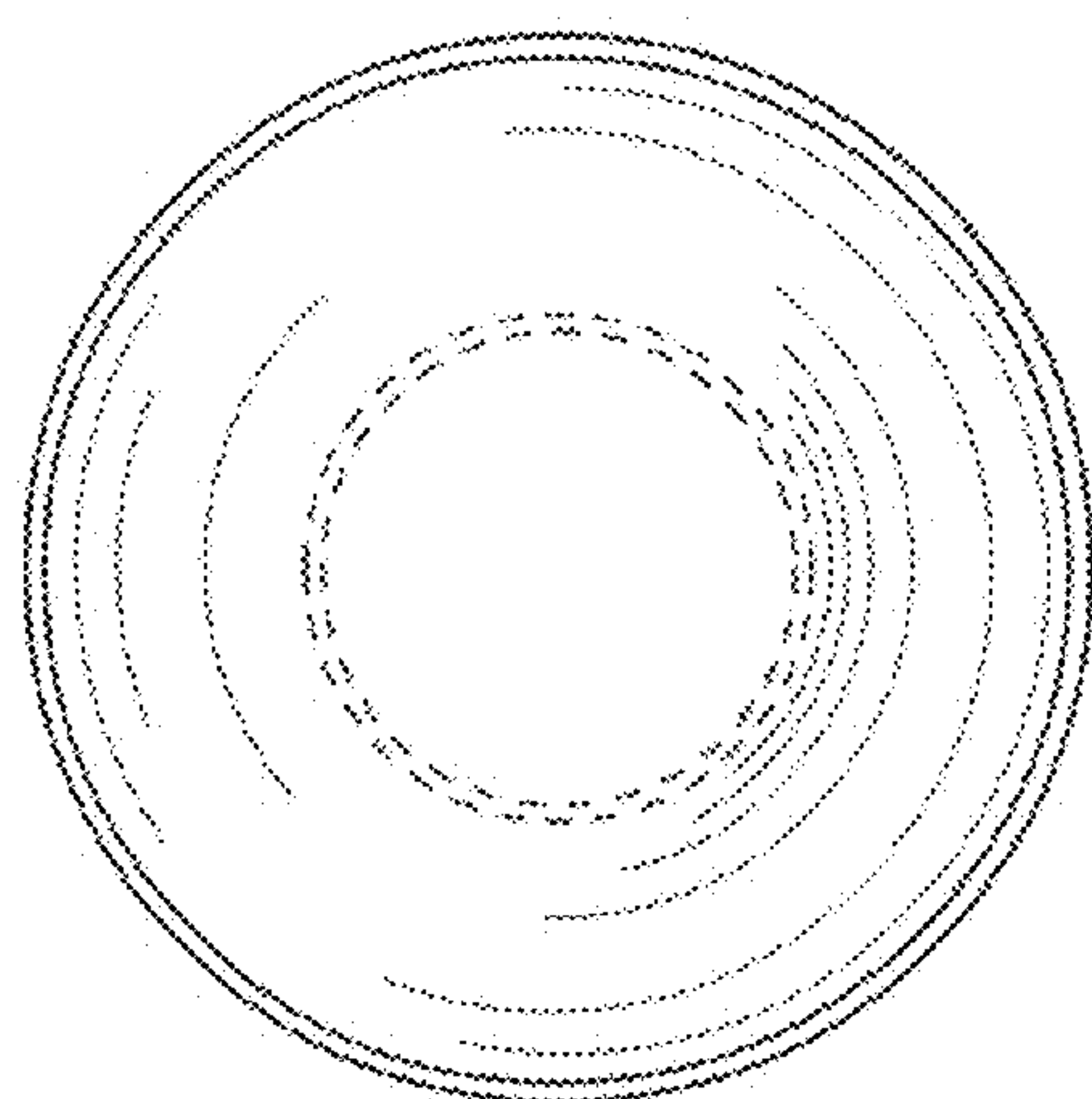

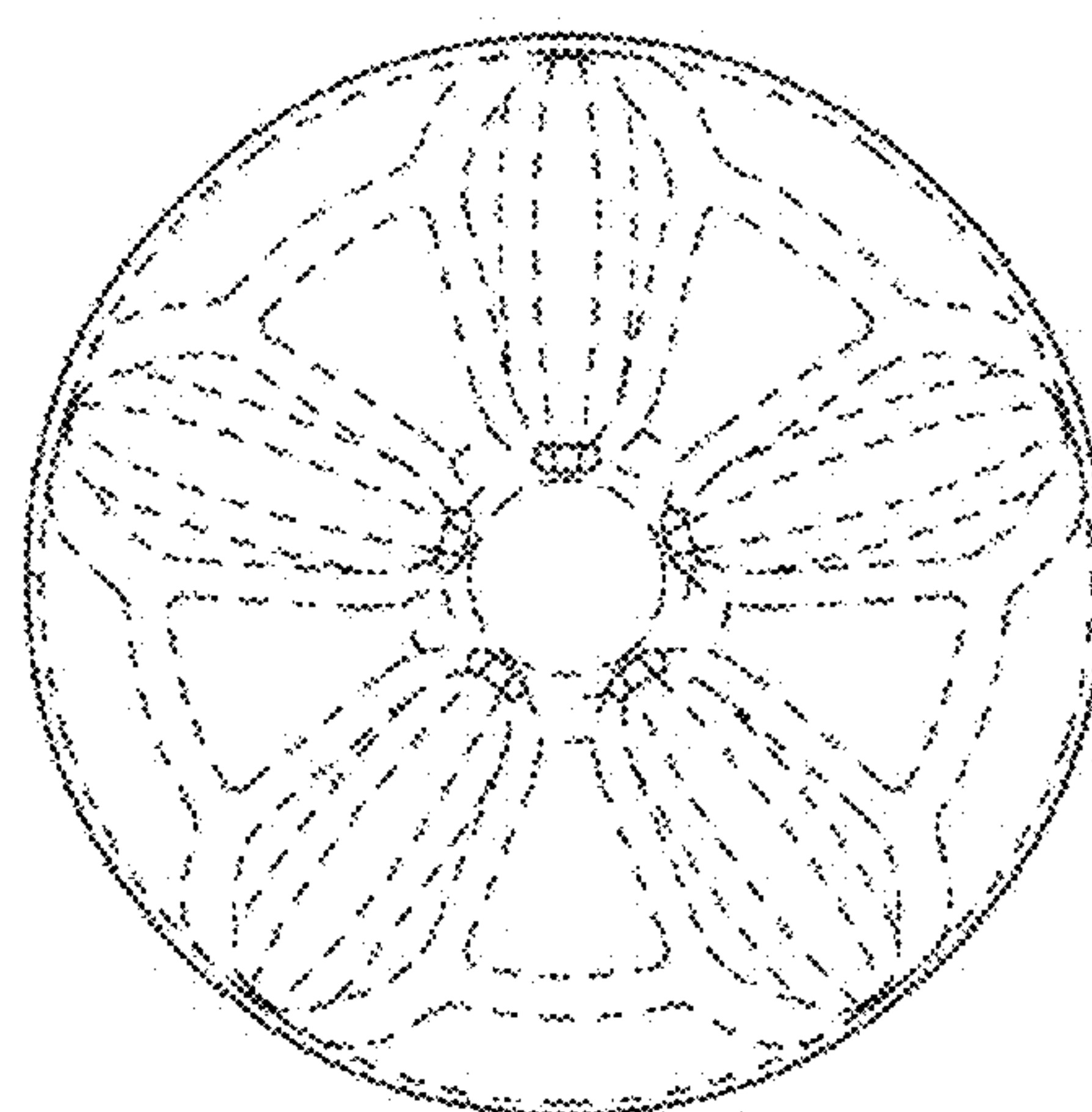
