(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

This application is related to co-pending application 29/453,035 filed Apr. 24, 2013, titled “Klear Solutions Bottle” and to co-pending application 29/453,063 filed Apr. 24, 2013, titled “Bottle” and to co-pending application 29/461,302 filed Jul. 22, 2013, titled “Bottle.”

FIG. 1 is a front view of a bottle, showing my new design.

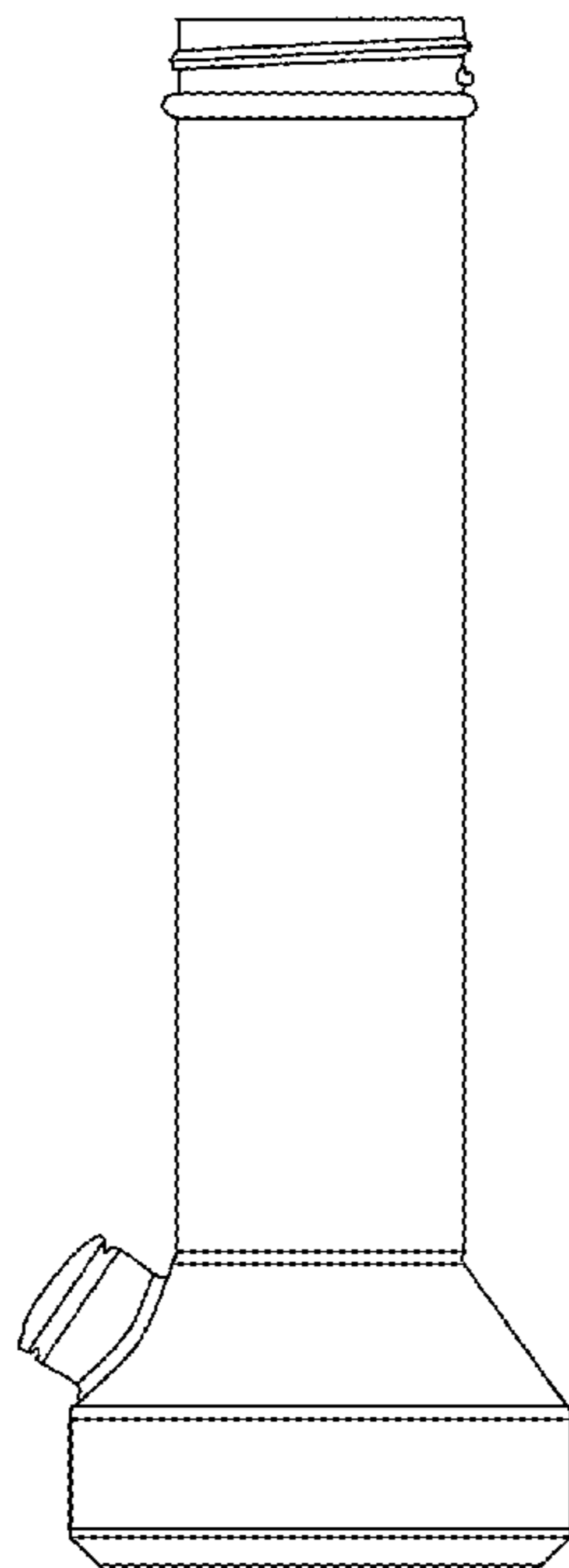
FIG. 2 is a top view of a bottle, thereof; and,

FIG. 3 is a bottom view of a bottle, thereof.

The claimed bottle is used for storing cleaning fluids and cleaning small parts.

The broken lines in FIG. 3 are included for the purpose of illustrating a portion of the bottom that forms no part of the claimed design.

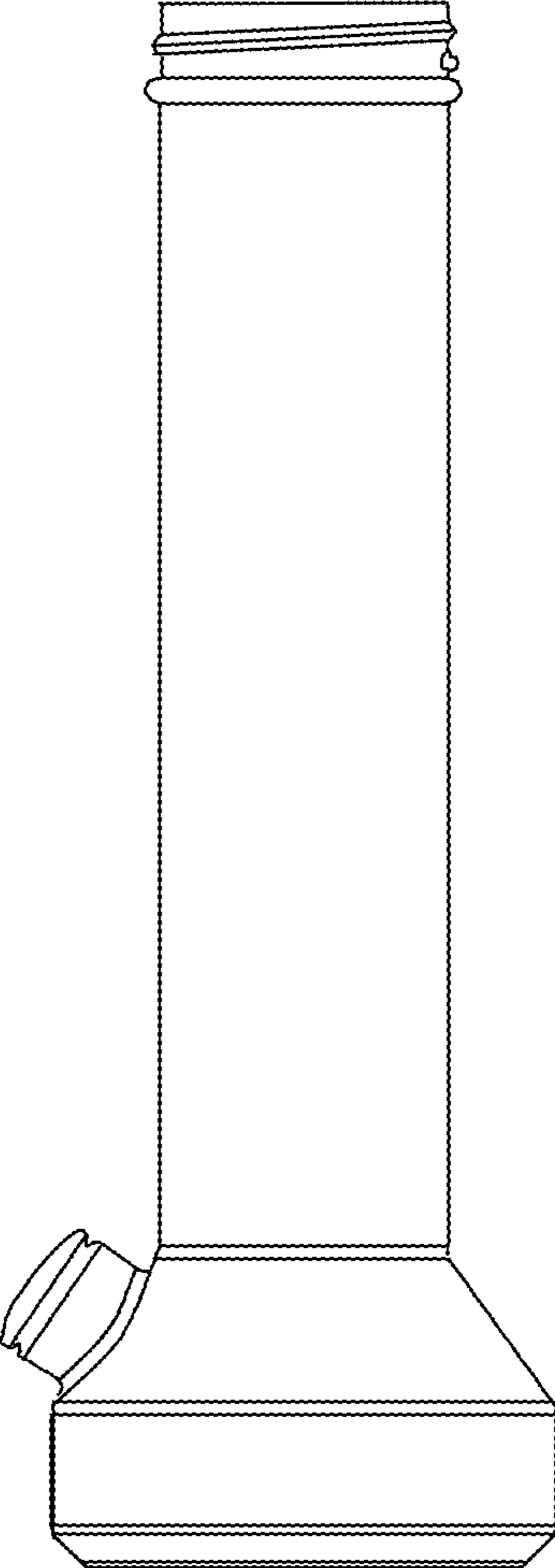

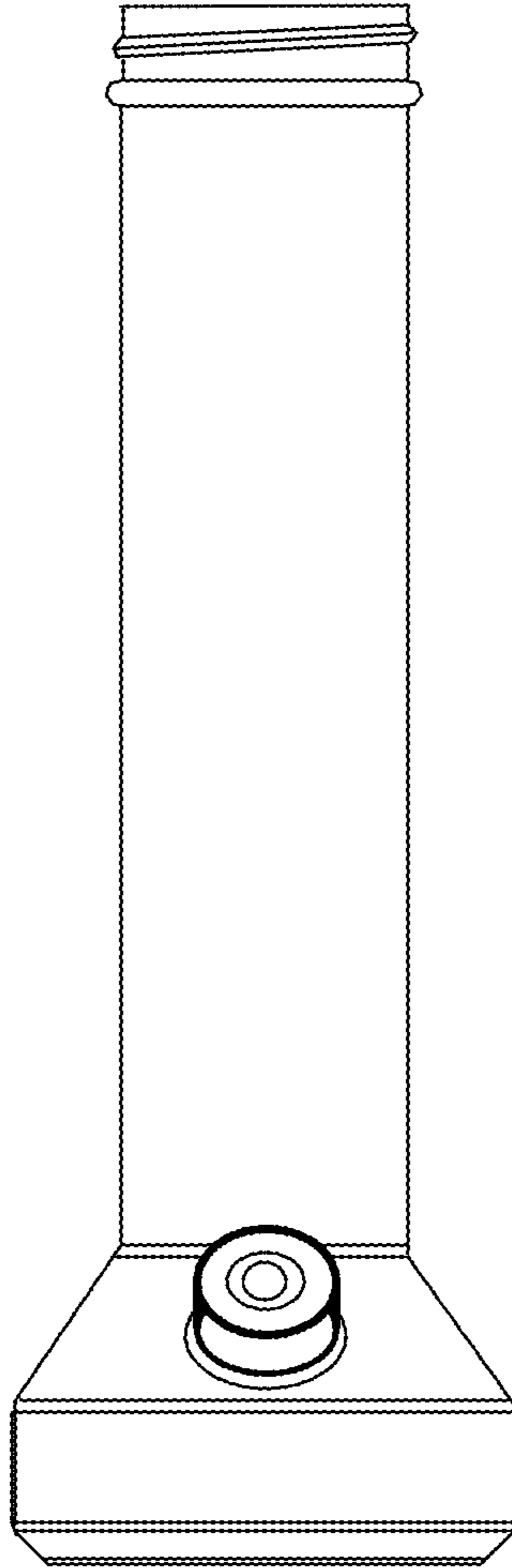

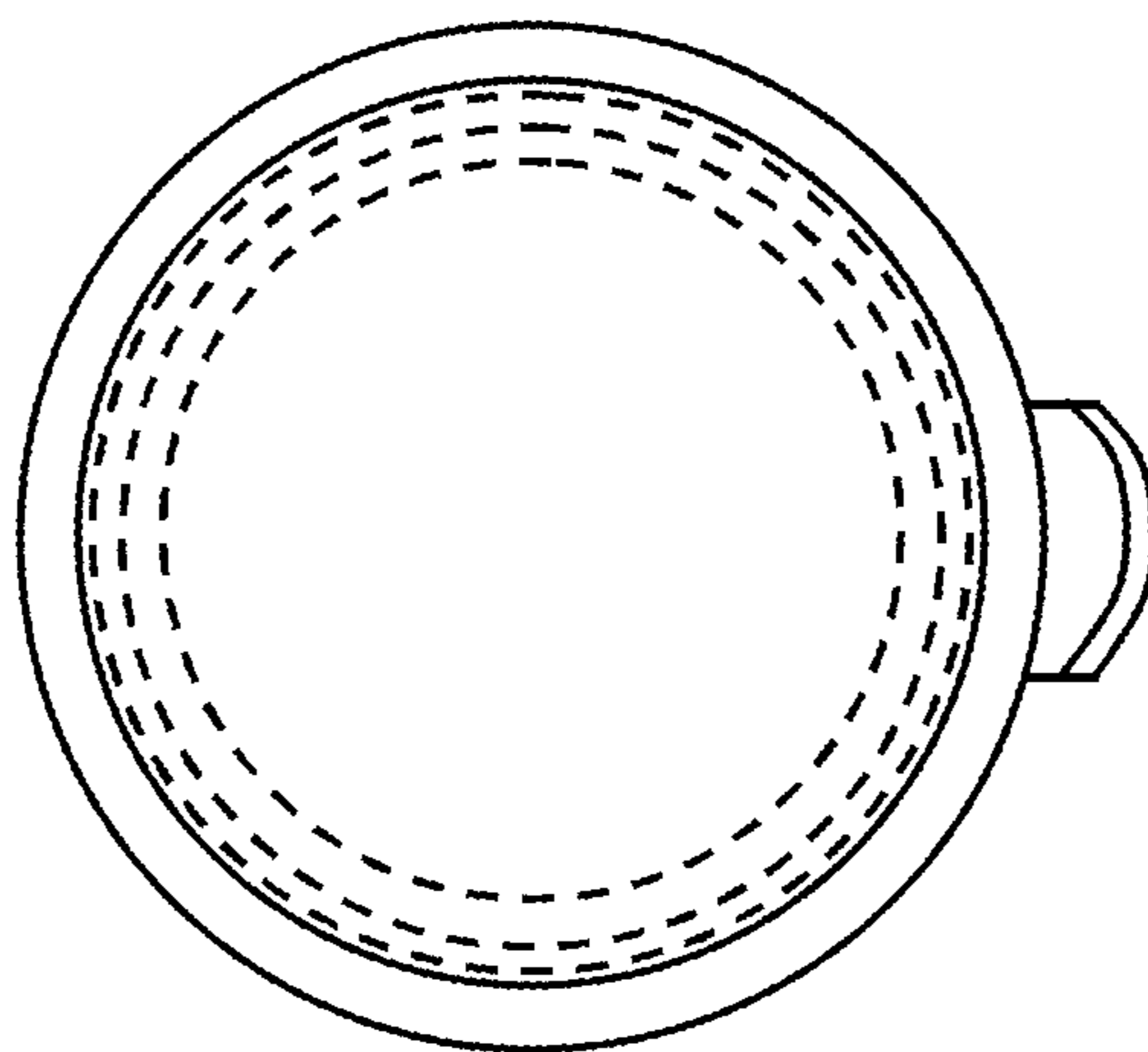
