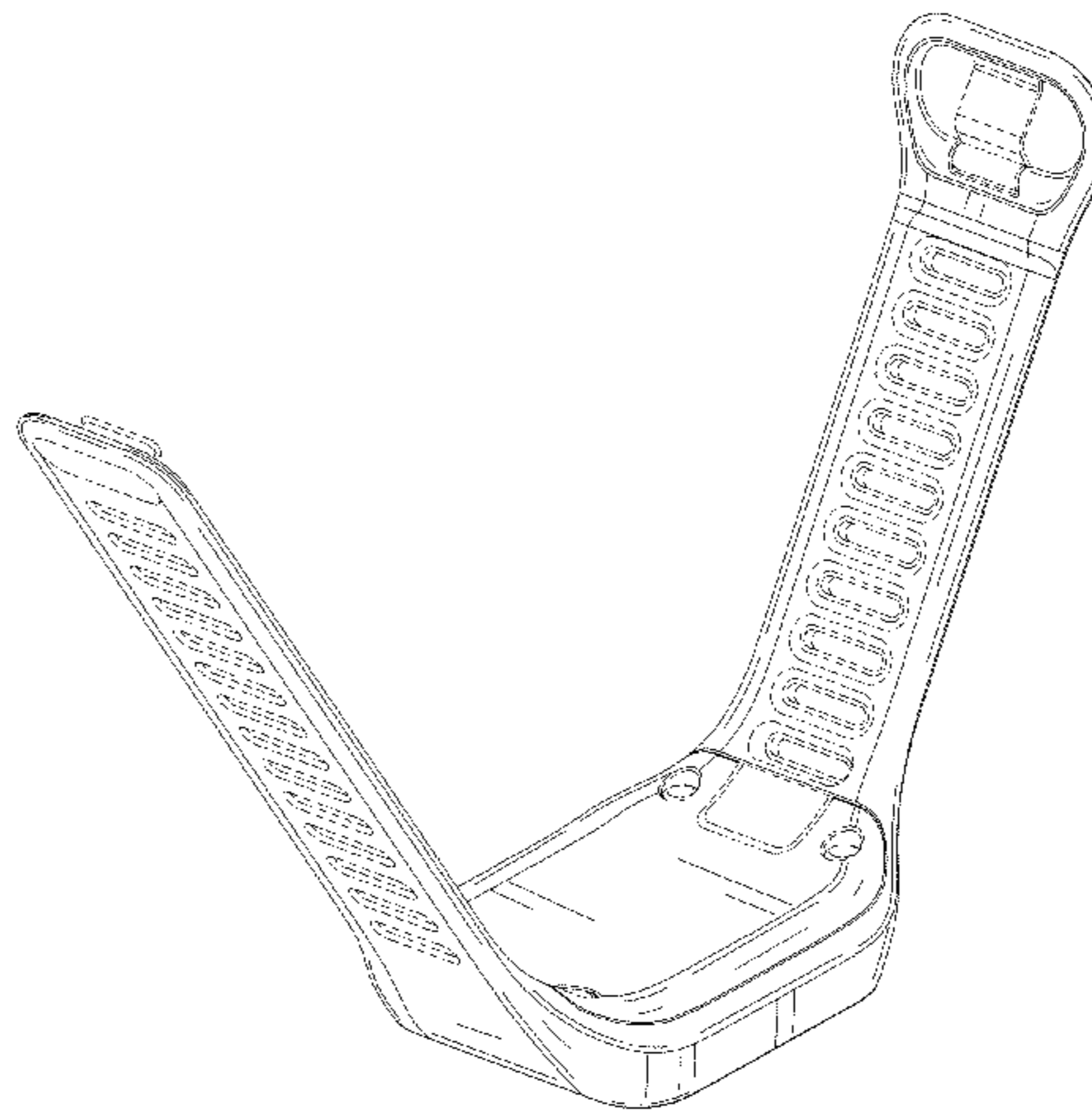
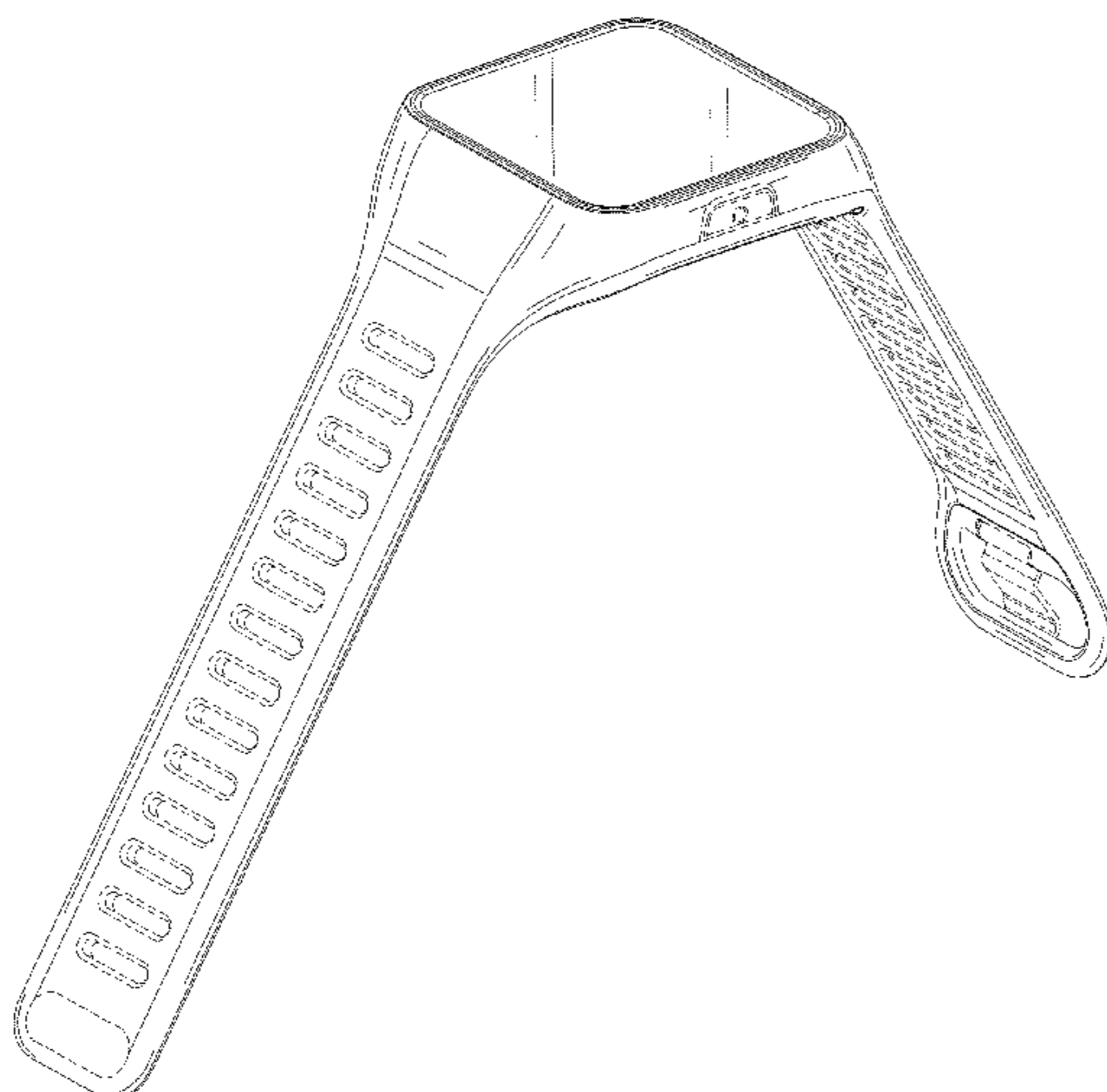
The ornamental design for a wrist-worn display, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wrist-worn display showing our new design;

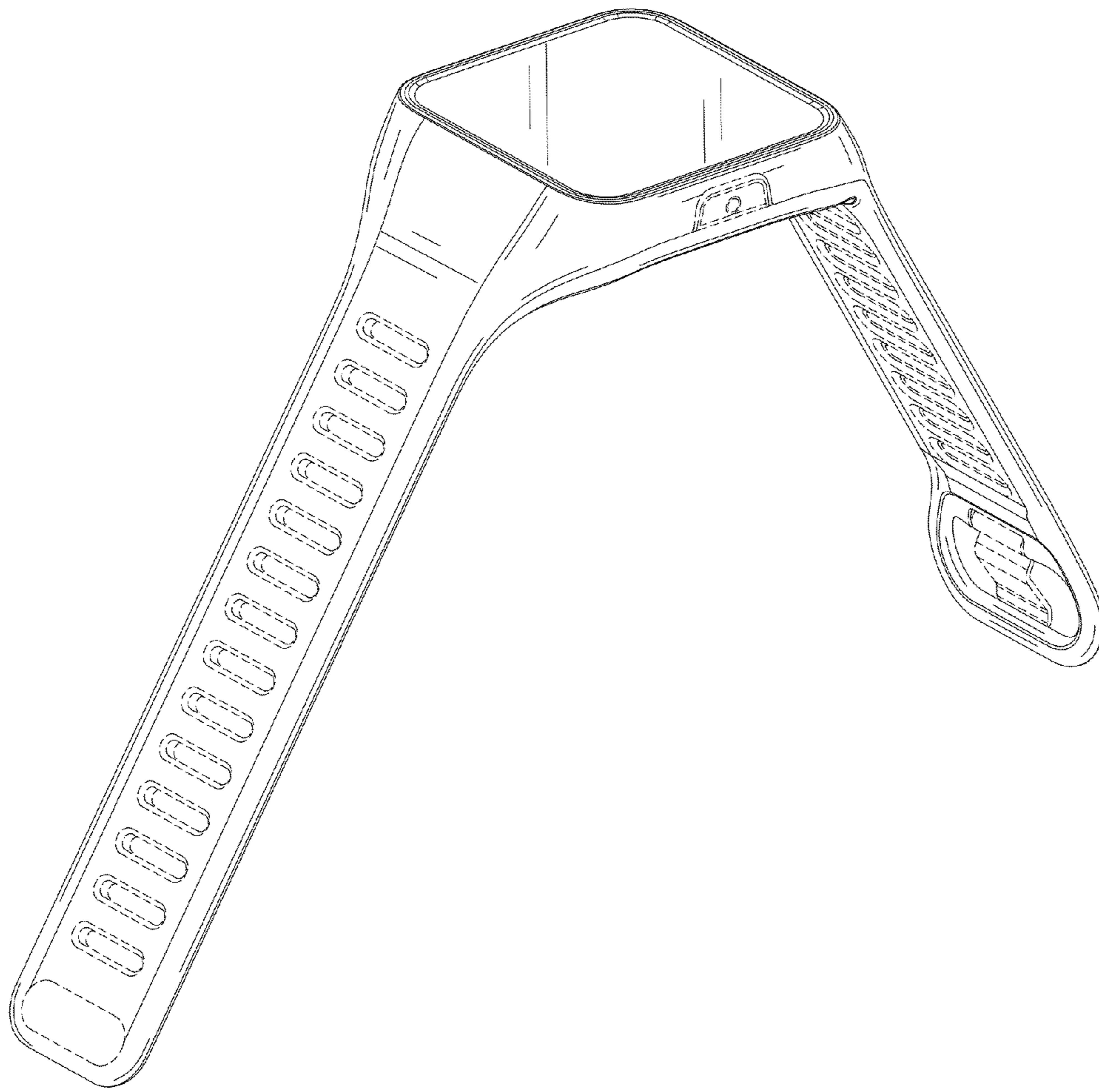

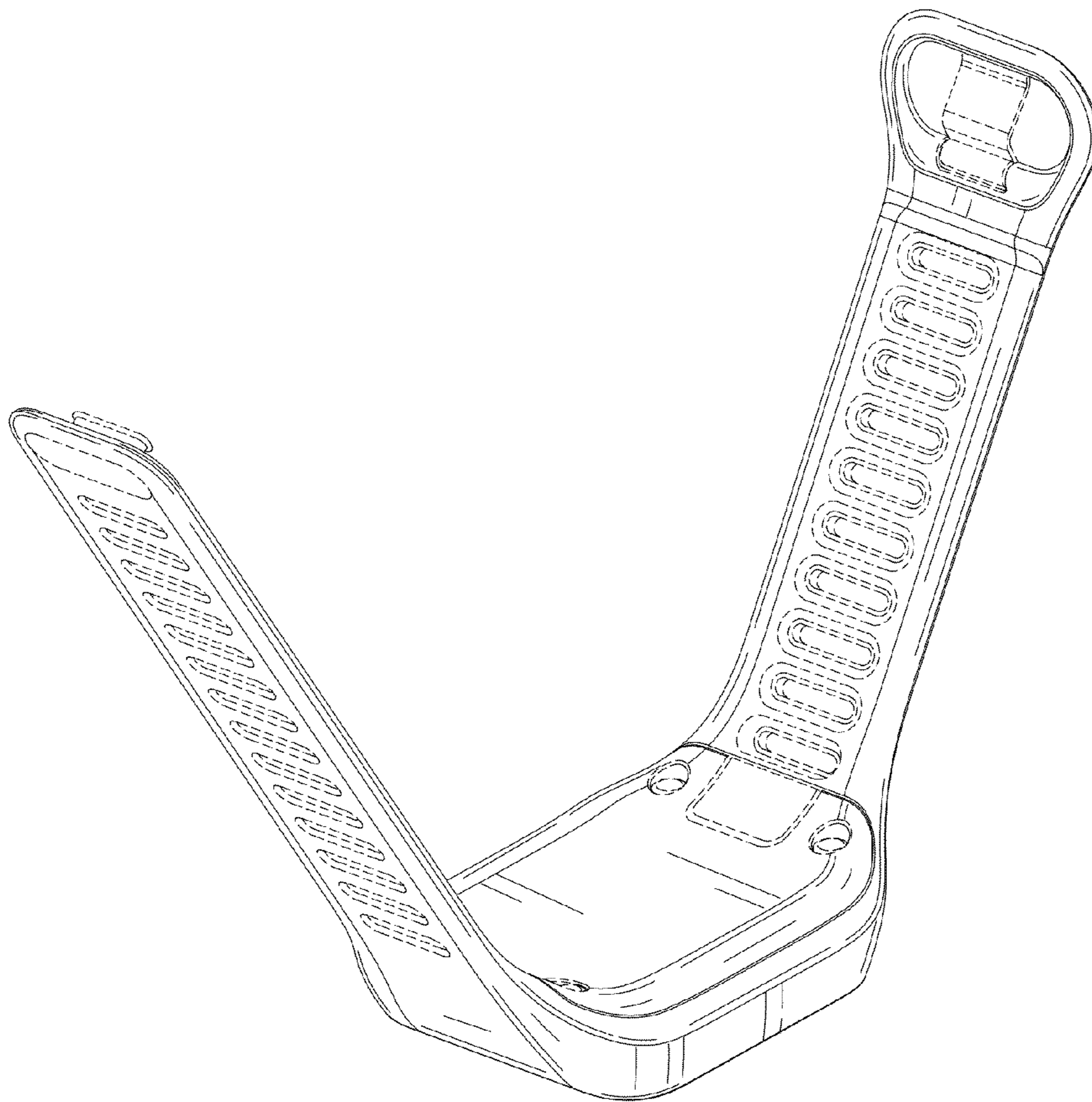

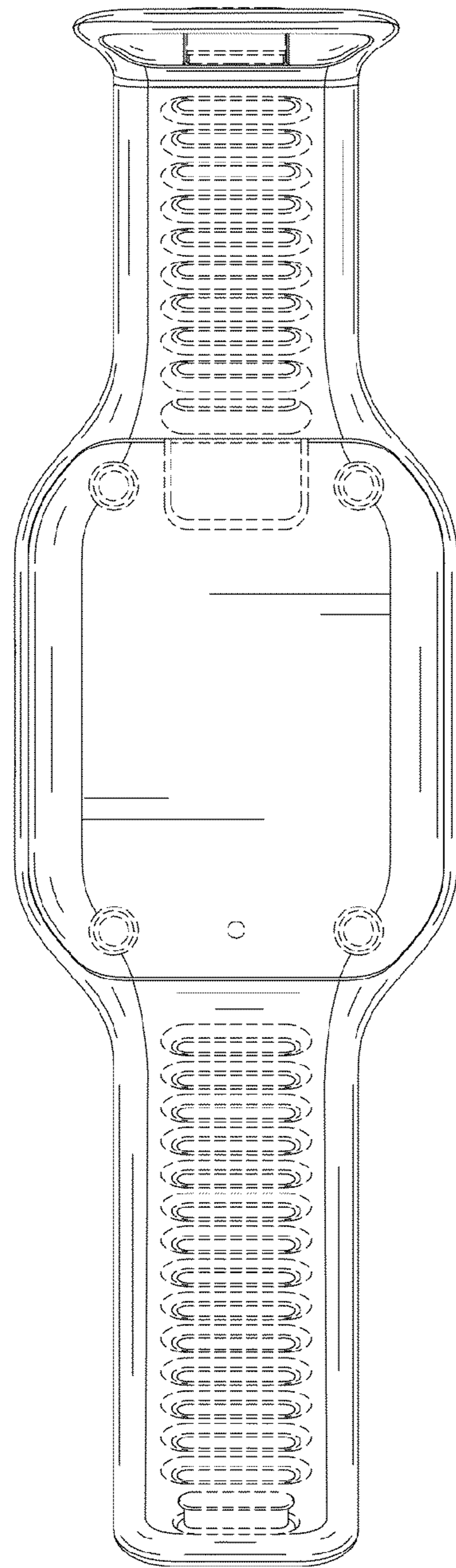

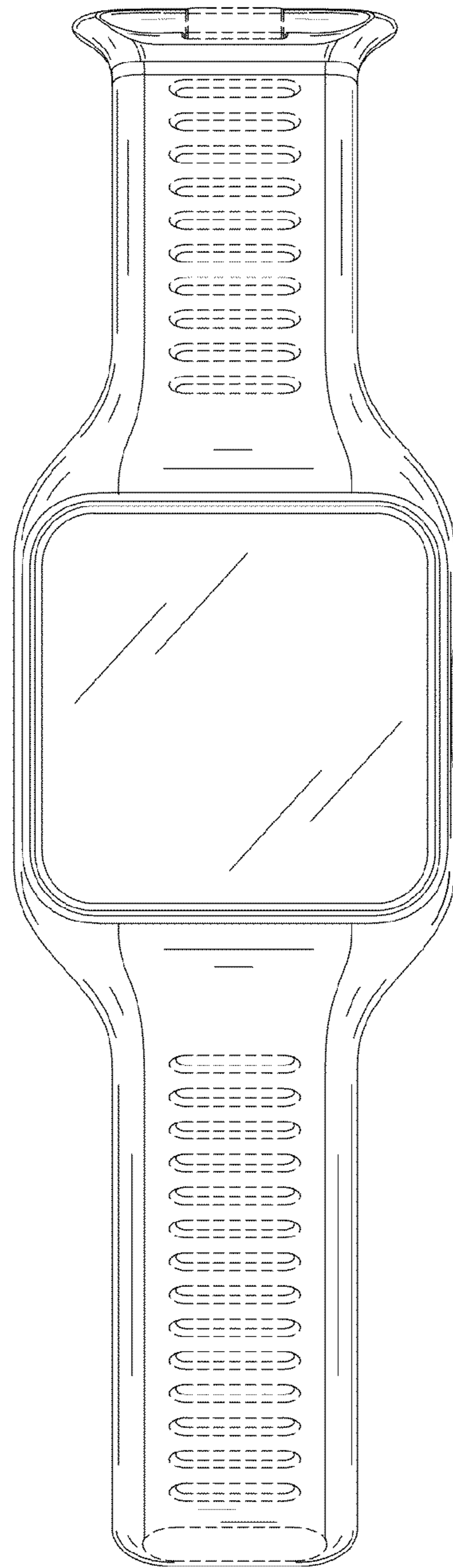

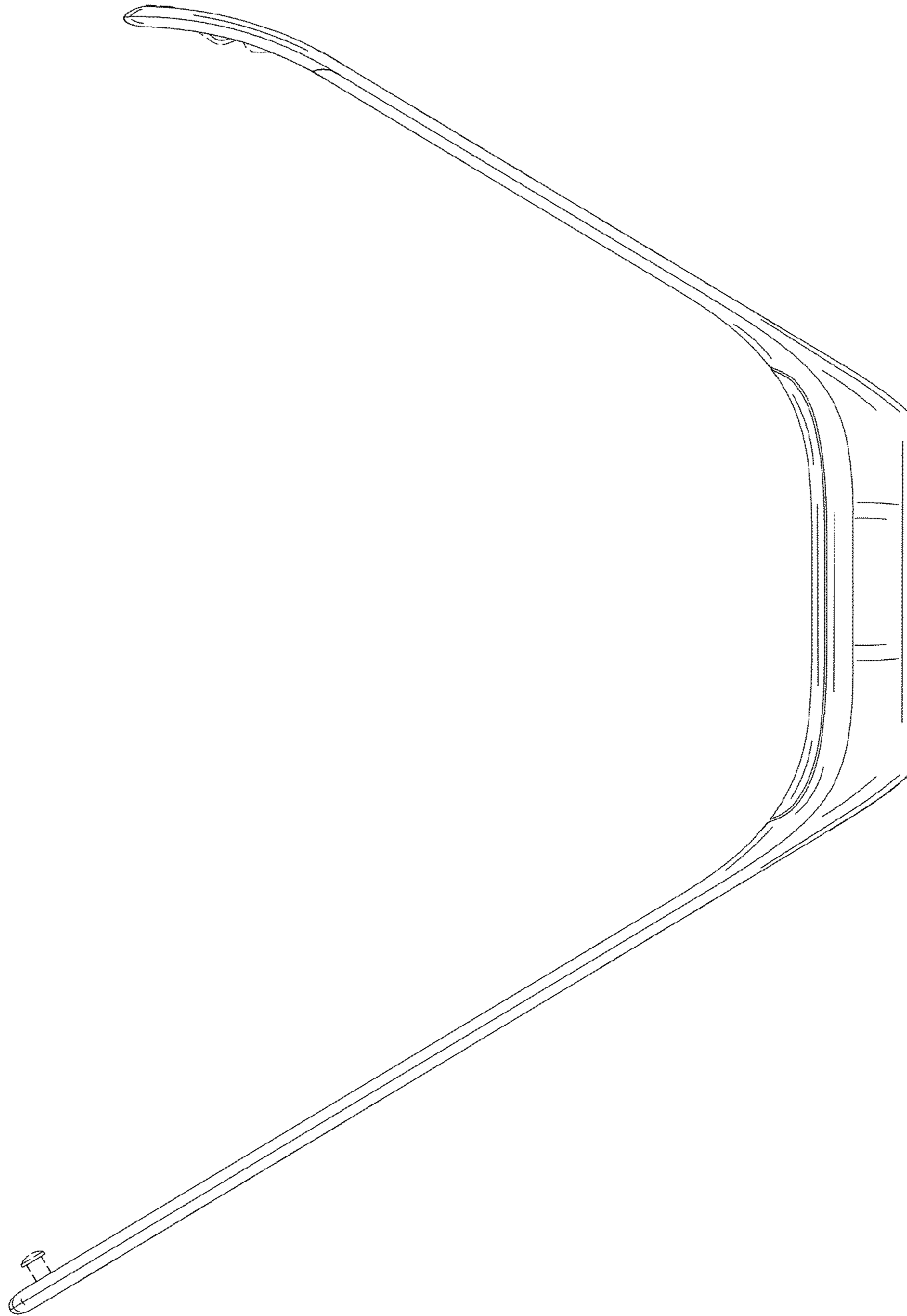

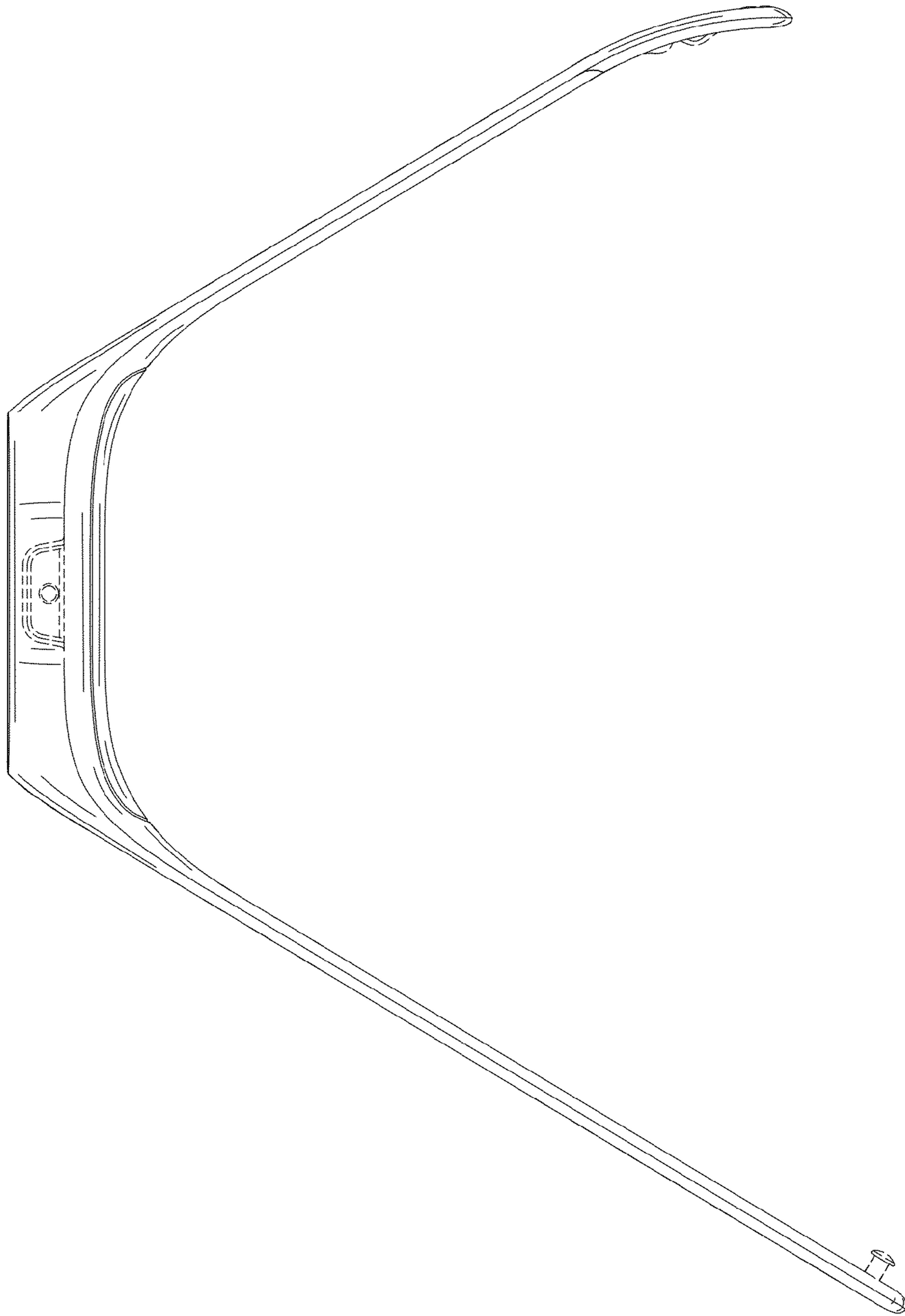

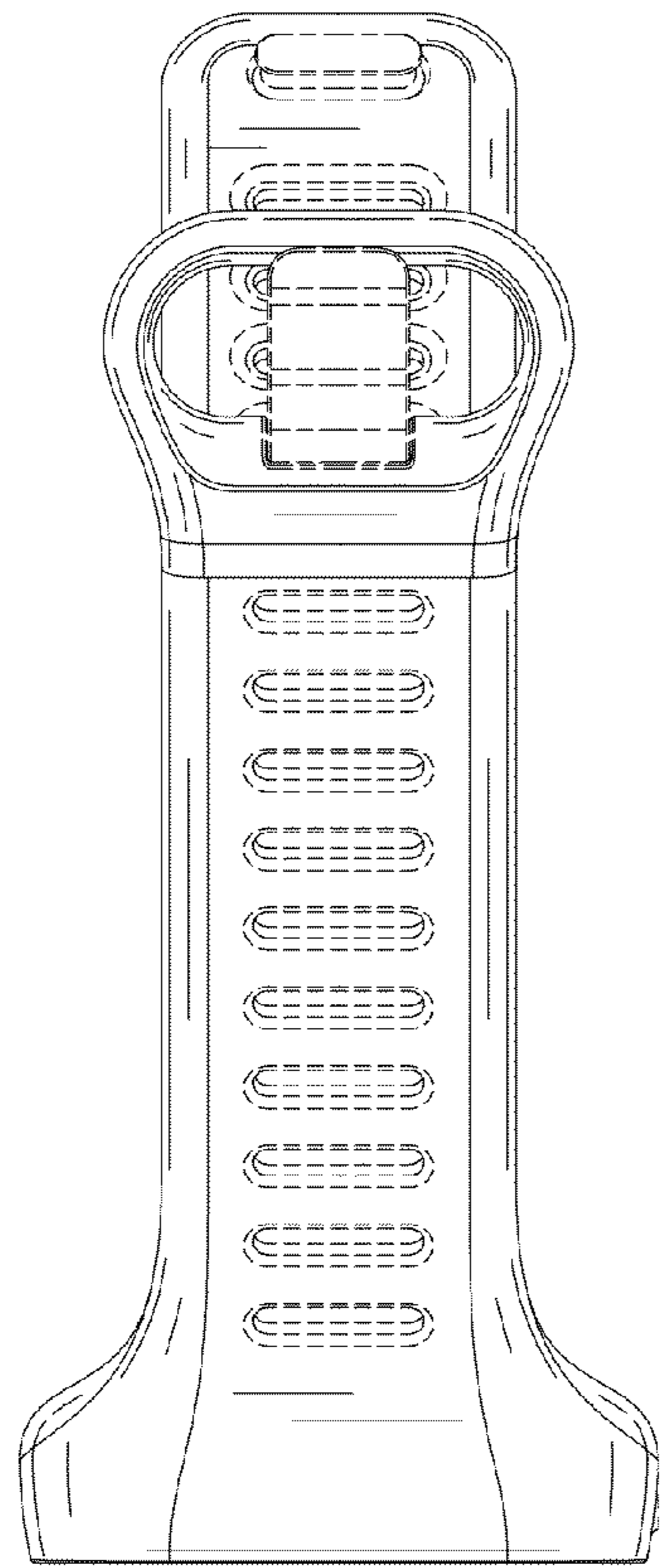

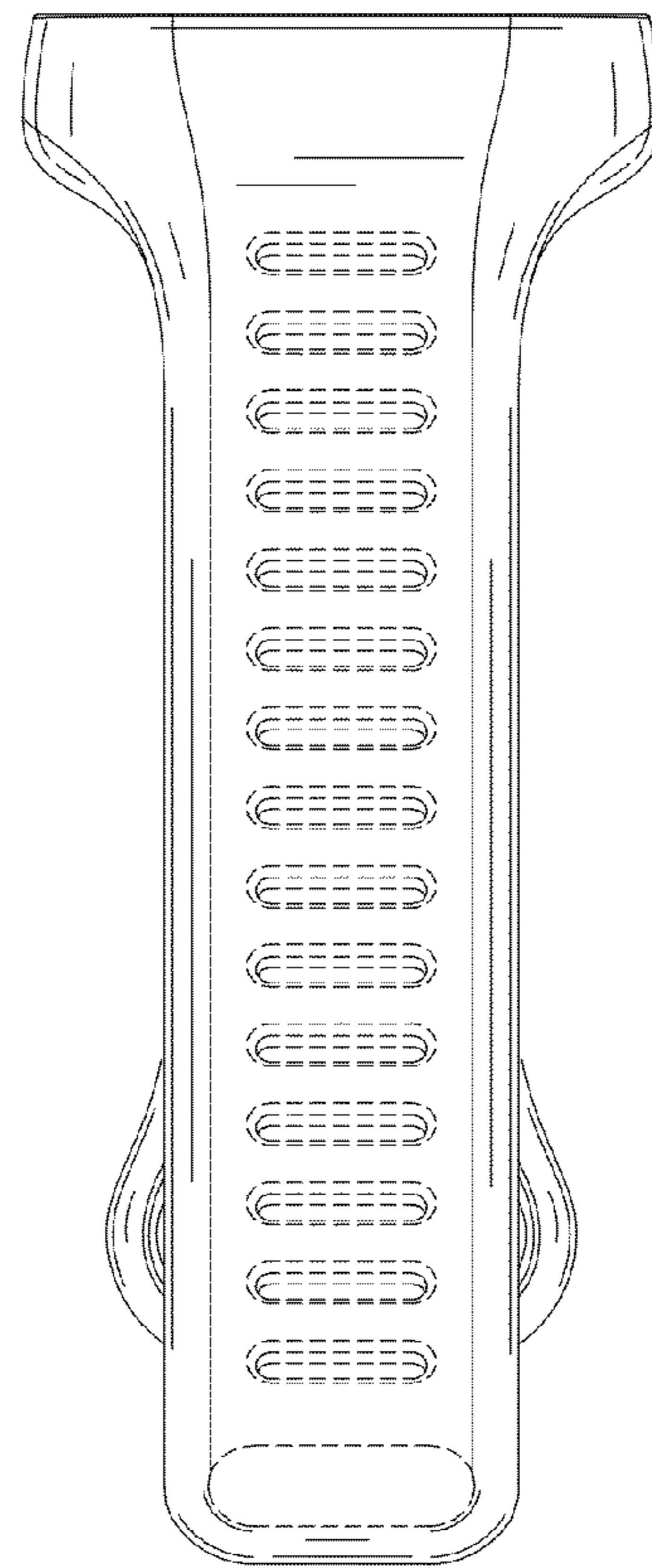
