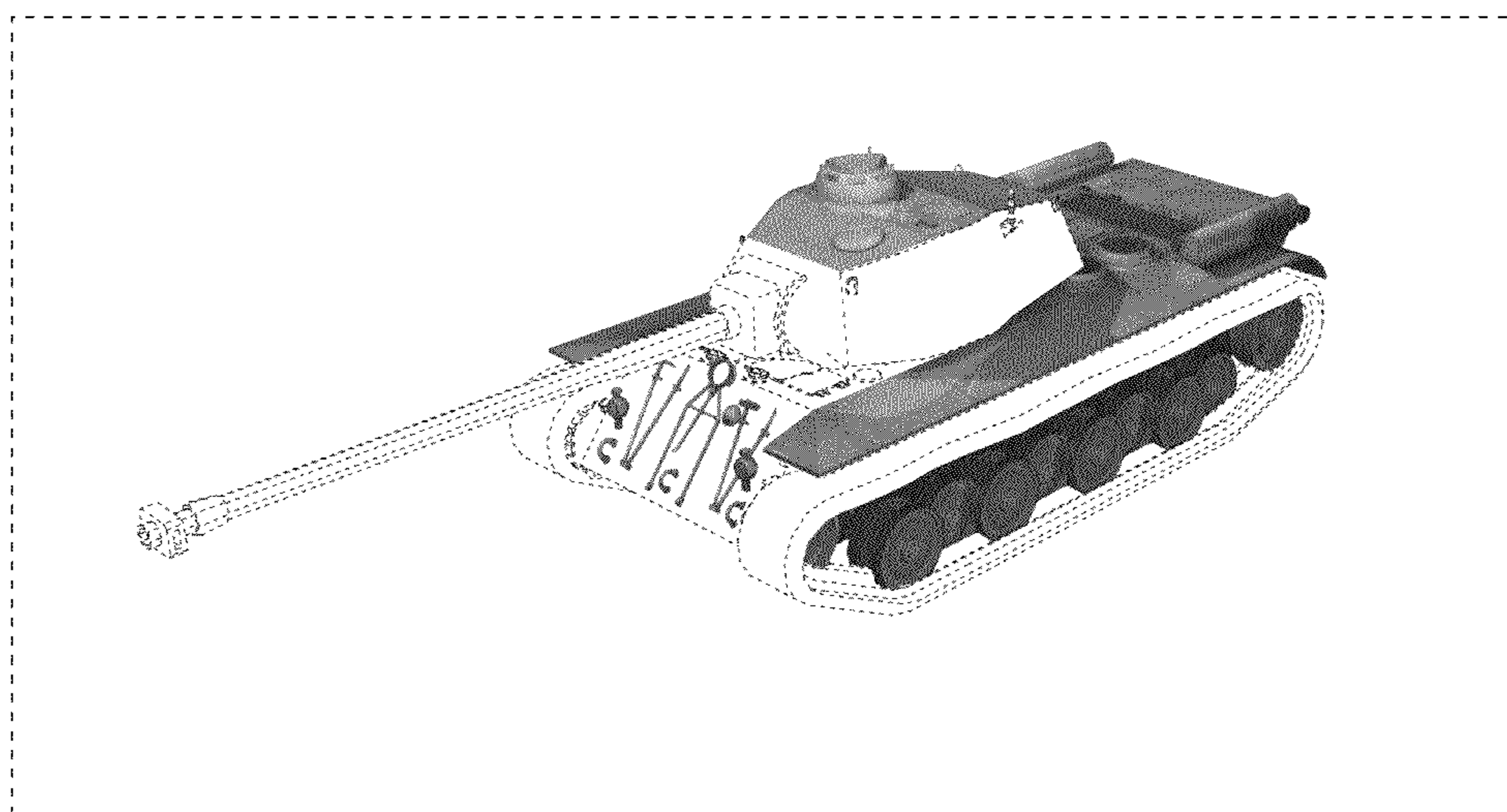

(57) **CLAIM**  
The ornamental design for a display device portion with a graphical user interface showing an armored vehicle, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display device portion with a graphical user interface showing an armored vehicle according to the new design.
