(57) **CLAIM**

The ornamental design for a display screen with icon group and display screen with icon set, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with icon group showing the new design;

FIG. 2 is another embodiment thereof;

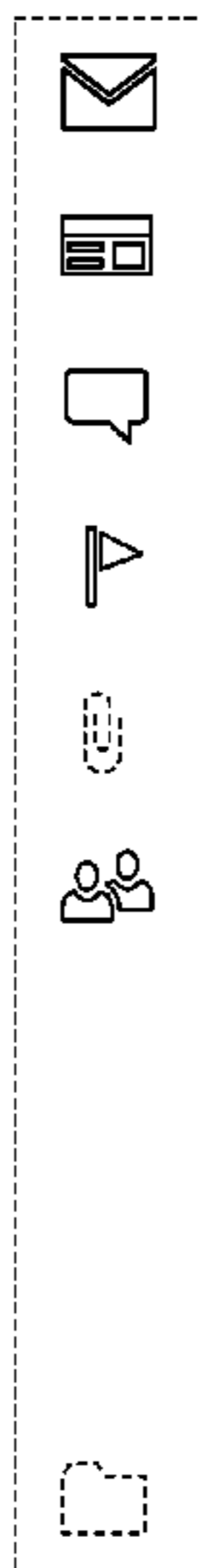
FIG. 3 is a front view of a display screen with icon set showing the new design;

FIG. 4 is another embodiment thereof; and,

FIG. 5 is a front view of the display screen with icon group of FIG. 1 shown on a device.

The broken line showing of the two icons in FIGS. 1, 2, and 5 is for environmental purposes only and forms no part of the claimed design. The broken line showing of the remainder of the user interface and the remainder of the display screen is for environmental purposes only and forms no part of the claimed design. The icons in FIGS. 3-4 are arranged relatively on the drawing sheet for the convenience of display, and their relative positioning forms no part of the claimed design.

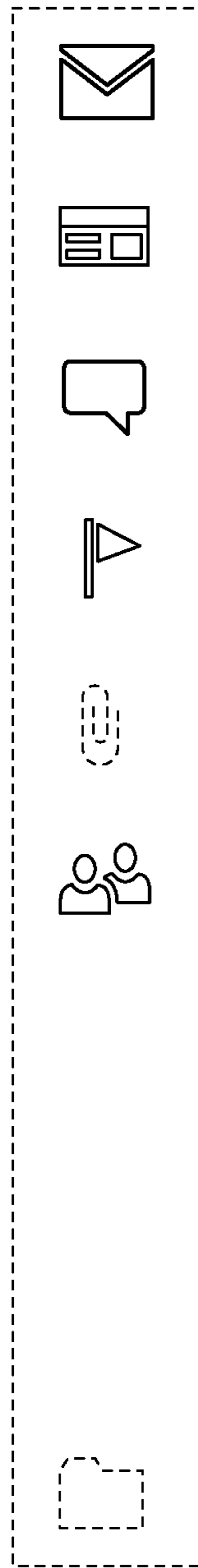

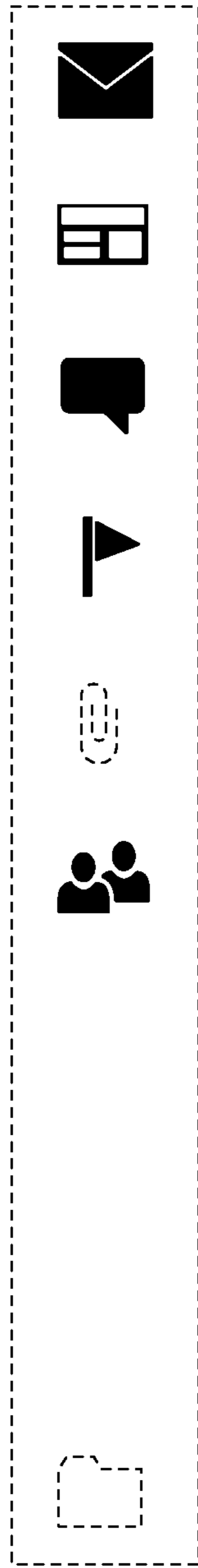

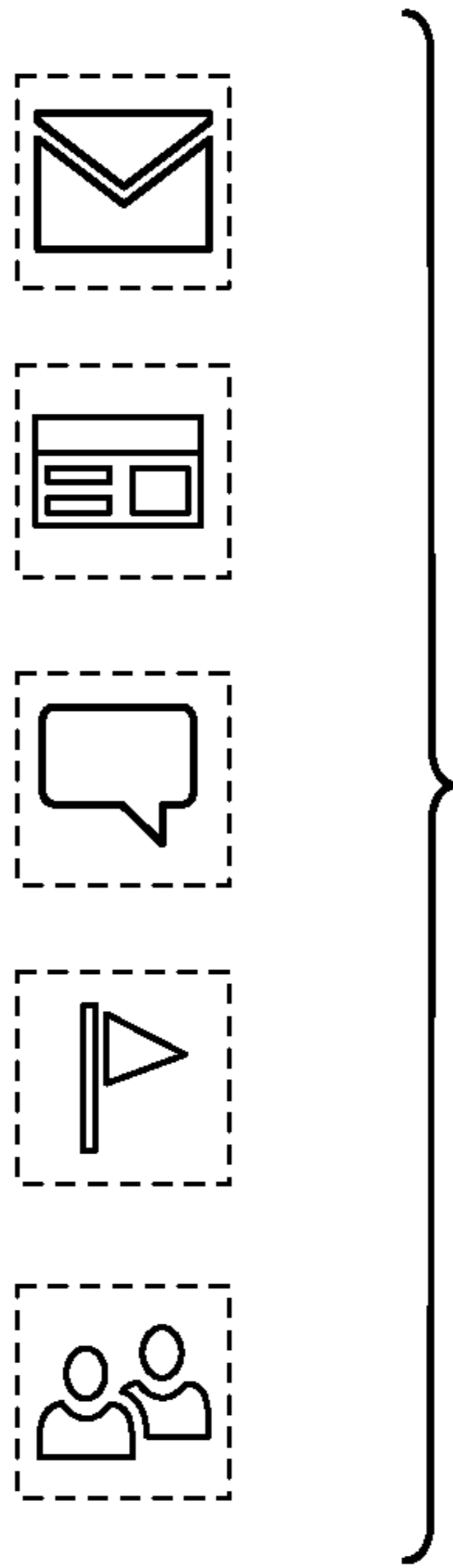

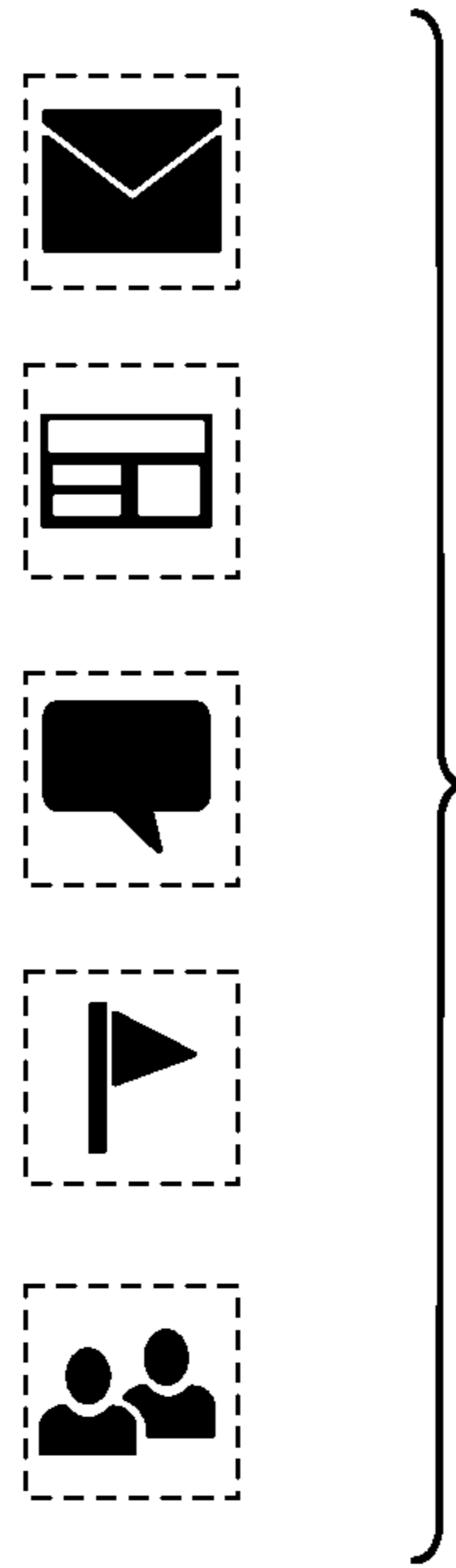

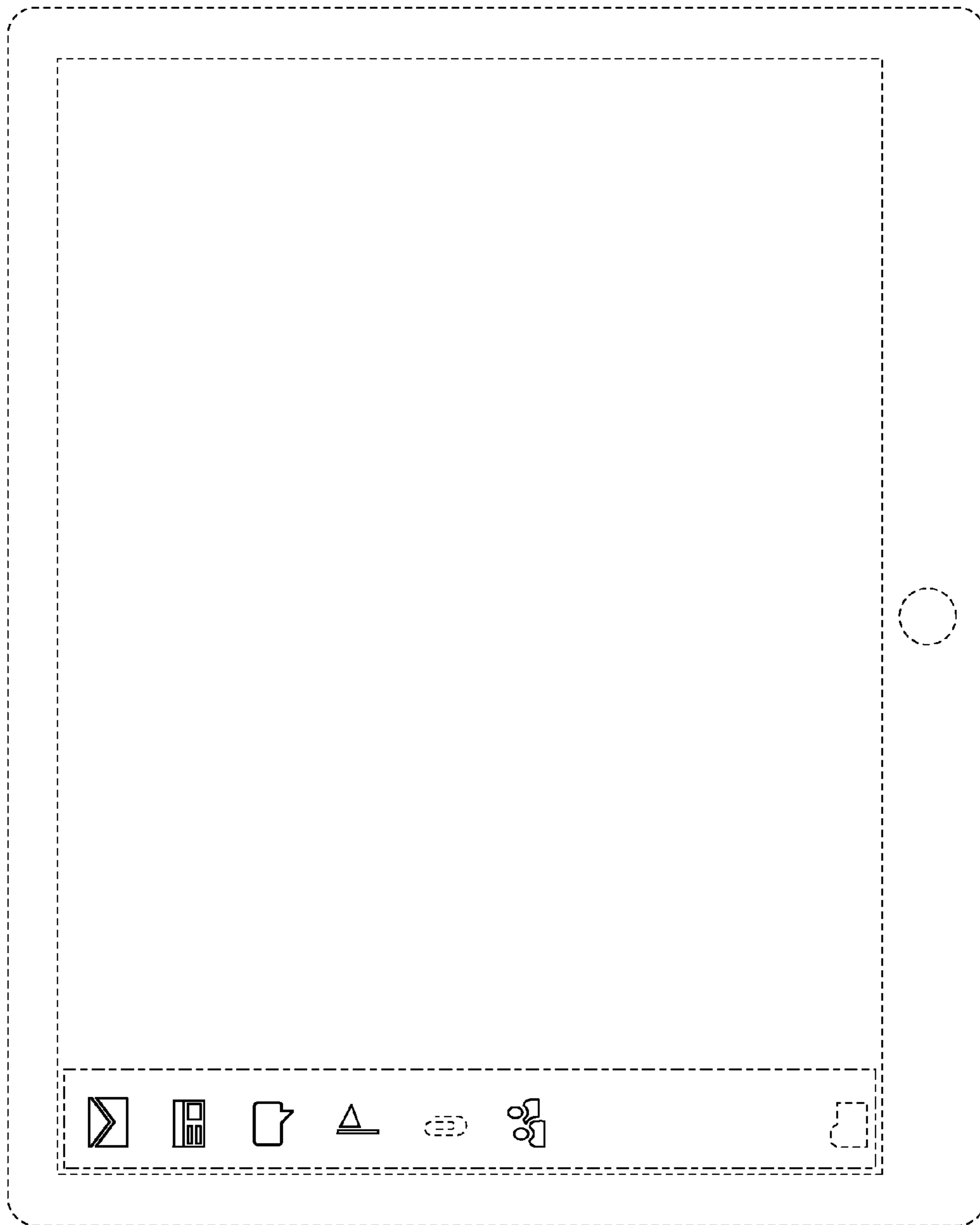
