(57) **CLAIM**

The ornamental design for a drumstick grip accessory, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a drumstick grip accessory showing my new design in an installed position on a drumstick;

FIG. 2 is a perspective view of the drumstick grip accessory; FIG. 3 is a top view of the drumstick grip accessory, with the bottom and side views being a mirror image of;

FIG. 4 is a front end view of the drumstick grip accessory; FIG. 5 is a rear end view of the drumstick grip accessory; and, FIG. 6 is a cross-section view of the drumstick grip accessory, taken along line 6-6 in FIG. 5.

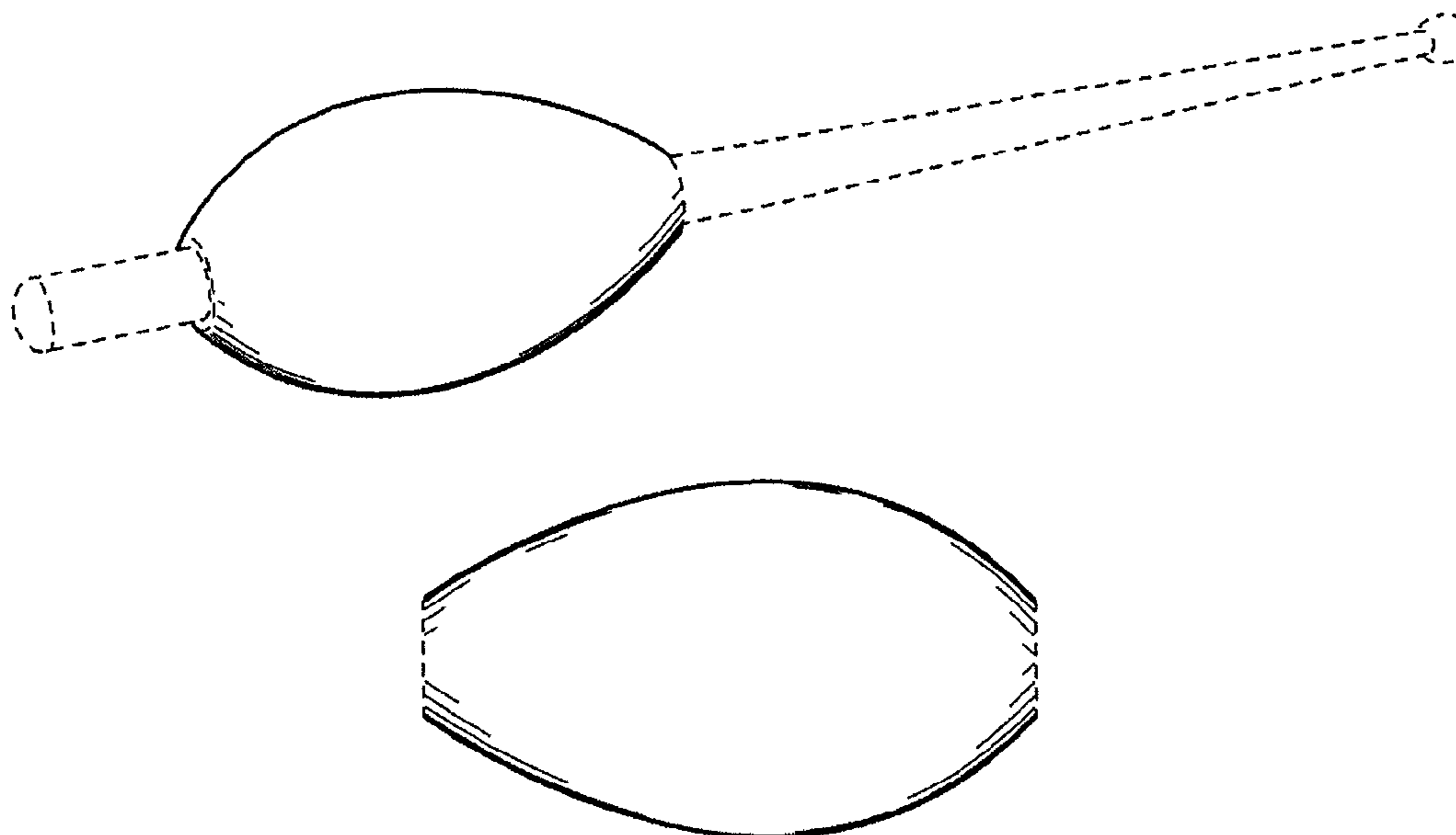

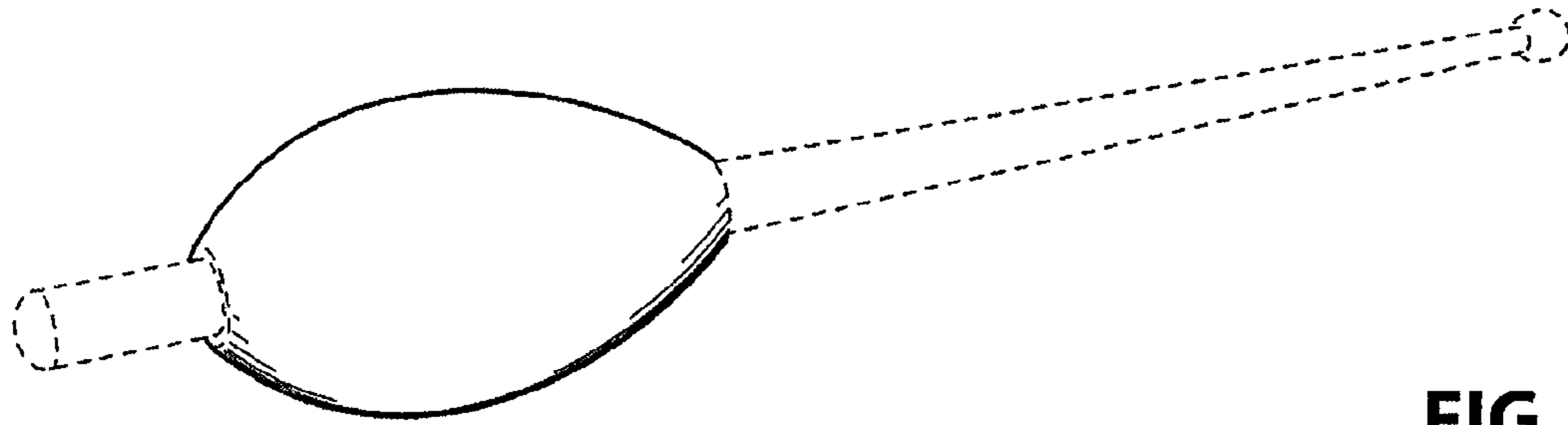

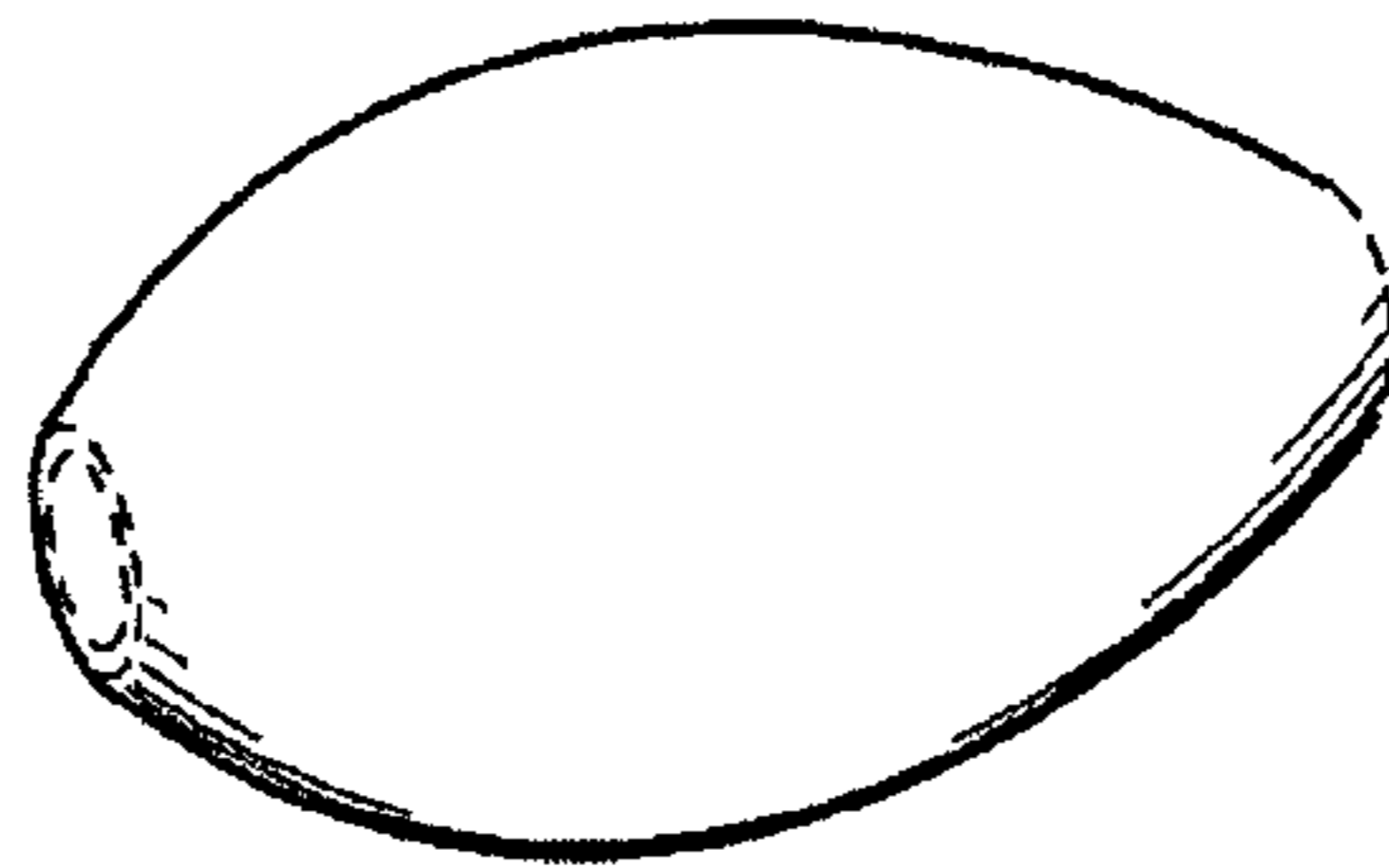

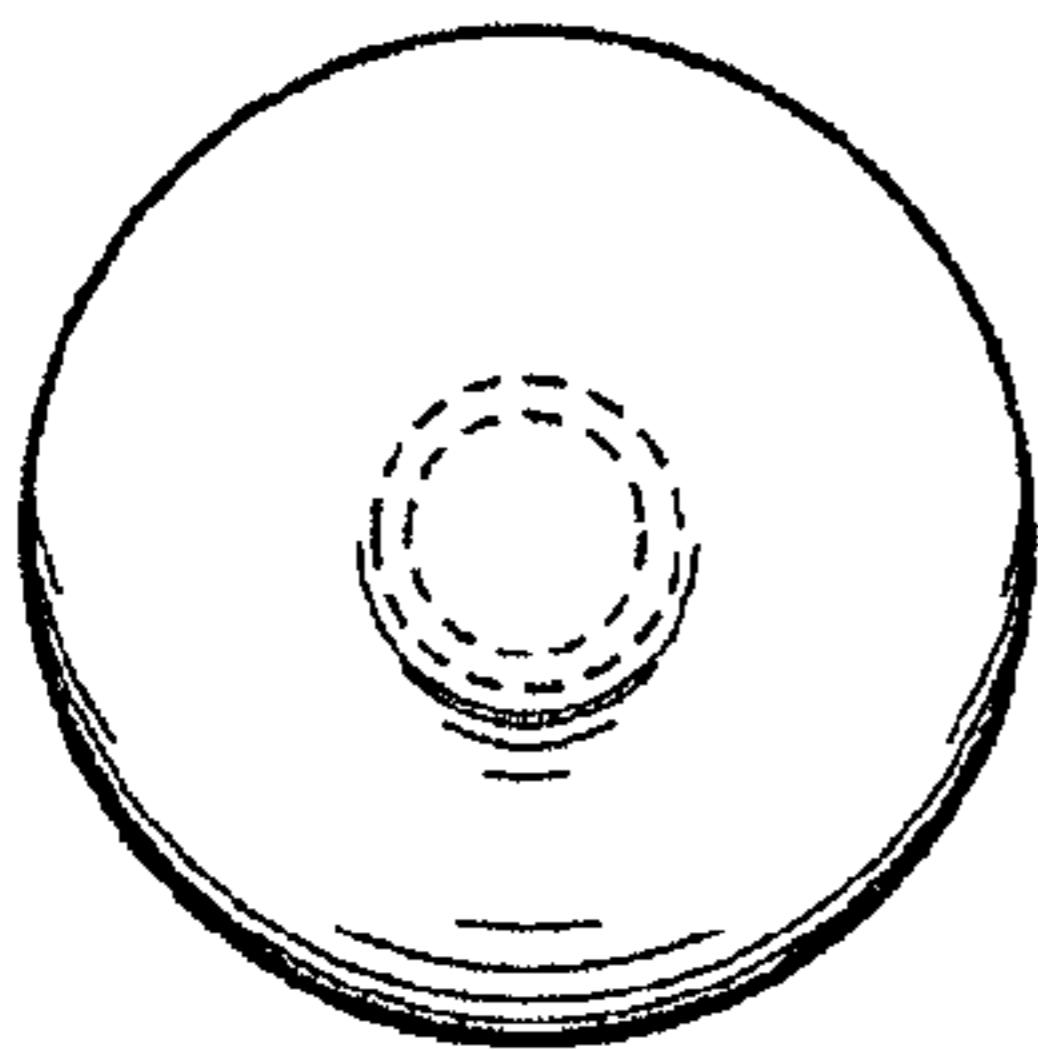

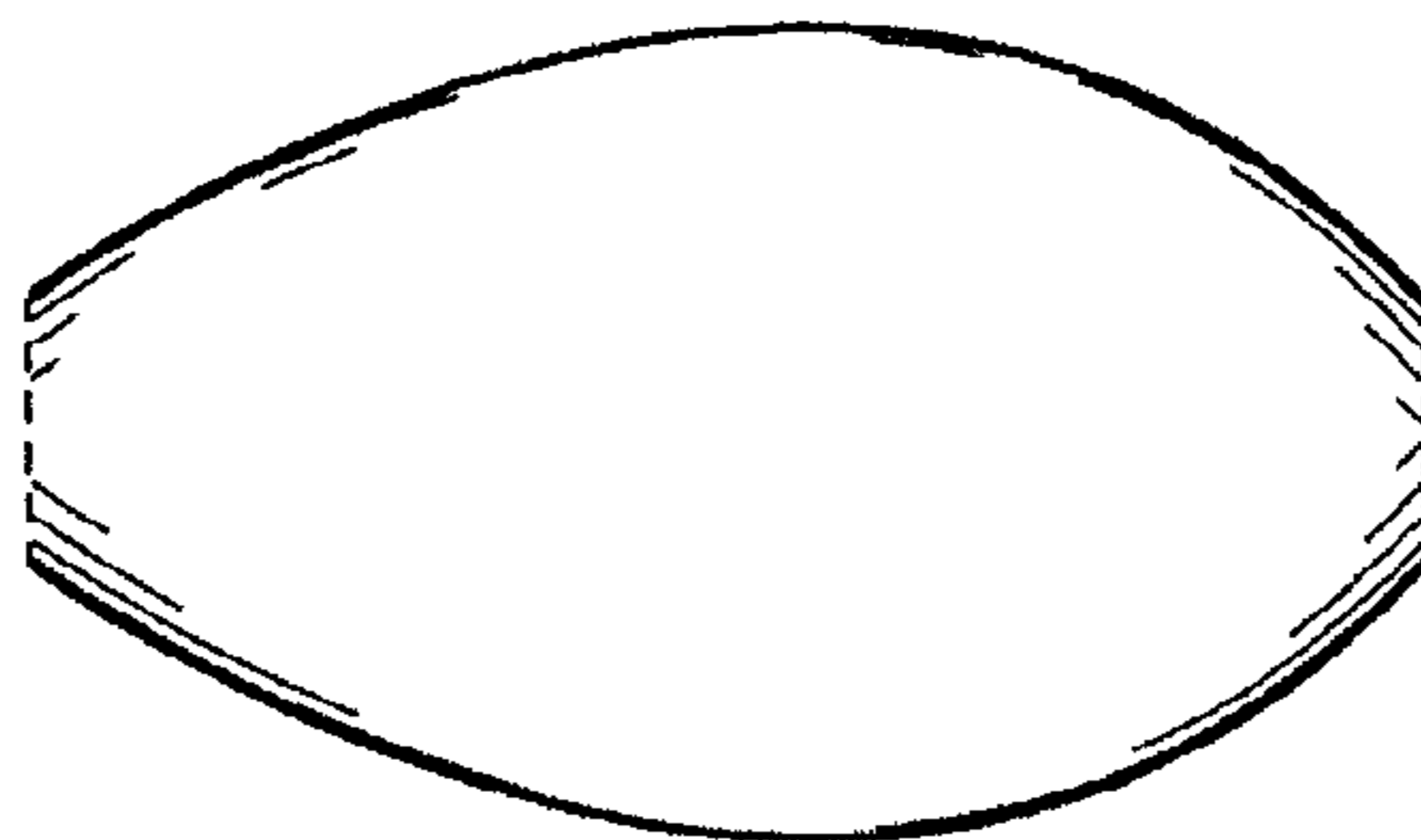

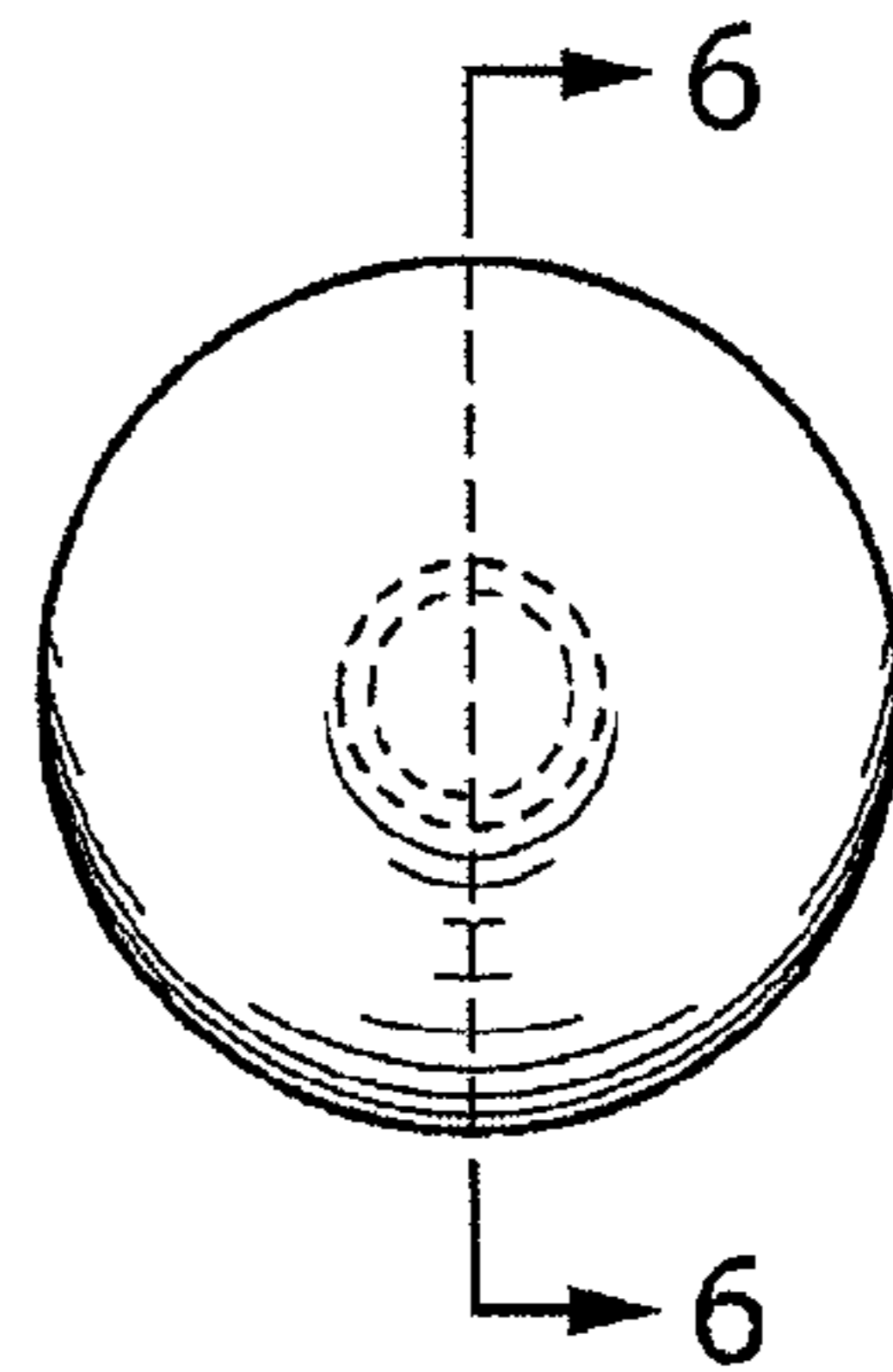

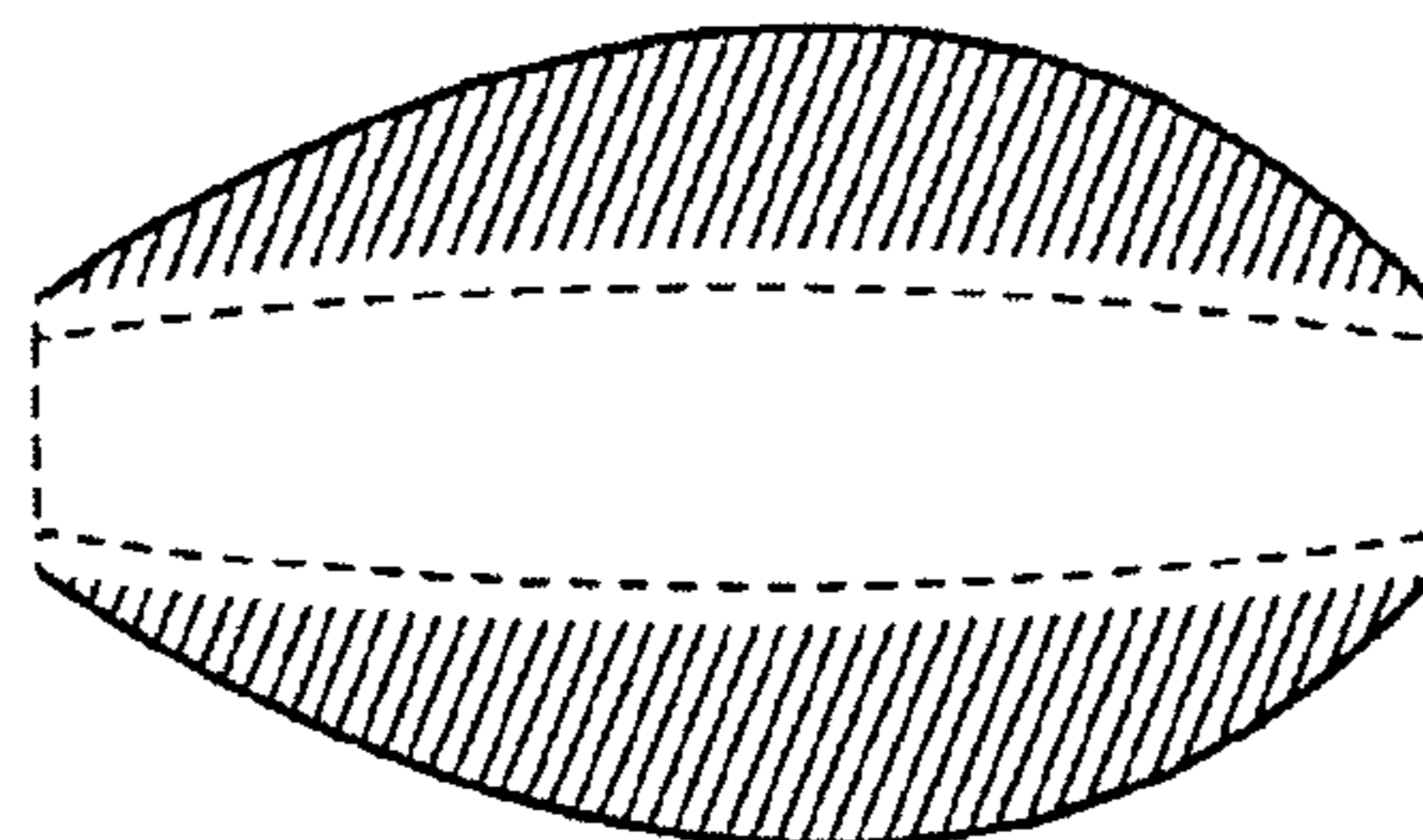
