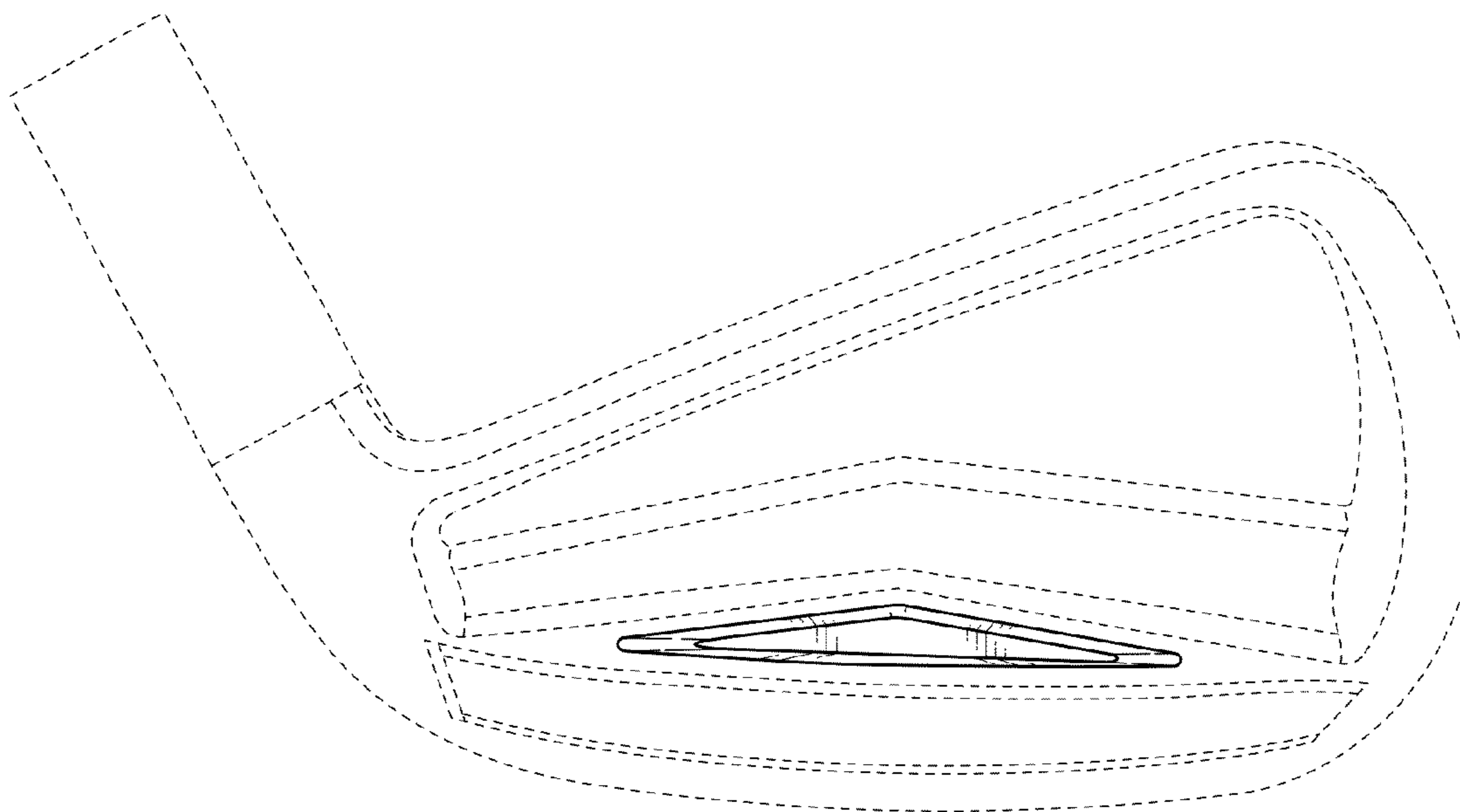
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a rear perspective view of a first embodiment of the  
golf club head as claimed herein;

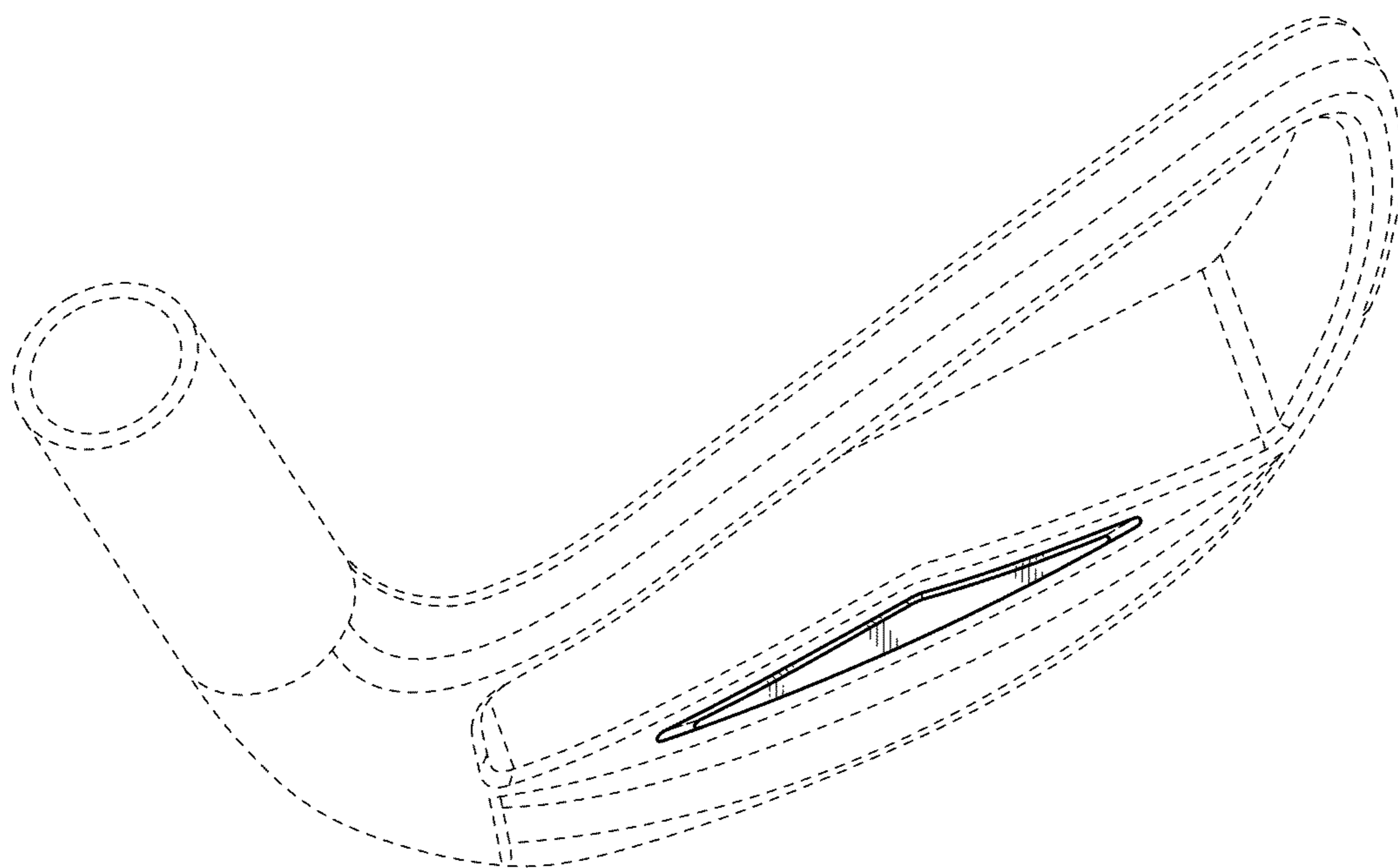

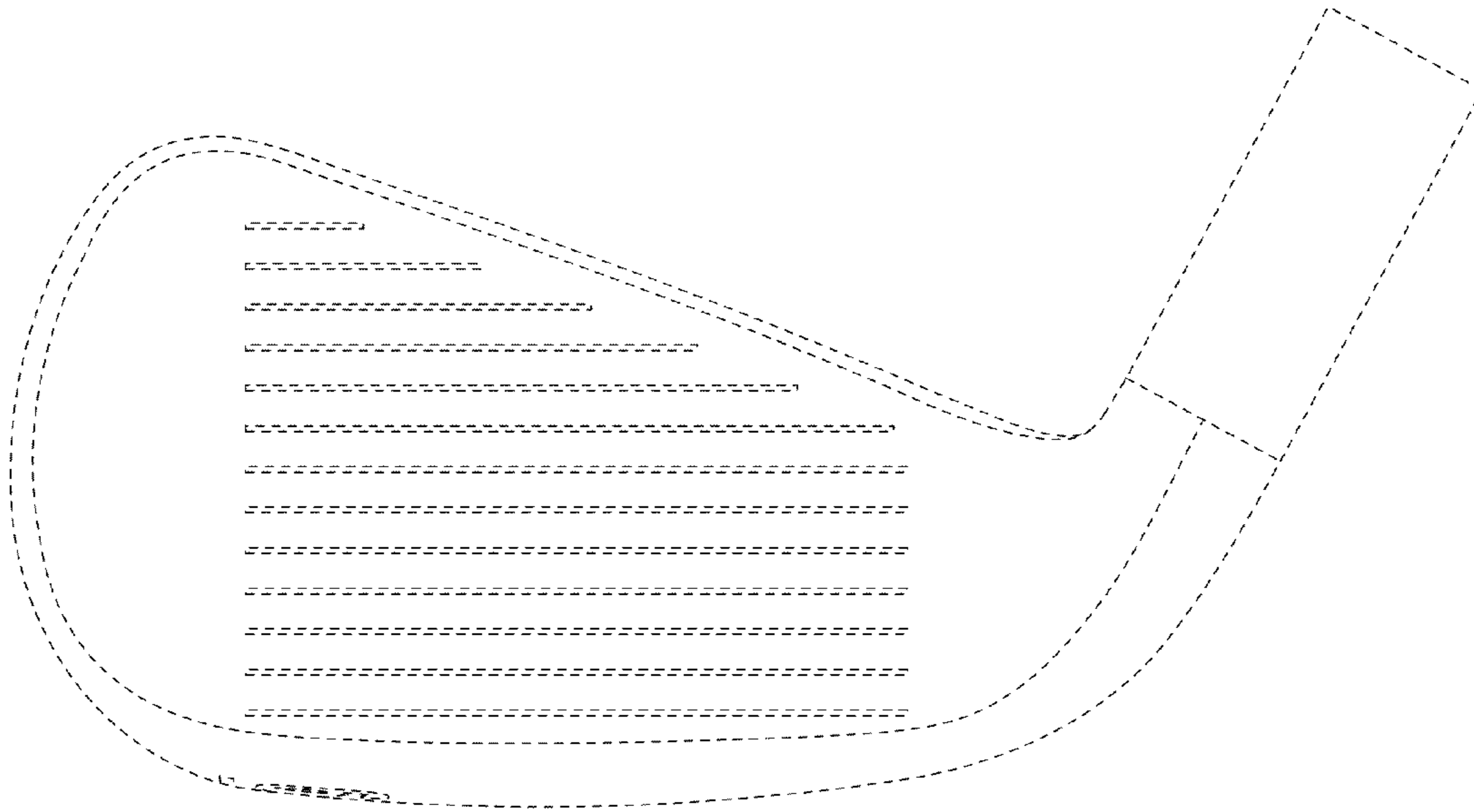

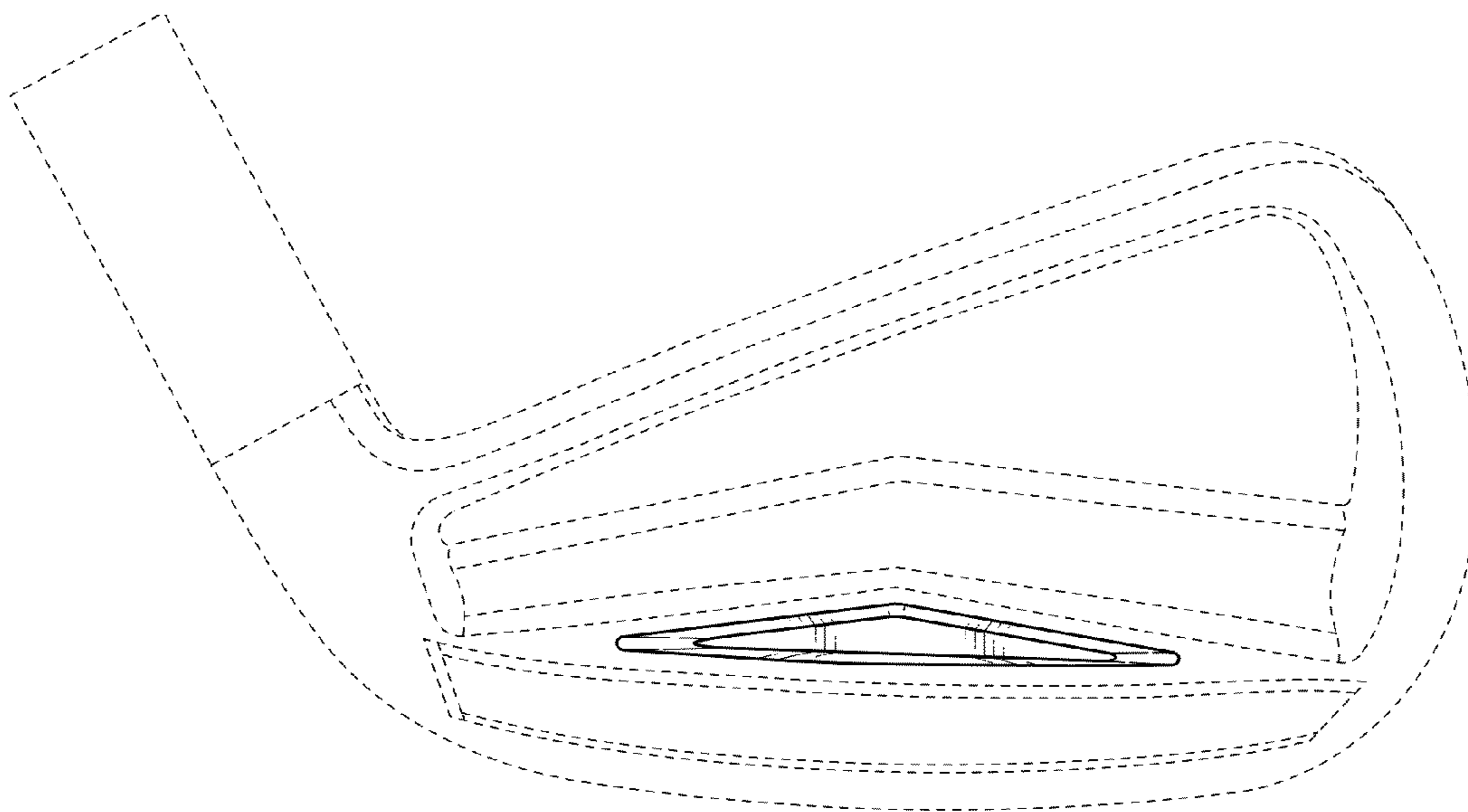

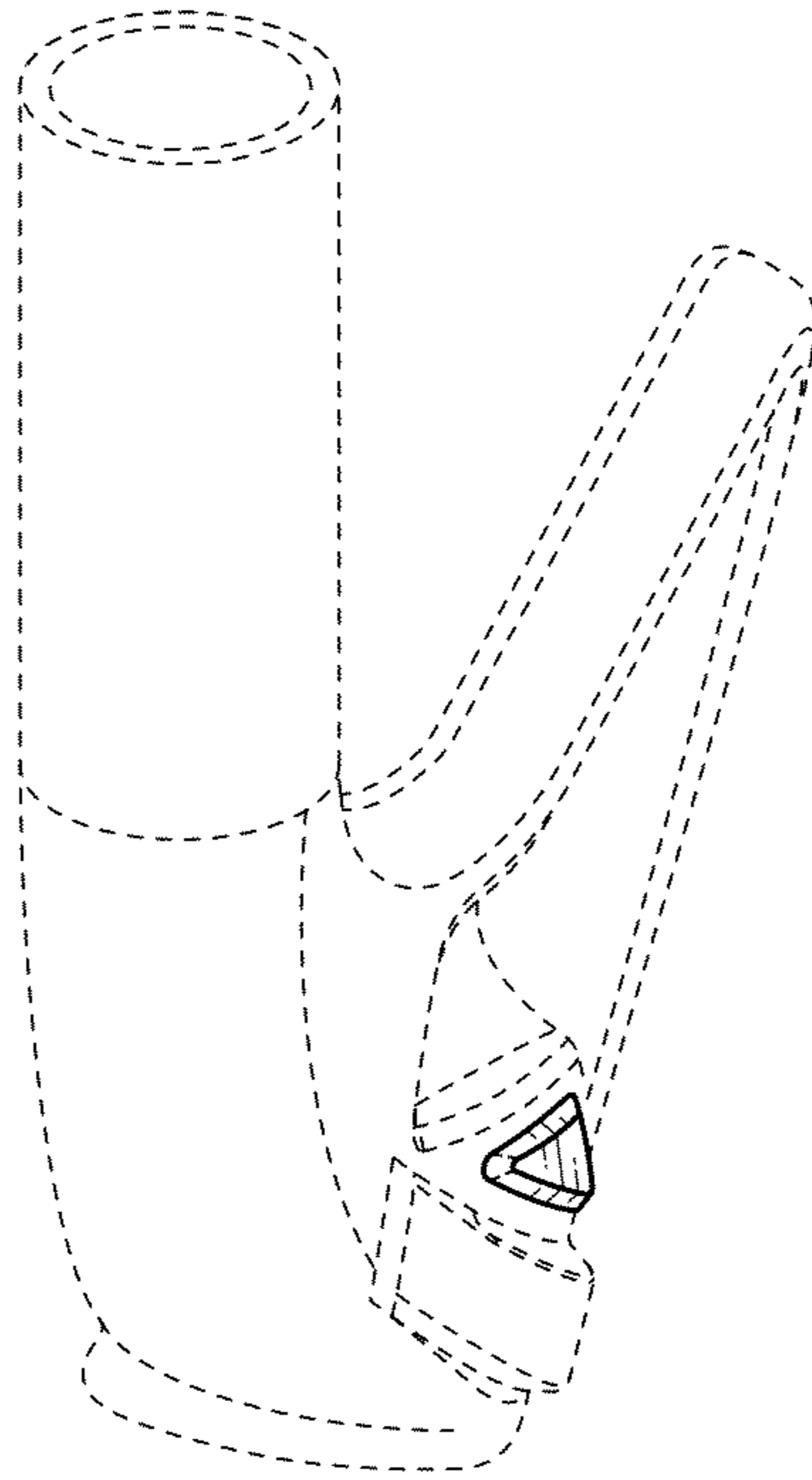

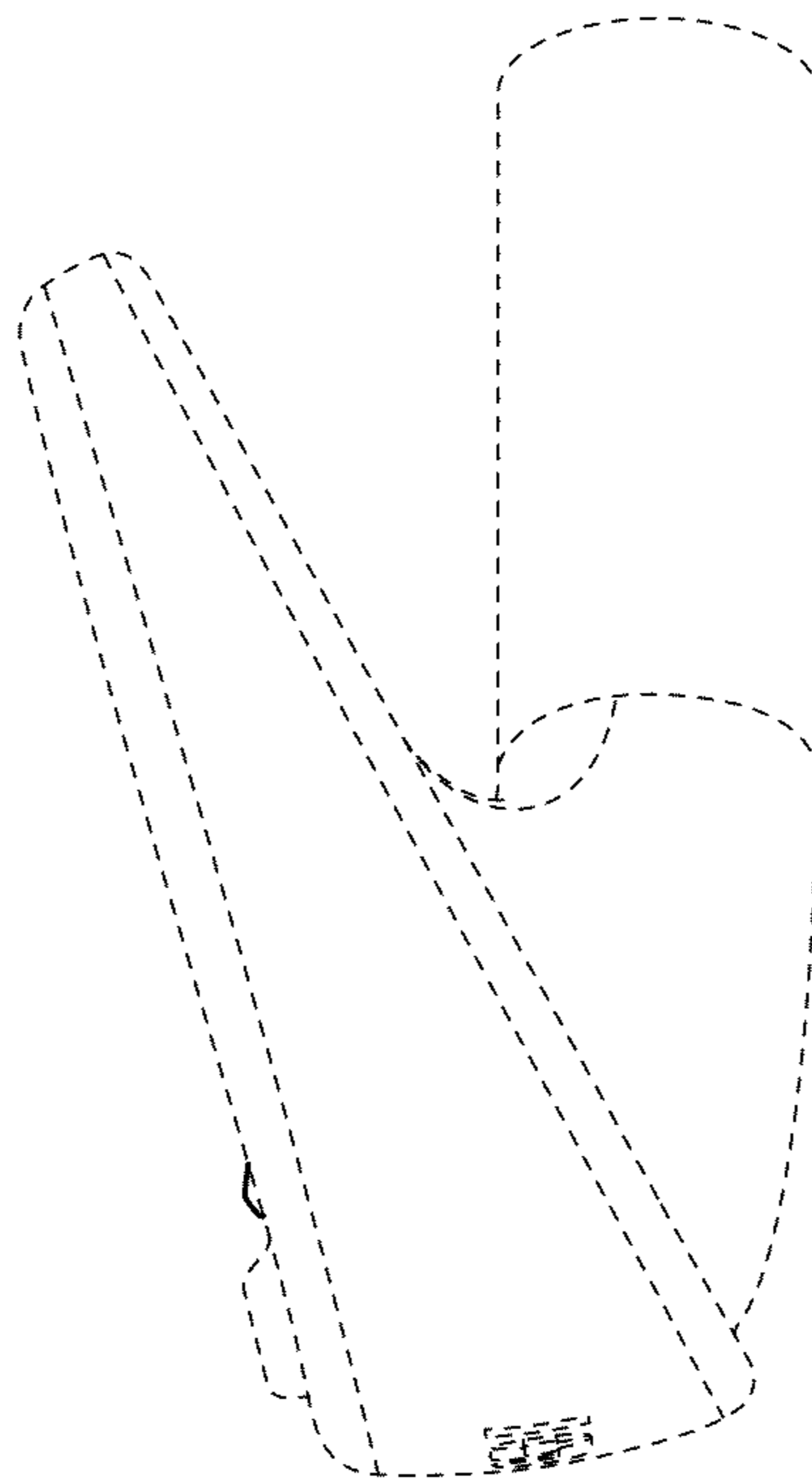

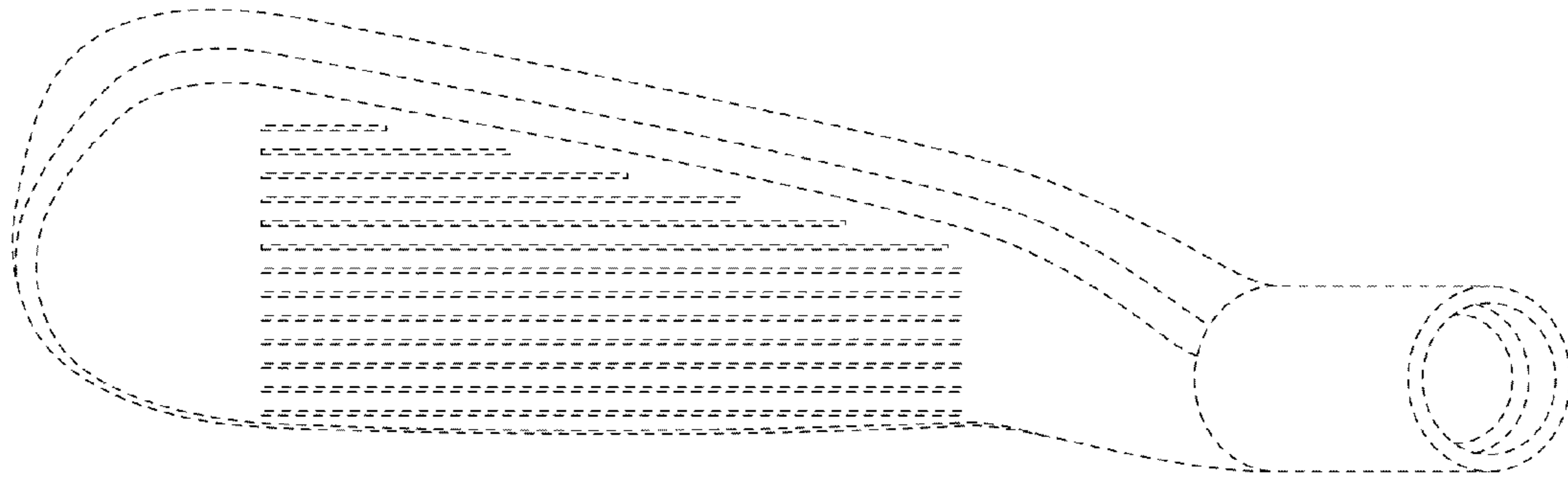

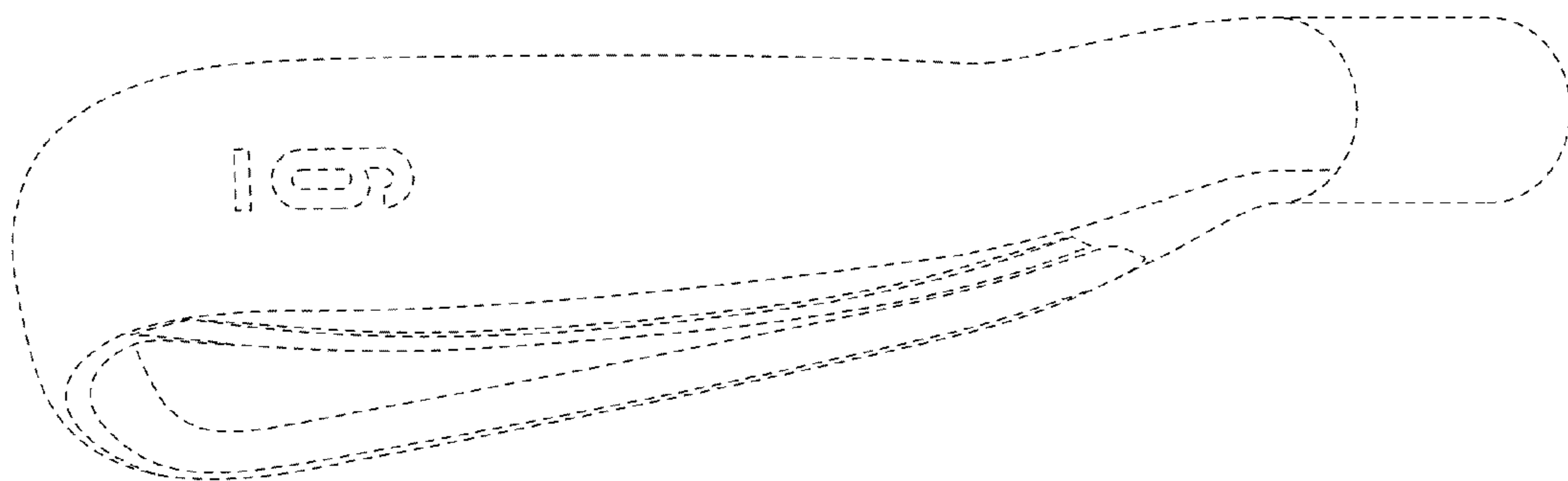
