FIG. 2 is a first side elevation view thereof.

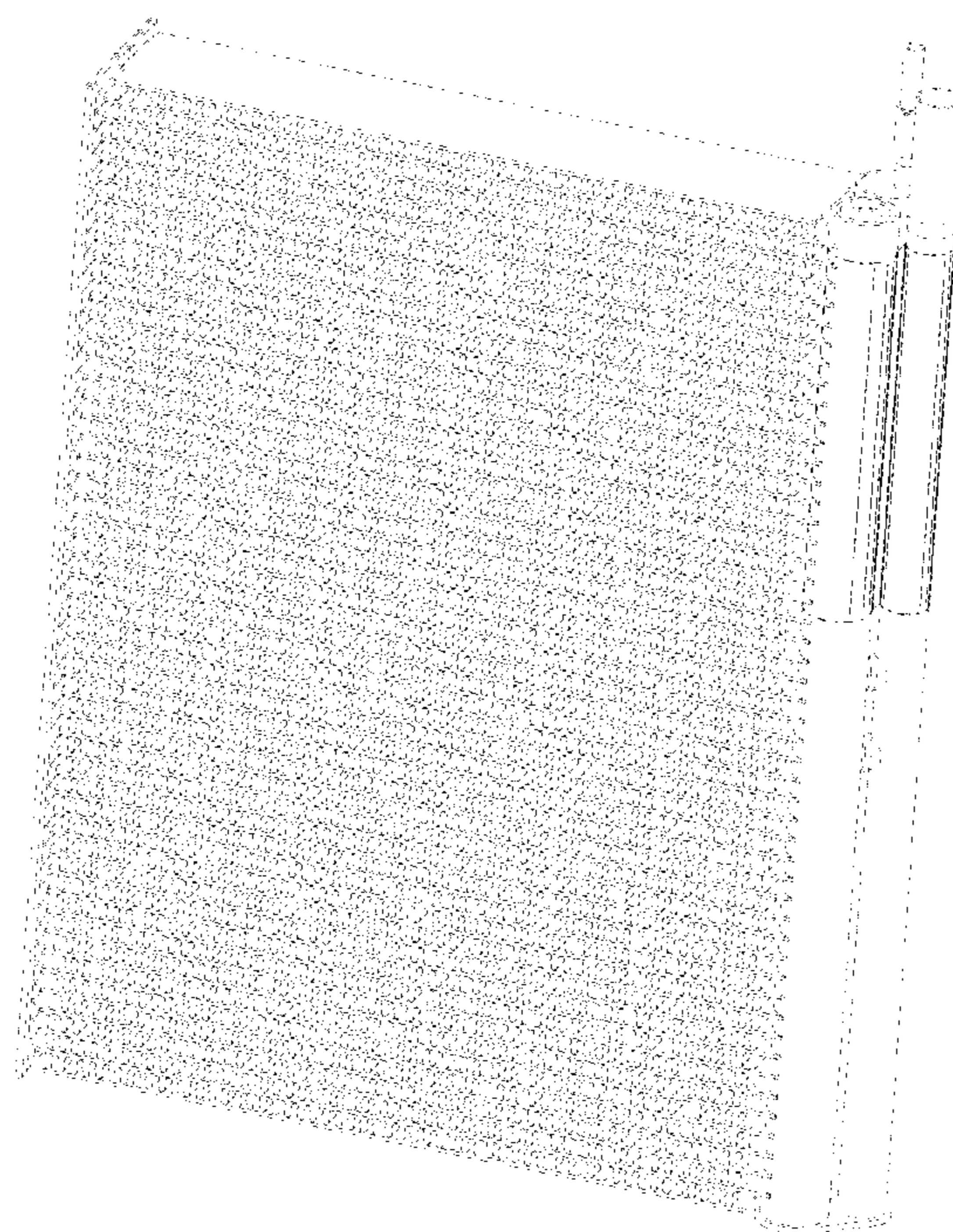
FIG. 3 is a second side elevation view thereof.

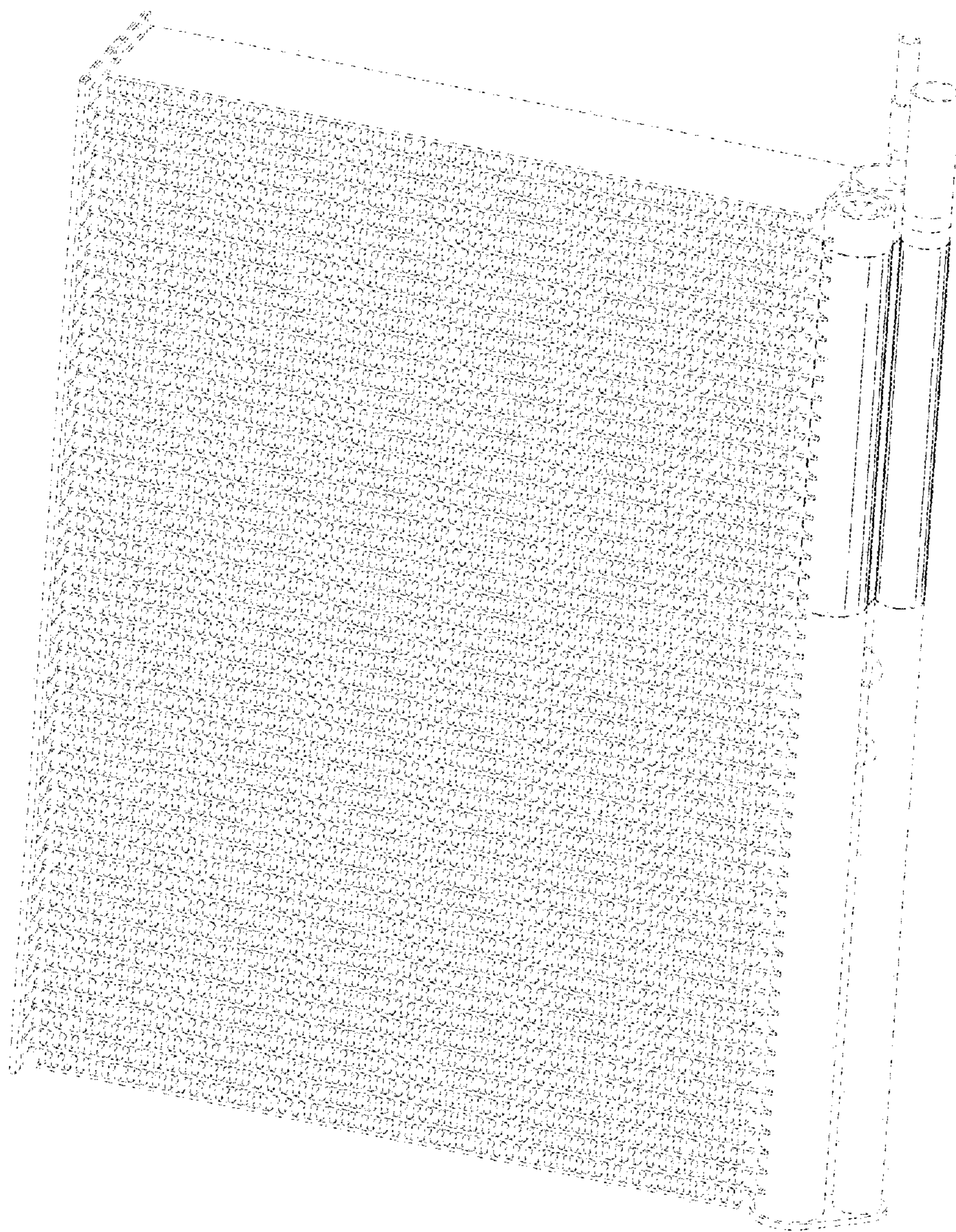

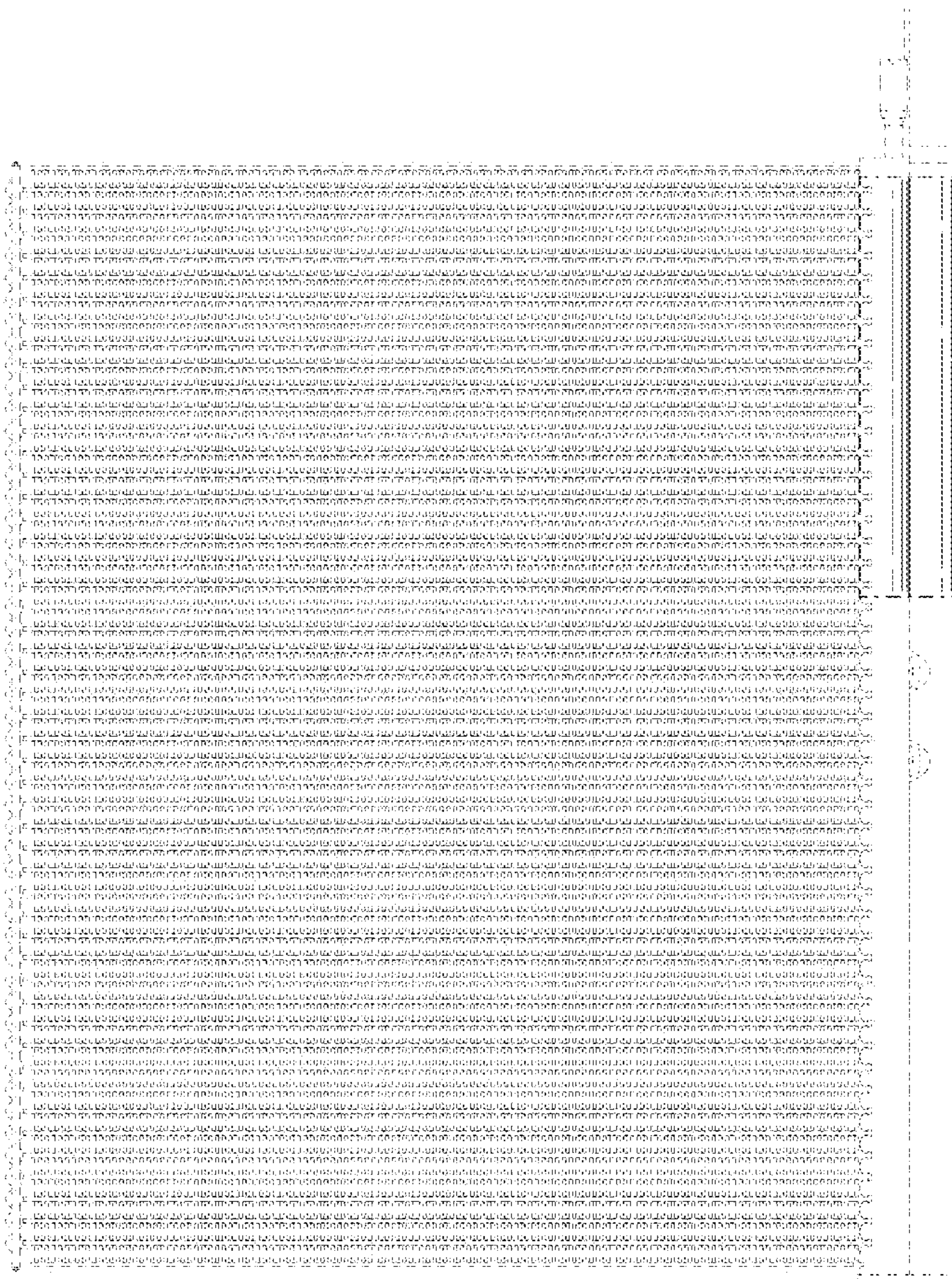

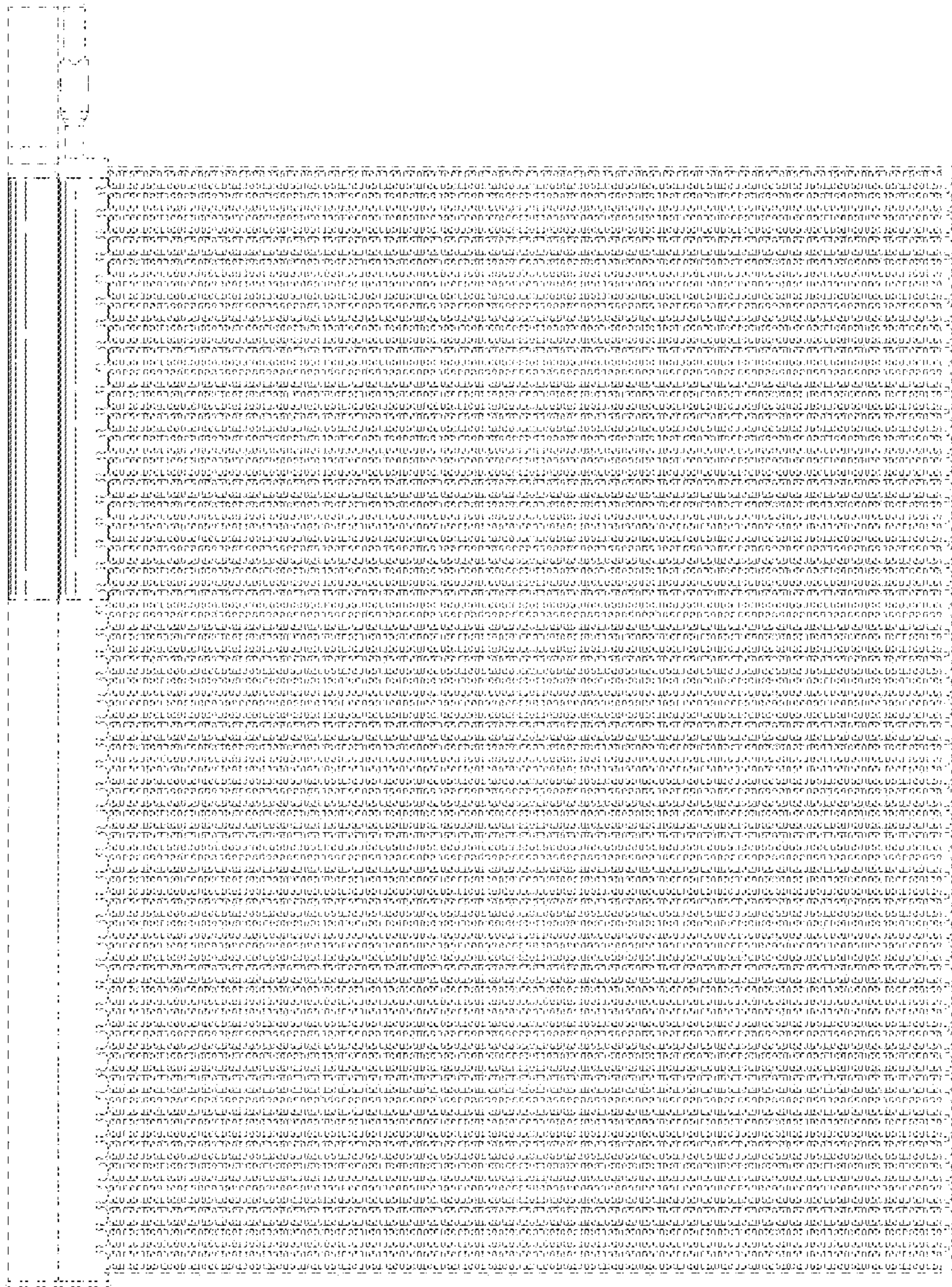

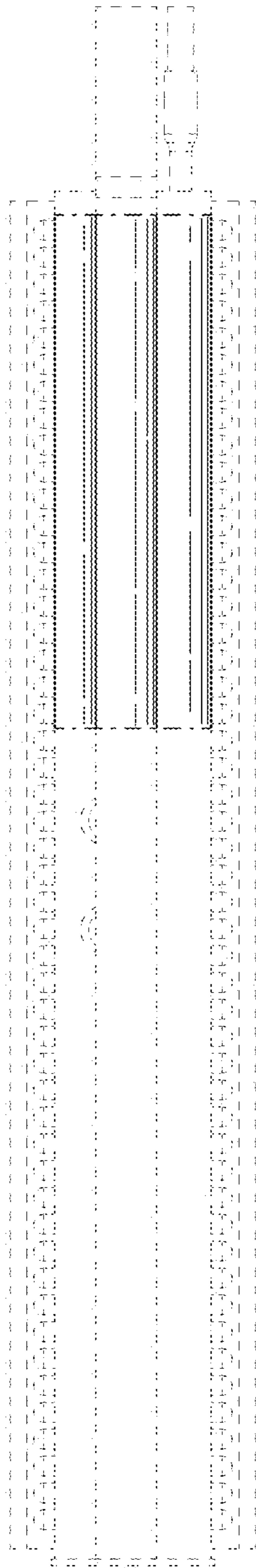

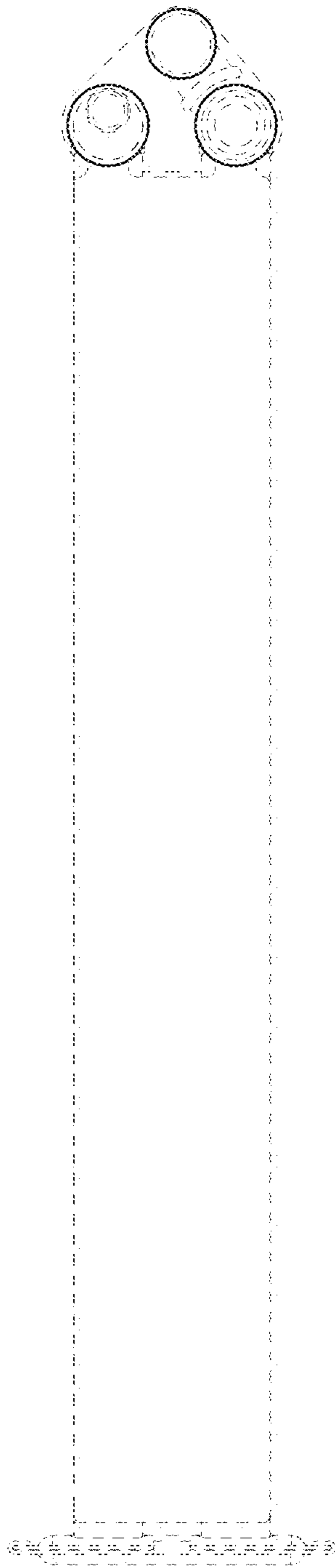
