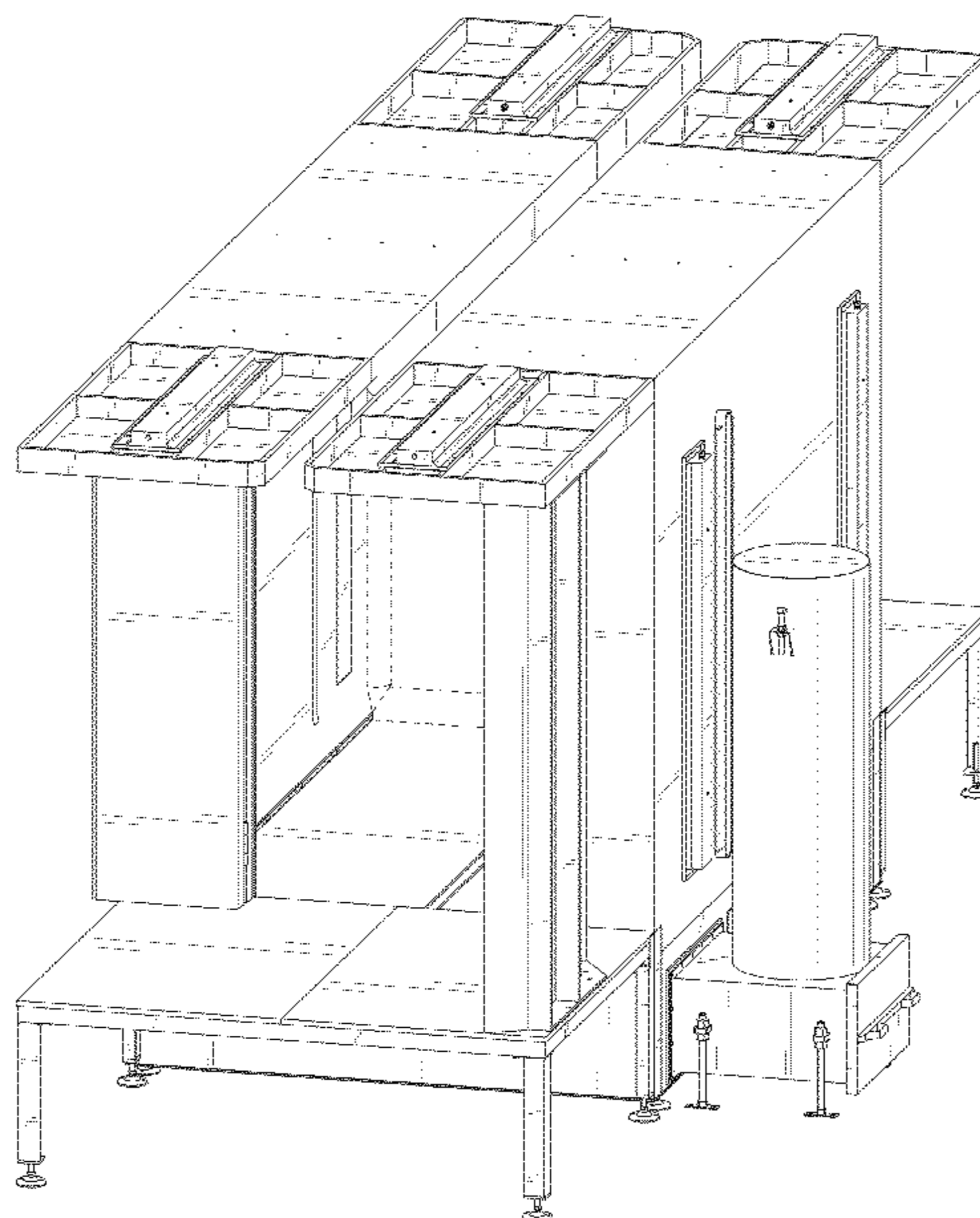
(57) **CLAIM**

The ornamental design for a powder spray booth, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a powder spray booth; FIG. 2 is a right side view of the powder spray booth of FIG. 1; FIG. 3 is a left side view of the powder spray booth of FIG. 1; FIG. 4 is a back view of the powder spray booth of FIG. 1; FIG. 5 is a front view of the powder spray booth of FIG. 1; FIG. 6 is a top view of the powder spray booth of FIG. 1; and, FIG. 7 is a bottom view of the powder spray booth of FIG. 1. The broken lines shown in FIGS. 1-5 and FIG. 7 illustrate portions of the powder spray booth that form no part of the claimed design.

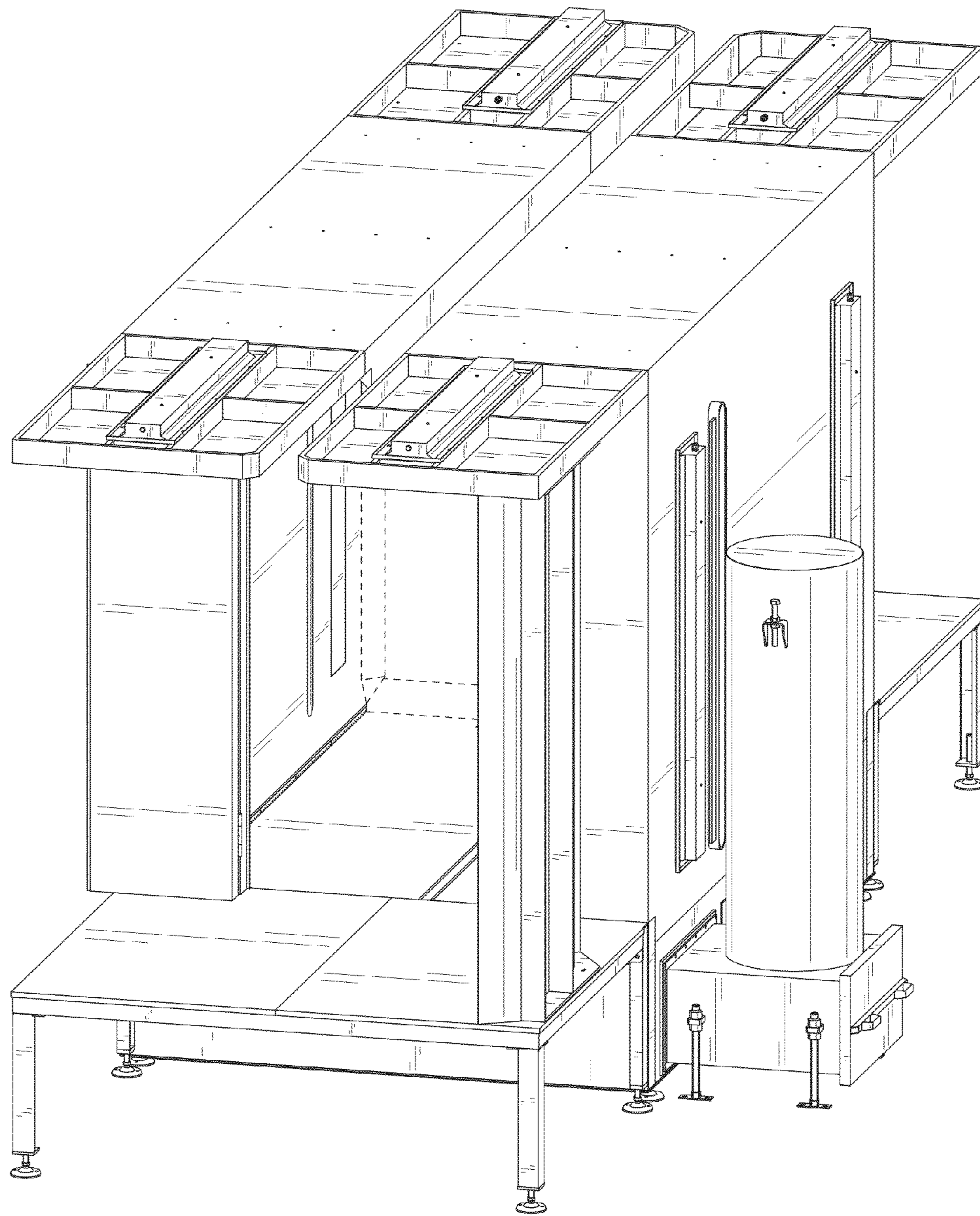

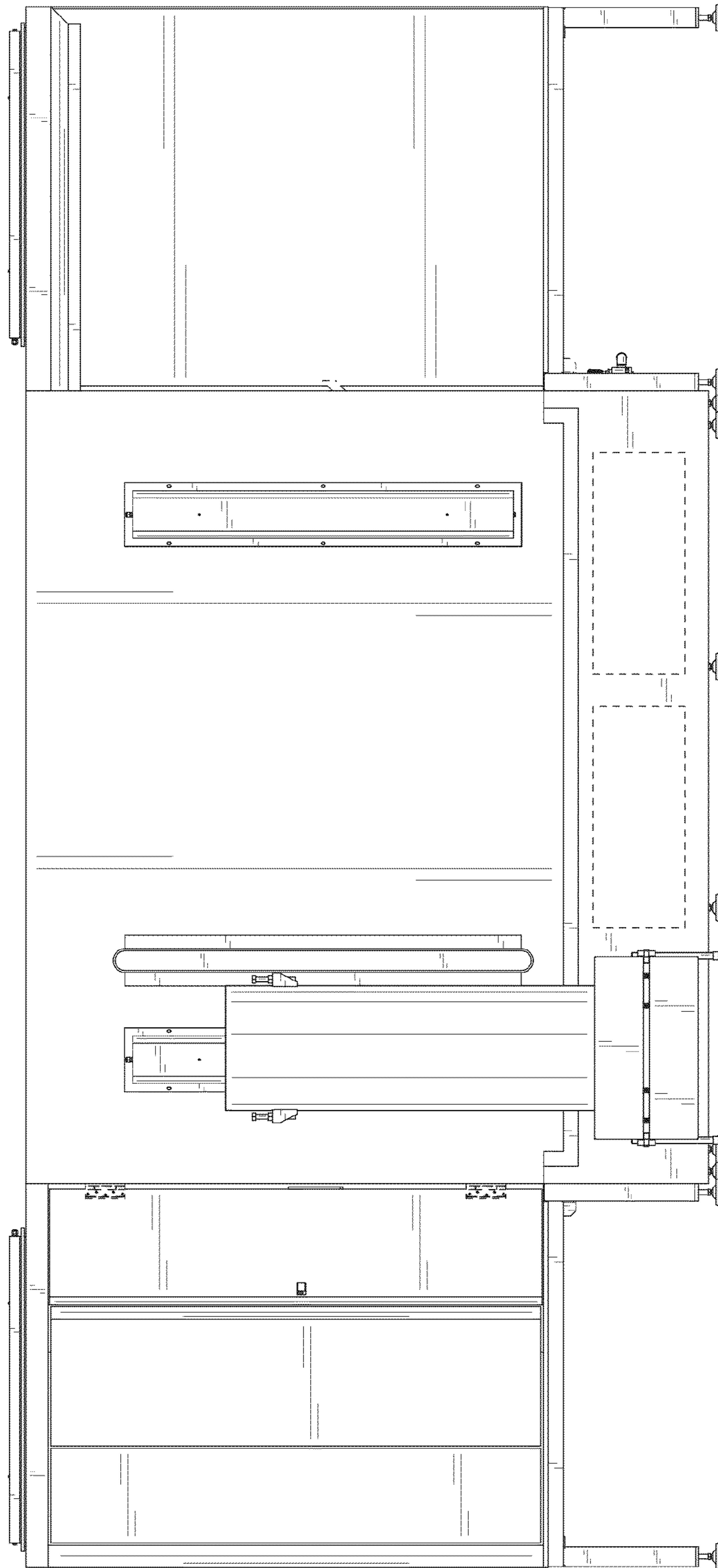

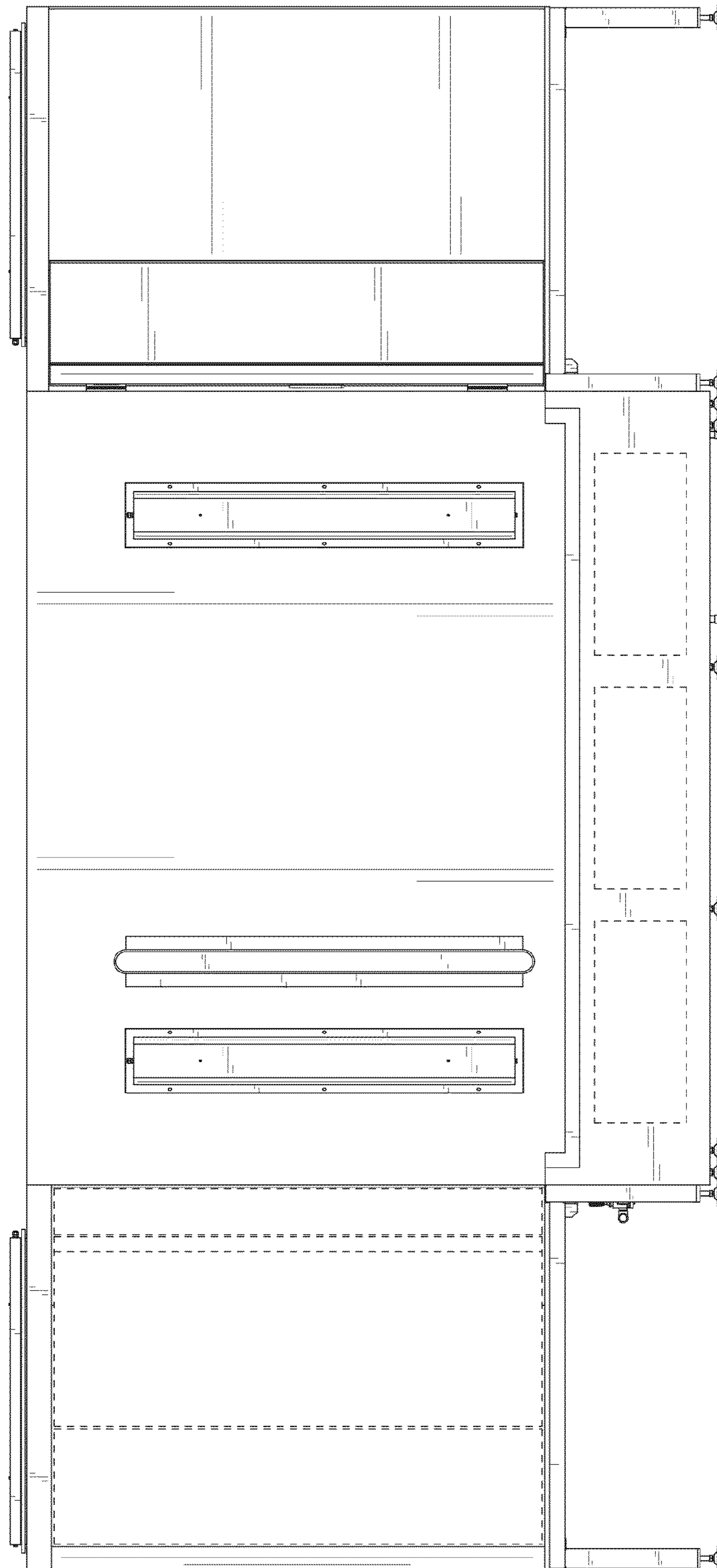

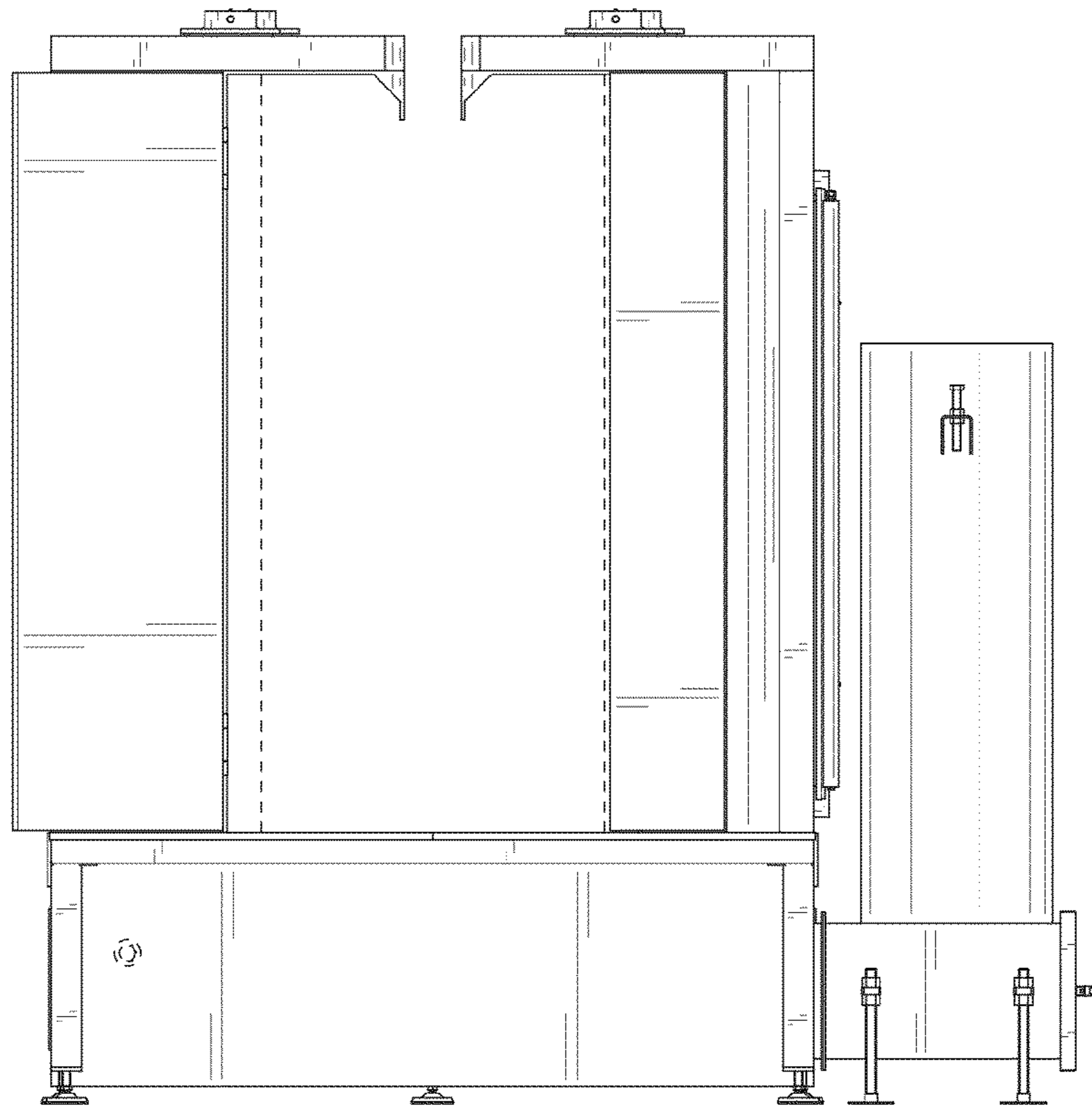

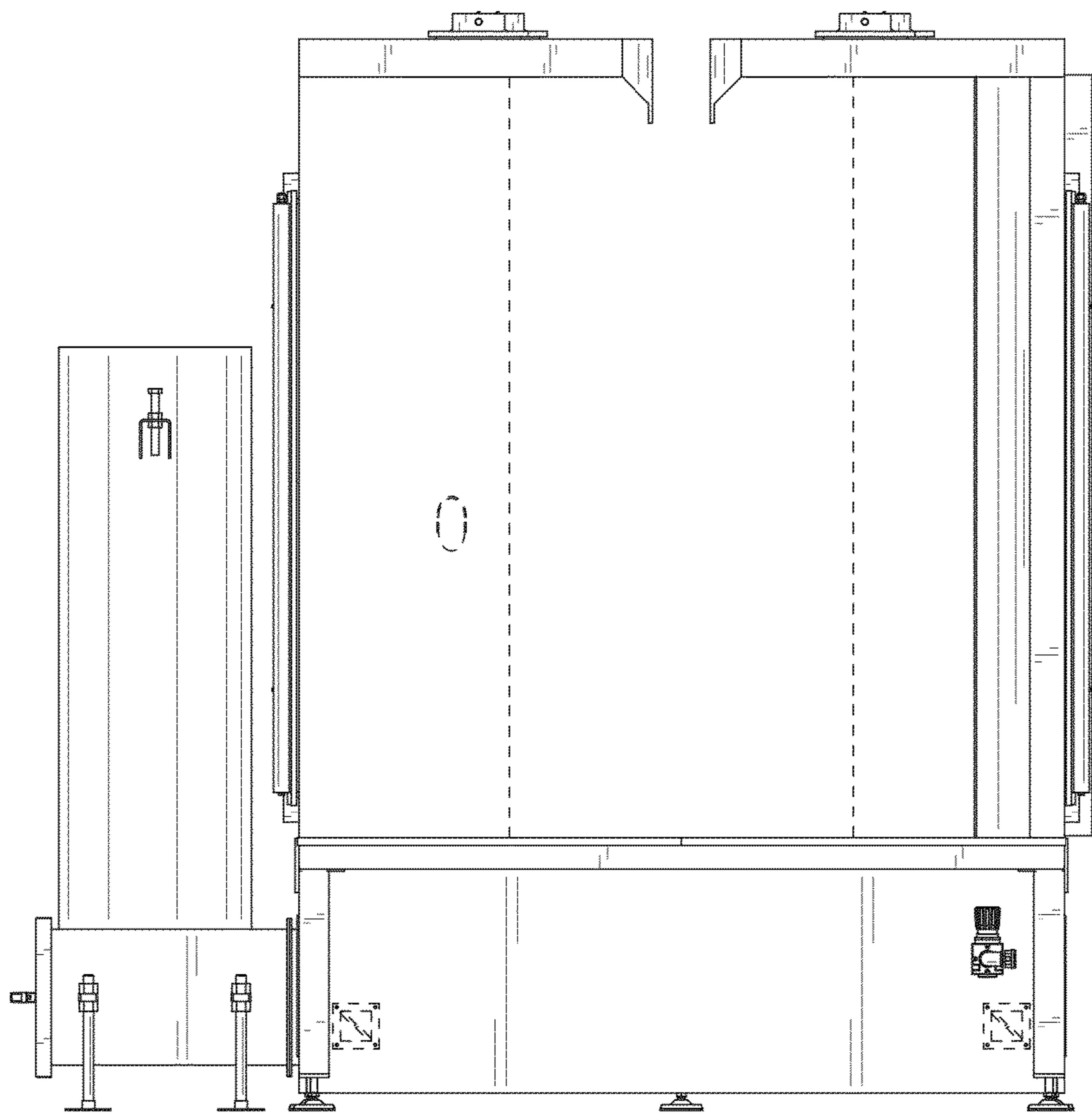

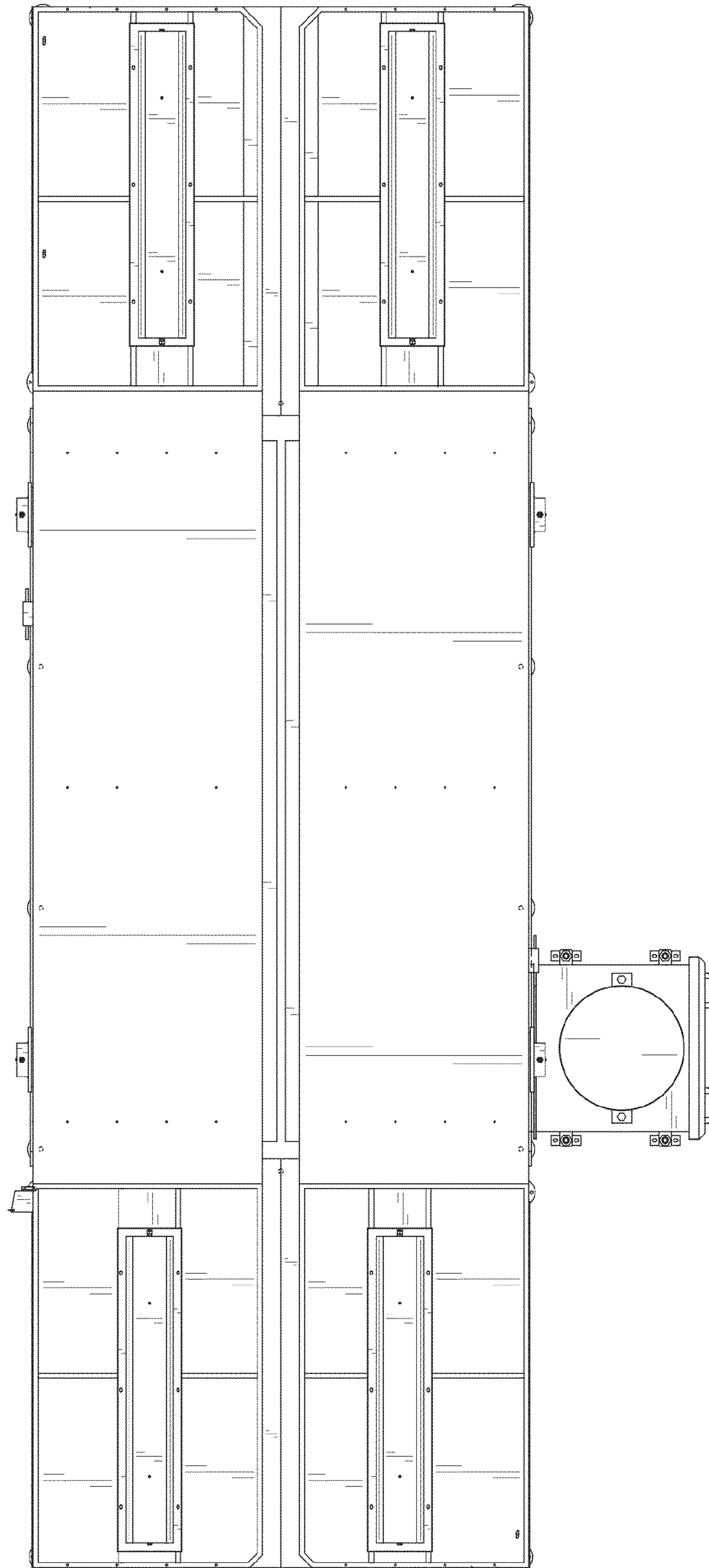

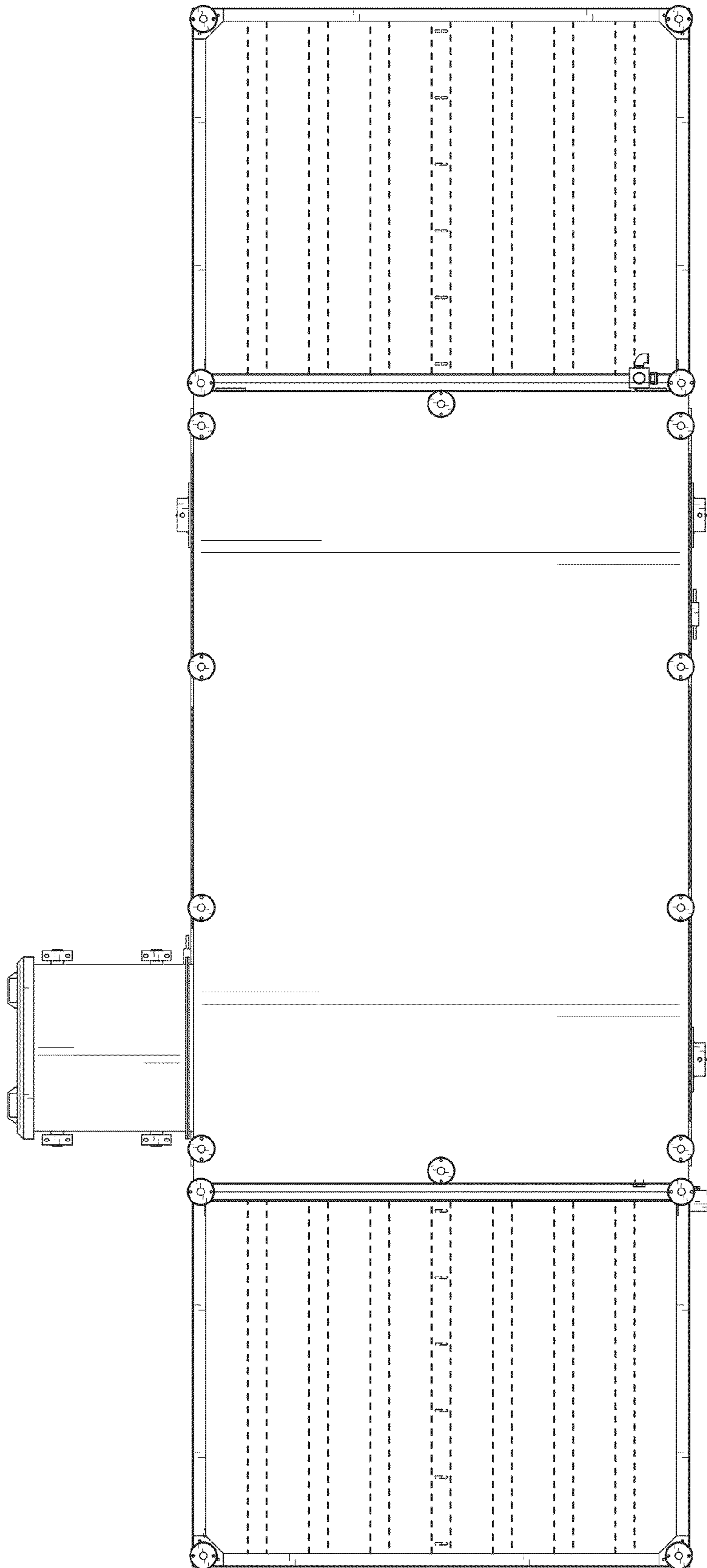
