(57) **CLAIM**

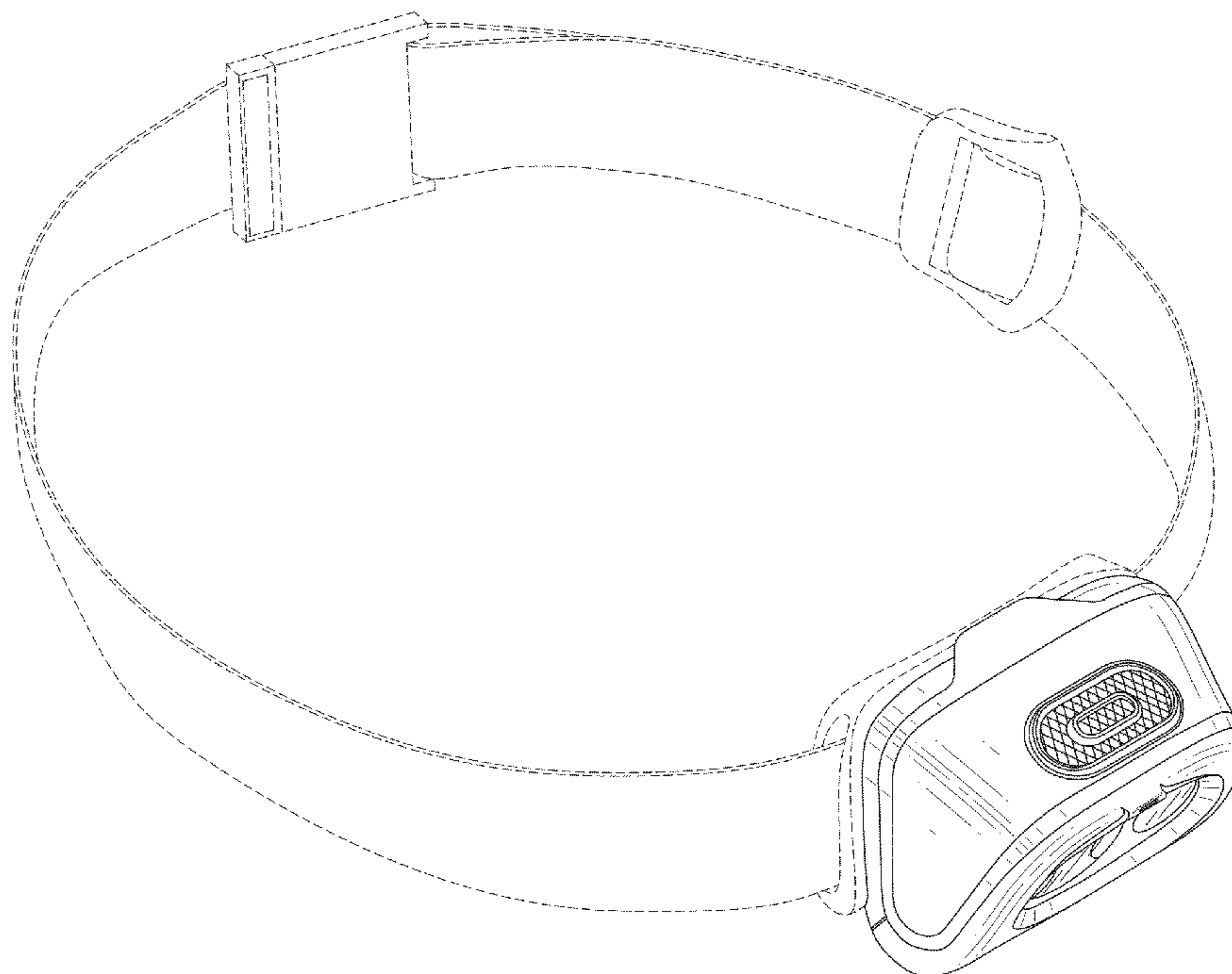
The ornamental design for a headlamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the headlamp with a strap;
FIG. 2 is a front view of the headlamp;
FIG. 3 is top view thereof;
FIG. 4 is a right-side view thereof (the left-side view being a mirror image of the right-side view);
FIG. 5 is a rear view thereof; and,
FIG. 6 is a bottom view thereof.

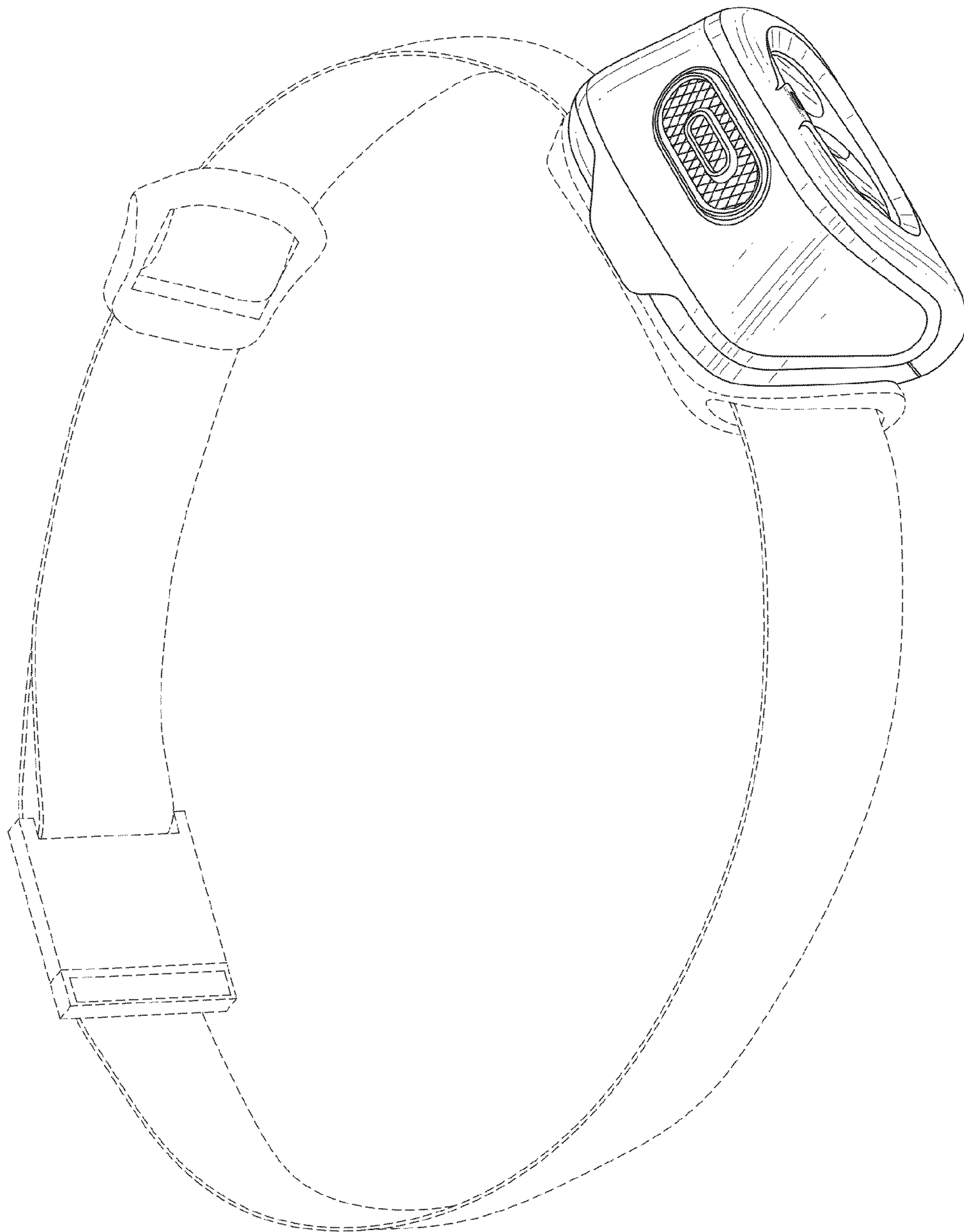

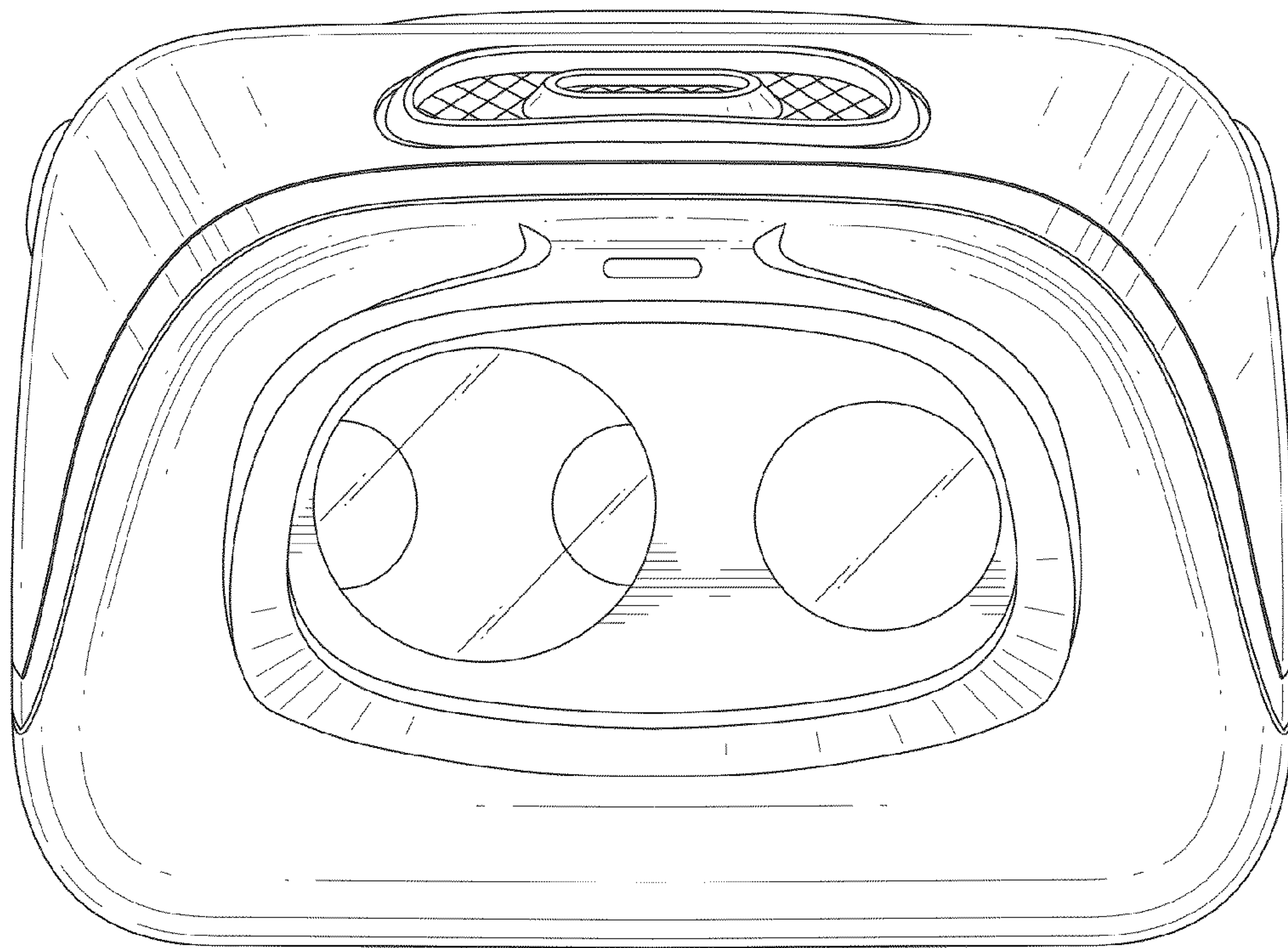

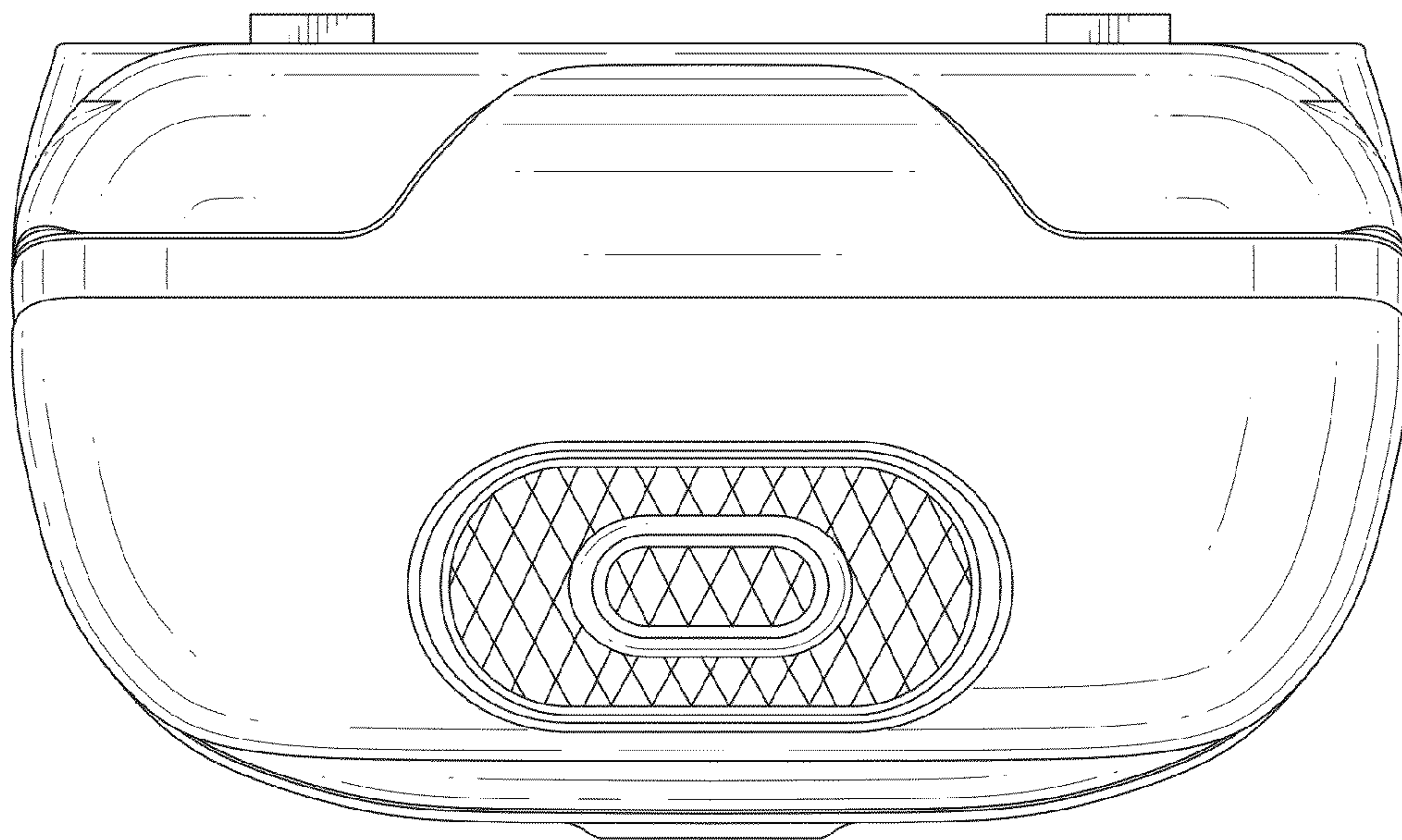

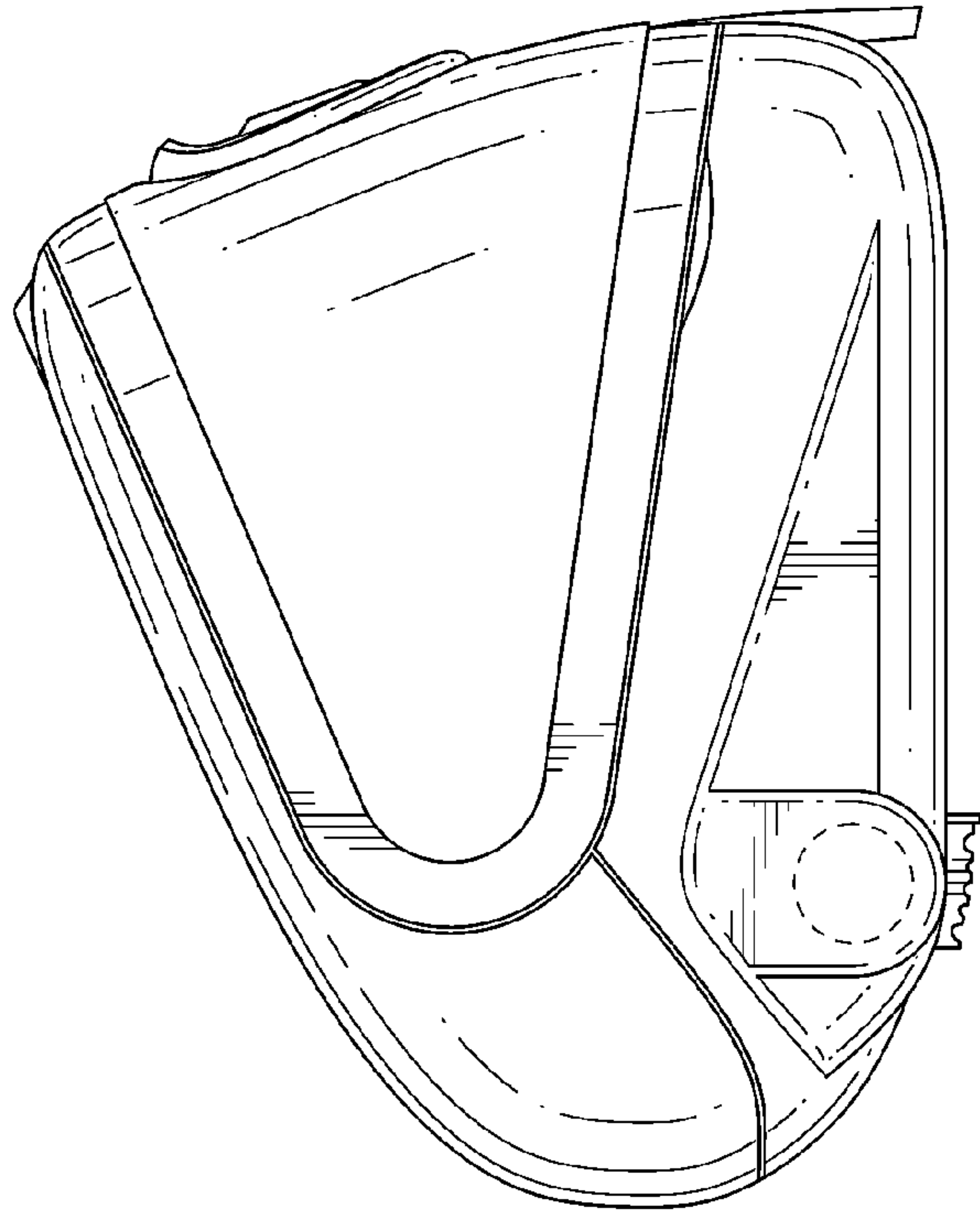

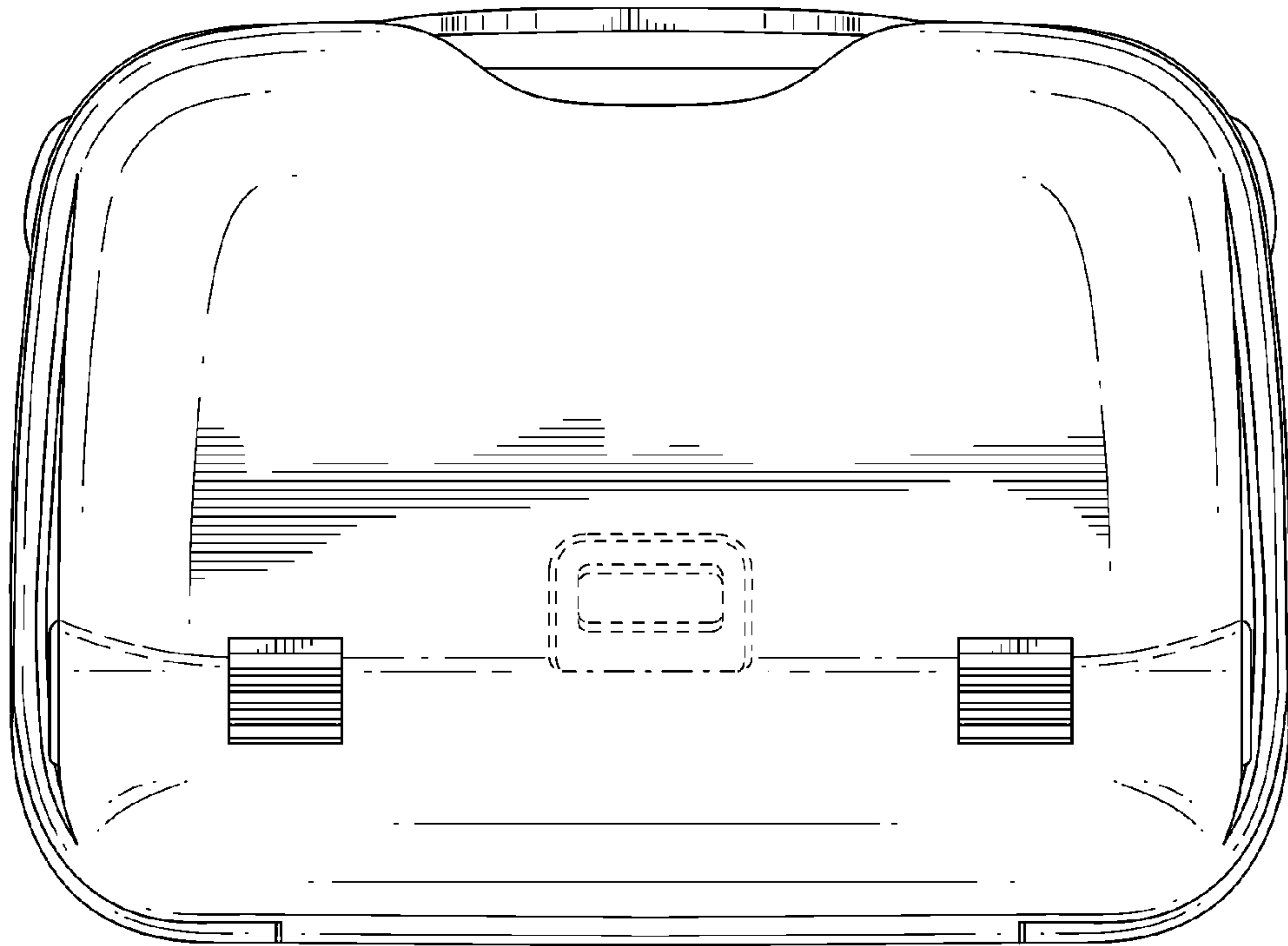

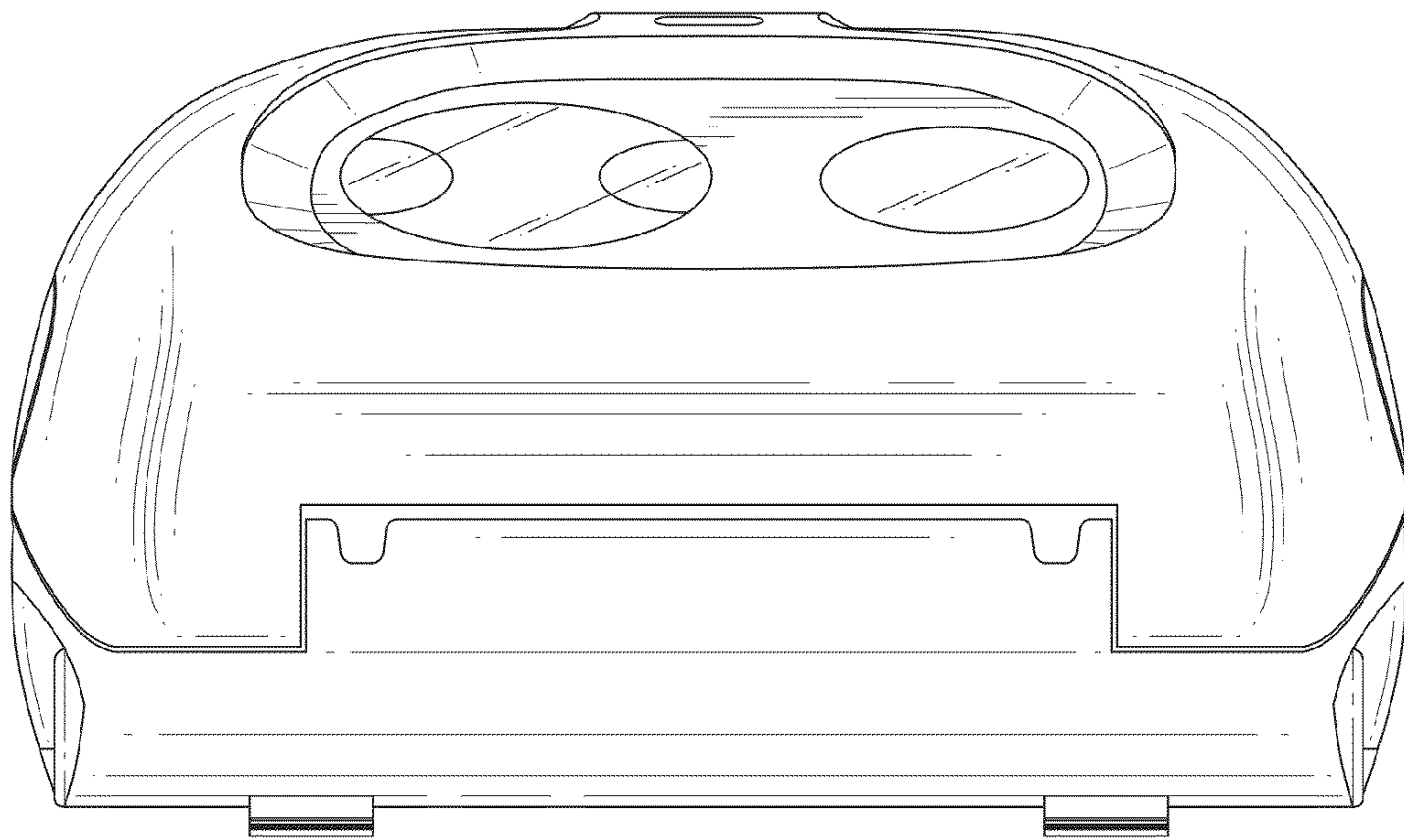
