(57) **CLAIM**

The ornamental design for a camouflage item for a hunter, or a soldier, or the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a camouflage item for a hunter, or a soldier, or the like, showing the design of the present invention.

FIG. 2 is a right side elevational view thereof.

FIG. 3 is a left side elevational view thereof.

FIG. 4 is a top plan view thereof.

FIG. 5 is a bottom plan view thereof.

FIG. 6 is a rear elevational view thereof.

FIG. 7 is a front elevational view thereof; and,

FIG. 8 is taken along line 8-8 of FIG. 4 of the interior section of the left side thereof, the right side of the interior section being a mirror image of the left side.

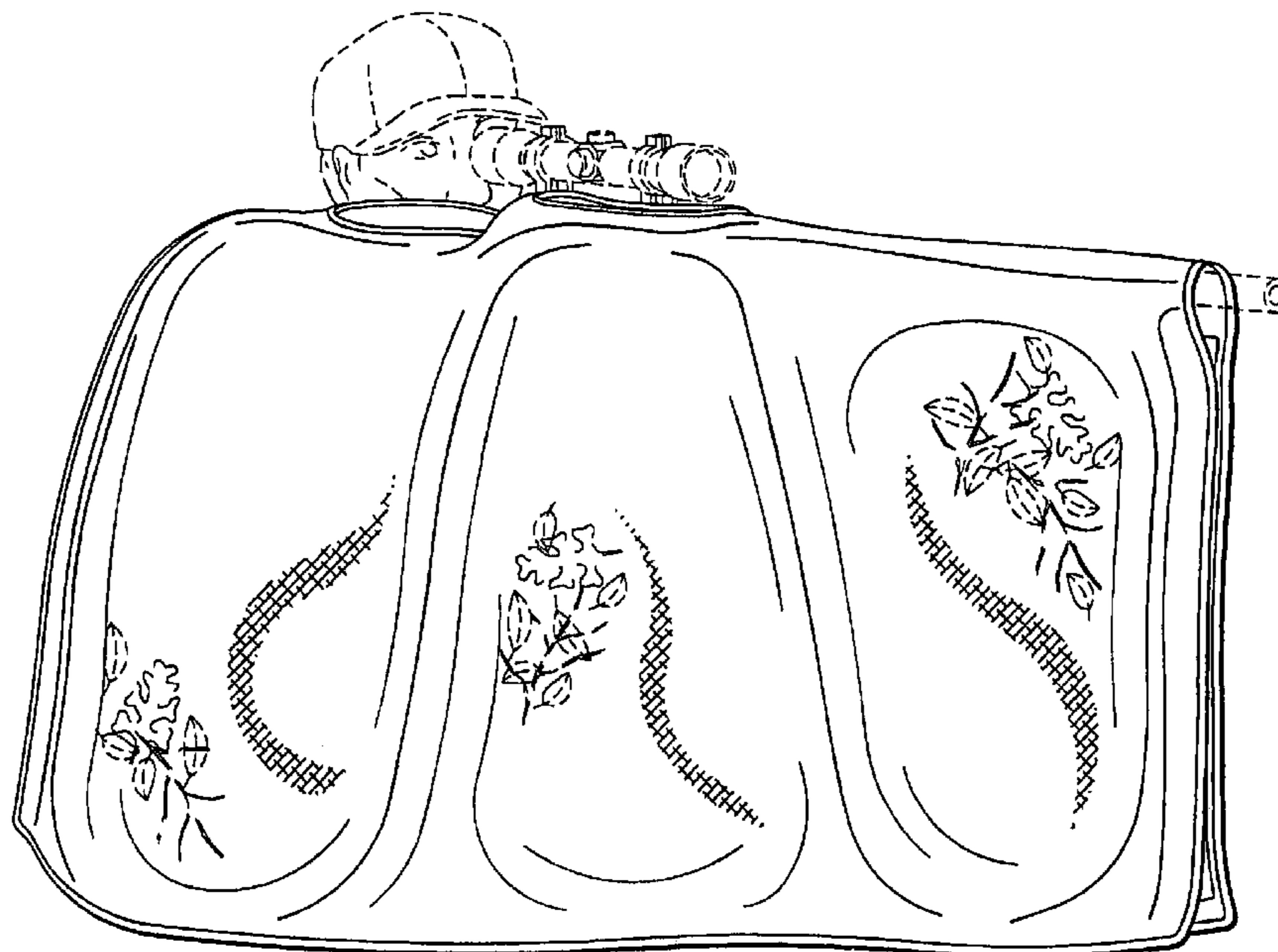
The broken lines depict portions of the camouflage item for a hunter, or a soldier, or the like that form no part of the claimed design. Additionally the hunter shown in FIG. 1 shows environment only and likewise forms no part of the claimed design. It is also to be understood that the camouflage pattern in the material may vary from that shown.

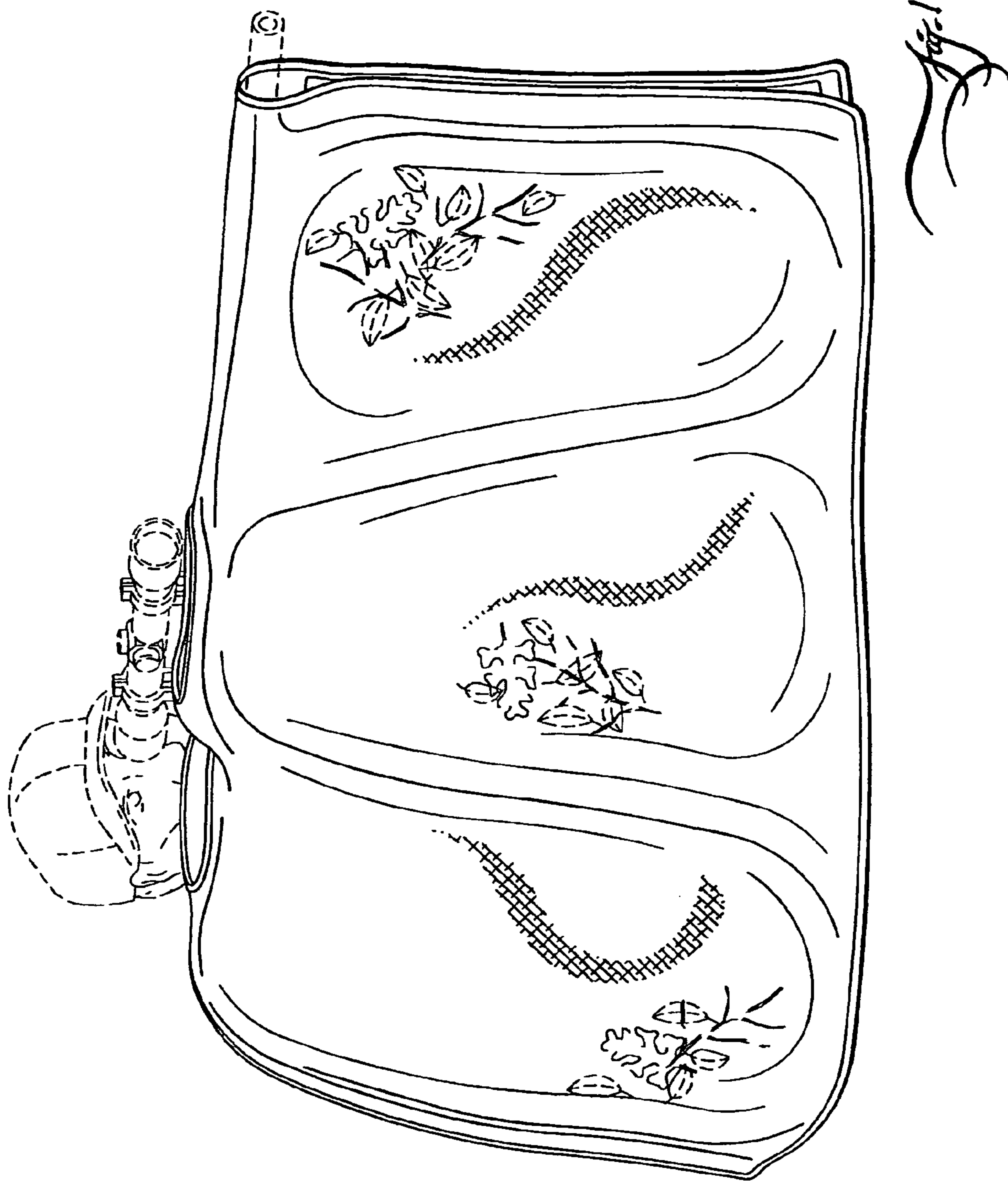

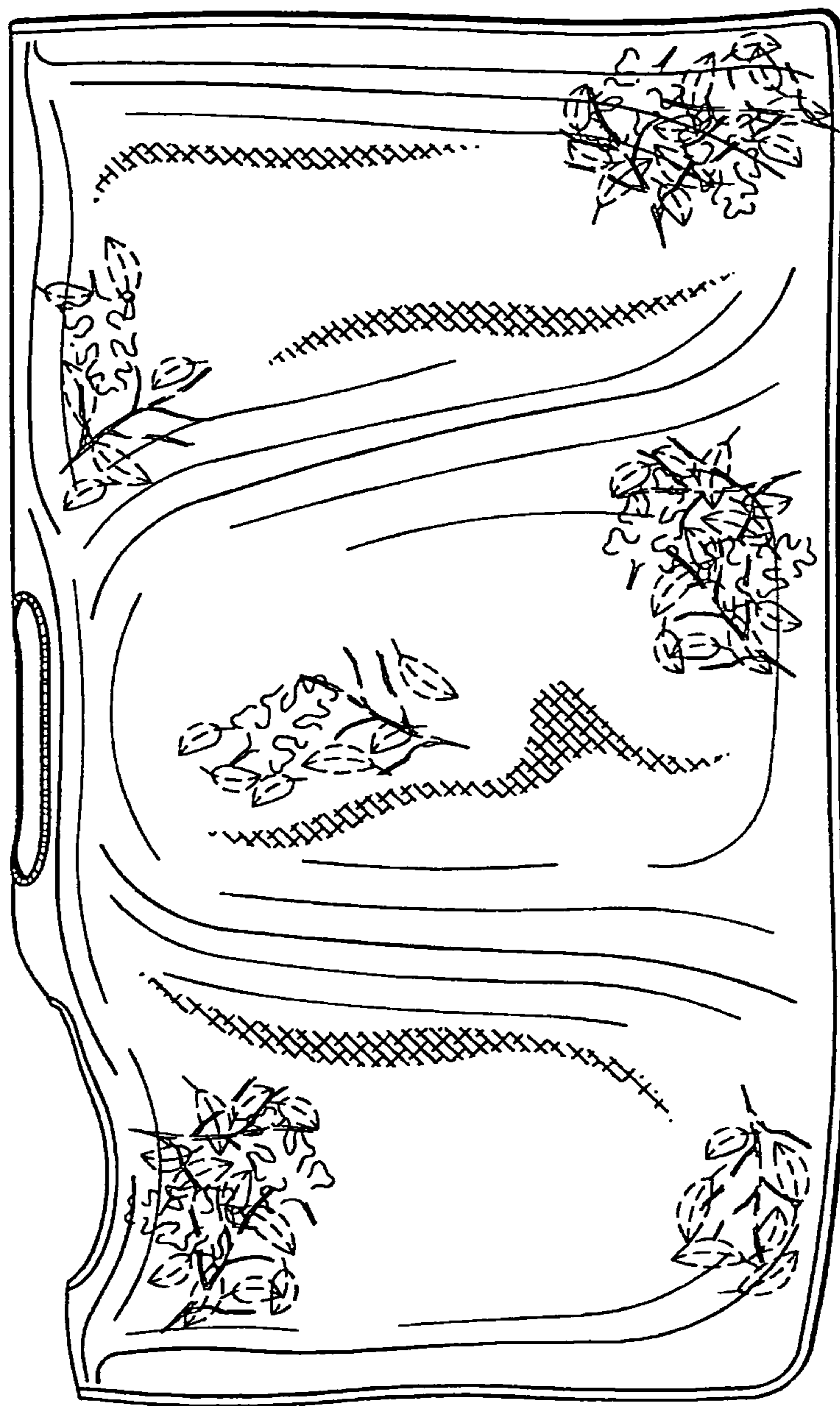

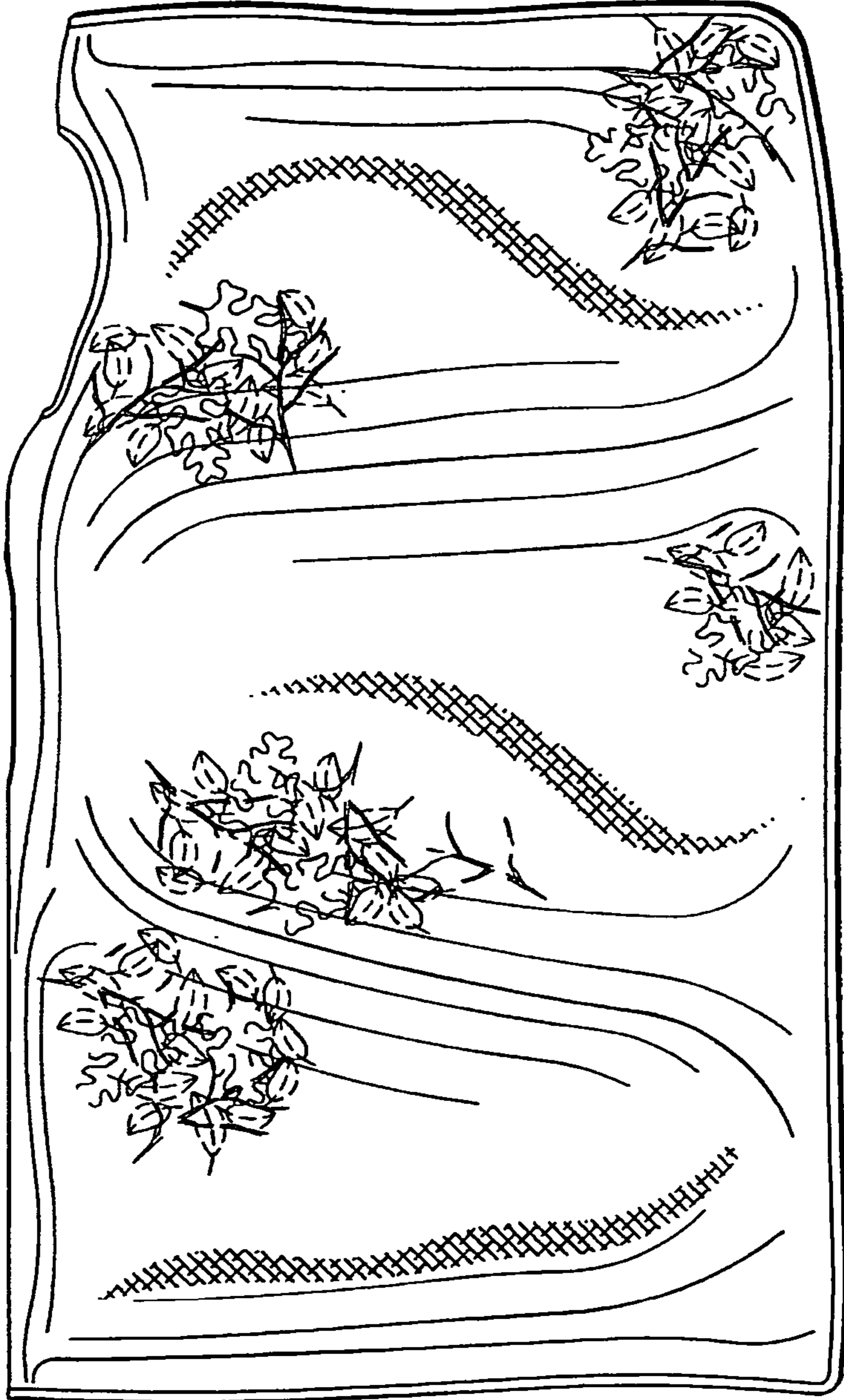
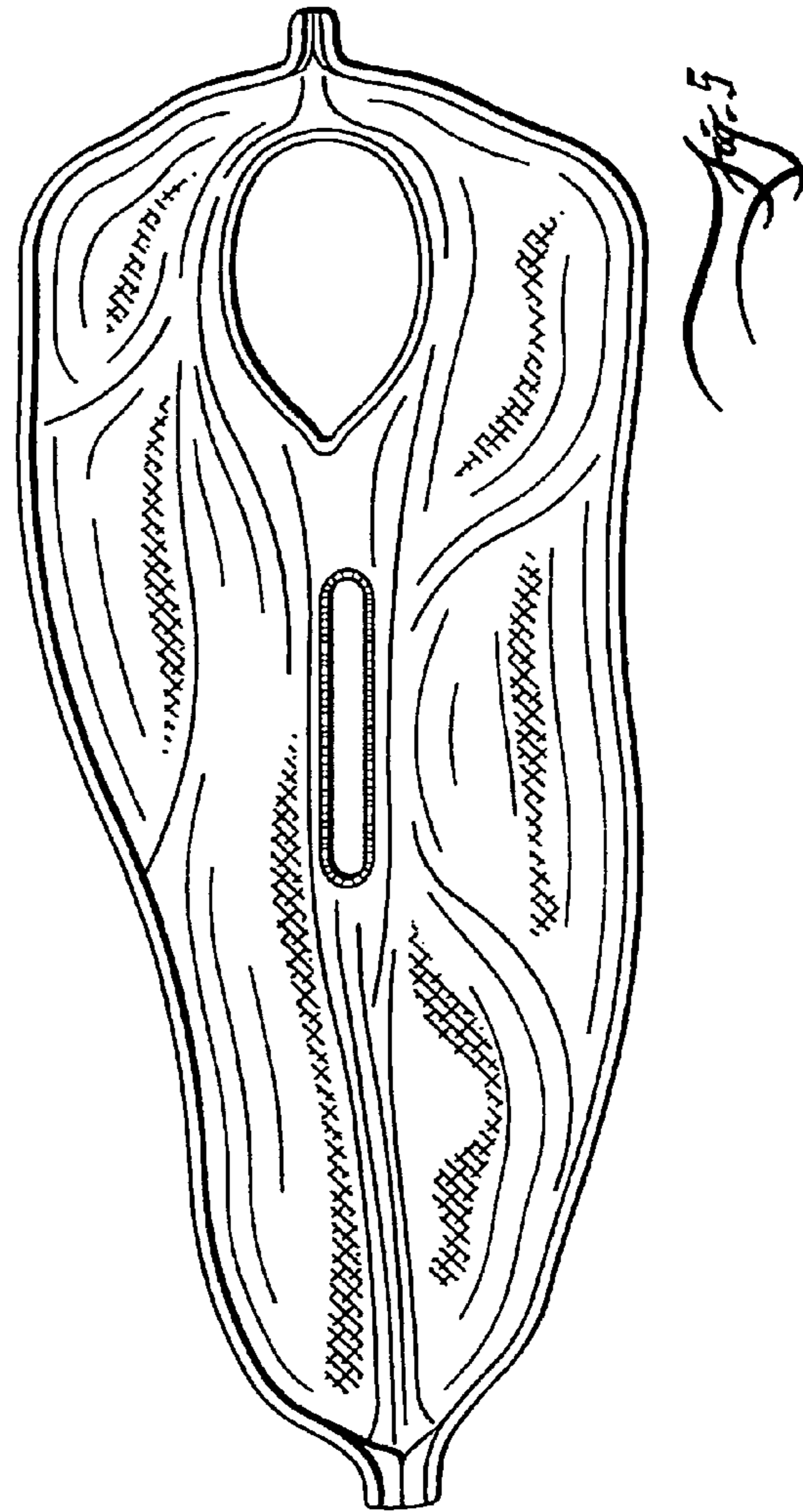
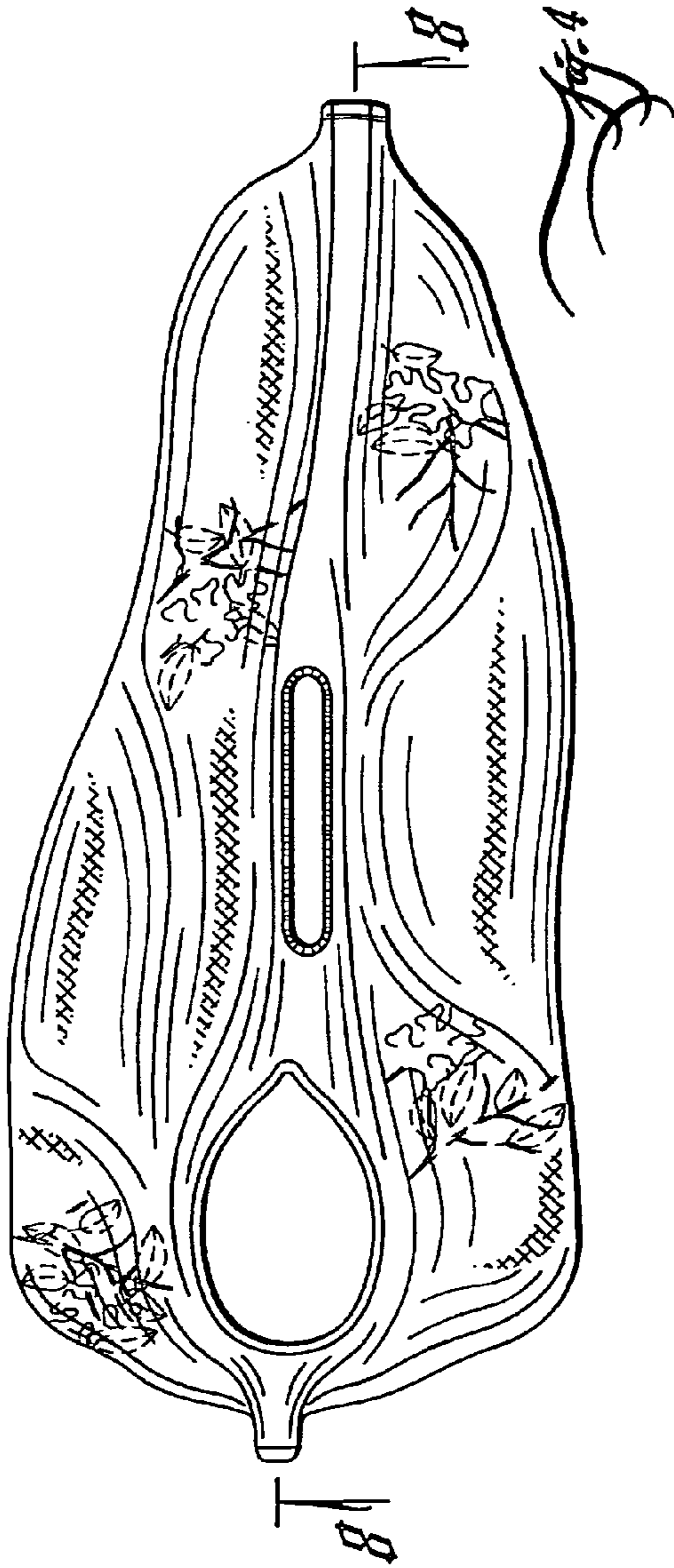

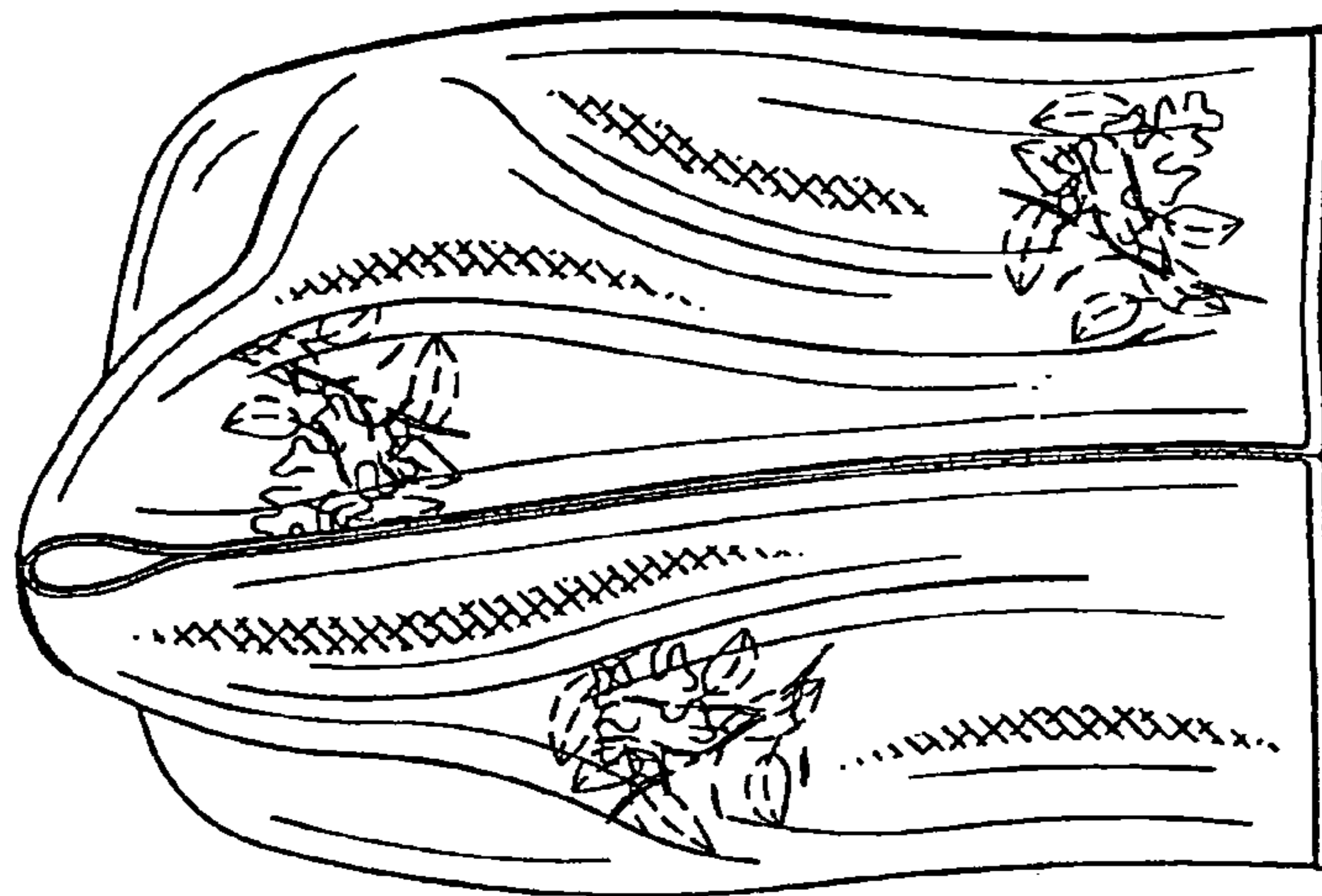

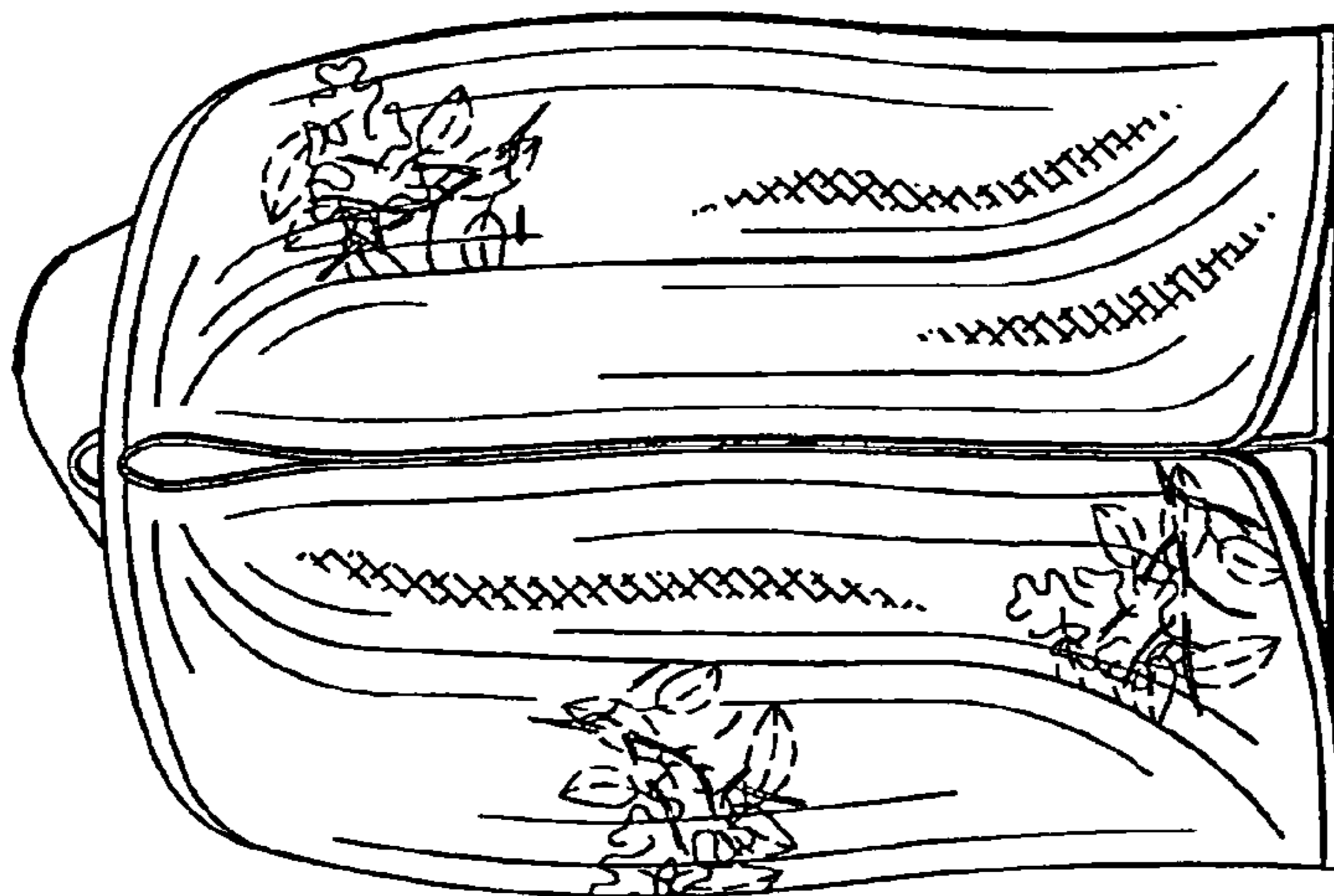

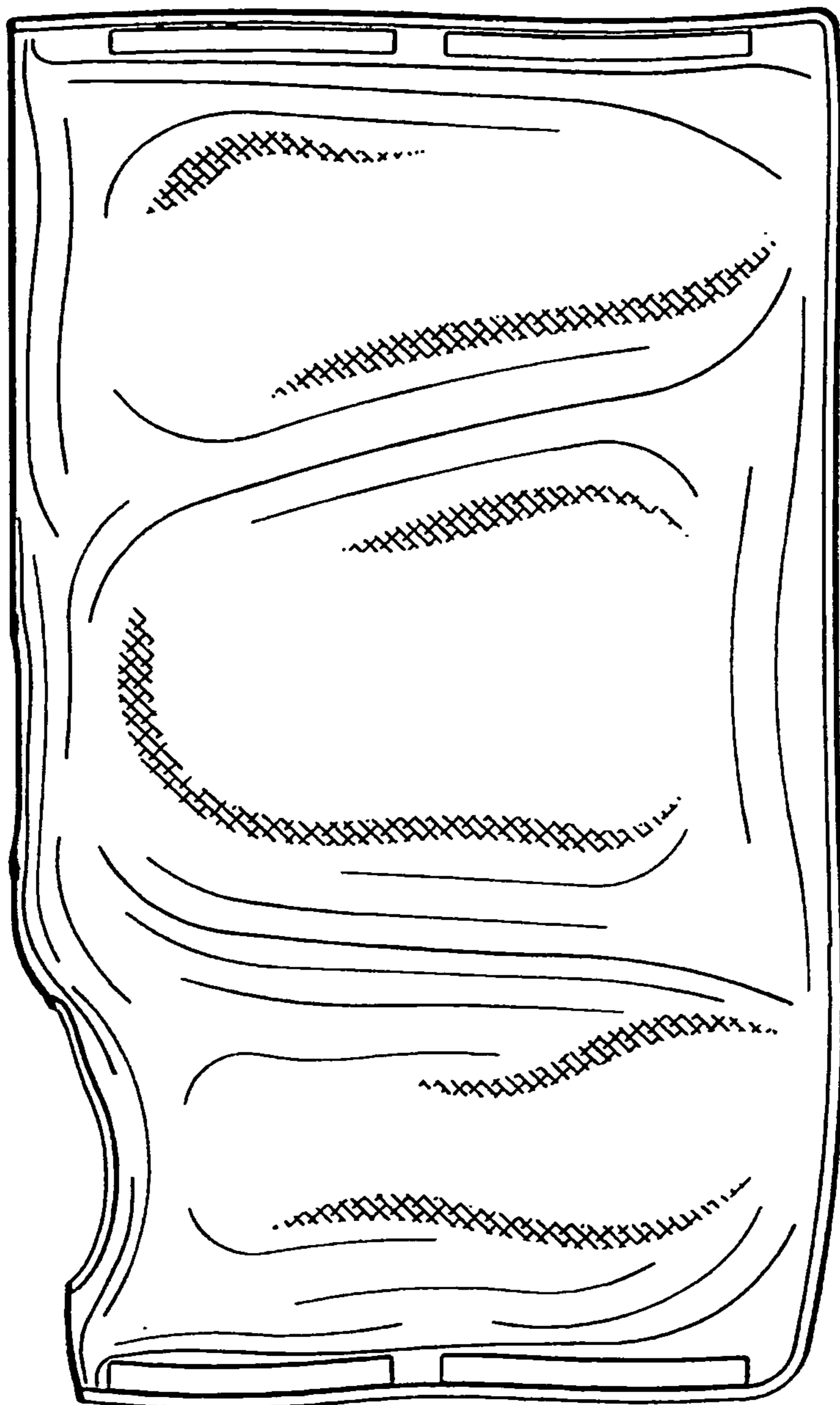
