FIG. 3 is a rear elevation view of my design;

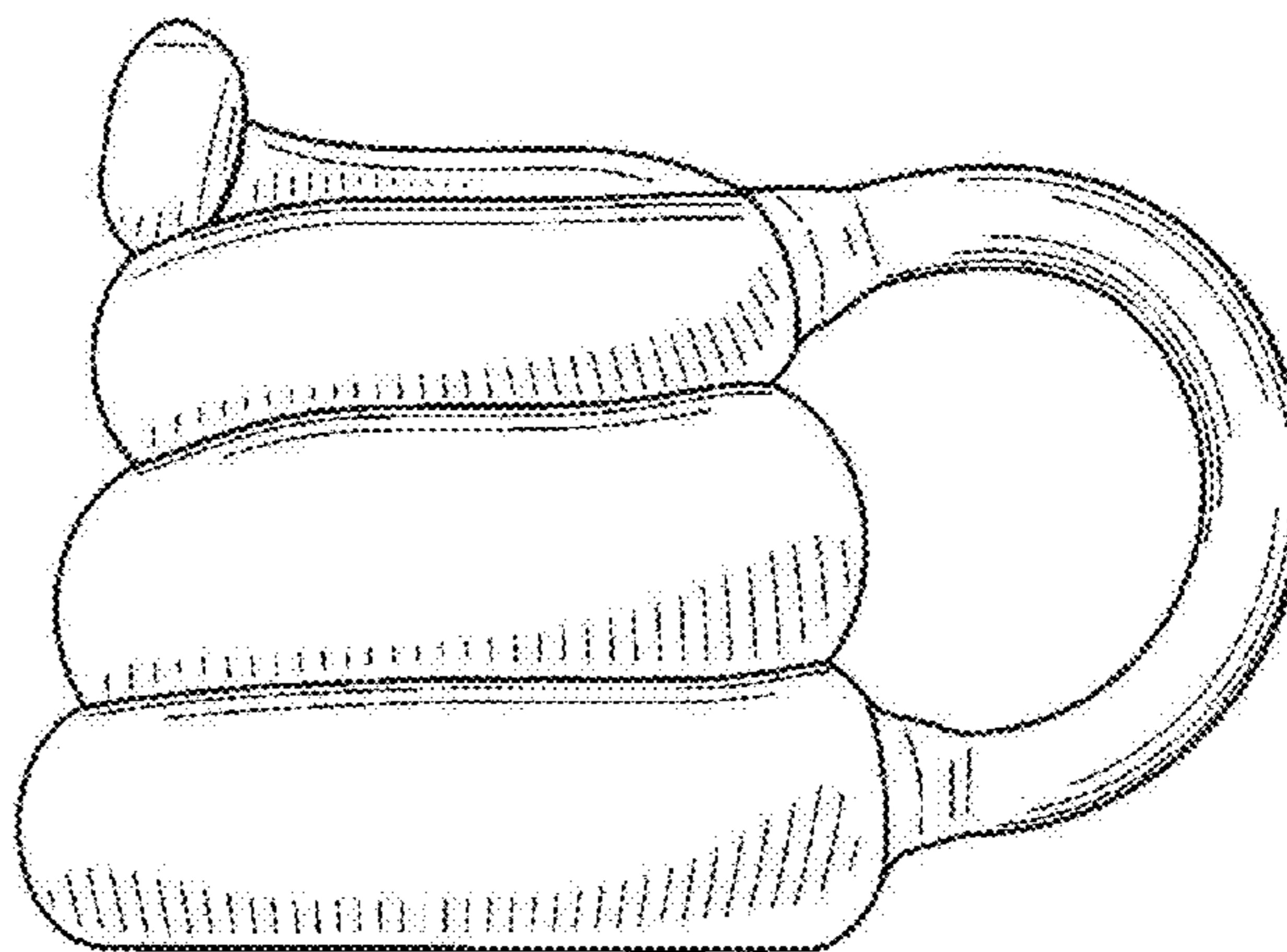
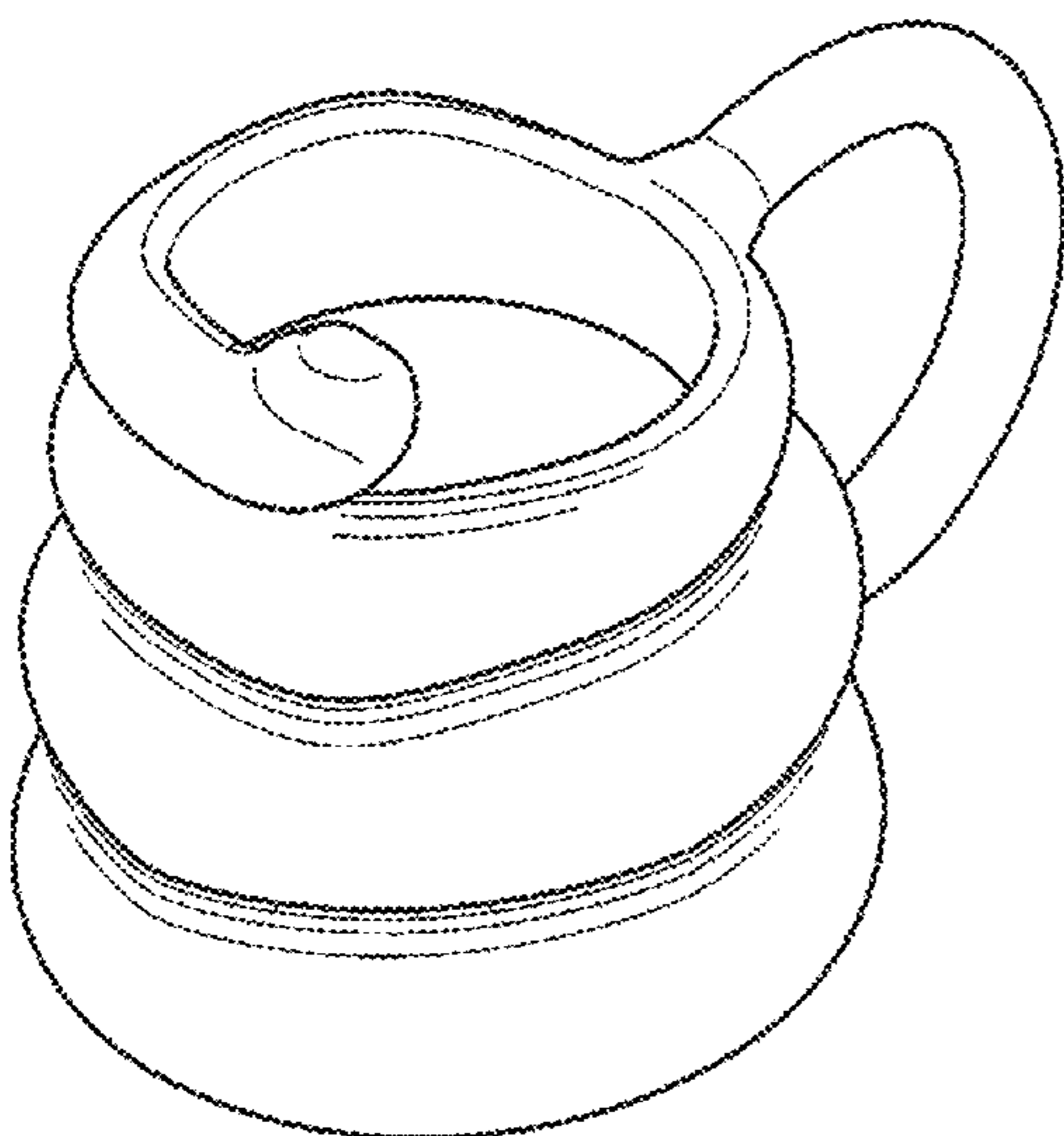
FIG. 4 is a right side view thereof;

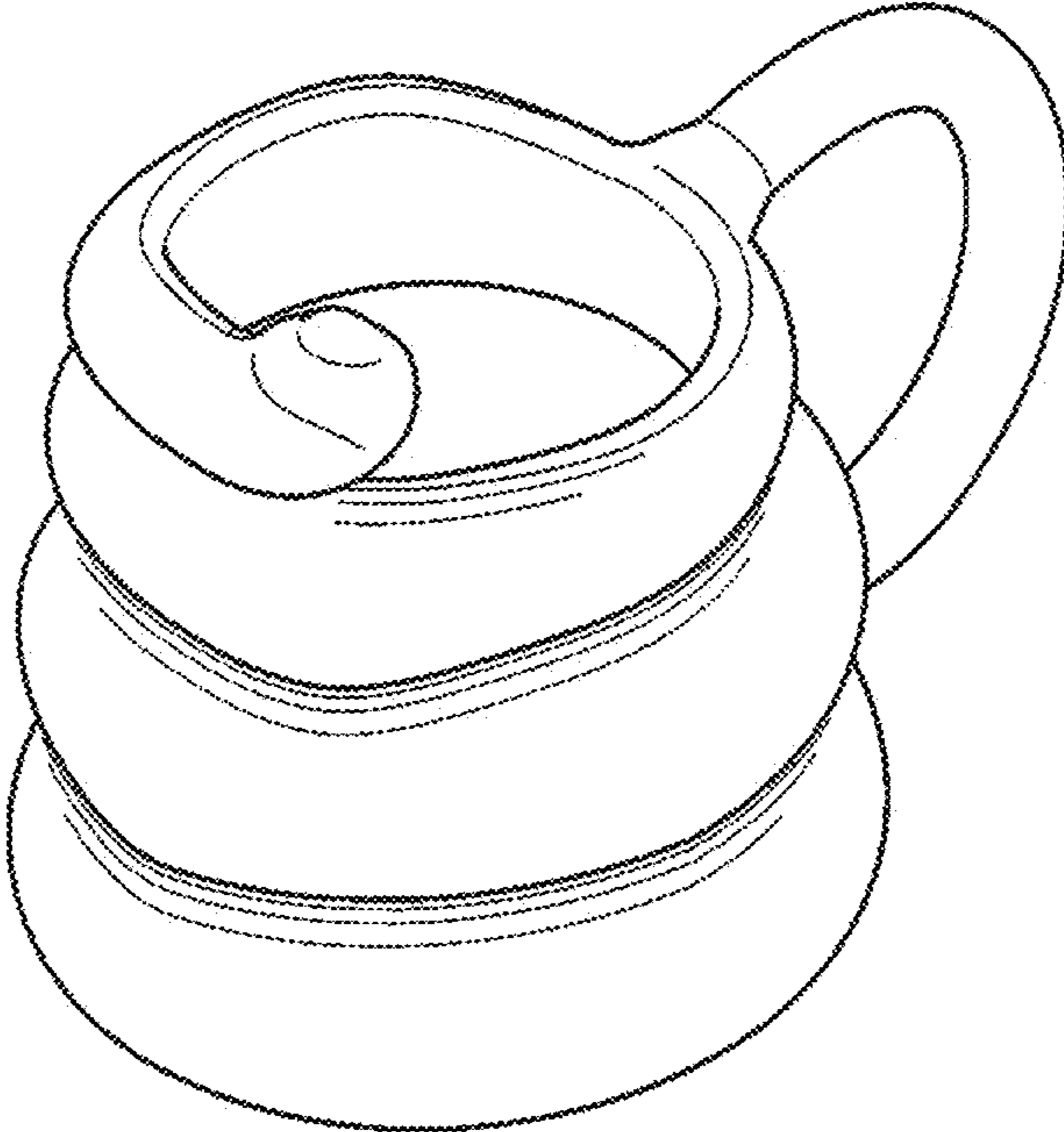

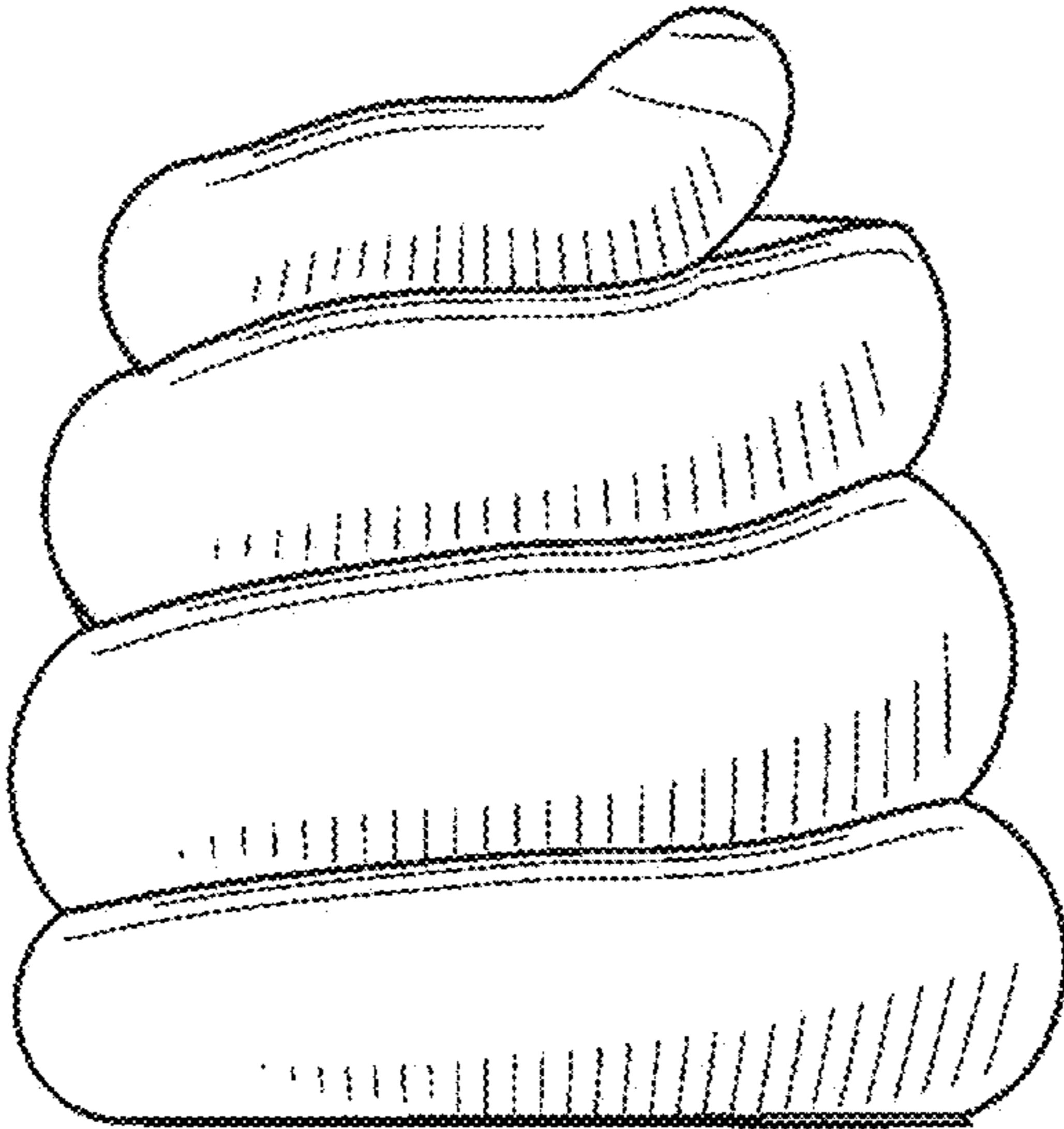

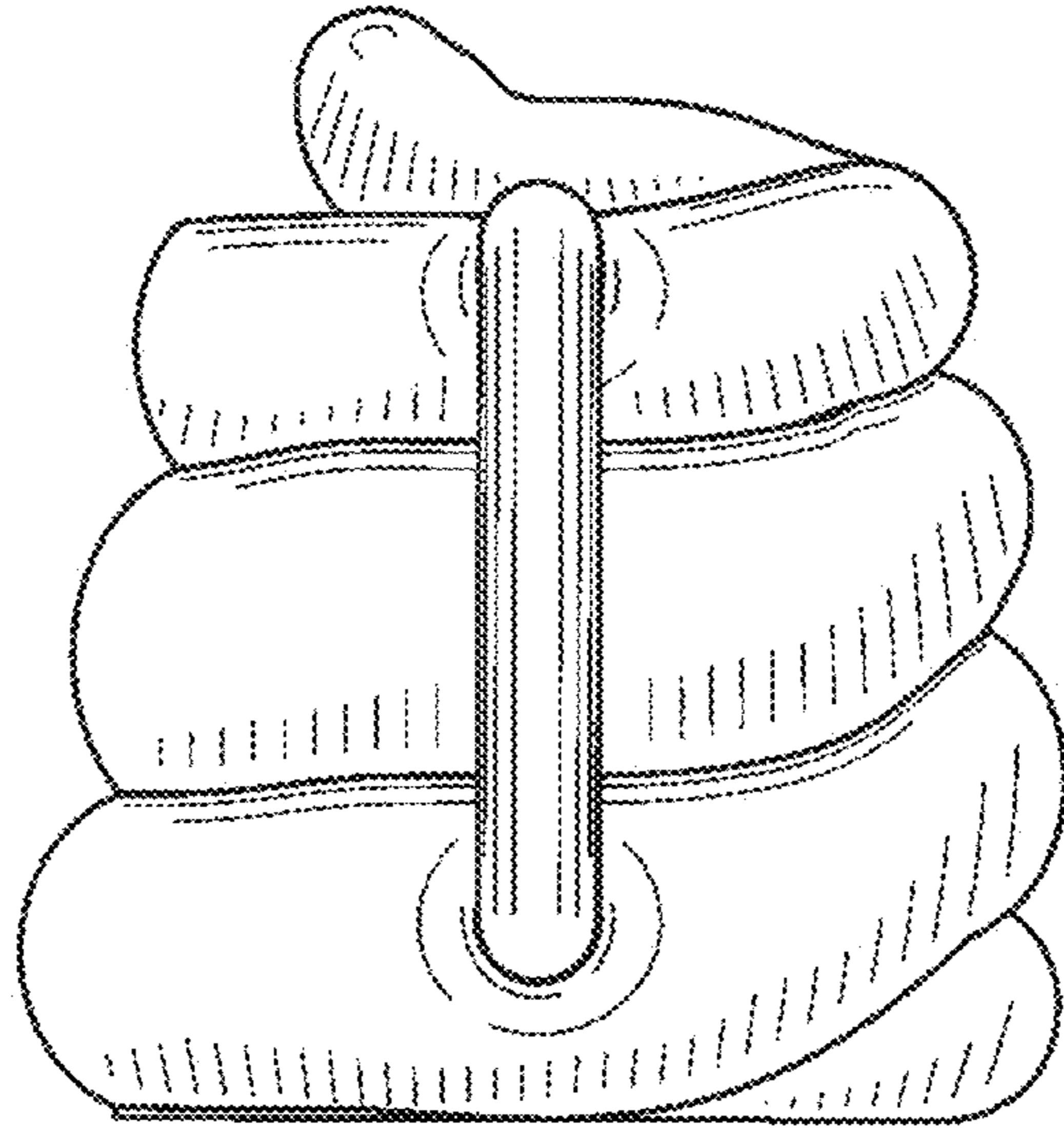

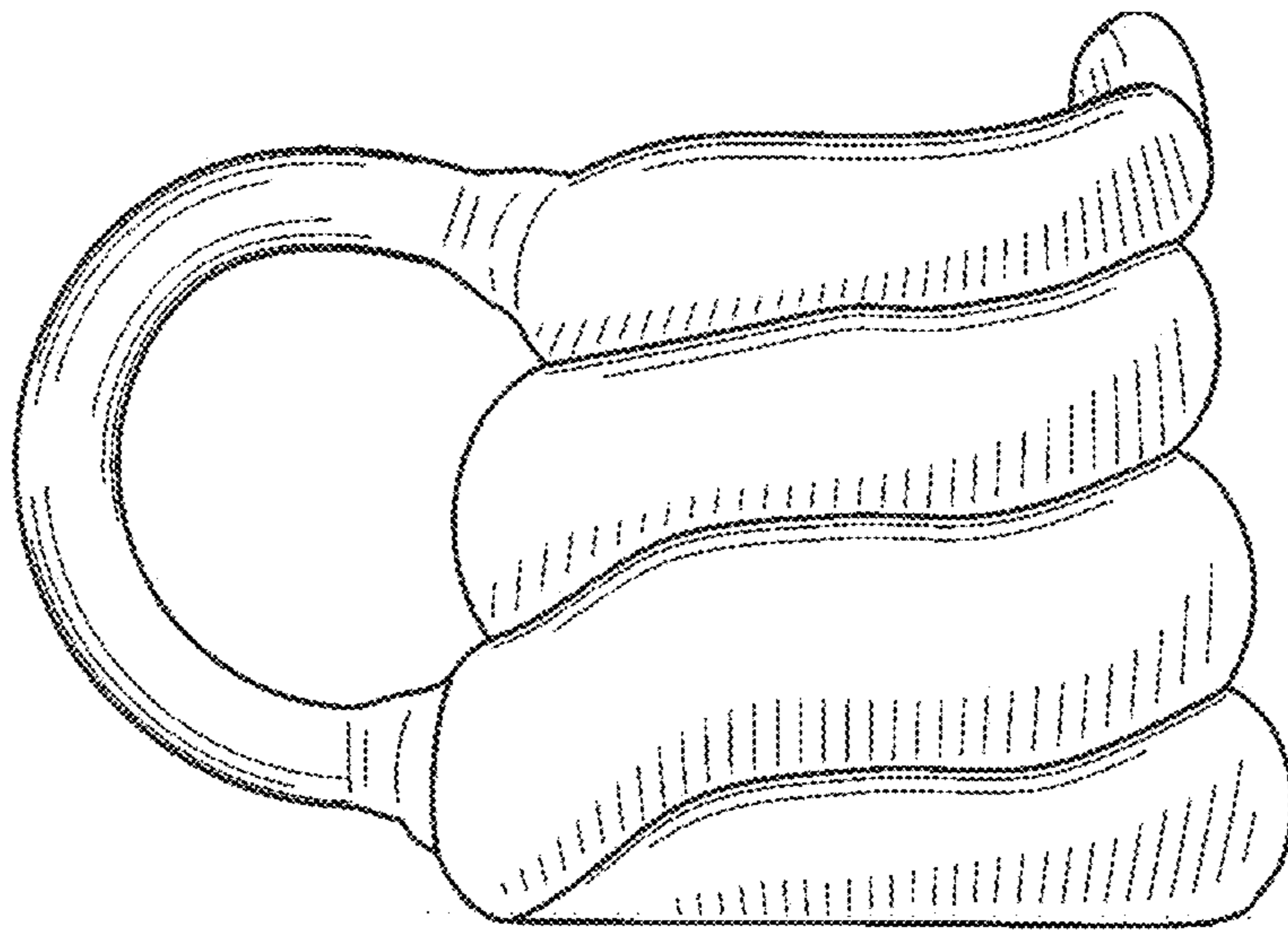

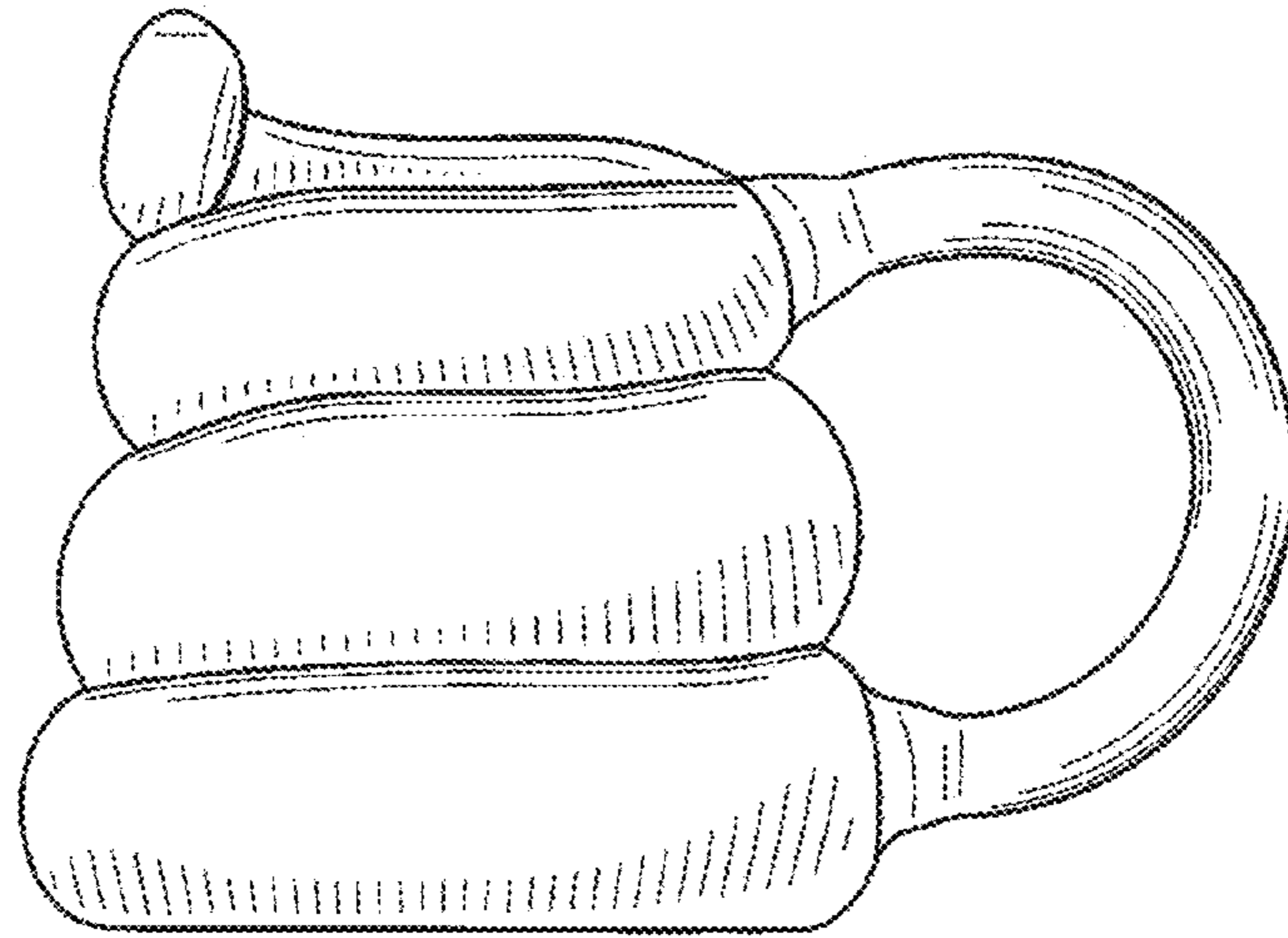

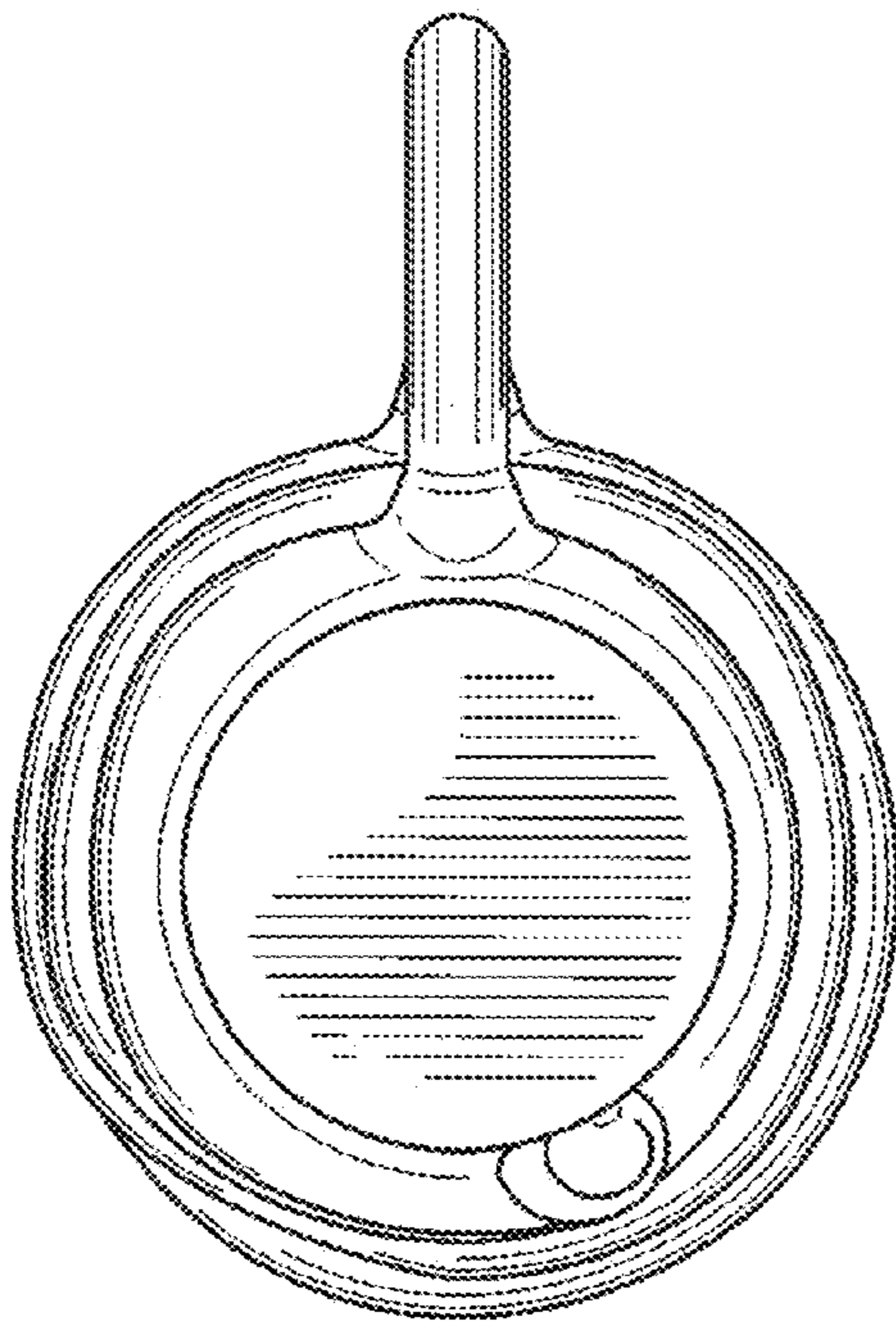

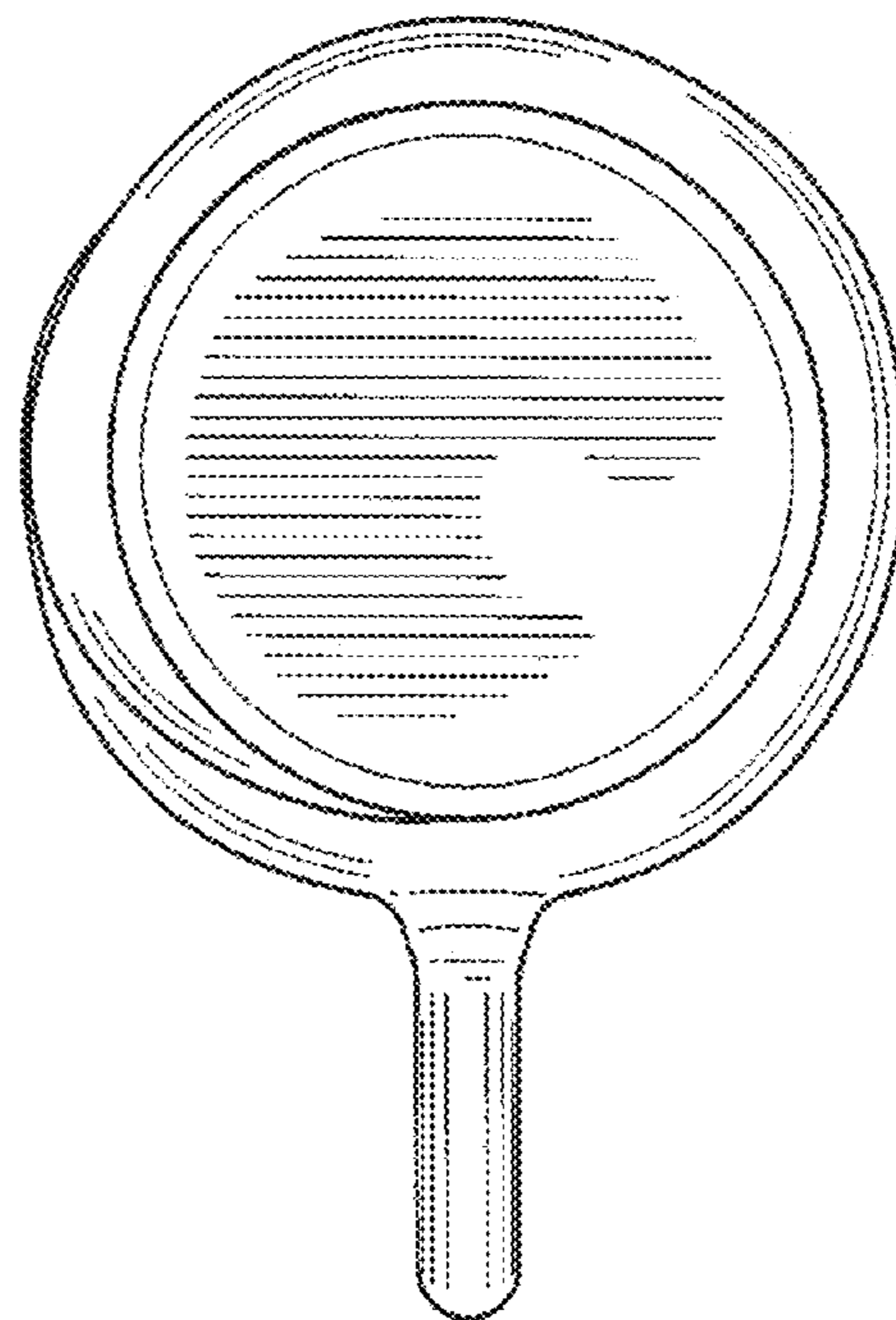
