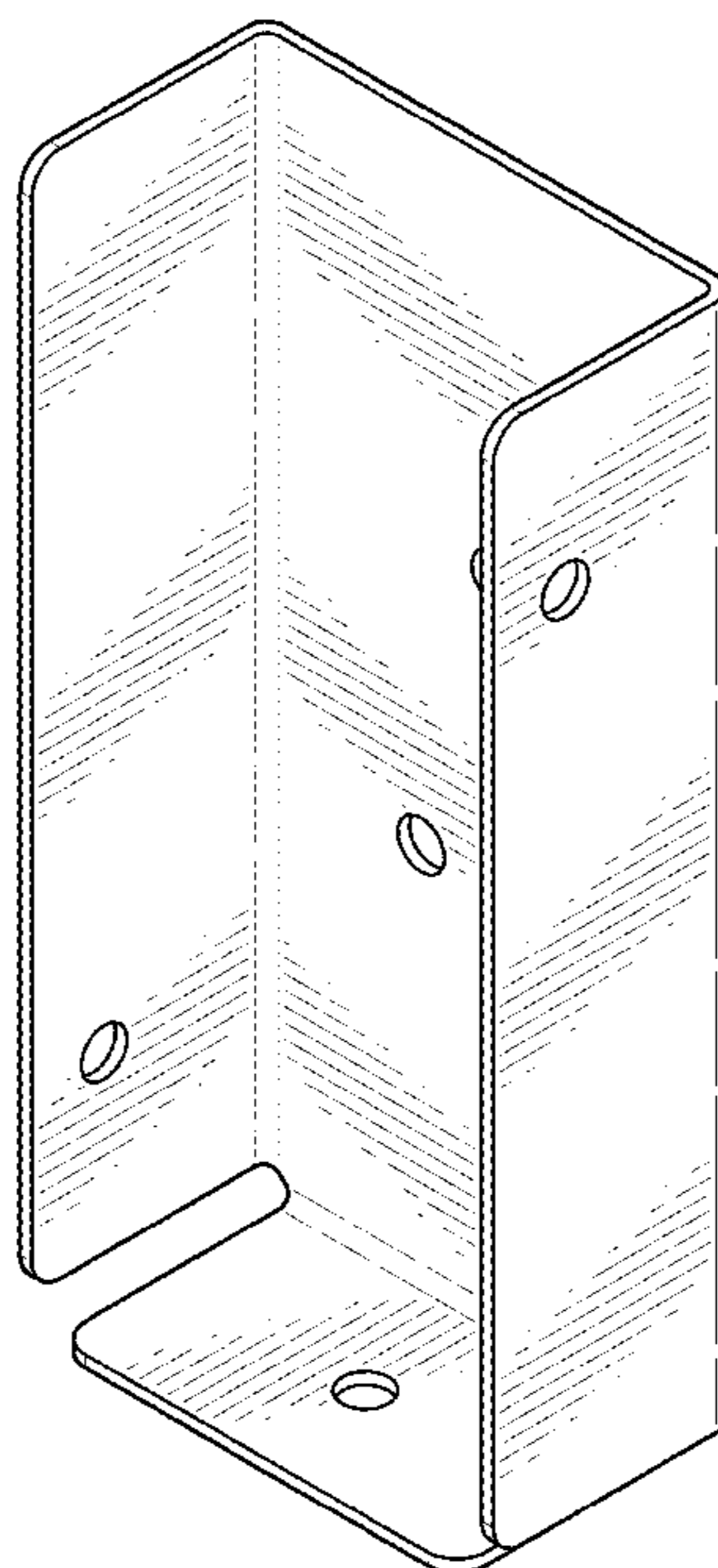
(57) **CLAIM**

The ornamental design for a fence bracket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the fence bracket of the present invention as viewed from the front, right and above.  
FIG. 2 is a perspective view of the fence bracket as viewed from the front, left and above.  
FIG. 3 is a perspective view of the fence bracket as viewed from the front, right and below.  
FIG. 4 is a perspective view of the fence bracket as viewed from the front, left and below.  
FIG. 5 is a front elevation view of the fence bracket.  
FIG. 6 is a rear elevation view of the fence bracket.  
FIG. 7 is a top plan view of the fence bracket.  
FIG. 8 is a bottom plan view of the fence bracket.  
FIG. 9 is a left side elevation view of the fence bracket; and, FIG. 10 is a right side elevation view of the fence bracket.

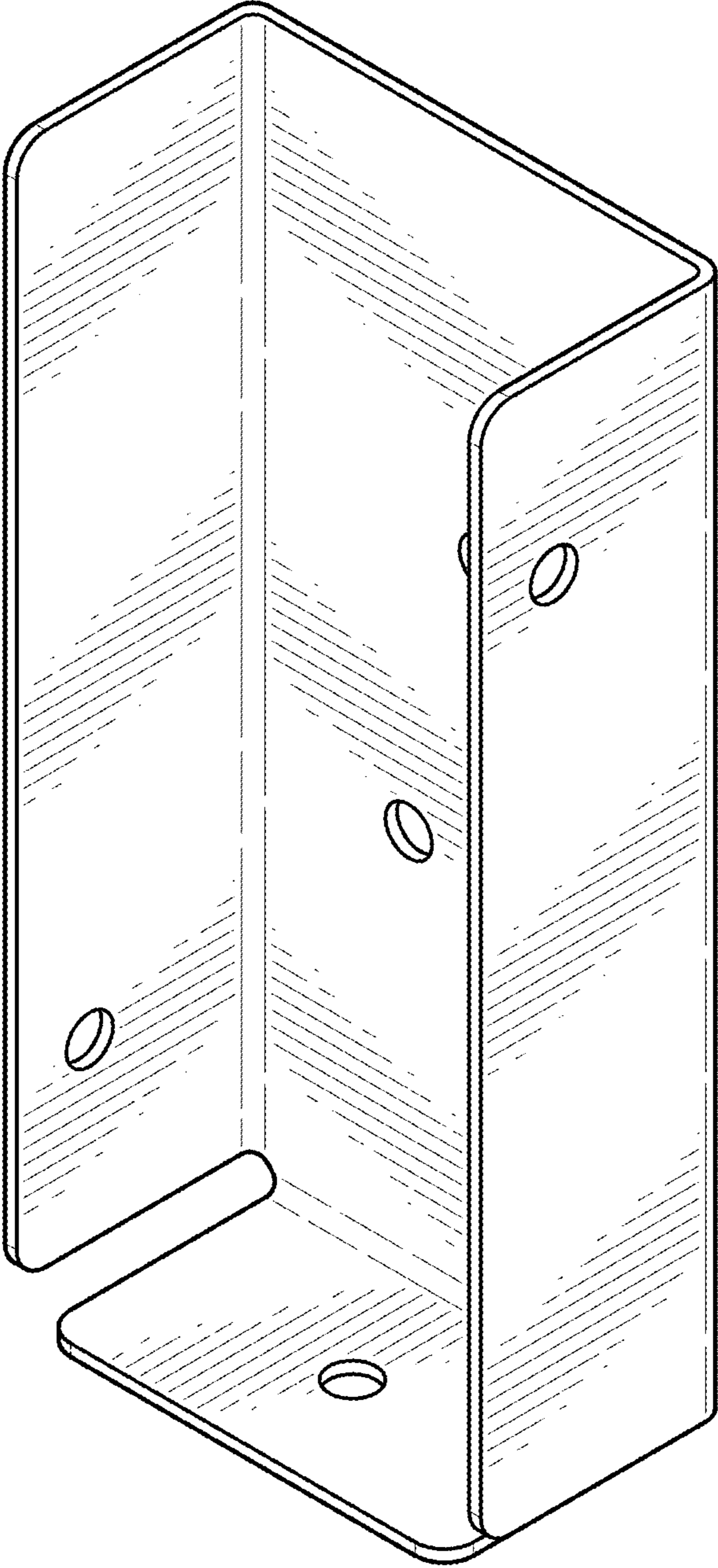

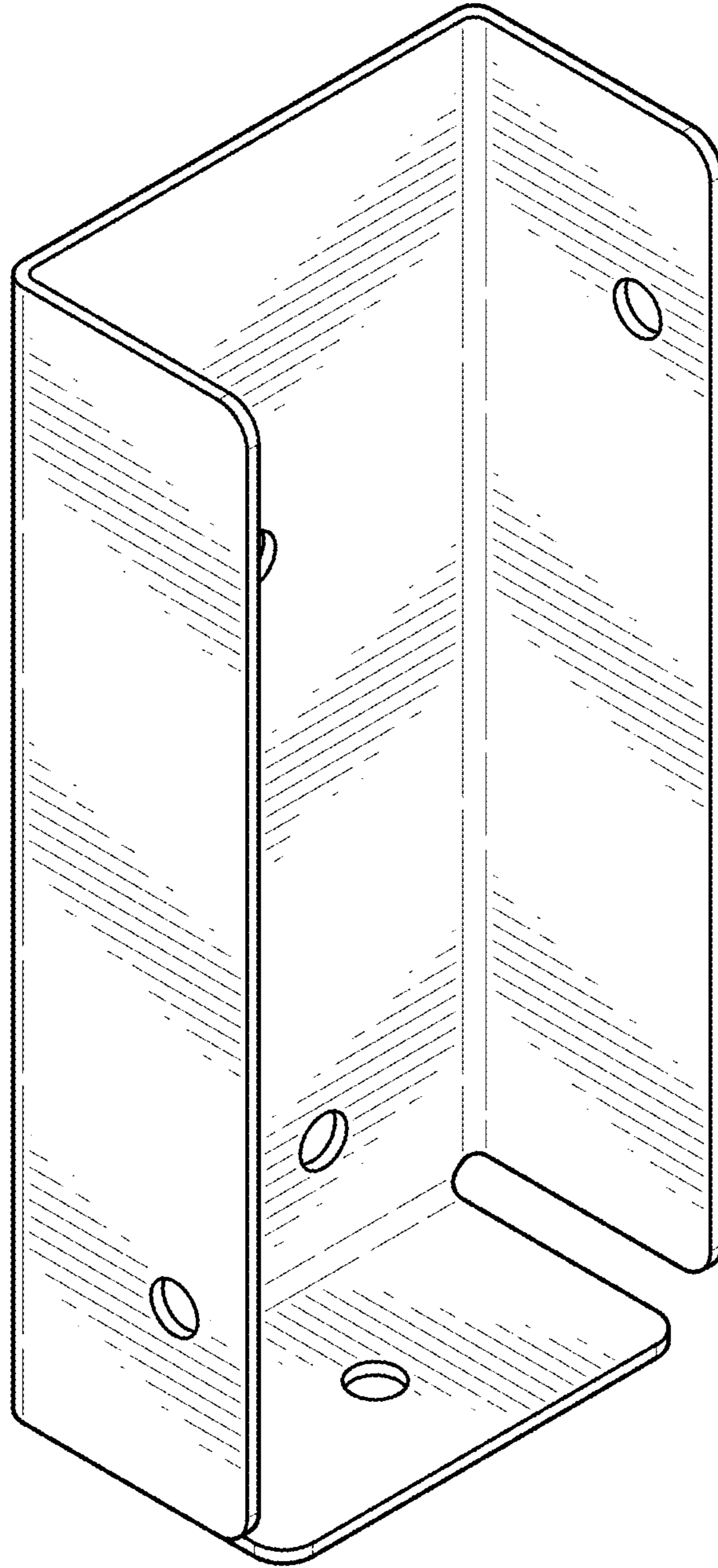

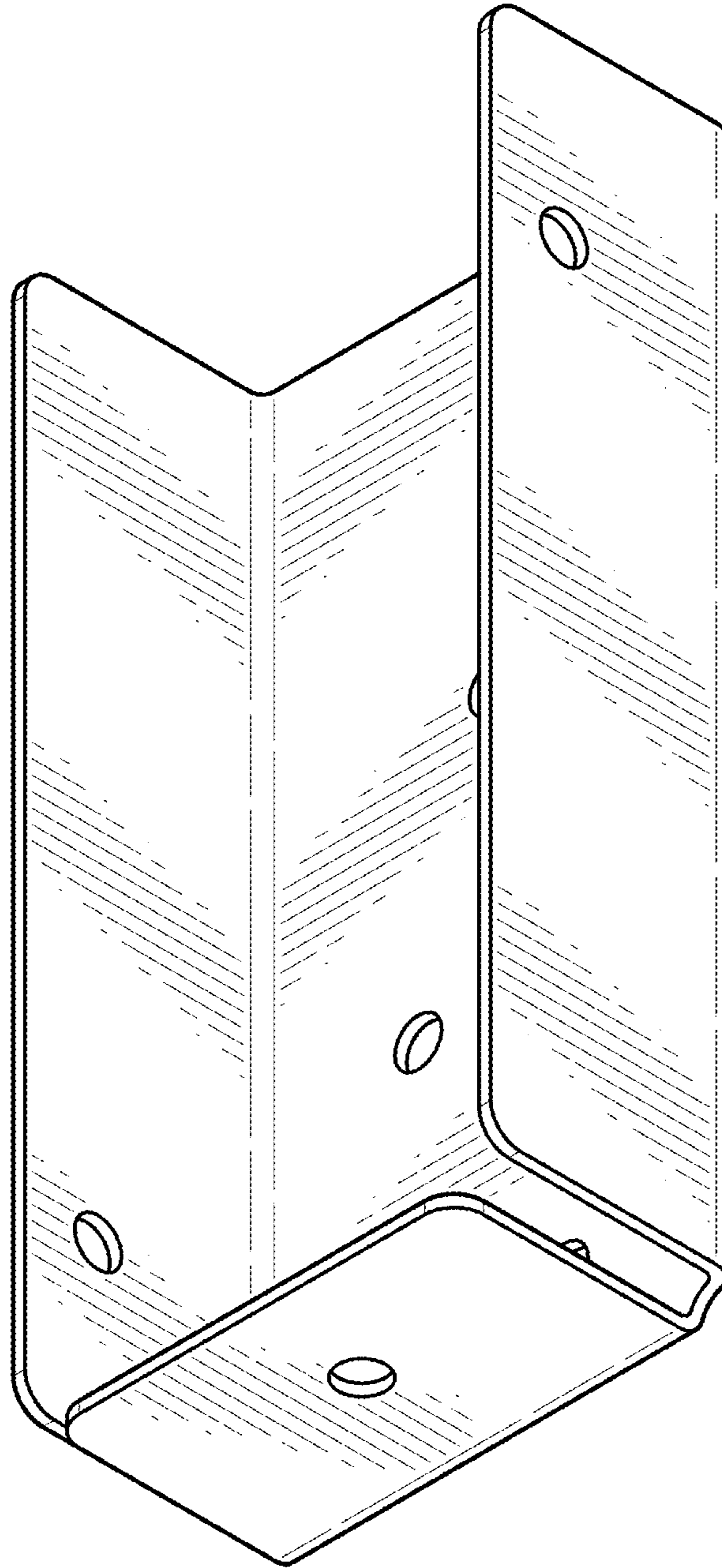

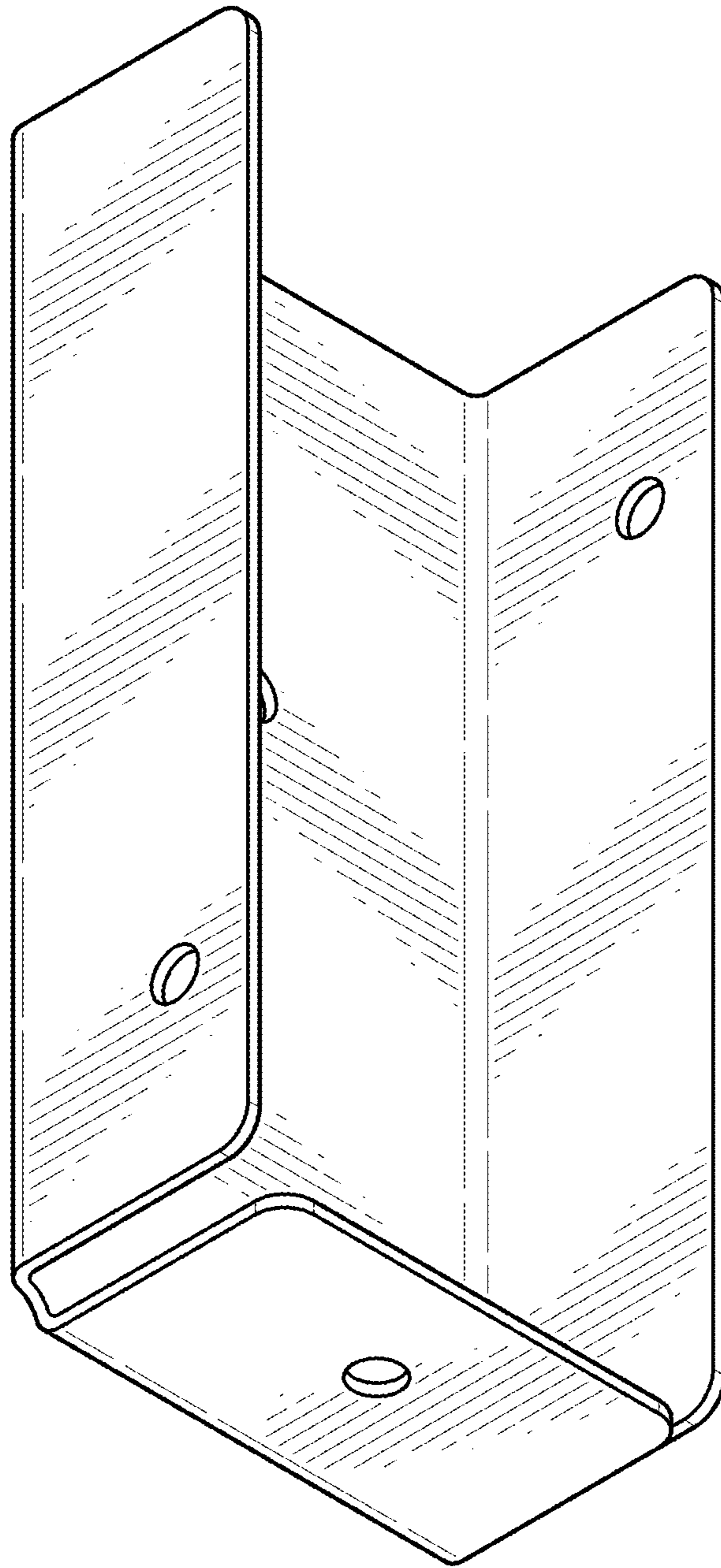

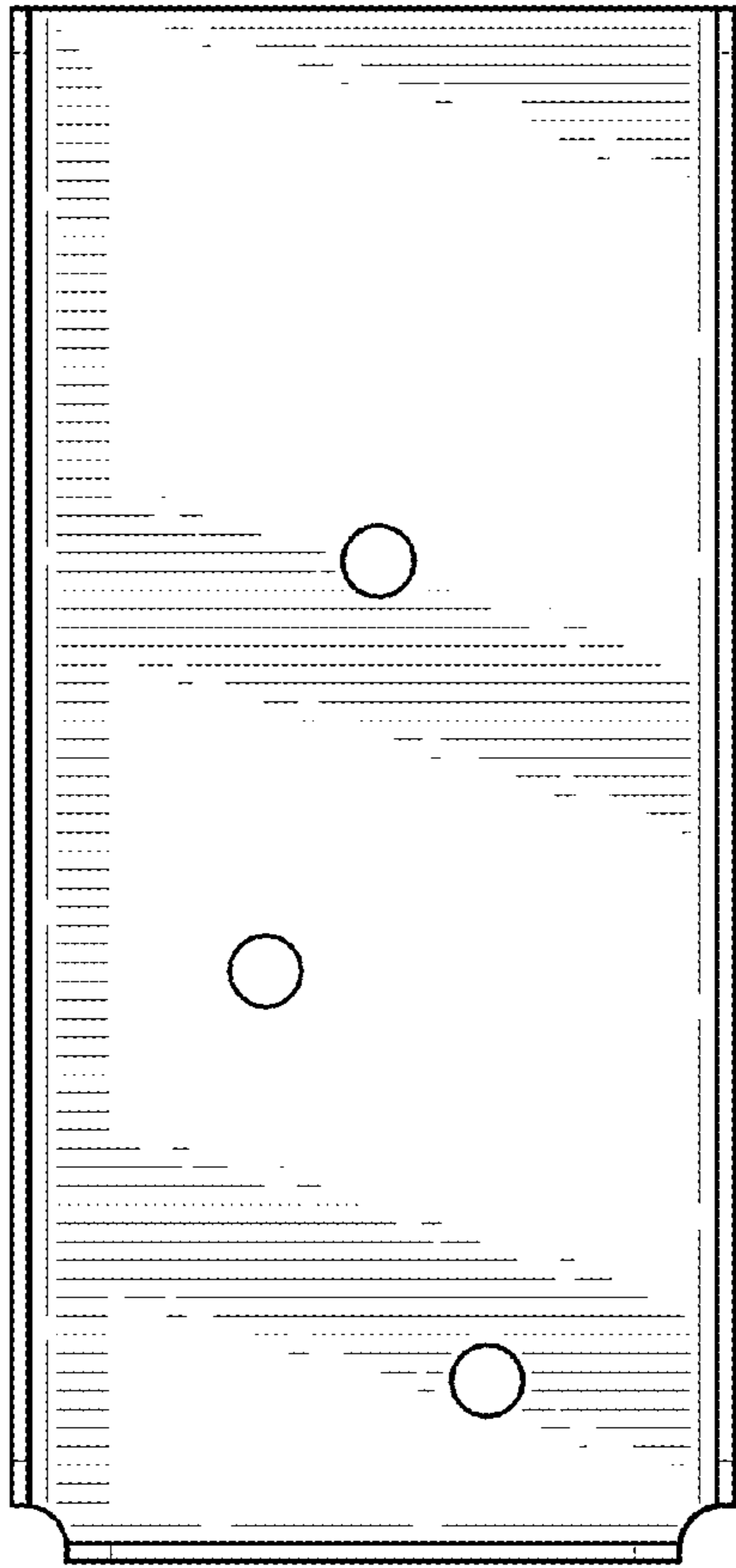

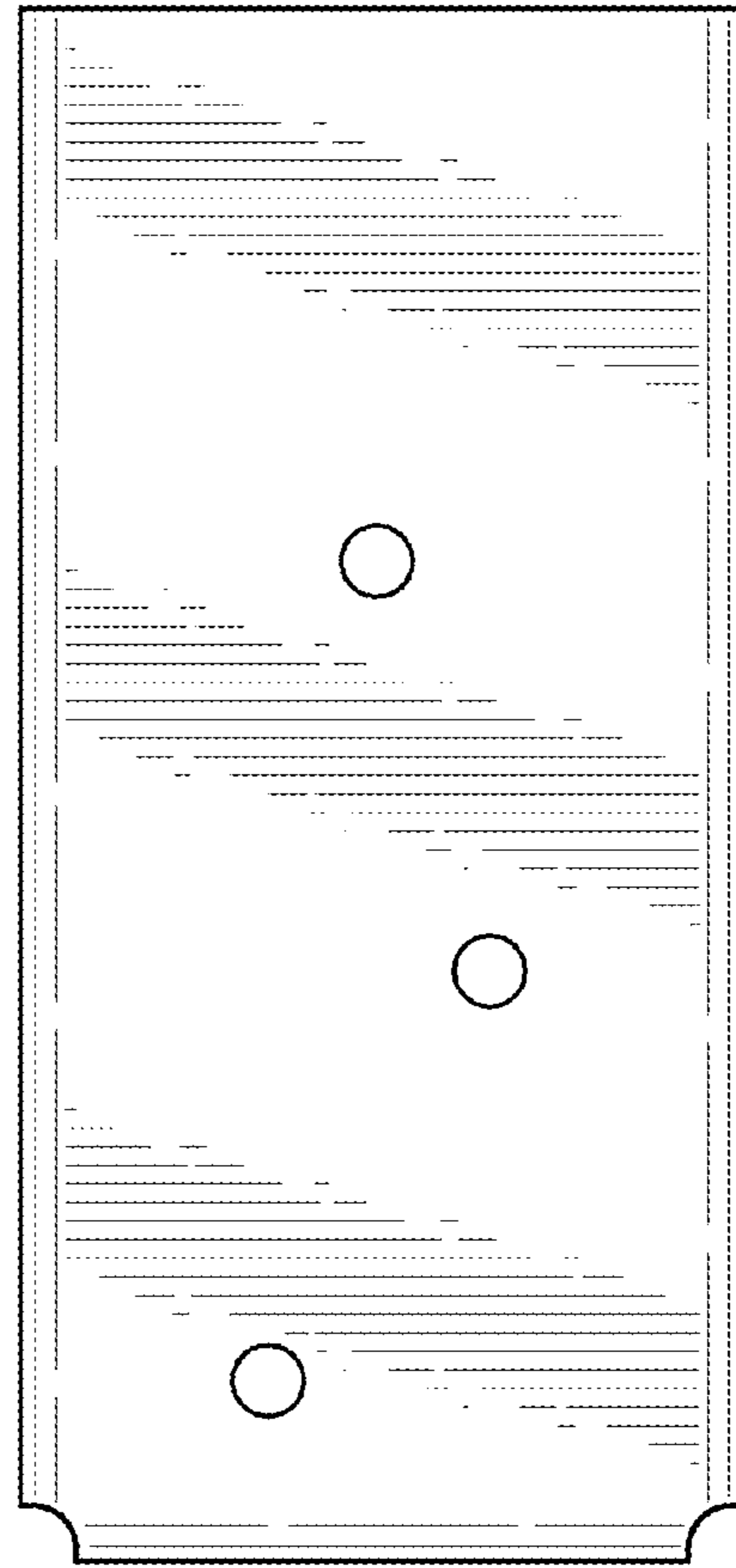

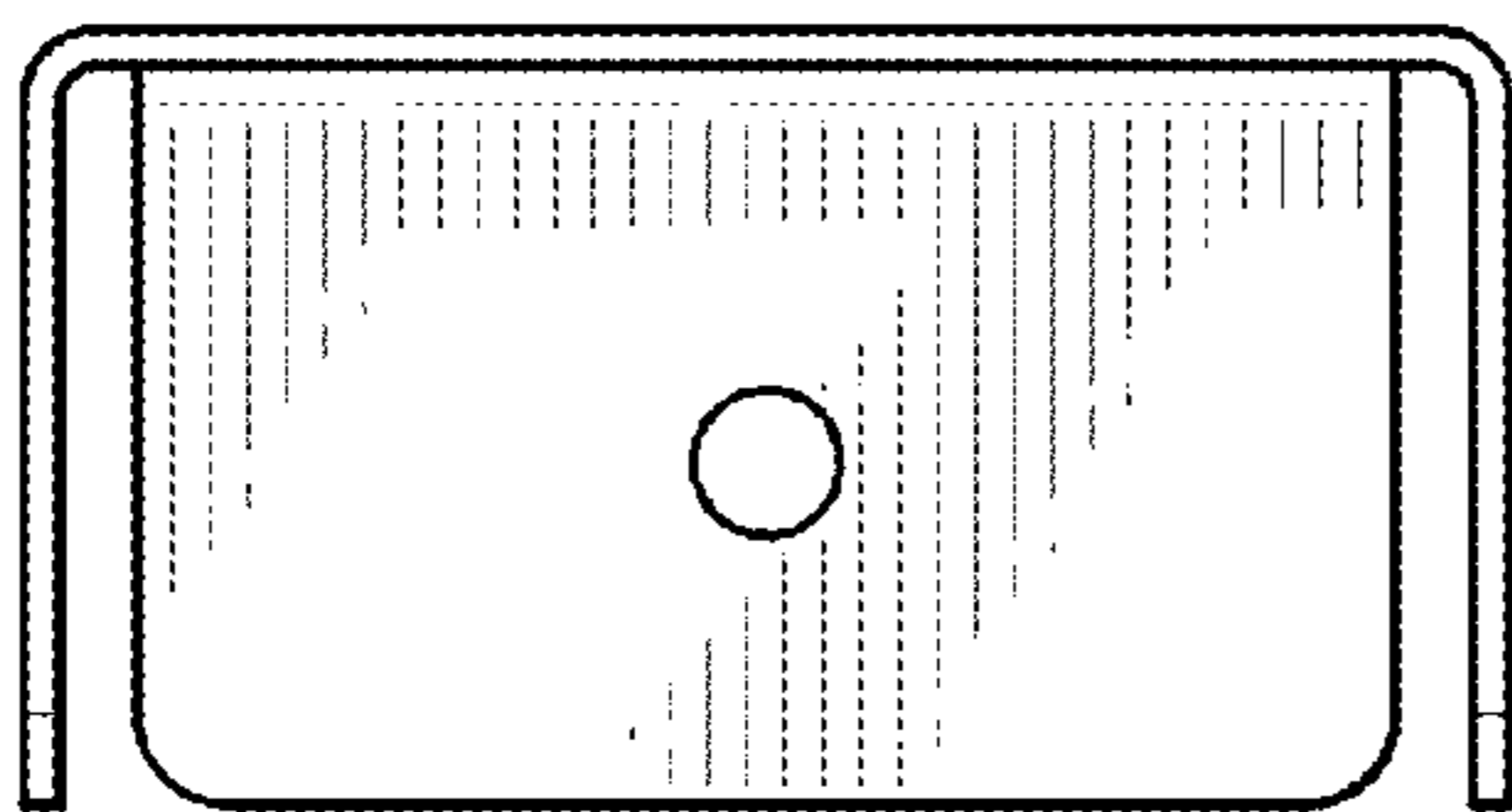

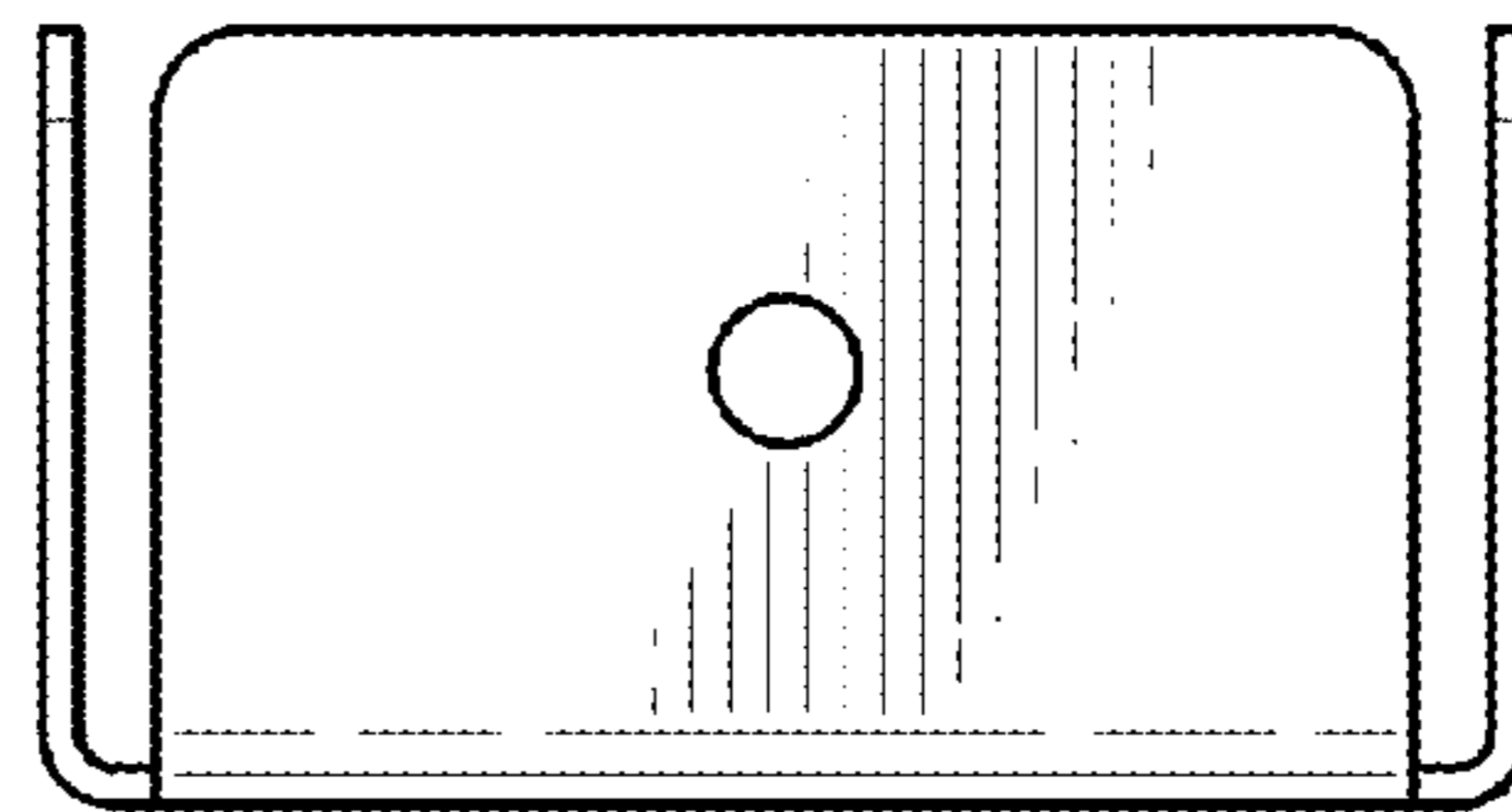

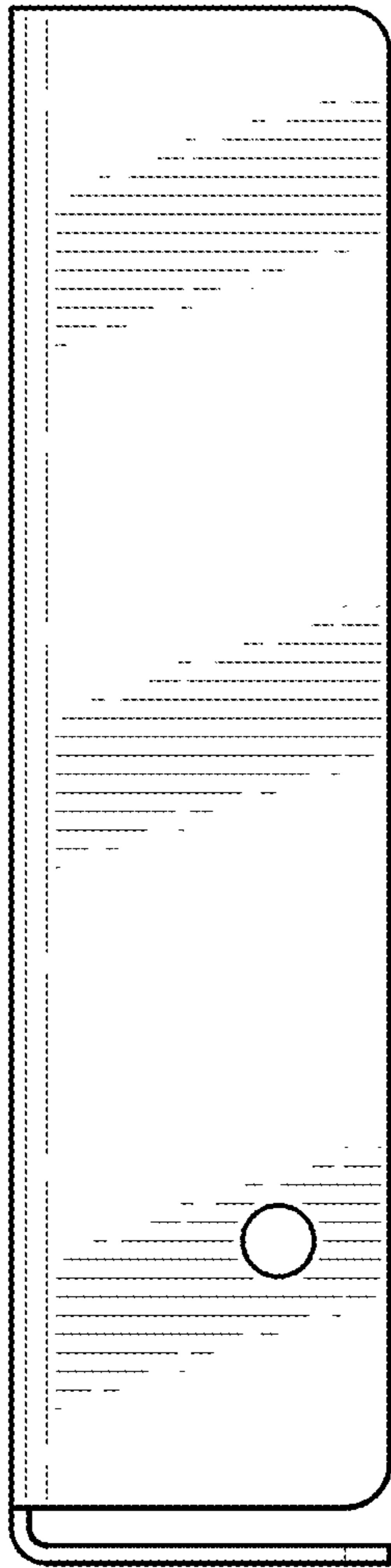

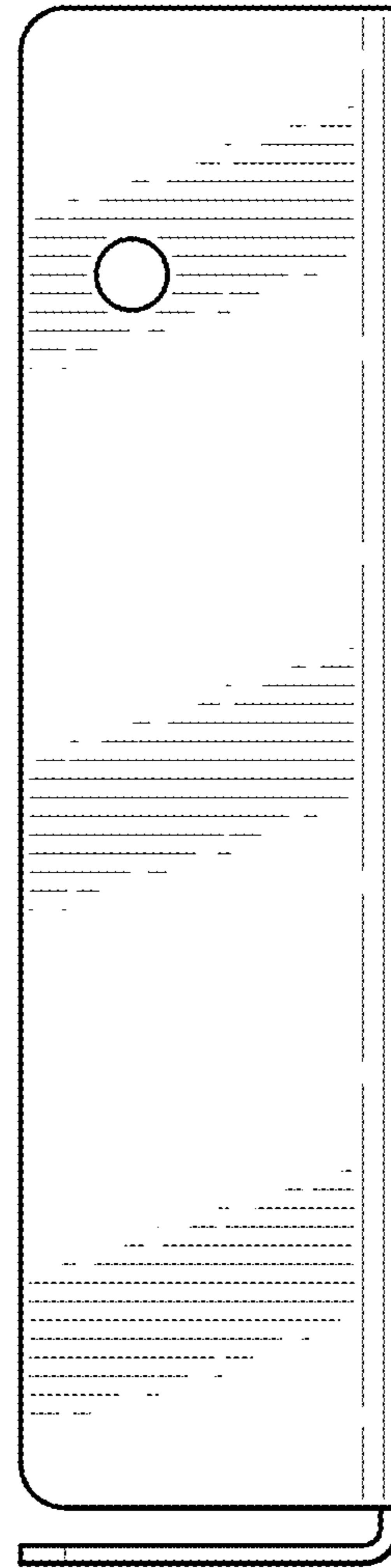
