(57) **CLAIM**

The ornamental design for an ink cartridge box for printers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of an ink cartridge box for printers showing our new design; FIG. 2 is a rear, bottom and left side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a left side view thereof, the right side view being a mirror image of FIG. 7. The features shown in broken lines in the drawings depict environmental subject matter only and form no part of the claimed design.

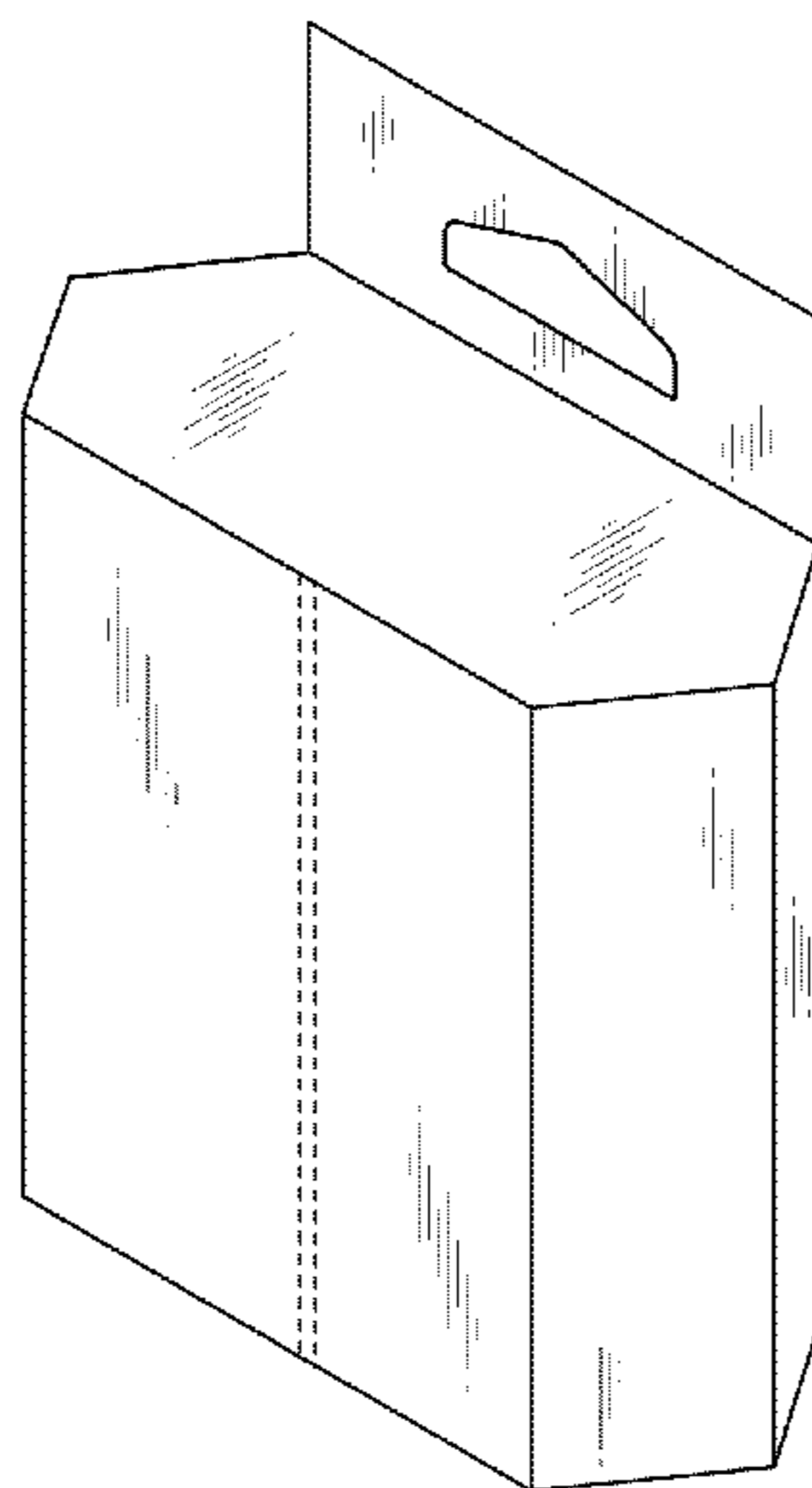

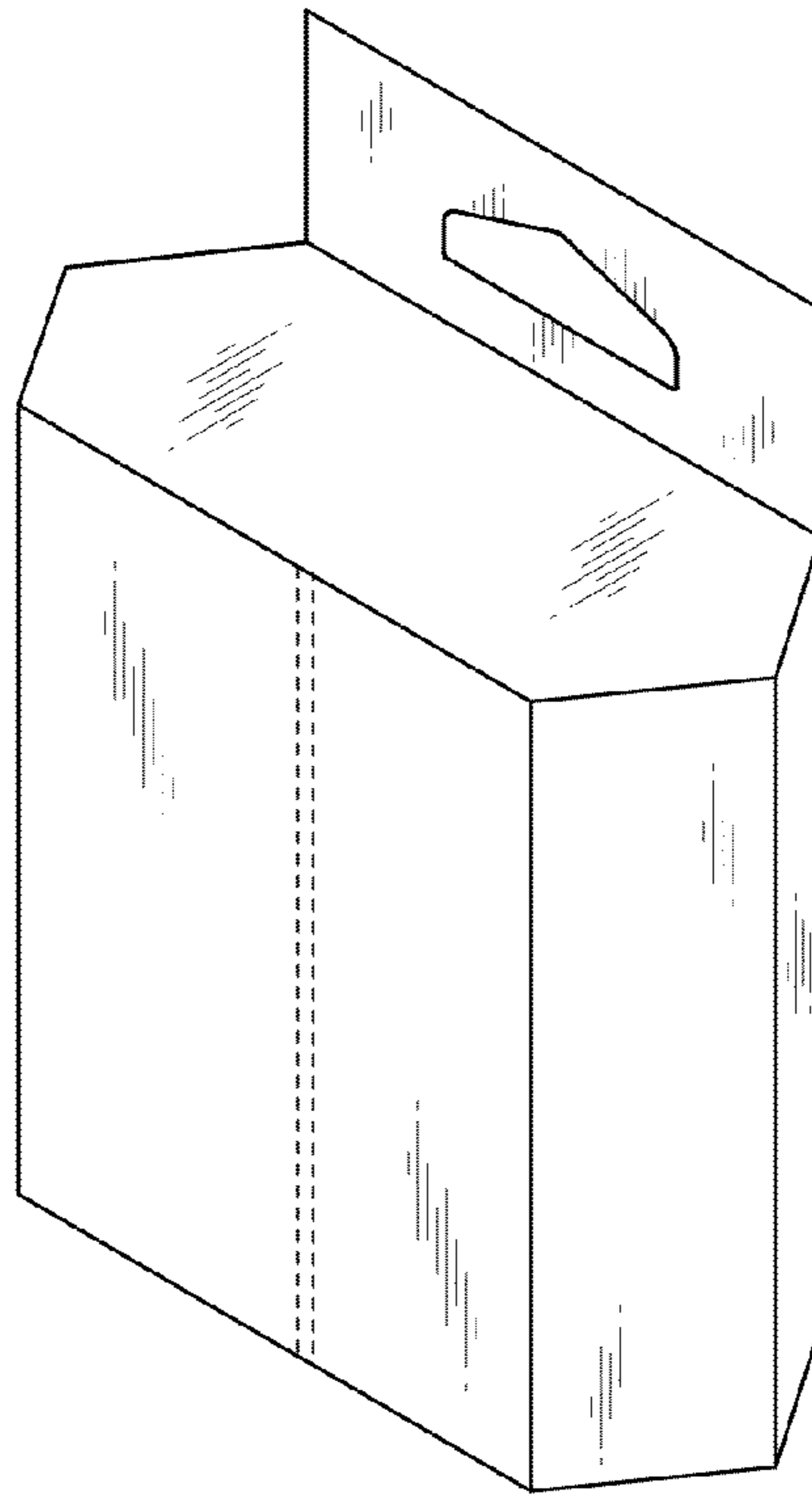

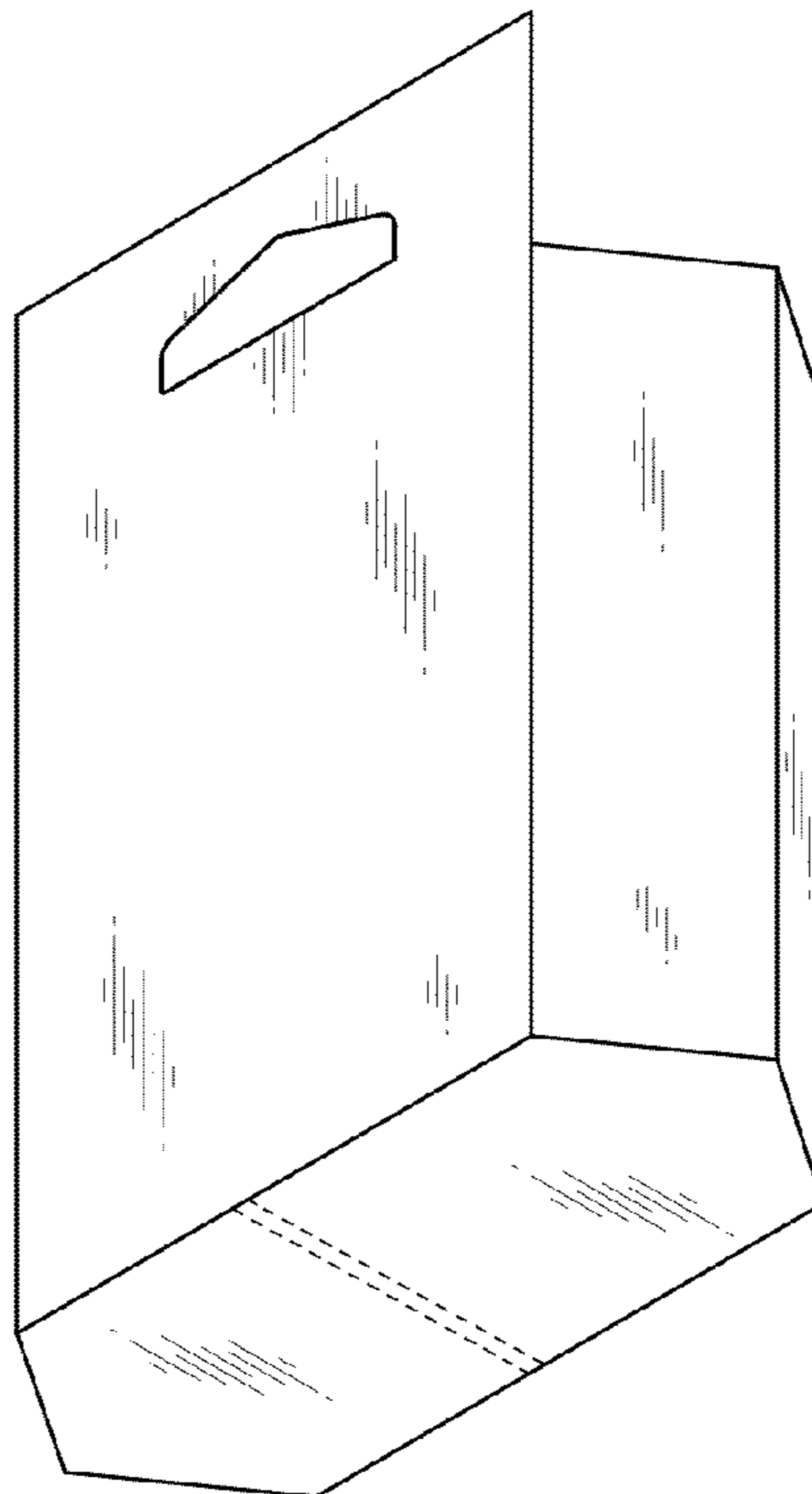

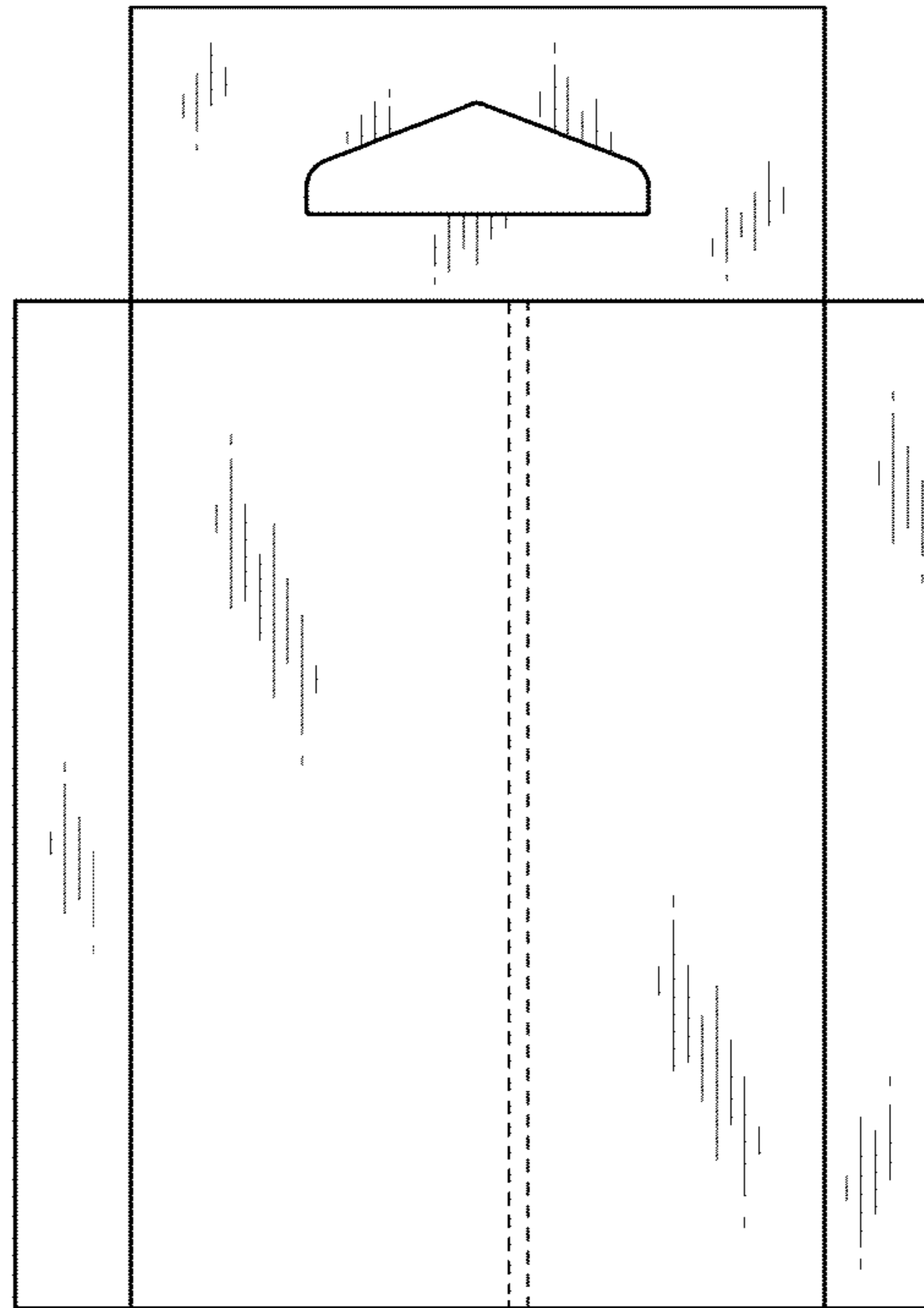

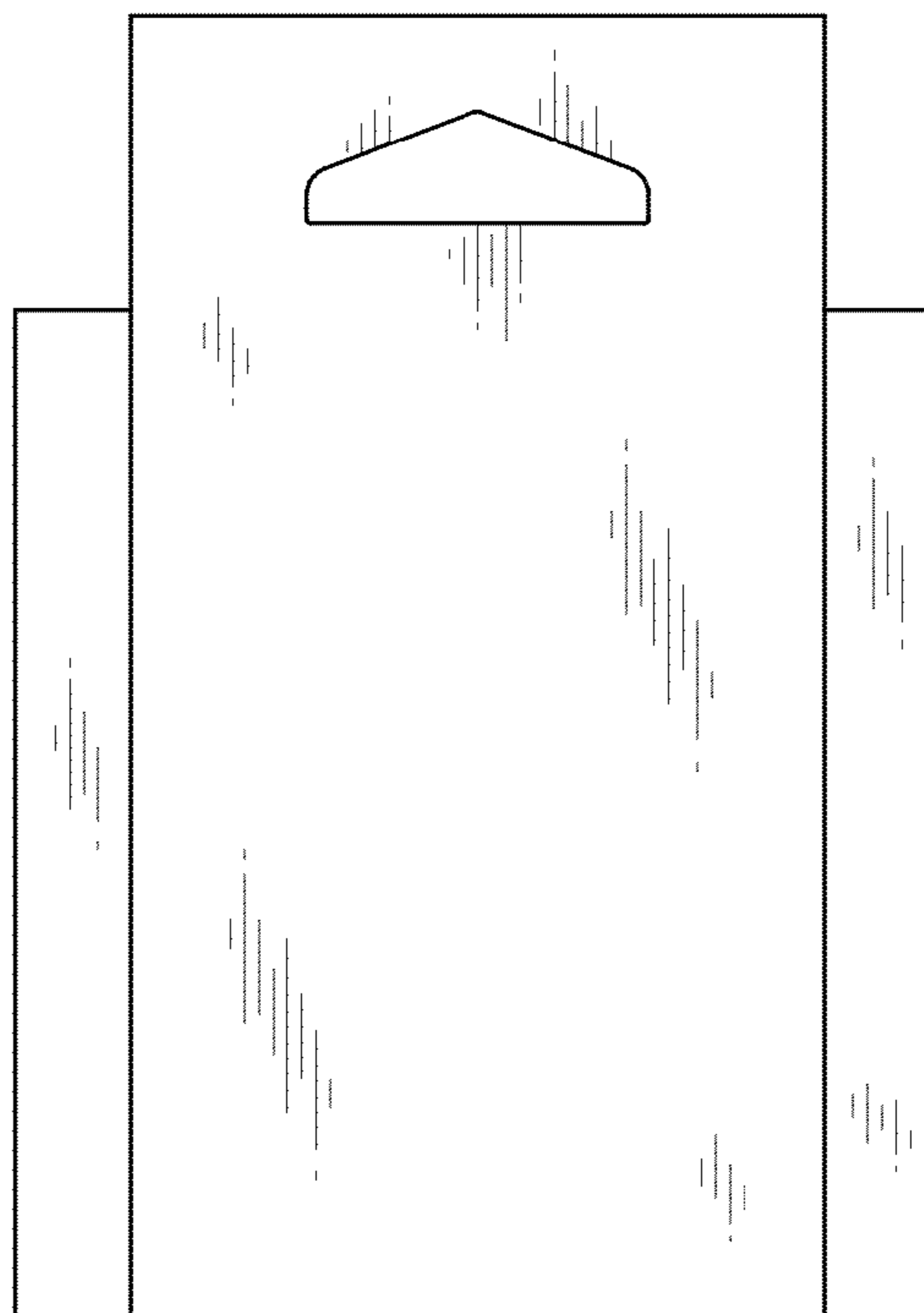

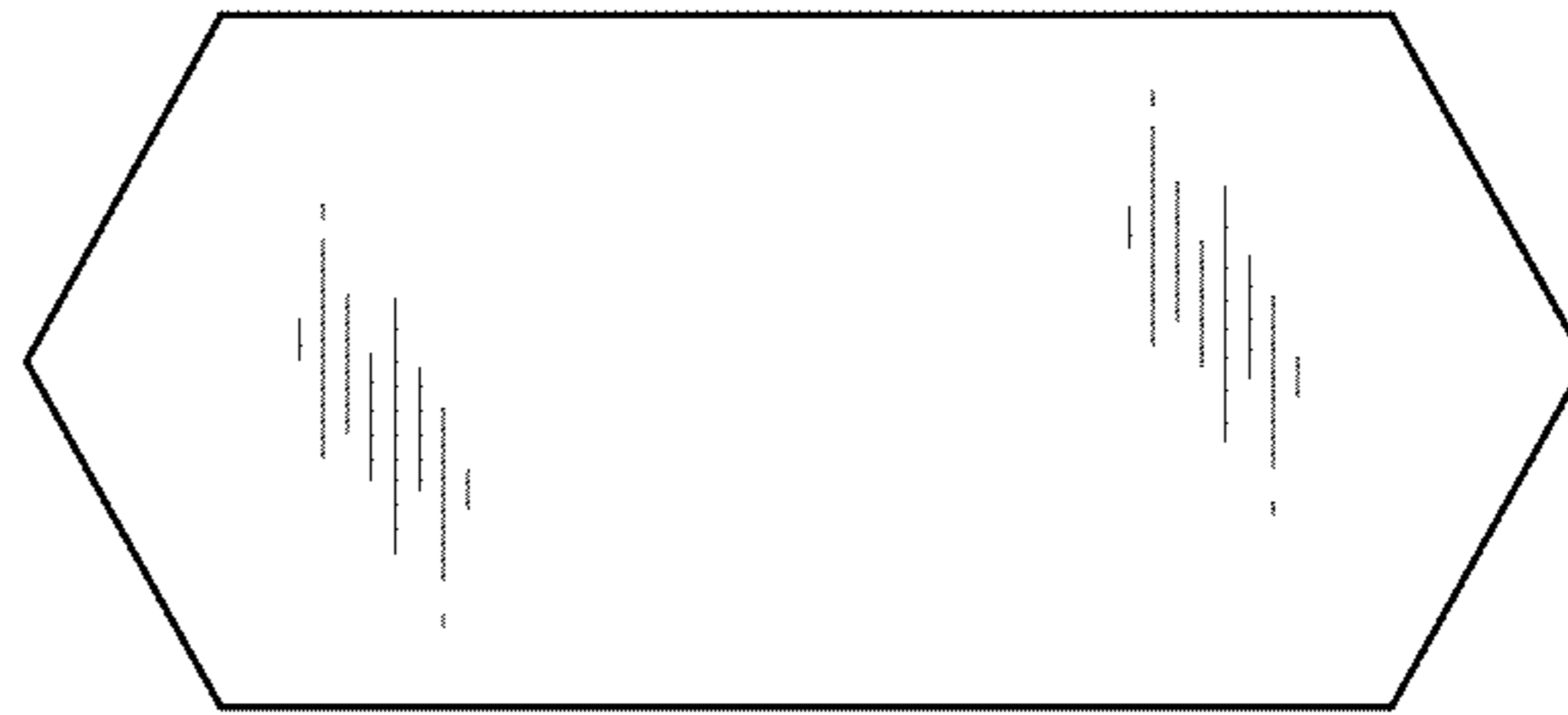

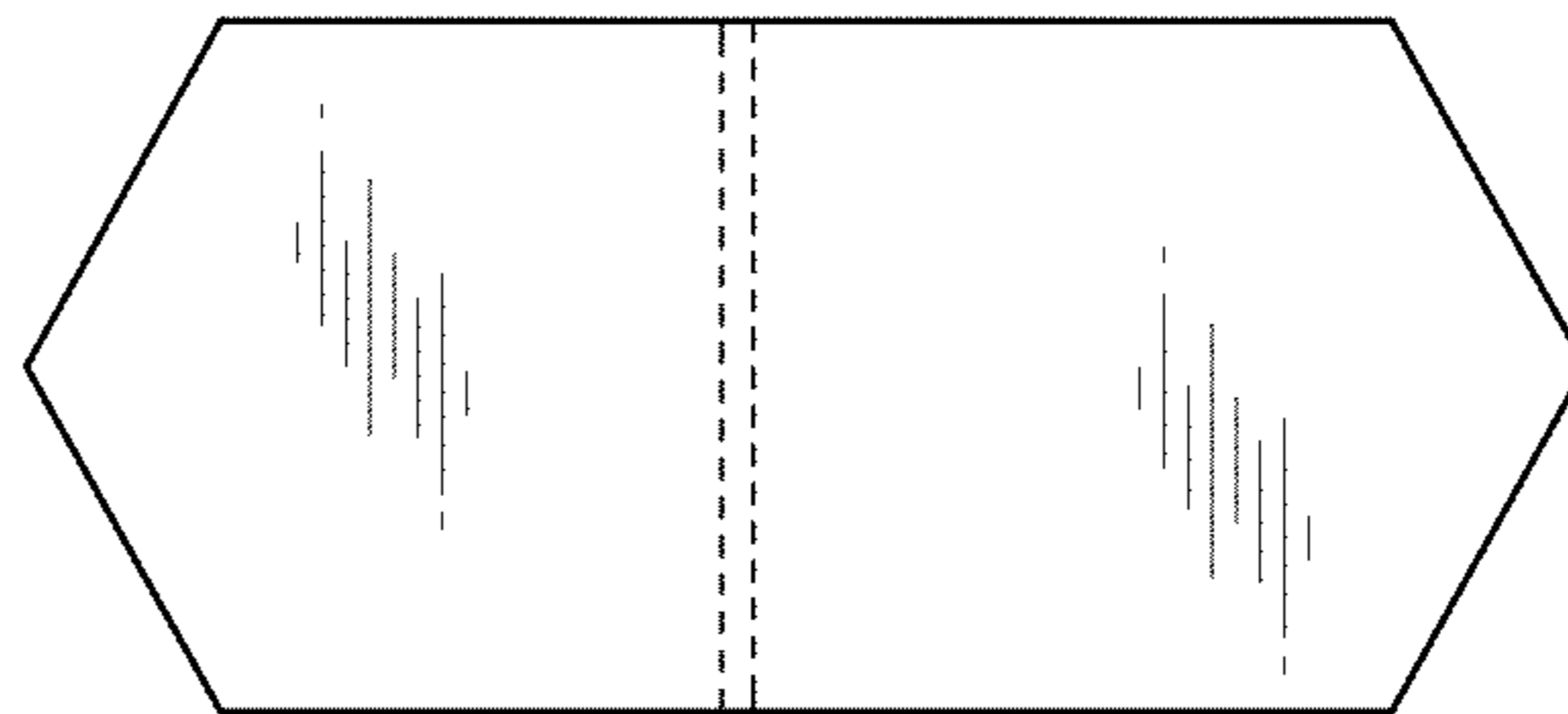
