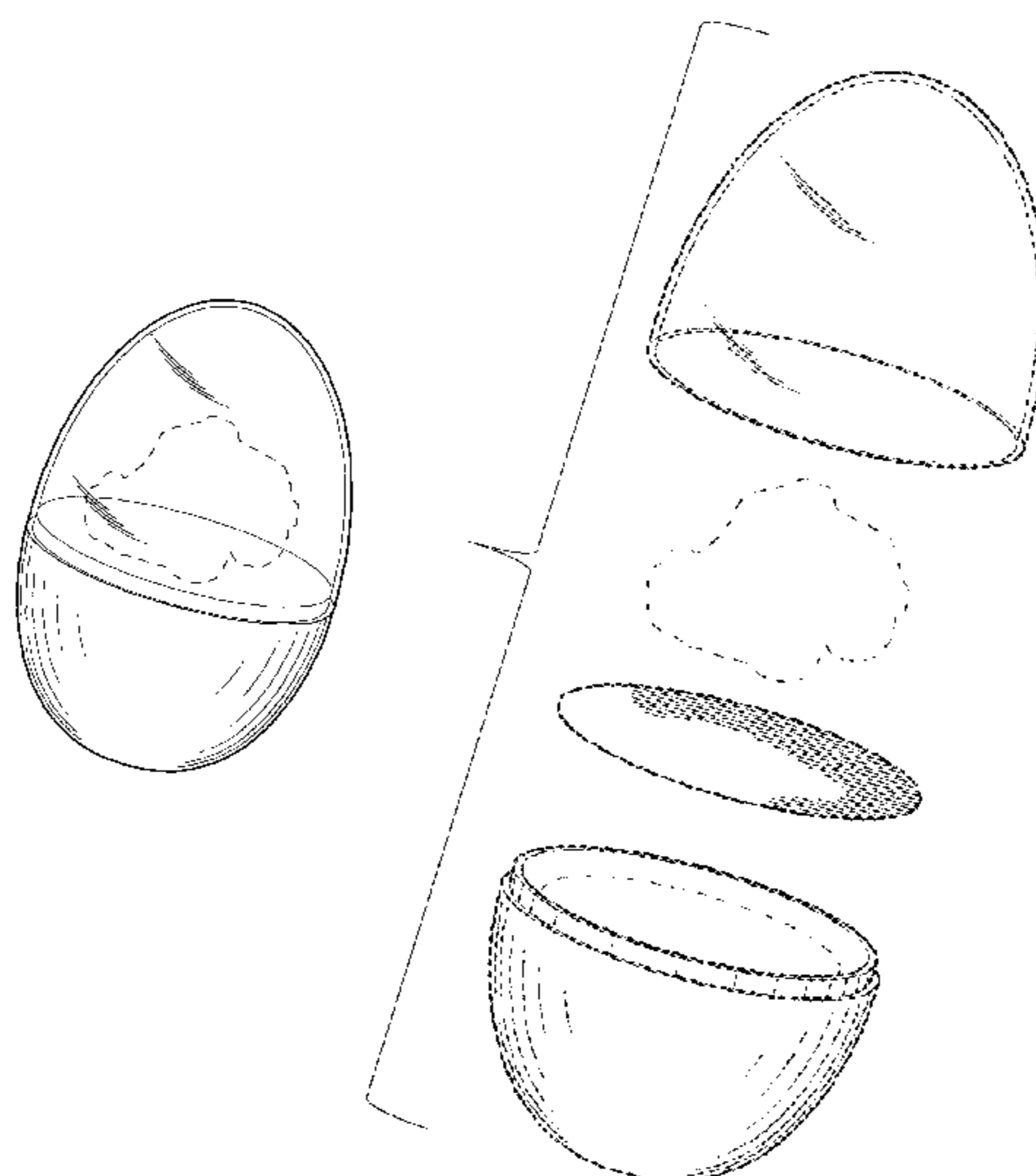
(57) **CLAIM**

The ornamental design for an object storage device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an object storage device showing my new design;
FIG. 2 is an exploded perspective view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a side elevation view with the top separated from the bottom thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

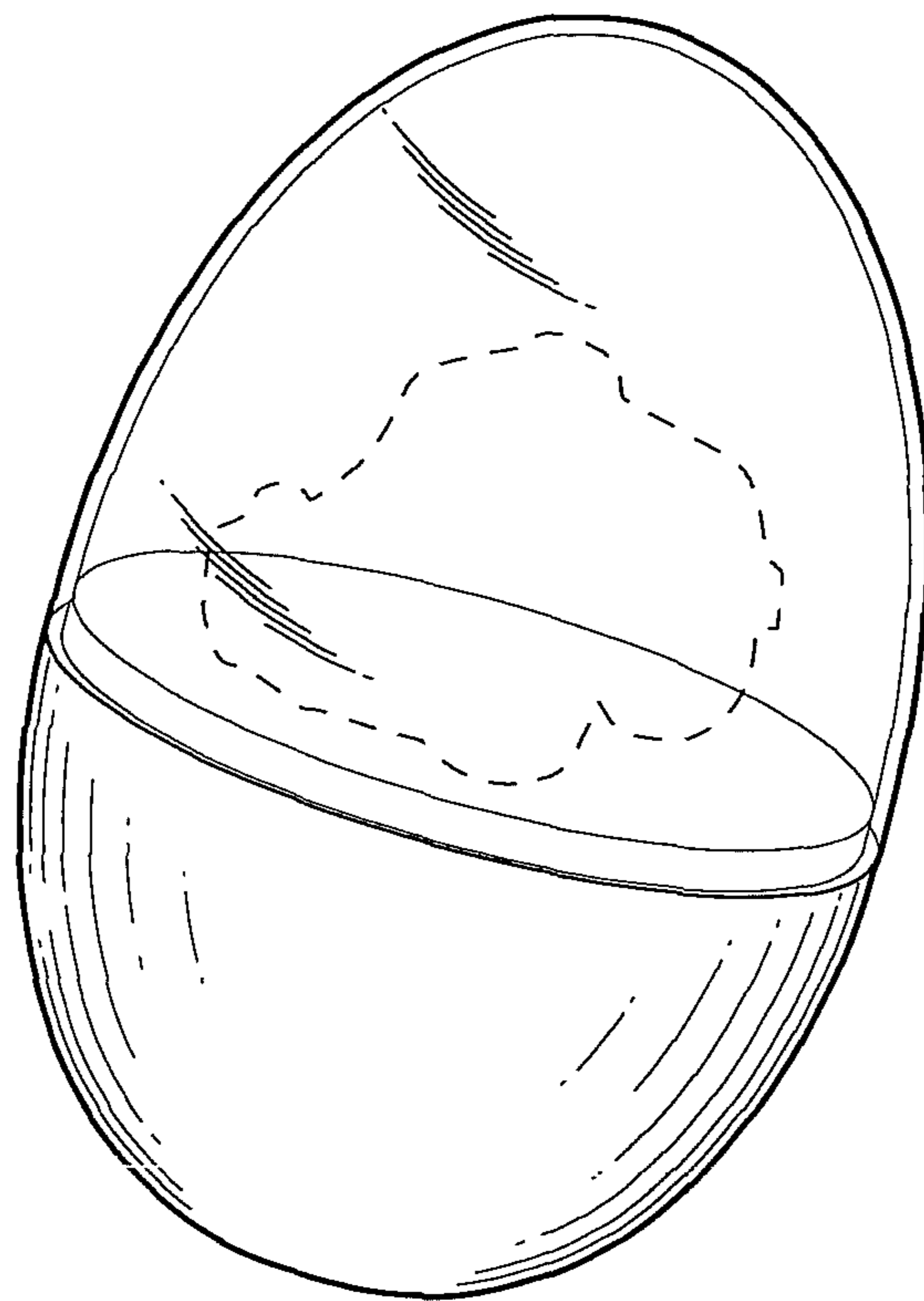

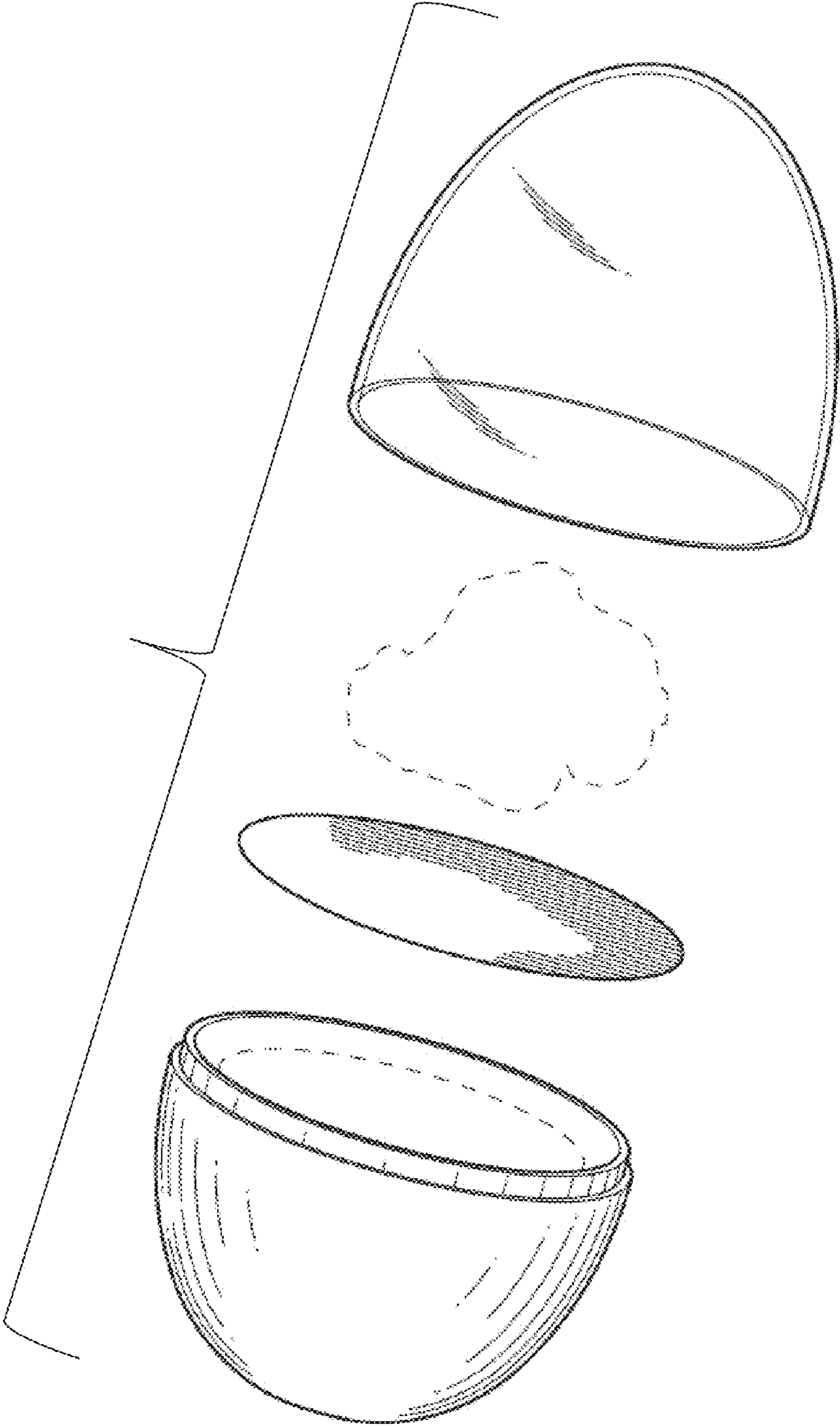

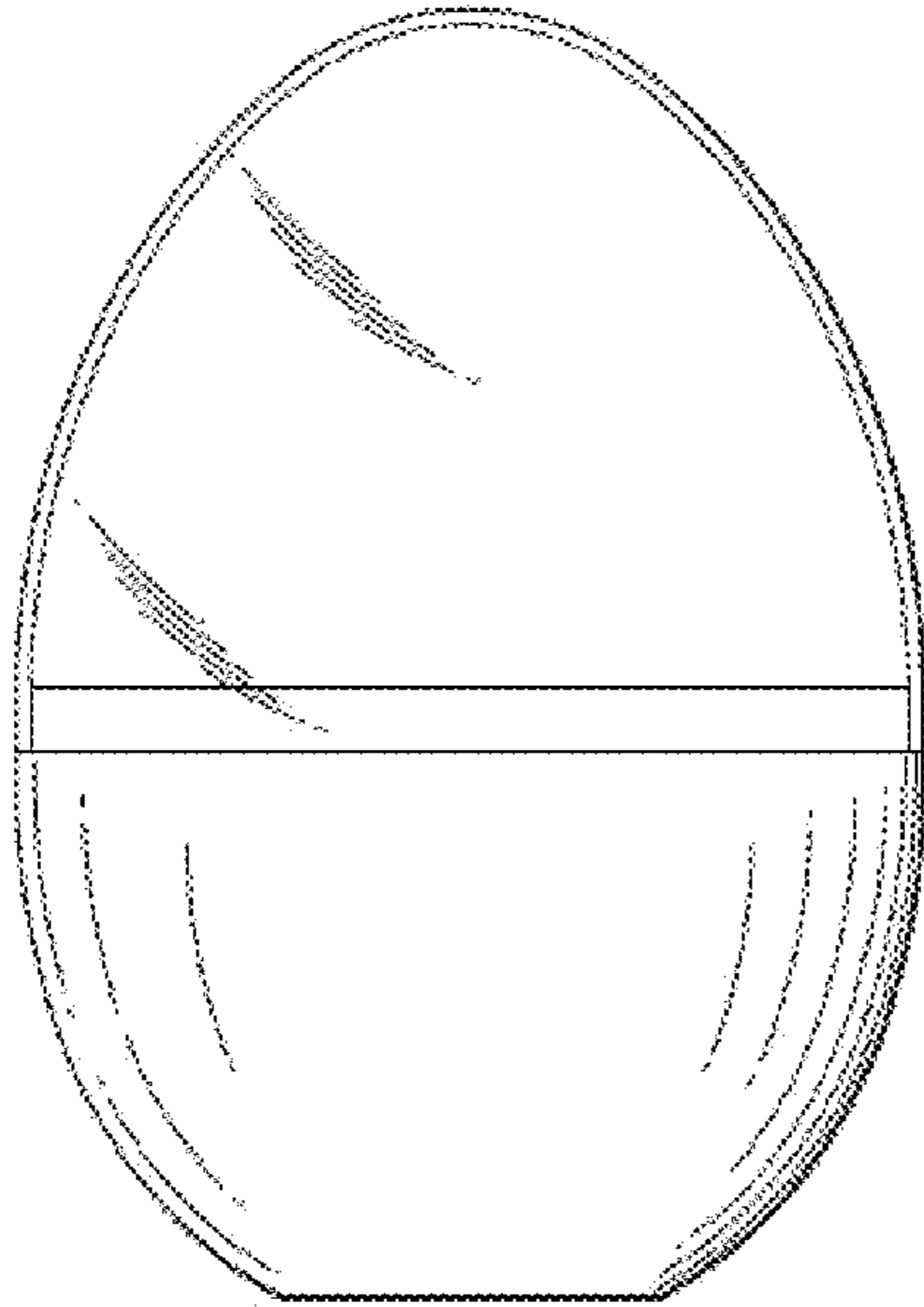

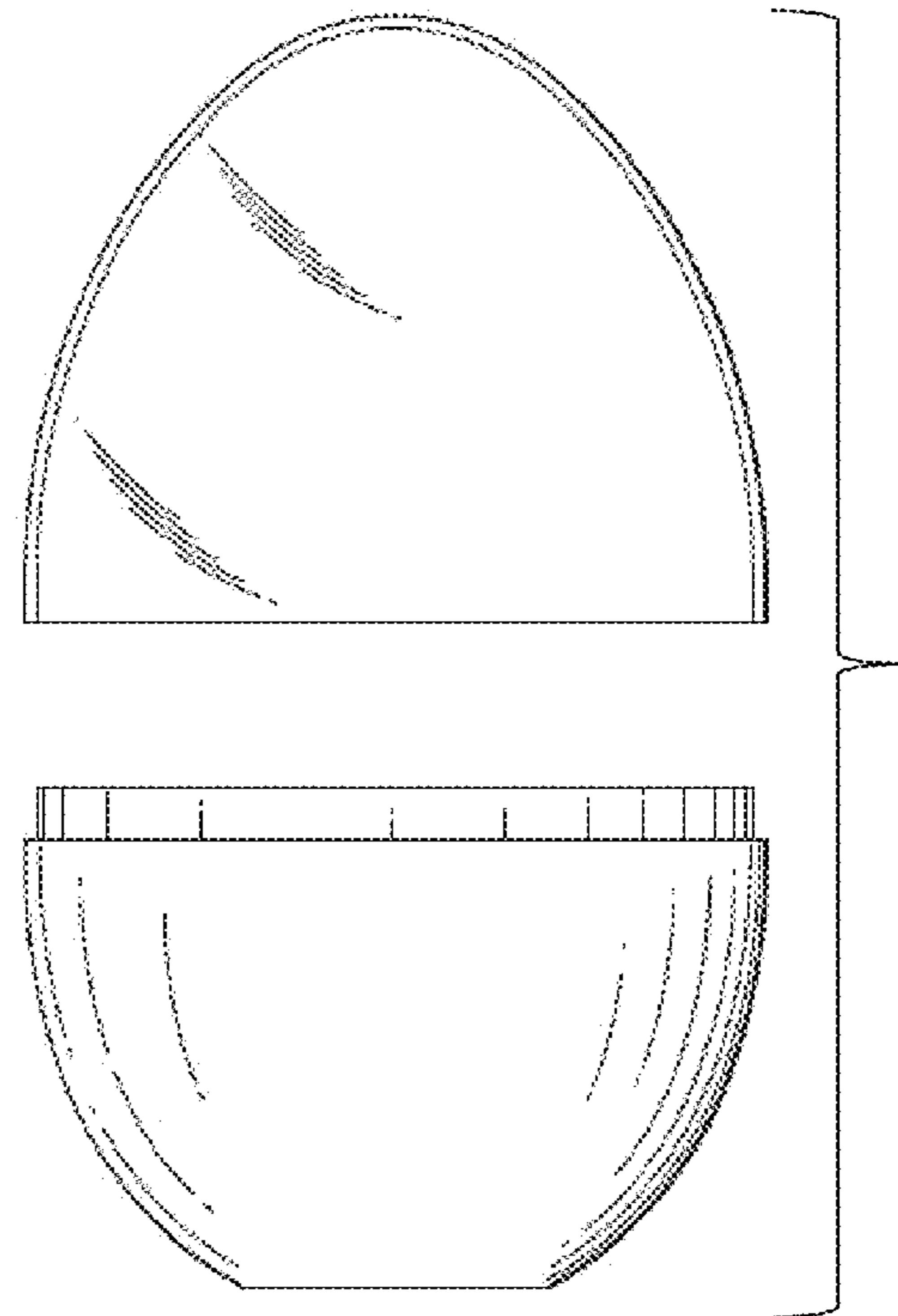

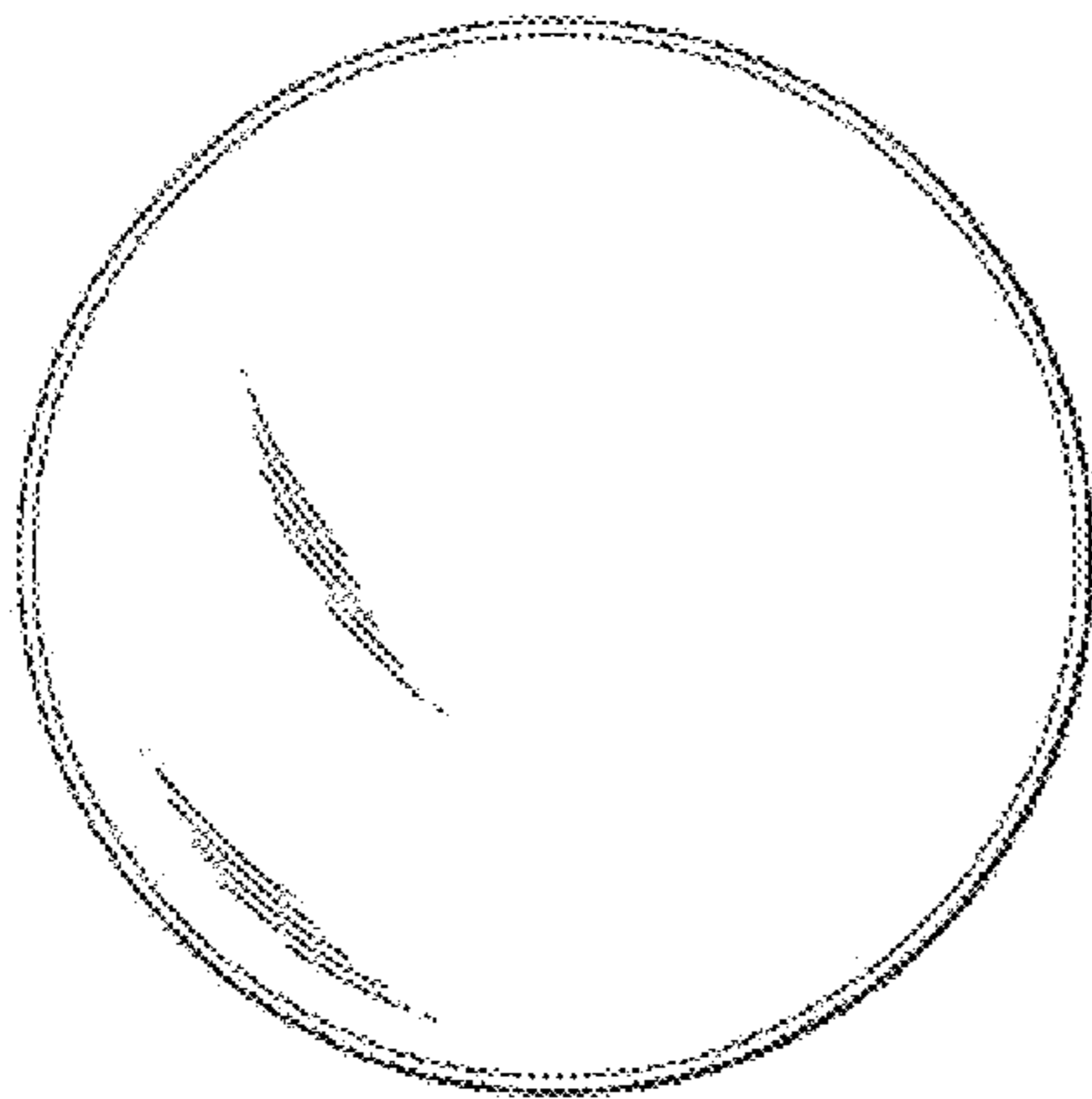

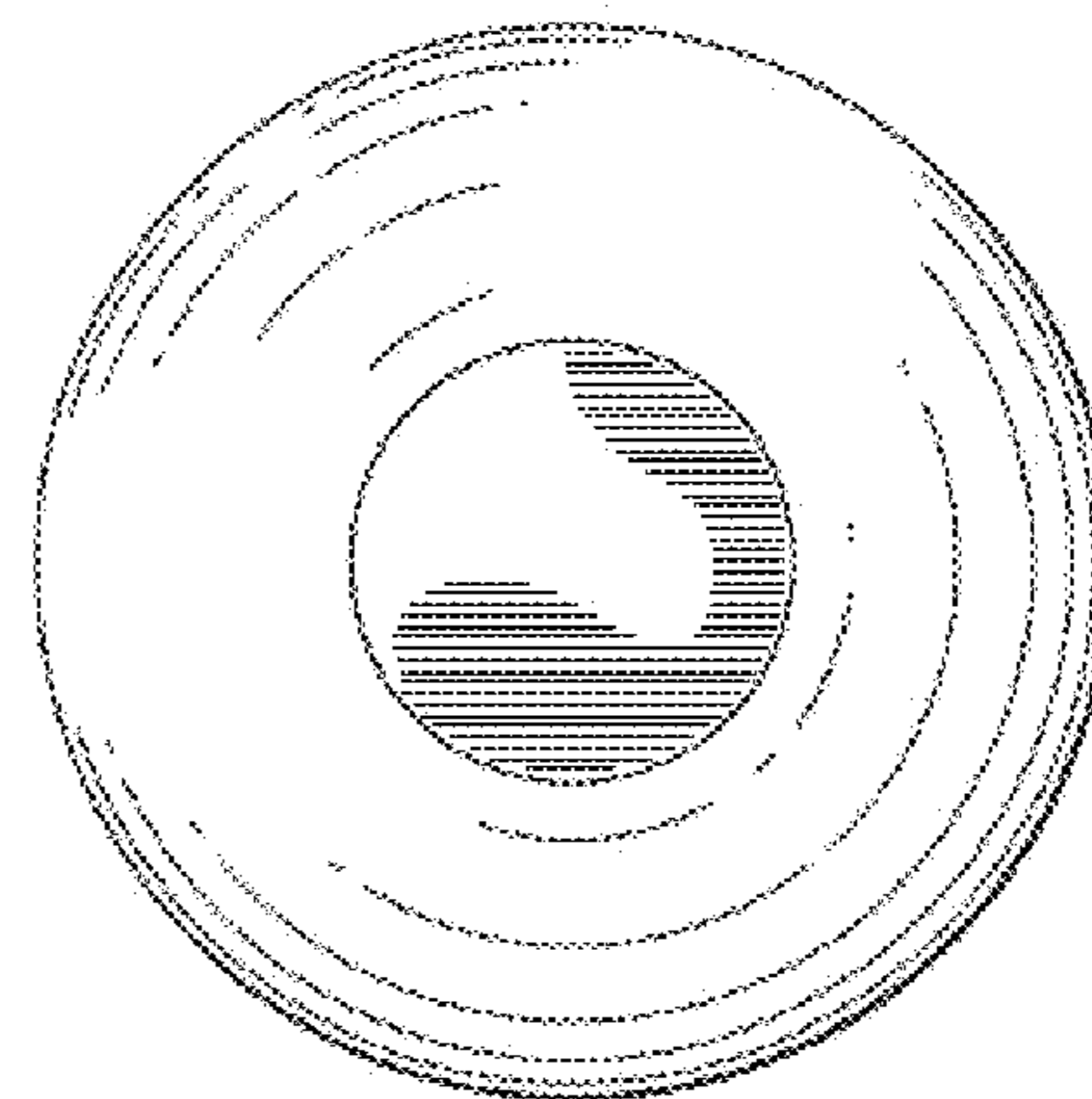
